# Another Look at AR(1)

#### Abstract

Given a stationary first-order autoregressive process $X_{t}$ (with lag-one correlation $\rho$ satisfying $|\rho|<1$ ), we examine the Central Limit Theorem for $\frac{1}{n} \ln \left|X_{1} \cdots X_{n}\right|$ and compute variances to high precision. Given a nonstationary process $X_{t}$ (with $|\rho|>1$ ), we examine instead $\frac{1}{n} \ln \left|X_{n}\right|$ and study the distribution of $\ln \left|X_{n}\right|-n \ln |\rho|$.


This research began as an effort to better understand Viswanath's random integer recurrence [1]:

$$
\begin{gathered}
X_{t}=X_{t-1} \pm X_{t-2}, \quad X_{0}=1, \quad X_{1}=1 \\
\frac{1}{n} \ln \left|X_{n}\right| \rightarrow \ln (1.13198824 \ldots) \quad \text { almost surely as } n \rightarrow \infty
\end{gathered}
$$

and one of Wright \& Trefethen's real recurrences [2]:

$$
\begin{gathered}
X_{t}=X_{t-1}+\varepsilon_{t} X_{t-2}, \quad X_{0}=1, \quad X_{1}=1 \\
\frac{1}{n} \ln \left|X_{n}\right| \rightarrow \ln (1.057473553704 \ldots) \quad \text { almost surely as } n \rightarrow \infty
\end{gathered}
$$

where $\varepsilon_{t}$ is $N(0,1)$ white noise. What are the corresponding asymptotic results for certain well-known recurrences in standard time series analysis?

When $|\rho|>1$, the nonstationary first-order autoregressive process

$$
X_{t}=\rho X_{t-1}+\sqrt{\rho^{2}-1} \varepsilon_{t}, \quad X_{0}=0
$$

is readily shown to satisfy

$$
\frac{1}{n} \ln \left|X_{n}\right| \rightarrow \ln |\rho| \quad \text { almost surely as } n \rightarrow \infty
$$

The quantity $\ln |\rho|$ is called the Lyapunov exponent of the system 3. More precisely,

$$
\mu_{n}=\mathrm{E}\left(\ln \left|X_{n}\right|\right)=\frac{1}{2}\left(\ln \left(\rho^{2 n}-1\right)-\ln (2)-\gamma\right), \quad \sigma^{2}=\operatorname{Var}\left(\ln \left|X_{n}\right|\right)=\frac{\pi^{2}}{8}
$$

where $\gamma$ denotes the Euler-Mascheroni constant [4]. We wish to ascertain the distribution of the errors $\left(\ln \left|X_{n}\right|-\mu_{n}\right) / \sigma$, which do not appear to be $N(0,1)$.

[^0]When $|\rho|<1$, the stationary first-order autoregressive process

$$
X_{t}=\rho X_{t-1}+\sqrt{1-\rho^{2}} \varepsilon_{t}
$$

gives rise to a different question. Here we have

$$
\mu=\mathrm{E}\left(\ln \left|X_{t}\right|\right)=\frac{1}{2}(-\ln (2)-\gamma), \quad \sigma^{2}=\operatorname{Var}\left(\ln \left|X_{t}\right|\right)=\frac{\pi^{2}}{8}
$$

in contrast to before. The Central Limit Theorem gives [5, 6]

$$
\sqrt{n} \frac{\frac{1}{n} \sum_{t=1}^{n} \ln \left|X_{t}\right|-\mu}{\xi_{\rho}} \rightarrow N(0,1) \quad \text { as } n \rightarrow \infty
$$

for some constant $\xi_{\rho}>0$; clearly $\xi_{0}=\sigma$. What is the numerical value of $\xi_{\rho}$ as a function of $\rho \neq 0$ ? This is our first question to be addressed.
0.1. Stationary Case. Let $f(x)$ denote the $N(0,1)$ density function and $f^{(j)}(x)$ denote its $j^{\text {th }}$ derivative. Since $\operatorname{Cov}\left(X_{1}, X_{\ell+1}\right)=\rho^{\ell}$ for integer lag $\ell \geq 1$, it follows that [7]

$$
\begin{aligned}
\mathrm{E}\left(\ln \left|X_{1}\right| \cdot \ln \left|X_{\ell+1}\right|\right) & =\sum_{j=0}^{\infty}\left|\int_{-\infty}^{\infty} \ln \right| x\left|f^{(j)}(x) d x\right|^{2} \frac{\rho^{j \ell}}{j!} \\
& =\mu^{2}+\sum_{k=1}^{\infty} \nu_{2 k}^{2} \frac{\rho^{2 k \ell}}{(2 k)!}
\end{aligned}
$$

where

$$
\nu_{2 k}=(-1)^{k-1} \int_{-\infty}^{\infty} \ln |x| f^{(2 k)}(x) d x=2^{k-1}(k-1)!
$$

Hence

$$
\begin{aligned}
\operatorname{Var}\left(\frac{1}{\sqrt{n}} \sum_{t=1}^{n} \ln \left|X_{t}\right|\right) & =\frac{1}{n} \sum_{t=1}^{n} \sum_{s=1}^{n} \operatorname{Cov}\left(\ln \left|X_{t}\right|, \ln \left|X_{s}\right|\right) \\
& =\sigma^{2}+\frac{2}{n} \sum_{\ell=1}^{n-1}(n-\ell)\left(\mathrm{E}\left(\ln \left|X_{1}\right| \cdot \ln \left|X_{\ell+1}\right|\right)-\mu^{2}\right) \\
& =\sigma^{2}+\frac{2}{n} \sum_{k=1}^{\infty} \frac{\nu_{2 k}^{2}}{(2 k)!} \sum_{\ell=1}^{n-1}(n-\ell) \rho^{2 k \ell} \\
& =\sigma^{2}+\frac{2}{n} \sum_{k=1}^{\infty} \frac{\nu_{2 k}^{2}}{(2 k)!}\left(\frac{n}{1-\rho^{2 k}}-\frac{1-\rho^{2 k n}}{\left(1-\rho^{2 k}\right)^{2}}\right) \rho^{2 k}
\end{aligned}
$$

and therefore

$$
\begin{aligned}
\xi_{\rho}^{2}= & \lim _{n \rightarrow \infty} \operatorname{Var}\left(\frac{1}{\sqrt{n}} \sum_{t=1}^{n} \ln \left|X_{t}\right|\right)=\sigma^{2}+2 \sum_{k=1}^{\infty} \frac{\nu_{2 k}^{2}}{(2 k)!} \frac{\rho^{2 k}}{1-\rho^{2 k}} \\
= & \frac{\pi^{2}}{8}+2\left(\frac{1}{2} \frac{\rho^{2}}{1-\rho^{2}}+\frac{1}{6} \frac{\rho^{4}}{1-\rho^{4}}+\frac{4}{45} \frac{\rho^{6}}{1-\rho^{6}}+\frac{2}{35} \frac{\rho^{8}}{1-\rho^{8}}\right. \\
& +\frac{64}{1575} \frac{\rho^{10}}{1-\rho^{10}}+\frac{64}{2079} \frac{\rho^{12}}{1-\rho^{12}}+\frac{512}{21021} \frac{\rho^{14}}{1-\rho^{14}}+\frac{128}{6435} \frac{\rho^{16}}{1-\rho^{16}} \\
& \left.+\frac{16384}{984555} \frac{\rho^{18}}{1-\rho^{18}}+\frac{16384}{1154725} \frac{\rho^{20}}{1-\rho^{20}}+\frac{131072}{1066965} \frac{\rho^{22}}{1-\rho^{22}}+\cdots\right)
\end{aligned}
$$

via computer algebra. This is an example of what is called a Lambert series [8]. With suitably many terms, we calculate

$$
\begin{aligned}
& \xi_{0.1}=1.11527354305263680232 \ldots \\
& \xi_{0.3}=1.15562165351986837602 \ldots \\
& \xi_{0.5}=1.26199222423122947973 \ldots \\
& \xi_{0.7}=1.52783735828651737636 \ldots \\
& \xi_{0.9}=2.55564072887132125752 \ldots
\end{aligned}
$$

to 20 decimal places.
As a corollary, if $Y_{t}$ is an Ornstein-Uhlenbeck process (Gauss-Markov process) satisfying

$$
d Y_{t}=-\theta Y_{t} d t+\sqrt{2 \theta} d W_{t}, \quad 0 \leq t \leq T
$$

where $\theta>0$ and $W_{t}$ is Brownian motion with unit variance, then [5]

$$
\sqrt{T} \frac{\frac{1}{T} \int_{0}^{T} \ln \left|Y_{t}\right| d t-\mu}{\eta_{\theta}} \rightarrow N(0,1) \quad \text { as } T \rightarrow \infty
$$

for some constant $\eta_{\theta}>0$. A formula for $\eta_{\theta}$ is proved as follows [7]:

$$
\begin{aligned}
\mathrm{E}\left(\ln \left|Y_{0}\right| \cdot \ln \left|Y_{\ell}\right|\right) & =\sum_{j=0}^{\infty}\left|\int_{-\infty}^{\infty} \ln \right| y\left|f^{(j)}(y) d y\right|^{2} \frac{e^{-j \theta \ell}}{j!} \\
& =\mu^{2}+\sum_{k=1}^{\infty} \nu_{2 k}^{2} \frac{e^{-2 k \theta \ell}}{(2 k)!}
\end{aligned}
$$

because $\operatorname{Cov}\left(Y_{0}, Y_{\ell}\right)=e^{-\theta \ell}$ for real lag $\ell>0$; hence

$$
\begin{aligned}
\operatorname{Var}\left(\frac{1}{\sqrt{T}} \int_{0}^{T} \ln \left|Y_{t}\right| d t\right) & =\frac{1}{T} \int_{0}^{T} \int_{0}^{T} \operatorname{Cov}\left(\ln \left|Y_{t}\right|, \ln \left|Y_{s}\right|\right) d s d t \\
& =\frac{2}{T} \int_{0}^{T} \int_{0}^{t} \operatorname{Cov}\left(\ln \left|Y_{t}\right|, \ln \left|Y_{t-\ell}\right|\right) d \ell d t
\end{aligned}
$$

upon setting $\ell=t-s, d \ell=-d s$ for fixed $t$; hence

$$
\operatorname{Var}\left(\frac{1}{\sqrt{T}} \int_{0}^{T} \ln \left|Y_{t}\right| d t\right)=\frac{2}{T} \int_{0}^{T} \int_{\ell}^{T} \operatorname{Cov}\left(\ln \left|Y_{t-\ell}\right|, \ln \left|Y_{t}\right|\right) d t d \ell
$$

upon reversing the order of integration; hence

$$
\begin{aligned}
\operatorname{Var}\left(\frac{1}{\sqrt{T}} \int_{0}^{T} \ln \left|Y_{t}\right| d t\right) & =\frac{2}{T} \int_{0}^{T} \int_{\ell}^{T} \operatorname{Cov}\left(\ln \left|Y_{0}\right|, \ln \left|Y_{\ell}\right|\right) d t d \ell \\
& =\frac{2}{T} \int_{0}^{T}(T-\ell)\left(\mathrm{E}\left(\ln \left|Y_{0}\right| \cdot \ln \left|Y_{\ell}\right|\right)-\mu^{2}\right) d \ell \\
& =\frac{2}{T} \sum_{k=1}^{\infty} \frac{\nu_{2 k}^{2}}{(2 k)!} \int_{0}^{T}(T-\ell) e^{-2 k \theta \ell} d \ell \\
& =\frac{2}{T} \sum_{k=1}^{\infty} \frac{\nu_{2 k}^{2}}{(2 k)!}\left(\frac{T}{2 k \theta}+\frac{e^{-2 k \theta T}-1}{(2 k \theta)^{2}}\right)
\end{aligned}
$$

and therefore

$$
\begin{aligned}
\eta_{\theta}^{2} & =\lim _{T \rightarrow \infty} \operatorname{Var}\left(\frac{1}{\sqrt{T}} \int_{0}^{T} \ln \left|Y_{t}\right| d t\right)=\frac{1}{\theta} \sum_{k=1}^{\infty} \frac{\nu_{2 k}^{2}}{(2 k)!} \frac{1}{k} \\
& =\frac{1}{\theta} \sum_{k=1}^{\infty} \frac{2^{2 k-2}(k-1)!^{2}}{(2 k)!k}=\frac{1}{\theta} \sum_{n=0}^{\infty} \frac{2^{2 n-1}}{\binom{2 n}{n}(n+1)^{2}(2 n+1)} \\
& =\frac{1}{\theta}\left(\frac{1}{4} \pi^{2} \ln (2)-\frac{7}{8} \zeta(3)\right)=\frac{1}{\theta}(0.81146307722510340753 \ldots)^{2}
\end{aligned}
$$

where $\zeta(s)$ denotes the Riemann zeta function 9. Many analogous central binomial sums appear in [10].
0.2. Nonstationary Case. Since $X_{n} \sim N\left(0, \rho^{2 n}-1\right)$, we deduce that

$$
\begin{aligned}
\mathrm{P}\left(\frac{\ln \left|X_{n}\right|-\mu_{n}}{\sigma} \leq x\right) & =\mathrm{P}\left(\left|X_{n}\right| \leq e^{\sigma x+\mu_{n}}\right) \\
& =\sqrt{\frac{2}{\pi\left(\rho^{2 n}-1\right)}} \int_{0}^{e^{\sigma x+\mu_{n}}} \exp \left(-\frac{y^{2}}{2\left(\rho^{2 n}-1\right)}\right) d y
\end{aligned}
$$

thus

$$
\begin{aligned}
\frac{d}{d x} \mathrm{P}\left(\frac{\ln \left|X_{n}\right|-\mu_{n}}{\sigma} \leq x\right) & =\sqrt{\frac{2}{\pi\left(\rho^{2 n}-1\right)}} \exp \left(-\frac{e^{2\left(\sigma x+\mu_{n}\right)}}{2\left(\rho^{2 n}-1\right)}\right) e^{\sigma x+\mu_{n}} \sigma \\
& =\frac{1}{2} \sqrt{\frac{\pi}{\rho^{2 n}-1}} \exp \left(-\frac{e^{2\left(\sigma x+\mu_{n}\right)}}{2\left(\rho^{2 n}-1\right)}+\sigma x+\mu_{n}\right) \\
& =\frac{1}{2} \sqrt{\frac{\pi}{2}} \exp \left(-\frac{1}{4} e^{2 \sigma x-\gamma}+\sigma x-\frac{\gamma}{2}\right) \\
& =\frac{1}{2} \sqrt{\frac{\pi}{2}} \exp \left(-\frac{1}{4} e^{z}+\frac{1}{2} z\right)
\end{aligned}
$$

where $z=\pi x / \sqrt{2}-\gamma$. Clearly $\left(\ln \left|X_{n}\right|-\mu_{n}\right) / \sigma$ possesses a doubly exponential density function (called a Gumbel density or Fisher-Tippett Type I extreme values density [11]) with mean $=0$, variance $=1$,

$$
\text { skewness }=-\frac{28 \sqrt{2}}{\pi^{3}} \zeta(3)=-1.53514159072290597506 \ldots
$$

and kurtosis $=7-3=4$. Negativity of the third moment above confirms that the distribution is skewed to the left. Closed-form expressions for the quartiles do not exist:

$$
\begin{gathered}
25^{\text {th }} \% \text {-tile }=-0.45782337329420373497 \ldots \\
\text { median }=50^{\text {th }} \% \text {-tile }=0.21732071404060381038 \ldots \\
75^{\text {th }} \% \text {-tile }=0.69796763838144042777 \ldots
\end{gathered}
$$

but the maximum point of the density is easily found:

$$
\text { mode }=\frac{\sqrt{2}(\ln (2)+\gamma)}{\pi}=0.57186419860436852975 \ldots
$$

It is pleasing that, upon subtracting the "trend" from an $\mathrm{AR}(1)$ process, such a nice residual distribution emerges (independent of both $\rho$ and $n$ ).

As a corollary, if $Y_{t}$ satisfies

$$
d Y_{t}=-\theta Y_{t} d t+\sqrt{-2 \theta} d W_{t}, \quad Y_{0}=0, \quad 0 \leq t \leq T
$$

where $\theta<0$, then

$$
\frac{1}{T} \ln \left|Y_{T}\right| \rightarrow-\theta \quad \text { almost surely as } T \rightarrow \infty
$$

and the density of $\left(\ln \left|Y_{T}\right|+T \theta\right) / \sigma$ approaches the same doubly exponential function as before. The proof is immediate.

More generally, consider the nonstationary $\operatorname{AR}(m)$ process

$$
\begin{gathered}
X_{t}=a_{1} X_{t-1}+a_{2} X_{t-2}+\cdots+a_{m} X_{t-m}+b \varepsilon_{t} \\
X_{0}=X_{-1}=\cdots=X_{2-m}=X_{1-m}=0
\end{gathered}
$$

Let $A$ denote the $m \times m$ matrix with $\left(a_{1}, a_{2}, \ldots, a_{m}\right)$ in the top row, 1 s on the subdiagonal and 0 s elsewhere. Order the complex eigenvalues $\lambda_{1}, \lambda_{2}, \ldots, \lambda_{m}$ of $A$ so that $\lambda_{1}$ has maximum modulus. When $\left|\lambda_{1}\right|>1, \operatorname{AR}(m)$ is shown to satisfy [12]

$$
\frac{1}{n} \ln \left|X_{n}\right| \rightarrow \ln \left|\lambda_{1}\right| \quad \text { almost surely as } n \rightarrow \infty .
$$

This occurs, for $m=2$, if and only if $\left|a_{2}\right|>1$ or $\left|a_{1}\right|>1-a_{2}$. An evaluation of the residual distribution remains open.
0.3. Variations. Surely the results given in this paper are not new! A careful literature search was unsuccessful. An example in [3] inspires us to look at the stationary case with $\varepsilon_{t}$ assumed to be $U(-\sqrt{3}, \sqrt{3})$ white noise. Obviously $\mathrm{E}\left(X_{t}\right)=0$ and $\operatorname{Var}\left(X_{t}\right)=1$. When $\rho=0$, it follows that

$$
\mathrm{E}\left(\ln \left|X_{t}\right|\right)=\frac{1}{2} \ln (3)-1 \approx \ln (0.637), \quad \operatorname{Var}\left(\ln \left|X_{t}\right|\right)=1
$$

because each $X_{t}$ is uniformly distributed 1 When $\rho \neq 0$, this fact no longer holds and hence the relevant Central Limit Theorem parameters are not apparent.

We conclude with a recurrence that somewhat resembles Viswanath's:

$$
X_{t}=\rho X_{t-1} \pm \sqrt{\rho^{2}-1}, \quad X_{0}=0
$$

where $|\rho|>1$ and plus/minus signs are equiprobable. While $\mathrm{E}\left(X_{n}\right)=0$ and $\operatorname{Var}\left(X_{n}\right)=\rho^{2 n}-1$ as in the Gaussian nonstationary case, it seems difficult to find $\mathrm{E}\left(\ln \left|X_{n}\right|\right)$ and $\operatorname{Var}\left(\ln \left|X_{n}\right|\right)$, let alone to find the distribution of residuals.
