# Analysis of Lepton Flavor Violating $\tau^{ \pm} \rightarrow \mu^{ \pm} \mu^{ \pm} \mu^{\mp}$ Decays

#### Abstract

Supposing only Lorentz and the gauge invariances of the Lagrangian, we derive energy and angular distributions for $\tau^{ \pm} \rightarrow \mu^{ \pm} \mu^{ \pm} \mu^{\mp}$ lepton flavor violating decay process. Using these results, we discuss methods to determine the parameters associated with the lepton flavor violating interactions.

## 1 Introduction

Lepton flavor violating (LFV) decays, for example, $\mu \rightarrow e \gamma, \tau \rightarrow \mu \gamma, \mu-e$ conversion and $\tau \rightarrow 3 \mu$ are being studied extensively by experimentists [1][4], and by theorists [5]- [8]. Especially, a large number of $\tau$ decay events are collected in B Factories and we hope that LFV decay mode of $\tau$ may be found in the near future. In that case, the Super B Factory [9] might give us the large number of $\tau \rightarrow 3 \mu$ events. We might also hope to observe the energy and polarization distributions.

In $\tau \rightarrow 3 \mu$ decay, we can measure all the energies and directions of the final state muons. For definiteness, let's say that we want to investigate the $\tau^{+}$decay. B Factories generate back to back $\tau^{+} \tau^{-}$pairs. As mentioned in Section 2, the polarization of $\tau^{+}$can be observed statistically by correlation of momenta of decay products of both $\tau^{+}$and $\tau^{-}[10]$. For $\mu^{+} \rightarrow e^{+} e^{+} e^{-}$ process, the differential branching ratio which is a function of energies of 2 positrons in the final state and the polarization of $\mu^{+}$in initial state is already derived in Ref. [5]. The structure of weak interaction which causes the $\mu \rightarrow e \nu \bar{\nu}$ decay was investigated by Michel [11]. He introduced Michel parameters which proved to be very useful. We follow the similar strategies and formulate the method with which we can probe the structure of LFV interactions starting from a general Lagrangian.

The general Lagrangian for $\tau^{+}$decaying to $\mu^{+} \mu^{+} \mu^{-}$supposing Lorentz invariance and gauge invariance is written as:

where $m_{\mu}$ and $m_{\tau}$ are the masses of the $\mu^{ \pm}$and $\tau^{ \pm}$, respectively, $G_{F}$ is the Fermi constant. $\left\{\bar{\tau}_{L}, \bar{\mu}_{L}, \mu_{R}\right\}$ and $\left\{\bar{\tau}_{R}, \bar{\mu}_{R}, \mu_{L}\right\}$ are the Dirac spinors with the helicity operators, $\left(1 \pm \gamma_{5}\right) / 2$, respectively. For example, $\bar{\tau}_{R}=$ $\bar{\tau}\left(1-\gamma_{5}\right) / 2$ and $\mu_{R}=\left(1+\gamma_{5}\right) \mu / 2$. $\sigma^{\alpha \beta}=\frac{i}{2}\left(\gamma^{\alpha} \gamma^{\beta}-\gamma^{\beta} \gamma^{\alpha}\right), D^{\alpha}=\partial^{\alpha}+i e A^{\alpha}$, $F^{\alpha \beta}=\partial^{\alpha} A^{\beta}-\partial^{\beta} A^{\alpha}, A^{\alpha}$ is the photon field and $e=-|e|$ is the electron charge. $\mathcal{L}_{\gamma}$ represents $\tau \rightarrow \mu \gamma$ interaction as well as the terms present in

ordinary QED. These terms generate diagrams in Fig. [1. So, $A_{L}$ and $A_{R}$ are the coefficients of interactions in which the intermediate photon has the left polarization, and the right polarization, respectively. The coefficients $g_{1} \sim g_{6}$ in $\mathcal{L}_{F F}$ are the coefficients of various 4 -Fermi type interactions. These terms generate diagrams in Fig. 2. Using the Fierz transformation, it is shown in the Appendix A that Eq. (1) is the general Lagrangian.

For convenience, we summarize our major results, here assuming that enough events are collected.

1. We have shown that the absolute values of the coefficients $\left|g_{1}\right|^{2} / 16+$ $\left|g_{3}\right|^{2}+\left|g_{2}\right|^{2} / 16+\left|g_{4}\right|^{2},\left|g_{5}\right|^{2}+\left|g_{6}\right|^{2},\left|A_{R}\right|^{2}+\left|A_{L}\right|^{2}, \operatorname{Re}\left[g_{3} A_{L}^{*}\right]+\operatorname{Re}\left[g_{4} A_{R}^{*}\right]$ and $\operatorname{Re}\left[g_{5} A_{L}^{*}\right]+\operatorname{Re}\left[g_{6} A_{R}^{*}\right]$ can be obtained by measuring the energy distributions of decay products of $\tau^{+}$.
2. We have shown that the absolute values of the coefficients $\left|g_{1}\right|^{2} / 16+$ $\left|g_{3}\right|^{2},\left|g_{2}\right|^{2} / 16+\left|g_{4}\right|^{2},\left|g_{5}\right|,\left|g_{6}\right|,\left|A_{R}\right|,\left|A_{L}\right|, \operatorname{Re}\left[g_{3} A_{L}^{*}\right], \operatorname{Re}\left[g_{4} A_{R}^{*}\right], \operatorname{Re}\left[g_{5} A_{L}^{*}\right]$, $\operatorname{Re}\left[g_{6} A_{R}^{*}\right], \operatorname{Im}\left[g_{3} A_{L}^{*}\right]+\operatorname{Im}\left[g_{4} A_{R}^{*}\right]$ and $\operatorname{Im}\left[g_{5} A_{L}^{*}\right]+\operatorname{Im}\left[g_{6} A_{R}^{*}\right]$ can be obtained by measuring the momentum distribution of decay products of $\tau^{-}$in addition to the energy distributions of decay products of $\tau^{+}$.
3. In some suitable cases, we can determine $\left|g_{1}\right|,\left|g_{2}\right|,\left|g_{3}\right|$ and $\left|g_{4}\right|$, independently, and phases $\arg \left[g_{4} A_{R}^{*}\right], \arg \left[g_{3} A_{L}^{*}\right], \arg \left[g_{6} A_{R}^{*}\right]$ and $\arg \left[g_{5} A_{L}^{*}\right]$ as shown in section 9
4. It is interesting to note that there is a possibility that some information on $\tau \rightarrow \mu \gamma$ could be obtained before $\tau \rightarrow \mu \gamma$ decay is measured. For example, $\operatorname{Re}\left[g_{4} A_{R}^{*}\right]$ and $\operatorname{Re}\left[g_{3} A_{L}^{*}\right]$ arise from the interference terms between the four Fermi interaction amplitudes and the $\tau \rightarrow \mu \gamma$ decay amplitudes. The decay rate for $\tau \rightarrow \mu \gamma$ is quadratic in $\left|A_{R}\right|$ or $\left|A_{L}\right|$
while the observables given in $\operatorname{Re}\left[g_{4} A_{R}^{*}\right]$ and $\operatorname{Re}\left[g_{3} A_{L}^{*}\right]$ are linear in $\left|A_{R}\right|$ and $\left|A_{L}\right|$. So the interference effect may be seen before the decay rate for $\tau \rightarrow \mu \gamma$ is seen.

This paper is organized as follows. Section 2 gives the differential branching ratio of $\tau^{+} \rightarrow \mu^{+} \mu^{+} \mu^{-}$decay. Also, a general formula which yields information on the current structure for $\tau^{+} \rightarrow \mu^{+} \mu^{+} \mu^{-}$decay is derived. In section 3, we pick energetic one of the two $\mu^{+} \mathrm{n}$ the final state and analyze its energy dependence. In section 4, we discuss physics implications of our results using only the results of section 3. In section 5, we give the energy dependence of $\mu^{-}$. In section 6, we discuss physics implications of our results using only the results of section 5. In section 7, we discuss physics implications of our results using the results of sections 4 and 6. In section 8, we give $\tau^{+}$polarization dependence of the branching ratio in addition to the energetic $\mu^{+}$energy dependence and analyze the results. In section 9, we discuss physics implications of our results using the results derived until previous section. Section 10 contains the concluding remarks.

## 2 General Formula

In this section, we derive the differential branching ratio for $\tau^{+} \rightarrow \mu^{+} \mu^{+} \mu^{-}$ decay including $\tau^{+}$polarization, and the general formula for the observables which are relevant for the actual experimental situation.

The final state contains two $\mu^{+}$mesons. The one with higher energy is denoted as $\mu_{1}$. The other is denoted as $\mu_{2} . \mu^{-}$is denoted as $\mu_{3}$.

In the real experiment, the processes we want to detect are

where $a$ is a particle which has the charge -1 . So we must calculate the differential cross section for these processes.

Here, we use the center of mass frame of $e^{+} e^{-}$initial state, which we call frame 1. In the rest frame of $\tau^{+}$, which we name frame 3 , the momenta of $\mu_{1}$, $\mu_{2}, \mu_{3}$ and $\tau^{+}$are denoted as $p_{1}=\left(E_{1}, \mathbf{p}_{1}\right), p_{2}=\left(E_{2}, \mathbf{p}_{2}\right), p_{3}=\left(E_{3}, \mathbf{p}_{3}\right)$ and $p_{\tau}=\left(m_{\tau}, \mathbf{0}\right)$, and finally the polarization of $\tau^{+}$is denoted as $s^{+} . s^{-}$denotes the polarization of $\tau^{-}$in the rest frame of $\tau^{-}$. Here, $s^{+} \cdot p_{\tau}=s^{-} \cdot k_{\tau}=0$ and $\left(s^{ \pm}\right)^{2}=-1$ where $k_{\tau}$ is the momentum of $\tau^{-}$in the $\tau^{-}$rest frame which we call frame 2 .

For the definiteness, we set the relations between frame $1,2,3$, as follows and they are depicted in Fig. 3 ,

Frame 1 is the center of mass frame of $e^{+} e^{-}$. Defining the $\tau^{+}$momentum as $\mathbf{p}_{\tau}^{\prime}$ and the initial state positron momentum as $\mathbf{p}_{e^{+}}^{\prime}$, we set the $z$

direction in this frame as the direction of $\mathbf{p}_{e^{+}}^{\prime}, y$ direction is the same as $\mathbf{p}_{e^{+}}^{\prime} \times \mathbf{p}_{\tau}^{\prime}$ and the $x$ direction as $\left(\mathbf{p}_{e^{+}}^{\prime} \times \mathbf{p}_{\tau}^{\prime}\right) \times \mathbf{p}_{e^{+}}^{\prime}$.

Frame 2 is the $\tau^{-}$rest frame. We set the $z$ direction in this frame as the direction of $\mathbf{p}_{\tau}^{\prime}$. The $y$ direction is the same as that of the frame 1 . The $x$ direction id defined by $\left(\mathbf{p}_{e^{+}}^{\prime} \times \mathbf{p}_{\tau}^{\prime}\right) \times \mathbf{p}_{\tau}^{\prime}$.

Frame 3 is the $\tau^{+}$rest frame, We set the directions in this frame are the same as that of the frame 2 .

There are four ingredients that are used to compute the differential cross section for the process shown in Eq. (4).

1. The narrow width approximation where we approximate

is described in appendix B.3.
2. The differential cross section for $e^{+} e^{-} \rightarrow \gamma^{*} \rightarrow \tau^{+}\left(s^{+}\right) \tau^{-}\left(s^{-}\right)$is presented in appendix B. 1 .
3. The differential branching ratio for $\tau^{-}\left(s^{-}\right) \rightarrow \nu_{\tau}+a+$ anything is presented in appendix B.2.
4. The differential branching ratio for $\tau^{+}\left(s^{+}\right) \rightarrow \mu_{1} \mu_{2} \mu_{3}$ is given below.

The differential cross section for this process $d \sigma$ is written as 12

S implies sum over polarizations. $k_{a}$ is the momentum of the particle $a$ in $\tau^{-}$rest frame. The definitions of $\Omega_{\tau}$ and $\psi$ are written in next paragraph.

We have computed the branching ratio for $\tau^{+}\left(s^{+}\right) \rightarrow \mu_{1} \mu_{2} \mu_{3}$ including $m_{\mu}$ dependences. However, for now, we confine our discussion where we can approximate $m_{\mu} / m_{\tau}=0$. The result is

where the definitions of $G_{0}\left(x_{1}, x_{2}\right)$ and $G_{i}^{s}\left(x_{1}, x_{2}\right)$ are written in Appendix C. $\operatorname{Br}(\tau \rightarrow \mu \nu \bar{\nu})$ is the branching ratio of $\tau^{+} \rightarrow \mu^{+} \nu_{\mu} \bar{\nu}_{\tau}$ decay.

Note that $x_{1}, x_{2}$ and $x_{3}$ take values between 0 and 1 , and $x_{1}+x_{2}+x_{3}=2$. $\Omega_{\tau}$ is the solid angle defined in Fig. 4 and $\psi$ is the angle between the $\mathbf{p}_{2}-\mathbf{p}_{3}$ plane and $z-\mathbf{p}_{3}$ plane as defined in Fig. 5. $\mathbf{P}_{i}=\left\{\hat{\mathbf{p}}_{1}, \hat{\mathbf{p}}_{2}, \hat{\mathbf{p}}_{1} \times \hat{\mathbf{p}}_{2}\right\}$ where $\hat{\mathbf{p}}_{1}=\mathbf{p}_{1} /\left|\mathbf{p}_{1}\right|$ and $\hat{\mathbf{p}}_{2}=\mathbf{p}_{2} /\left|\mathbf{p}_{2}\right|$.

Carrying out the summation for $\pm s^{+}$and $\pm s^{-}$using $s_{i}^{ \pm} s_{j}^{ \pm}=\delta_{i j}$, Eq. (8) becomes

This expression is the general formula of the process (4) as long as we stay sufficiently away from singularity at $m_{\mu}=0$. In following sections, we'll start analyzing from this expression.

## $3 G_{0}\left(x_{1}\right)$ : Energy Dependence of $\mu_{1}$

In this section, we derive the formulae convenient for investigating the structure of the LFV four Fermi interactions, using the $\mu_{1}$ energy dependence of the differential branching ratio for $\tau \rightarrow 3 \mu$ decay mode.

Our first priority is to discuss the observable which is easier to detect and analyze. So here, we integrate the polarization dependence as follows.

First, we integrate over $d \Omega d \Omega_{\tau} d \psi$,

Eq. (11) allow us to obtain $G_{0}\left(x_{1}, x_{2}\right)$. It has the arguments $x_{1}$ and $x_{2}$. Even expression, however, is pretty complicated for a discussion here. We thus discuss only the $x_{1}$ dependence integrating over $x_{2}$. For the physical region, we found that the effect of neglecting muon masses in the differential branching ratio for the $\tau \rightarrow 3 \mu$ decay introduces an error of $\mathcal{O}\left(2 m_{\mu} / m_{\tau}\right)$.

Now we define

## 4 Physics from $G_{0}\left(x_{1}\right)$ Distribution of $\mu_{1}$

The conclusion of previous section is how to determine the parameters, $c_{+}$, $J_{1}, \rho_{1 a}, \rho_{1 b}$. Using only these parameters, $a_{+}, b_{+}, d_{+}$and $e_{+}$can't be determined. However, if we take some special cases which are explained bellow, we can restrict the allowed regions of $a_{+}, b_{+}, d_{+}$and $e_{+}$.

### 4.1 What happens if one of $a_{+}, b_{+}, c_{+}, d_{+}, e_{+}=0$

If we impose that one of $a_{+}, b_{+}, c_{+}, d_{+}$and $e_{+}$is zero from other experimental results or supposing some specific models, the results are as follows. When $a_{+}=0$, also $d_{+}=0$ and

### 4.2 Results if either $a_{+} \neq 0, b_{+} \neq 0, d_{+} \neq 0$ or $e_{+} \neq 0$

Similarly, When only $a_{+} \neq 0$,

### 4.3 What happens if $\tau \rightarrow \mu \gamma$ dominates

If $\tau \rightarrow \mu \gamma$ type interaction which has coefficient $c_{+}$is much larger than other interactions, only $c_{+}, d_{+}$and $e_{+}$may be determined since $d_{+}$and $e_{+}$are not quadratic but linier of 4 -fermi type interactions. In this case,

### 4.4 Lower limits of $c_{+}$when $\tau \rightarrow \mu \gamma$ is highly suppressed

We give three types of $c_{+}$lower limits. Especially, these are very useful when $\tau \rightarrow \mu \gamma$ is highly suppressed compared with $\tau \rightarrow 3 \mu$ and $c_{+}$cannot determine directly.

First, we give the relations,

Similarly, when $b_{+} \gg c_{+}$, if $3 J_{1}-3 J_{1} \rho_{1 a}-\frac{22}{9} J_{1} \rho_{1 b}=4\left(a_{+}-2 e_{+}\right)<0$ and no special cancelation between $a_{+}$and $2 e_{+}$, then $a_{+}-2 e_{+}=\mathcal{O}\left(-2 e_{+}\right)$ and $a_{+} \leq \mathcal{O}\left(2 e_{+}\right) \ll b_{+} / 4$. So, using Eq. (236),

If we suppose that $b_{+}=0$ from some special models or other experimental results, we have $c_{+}$lower limit from (23) and (234),

then $e_{+}>0$; and if

0 \leq \frac{\rho_{1 b}}{3-3 \rho_{1 a}-2 \rho_{1 b}} \leq \frac{9}{4} \tag{56}
\end{equation*}
$$

then, from Eq. (33),

-J_{1} \frac{3-3 \rho_{1 a}-2 \rho_{1 b}}{8} \leq e_{+} \leq J_{1} \frac{3-3 \rho_{1 a}-2 \rho_{1 b}}{8} \tag{57}
\end{equation*}

Furthermore, we can determine $e_{+}$allowed region as follows. Using the fact

### 4.6.2 Using information $c_{+}$

We obtain a bound for $e_{+}$using information from $G_{0}\left(x_{1}\right)$ measurement with using information on $c_{+}$.

Similar to previous subsection, from Eq. (14),

So we have another limit of $e_{+}$.

## $5 G_{0}\left(x_{3}\right)$ ：Energy Dependence of $\mu_{3}$

In the previous section，we have discussed how the values of parameters $c_{+}$， $J_{1}, \rho_{1 a}$ and $\rho_{1 b}$ can be obtained from $G_{0}$ but we have not determined the values of $a_{+}, b_{+}, d_{+}$and $e_{+}$．This will be the subject of this section．


Figure 6：The physical region for $\tau^{+} \rightarrow \mu_{1} \mu_{2} \mu_{3}$ is the area which is included in curbed line and besides the right side of the line $x_{3}=2-2 x_{1}$ ．Near the line $x_{1}=1$ ，the differential branching ratio is singular since the intermediate state photon becomes real．

In the previous section，we gave $x_{1}$ dependence for $G_{0}$ ．In this section， to determine the values of $a_{+}, b_{+}, d_{+}$and $e_{+}$，we give $x_{3}$ dependence of differential branching ratio．As in the previous section，we do not discuss the polarizations．For most of the analysis，muon mass dependence can be neglected．But，as we shall see，in some part of the phase space，$m_{\mu}$ dependence must be taken into account．

To study the formula of the $G_{0}$ as function of $x_{3}$ ，we give the following prescription．We can get the $x_{3}$ dependence of $G_{0}\left(x_{1}, x_{2}\right)$ by using $x_{1}+x_{2}+$ $x_{3}=2$ ．From the condition $x_{1} \geq x_{2}$ and the relation $x_{1}+x_{2}+x_{3}=2$ ，

\end{equation*}

So，if all muon masses can be neglected，we have $1 / 2 \leq x_{1} \leq 1$ and $0 \leq x_{3} \leq$ 1 as shown in Fig．6．The integration of $x_{1}$ in the $x_{1}-x_{3}$ plane is given by

When $x_{1}=1$ in massless limit of muons，the photon in Fig．$⿴ 囗 十$ becomes on shell and the propagator becomes singular．This leads a divergence of $x_{1}=1$ in differential branching ratio for $\tau \rightarrow 3 \mu$ decay．

So we have to be more careful with the range of at $x_{1}$ including the muon mass dependence. The on shell constraint $p_{2}^{2}=m_{\mu}^{2}$ leads to

\frac{\delta^{2}}{4}+1-x_{1}-x_{3}+\frac{x_{1} x_{3}}{2}-\frac{1}{2} \hat{\mathbf{p}}_{1} \cdot \hat{\mathbf{p}}_{3} \sqrt{x_{1}^{2}-\delta^{2}} \sqrt{x_{3}^{2}-\delta^{2}}=0, \tag{67}
\end{equation*}

where $\delta \equiv 2 m_{\mu} / m_{\tau}$. The true integration range for $x_{1}$ is given by Eqs. (65) and (67) with $-1 \leq \hat{\mathbf{p}}_{1} \cdot \hat{\mathbf{p}}_{3} \leq 1$ as shown in Fig. 6 . We find it convenient to approximate the domain of integration as $1-\frac{x_{3}}{2} \leq x_{1} \leq 1-\left(\frac{4 \delta}{3}\right)^{2}$. Here, the upper bound of $x_{1}$ is decided as follows. First, we calculate the total branching ratio of $c_{+}$sector integrated on the true physical region in $\mathcal{O}\left(\delta^{2}\right)$. Next, we calculate the total branching ratio of $c_{+}$sector integrated on the approximated region. Finally, we set the approximated upper bound to match these two total branching ratios. This approximation allows us to avoid the divergent region. With this approximation, we give the $x_{3}$ dependence of $G_{0}$ as

G_{0}\left(x_{3}\right)= & \int_{1-\frac{x_{3}}{2}}^{1-\left(\frac{4 \delta}{3}\right)^{2}} d x_{1} G_{0}\left(x_{1}, x_{3}\right) \\
= & \frac{1}{2} J_{3} x_{3}\left\{x_{3}\left(1-x_{3}\right)+\rho_{3 a} x_{3}\left(x_{3}-\frac{2}{3}\right)+\rho_{3 b}\left(x_{3}-1\right)\left(x_{3}-\frac{1}{3}\right)\right\} \\
& +4 c_{+}\left\{2 x_{3}-3 x_{3}^{2}+2\left(2 x_{3}^{2}-2 x_{3}+1\right) \log \left[\frac{3 \sqrt{x_{3}}}{4 \delta}\right]\right\} \tag{68}
\end{align*}
$$

where

$$
\begin{align*}
J_{3} & =\frac{1}{3}\left(12 a_{+}+5 b_{+}+144 d_{+}+36 e_{+}\right) \\
J_{3} \rho_{3 a} & =b_{+}+12 e_{+}  \tag{69}\\
J_{3} \rho_{3 b} & =48 d_{+} .
\end{align*}
$$

First, to determine $c_{+}$, it is convenient to define the function

By choosing the kinematics such that $x_{3} \rightarrow 0$ for the function $F_{3}\left(x_{3}\right)$, we can obtain $c_{+}$as

\end{align*}

where

\left(c_{+}, x_{3} \text { term }\right)=4 c_{+}\left\{2 x_{3}-3 x_{3}^{2}+2\left(2 x_{3}^{2}-2 x_{3}+1\right) \log \left[\frac{3 \sqrt{x_{3}}}{4 \delta^{2}}\right]\right\} \tag{73}
\end{equation*}
$$

From the function $F_{4}\left(x_{3}\right)$, we can obtain the values of $J_{3}, \rho_{3 a}$ and $\rho_{3 b}$ by fitting the experimental data as follows:

In addition to $J_{1}, \rho_{1 a}$ and $\rho_{1 b}$ from previous section, the parameters $a_{+}$, $b_{+}, d_{+}$and $e_{+}$can now be determined. For example,

\end{align*}

From the differential cross section which are the functions of $x_{1}$ and $x_{2}$, $x_{1}$ and $x_{3}$ or $x_{2}$ and $x_{3}$, all we can determine are the quantities $a_{+}, b_{+}, c_{+}, d_{+}, e_{+}$. Now, we will discuss some specific cases in which we can go further.

## 6 Physics from $G_{0}\left(x_{3}\right)$ Distribution of $\mu_{3}$

Similar to the section 4, we have some bounds for $a_{+}, b_{+}, d_{+}$and $e_{+}$from the analysis of previous section.

### 6.1 What can we conclude if one of $a_{+}, b_{+}, c_{+}, d_{+}, e_{+}=0$

If we impose that one of $a_{+}, b_{+}, c_{+}, d_{+}$and $e_{+}$is zero from other experimental results or supposing some specific models, the results are as follows. When $a_{+}=0$, also $d_{+}=0$ and

J_{3} \rho_{3 a} & =b_{+}+12 e_{+}  \tag{76}\\
J_{3} \rho_{3 b} & =0 .

When $b_{+}=0$, also $e_{+}=0$ and

J_{3} & =4\left(a_{+}+12 d_{+}\right) \\
J_{3} \rho_{3 a} & =0  \tag{77}\\
J_{3} \rho_{3 b} & =48 d_{+} .
\end{align*}
$$

When $c_{+}=0$, also $d_{+}=e_{+}=0$ and

J_{3} & =\frac{1}{3}\left(12 a_{+}+5 b_{+}\right) \\
J_{3} \rho_{3 a} & =b_{+}  \tag{78}\\
J_{3} \rho_{3 b} & =0 .

When $d_{+}=0$,

J_{3} & =\frac{1}{3}\left(12 a_{+}+5 b_{+}+36 e_{+}\right) \\
J_{3} \rho_{3 a} & =b_{+}+12 e_{+}  \tag{79}\\
J_{3} \rho_{3 b} & =0
\end{align*}
$$

When $e_{+}=0$,

$$
\begin{align*}
J_{3} & =\frac{1}{3}\left(12 a_{+}+5 b_{+}+144 d_{+}\right) \\
J_{3} \rho_{3 a} & =b_{+}  \tag{80}\\
J_{3} \rho_{3 b} & =48 d_{+} .
\end{align*}
$$

If any one of $a_{+}, b_{+}, c_{+}$or $e_{+}$is zero, we can determine $a_{+}, b_{+}, c_{+}, d_{+}$ and $e_{+}$from only the $x_{3}$ distribution. However, if $d_{+}=0$, then we cannnot determine $a_{+}, b_{+}$and $e_{+}$, independently.

### 6.2 Results if either $a_{+} \neq 0, b_{+} \neq 0, d_{+} \neq 0$ or $e_{+} \neq 0$

Similarly, When only $a_{+} \neq 0$,

$$

J_{3} & =4 a_{+} \\
\rho_{3 a} & =0  \tag{81}\\
\rho_{3 b} & =0 .
\end{align*}
$$

When only $b_{+} \neq 0$,

$$
\begin{align*}
J_{3} & =\frac{5}{3} b_{+} \\
\rho_{3 a} & =\frac{3}{5}  \tag{82}\\
\rho_{3 b} & =0 .
\end{align*}
$$

When only $a_{+}, c_{+}, d_{+} \neq 0$ but $a_{+}$is negligible,

$$
\begin{align*}
J_{3} & =48 d_{+} \\
\rho_{3 a} & =0  \tag{83}\\
\rho_{3 b} & =1 .
\end{align*}
$$

When only $b_{+}, c_{+}, e_{+} \neq 0$ but $b_{+}$is negligible,

$$
\begin{align*}
J_{3} & =12 e_{+} \\
J_{3} \rho_{3 a} & =1  \tag{84}\\
J_{3} \rho_{3 b} & =0 .
\end{align*}
$$

In these case, $\rho_{3 a}$ and $\rho_{3 b}$ are independent from $a_{+}, b_{+}, d_{+}$and $e_{+}$.
The results in subsection 4.2 and here is summed in the table below.

& b_{+} \geq \frac{e_{+}^{2}}{c_{+}}=\frac{1}{c_{+}}\left(\frac{J_{3} \rho_{3 a}}{12}\right)^{2} . \tag{86}
\end{align*}

So, we can determine $a_{+}$and $b_{+}$lower limit, though we can't determine $a_{+}$ and $b_{+}$, directly.

We note here that since the relation $J_{3} \rho_{3 b}=48 d_{+}$is always true, $a_{+}$ lower limit is always determined.

### 6.4 Lower limit of $c_{+}$when $\tau \rightarrow \mu \gamma$ is highly suppressed

We give three types of $c_{+}$lower limits. Especially, these are very useful when $\tau \rightarrow \mu \gamma$ is highly suppressed compared with $\tau \rightarrow 3 \mu$ and $c_{+}$cannot determine directly.

First, we give the relations,

Using Eqs. (87) and (234) and the fact that $a_{+}, b_{+} \geq 0$,

Here, if $c_{+} \ll b_{+}$, then $J_{3} \rho_{3 a}=b_{+}+12 e_{+}=\mathcal{O}\left(b_{+}\right)$and $b_{+} \geq \mathcal{O}\left(\left|12 e_{+}\right|\right)$. So, if $\left(3 J_{3}-5 J_{3} \rho_{3 a}-3 J_{3} \rho_{3 b}\right) / 12 \gtrsim J_{3} \rho_{3 a}$, this means $a_{+}-2 e_{+} \geq \mathcal{O}\left(b_{+}\right)$and then $a_{+}-2 e_{+} \simeq a_{+}$. So, using the relation (234),

$b_{+} \gg c_{+}$and there is no special cancelation between $a_{+}$and $2 e_{+}$, then $a_{+}-2 e_{+}=\mathcal{O}\left(-2 e_{+}\right)$and $a_{+} \leq \mathcal{O}\left(2 e_{+}\right) \ll b_{+} / 6$. So,

\end{equation*}

We note here that $6 a_{+}+b_{+}$is similar to $b_{+}+12 e_{+}$in this situation. So, we have similar result if the denominator of left hand side in Eq. (92), $J_{3}-$ $J_{3} \rho_{3 a}-J_{3} \rho_{3 b}=2\left(6 a_{+}+b_{+}\right) / 3$ is exchanged by $2 J_{3} \rho_{3 a} / 3=2\left(b_{+}+12 e_{+}\right) / 3$.

From (77) and (234), if we suppose that $b_{+}=0$ from some special models or other experimental results,

Similarly, from (76) and (236), if we suppose that $a_{+}=0$ from some special models or other experimental results,

\frac{1}{864} \frac{\left(3 J_{3}-5 J_{3} \rho_{1 a}\right)^{2}}{J_{3}-J_{3} \rho_{1 a}}=\frac{e_{+}^{2}}{b_{+}} \leq c_{+} . \tag{94}
\end{equation*}

### 6.5 A bound for $e_{+}$

### 6.5.1 Without using information $c_{+}$

We obtain a bound for $e_{+}$using information from $G_{0}\left(x_{1}\right)$ measurement without using information on $c_{+}$.

Similarly to the subsection 4.6,

This becomes equation when $b_{+}=0$ and $a_{+}=0$ respectively. So, if

## 7 Physics Implications from $G_{0}\left(x_{1}\right)$ and $G_{0}\left(x_{3}\right)$ Distributions

From the analysis of both of $G_{0}\left(x_{1}\right)$ and $G_{0}\left(x_{3}\right)$ distributions, we can determine not only $a_{+}, b_{+}, c_{+}, d_{+}$and $e_{+}$but also in more detail in some suitable cases as explained in this section.

Introducing new real parameters $\left\{r_{1}, r_{2}, r_{3}, r_{4}, r_{5}, r_{6}, r_{R}, r_{L}\right\} \geq 0$ and $2 \pi>\left\{\theta_{1}, \theta_{2}, \theta_{3}, \theta_{4}, \theta_{5}, \theta_{6}, \theta_{R}, \theta_{L}\right\} \geq 0$, the effective coupling constants can be explained as

## 8 Angular Distribution, $G_{i}^{s}\left(x_{1}\right)$

As we shall see, angular distribution of the particle $a$ in $\tau \rightarrow \nu_{\tau}+a+$ anything will give us information about $a_{-}, b_{-}, c_{-}, d_{-}, e_{-}, f_{+}$and $g_{+}$.

The general formula (9) contains all the information. However, it is too complex to analyze it here. So, we integrate about $d \Omega$ to simplify the formula. Furthermore, we introduce three formulae, which are the general formulae integrated about three kinds of azimuthal angles of the momentum $\mathbf{k}_{a}$ as explained in Figs. 7779 to simplify the formula, respectively. Thanks to this prescription, we obtain three simple formulae which are convenient to analyze here.

Moreover, in some suitable cases, we can determine $\left|g_{1}\right|$ and $\left|g_{3}\right|$ ( also $\left|g_{2}\right|$ and $\left|g_{4}\right|$ ), separately. To separate these are the main purpose of following subsection.

## 9 Physics Implication from $G_{i}^{s}\left(x_{3}\right)$ Distribution of $\mu_{3}$

In sections 3 and 5, we studied that $a_{+}, b_{+}, c_{+}, d_{+}$and $e_{+}$are determined by the energy distribution. In section 图, we also studied that $a_{-}, b_{-}, c_{-}, d_{-}$, $e_{-}, f_{+}$and $g_{+}$are determined by the energy distribution and the angular distribution.

Here, we study some special cases using these parameters. Using Eq. (108), each parameter defined in (157) and (173) are represented as

If the left hand side becomes zero and $a_{+}+a_{-} \neq 0$, then $\sin \left(\theta_{3}-\theta_{L}\right)=g_{1}=0$ and $\left(a_{+}+a_{-}\right) / 2=\left|g_{3}\right|^{2}$. On the other hand, if the left hand side is larger than zero, at least, $\left|g_{3}\right| \sin \left(\theta_{3}-\theta_{L}\right) \neq 0$ or $g_{1} \neq 0$. $\left|g_{3}\right| \sin \left(\theta_{3}-\theta_{L}\right) \neq 0$ means CP violation. $g_{1} \neq 0$ means that the scalar and/or pseudo scalar current exists. Similarly, we make the relation,

If the left hand side becomes zero and $a_{+}-a_{-} \neq 0$, then $\sin \left(\theta_{4}-\theta_{R}\right)=g_{2}=0$ and $\left(a_{+}-a_{-}\right) / 2=\left|g_{4}\right|^{2}$. On the other hand, if the left hand side is larger than zero, at least, $\left|g_{4}\right| \sin \left(\theta_{4}-\theta_{R}\right) \neq 0$ or $g_{2} \neq 0$. $\left|g_{4}\right| \sin \left(\theta_{4}-\theta_{R}\right) \neq 0$ means CP violation. $g_{2} \neq 0$ means the that scalar and/or pseudo scalar current exists.

### 9.3 Existence of $g_{1}$ and/or $g_{2}$, or the Values of $\operatorname{Im}\left[g_{3} e A_{L}^{*}\right]$ and $\operatorname{Im}\left[g_{4} e A_{R}^{*}\right]$

Finally, we have two more relations. First one is

& =r_{L} \sqrt{r_{3}^{2} \sin ^{2}\left(\theta_{3}-\theta_{L}\right)+\frac{r_{1}^{2}}{16}}+r_{R} \sqrt{r_{4}^{2} \sin ^{2}\left(\theta_{4}-\theta_{R}\right)+\frac{r_{2}^{2}}{16}} \\
& \geq r_{3} r_{L}\left|\sin \left(\theta_{3}-\theta_{L}\right)\right|+r_{4} r_{R}\left|\sin \left(\theta_{4}-\theta_{R}\right)\right| \\
& \geq\left|f_{+}\right| . \tag{184}

It becomes an equality when

In that case, from the relation (184) and the conditions (185), $\operatorname{Im}\left[g_{3} e A_{L}^{*}\right]$ and $\operatorname{Im}\left[g_{4} e A_{R}^{*}\right]$ are determined as

& \operatorname{Im}\left[g_{4} e A_{R}^{*}\right]=-\frac{f_{+}}{\left|f_{+}\right|} \sqrt{\frac{a_{+}-a_{-}}{2} \frac{c_{+}+c_{-}}{2}-\left(\frac{d_{+}-d_{-}}{2}\right)^{2}} . \tag{186}

If $f_{+}=0$, it means $\operatorname{Im}\left[g_{3} e A_{L}^{*}\right]=\operatorname{Im}\left[g_{4} e A_{R}^{*}\right]=0$ since $\operatorname{Im}\left[g_{3} e A_{L}^{*}\right] \operatorname{Im}\left[g_{4} e A_{R}^{*}\right] \geq$ 0.

We derive another relation from (178)

& +\frac{1}{16}\left(\left|g_{1}\right|^{2}\left|e A_{L}\right|^{2}+\left|g_{2}\right|^{2}\left|e A_{R}\right|^{2}\right)  \tag{187}\\
& \geq \frac{1}{2}\left\{2 f_{+}^{2}-\left(a_{+} c_{+}-a_{-} c_{-}\right)+\left(d_{+}^{2}+d_{-}^{2}\right)\right\} .

When the equation of (184) is not an equality and $2 f_{+}^{2}-\left(a_{+} c_{+}-a_{-} c_{-}\right)+$ $\left(d_{+}^{2}+d_{-}^{2}\right) \geq 0$, then we can derive, using (185), that $g_{1} \neq 0$ and/or $g_{2} \neq 0$. Furthermore, if $2 f_{+}^{2}-\left(a_{+} c_{+}-a_{-} c_{-}\right)+\left(d_{+}^{2}+d_{-}^{2}\right)>0$, then $\operatorname{Im}\left[g_{3} e A_{L}^{*}\right] \neq 0$ and $\operatorname{Im}\left[g_{4} e A_{R}^{*}\right] \neq 0$ since $\operatorname{Im}\left[g_{3} e A_{L}^{*}\right] \operatorname{Im}\left[g_{4} e A_{R}^{*}\right]>0$. In that case, CP symmetry is violated and the sign of $\operatorname{Im}\left[g_{3} e A_{L}^{*}\right]$ and $\operatorname{Im}\left[g_{4} e A_{R}^{*}\right]$ is the same as that of $-f_{+}$.

## 9.4 $\operatorname{Im}\left[g_{5} e A_{L}^{*}\right]$ and $\operatorname{Im}\left[g_{6} e A_{R}^{*}\right]$

Here, we give the method to determine $\operatorname{Im}\left[g_{5} e A_{L}^{*}\right]$ and $\operatorname{Im}\left[g_{6} e A_{R}^{*}\right]$.
Substituting the relations

the imaginary part of $g_{6} e A_{R}^{*}$ is represented only by the observables as

So, if $g_{+} \neq 0, \operatorname{Im}\left[g_{6} e A_{R}^{*}\right]$ can be determined independently. Similarly, $\operatorname{Im}\left[g_{5} e A_{L}^{*}\right]$ is represented as

Even if $g_{+}=0$,

So we can determine the absolute values of $\operatorname{Im}\left[g_{5} e A_{L}^{*}\right]$ and $\operatorname{Im}\left[g_{6} e A_{R}^{*}\right]$.

### 9.5 What can we say if one of $A_{R}, A_{L}, g_{3}, g_{4}=0$

If we restrict that $A_{R}=0$ from other experiments or some specific models, then

In this case, $\left|g_{3}\right|$ and $\left|g_{1}\right|$ are determined independently. Similarly, if $A_{L}=0$,

\frac{a_{+}+a_{-}}{2}-\left(d_{+}^{2}+f_{+}^{2}\right) \frac{2}{c_{+}-c_{-}} & =\frac{\left|g_{1}\right|^{2}}{16}  \tag{197}\\
\frac{a_{+}-a_{-}}{2} & =\frac{\left|g_{2}\right|^{2}}{16}
\end{align*}

and if $g_{3}=0$,

### 9.6 CP violation

The master formula (9) contains a part,

In this part, each term is proportional to
$\hat{k}_{a z}\left(\hat{\mathbf{p}}_{1} \times \hat{\mathbf{p}}_{1}\right)_{z}, \quad \hat{k}_{a y}\left(\hat{\mathbf{p}}_{1} \times \hat{\mathbf{p}}_{1}\right)_{y}, \quad \hat{k}_{a x}\left(\hat{\mathbf{p}}_{1} \times \hat{\mathbf{p}}_{1}\right)_{x}, \quad \hat{k}_{a x}\left(\hat{\mathbf{p}}_{1} \times \hat{\mathbf{p}}_{1}\right)_{z}+\hat{k}_{a z}\left(\hat{\mathbf{p}}_{1} \times \hat{\mathbf{p}}_{1}\right)_{x}$.

Supposing CPT theorem, time reversal is equivalent to CP transformation. In time reversal, momentum flips their directions. In fact,

In this transformation, (200) flip their signs. This means (199) part in (9) flips its sign. This part proportions to $g_{+}$or $f_{+}$. These coefficients are the imaginary parts of the interactions. So, if they do not vanish, then CP symmetry is violated.

## 9.7 $A_{L}, A_{R} \gg$ others

If $\alpha \operatorname{Br}(\tau \rightarrow \mu \gamma)$ is large compared to 4 -fermi sector of $\operatorname{Br}(\tau \rightarrow 3 \mu)$, here $\alpha$ is the fine structure constant, it may be difficult to determine $\left|g_{1}\right|$ to $\left|g_{6}\right|$
directly from $\tau \rightarrow 3 \mu$. It may be still possible to get a bound for these coupling constant from interference effects as follows.

& \left|g_{5}\right|^{2}=r_{5}^{2} \geq r_{5}^{2} \cos ^{2}\left(\theta_{5}-\theta_{L}\right)=\frac{\left(e_{+}-e_{-}\right)^{2}}{2\left(c_{+}-c_{-}\right)}  \tag{204}\\
& \left|g_{6}\right|^{2}=r_{6}^{2} \geq r_{6}^{2} \cos ^{2}\left(\theta_{6}-\theta_{R}\right)=\frac{\left(e_{+}+e_{-}\right)^{2}}{2\left(c_{+}+c_{-}\right)} \tag{205}
\end{align*}
$$

9.8 $A_{L}, A_{R} \ll$ others

If $\alpha \operatorname{Br}(\tau \rightarrow \mu \gamma)$ is small compared to $\operatorname{Br}(\tau \rightarrow 3 \mu)$, we can still get some lower bounds from the amplitudes of $\tau \rightarrow \mu \gamma$ decay as follows.

& \left|e A_{L}\right|^{2}=r_{L}^{2} \geq \frac{r_{5}^{2} r_{L}^{2} \cos ^{2}\left(\theta_{5}-\theta_{L}\right)}{r_{5}^{2}}=\frac{\left(e_{+}-e_{-}\right)^{2}}{2\left(b_{+}+b_{-}\right)}  \tag{207}\\
& \left|e A_{R}\right|^{2}=r_{R}^{2} \geq \frac{r_{4}^{2} r_{R}^{2} \cos ^{2}\left(\theta_{4}-\theta_{R}\right)}{\frac{r_{2}^{2}}{16}+r_{4}^{2}}=\frac{\left(d_{+}-d_{-}\right)^{2}}{2\left(a_{+}-a_{-}\right)}  \tag{208}\\
& \left|e A_{R}\right|^{2}=r_{R}^{2} \geq \frac{r_{6}^{2} r_{R}^{2} \cos ^{2}\left(\theta_{6}-\theta_{R}\right)}{r_{6}^{2}}=\frac{\left(e_{+}+e_{-}\right)^{2}}{2\left(b_{+}-b_{-}\right)} \tag{209}
\end{align*}

## 10 Concluding Remarks

Neutrino oscillation suggests that, flavor quantum number isn't conserved not only in quark sector but also in neutrino sector. KM ansatz implies that if neutrino sector violate the flavor quantum number, charged lepton sector also do it. In the Standard Model, this violation is too small to determine in any designed futur experiments. However, in some new models, it is suggested that this violation is going to be determine. If $\tau \rightarrow 3 \mu$ event is
detected, there are many models which are suitable to the first experimental result. However, at least, all models without one model is not true. So, if $\tau \rightarrow 3 \mu$ event is detected, our analysis must be necessary to figure out if one model is allowed or forbidden.

We assumed only Lorentz and gauge invariance of the Lagrangian and locality of the action. So, if we cannot fit the data to the differential cross section, it means violation of Lorentz or gauge invariance.

From energy distributions $\left(\left|g_{1}\right|^{2} / 16+\left|g_{3}\right|^{2}\right)+\left(\left|g_{2}\right|^{2} / 16+\left|g_{4}\right|^{2}\right),\left|g_{5}\right|^{2}+\left|g_{6}\right|^{2}$, $\left|A_{R}\right|^{2}+\left|A_{L}\right|^{2}, \operatorname{Re}\left[g_{4} A_{R}^{*}\right]+\operatorname{Re}\left[g_{3} A_{L}^{*}\right]$ and $\operatorname{Re}\left[g_{6} A_{R}^{*}\right]+\operatorname{Re}\left[g_{5} A_{L}^{*}\right]$ can be determined. Using the angular distribution of decaying products of $\tau^{+}$and $\tau^{-}$, we can determine $\left(\left|g_{1}\right|^{2} / 16+\left|g_{3}\right|^{2}\right)$, $\left(\left|g_{2}\right|^{2} / 16+\left|g_{4}\right|^{2}\right),\left|g_{5}\right|,\left|g_{6}\right|,\left|A_{R}\right|$, $\left|A_{L}\right|, \operatorname{Re}\left[g_{4} A_{R}^{*}\right], \operatorname{Re}\left[g_{3} A_{L}^{*}\right], \operatorname{Re}\left[g_{6} A_{R}^{*}\right], \operatorname{Re}\left[g_{5} A_{L}^{*}\right], \operatorname{Im}\left[g_{4} A_{R}^{*}\right]+\operatorname{Im}\left[g_{3} A_{L}^{*}\right]$ and $\operatorname{Im}\left[g_{6} A_{R}^{*}\right]+\operatorname{Im}\left[g_{5} A_{L}^{*}\right]$ independently. We can determine the argument of relative phases, $\arg \left[g_{4} A_{R}^{*}\right]$ and $\arg \left[g_{3} A_{L}^{*}\right]$, if $\operatorname{Im}\left[g_{4} A_{R}^{*}\right]$ and $\operatorname{Im}\left[g_{3} A_{L}^{*}\right]$ have same sign, and if there are no scalar and pseudo scalar interaction. Similarly, we can also determine the argument of relative phases, $\arg \left[g_{6} A_{R}^{*}\right]$ and $\arg \left[g_{5} A_{L}^{*}\right]$, if $g_{+}$is nonzero.

Even if $\tau \rightarrow \mu \gamma$ process is suppressed by a factor of 100 or more than $\tau \rightarrow 3 \mu$ process, we may still estimate the branching ratio of $\tau \rightarrow \mu \gamma$ from these interference:

\frac{\operatorname{Br}(\tau \rightarrow 3 \mu \text { interference })}{\operatorname{Br}(\tau \rightarrow \mu \gamma)} \sim \sqrt{\alpha}\left|\frac{g_{3}+g_{4}+g_{5}+g_{6}}{A_{R}+A_{L}}\right| \gg 1 \tag{210}
\end{equation*}
$$

where $\alpha$ is the fine structure constant. In concrete terms, for instance, even if $\left|e A_{L}\right|^{2}$ is too small to determine directly, we may be still able to get a lower bound $\left(d_{+}+d_{-}\right)^{2} /\left\{2\left(a_{+}-a_{-}\right)\right\}$as explained in subsection 9.8.

First term $\left(\left|g_{1}\right|^{2}+\left|g_{2}\right|^{2}\right)\left(\left|e A_{L}\right|^{2}+\left|e A_{R}\right|^{2}\right) / 16$ has the information about scalar and pseudo scalar currents. Second term $\left|g_{3} e A_{R}-g_{4} e A_{L}\right|^{2}$ has information about parity symmetry. Third term $\left(\operatorname{Im}\left[g_{3} e A_{L}^{*}\right]+\operatorname{Im}\left[g_{4} e A_{R}^{*}\right]\right)^{2}$ has information about CP symmetry.

If $a_{+}=0$, then $r_{1}=r_{2}=r_{3}=r_{4}=0$ and also $d_{+}=0$. Similarly, if $c_{+}=0$, then $r_{R}=r_{L}=0$ and also $d_{+}=0$. In these cases, we can't use interference effect. So, we consider only the case

If $b_{+}=0$, then $r_{5}=r_{6}=0$ and also $e_{+}=0$. Similarly, if $c_{+}=0$, then $r_{R}=r_{L}=0$ and also $e_{+}=0$. In these cases, we can't use interference effect. So, we consider only the case

To write it briefly, we define $s \eta, c \eta, s \phi, c \phi, s \theta, c \theta, s \psi, c \psi, s \xi, c \xi, s \chi$ and $c \chi$ as $\sin \eta, \cos \eta, \sin \phi, \cos \phi, \sin \theta, \cos \theta, \sin \psi, \cos \psi, \sin \xi, \cos \xi, \sin \chi$ and $\cos \chi$, respectively. Also we define the quantities $p_{1}^{\prime}, p_{2}^{\prime}, p_{3}^{\prime}, k_{a}^{\prime}$ as the quantities $p_{1}, p_{2}, p_{3}, k_{a}$ in frame 1. First,
