# X -ray Em ission from O Stars

### Abstract.

Young O stars are strong, hard, and variable X -ray sources, properties which strongly a ect their circum stellar and galactic environments. A fier 1 M yr, these stars settle down to become e steady sources of soft X -rays. I will use high-resolution X -ray spectroscopy and M H D modeling to show that young O stars like  $^1$  O ri C are well explained by the magnetically channeled wind shock scenario. A fier their magnetic elds dissipate, older O stars produce X -rays via shock heating in their unstable stellar winds. Here too I will use X -ray spectroscopy and num erical modeling to con m this scenario. In addition to elucidating the nature and cause of the O star X -ray emission, modeling of the high-resolution X -ray spectra of O supergiants provides strong evidence that m ass-loss rates of these O stars have been overestim ated.

## 1. Introduction

O stars dom inate the X-ray em ission from young clusters, with X-ray lum inosities up to  $L_x = 10^{34}$  ergs s<sup>-1</sup> and em ission that is hard (typically several keV) and often variable. This strong X-ray em ission has an elect on these O stars' environments, including nearby sites of star formation and protoplanetary disks surrounding nearby low-mass premain-sequence stars. The X-ray em ission is also interesting in its own right, as it traces important high-energy processes in the extended atmospheres of O stars. In this paper, I will show how the spectral properties of the X-rays from the prototypical young, magnetized O star, <sup>-1</sup> O ri C are in line with the predictions of the M agnetically Channeled W ind Shock (M CW S) model, but how this process seems to dissipate as O stars age, with weaker line-driven instability wind shocks explaining the X-ray em ission in older O stars. I also will show how the X-ray em ission can be used as a probe of the conditions in the bulk stellar winds of these objects. Speci cally, the resolved X-ray line pro les in normal O supergiants provide an independent line of evidence for reduced m ass-loss rates.

Now, it is certainly the case that m any young O stars do not show the X -ray signatures of the MCW S mechanism. And indeed, only a handfill of O and early B stars have had direct detections of m agnetic elds. Of course, highly structured, non-dipole elds will be very di cult to detect on hot stars, even if their local strength is quite high. But one should keep in m ind that wind-wind interactions in close binaries can also produce the hard, strong, and variable X -rays seen in m any young O stars.

Because <sup>1</sup> O ri C has a wellestablished, predom inantly dipole eld, and because m any of its properties are explained by this eld, I treat it here as a potential prototype. I also note that the incidence of hard, strong X-ray em ission from O stars dim inishes rapidly as one looks from young (< 1 M yr) clusters to older (2 to 5 M yr) clusters. This fact can be explained if the fossil elds in young O stars dissipate as the stars age. If w ind-w ind

binaries account for m any of these sources, then only the very earliest 0 stars with very short lifetim es are involved.

## 2. D ata com parison: high-resolution X -ray spectra

We begin the comparison of young and old O stars and their X -rays by showing in Fig. 1 the Chandra MEG spectra of two representative stars:  $^1$  OriC (O 4-7 V), with an age of 1 M yr, and Pup (O 4 If), with an age of several M yr, and already evolved wello the main sequence. The Pup X-ray spectrum is typical of those measured for most O stars.

Two obvious di erences between these spectra are the hardness of the X -ray em ission from  $^{1}$  O riC and the sm all line widths in that star's spectrum. The hardness im plies a much higher plasm a tem perature in the young O star, and this is best seen in the data when one compares resonance lines of hydrogen-like and helium -like ionization states of abundant elements. In Fig. 1 I have labeled these lines for silicon and m agnesium. In  $^{1}$  O riC the hydrogen-like lines are much stronger, whereas in Pup the helium -like lines are stronger. This rejects a signi cantly di erent ionization balance in these two stars which is a direct e ect of their di erent plasm a tem peratures. The plasm a tem perature distribution, based on the analysis of high-resolution C handra spectra of severalO stars, has been determ ined by W ojdowski& Schulz (2005). These authors assume a continuous D i erential Em ission M easure (DEM ), which can be thought of as a density-squared weighting of the plasm a tem perature distribution. Their results are shown in Fig. 2, where it can easily be seen that the DEM for  $^{1}$  O riC is the only one (of seven O stars) with a positive slope. Its peak is near T = 30 m illion K, whereas the DEM so f the more evolved O stars (including Pup) all peak near one or two m illion K.

We also show in Fig. 2 the DEM from a snapshot of an MHD simulation of the magnetically con ned wind of  $^1$  O riC. The agreement is quite good, both in term softhe overallem ission measure and the shape of the DEM. The simulation shows a peak at 15 to 20 m illion K, modestly lower than that seen in the data, but the main property { a rising DEM up to and beyond 10 m illion K { matches the data well. These MHD simulations con m the predictions of Babel & M ontm erek (1997) that strong shock fronts near the magnetic equator where the wind from the northerm and southerm hem ispheres meets can

heat a signi cant am ount of wind plasm a to the observed high tem peratures. Snapshots of tem perature and em ission measure from an MHD simulation are shown in Fig. 3. It can be seen that the bulk of the shock-heated plasm a is in the magnetically con ned region near r 2 R. Due to this con nem ent, the speed and line-of-sight velocity of this material is low, and thus the em ission lines from the therm al X-ray em ission are relatively narrow.

The head-on nature of the wind shocks leads to high shock velocities and tem peratures. In these M HD models, the eld conguration is self-consistently solved for along with the wind dynamics. Note that another di erence between the M HD simulations of the M CW S model and the initial analysis of B abel & M ontmerel (1997) is the dynamical infall of material from the magnetic equator. Evidence of this can be seen in the snake-like structure visible in the em ission measure panel, just above the star's surface, slightly below the equator.

In contrast, the X-ray emission lines of mature O stars, like Pup, are quite broad, as can be seen in Fig. 4, where I show the neon Ly lines for the two stars. The X-

ray spectrum of Pup is also soft, as I have already shown. The X-ray em ission from these older, presumably non-magnetized, O stars is thought to arise in much milder wind shocks, embedded in the out owing, highly supersonic line-driven winds. The Line-D riven Instability (LD I) is generally thought to produce these shocks, although models have diculty reproducing the overall level of X-ray emission unless the instability is seeded, perhaps by sound waves injected at the base of the wind (Feldmeier et al., 1997). The softness of the X-ray spectra, along with the large line widths from the high velocity of the shock-heated wind, is well explained by this LD I wind-shock scenario, as I show in Fig. 5. This gure shows a snapshot from a 1-D radiation hydrodynamics simulation of the wind of an O supergiant like Pup, accounting for non-local line radiation transport. The instability grows rapidly beyond about half a stellar radius (in height; r = 1.5 R). Shock fronts can be seen in this snapshot, but they typically have velocities of only a few hundred km s  $^1$ , leading to heating of only a few million K. The soft spectra seen in Fig.

1 and the DEM s weighted to low plasm a tem peratures, shown in the left-hand panel of Fig. 2, are in line with the results of this simulation.

The predictions of this model can be further tested by examining the X-ray emission line proles, which have a characteristic asymmetric, skewed shape, as can be seen in the right-hand panel of Fig. 4. This shape, with a decit of red-shifted photons, arises in a spherically expanding wind with hot, line-emitting material intermixed with warm, continuum -absorbing material, as motivated by the global structure seen in Fig. 5. If the wind is optically thick (in the continuum; constant across a line), then there is signi cantly more attenuation of emission from the back of the wind, which is the red shifted portion. And there is comparatively more emission from the front, blue shifted, less attenuated, side. In Fig. 6 I show a schematic demonstrating a simple, empirical wind line prolemodel that I use to t the data.

The units of the axis labels are stellar radii. N ote that the em ission starts half a stellar radius above the surface of the star (which can be seen as a white circular outline), and its intensity falls o with radius. The absorption properties of the dom inant, cool wind component in this model are represented by the three white contours of constant optical depth (again, for an observer on the left). The em ission line prole that results from this particular model realization is shown (at in nite resolution) in the right-hand panel. N egative values of the scaled wavelength correspond to blue shifts. The e ect of the continuum opacity on the skewed line prole can be clearly seen. Note that most of the red-shifted, back side of the stellar wind su ers at least one optical depth of attenuation.

I tan empirical model (O wocki & Cohen, 2001) to emission lines in the spectrum of Pup and get good ts by adjusting only three parameters: the normalization, the inner radius below which there is assumed to be no emission ( $R_{\circ}$ ), and the wind optical depth (parameterized by the quantity  $M_{-}$  =4 R  $v_{1}$ ). The tto the Fe xvii line at 15.014 A is typical and is shown in Fig. 7 as the red dashed histogram. The t is formally good, and the best-t values with joint 68% parameter condence limits are  $R_{\circ} = 1.53^{+0.12}_{-0.15}$  R and = 2.0 0.4.

## 3. Evidence for a low ered m ass-loss rate

The R<sub>o</sub> derived from the prole is consistent with the onset of the self-excited instability seen in the hydrodynam ics simulation shown in Fig. 5. The optical depth consistent with the data is actually quite small, which can be seen qualitatively in the relatively modest asymmetry. The mass-loss rate of 6 10 <sup>6</sup> M yr <sup>1</sup> derived from H emission (Puls et al., 1996) im plies = 8. The best-tmodel with that value xed is shown in Fig. 7 as the blue solid histogram. The t is form ally very poor. Thus it would appear that the X-ray line proles provide independent evidence that mass-loss rates of 0 stars must be revised downward by a factor of several; a factor of 4 for this star, according to this particular line ( = 2:0 0:4 vs. = 8).

It has been suggested that porosity associated with large-scale clumping { rather than reduced m ass-loss rates { can account for the surprisingly sm all degree of asym m etry in the observed X-ray em ission line pro les in O stars (O skinova et al., 2006). By tting the line pro le model, modi ed for the e ects of porosity produced by spherical clum ps (Owocki& Cohen, 2006), I can quantify the trade-o between atom ic opacity and porosity (see also Cohen et al., 2008). In Fig. 8 I show the best-t porous model with = 8, thevalue in plied by the literature mass-loss rate, and with the porosity length, h '=f, free to vary. Here ' is the clump size and f is the volume lling factor of the clumps. The porosity length, h, completely describes the e ects of porosity on line pro les and in the lim it of sm all clum ps it is equivalent to the interclum p spacing. The best-t porous m odel with the literature mass-loss rate is nearly indistinguishable from the best-t non-porous model, although the t quality is form ally not as good. M ore importantly, it requires a term inal porosity length (the value of h in the outer portion of the wind) of at least  $h_1 = 2.5 \text{ R}$  (68% con dence), as shown in the right-hand panel of Fig. 8. Even ignoring the worse quality of the porous model ts, the very high values of the porosity length required to t the data are vastly larger than the porosity lengths seen in state-of-the-art 2-D radiation hydrodynamics simulations, which show LD I-induced structure down to

the grid scale (D essart & O wocki, 2005). Therefore, I conclude that there is no com pelling evidence that porosity explains the modestly asymmetric X-ray line proles in Pup. Rather, these proles provide independent evidence for a reduced mass-loss rate.

### D iscussion

K udritzki: It is very important to repeat the observing experiment that you have done for theta-1 O riC for young O stars, which are more massive and lum inous than theta-1 O riC. I speculate that for those objects, the magnetic focusing of the stellar winds will be less e ective, because the winds are stronger and the ratio of magnetic to mechanical wind energy is lower. I think it is really crucial to do such observations. C ohen: I agree. The degree of channeling and con nem ent, how ever, goes as B<sup>2</sup> but only as 1/M -dot, so the extent of channeling and con nem ent in any given star is more likely to be dom inated by trends in magnetic eld strength, which we don't understand, than by trends in m ass-loss rate associated with stellar m ass and lum inosity. I think the key m easurem ents to m ake in order to test the idea that the M CW S mechanism on thetal O riC is a paradigm for X-ray em ission in young O stars would be Zeem an measurem ents of elds on the massive cluster stars that are known to be strong, hard X-ray sources. H igh-resolution X-ray spectroscopy would also be very useful, obviously, if it's feasible. As I discussed in my talk in the special session on magnetic massive stars on Sunday, line widths and helium-like forbidden-to-intercom bination line strength ratios provide inform ation beyond what's provided by CCD-based (e.g. Chandra AC IS or XM M EP IC) X-ray data.

Zinnecker: My question refers to theta-1 Ori C and the origin of the obliquity between its rotational axis and magnetic eld axis. From star formation theory it would seem an aligned magnetic rotator would be expected. Any suggestions to explain the misalignment?

C ohen: I don't have any special expertise in star form ation theory, but if models predict aligned rotation and m agnetic axes, then there must be some important physics m issing from them . M any of the m agnetic m assive stars have highly m isaligned axes: tau Sco, beta Cep, and sigm a O riE, for example, are all close to = 90 degrees.

Skinner: A new paper appearing in the journal Science this week by M.Gudel et al. (2007) reports the rst detections of hot (1 to 2 M K) di use X-ray emission in the extended O rion Nebula. This article argues that massive Trapezium O stars (and their shocked winds) are ultimately responsible for the di use X-ray emission detected by XMM-Newton.

C ohen: I think that the problem of heating the di use, X -ray em itting plasm a in m assive star clusters is a hard one. The shocked wind (such as zeta Pup's) will adiabatically cool over distances much less than 1 pc. And the morphology of the X -rays isn't what you'd expect from the wind slamming into dense interstellar gas at the boundaries of these cavities.

W alborn: There are currently only two O stars with observed m agnetic elds, theta-1 O riC and HD 191612. The latter can be understood as a spun-down version of the form er, with a rotational period of 538 d (vs. 15 d for theta-1 O riC), a soft X -ray spectrum, and an age of 3 to 4 M yr. N evertheless, it is a very unusual object, with a very peculiar spectrum and extrem e, periodic spectral variations. So these two stars are inconsistent with your hypothesis that theta-1 O riC is a typical very young O star, and that m agnetic elds have disappeared at 5 M yr. I think that both of these objects are unusual areas of large fossil elds. An alternate interpretation of your cluster X -ray di erences m ight be di erent frequencies of wind-wind collision binaries.

Cohen: W hile I agree than wind-wind collision binaries may make a signi cant contribution to the observed population of hard, strong X-ray sources in young clusters, I think we need more information about the highly unusual O star, HD 191612, not to mention more positive detections or strong upper limits to magnetic eld strengths in other O stars, both young and old. The X-ray spectrum of HD 191612 looks like that of a typical, older O star, with very broad lines and an SED that is quite soft. Perhaps the elds of young O stars like theta-1 O ri C become more spatially structured as they evolve. It's possible that HD 191612 has a eld that looks more like that of tau Sco and is not dom inated by a large scale dipole. If that's the case, then there m ay not be any large-scale con nem ent and channeling of the stellar wind, and no substantial M CW S m echanism . The X-ray emission m ay instead arise in open eld regions, in a loose analogy to the solar wind and coronal holes.
