Entanglem ent entropy, conform al invariance and extrinsic geom etry

Abstract

W e use the conform al invariance and the holographic correspondence to fully specify the dependence of entanglem ent entropy on the extrinsic geom etry of the 2d surface that separates two subsystems of quantum strongly coupled N = 4 SU (N) superconform al gauge theory. We extend this result and calculate entanglem ent entropy of a generic 4d conform all eld theory. As a byproduct, we obtain a closed-form expression for the entanglem ent entropy in at space-time when is sphere S₂ and when is two-dimensional cylinder. The contribution of the type A conform all anom aly to entanglem ent entropy is always determined by topology of surface while the dependence of the entropy on the extrinsic geometry of is due to the type B conform all anom aly.

1 Introduction

Entanglement entropy is a well-de ned measure of the quantum correlations between two subsystems separated by a surface . Since the correlations are short-range the entropy is essentially determined by geometry, both intrinsic and as an embedding into a larger space-time, of the surface . The recent studies revealed the important role the entanglement entropy plays in the physics of black holes and in the quantum eld models [1]-[17]. An important element of the present understanding is the holographic interpretation of entanglement entropy [18], [19]. This interpretation suggests a purely geometric way of computing the entropy of a strongly coupled conformal eld theory [20]-[24].

In this note we give a derivation of entanglem ententropy of a generic four-dimensional conformal eld theory based on the conformal properties of the theory. Our approach is partially motivated by work of Dowker [25]. In particular, we suggest that, in the large N limit, the entanglement entropy calculated in a four-dimensional N = 4 SU (N) superconformal gauge theory, the quantum eld theory counterpart in the holographic duality, is given by expression

where A () is area of , R is the Ricci scalar of four-dimensional metric g, $R_{aa} = P_{i=1}^2 R_n_a n_a$ is projection of the Ricci tensor onto the subspace orthogonal to surface , n_a ; a = 1; 2 is a pair of unite vectors orthogonal to the surface . k_a is the trace of the second fundamental form $k^a = r n^a$, where $= g n^a n^a$ is the induced metric of . is an UV cut-o needed for regularization of the theory on curved background.

The logarithm ic term in (1.1) is invariant under generic conformal transformations, g ! e ^{2!}g , in particular under those with non-vanishing normal derivatives of ! on . The term k^ak^a in (1.1) takes care of the invariance under these particular transformations.

The function s_{sc} (g) in (1.1) is the UV nite part of the entropy. Under global rescaling of the metric, g ! ²g, this function changes as

Thus, the logarithm ic term in (1.1) and (1.2) is due to the integrated conformal anomaly. This aspect will be clarified below. The property 1.2) is particularly useful if the configuration of surface in 4d space-time is characterized by only one dimensionful parameter, a. Then, rescaling the 4d metric and using (1.2) one can determ ine the dependence of the entropy on this parameter. The logarithm ic term in entanglement entropy of a black hole was obtained in [6] and further studied in [7], [9], [11], [10].

The expression (1.1) is general in that it gives the entropy for all possible choices of surface . In particular, can be a black hole horizon. The extrinsic curvature k^a ; a = 1;2 vanishes in this case. The other possible choice of is any compact surface in curved space-time. Of a particular interest is a surface in at space-time. Then, the logarithm ic contribution to the entropy is given entirely by the extrinsic curvature of .

The entropy (1.1) has a holographic interpretation. In fact, the holographic origin of the logarithm ic term was already veried in [9] in the no black hole case and in [2] for a

black hole horizon. In both cases the extrinsic curvature of assumed to be zero². Thus, a goal of this note is to single out the important contribution of the extrinsic curvature to the logarithm ic term in (1.1). The holographic interpretation of entanglement entropy was questioned recently in [27]. Below we comment on this.

That entanglem ent entropy may depend on the extrinsic curvature of was earlier suggested in [12] based on the heat kernel analysis of D ow ker [25].

2 Replica method, singular surface and the conformal structure of e ective action

The most e cient m ethod to compute entanglem ententropy is to introduce at the surface a conical singularity of sm all angle de cit = 2(1), compute the e ective action

W (E) on a manifold E with a singular surface and then apply the formula

and obtain the entanglement entropy. Explanation of this method is available in papers [4], [15].

In this note we are interested in entanglem ent entropy of a four-dimensional conform al eld theory. The elective action then has a general structure

The term sa_0 and a_1 , representing the polynom ialUV divergences, are not universal while the term a_2 is universal and is determined by the integrated conformal anomaly. w (g⁽⁾) is the UV nite part of the elective action. Under a global rescaling of the 4d metric on E, g⁽⁾! ²g⁽⁾, one has

It is proved (see [33] and references therein) on a rather general grounds that for a generic manifold and a generic conformal eld the corresponding coe cient a_2 is conformal invariant, $a_2 [e^{2!}g] = a_2 [g]$. This is an important property that plays a key role in our consideration.

On 4d m an ifold with a singular surface the coe cients a_1 and a_2 have both the bulk part and the surface part. To rst order in (1) one nds that

with constant C depending on the UV regularization scheme. In this note we use normalization $C = \frac{1}{16^{-2}}$. Coe cients a_2^{bulk} (E) and a_2 () are respectively the integrated bulk

and surface conform all anom alies. Under a conform all transform at ion $g ! e^{2!} g$ one has that

In four dimensions the bulk conform alanom aly is a combination of two terms, the topologicalEuler term and the square of the Weyl tensor,

These are respectively the conform all anomalies of type A and B. The surface contribution to the conform all anomaly can be calculated directly by, for example, the heat kernelm ethod as in [28]. The direct computation although straightforw and is technically involved. One has how ever a short cut: there is a precise balance, observed in [6] and [8], between the bulk and surface anomalies, this balance is such that to rst order in (1) one can take $a_2 (E) = a_2^{bulk} (E) + O(1)^2$ and use for the Riem ann tensor of E the representation as a sum of regular and singular (proportional to a delta-function concentrated on surface) parts. The precise expressions are given in [3], [26]. This representation, how ever, is obtained under the assumption that the surface has the extrinsic curvature vanishing. Under this assumption one nds that [3], [26]

Each surface term in (2.9) is invariant under a sub-class of conform altransform ations, $g ! e^{2!}g$, such that the norm alderivatives of ! vanish on surface . The surface term due to the bulk Euler number is, moreover, a topological invariant: using the G auss-C odazzi equation (A.5) and in the assumption of vanishing extrinsic curvature this term, as shown in [26], is proportional to the Euler number of the 2d surface ,

where R is intrinsic curvature of .

As we discussed above the coe cient a_2 is conform al invariant and thus it should be invariant under arbitrary conform al transform ations. The equation (2.9) is however invariant under a specience subclass of the conform altransform ations, those with the norm all derivatives vanishing on . This is because the term s depending on the extrinsic geometry are neglected in (2.9). Such term s however become very important for the invariance of a_2 on manifold with a \squashed conical singularity" (in the term inology of D ow ker [25]) that has a structure of the product of a conical metric and the surface scaled by an arbitrary conform al factor.

Thus, our goal in this section is to nd a modi cation of 2(.9) that would be invariant under a generic conform altransform ation with the norm alderivatives of ! non-vanishing on . A generalization can be easily found with the help of form ulae (A.4), (A.5) and (A.6) presented in Appendix.

The term s with the normal derivatives of ! in the conformal transformation of a_2 then can be cancelled by adding the quadratic combinations of extrinsic curvature, trk^2 and k_ak_a . We notice that the conformal covariant combination ($trk^2 = \frac{1}{2}k_ak_a$) always can be added with a numerical pre-factor, to be further specified. Additionally to the requirement of the conformal invariance we demand that the surface term in the anomaly determined by the Euler number to be topological invariant (2.10) even if the extrinsic curvature of is non-vanishing. This latter condition completely was the conformal covariant part in a_A . One then obtains

The method used in this section to determ ine a_2 is that of D owker [25]. The value of can not be determ ined by the conformal invariance. In section 4 we use the holographic correspondence in order to specify ³.

The surface anom alies have been recently studied in [27] and a non-conform al invariant form of the type A anom aly has been found. A lthough this issue requires a further analysis we note that, as equations (2.8) and (2.11) indicate, a simple form of the decom position, like the one used in the cohom ological analysis of [27], of the R iem ann tensor on E on regular and singular parts is likely not valid when the extrinsic curvature of is non-vanishing.

3 Entanglem ent entropy of N = 4 SU (N) super Y ang-M ills theory

Provided the value of constant in (2.11) is determined (this will be done in section 4) the result (2.11) can be used to calculate the entanglement entropy of any conformal

eld theory in four dimensions. In this section we consider a particular conformal eld theory that has a holographic dual description in terms of the gravity on anti-de Sitter space-time.

In the large N lim it the N = 4 SU (N) superconform algauge theory is characterized by the conform al anomaly, computed holographically in [29], that takes the form (2.8) with

A swe show in the next section the holographic correspondence predicts value = 1. With this value the entropy of the superconform all gauge theory is given by (1.1) as announced in the introduction.

4 The holographic calculation

In the holographic duality the quantum eld theory is placed on a regularized boundary (param etrized by) of ve-dimensional anti-de Sitter space-time. The 2d surface that separates two subsystems in the entanglement entropy calculation is, thus, de ned on the regularized boundary. The parameter plays the role of the UV cut-o on the quantum

eld theory side. A coording to the proposal of R yu and Takayanagi [8], [19] in the anti-de Sitter space-time one considers a minimal 3d surface which bounds the surface . The quantity

where G_N is ve-dimensional Newton's constant, then is equal to entanglement entropy (3.3) in the boundary quantum conformal eld theory. This proposal has been veried in many particular cases and there are reasons why it should be valid in general [21]. In this section we use this holographic interpretation in order to determ in the parameter in (3.2) and (2.11).

To simplify things, we consider the case of at four-dimensional space-time. Then the logarithm ic term in the entropy (3.2) or (4.1) is entirely due to the extrinsic curvature of

. We note that in at space-time $R = k_a k_a$ trk², as follows from (A.5).

The result of the holographic calculation (4.1) can be presented in general form

where ".." stands for the nite part and we use that in the holographic correspondence $\frac{1}{G_N} = \frac{2N^2}{2}$. We further consider two choices of surface , a two-dimensional cylinder and

sphere S_2 , determ ine the constants and and then compare (4.2) with (3.3), (3.2) to determ ine value of parameter .

Generally, the holographic calculation of the logarithm ic term in (3.3), (4.2) is related to the surface anomalies studied by G raham and W itten [30] (see also [31] and [32]).

Two-dimensional cylinder. We choose the AdS metric in the form (and x AdS radius l=1)

A lthough expression (4.7) is asymptotic the nite part in (4.7) can be easily restored. Indeed, the metric (4.3) is invariant under rescaling, $!^2$, t!, z!, z and r! r. This invariance determines, up to an additive numerical constant, the nite part. Thus, the holographic entropy in the case of cylinder is

In order to compare this to (4.2) we have to know the extrinsic curvature of the cylinder. In at space-time one of the normal vectors to surface is timelike, $\frac{1}{1} = 1$. The corresponding extrinsic curvature vanishes. The other normal vector is $n_2^r = 1$. It has the only non-vanishing component of the extrinsic curvature $k^2 = a$. Thus, one has that

5 Generic 4d conform al eld theory

The result (1.1) for entanglement entropy is easily generalized for a generic conformal

eld theory in four dimensions. The conform al anom aly of such a theory is a combination of the type A and type B anom alies, the surface term taking the form (2.11) with value of parameter = 1, already determ ined in section 4 by using the holographic correspondence. Entanglem ent entropy of the theory is then given by (2.7),

where a_A and a_B are given by (2.11) (with = 1). The contribution of the type A anomaly is always determined by topology of surface while the dependence of the entropy on the extrinsic geometry of is due to the type B anomaly.

In at space-time only the extrinsic curvature contributes to a and one has that

where $R = k_a k_a$ trk² in at space-time. The nite part $g_{i,B}$ in (5.2) can be determined, using the rescaling property of $s_{(A,B)}$, for some geometries, in particular for sphere S_2 and the two-dimensional cylinder. Using the expressions, obtained in section 4, for the extrinsic curvature of these two surfaces in at space-time one nds that the entanglement entropy of a generic CFT in the case of cylinder is

in the case of sphere S_2 . Thus, these two geometries single out two dimensions of conform alanom aly in the calculation of entanglem ententropy.

6 Conclusions

The dependence of entanglem ent entropy on the extrinsic geom etry of the surface that separates two subsystems is a missing element in the previous study of entanglem ent entropy (see, how ever, [12] for an earlier discussion). In particular, the extrinsic geom etry plays an important role in the entanglem ent entropy calculation in at space-time. In this paper we use the conform all symmetry and the holographic correspondence and fully specify the way the extrinsic curvature appears in entanglem ent entropy. The case of the conform all eld theory dual to a gravity on anti-de Sitter space-time is considered in detail. We extend this consideration to a generic conform all eld theory in four dimensions. In particular, we obtain a closed-form expression for entanglem ent entropy of a generic CFT in the case when is a two-dimensional cylinder and when is two-dimensional sphere. We specify the way the type A and the type B conform all anom alies show up in the entanglem ent entropy.
