Analysis of the B ! a₁ (1260) form-factors with light-cone QCD sum rules

A bstract

In this article, we calculate the B ! a_1 (1260) form -factors V_1 (q^2), V_2 (q^2), V_3 (q^2) and A (q^2) with the B -m eson light-cone QCD sum rules. Those form - factors are basic parameters in studying the exclusive non-leptonic two-body decays B ! AP and sem i-leptonic decays B ! Al₁, B ! All. Our num erical results are consistent with the values from the (light-cone) QCD sum rules. The main uncertainty comes from the parameter !₀ (or _B), which determines the shapes of the two-particle and three-particle light-cone distribution am plitudes of the B -m eson, it is of great in portance to re ne this parameter.

1 Introduction

The weak B ! P;V;A form -factors with P = ;K, V = ;K and A = a_1 ;K nal states are basic input parameters in studying the exclusive sem i-leptonic decays B ! P (V; A) l 1, B ! P (V; A) ll and radiative decays B ! V (A) , they also determ ine the factorizable amplitudes in the non-leptonic charm less two-body decays B ! PP (AP; PV; VV). Those decays can be used to determ ine the CKM matrix elem ents and to test the standard m odel, how ever, it is a great challenge to pin dow n the uncertainties of the form -factors to obtain more precise results. The exclusive sem i-leptonic decays B ! P (V) l 1, B ! P (V) ll and radiative decays B ! V and hadronic two-body decays B ! P P (P V;V V) have been studied extensively [1, 2, 3, 4, 5, 6, 7], while the decays B ! AP; VA have been calculated with the QCD factorization approach [8, 9, 10], generalized factorization approach [11, 12], etc. It is more easy to deal with the exclusive sem i-leptonic precesses than the nonleptonic precesses, and there have been many works on the relevant form -factors , B ! in determining the CKM matrix element V_{ub} [13, 14, 15, 16]. в! a₁ (1260) form -factors have been studied with the covariant light-front The B ! approach [17], ISGW 2 quark model [18], quark-meson model [19], QCD sum rules [20], light-cone QCD sum rules [9] and perturbative QCD [21]. How ever, the values from dierent theoretical approaches dier greatly from each other.

The BaBar Collaboration and Belle Collaboration have measured the charm less hadronic decays B^0 ! a_1 [22, 23]. Moreover, the BaBar Collaboration has

m easured the time-dependent CP asymmetries in the decays B^0 ! a_1 with a_1 ! , from the measured CP parameters, we can determ ine the decay rates of a_1^+ and a_1^- respectively [24]. Recently, the BaBarC ollaboration has reported the observation of the decays B ! a_1^0 ; $a_1^ ^0$, B^+ ! a_1^+ K 0 and B^0 ! a_1 K $^+$ [25, 26]. So it is interesting to re-analyze the B ! a_1 form-factors with the B-m eson light-cone QCD sum rules [27].

In Ref.[27], the authors obtain new sum rules for the B ! ;K; ;K form – factors from the correlation functions expanded near the light-cone in terms of the B -m eson distribution am plitudes, and suggest QCD sum rules motivated models for the three-particle B -m eson light-cone distribution am plitudes, which satisfy the relations given in Ref.[28]. In Ref.[28], the authors derive exact relations between the two-particle and three-particle B -m eson light-cone distribution am plitudes from the QCD equations of motion and heavy-quark symmetry. The two-particle B -m eson light-cone distribution am plitudes have been studied with the QCD sum rules and renorm alization group equation [29, 30, 31, 32, 33, 34, 35]. A lthough the QCD sum rules can't be used for a direct calculation of the distribution am plitudes, it can provide constraints which have to be im plemented within the QCD motivated models (or parameterizations) [32].

The B-m eson light-cone distribution amplitudes play an important role in the exclusive B-decays, the inverse m on ent of the two-particle light-cone distribution amplitude $_+$ (!) enters m any factorization form ulas (for example, see Refs.[3, 4]). However, the light-cone distribution amplitudes of the B-m eson are received relatively little attention comparing with the ones of the light pseudoscalar m esons and vector m esons, our know ledge about the nonperturbative parameters which determ ine those light-cone distribution amplitudes is limited and an additional application (or estimation) based on QCD is useful.

In this article, we use the B-m eson light-cone QCD sum rules to study the B ! a_1 form-factors. The sem i-leptonic decays B ! Al₁ can be observed at the LHCb, where the bb pairs will be copiously produced with the cross section about 500 b.

W e can also study the form -factors with the light-cone QCD sum rules using the light-cone distribution amplitudes of the axial-vector m esons. Recently, the twist-2 and twist-3 light-cone distribution amplitudes of the axial-vector m esons have been calculated with the QCD sum rules [36].

The B-m eson light-cone QCD sum rules have given reasonable values for the B ! ;K ; ;K form-factors [27], so it is interesting to study the B ! a_1 form-factors and cross-check the properties of the B-m eson light-cone distribution amplitudes. Furtherm ore, it is necessary to investigate the form-factors with di erent approaches and compare the predictions of di erent approaches.

The article is arranged as: in Section 2, we derive the B ! a_1 (1260) form -factors with the light-cone QCD sum rules; in Section 3, the num erical result and discussion; and Section 4 is reserved for conclusion.

2 B ! a₁ (1260) form -factors with light-cone QCD sum rules

In the following, we write down the de nitions for the weak form -factors $V_1(q^2)$, $V_2(q^2)$, $V_3(q^2)$, $V_0(q^2)$ and A (q^2) [17],

 $V_0(0) = V_3(0)$, and the is the polarization vector of the axial-vector meson $a_1(1260)$. We study the weak form -factors $V_1(q^2)$, $V_2(q^2)$, $V_3(q^2)$, $V_0(q^2)$ and $A(q^2)$ with the two-point correlation functions ⁱ (p;q),

where $J^{i}(x) = J(x)$ and $J^{A}(x)$ respectively, and the axial-vector current $J^{a}(x)$ interpolates the axial-vector m eson a_{1} (1260). The correlation functions i (p;q) can be decomposed as

due to Lorentz covariance. In this article, we derive the sum rules with the tensor structures g , q p and p q respectively to avoid contam inations from the m eson.

A coording to the basic assumption of current-hadron duality in the QCD sum rules approach [37, 38], we can insert a complete series of intermediate states with the same quantum numbers as the current operator $J^{a}(x)$ into the correlation functions

ⁱ (p;q) to obtain the hadronic representation. A fter isolating the ground state contributions from the pole term s of the m eson a_1 (1260), the correlation functions

ⁱ (p;q) can be expressed in the following form,

where we have used the standard de nition for the decay constant f_a , h0 jJ^a (0) ja_1 (p) $i=f_aM_a$.

In the following, we brie y outline the operator product expansion for the correlation functions ⁱ (p;q) in perturbative QCD theory. The calculations are performed at the large space-like momentum region p² 0 and 0 $q^2 < m_b^2 + m_b p^{2} =$, where $M_B = m_b +$ in the heavy quark limit. We write down the propagator of a massless quark in the external gluon eld in the Fock-Schwinger gauge and the light-cone distribution amplitudes of the B meson rstly [39],

the ! $_0$ and $~_{\rm E}^2\,$ are some parameters of the B -m eson light-cone distribution amplitudes.

Substituting the d quark propagator and the corresponding B-m eson light-cone distribution amplitudes into the correlation functions ⁱ (p;q), and completing the integrals over the variables x and k, nally we obtain the representation at the level of quark-gluon degrees of freedom. In this article, we take the three-particle B-m eson light-cone distribution amplitudes suggested in Ref.[27], they obey the powerful constraints derived in Ref.[28] and the relations between the m atrix elements of the local operators and the moments of the light-cone distribution amplitudes, if the conditions $!_0 = \frac{2}{3}$ and $\frac{2}{E} = \frac{2}{H} = \frac{3}{2}!_0^2 = \frac{2}{3}$ are satis ed [29].

In the region of sm all !, the exponential form of distribution amplitude $_+$ (!) is num erically close to the more elaborated model (or the BIK distribution amplitude (BIK DA)) suggested in Ref.[32],

where $!_0 = {}_B$. The parameters ${}_B$ and ${}_B$ are determined from the heavy quark e ective theory QCD sum rules including the radiative and nonperturbative corrections. There are other phenom enological models for the two-particle B -m eson light-cone distribution amplitudes, for example, the k_T factorization form alism [40, 41], in this article, we use the QCD sum rules motivated models.

A flerm atching with the hadronic representation below the continuum threshold s_0 , we obtain the following three sum rules for the weak form -factors $V_1(q^2)$, $V_2(q^2)$

In R ef.[31], Lange and N eubert observe that the evolution elects drive the lightcone distribution amplitude $_{+}$ (!) toward a linear growth at the origin and generate a radiative tail that falls o slower than $\frac{1}{!}$, even if the initial function has an arbitrarily rapid fallo, which implies the normalization integral of the $_{+}$ (!) is ultraviolet divergent. In this article, we derive the sum rules without the radiative 0 ($_{s}$) corrections, the ultraviolet behavior of the $_{+}$ (!) plays no role at the leading order (0 (1)). Furthermore, the duality thresholds in the sum rules are well below the region where the elect of the tail becomes noticeable. The nontrivial renormalization of the B -m eson light-cone distribution amplitude is so far known only for the $_{+}$ (!), we use the light-cone distribution amplitudes of order 0 (1), which satisfy all QCD constraints.

3 Num erical result and discussion

The input parameters are taken as $!_0 = {}_{\rm B}$ () = (0:46 0:11) GeV, = 1 GeV §2], ${}_{\rm E}^2$ = (0:11 0:06) GeV² [29], M_a = (1:23 0:06) GeV, f_a = (0:238 0:010) GeV, s₀ = (2:55 0:15) GeV² [36], M_B = 5:279 GeV, f_B = (0:18 0:02) GeV §2, 43].

The B orel parameters in the three sum rules are taken as $M^2 = (1:1 \quad 1:5) \text{ G eV}^2$, in this region, the values of the weak form -factors V_1 (q²), V_2 (q²) and A (q²) are stable enough.

Taking into account all the uncertainties, we obtain the numerical values of the weak form-factors V_1 (q²), V_2 (q²) and A (q²), which are shown in Fig.1, at zero momentum transfer,

The form -factors can be param eterized in the double-pole form,

where we use the notation $F_i(q^2)$ to denote the $V_1(q^2)$, $V_2(q^2)$ and $A(q^2)$, the a_F and b_F are the corresponding coe cients and their values are presented in Table 3.

In calculation, we observe the dom inating contributions in the three sum rules come from the two-particle B-meson light-cone distribution amplitudes, the contributions from the three-particle B-meson light-cone distribution amplitudes are of minor importance, about 1%, and can be neglected safely. It is not un-expected that the main uncertainty comes from the parameter $!_0$ (or $_B$), which determines the shapes of the two-particle and three-particle light-cone distribution amplitudes of the B meson. From Fig.1, we can see that the uncertainty of the parameter $_B$ alm ost saturates the total uncertainties, it is of great importance to re ne this parameter. In this article, we take the value from the QCD sum rules in Ref.[32], where the B-meson light-cone distribution amplitude $_+$ is parameterized by the matrix element of the bibcal operator at imaginary light-cone separation.

In the region of sm all !, the exponential (G aussian) form of distribution am – plitude $_+$ (!) is num erically close to the BIK DA suggested in Ref.[32]. In Fig.1, we also present the num erical results with the BIK DA for the central values of the input parameters $_{\rm B}$ and $_{\rm B}$, the G aussian distribution am plitude and the BIK DA

lead to alm ost the sam e values.

From Table 1, we can see that the values of the V_0 (0) from the covariant lightfront approach, ISG W 2 quark model and quark-meson model dier greatly from the corresponding ones from the (light-cone) QCD sum rules, while the values from the (light-cone) QCD sum rules and perturbative QCD are consistent with each other. From Table 2, we observe that the values of the A (0) from the covariant light-front approach, quark-meson model and perturbative QCD dier greatly from the corresponding ones from the (light-cone) QCD sum rules, while the values of the form -factors from the (light-cone) QCD sum rules are consistent with each other.

4 Conclusion

In this article, we calculate the weak form -factors $V_1(q^2)$, $V_2(q^2)$, $V_3(q^2)$ and $A(q^2)$ with the B-m eson light-cone QCD sum rules. The form -factors are basic parameters in studying the exclusive hadronic two-body decays B ! AP and sem i-leptonic decays B ! Al 1, B ! All. Our num erical values are consistent with the values from the (light-cone) QCD sum rules. The main uncertainty comes from the parameter $!_0$ (or $_B$), which determ ines the shapes of the two-particle and three-particle light-cone distribution amplitudes of the B m eson, it is of great in portance to re ne this parameter. However, it is a di cult work, as we cannot extract the values of the basic parameter $_B$ directly from the experimental data on the sem i-leptonic decays B ! Al 1.
