## T im e-and Spacelike N ucleon E lectrom agnetic Form Factors beyond R elativistic C onstituent Q uark M odels

## A bstract

For the st time, a phenomenological analysis of the experimental electrom agnetic form factors of the nucleon, both in the timelike and spacelike regions, is performed by taking into account the electron of nonvalence components in the nucleon state, within a light-front framework. Our model, based on suitable Ansatzes for the nucleon Bethe-Salpeter amplitude and a microscopic version of the well-known Vector M eson D om inance model, has only four adjusted parameters (determined by the spacelike data with <sup>2</sup>=datum 1:7), and yields a nice description of the experimental electrom agnetic form factors in the physical region in the range 30 (G eV=c)<sup>2</sup> < q<sup>2</sup> < 20 (G eV=c)<sup>2</sup>, except for the neutron one in the timelike region. Valuable information can be gained in the timelike region on possible missing Vector M esons around q<sup>2</sup> 4:5 (G eV=c)<sup>2</sup> and q<sup>2</sup> 8:0 (G eV=c)<sup>2</sup>.

In recent years there has been a renewed interest in the investigation of nucleon electrom agnetic form factors (FF), given an unexpected discrepancy between experimental data for the spacelike (SL) ratio  ${}^{p} G_{E}^{p} (q^{2})=G_{M}^{p} (q^{2}) ex-$ tracted by using: i) the Rosenbluth separation method (see Ref. [1] for recent measurements) and ii) the polarization transfer technique adopted in experiments carried out at TJLAB [2]. Indeed in the SL region (where the squared four-momentum transfer becomes negative, i.e.  $q^{2} = !^{2} jq^{2} = 0$ ), data obtained by the Rosenbluth separation follow the dipole law, while, suprisingly, data from the polarization transfer technique decrease faster than the dipole law for  $Q^{2} = q^{2} > 1$  (G eV=c)<sup>2</sup>. This experimental puzzle has not yet been completely explained, although both two-photon exchange processes [3] and higher-order radiative corrections [4] appear relevant for its solution.

Furtherm ore, the timelike (TL) region calls for both experimental and theoretical investigations (in particular for the neutron !), since the ratio, R, between experimental neutron and proton form factors, beyond the threshold  $q^2 = 4M_N^2$  (with  $M_N$  the nucleon mass), turns out to be greater than one [5], while naive expectations from perturbative QCD (see, e.g. [6]) yield  $R_je_d=e_uj=0.5$ . A deeper understanding of all these experimental issues could open new windows in the investigation of the nucleon internal structure, also elucidating the role of sm all components in the nucleon state, (see, e.g., [7] for the possible in uence of the above mentioned SL puzzle on the nucleon shape studies).

W ithin the light-front dynamics [8,9], we successfully reproduced the pion experimental FF in the interval  $10 (GeV=c)^2$  $q^2$ 10 (G eV=c)<sup>2</sup> [10], namely both in the SL and TL regions, by introducing components of the pion state beyond the valence one. A im of this letter is the generalization of our approach to the nucleon, presenting for the st time within the light-front dynamics a unied, direct calculation of both SL and TL nucleon FF (see, also [11] for prelim inary results with a slightly di erent model). In particular, the role of the contribution due to the qq-pair, created by the incoming virtual photon, turns out to be essential as in the pion case. Our approach shares many ingredients with the model of Ref. [12], but it exhibits distinct features, like i) the choice of a reference frame with the plus component of the momentum transfer  $q^+ = q^0 + q_z \in 0$  [13], allowing a unied analysis of SL and TL regions (see Figs. 1 and 2 for a diagram matic illustration), and ii) the gaugeinvariant dressing of the quark-photon vertex through a m icroscopic Vector Meson Model (VMD) [10].

Nucleon FF, that enter in the macroscopic description of the em current operator,  $\underline{I}(q^2)$ , are calculated in a reference frame where  $q_2 = P_{N_2} = 0$  and  $q^{+} = \frac{1}{3q^2}j$ . In the SL region, where  $q = P_N^0 = P_N^0$  (with  $P_N$  and  $P_N^0$  the initial and nal nucleon fourmomenta, respectively) and  $q^2 = 0$ , the nucleon Sachs FF are given by

where =  $2M_N^2 = q^2$ . The expressions for the TL form factors corresponding to Eq. (1) can be easily obtained by changing  $P_N$  with  $P_N$  and  $P_N^0$  with  $P_N$ . In our approach, for the SL kinem atics, the matrix elements of the nucleon current (see [11]) are approximated microscopically in impulse approximation by the M andelstam formula [14] as follows (see also [12])

where  $U_N$  is the nucleon D irac spinor, the factor 3 com es from the symmetry of our problem,  $N_c$  is the number of colors,  $(k_1;k_2;k_3;P_N)$  the nucleon Bethe-Salpeter amplitude (BSA),  $k_i$  the i-th constituent quark (CQ) fourmomentum,  $k_3^0 = k_3 + q$ ,  $P_N = k_1 + k_2 + k_3$  and  $P_N^0 = k_1 + k_2 + k_3^0$ . In Eq. (2),

in plies a sum over isospin and spinor indexes, S  $(k_i)$  is the D irac propagator of a CQ (with a chosen constituent mass m = 200 M eV) and I  $(k_3;q)$  is the quark-photon vertex, obtained by dressing a pointlike quark (see below). An expression analogous to Eq. (2) holds for the TL region (see [15]).

The nucleon BSA must have a D irac structure, that has been devised exploiting a qqq N e ective Lagrangian which couples a scalar-isoscalar quark-pair plus a quark to the nucleon, as suggested in Ref. [12]. In particular, for the present calculation, no derivative coupling has been considered. Then, the properly symmetrized BSA of the nucleon is approximated as follows

where  $(k_1;k_2;k_3)$  describes the symmetric momentum dependence of the vertex function upon the quark momenta, and U is given by

with  $_{\rm N}$  the nucleon isospin state and

In Eq. (5), C is the charge conjugation operator,  $S_C$  (k) = C  $S^T$  (k) C  $^1$  and the symbol keeps separated the matrices acting on the quark pair from

the ones acting on the quark-nucleon system . Note that the symmetry in the quark pair variables reduces the number of possible terms from 6 to 3.

The quark-photon vertex I (k;q) =  $I_{IS} + {}_{z} I_{IV}$  has both isoscalar and isovector contributions. In turn, each term,  $I_{i}$  (with i = IS;IV), is the sum of i) a purely valence (V) contribution,  $I_{iV}$  (k;q), which is present in the SL region only (see below) and ii) a nonvalence (NV) contribution,  $I_{iNV}$  (k;q), corresponding to the qq-pair production (Z-diagram). Moreover,  $I_{iNV}$  (k;q) is composed of a point-like bare term and of a VMD term (cf [16]). Sum marizing one has

where N  $_{IS} = 1=6$ , N  $_{IV} = 1=2$ . The constants Z  $_{B}$ , Z  $_{VM}^{IV}$  and Z  $_{VM}^{IS}$  are unknown weights for the pair-production contributions, to be determ ined from the phenom enological analysis of the experim ental data. In principle, we should expect only one renorm alization factor, but in the actual thing procedure, we have taken  $Z_{VM}^{IS} \in Z_{VM}^{IV} = Z_B$ , given the lower degree of know ledge of VM isoscalar sector. We anticipate that, from our thing procedure, the devia-10%. As in the case of the pion [10], the bare tion from the equality is ful lls the current conservation in a covariant model [15]. For the term VMD term, we extended the microscopic model of Ref. [10], by including the isoscalar mesons and by making the VM vertex trivially transverse to q [15] (this means q = 0). The same VM mass spectrum, em decay constants and total decay widths of Ref. [10] have been used for the isovector part of the VMD term . As to the isoscalar term , for i = 1;2;3, VM m asses and the corresponding total decay widths have been taken from PDG [17], while for i > 3 we have calculated the masses by using the mass operator of Ref. [18], with an interaction parameter  $w_{IS} = w_{IV} = 0.27 \text{ GeV}^2$  ( $w_{IV} = 1.556 \text{ GeV}^2$ ), in order to follow the Anisovitch-Jachello law (see, e.g., [10] for the isovector case), and we have adopted the same total decay width  $\frac{i}{n} = :150 \text{ GeV}$  as we had for the isovector case. The em decay constants,  ${\stackrel{i}{}_{e^+e}}$  , necessary for determ ining VMD (k;q;i), have been calculated with the model of Ref. [18], and agree, within the errors, with the corresponding experimental values of the known IV and IS vector m esons [17]. Finally, we considered up to 20 m esons for achieving convergence at high  $jq^2 j$ .

Following the pion case [10], the four-dimensional integrations on  $k_1$  and  $k_2$  in Eq. (2) are regularized by assuming a suitable fall-o of the momentum component of the BSA. Furthermore, in the integrations on  $k_1$  and  $k_2$  we consider only the poles of S ( $k_1$ ), namely we disregard the analytic structure of ( $k_1$ ; $k_2$ ; $k_3$ ) and of the momentum components of the VM amplitudes, present

in Figs. 1 and 2. Then the covariance is only approximate (see Ref. [10] for a quantitative discussion in the pion case).

For the sake of concreteness, let us show the form al expression of the m icroscopic current I (q<sup>2</sup>) (whose matrix elements are given in Eq. (2)) in the SL region. It becomes the sum of two contributions: i) a purely valence (or triangle) contribution,  $I_V$  (SL;q<sup>2</sup>) (Fig. 1, diagram (a)), where both the nucleon vertexes have two quarks on their k -shell (k =  $k_{on} = (k_2 f + m^2) = k^+$ ) and the quark variables are in the valence region ( $P_N^+ k_1^+ = 0$ ); ii) a nonvalence (pair-production or Z-diagram) contribution,  $I_{NV}$  (SL;q<sup>2</sup>), where the initial nucleon vertex has a quark outside the valence range ( $k_3^+ < 0$ , see Fig. 1, diagram (b)) viz

where  $K_i = fk_i^+$ ;  $k_{i?}$  g is the light-front m on entum and  $k_{3on}^0 = (P_N^0 = k_1 = k_2)_{on}$ . The quantity F is a 4 4 m atrix (see [12] and [15]) constructed from U and  $I_i$  (k;q) (Eq. 6), given by

where  $I_N = I_{IS} + N_{IV}$  and K (i; j) = ( $k_i + m$ ) ( $k_j + m$ ).

In Eqs. (7, 8) the momentum dependence of the vertex functions in the valence range ( $P_N^+$   $k_i^+$  0) is expressed through a light-front wave function, N, which is a PQCD inspired wave function a la Brodsky-Lepage (see, e.g., [8]), described in terms of the squared free mass of the three-quark system M  $_{0N}^2$  ( $k_1$ ; $k_2$ ; $k_3$ ) =  $P_N^+$   $_i^P$   $_i$   $k_{i,on}$ , i.e.

where  $_{i} = k_{i}^{+} = P_{N}^{+}$  and N is a normalization constant, obtained from the plus component of the proton current at  $Q^{2} = 0$ , i.e. from the proton charge normalization. In Eq. (10) the power 7=2 and the parameter p = 0.13, which controls the end-point behavior and a ects the FF mainly through the Z-diagram, allow one to obtain an asymptotic decrease of the valence contribution faster than the dipole  $G_{D}(\dot{p}^{2}) = [1 + \dot{p}^{2} \div (0.71 (\text{GeV}=\text{c})^{2})]^{2}$ . Since the Z-diagram gives no contribution to the nucleon magnetic moments, the parameter = 0.645 GeV in Eq. (10) can be directly xed through a t to the experimental values, obtaining  $\frac{\text{th}}{p} = 2.87 - 0.02$  ( $\frac{\text{exp}}{p} = 2.793$ ) and  $\frac{\text{th}}{n} = -1.85 - 0.02$  ( $\frac{\text{exp}}{p} = -1.913$ ). Theoretical uncertainties come from the M ontecarbo integration of (7).

In Eq. (8), the vertex function  $(k_1;k_2;k_3)j_{(k_{1on},k_{3on}^0)}$  describes a qqq system since  $k_3^+ < 0$ , and therefore it cannot be approximated as the one in the valence region. It turns out [15] that this NV vertex leads to a contribution to the nucleon FF to be interpreted as a transition from jqqqi to jqqqqqi Fock components of the nal nucleon. In the present calculation, an Ansatz,  ${}_{\rm NV}^{\rm SL} = (k_1;k_2;k_3)j_{(k_{1on},k_{3on}^0)}$ , in terms of invariants as the squared free m ass, M  $_0^2$  (1;2), of the quark pair propagating from the initial nucleon toward the nal one, and the squared free m ass of the system N + 3, has been adopted (cf diagram (b) in Fig. 1)

where  $g_{A,B} = (m_A m_B) = [^2 + M_0^2 (A;B)]$  and  $k_{12}^+ = k_1^+ + k_2^+$ . The ratio  $k_{12}^+ = P_N^{0+}$ enforces the collinearity of the spectator-quark pair and the nal nucleon, while  $\mathbb{P}_N^{0+} = k_3^+ \mathbb{F} \mathbb{P}_N^+ = k_3^+ \mathbb{F}$  controls the end-point behavior of the antiquarkleg attached to the nonvalence vertex (with a chosen symmetrical form). The powers of  $g_{12}$  and  $g_{N,3}$  and the parameter r = 0.17 allow one to obtain a dipole asymptotic behavior for the NV contribution.

In the TL region, where  $q = P_N + P_N$ ,  $k_{12} + k_3 = P_N$  and  $k_{12} + k_3^0 = P_N$ , after integrating on  $k_1$  and  $k_2$ , one obtains two contributions, with a form sim ilar to Eq. (8), but corresponding to diagram s (a) and (b) of Fig.2. In both contributions valence and NV nucleon vertexes are present, as a result of a transition between the jqq; qqqi hadronic component of the photon state and the NN nal state. The nucleon NV vertex is approximated by an Ansatz,  $\prod_{NV}^{TL}$ , analogous to Eq. (11), built up with the corresponding invariants, e.g.,

in the contribution (a) of Fig. 2 one has

where the factor 2 counts the possible patterns for gluon em issions. In  $g_{N,\overline{12}}$ , we put in the norm alization factor  $m_{\overline{12}} = 0.500 \text{ GeV}$  [19], and in the denom inator  $M_0^2$  (N;  $\overline{12}$ ) = ( $P_N^+$  k\_1^+ k\_2^+) ( $P_N^-$  k\_{1on}^- k<sub>2on</sub>)  $k_{12}^+$  +  $k_{22}^2$   $j^2$ 

To determ ine the free parameters  $Z_B$ ,  $Z_{VM}^{IS}$ , p and r, a tting procedure has been performed in the SL region, including proton data ( $_p G_E^p = G_M^p$  and  $G_M^p$ ) with Q<sup>2</sup> 10 (G eV=c)<sup>2</sup> and neutron data ( $G_E^n$  and  $G_M^n$ ) with Q<sup>2</sup> 1 (G eV=c)<sup>2</sup>. We obtained a value <sup>2</sup>=datum = 1:7, with a very nice description of the data, as shown in Fig. 3. From the tting procedure we have: i) the ratio  $Z_{VM}^{IS} = Z_{VM}^{IV} = 1:12$ , remarkably close to one, and ii)  $Z_B = Z_{VM}^{IV} = 2:283$ . In correspondence to the previous outcome, the proton charge radius is  $r_p =$ 0:903 :004 fm ( $r_p^{exp} = 0:895$  0:018 [20]) and  $dG_E^n (q^2) = dq^2 = 0:501$ 0:002 (G eV=c)<sup>2</sup> (the exp. value is 0:512 0:013 (G eV=c)<sup>2</sup> [20]).

The same values for  $Z_B$ ,  $Z_{VM}^{IS}$  and r (see Eq. (12)) are adopted for calculating the elective TL form factors, de ned as follows, according to experimentalists (see, e.g., [21]),

The Z-diagram (higher Fock components) is essential for describing the nucleon FF, in the adopted reference frame (q<sup>+</sup>  $\in$  0), as in the pion case [10]. In the SL region, it produces the striking feature of a zero around Q<sup>2</sup> 9:0 (GeV=c)<sup>2</sup> for G<sup>p</sup><sub>E</sub>. Notably, retaining only three sets of data, G<sup>p</sup><sub>M</sub>, G<sup>n</sup><sub>E</sub> and G<sup>n</sup><sub>M</sub>, in the tring procedure, one gets again the cancellation between triangle and pair-production contributions to G<sup>p</sup><sub>E</sub>, and only tiny di erences from the results shown in Fig. 3. This means that, in our model, the fallo of p G<sup>p</sup><sub>E</sub>=G<sup>p</sup><sub>M</sub> for Q<sup>2</sup> > 1:0 (GeV=c)<sup>2</sup> is enforced by the other three sets of data.

In the TL region, our calculations are parameter free, and give a fair description of the proton data, apart the peak at the threshold, which is outside the present model due to the absence of the nal state interaction. The TL proton data clearly show a structure due to the resonances (see Fig. 4), allowing to gather more details on the hadronic content of the photon wave function. In particular, the comparison with the most recent data [21] put in evidence that some strength is lacking in our model for q<sup>2</sup> 4.5 and 8 (G eV=c)<sup>2</sup> (as for the pion [10]). Finally, available TL neutron data are not reproduced by the present model, but, even a constant factor of 2 could in prove the description

(cfFig.4, right panel).

Sum marizing, in a frame with  $q^+ \in 0$  (that allows a unied treatment of both the SL and TL regions), our approach, with only four adjusted parameters ( $Z_B = Z_{VM}^{IV}$ ,  $Z_{VM}^{IS}$ , p and r), is able to describe the nucleon SL FF (<sup>2</sup>=datum = 1:7) and to give predictions for the TL ones. A complete analysis of the model dependence, as well as a detailed study of the momentum distributions of the valence nucleon vertex functions will be presented elsewhere, together with a study of nucleon FF in the unphysical region ( $0 < q^2 < 4M_N^2$ ), which appears very challenging, but needs a non trivial inclusion of the N N interaction [15].
