# C oherent state quantization of angle, tim e, and m ore irregular functions and distributions

#### Abstract

$T$ he dom ain of application of quantization $m$ ethods is traditionally restricted to sm ooth classical observables. W e show that the coherent states or \anti-W ick" quantization enables us to construct fairly reasonable quantum versions of irregular observables living on the classical phase space, such as the angle function, the time function of a free particle and even a large set of distributions com prising the tem pered distributions.


## 1 Introduction

In this work, we reexam ine the way in whidh G aussian (or standard) coherent states (C S) allow a natural quantization ( $\backslash B$ erpezin $K$ lauder CS or anti-N idk quantization") of the complex plane $C=f z=(q+i p)=\overline{2} g$ viewed as the phase space of the particle $m$ otion on the line. First, we extend the de nition of what should be considered as an acceptable quantum observable. Then, we prove that $m$ any classical singular functions give rise to such reasonable quantum operators. M ore precisely, we apply the C S quantization schem e to classical observables which are not sm ooth functions or, even $m$ ore, which are, with $m$ ild restrictions, distributions on the plane. In particular, this departure from the canonical quantization principles allow sus to put in a CS diagonal form the argum ent function C 3 $z=r e^{i} \eta \arg z=$ and the time function of a free particle $C 3 z \frac{i z+z}{z}=\cot =q=p$.

W e also consider the D irac distribution on the plane and its derivatives, and this allow s us to readh any kind of nite-dim ensional projector on the $H$ ilbert space of quantum states. Finally, we extend this quantization schem e to a set of distributions which includes the space of tem pered distributions.

Them otivation for en larging the space of quantizable classical observable also stem $s$ from the fact that this coherent state quantization can have possible applications in a wide variety of physical problem $s$, like the long standing and controversial question of the determ ination and the study of the tim e operator for an interacting particle (see [1] and references therein). This aspect will be considered in this paper in the sim plest case of the one-dim ensionalm otion of a free particle (the quantization of $q=p$ ) or of the harm on ic oscillator (angle operator). O ur approach has also possible im plications in noncom mutative ( $\mathrm{N} C$ ) quantum $m$ echanics, which is being currently studied for its possible application in fractional Q uantum $H$ all E ect ( FQHE ): If one considers the Landau problem in a 2D plane, the com $m$ utators of the pro jected $x$ and $y$ coordinate operators of a particle onto the low est Landau levelgive rise to noncom m utativity in term s of the inverse of the applied $m$ agnetic eld [2]. O ne is therefore led to study the planar $N C$ quantum $m$ echanics per se, where the \classical" H ilbert space itself corresp onds to the H ilbert space of quantum states for the particle $m$ otion on the line. The quantum $H$ ilbert space for this planar N C system is thus identi ed w ith the set of allbounded operators in th is classicalH ilbert space, w ith respect to a certain inner product [3]. O ne can then introduce a disk [3] or defects [4] in the N C plane in term s of these projectors in the classical H ibert space. T hese defects, on tum, can give rise to certain edge states, relevant for $F Q H E$.

## 2 The Berezin $-K$ lauder or anti-W ick quantization of the $m$ otion of a particle on the line

Let us consider the quantum $m$ otion of a particle on the real line. On the classical level, the phase space (w ith suitable physical units) reads as $C=f z=p_{1}^{1}(q+i p) g=R^{2} \cdot T$ his phase space is equipped w the ordinary Lebesgue $m$ easure on the plane which coincides w ith the sym plectic 2-form : $\frac{1}{-} d^{2} z$ where $d^{2} z=d<z d=z$. Strictly included in the $H$ ibert space $L^{2}\left(C ;{ }^{1} d^{2} z\right)$ of all com plex-valued functions on the com plex plane which are squareintegrable w ith respect to this $m$ easure, there is the Fock-B argm ann H ibert subspace F B of all square integrable functions which are of the form $(z ; z)=e^{\frac{\mathrm{kj}^{2}}{2}} g(z)$ where $g(z)$ is analytical entire. A s an orthonorm albasis of this subspace we have chosen the norm alized powers of the con jugate of the com plex variable $z \mathrm{w}$ eighted by the G aussian fiunction, i.e. $n(z ; z) \quad e^{\frac{j j^{2}}{2}} \mathrm{~F}^{\mathrm{z}^{\mathrm{n}}} \frac{\mathrm{n}!}{\mathrm{n}}$ w th n 2 N . N orm alized coherent states are well known $[5, ~ 6, ~ 7, ~ 8]$
and read as the follow ing superposition of num ber eigenstates:

W e here recall one fundam ental feature of the states (1), nam ely the resolution of the unity in the $H$ ilbert space $H$ having as orthonorm albasis the set of ini:

The property (2) is crucial for ourpunpose in setting the bridge betw een the classicaland the quantum world. It encodes the quality of coherent states of being canonical quantizers [9] along a guideline established by K lauder and Berezin (and also Toeplitz on a m ore abstract $m$ athem atical level). This Berezin -K lauder-T oeplitz (BKT) (or anti-w ick, or anti-norm al) coherent states quantization, called hereafter C S quantization, consists in associating w ith any classical observable $f$, that is a (usually supposed sm ooth, but we w ill not retain here this too restrictive attribute) function of phase space variables (q;p) or equivalently of $(z ; z)$, the operator-valued integral

$T$ he resulting operator $A_{f}$, if it exists, at least in a weak sense, acts on the $H$ ilbert space $H$. It is worthy to be $m$ ore explicit about what we $m$ ean by \w eak sense" : the integral

should be nite for any ji2 2 (or 2 some dense subset in H). O ne notices that if is nom alized then (4) represents the $m$ ean value of the function $f w$ ith respect to the -dependent probability distribution $z$ In jif on the phase space.
$M$ ore $m$ athem atical rigor is necessary here, and we will adopt the follow ing acceptance criteria for a function (or distribution) to belong to the class of quantizable classical observables.

 smooth ( $2 \mathrm{C}^{1}$ ) function $w$ ith respect to the ( $\mathrm{q} ; \mathrm{p}$ ) coordinates of the phase plane.
and, if we restore the dependence on $\sim$ through $z!p_{\sim}^{z}$, we must get the right

sam e asym ptotic behavior $m$ ust hold in a distributional sense if we are quantizing distributions.

The function f (resp. the distribution T ) is an upper or contravariant sym bol of the operator $A_{f}$ (resp. $A_{T}$ ), and the $m$ ean value hz $\AA_{f} \dot{z} i$ (resp. $h z A_{T} \dot{k} i$ ) is the lower or covariant sym bolof the operator $A_{f}$ (resp. $A_{T}$ ). Them ap $f \eta A_{f}$ is linear and associates w ith the function $\mathrm{f}(\mathrm{z})=1$ the identity operator in $H$. N ote that the low er sym bol of the operator $A_{f}$ is the $G$ aussian convolution of the function $f(z ; z)$ :

This expression is of great im portance and is actually the reason behind the robustness of CS quantization, since it is well de ned for a very large class of non sm ooth fiunctions and even for a class of distributions com prising the tem pered ones. Equation (5) ilhustrates nicely the regularizing role of quantum $m$ echanics versus classical singularities. $N$ ote also that the G aussian convolution helps to carry out the sem i-classical lim it, since the latter can be extracted by using a saddle point approxim ation. For regular functions for whidh $A_{f}$ exists, the application of the saddle point approxim ation is trivial and we have

For singular functions the sem i-classical lim it is less obvious and has to be veri ed for each special case, som ething we w ill do system atically for those ones considered in the follow ing sections. A lso, this particular aspect of CS quantization can be very usefiul in the context of the quantum $m$ echanical problem of particles $m$ oving in the $N C$ plane, as we had m entioned earlier [3]. Since in this context the quantum H ibert space com prises the bounded operators in the classical H ilbert space, one can recover the usual coordinate space wave function by taking expectation values of these operators in the coherent state fam ily (1), i.e. by obtaining the corresponding low er sym bol [10].

N ow let us m ake the CS quantization program m ore explicit. Expanding bras and kets in (3) in term $s$ of the Fock states yields the expression of the operator $A_{f}$ in term $s$ of its in nite $m$ atrix elem ents $\left(A_{f}\right)_{n n} \stackrel{\text { def }}{=} h n \not A_{f} \eta^{0} 0_{i}$ :

In the case where the classical observable is \isotropic", i.e. $f(z) \quad h\left(j^{2}\right)$, then $A_{f}$ is diagonal, $w$ ith $m$ atrix elem ents given by a kind of gam $m$ a transform :

Let us explore what this quantization $m$ ap produces starting $w$ ith som e elem entary functions f. W e have for the $m$ ost basic one,

In consequence, the self-adjoint operators $Q$ and $P$ obtained in this way obey the canonical commutation rule $Q ; P]=i T_{H}$, and for this reason fully deserve the nam ef position and $m$ om entum operators of the usual (galilean) quantum m echanics, together with all localization properties speci c to the latter.

## 3 C anonical quantization rules

At this point, it is worthy to recall what quantization of classical $m$ echanics does $m$ ean in a com $m$ only accepted sense (for a recent review see [11]). In this context, a classical observable $f$ is supposed to be a sm ooth function $w$ ith respect to the canonical variables. In the above we have chosen units such that the $P$ lanck constant is just put equal to 1. H ere we reintroduce it since it param etrizes the link betw een classical and quantum $m$ echanics.
$V$ an $H$ ove canonical quantization rules [12]

G iven a phase space w ith canonical coordinates (q;p)
(i) to the classical observable $\mathrm{f}(\mathrm{q} ; \mathrm{p})=1$ corresponds the identity operator in the (projective) H ibert space H of quantum states,
(ii) the correspondence that assigns to a classical observable $f(q ; p)$, a self-adjoint operator on $H$ is a linear $m$ ap,
(iii) to the classical Poisson bracket corresponds, at least at the order $\sim$, the quantum com m utator, $m$ ultiplied by i~:

(iv) som e conditions ofm in im ality on the resulting observable algebra.

The last point can give rise to technical and interpretational di culties [ [11].
It is clear that points (i) and (ii) are full led w th the CS quantization, the second one at least for observables obeying fairly $m$ ild conditions. In order to better understand the \asym ptotic" $m$ eaning of $C$ ondition (iii), let us quantize higher degree $m$ onom ials, starting w ith $\left.H=\frac{\tilde{2}}{2}\left(p^{2}+q^{2}\right)=\sim \dot{\psi}\right\}$, the classical harm on ic oscillator H am iltonian. For the latter, we get im $m$ ediately from (8):

where $N=a^{\mathrm{y}} \mathrm{a}$ is the num ber operator. W e see on this elem entary exam ple that the CS quantization does not $t$ exactly with the canonical one, which consists in just replacing $q$ by $Q$ and $p$ by $P$ in the expressions of the observables $f(q ; p)$ and next proceeding to a sym $m$ etrization in order to com ply w th self-adjointness. In fact, the quantum $H$ am iltonian obtained by this usual canonical procedure is equal to $\hat{H}=\sim N+\sim=2 I_{H}$. In the present case, there is a shifl by $\sim=2$ betw een the spectrum of $\hat{H}$ and our coherent state quantized H am iltonian $A_{H}$. A ctually, it seem sthat no physical experim ent can discrim inate betw een those tw o spectra that di er from each other by a sim ple shift (for a deepened discussion on this point, see for instance [13]), unless one couples the system with gravity which couples to any system carrying energy and $m$ om entum. 1

Let us add for future references the quantization of the H am iltonian of a free particle $m$ oving on the line. The $H$ am iltonian for the free particle of unit $m$ ass is $H(q ; p)=\frac{p^{2}}{2}$. $W$ th $z=(q+i p)={ }^{p} \overline{2}=r e^{i}$ the $H$ am ittonian is $H(z ; z)=r^{2} \sin ^{2}$. U sing the expression (7) we get the quantum H am iltonian operator

W e also observe that the low er sym bol is exactly equal to the classical H am iltonian for any value of $z$

## 4 M ore upper and low er sym bols: the angle operator

Since we do not retain in our quantization scheme the condition of sm oothness on the classical observables, we feel free to CS quantize a larger class of fiunctions on the plane, like the argum ent $2[0 ; 2) \mathrm{mod} 2$ of the complex variable $z=r e^{i}$. Thefunction C $3 \mathrm{zy}=\arg \mathrm{z}$ is in nite-valued w th a branch cut starting from the origin which is a branching point. C om puting its quantum counterpart from (9) is straightforw ard and yields the in nite $m$ atrix:

$T$ he canonical com $m$ utation relations $\left.Q_{w} ; P_{W}\right]=$ i工 correspond to $E_{0}=1=2$. The CS quantization gives $\mathrm{E}_{0}=1$ which would correspond to $\left.Q_{\mathrm{w}} ; \mathrm{P}_{\mathrm{W}}\right]=2$ ir in the W ignerquantization schem p , and so should entail a (non-canonical!) rede nition of position and $m$ om entum, som ething like $P=Q w=\overline{2} ; Q=P_{w}=\overline{2}$. At th is stage, let us recall that the vacuum energy of a free scalar eld of mass m is given by

and it is worth noting that the quantization ambiguity showed by W igner does not allow $\mathrm{E}_{0}=0$, with all the im plications to the cosm ological constant problem that such a sem i-classical com putation w ould have.

W e can also w rite an integral representation of the low er sym bol using the convolution (5)

Let us verify that this low er symbol is $C^{1}$ as a function of $r$ and in conform ation $w$ ith our de nition 2.1. First we note that

The behavior of the low er sym bol (17) is show $n$ in $F$ igure 1). It is interesting to evaluate the asym ptotic behaviors of the function (17) at $s m$ all and large $\frac{r}{p}$ respectively. At sm all r, it oscillates around its average value $w$ th am plitude equal to ${ }^{\mathrm{P}}-_{r}$ :

At large r, we recover the Fourier series of the 2 -periodic angle function:

The latter result can be equally understood in term s of classical lim it of these quantum ob jects. Indeed, by re-in jecting into our form ula physical dim ensions, we know that the quantity $\dot{k} \jmath^{3}=r^{2}$ acquires the dim ension of an action and should appear in the form ulas as divided by the $P$ lanck constant $\sim$. H ence, the lim it $r$ ! 1 in our previous expressions can also be considered as the classical lim it ~! 0. Since we have at our disposal the num ber operator $N=a^{y} a$, which is up to a constant shift the quantization of the classical action,

and an angle operator, we can exam ine their com $m$ utator and its low er sym bol in order to see to what extent we get som ething close to the expected canonical value, nam ely $i I_{H}$. $T$ he com $m$ utator reads as

At $s m$ all $r$, the function $C(r ;)$ oscillates around $0 w$ th am plitude equal to ${ }^{\mathrm{p}}-{ }_{r}$ :

At large $r$, the function $C(r ;)$ tends to the Fourier series $2^{P}{ }_{q=1}^{1}$ cosq whose convergence has to be understood in the sense of distributions. A pplying the P oisson sum $m$ ation formula, we get at r! 1 (or ~! 0) the expected \canonical" behavior for $2[0 ; 2$ ). The fact that this com $m$ utator is not exactly canonicalw as expected since we know from $D$ irac [17] about the im possibility to get canonicalcom m utation rules for the quantum versions of the classical canon ical pair action-angle. O n a m ore general level, we know that there exist such classical pairs for which $m$ athem atics -e.g. the $P$ auli theorem - [18] prevent the corresponding quantum commutator of being exactly canonical. Wewill discuss this point in
$m$ ore details $w$ hen quantizing the tim e function in the next section. H ow ever, in the present case, we obtain in the quasi-classical regim e the follow ing asym ptotic behavior:

## 5 C lassical and quantum tim e of the free particle

The quantization of the tim e function is, like for the angle, an old, im portant, and controversial question [l]. A side from conceptual problem s, the basic di culty encountered in the construction of a quantum tim e operator is sum $m$ arized in the called $P$ auli theorem [18, 19, 20, 21]: one would expect naively the tim e operator $T$ to be conjugated to the H am iltonian H. H owever if one assum es that H is a bounded from below operator, such a commutation relation $[\mathrm{T} ; \mathrm{H}]=\quad i 工=$ cannot hold. $T$ he $H$ am iltonian for the free particle, $H(q ; p)=p^{2}=2$, im plies $q(t)=p t \quad$ (up to the addition of a constant). W e can invert this relation to get an expression of the classical tim e as a function on the phase space $t=q=p$. If we view the phase space as the complex plane by setting $z=(q+i p)=\overline{2}=r e^{i}$, then the classical time function is $t(z ; z)=c o t$. Since the time function is only dependent $t(z ; z)=g()$, its CS quantized version is given by (10). The coe cients $c_{m}$ are given by

The question now is to evaluate the extent to which this com mutator is di erent from the canonical $i_{H}$. $F$ irst we notioe that this $m$ atrix shares the sam e diagonal part as the canonical com $m$ utator and is well localized along its diagonal since asym ptotically the coe cients are rapidly decreapsing aw ay from the diagonal. For instance, for large $n$, we have $h 0 j\left[A_{t} ; A_{H}\right]$ jni const $(1+12 n) 2^{n} n^{1=2}$, which goes to $0 m$ ore rapidly than $e^{n=3}$. F igure 3 show $s$ th is localization. In order to go further in the com parison ofour com $m$ utator

w ith the canon icalone, we num erically study its spectrum by truncating the in nitem atrix. $T$ he results are shown in gure 4 and con m s that the spectrum of the commutator $C$ is very close to that of the canonical spectrum iwith in nite degeneracy.

Thus the spectral norm of $D$, given by $\overline{\sup \left(D V_{D}\right)}$ is well de ned. N um erically its value is equal to 1 as shown in $F$ igure 5.

## 6 Q uantization of distributions: D irac and others

It is com $m$ only accepted that a \C S diagonal" representation of the type (3) is possible only for a restricted class of operators in $H$. The reason is that we usually put too m uch restrictive conditions on the upper symbolf $(z ; z)$ view ed as a classical observable on the phase
space, and so it is subm itted to belong to the space of in nitely di erentiable functions on $R^{2}$. W e already noticed that a \reasonable" phase or angle operator is easily built starting from the classical discontinuous periodic angle function. W e are now going to show that any simple projector $n n^{0} \stackrel{\text { def }}{=}$ nihn $^{0}{ }^{j}$ has also a CS diagonal representation by extending the class of classical observables to distributions on $R^{2}$ (for canonical coordinates ( $q$;p) or possibly on $\mathrm{R}^{+}\left[0 ; 2\right.$ ) (for ( $u \stackrel{\text { def }}{=} \mathrm{r}^{2} ;$ ) coordinates). D ue to the general expression (7) form atrix elem ents of the quantized version of an observable $f$, one can im m ediately think to tem pered distributions on the plane only since the functions

U sing com plex coordinates is clearly more convenient and we will adopt the follow ing de nitions and notations for tem pered distributions. Firstly any function $f(z ; z)$ which is \slow ly increasing" and locally integrable w ith respect to the Lebesgue $m$ easure $d^{2} z$ on the plane de nes a regular tem pered distribution $T_{f}$, i.e. a continuous linear form on the vector space $S\left(R^{2}\right)$ equipped w ith the usual topology of uniform convergence at each order of partial derivatives multiplied by polynom ial of arbitrary degree [24]. This de nition rests on the $m a p$,

H owever the question of the validity of such form ulas is $m$ athem atically non trivial: the convergence in the sense of distributions of (41,42) is a di cult problem, and for instance has been partially studied by M iller in [32] M anifestly, the work done in this direction w as concentrated on the dequantization problem ( nding an associated classical function to each quantum operator) and this was done in a quite pragm atic spirit in order to sim plify com putations. Let us note that the existence of such a well-de ned dequantization procedure is by no $m$ eans a physical requirem ent since the quantum realm is by de nition richer than the classical one. A m ore physical requirem ent is that the sem i-classical lim it is well behaved, a property that we have placed at the center of our w ork.

Extension of this analysis involving the form ulation of $N C$ Q uantum $M$ echanics in 3D is rather non-trivial as the rotational invariance is broken in presence of such a constant (nontransform ing) antisym $m$ etric $m$ atrix ij satisfying $\left[\mathbb{x}_{i} ; \hat{x}_{j}\right]=i_{i j}$ as the dual vector ${ }^{\sim}=$ $\mathrm{f}_{\mathrm{i}} \quad \frac{1}{2} i_{i j k} \quad \mathrm{jk}$ g is pointed to a particular direction in space and which can only be restored by a tw isted im plem entation of the rotation group ( SO (3)) in a H opf algebraic setting [35]. H ow ever one has to sacri ce the vectorial transform ation property of the coordinate operators in D 3, which can now be identi ed as the prim itive linear operators in a deform ed H opfalgebra [36]. Further work in this direction is in progress and will.be reported later.

In this paper, we have established that the CS quantization $m$ ap enables us to quantize singular classical functions, and, m ore generally, distributions including tem pered distributions. M ore precisely, we are able to construct a reasonable and well behaved quantum angle and tim e operator for the free particle $m$ oving on the line. In particular our tim e operator is herm itian, veri es the canonical com m utation relation $w$ ith the $H$ am iltonian up to order ~, and has the right sem i-classical lim it. Let us point out the relevance of our work to the study of a \phase space form ulation" of quantum m echanics, which enables to m im ic at the level of functions and distributions the algebraic $m$ anipulations on operators within the quantum context. In particular, by carrying out the C S quantization of C artesian pow ers ofplanes, we could so have at our disposalan interesting \functionalportrait" in term s of a \star" product on distributions for the quantum logic based on $m$ anipulations of tensor products of quantum states.

In fact for the harm onic oscillator ( $w$ ith unit $m$ ass and frequency) a whole fam ily of com m utation relations param etrized by the ground state energy $E_{0}$ are adm issible:
