# Update of axion CDM energy density

We improve the estimate of the axion CDM energy density by considering the new values of current quark masses, the QCD phase transition e ect and a possible anharm onic e ect.

#### I. IN TRODUCTION

The standard model is the greatest trium ph of the 20th century particle physics. How ever, it su ers several naturalness problem s. The so-called strong CP problem is one of them . Up to now, the most promising strong CP solution is axion [1]. A lthough its coupling is very sm all, it could have a ected the evolution of the Universe.

On the other hand, the observations like the galaxy rotation curve and the cosm ic m icrow ave background radiation tellus that a signi cant portion of the energy density of the universe cannot be explained by the ordinary baryonic m atter. The recent analysis of W MAP data [2] com bining the observation of the large scale structure prefers the standard vacuum energy and cold dark m atter (CDM) m odel, with the cold dark m atter (CDM) density  $_{\rm DM}$  h<sup>2</sup> ' 0:1143 0:0034.

D uring the in ation, a su ciently light scalar eld becom es spatially hom ogeneous and its value is selected stochastically  $\beta$ ]. A first the in ation, the Hubble param – eter decreases as the universe expands. If the Hubble param eter becom es sm aller than som e scale, usually the scalar m ass scale, the scalar eld starts to roll down. In the hydrodynamic description, this coherent oscillation works as cold m atter in the evolution of the universe. If the interaction is sm all enough to keep coherence until the m atter-dom inant era, it can be a part of the present m atter energy density of the universe. The axion is that kind of particle and can be coherent until even now.

Just after the invisible axion was introduced [4], people recognized its cosm ological in plications that the classical axion eld oscillation behaves like CDM [5]. On the axion CDM energy density, Tumer presented a more accurate number including anharmonic e ect and num erical instanton calculation in late 1980s [6]. DeG rand et. al. concerned about the possible e ects of the chiral phase transition [7].

A fter Turner's pioneering work, m any input param eters in axion cosm ology, especially the QCD param eters, are re ned. W e present the im proved num ber for the axion dark m atter relic density with these new param eters. W e also discuss the possible e ects of the chiral phase transition on the total entropy and the axion number density. This occurs only when supercooling arises.

# II. COMPUTATION OF AXION RELIC DENSITY

Axion is a pseudo N am bu-G oldstone boson, acquiring m ass from the instanton e ect. The tem perature dependence of the axion m ass is in portant in calculating axion energy density for which we will use the result of R ef. [8] obtained in the dilute gas approxim ation. For the purpose of sketching the com putation, we just parameterize the axion potential as

The in ation freezes all elds whose m asses are sm aller than the Hubble parameter at that time. It also attens the uctuation of the eld. Consequently, just after the in ation, the su ciently light elds remain hom ogeneous with a certain value that is determined stochastically. The axion and the moduli are typical representatives of them.

At the end of in ation, the universe is reheated by som e processes. Since axion is very weakly interacting, the reheated radiation of the early universe cannot destroy its coherence. As the universe cools down, the Hubble friction can no longer be the dom inant term and the axion eld starts rolling down the potential hill and continues to oscillate. Since the Hubble param eter becom es sm aller and sm aller than the axion m ass, or the oscillating period of the axion is smaller than the Hubble time, its energy and pressure can be described by the time averages during each oscillation. In the case of the harm onic potential, the elective pressure is zero and the axion eld acts like cold m atter in the evolving universe. M oreover, if the axion can keep the coherence until the matter dom ination epoch, it can contribute to the present CDM energy density.

Since the axion m ass depends on the tem perature or the time, the com oving energy density conservation does

not work in estimating the axion relic density. However, the adiabatic theorem says that as long as the adiabatic conditions  $H; \underline{m}_a = \underline{m}_a \qquad \underline{m}_a$  hold, we can nd the adiabatic invariant I. For the harm onic potential, the invariant is the com oving axion number density I = R<sup>3</sup> a=m a (T). Since the coherent state is not the number eigenstate, the interpretation as the number density only works for the harm onic potential, i.e. the free eld case. W e will discuss the appropriate invariant quantity in the case of the interacting axion eld.

# III. TEM PERATURE DEPENDENCE OF AXION MASS

The QCD vacuum has the quark-gluon phase and the chiral symmetry breaking hadronic phase, separated by the critical tem perature  $T_c$  of the chiral symmetry breaking.  $T_c$  has been calculated to be  $148^{+32}_{-31}$  ( $172^{+40}_{-34}$ ) MeV for three (two) light quarks [9]. This region is in the boundary of weak and strong coupling regimes and it is di cult to estimate the axion mass very accurately in this region. Early attempts to estimate the temperature dependent axion mass has been given in [6, 11]. In these earlier studies, this phase transition was not considered and here we point out that the consideration of the phase transition does not lead to a substantial change in the estimation of the axion energy density.

In the hadronic phase below the critical tem perature, the correlation length of q qpair is large and we assume a tem perature independent height for the axion potential as schem atically depicted in Fig. 1 in the sudden phase change approximation. In this phase, the squared axion mass has the well-known one power of the light quark mass, and the coe cient of the axion potential is  $f^2m^2Z = (1+Z)^2$  [12] which is the second line in Fig. 2 in the expansion of the determ inental interaction [13]. On the other hand, in the quark-gluon phase mesons such as <sup>0</sup> and <sup>0</sup> are not dynamical, and the rst term of

Fig. 2 is the coe cient of the axion potential, which is K <sup>5</sup> uuddss cos for three light quarks where is the QCD vacuum angle. Considering the 3 3 mass matrix for a; <sup>0</sup>; <sup>0</sup>, the insertions of qq VEVs (the lightly shaded diagram of Fig. 2) is the dom inant contribution to the <sup>0</sup> mass [14] from which we estimate the strength K <sup>5</sup> m<sup>2</sup> of<sup>2</sup> =4v<sup>9</sup> ' 10 <sup>13</sup> MeV <sup>5</sup> for f o ' f in the hadronic phase and v 260 MeV. The sam enum berK <sup>5</sup> also appears in the quark-gluon phase. This value will be needed if the adiabatic approximation is violated, but we will show below that the adiabatic approximation is not violated in the bulk of the remaining parameter space and the num ber K will not be used in the end.

C losing the quark lines to insert the current quark masses in the quark gluon phase, we obtain K <sup>5</sup> (m  $_{\rm u}$  m  $_{\rm d}$  m  $_{\rm s}$  = <sup>6</sup>) cos where is the elective instanton size in the instanton size integration at high tem perature. Instead of this naive averaging, we use the original expression given in [8]

where  $_0 = 11 \frac{2}{3} N_f$ ;  $_1 = 51 \frac{19}{3} N_f$ , and  $_2 = 2857 \frac{5033}{9} N_f + \frac{325}{27} N_f^2$ . The leading factors are m  $_u$ m  $_d$ m  $_s$ T and (=T) $^{\frac{1}{3}(11N-2N-f)}$ . So, we parametrize the instanton size integration of (3) at T = T<sub>G eV</sub> G eV near 1 G eV (from 700 M eV to 1.3 G eV) as

For  $_{QCD}$  = 380 (440; 320) MeV [10], we obtain inst = 3:964 10<sup>12</sup> (1:274 10<sup>11</sup>;9:967 10<sup>13</sup>), and n = 6:878 (6:789; 6:967). It starts rolling down the axion potential hill when the axion m ass term becomes dom inant over the Hubble friction term in the equation of motion, i.e. 3H m(T). The Hubble parameter is 1:66g<sup>1-2</sup> (T)T<sup>2</sup>=M<sub>P</sub>.AtT 1GeV, u;d;s;e; ;3 ;8G; remain relativistic. So g (T 1GeV) = (8 + 1) 2 +  $\frac{7}{8}$ f (3 3 + 1 + 1) 2 + 3g 2 = 61:75. Equating 3H (T) and m (T) =  $\frac{P}{C}$  (T)= $F_a^2$ , we obtain

for  $_{\rm Q\,C\,D}$  = 320 M eV , 380 M eV , and 440 M eV , respectively.

# IV. ANHARM ON IC EFFECT ON AXION NUMBER

In early studies [5], the anharm onic higher order term s in the axion potential were neglected and only the harmonic term (the mass term) was considered. In such an approximation, the axion total number in the com oving volume is conserved whenever the adiabaticity conditions, H;  $m_a = m_a$  m<sub>a</sub> are satis ed. Turner [6, 11] considered the e ect due to the anharm onic term s on the axion CDM energy density. Later, Lyth presented an extensive study on this issue [15]. In the early epoch after the classicalaxion eld starts to rolldow n, the axion num ber is not conserved because the anham onic term s are not negligible when  $_1$  & 1. Physically, the introduction of the anham onic term s m ean the axion num ber changing interactions so that the axion num ber conservation is not guaranteed.

#### A. A diabatic invariant

Here, we present the method to treat this anharm onic e ect. The axion eld satis es

where  $= a=F_a; V() = V()=F_a^2$ , and the prime denotes the derivative with respect to  $\cdot$ . This equation of motion can be derived from the time-varying Lagrangian,

where  $V = m_a^2 F_a^2 (1 \cos)$ . We treat here R and  $m_a$  as time-varying parameters. Under the adiabatic condition,  $H; m_a = m_a m_a$ , we have the adiabatically invariant quantity [16],

The num erical result is shown in Fig. 3. The same form was also obtained in [15].

Thus, we obtain

where T = 2.73K. We approximate here f((T))' 1 since axion amplitude decreases as the universe expands and present axion amplitude is small enough to be harmonic.

#### B. Initial anharm onic correction

There exists the adjustment in the initial stage of the rolling down. This initial anharm onic correction will turn out to be larger than the general correction presented in the previous subsection. We assumed two adiabaticity m <sub>a</sub> and H conditions, m\_a=m\_a m<sub>a</sub>. However, since the expansion rate during the st few oscillations are not so sm all, 3H ma, we should be careful in treating the anham onic correction in the initial stage. A ctually, even for the case of the harmonic  $\lim it$ , 1 1, theinitial adjustment is needed. For a large initial misalignm ent angle, 1 1, the duration time during which the expansion rate is not so sm all is longer than for the case of a sm all 1. The e ect of the initial adjustm ent is larger for the larger  $_1$ .

To estim ate the initial adjustm ent correction, we solve the equation of motion num erically and obtain another tem perature T<sub>2</sub> and the corresponding m isalignm ent angle 2 to use them in the subsequent calculation rather than using the original  $T_1$  and  $1 \cdot W$  e have noted that a consideration of the rst half oscillation is enough for this purpose toward obtaining H m<sub>a</sub> as depicted in Fig. 4. The common tangent (the dashed ling) to the dashed curves is the square root of the invariant I. In fact, this invariant shows an overshoot (a factor of 1.8 which will be shown later) from the initial misalignment angle 1, the initial value of the solid curve, which occurs because in this initial stage the expansion rate is non-negligible com pared to m  $_{\rm a}$  . Hence we obtain a larger axion  ${\rm CD\,M}$ energy com pared to the previous estim ates.

For the presentation of the result, we parametrize  $t_2=t_1 = f_2^2$  (1;n) and  $_2=1 = f_3$  (1;n) where n is the exponent in the temperature dependent axion m ass discussed earlier. The correction factors  $f_2$  (1;n) and  $f_3$  (1;n) are shown in Fig. 5.

If the signi cant entropy production is absent during the cooling period from  $T_1$  down to  $T_2$ ,  $T_2=T_1 = (t_2=t_1)^{1=2} = f_2(_1;n)$ . To split the pure anharmonic e ect from the rest, we parameterize these as  $T_2=T_1 = c_2f_2(_1;n)$  and  $_2=_1 = c_3f_3(_1;n)$  where  $c_2 = \lim_{n \to \infty} \frac{1}{n!} \frac{1}{n!}$ 

Then, the appropriate 1 dependence on the relic den-

where the function  $F(_1;n) = f_3^2(_1;n)f_1(_1c_3f_3(_1;n))=f_2^{3+n=2}(_1;n)$  which is shown in Fig. 6.

# V. QCD PHASE TRANSITION AND AXION NUMBER CHANGE

W e know that the adiabatic invariant I is conserved in the com oving volume. We calculated this at a later time  $t_2 > t_1$  where H;  $m_a = m_a$  m<sub>a</sub> are satistical. Thus, if we know the initial misalignment angle  $_1 = (T_1)$ , we can determ ine the current axion energy density. During the universe evolution from  $T = T_1$  to T = 2.73 K, how ever, there is the QCD chiral phase transition epoch

when quarks and gluons in the quark-gluon phase combine each other and change to hadrons in the hadronic phase. Hence, we must check the e ect of this phase transition on the total axion number. Since we do not know the exact phenom ena during this phase transition, we must interpolate two regions of the quark-gluon phase and the hadronic phase as shown in Fig. 1.

# A. Possible supercooling e ect in phase transition

In [7, 17], DeG rand et al. studied supercooling effect during the QCD phase transition for various cases. We brie y explain their argument. Assuming that the universe undergoes rst-order phase transition at T

in the hadronic phase, where  $\hat{T} = T = T_c$ ,  $r = g_q = g_h ' 3$ , B =  $(g_h \quad g_1) (2 = 90)T_c^4$  and  $g_q (g_h)$  is the relativistic degrees of freedom of quark-gluon (hadron) phase. We shall

interpolate and p linearly between  $T_i$  and  $T_f$  like Fig. 7. Subscript i(f) denotes the initial(nal) temperature during the phase transition. A fler some simple algebra, we obtain the following relations [17]

where  $_{i} = _{q}(T_{i}), _{f} = _{h}(T_{f}), and = (\frac{8}{3} G_{N} B)^{1=2}$ 022 GeV<sup>2</sup>=m<sub>Pl</sub>. Since we do not have enough inform ation on T<sub>i</sub> and T<sub>f</sub>, we treat these as free parameters. Then, we obtain the phase diagram in the T<sub>i</sub>-T<sub>f</sub> plane as shown in Fig. 8.

Parameters in colored region are not allowed because of some physical constraints. The dark blue region is excluded from the condition that  $T_f$  is equal or larger than  $T_i$ . The green region is excluded from the condition that entropy never decreases. The yellow region (beyond the red line) is excluded from the constraint that energy conservation is not violated. The light blue region is excluded from the constraint on the kinematical limit of the bubble nucleation rate[17]. The thin red wedge for  $t < 10^{-3}$  is the exaggerated region (an abrupt change case is for  $t < 10^{-4}$  which is not noticeable in the gure) where the adiabaticity condition is violated, which is explained below.

## B. Axion num ber change

Now we estimate axion number change in the allowed region. To do this, we shall examine if the adiabaticity condition is still valid or not in this region. Since H is decreasing during the expansion of the universe,  $m_a > H$  condition is satis ed after the axion eld starts to roll down. We must check whether the adiabaticity condition  $m_{a} = m_a < m_a$  is satis ed during the phase transition.

## 1. Sm ooth transtion

For a smooth transition,  $T_i = T_f = T_c$ , we have  $i = \beta r = (r \quad 1) + 1\beta$ ,  $f = 3\beta = (r \quad 1)$ . Thus, we obtain

where  $t = t_f$  §. Therefore, we obtain t  $10^{10}$  eV  $^1$  m<sub>a</sub><sup>1</sup>. Thus, the adiabaticity condition is satis ed and the axion number in the comoving volume is not changed.

## 2. A brupt transition

In this case, t = 0 and hence we cannot sustain the adiabaticity condition. Thus, the axion number must be changed. Depending on the phase of the axion eld, the axion number may be either lowered or raised by factor 0.1 or 10 [7].

## 3. Bulk region

In the bulk region in Fig. 8, we show a reliable region satisfying the adiabaticity condition. In Fig. 8, we can see that very tiny part(red wedge) of the bulk region breaks the adiabaticity condition. Thus, the axion number is not changed in the allowed region except the red wedge. In Fig. 8, the entropy increase is shown as violet color shades. For a sm all(< 50%) entropy production during the transition in this region, the axion energy density changes because the entropy increase ratio is changed. Entropy change in the bulk region is given by

Thus, we conclude that the chiralphase transition does not have any serious e ect on the initial total axion num ber in the com oving volum e.

#### VI. RESULT

The axion energy density, using the new numbers on the current quark masses [18] and including anharm onic e ect and QCD phase transition e ect, is estimated as

where we used Z  $m_u = m_d = 0.5$ ,  $m_o = 135.5$  MeV, f = 93 MeV and  $g_s$  (present)= 3.91,  $f(_1)$  is the anharmonic correction given in Eq. (13) and is the entropy increase ratio. Inserting Eqs.(8) to (28), we obtain for  $_1$  1

for  $_{QCD}$  = 320 MeV, 380 MeV, and 440 MeV, respectively. For the critical density  $_{c}$  = 3:978 10 <sup>11</sup> (h=0:701)<sup>2</sup> (eV)<sup>4</sup>, the axion energy fraction is given by

for  $_{QCD} = 320 \text{ MeV}$ , 380 MeV, and 440 MeV, respectively. From this result, we can determ ine the cosmological bound on the axion decay constant  $F_a$  which is presented in Fig. 9. In Fig. 9, the yellow band shows the error bars of and two red lines are the allowed limits of the current quark masses, Z. From the W MAP ve year data [2],  $_{DM}$  h<sup>2</sup> ' 0:1143 0:0034, we obtain the bound  $F_a$   $10^{12}$ GeV for  $_1$  O (1). For  $_1 = \stackrel{P}{} = 0.18$ ,  $F_a$   $10^{13}$  GeV is allowed. The increase of a factor of few on the upper bound of  $F_a$  mainly comes from the currently used sm aller current quark masses compared to the previous ones, and the overshoot of the adiabatic invariant  $\overline{I}$  from the initial misalignment angle  $_1$ .

## VII. CONCLUSION

In conclusion, we presented a new expression for the cosm ic axion energy density using the new values for the current quark m asses, in plem enting the QCD chiralsym – m etry breaking and the adiabatic invariant I. We included the e ect of anharm onic terms also. Using the adiabatic invariant quantity I, we presented the correction function F to the anharm onic e ect and a factor 1.85 which arose from the overshoot from  $_1$ . Using the bag m odel for the phase transition in the early universe, the axion num ber is shown to be conserved in m ost circum stances. If the axion num ber change is considered

during the phase transition, it is extrem ely ne-tuned in the  $T_i$   $T_f$  space, in which case the only change is from a small entropy production during the phase transition. In this way, we obtain a factor of few larger bound on  $F_a$  compared to the previous ones even for the smaller requirement on  $_a$ . O f course, for a small  $_1$  a strip with large  $F_a$  s is allowed, which has been used in the anthropic arguments [19].
