## Sem ileptonic B<sub>q</sub>! D<sub>q</sub>l (q = s;d;u) Decays in QCD Sum Rules

#### A bstract

The form factors relevant to  $B_q ! D_q (J^P = 1)$  ' (q = s;d;u) decays are calculated in the fram ework of the three point QCD sum rules approach. The heavy quark e ective theory prediction of the form factors as well as  $1=m_b$  corrections to those form factors are obtained. A comparison of the results for the ratio of form factors at zero recoil limit and other values of  $q^2$  with the predictions of the subleading IsgurW ise form factor application for B ! D ' is presented. The total decay width and branching ratio for these decays are also evaluated using the  $q^2$  dependencies of these form factors. The results are in good agreement with the constituent quark meson model and existing experimental data. The q = s case can also be detected at LHC in the near future.

### 1 Introduction

Sem ileptonic pseudoscalar  $B_q$  decays are crucial tools to restrict the Standard M odel (SM ) parameters and search for new physics beyond the SM. These decays provide possibility to calculate the elements of the C abbibo-K obayashiM askawa (CKM) m atrix, leptonic decay constants as well as the origin of the CP violation.

When LHC begins to operate, a large number of  $B_q$  m exons will be produced. This will provide experimental framework to check the  $B_q$  decay channels. An important class of  $B_s$  and entire  $B_{u;d}$  decays occur via the b quark decays. Among the b decays, b! c transition plays a significant role, because this transition is the most dominant transition among b decays. Some of the B decay channels could be  $B_q$ !  $D_q l$  (q = s;d;u) via b! c transition. These decays could give useful information about the structure of the vector  $D_s$  m esons. The observation of two narrow resonances with charm and strangeness,  $D_{sJ}$  (2317) in the  $D_s$  <sup>0</sup> invariant m ass distribution [1]{[6], and  $D_{sJ}$  (2460) in the  $D_{s_0}$  (2317) !  $D_s$ ,  $D_{sJ}$  (2460) !  $D_s$  and  $D_{sJ}$  (2460) !  $D_{s_0}$  (2317) indicates that the quark content of these m esons is probably cs [11].

Form factors are central objects in studying of the semileptonic  $B_q$  !  $D_q l$  decays. For the calculation of these form factors, we need reliable nonperturbative approaches. Am ong all non-perturbative models, the QCD sum rules has received especial attention since this model is based on the QCD Lagrangian. QCD sum rules is a fram ework which connects hadronic param eters with QCD parameters. In this method, hadrons are represented by their interpolating currents taken at large virtualities. The correlation function is calculated in hadrons and quark-gluon languages. The physical quantities are determ ined by m atching these two representations of correlators. The application of sum rules has been extended rem arkably during the past twenty years and applied for wide variety of problems (For review see for example [12]).

The aim of this paper is to analyze the sem ileptonic  $B_q ! D_q l$  decays using three point QCD sum rules method. Note that, this problem has been studied for  $B_q ! D_q l$  (q = s;d;u) in constituent quark meson (CQM) model in [13] and for q = d;u (B<sup>0</sup>;B) cases in experiment [14]. The application of subleading Isgur-W ise form factor for B ! D l at heavy quark e ective theory (HQET) is calculated in [15] (see also [16, 17]). Present work takes into account the SU (3) symmetry breaking and could be considered as an extension of the form factors of D ! K e presented in [18].

The paper is organized as fallow: In section II, sum rules expressions for form factors relevant to these decays and their HQET limit and  $1=m_b$ corrections are obtained. The num erical analysis for form factors and their HQET limit at zero recoil and other values of y, conclusion and comparison of our results with the other approaches are presented in section III.

# 2 Sum rules for the B<sub>q</sub> ! D<sub>q</sub> ' transition form factors

The  $B_q ! D_q$  transitions occur via the b! c transition at the quark level. At this level, the matrix element for this transition is given by:

To derive the matrix elements for  $B_q ! D_q l$  decays, it is necessary to sandwich Eq. (1) between initial and nalmeson states. The amplitude of

the  $B_q$ !  $D_q$ l decays can be written as follows:

The aim is to calculate the matrix element  $\langle D_q (p^0; ") j\bar{c} (1_5) b j B_q (p) \rangle$  appearing in Eq. (2). Both the vector and the axial vector part of  $\bar{c}$  (1<sub>5</sub>)b contribute to the matrix element stated above. Considering Lorentz and parity invariances, this matrix element can be parameterized in terms of the form factors below :

where  $f_V(q^2)$ ,  $f_0(q^2)$ ,  $f_+(q^2)$  and  $f(q^2)$  are the transition form factors and  $P = (p + p^0)$ ,  $q = (p \quad p^0)$ . In order to calculate these form factors, the QCD sum rules method is applied. Initially the following correlator is considered:

where  $J_{D_q}(y) = \overline{q}$  c and  $J_{B_q}(x) = \overline{b}_5 q$  are the interpolating currents of  $D_q$ and  $B_q$  m exons, respectively and  $J^V = \overline{c}_5$  b and  $J^A = \overline{c}_5$  b are vector and axial vector transition currents. Two complete sets of intermediate states with the same quantum numbers as the currents  $J_{D_q}$  and  $J_{B_q}$  are inserted to calculate the phenom enological part of the correlation function given in Eq. (5). A fler standard calculations, the following equation is obtained:

where represents contributions coming from higher states and continuum. The matrix elements in Eq. (6) are de ned as:

where  $f_{D_q}$  and  $f_{B_q}$  are the leptonic decay constants of  $D_q$  and  $B_q$  m esons, respectively. Using Eq. (3), Eq. (4) and Eq. (7) and perform ing sum m ation over the polarization of the  $D_q$  m eson in Eq. (6) the equation below are derived:

From the QCD (theoretical) sides,  $(p^2; p^2; q^2)$  can also be calculated by the help of OPE in the deep space-like region where  $p^2$   $(m_b + m_q)^2$ and  $p^2$   $(m_c + m_q)^2$ . The theoretical part of the correlation function is calculated by m eans of OPE, and up to operators having dimension d = 6, it is determined by the bare-loop (Fig. 1 a) and the power corrections (Fig. 1 b, c, d) from the operators with d = 3, < - >, d = 4,  $m_s < -$  >, d = 5,  $m_0^2 < -$  > and d = 6, < - >. The d = 6 operator is ignored in the calculations. To calculate the bare-loop contribution, the

double dispersion representation for the coe cients of corresponding Lorentz structures appearing in the correlation function are used:

The spectral densities  $_{i}(s;s^{0};q^{2})$  can be calculated from the usual Feynm an integral with the help of Cutkosky rules, i.e., by replacing the quark propagators with D irac delta functions:  $\frac{1}{p^{2} m^{2}}$ ! 2 ( $p^{2} m^{2}$ ); which im plies that all quarks are real. A fter long and straightforward calculations for the corresponding spectral densities the follow ing expressions are obtained:

The subscripts V, 0 and correspond to the coe cients of the structures proportional to i"  $p^0 p$ , g and  $\frac{1}{2}(p p p^0 p)$ , respectively. In Eq. (10) N<sub>c</sub> = 3 is the number of colors.

The integration region for the perturbative contribution in Eq. (9) is determined from the condition that arguments of the three functions must vanish simultaneously. The physical region in s and  $s^0$  plane is described by

the following inequalities:

From this inequalities, we calculate s in term s of  $s^0$  in order to put to the lower lim it of integration over s. For the contribution of power corrections, i.e., the contributions of operators with dimensions d = 3, 4 and 5, the following results were derived:

Here, we should mention that the contribution of higher dimensions are proportional to the powers of the inverse of the heavy quark masses, so this contributions are suppressed.

Next, we present the in nite heavy quark mass limit of the form factors for  $B_q$  !  $D_q$  l transitions. In HQET, the following procedure are used (see [19, 20, 21]). First, we use the following parametrization:

### 3 Num erical analysis

This section is devoted by num erical analysis for the form factors  $f_v$  (q<sup>2</sup>),  $f_0(q^2)$ ,  $f_+(q^2)$  and  $f(q^2)$ . From sum rule expressions of these form factors it is clear that the condensates, leptonic decay constants of B  $_{\rm q}$  and D  $_{\rm a}$  m esons, continuum thresholds  $s_0$  and  $s_0^0$  and Borel parameters M  $_1^2$  and M  $_2^2$  are the main input parameters. In the numerical analysis the values of the condensates are chosen at a xed renormalization scale of about 1 GeV. The values of the condensates are [23] :  $<\overline{u}u > = <\overline{d}d > =$ (240 10 M eV<sup>3</sup>, <  $\overline{ss}$  >= (0.8 0.2) <  $\overline{u}u$  > and  $m_0^2$  = 0.8 GeV<sup>2</sup>. The quark masses are taken to be  $m_c$  ( =  $m_c$ ) = 1.275 0.015 GeV,  $m_s$  = 95  $25~{\rm M}$  eV , 3) M eV,  $m_d$  ' (3 5) M eV [4] and  $m_b$  = (4:7)  $m_u = (1:5)$ 0:1) G eV [23]. The mesons masses are chosen to be m  $_{\rm D_{s}}$  = 2.112 GeV , m  $_{\rm D_{u}}$  = 2:007 GeV , m  $_{\rm D_{d}}$  = 2:010 GeV , m  $_{\rm B_{s}}$  = 5:3 GeV , m  $_{\rm B_{d}}$  = 5:2794 GeV and  $m_{B_u} = 5.2790 \text{ GeV}$  [14]. For the values of the leptonic decay constants of  $B_q$ and D  $_{\rm q}$  m esons the results obtained from two-point QCD analysis are used:  $f_{B_s} = 0.209$  38 GeV [2],  $f_{D_s} = 0.266$  0.032 GeV [1]. For the others  $f_{B_{d(u)}} = 0.14$  0.01 GeV and  $f_{D_{d(u)}} = 0.23$  0.02 GeV [4] are selected. The threshold parameters  $s_0$  and  $s_0^0$  are also determ ined from the two-point QCD sum rules:  $s_0 = (35 \ 2) \text{ GeV}^2$  [24] and  $s_0^0 = (6 \ 8) \text{ GeV}^2$  [11]. The Borelparam eters M  $_1^2$  and M  $_2^2$  are not physical quantities, hence form factors should not depend on them . The reliable regions for the Borel param eters M  $_1^2$  and  $M_2^2$  can be determined by requiring that both the continuum contribution and the contribution of the operator with the highest dimension be small. As a result of the above-m entioned requirem ents, the working regions are determ ined to be 10 G eV  $^2$  < M  $_1^2$  < 25 G eV  $^2$  and 4 G eV  $^2$  < M  $_2^2$  < 10 G eV  $^2$ .

To determ ine the decay width of  $B_q ! D_q l$ , the  $q^2$  dependence of the form factors  $f_V(q^2)$ ,  $f_0(q^2)$ ,  $f_+(q^2)$  and  $f_-(q^2)$  in the whole physical region

 $m_1^2 \quad q^2 \quad (m_{B_q} \quad m_{D_q})^2$  are needed. The value of the form factors at  $q^2 = 0$  are given in Table 1.

The q<sup>2</sup> dependence of the form factors can be calculated from QCD sum rules (for details, see [18, 25]). To obtain the q<sup>2</sup> dependent expressions of the form factors from QCD sum rules, q<sup>2</sup> should be stay approximately 1 G eV<sup>2</sup> below the perturbative cut, i.e., up to 10 G eV<sup>2</sup>. Our sum rules, also, are truncated at ' 10 G eV<sup>2</sup>, but in the interval 0  $\dot{q}$  10 G eV<sup>2</sup> we can trust the sum rules. For the reliability of the sum rules in the full physical region, the parametrization of the form factors were identied such that in the region 0  $\dot{q}$  10 G eV<sup>2</sup>, these parameterizations coincide with the sum rules prediction. Figs. 2, 3, 4 and 5 show the dependence of the form factors form factors, we choose the following two t functions.

where  $\hat{q} = q^2 = m_{B_q}^2$ . The values of the parameters  $f_i(0)$ ; ; ; , and are given in Tables 2, 3 and 4.

The values for a, b and m  $_{fit}^2$  are given in Tables 5, 6 and 7. For details about the tparam etrization (ii) which is theoretically m ore reliable and som e other

t functions see [26, 27]. These two param eterizations coincide well with the sum nules predictions in the whole physical region 0  $q^2$  10 G eV<sup>2</sup> and also for  $q^2 < 0$  region. For higher  $q^2$ , starting from the upper lim it of the physical region the two t functions deviate from each other and this behavior is almost the same for all form factors. As an example, we present the deviation of above mentioned t functions in Fig. 6. From this gure, we see that in the outside of the physical region the t (i) grow thes more rapidly than t (ii). The t param etrization (ii) depicts that the m<sub>B</sub> pole exists outside the allowed physical region and related to that one could calculate the hadronic param eters such as  $g_{BB}$  (see [26, 28]).

In deriving the num erical values for the ratio of the form factors at HQET limit, we take the value of the and obtained from two point sum rules, = 0.62 GeV [29] and = 0.86 GeV [30]. The following relations are de ned for the ratio of the form factors,

the subleading Isgur-W ise form factors for B ! D ' are shown in Table 8. Note that the values in this Table are obtained with  $T_1 = T_2 = 2 \text{ GeV}$  correspond to M  $_1^2 = 19 \text{ GeV}^2$  and M  $_2^2 = 5 \text{ GeV}^2$  which are used in Tables [2-7].

Table 8 shows a good consistency between our results and the prediction of [15] for  $R_1$  at zero recoil limit, y = 1:1 and 1:2, but for the other values of y, the changes in present work results are little greater. The values for  $R_2$  shows an approximate agreement between two predictions, however the changes in the value of  $R_2$  in our work is also a bit more then [15]. For both  $R_1$  and  $R_2$ , our study and [15] predictions have the same behavior, i.e.,  $R_1$ decreases when the value of y is increased and increasing in the value of y causes the increasing in the value of  $R_2$ . From this Table, we also see that the

 $R_4$  is sensitive to the changes in the value of y. However, the results of  $R_3$ ,  $R_5$  and  $R_6$  vary slow ly with respect to y. Our numerical analysis for 1=m b corrections of form factors in Eq. (25) shows that this correction increase the HQET limit of the form factors  $f_V$  and  $f_+$  about  $7:1^0=_0$  and  $6^0=_0$ , respectively, how ever it doesn't change the  $f_0$  and decrease the f about  $6:5^0=_0$ .

The next step is to calculate the di erential decay width in terms of the form factors. A fler some calculations for di erential decay rate

The follow ing part presents evaluation of the value of the branching ratio of these decays. Taking into account the q<sup>2</sup> dependence of the form factors and perform ing integration over q<sup>2</sup> in the intervalm  $_{1}^{2}$   $q^{2}$  ( $m_{B_{q}}$   $m_{D_{q}}$ )<sup>2</sup> and using the total life-times  $_{B_{u}} = 1:638$  10<sup>12</sup>s,  $_{B_{d}} = 1:53$  10<sup>12</sup>s [14] and  $_{B_{s}} = 1:46$  10<sup>12</sup>s [31], the branching ratios which are the same for both t functions are obtained as:

The ranges appearing in the above equations are related to the di erent lepton m asses (m $_{\rm e}$ ; m;m) as well as the errors in the value of input param eters. Finally, we would like to compare our results of the branching ratios with the predictions of CQM model [13] and existing experimental data in Table 9. From this Table, we see a good agreem ent among the phenom enological models and the experiment for u and d cases. However for s case our results are about 1.7 times sm aller than that of the CQM model. A loo, there is a same behavior between present work results and the experiment. In the experiment, the value for branching ratios decreases from u to d. In our results also, this value decreases from u to s cases. The order of the branching fraction in present work for  $B_s$ !  $D_s$ ' decay shows that this transition could also be detected at LHC in the near future. For the present and future experiments about the sem ileptonic b! cl based decays see  $[32]{[37]}$ and references therein. The comparison of results from the experiments and phenom enological models like QCD sum rules could give useful information about the strong interaction inside the D  $_{\rm s}$  and its structure.

In conclusion, the form factors related to the  $B_q ! D_q$ ' decays were calculated using QCD sum rules approach. The HQET limit of the form factors as well as  $1=m_b$  corrections to those limits were also obtained. A comparison of the results of form factors in HQET limit with the application of the subleading IsgurW ise form factors at zero recoil limit and others values of y was presented. Taking into account the  $q^2$  dependencies of the form factors, the total decay width and branching ratio for these decays were evaluated. Our results are in good agreement with that of the CQM m odel and existing experimental data. The result of  $B_s ! D_s$ ' case shows a

possibility to detect this decay channel at LHC in the near future.
