A direct m easurem ent of the Bose-E instein C ondensation universality class in N iC l_2 -4SC (N H $_2$) $_2$ at ultra-low tem peratures

In this work, we demonstrate eld-induced Bose-Einstein condensation (BEC) in the organic compound N iC l_2 -4SC (NH₂)₂ using AC susceptibility measurements down to 1 mK. The N i S=1 spins exhibit 3D XY antiferrom agnetism between a lower critical eld H_{c1} 2 T and a upper critical eld H_{c2} 12 T. The results show a power-law temperature dependence of the phase transition line H_{c1}(T) H_{c1}(0) = aT with = 1.47 0.10 and H_{c1}(0) = 2.053 T, consistent with the 3D Bose-Einstein Condensation universality class. An abnorm alchange was found in the phase boundary near H_{c2} at approximately 150 mK.

The idea of B ose-E instein condensation (BEC) occurring in the spin system s of certain quantum m agnets with axial sym m etry has been explored extensively in the past few years [1]. This idea was rst suggested by A eck in 1991 [2] and rst investigated experim entally in the compound T C uC $\downarrow_{\rm B}$ [3]. A lthough BEC in T C uC $\downarrow_{\rm B}$ was later called into question in an off-overlooked electron spin resonance (ESR) study [4], the work on T C uC $\downarrow_{\rm B}$ generated a urry of experim ental and theoretical activity in the eld and m any new candidate BEC system s have since

been proposed [5, 6, 7, 8, 9, 10, 11, 12, 13].

In these compounds, the axial symmetry of the spins allowsXY antiferrom agnetic order to occur over certain ranges oftem perature and magnetic eld. Near the criticalm agnetic elds where the long-range order is induced or suppressed, the spin system can be mapped onto a system of dilute hard-core bosons on a lattice and the eld-induced quantum phase transition at the boundary of the long-range ordered state can be modeled as a Bose-Einstein condensation [14, 15, 16, 17, 18]. The caveat is that in quantum magnets the boson number is proportional to the longitudinal magnetization, and thus is conserved in equilibrium rather than strictly on all time scales. Therefore, in quantum magnets only the therm odynam ic properties of the system should follow the predictions of BEC theory and nonequilibrium e ects such as supercurrents will not occur. Nevertheless, these com pounds provide an im portant test of BEC phase transition in the therm odynam ic lim it.

A key experimental signature of BEC is a powerlaw temperature-dependence of the number of condensed bosons with an exponent of 3/2. This power-law is the low-temperature limit of the boson distribution function. In the spin systems this translates to a power-law tem perature dependence of the critical eld line H_c (0) / T where = 3=2 [19, 20]. It is important to note that this power-law is valid in the limit of very low tem peratures. So far very few quantum magnet BEC candi-

date have been studied at tem peratures well below the energy scales for boson interactions, which are given by the antiferrom agnetic couplings between spins. Furtherm ore, if the tem perature range at which the power-law t is perform ed is far from zero tem perature, then it is very di cult to accurately identify the intercept, and the resulting power-law exponent that is derived from the t is highly dependent on the value of the intercept used [21]. One way to circum vent this problem is the windowing m ethod in which the intercept and the exponent are determ ined m ore-or-less independently by perform ing ts over di erent tem perature ranges and extrapolating the values of the intercept and the exponent to zero tem perature [22]. However, this extrapolation technique from higher tem peratures does not always correspond to the actual low-tem perature behavior as was seen in the com pound B aC uSi₂O₆, where at tem peratures above 1 K, the windowing method yields one exponent, but due to a reduction in dimensionality of the spin system, a di erent exponent can be observed at lower tem peratures [23].

Here we report a direct observation of the 3/2 power law exponent of the 3D BEC universality class at ultra low temperatures in the compound DTN (NiCl-4SC (NH₂)₂). Ourmeasurements were performed at temperatures down to 1 mK, which is two orders of magnitude below the lowest temperature scale for magnetic coupling in this system $J_a = 180 \text{ mK}$, and the lowest temperature ever used to investigate BEC in a quantum magnet. Thus we do not have to use any extrapolation to determ ine the power-law exponent.

The organic magnet DTN contains $S = 1 \text{ N} f^+$ atom s that form two interpenetrating tetragonal lattices. At zero eld, a uniaxial anisotropy D 9 K splits the N i S = 1 triplet into a $S_z = 0$ ground state and a $S_z = 1 \text{ excited doublet}$. The $S_z = 1$ state can be suppressed with applied magnetic elds along the tetragonal c-axis via the Zeem an e ect, thus producing a magnetic ground state above H $_{c1} = 2:1 \text{ T}$. A ntiferrom agnetic coupling between

the Niatom s with exchange strength $J_c = 1.8$ K along the c-axis and $J_a = 0.18$ K perpendicular to the c-axis produces long-range antiferrom agnetic order [24]. The long-range order occurs in a dom e-shaped region of the Т H phase diagram between H $_{c1}$, where the magnetic ground state is induced, and H_{c2} where the spins align with the applied magnetic eld and below T = 1 K[]. The X Y sym m etry, the m agnetic exchange couplings and the uniaxial anisotropy D have been identi ed via inelastic neutron scattering and electron spin resonance (ESR). The power-law dependence of the critical eld line H_{c1} was previously investigated using speci c heat, m agnetocaloric e ect and m agnetization m easurem ents down to a m in in um tem perature of 100 m K [7, 25] using the windowing method, and a power-law consistent with = 3=2 was determ ined. The validity of this power-law was called into question however due to the fact that it is an extrapolation rather a direct measurem ent in particular in light of the recent new results for BaCuSio 6 showing a di erent exponent at low tem peratures. [23]

W e have now m easured the power-law tem perature dependence of the critical eld H_{c1} down to 1 m K using AC susceptibility m easurem ents. The experim ents were carried out using a PrN is nuclear refrigerator and a 15 T m agnet at the High B = T facility of N ational High M agnetic Field Laboratory. The sample was immersed in liquid ³He in a polycarbonate cell, and therm al contact to the refrigerator was assured via sintered silver that was an integral part of an assembly of annealed silver rods extending form the nuclear refrigerator. The tem perature was calibrated by a ³H e m elting-pressure curve therm om eterm ounted in the zero- eld region of the magnet, at the top of the nuclear stage. Both AC and DC magnetic elds were applied in the direction parallel to the c-axis of the single crystal of DTN. An AC signal with an amplitude of 0.5 1 G and a low frequency of 275 Hz was generated in a primary coil wound from superconducting NbT iw ire, thereby avoiding heating at ultra-low temperatures. The AC susceptibility ac was m easured by sweeping the external DC eld at rates between 0.1 and 0.001 T/m in while the tem perature was xed at various values between 270 and 1.0 mK.

Fig. 1 shows three traces of AC susceptibility $_{\rm ac}$ for tem peratures of 20, 150, and 600 mK with a relatively fast sweep rate of 0.054 T/m in. The typical eld-induced long-range AFM (BEC) transitions appears as steps in these traces with H $_{\rm c1}$ 2 T and H $_{\rm c2}$ 12 T. As the tem perature is low ered, the steps become sharper and a peak develops near H $_{\rm c2}$.

The values of H_{c1} and H_{c2} were determined from the peak in the st derivative of the AC susceptibility d_{ac}=dH, as shown in the inset of Fig. 2. In the critical

eld -tem perature phase diagram shown in Fig.2(a) and Fig.2(b), the tem perature dependence of H_{c1} and H_{c2} have been plotted separately. The data points in Fig.2 were collected from the magnetization traces with a eld

sweep-rate of 0.0068 T/m in As shown in Fig.2(a), H_{c2} saturates at 12.175 T as T approaches zero. However, there exists a region marked by a dashed circle at approximately 150 mK, where a shoulder appears. The origin of this anomaly is unclear at this point.

For H_{c1} in Fig. 2(b), we tapower-law temperature dependence H $_{\rm c1}$ (T) $\,$ H $_{\rm c1}$ (O) = aT $\,$ to the data between 1 and 260 mK, yielding an intercept of 2.053 T and an exponent of 1:47 0:1 as shown in Fig. 1. In order to dem onstrate that the exponent is robust and independent of the intercept, we also perform ed ts to the data with the intercept held xed for various intercepts between 2.04 and 2.06 T in Fig. 3. The table in the gure indicates the exponent, it's error bar, and the value of 2 for each t. The intercept with the lowest value of 2 is $H_{c1}(0) = 2.053 \text{ T}$, yielding an exponent of 1.46 in that t. Furtherm ore, all the ts for all the intercepts yield values close to 1.5. Finally we show H_{c1} as a function of T^{1:5} in Fig. 4. The inset shows the same data as a function of T², show ing that we can rule out that tem perature dependence. Thus the best tyields an exponent = 1:47 0:1, which closely m atches the expected exponent = 1:5 for a quantum phase transition in the 3D BEC universality class. O ther nearby universality classes such as the 3D Ising (= 2) and 2D BEC (= 1) can be excluded.

Finally, we found that DTN reached therm al equilibrium at 1 mK in a few m inutes which is short in com – parison with other solid sam ples that we have measured in the same con guration, including heavy ferm ion and two-dimensional electronic gas sam ples with cooling time constants as long as hours [26]. DTN as well as the other sam ples mentioned here were immersed in the liquid ³He,

rather than being glued to a cold nger. There are several possible explanations for the short therm al equilibrium time at low temperatures. Firstly, the bose structure of DTN may enhance the cooling e ciency. The ³He atoms can penetrate into the interlayer distance of 8.981 A. Secondly, there exist possible exchange interactions between the spins of the ³He atom s and electrons in the sam ple. Finally, a compatibility between phonon vibration m odes in the ³He and the sam ple may play a role.

In conclusion, we have established that the eld-induced quantum phase transition at H $_{\rm c1}$ in DTN belongs to the 3D BEC universality class by directly measuring the power-law exponent in the relation H $_{\rm c1}$ (T) H $_{\rm c1}$ (O) / T down to 1 mK. This is the rst example of a direct measurement of this exponent at temperatures far below the energy scales for antiferrom agnetic coupling in a magnetic insulator.
