Resonance e ects due to the excitation of surface Josephson plasm a waves in layered superconductors

Abstract

We analytically exam ine the excitation of surface Josephson plasma waves (SJPW s) in periodically-modulated layered superconductors. We show that the absorption of the incident electromagnetic wave can be substantially increased, for certain incident angles, due to the resonance excitation of SJPW s. The absorption increase is accompanied by the decrease of the specular rejection. Moreover, we not the physical conditions guaranteeing the total absorption (and total suppression of the specular rejection). These conditions can be realized for Bi2212 superconductor lms.

I. INTRODUCTION

Over the last twenty years, the physical properties of layered superconductors have attracted the attention of many research groups. The strongly-anisotropic high-tem perature $B_{\frac{1}{2}}Sr_{2}C$ aC $u_{2}O_{8+}$ single crystals are the most prominent members of this family. Numerous experiments on the c-axis transport in layered high- T_{c} superconductors (HTS) justify the use of a model in which the superconducting CuO_{2} layers are coupled, through the block layers, by the intrinsic Josephson e ect. The Josephson current lowing along the c-axis is coupled with the electromagnetic eld inside the insulating dielectric layers, thereby causing a special kind of elementary excitations called Josephson plasma waves (JPW s) (see, e.g., Ref. 1). In other words, the layered structure of Bi-based superconductors and related compounds favors the propagation of electromagnetic waves through the layers. These waves are of considerable interest because of their terahertz (THz) and sub-THz frequency ranges, which are still hardly reachable for both electronic and optical devices. The frequencies of terahertz waves are in the region of resonance frequencies of molecules and are expected to have many applications.

The unusual optical properties of layered superconductors, including their re ectivity and transm issivity, caused by the JPW s excitation, were studied, e.g., in Ref. 2. Earlier works on this problem have focused on the propagation of bulk waves, that is possible in the frequency range above the Josephson plasma frequency $!_{J}$, at $! > !_{J}$, only. The presence of the sample boundary can produce a new branch of the wave spectrum below the Josephson plasma frequency, $! < !_{J}$, i.e., surface Josephson plasma waves (SJPW s), which are an analog of the surface plasm on polaritons^{3,4}. Recently, the existence of SJPW s in layered superconductors in the THz frequency range was predicted^{5,6}. Surface waves play an important role in many fundamental resonance optics phenomena⁷, such as the Wood's anomalies in rejectivity^{4,8} and transmissivity^{9,10} of periodically-corrugated metal samples. A recent overview of unusual resonators can be found in Ref. 7. Therefore, it is essential to study similar resonance phenomena caused by the excitation of surface waves in layered superconductors.

The dispersion curve, ! (q), of the surface waves lies below the \vacuum light line", ! = cq, where q is the wave-number and c is the speed of light. This means that the surface waves have wave-vectors greater than the wave-vectors of light of the same frequency in

vacuum. Thus, to excite the surface waves by m eans of incident irradiation, it is necessary to use special methods⁴, such as, e.g., the attenuated total method (ATR) method and the surface modulation method.

In this paper, we study the excitation of surface Josephson plasm a waves while di-racting the electrom agnetic wave incident onto the periodically-modulated layered superconductor. For simplicity, we present results for single-resonance cases, when only one SJPW is excited. The excitation of SJPW is a extisted absorption and re-extinon of the incident electrom agnetic waves, specifically, determining their resonance dependence on the frequency! and the incident angle. These phenomena are potentially useful for detecting THz radiation.

II. MODEL




FIG.1: (Color online) Geometry of the problem: k and k_0 are the wave-vectors of the incident and specularly rejected waves, k_0 is the wave-number of the SJPW. The case of backward resonance direction in the rth order (r < 0) is shown. Also, k_0 and k_0 are the wave-vectors of the incident and specularly rejected wave and k_0 are the wave-vectors of the incident and specularly rejected wave-vectors of the wave-number of the SJPW. The case of backward resonance direction in the rth order (r < 0) is shown. Also, k_0 are the wave-vectors of the incident and specularly rejected wave-vectors of the wave-number of the SJPW. The case of backward resonance direction in the rth order (r < 0) is shown. Also, k_0 are the wave-vectors of the incident and specularly rejected wave-vectors of the wave-number of the SJPW. The case of backward resonance direction in the rth order (r < 0) is shown. Also, k_0 and k_0 are the wave-vectors of the incident and specularly rejected wave-vectors of the wave-number of the SJPW. The case of backward resonance wave-vectors of the resonance wave, and k_0 are the wave-vectors of the incident and specularly rejected wave-vectors of the resonance wave, and k_0 are the wave-vectors of the incident and k_0 are the wave-vectors of the incident and k_0 are the wave-vectors of the problem:

Consider a sem i-in nite layered superconductor in the simplest geometry shown in Fig. 1.

The crystallographic ab-plane coincides with the xy-plane and the c-axis is directed along the z-axis. Superconducting layers are numbered by an integer l 1.

Suppose that the maximum c-axis Josephson current density, J_c , is periodically modulated in the x-direction with a spatial period L. Such a modulation can be realized, for instance, either by irradiating a standard $B_2Sr_2CaCu_2O_{8+}$ sample covered by a modulated mask¹¹ or by pancake vortices controlled by an out-of-plane magnetic eld^{12} .

A p-polarized (transverse magnetic) plane monochromatic electromagnetic wave with electric, $E = fE_x$; 0; E_z g, and magnetic, H = f0; H; 0g, elds is incident onto a periodically-modulated layered superconductor at an angle from the vacuum half-space. The in-plane and out-of-plane components of its wave-vector are

where H inc is the amplitude of the incident wave and R $_{n}$ are the transform ation coe cients (TCs). The time dependence exp (i!t) is omitted hereafter.

U sing M axwell equations, we express the tangential component of the electric eld in the vacuum in terms of the magnetic eld,

As was shown in Ref. 14, the intralayer quasi-particle conductivity, ab, should also be taken into account if! is far enough from the Josephson plasm a frequency. The contribution of the in-plane conductivity to the dissipation can be easily incorporated in our analysis. However, for the frequency range considered here (close to !,), this contribution is strongly suppressed and can be safely om itted because the relative value of the term with ab is

III. DIFFRACTION OF THE ELECTROM AGNETIC FIELD

Inside the layered superconductor, we represent the gauge-invariant phase di erence and the electrom agnetic eld as expansions over the eigenfunctions,

To solve the in nite set of equations (18) for C_s we use resonant perturbation theory, which allows presenting results in an explicit analytical form 15 .

When all spatial eld harm onics are far away from the eigen-modes of the unmodulated layered superconductor (nonresonance conditions), the diagonal elements b_s of the matrix \hat{D} $kD_{njs}k$ are of the order of one or larger, b_sj $j_s^Vj_s$ 1. In this case, the matrix \hat{D} is diagonal-dominated, that is, its o-diagonal elements are small compared to the diagonal ones, $jb_{njs}j$ j_nsj j_sj . Then, the solution of Eqs. (18), (19) gives us a trivial result: the specular rejection TC, R_0 , is close to the Fresnel coefficient,

A much more interesting case occurs under the resonance conditions, when Eq. (1) holds for one (or simultaneously for two) spatial eld (resonance) harmonics,

Here r > 0 (r < 0) corresponds to the forward (backward) propagation of the excited SJPW with respect to the incident wave.

For simplicity, we restrict ourselves to the single-resonance case. In the resonant case, the diagonal matrix element D $_{rjr} = b_r$ becomes anomalously small, and the determinant of the matrix \hat{D} decreases signicantly (see, e.g., Ref. 15). Recall that the normalized z-component of the wave-vectors in vacuum, $_s^V$, can be either purely real or purely imaginary. Therefore, the minimum of b_rj 1 holds in the vicinity of the point in the (!;)-plane where Im $[_r^V] = [m \ [a_r]]$, which is the dispersion relation for SJPW s, Eq. (2).

where C_r C_r (;;) is the parameter that describes the coupling between waves in the vacuum and the layered superconductor. Below we assume the coupling parameter C_r to be small. However, even when jC_rj 1, the coupling of the waves in the vacuum and superconductor plays a very important role in the excitation of SJPW s and in the anomalies of the rejection properties (W ood's anomalies).

First, the dispersion relation of the surface Josephson plasm a waves is modiled, involving the radiation leakage in the vacuum. The new spectrum of the SJPW s is defined by equating the denominator in Eq. (34) to zero. Thus, the quadratic in the modulation term, C_r , is

responsible for the shift of the position of the resonance, Im $[C_r]$, and its widening, $Re[C_r]$. The region where the coupling $[C_r]$ 1 (when the radiation leakage of the excited SJPW does not dominate) corresponds to the strongest excitation of the surface waves by the incident waves.

Second, due to the coupling, the specular re-ection coe cient, R $_0$, in Eq. (33) diers from the Fresnel coe cient, R $_{\rm F}$, and its modulus becomes less than one. Moreover, as we show below, the re-ection of waves with any given frequency ! < ! $_{\rm J}$ can be totally suppressed, for the specic incident angle and the modulation magnitude. This provides a way to control and liter the THz radiation.

In the next section, we study in detail the strong e ects in the excitation of the SJPW s, the enhancement of absorptivity, and the suppression of the specular rejectivity near the resonance.

IV. SUPPRESSION OF THE SPECULAR REFLECTION

Second, the parameter a_r in Eq. (39) depends weakly on the angle—in the vicinity of the resonance, whereas it depends strongly on the frequency detuning (1), and its real part is sensitive to the magnitude—of the damping. It is clearly seen that $\Re_0 j_h$ in depends strongly on the frequency detuning (1), dissipation parameter , and the coupling between waves in the vacuum and the layered superconductor, i.e., on the modulation magnitude $jf_r j$. This o ers several important applications of the predicted anomaly of the rejectivity in the THz range. For instance, if the coupling parameter $\Re_r (r)$ is equal to $\Re_r (r)$ the modulation magnitude $f_r (r)$ takes on the optimal value,

then the specular rejection coefficient R $_0$ at # = # $_{\rm res}$ vanishes. This means that, by appropriate choice of the parameters, the total suppression of the rejectivity can be achieved due to the resonance excitation of the surface Josephson plasma wave.

In the vicinity of the resonance, the relative amplitude of the excited SJPW can be approximated by

Note that equations $\#=\#_{res}$ and $Re[C_r(;)]=C_{opt}$ (i.e., $jf_rj=jf_rj_{opt}$) constitute the conditions not only for the total suppression of the specular rejection, but also for the best matching of the incident wave and the SJPW. Under such conditions, the amplitude of the excited surface wave is much higher than the amplitude of the incident wave,

Thus, we can achieve a high concentration of THz radiation energy in the SJPW.

The resonant decrease of the amplitude of the specularly-relected wave is accompanied by the resonant increase of the absorption. Evidently, for the optimal conditions, $\# = \#_{res}$, $\#_{rj} = \#_{rj} \#_{pt}$, which correspond to the total suppression of the specular relectivity, the energy pumped into the layered superconductor from the vacuum can be completely transformed into Joule heat due to the quasiparticle resistance. For the direction on the harmonic grating, the dependence of the absorptivity coelient A on the wave frequency and the incident angle is described by a resonance curve,

accurate within terms of order $j_r \hat{j}$. It should be noted that the resonance increase of the electrom agnetic absorption can result in a transition of the superconductor into normal state. Thus, new kinds of resonance phenomena can be observed in layered superconductors due to the excitation of the SJPW s. However, for rather low intensities of the incident wave, the sample heating due to the Joule losses can be neglected.




FIG. 2: (Color online) Numerical simulation of the total suppression of the specular relection. Black solid and red dashed curves show the angular dependences of the specular and resonance TCs, respectively, for the forward resonance direction (r=1) on the harmonic grating. These calculations were performed using Eqs. (34), (35) for the harmonic grating with pitch $L=1\,\mathrm{mm}$ and modulation magnitude jf_rj= 3:65 10 6 . Other parameters used here are: D = 2 10 7 cm, $_{ab}=2.5\,$ 10 5 cm, $_{}=10\,^7$, $_{}=20$, and $_{}=10\,^7$ cm, and $_{}=10\,^7$ cm, $_{}=10$

We have illustrated our analytical results by the numerical calculations of the specular and resonance TCs given in Eqs. (35), (34). The angular dependences of $\Re_0 \mathring{f}$ and $\Re_r \mathring{f}$ for the forward resonance direction in the rst direction order (r=+1) on a harm onic grating are shown in Fig. 2. The asymptotic formulae (43), (51) are in a good agreement with these plots. The modulation magnitude, $jf_r j$ was chosen to achieve the total suppression of the specular rejection. Its value is close to $jf_r j_{pt}$ defined by the asymptotic expression (50).

The minimum in the specular re-ectivity (see Fig. 2) is caused by the destructive interference of the waves scattered via two di-erent channels. The inst channel is the direct (approximately total) re-ection from the unmodulated vacuum-layered superconductor interface. The magnetic-eld amplitude of this wave is approximately equal to that of the incident wave, R_F '1. The second channel is de-ned by a two-step scattering process: the di-raction of the incident wave into the SJPW and the re-scattering of the SJPW into the specular direction. By means of Eqs. (51), (43), one can easily follow the phase changes in the resonance and specular TCs. The value of X_F (#;) changes its sign when # crosses the point $\#_{res}$. Correspondingly, the R_F experiences the phase shift—while the phase of R_0 changes by 2 (see insets in Fig. 2).




FIG. 3: The magnetic eld distribution for the non-resonant case, $=60^{\circ}$, shown in (a), and for the resonant di raction in di raction order + 1, = res = 48:93°, shown in (b). O ther parameters are the same as in Fig. 2.

We also illustrated the e ect of total suppression of the specular re ection by the distribution of the total magnetic eld in the vacuum, Fig. 3. The interference pattern is seen for the non-resonant case, when the amplitudes of the incident and re ected waves practically coincide. Under the resonance condition, when the re ected wave is totally suppressed, the interference pattern in the far eld disappears, while the near-eld \torch" structure of the SJPW is clearly seen near the vacuum-layered superconductor interface.

C on clusion

In this paper, we present the detailed exam ination of the resonance features for the di raction of THz radiation on periodically-modulated layered superconductors. The resonance is caused by the excitation of the SJPW s for de nite combinations of the incident angle and frequency, and is analog to the widely studied surface plasm on polariton resonance in

the visible and near-infrared region. The analytical approach developed here allows us to predict strong resonance e ects (total suppression of the specular re ection and total absorption) for speci c combinations of the parameters. The simplest (in-plane) con guration for TM-polarized incident wave was exam ined here under single-resonance conditions (i.e., excitation of one running SJPW). This approach allows a similar study of the simultaneous excitation of two SJPWs (double resonance), as well as the exam ination of the so-called \conical direction mount" (out-of-plane direction). These items will be studied in the future. It seems interesting also to consider the resonance direction features for superconducting lms of nite thickness. There, the elects of resonance enhancement of the transmissivity could exist.

The strongly selective interaction of SJPW s with the incident wave having a certain frequency and direction of propagation can be used for designing future THz detectors and lters. For instance, the simplest design of a THz detector could be built around a BiSrCuCaO sample xed on a precisely rotated holder and attached by contacts to measure its resistance. When rotating the sample, the incident THz radiation would produce a surface wave at certain angles. This results in a strong enhancement of the absorption. Respectively, the sample temperature increases, thus, its resistance would increase.
