F in ite-Size Scaling of C lassical Long-R anged Ising C hains and the C riticality of D issipative Q uantum Im purity M odels

M otivated in part by quantum criticality in dissipative K ondo systems, we revisit the nite-size scaling of a classical Ising chain with $1=r^2$ interactions. For $\frac{1}{2} < < 1$, the scaling of the dynam ical spin susceptibility is sensitive to the degree of \winding" of the interaction under periodic boundary conditions. In nite winding yields the expected m ean-eld behavior, whereas without any winding the scaling is of an interacting !=T form. The contrast with the behavior of the B ose-Ferm iK ondo m odel suggests a breakdown of a mapping from the quantum m odel to a classical one due to the sm earing of the K ondo spin ips by the continuum lim it taken in this mapping.

Quantum criticality describes the collective uctuations of a continuous quantum phase transition. The standard theoretical picture [1] is that quantum critical

uctuations in d spatial dimensions can be described in terms of the uctuations of an order parameter (a classicalvariable) in d+z dimensions, where z is the dynamic exponent. However, there has been much recent interest in quantum critical points (QCPs) that do not conform to this quantum -to-classical mapping [2].

O ne setting to explore this issue is quantum impurity models that involve one orm ore dissipative bosonic baths having a sub-ohm ic (> 0) power-law spectrum

Here w_p is the dispersion of the bosonic bath (s) and is the Heaviside function specifying the high-energy cut-o !... For 1=2 < < 1, the ⁴ theory has a Gaussian xed point with a violation of != T scaling. However, the QCP in a large-N, xed- limit of a spin-rotation-invariant SU(N) SU(N) Bose-Ferm iK ondo m odel (BFKM) satis es != T scaling and, hence, is interacting 4]. Numerical renormalization-group (NRG) studies have also found interacting QCPs for 1=2 < < 1 in two quantum m odels with Ising anisotropy: the dissipative spin-boson model [5] and the Ising BFKM [6]. The failure of the quantum -to-classicalm apping has been attributed in the spin-rotation-invariant case to the Berry phase [7], but remains to be claried for Ising symmetry.

This Letter reports a two-pronged study of the classicalm apping of the quantum -critical Ising BFKM .First, we show that, for 1=2 < < 1, the scaling of the dynam ical spin susceptibility of the classical model as a function of system size and wave vector (corresponding in the quantum problem to temperature and M atsubara frequency, respectively) depends crucially on the \w inding" of the interaction to extend the range of the interaction beyond the nite system size. For in nite winding, one recovers the mean-eld $!=T^{1=(2-2)}$ scaling expected from the corresponding ⁴ theory, in which the quartic coupling acts as a dangerously irrelevant variable. Lim iting the winding introduces an additional temperature dependence dom inating that from the dangerously irrelevant coupling and giving rise for zero winding to !=Tscaling. Second, we provide strengthened evidence for non-mean- eld behavior in the BFKM. These ndings can be reconciled through a breakdown of the quantum to-classicalm apping arising from failure of the continuum lim it to fully preserve the elects of K ondo spin ips.

Bose-Fermi Kondo model and the classical Ising chain. The BFKM describes a quantum spin coupled to both a ferm ionic band and a bosonic bath. The Ham iltonian for the Ising-anisotropic case is

where S is a spin-1=2 localm on ent, the c_p 's represent a ferm ionic band with a constant density of states $_p$ (! $E_p) = N_0$ and on-site spin s_c , and the $_p$'s represent a bosonic bath having the spectrum in Eq. (1). For xed N_0J_K , a QCP at $g = g_c$ separates K ondo (or delocalized) and localm on ent (or localized) phases. For g = 0, the BFKM reduces to the conventional K ondo m odel.

The partition function associated with H_{BFKM} is [8] Z_{BFKM} Trexp(S_{mp}), where

and the trace is over the spin degrees of freedom . $_0^1$ (⁰), with short-time cuto $_c = 2 = !_c$, encodes the bath spectrum . K_c (⁰), which has a Fourier transform $K_c(i!_n) = j!_n j w$ ith $= N_0 J_K$, com es from integrating out the ferm ions.

Trotter decomposition of $S^0_{im\,p}$ (with time slice $_0$) requires identifying the elect of the transverse eld term

The nearest-neighbor interaction $K_{nn} = 2 \ln (_0 = 2)$, while the long-range interaction K_{lr} (i j) results from discretizing $_0^{-1}$ (0) K_c (0). The bosonic spectrum speci ed by Eq. (1) gives rise form ax ($_0$; $_c$) <

The inverse temperature = 1=T in the BFKM sets the length L = $=_0$ of the Ising chain, with the periodic boundary condition $S_{L+1}^z = S_1^z$ enforced by the trace operation. Varying the bosonic coupling g am ounts to changing the elective temperature T of the classical m odel (which bears no relation to T in the BFKM).

Classical Ising chains with this type of long-ranged interaction have been studied for decades, and it is well established that the phase transition for = 0 is K osterlitz-Thouless-like [9, 11] and is described over the range 0 < < 1 by a local ⁴ theory [3, 12]. For 0 < < 1=2 the phase transition is controlled by the interacting G inzburg-W ilson-F isher xed point, whereas for 1=2 < < 1 mean- eld behavior obtains.

In general, if the classical system is below its upper critical dimension, then close to the critical temperature T_c the only relevant scale is the nite system size, and the static part of the order-parameter correlation function should scale as $_{\rm static}(L) = L^x Y \ (L = 1), where 1 \qquad static (L = 1) \qquad (T \ T) \ . \ C \ om bined \ with static (L = 1) \qquad (T \ T) \ , we have x = = . \ From the hyperscaling relation = (2) and the fact3] that = 1 \ , we end up with x = 1 \ : at T =_c T$

Above the upper critical dimension, the nite-size scaling is complicated by the presence of dangerously irrelevant variables that introduce additional scales to the problem and destroy hyperscaling [13]. Extensive theoretical work [13, 14] has concluded that at $T = T_c$,

Beyond the static limit, the full scaling properties of the susceptibility have not been clari ed. W e are aware only of a nding (Fig. 4 of [5]) that (; L) fails to show any scaling collapse in terms of =L. Separately, a study of the phase diagram has hinted at the importance of the winding of the interaction around the nite-size Ising ring [16]. These considerations motivate us to carry out a careful analysis of the scaling of with particular attention to the elects of winding.

Finite-size scaling of the classical Ising chain. The interaction $_0^{-1}(^{-0})$ is specified by $_0^{-1}(!)$ Im $_0^{-1}(!+i0^+) = g^2!^{-1}$ sgn(!), which follows from Eq. (1) with the cuto $!_c$ taken to in nity:

We study the Ising chain with e ective spin-spin interaction $_0^{-1}($ 0 ;T;M) for di erent values of M, the maximum number of times that the interaction wraps around the Ising ring of length L. The j 0 j! 1 behavior is not altered by choosing a nite value of M. We use a cluster-updating M onte C arlo scheme [17, 18] to measure the dynamical susceptibility (!n;T) at coupling g = g_c (i.e., T = T_c in the classical model); !n = 2 n=(_0L), n = 0, 1, 2, ::: are the M atsubara frequencies of the quantum model. A binning analysis of our data shows that the relative error = . 10 ² and the integrated autocorrelation time is small.

For 0 < < 1=2, the scaling properties do not depend on the choice of M and the static susceptibility obeys Eq. (6). As a result, the dynam ic susceptibility scales as

Figure 1 illustrates this $!_n = T$ scaling for = 0.4 with M = 1 [part (a)] and $M = 10^9$ [part (b)].

For 1=2 < < 1, by contrast, the scaling properties depend cnucially on M, as exemplied in Fig.1 for = 0.8. The scaling plot for M = 1 [part (c)] in plies that $(!_n) \quad j!_n j^{0.2}$ and (T) T $^{0.2}$. Only for M ! 1 do we recover the anticipated mean-eld result of Eq. (7), as shown in Fig.1(d) for M = 10^9 . Between these extremes, there is a slow crossover with increasing M, exemplied by the evolution of $_{static}$ (T) [19]. Di culty in recovering mean-eld physics in this model has been observed in the context of the phase diagram [16], but the origin of this behavior and its in plication for $!_n=T$ scaling have not previously been recognized.

In obtaining Fig.1, we set = 0 and K_{nn} = 0 because the construction of clusters via continuous bond probabilities is e cient only for pure power-law interactions

[17]. For nonzero and K_{nn} , the calculations can be carried out only for a more limited range of $!_n$ and T, but the same behavior is found, as illustrated in Fig.2.

The di erence between the cases of in nite and zero winding can be understood as follows. The in nite-winding interaction $_0^{-1}(!_n;T;M = 1)$ depends only on $!_n$. The temperature dependence of $(!_n;T)$ is then entirely determined by that of the \spin self-energy"

The tem perature dependence of M is controlled by the dangerously irrelevant quartic coupling of the local $\,^4$ theory, and is proportional to T $^{1=2}$. On the other hand,

the zero-winding interaction $_0^{-1}(!_n = 0;T;M = 1)$ T¹, so $^{-1}(T;!_n)$ acquires tem perature dependence from both $_0^{-1}$ and M. The leading term varies as T¹, which overpowers the T¹⁼² from the dangerously irrelevant coupling, so the !=T form of Eq. (10) ensues. We have con med that this distinction between M = 1 and M = 1 is robust over the range 1=64 _0 1=4.

Quantum critical behavior of the BFKM. | W e have system atically extended previous NRG calculations [6] to investigate the robustness of the quantum critical behavior. Figure 3 shows data for = 0.8 that can be tted to static (T) T ^x overm one than 20 decades of T with x = 1 to better than 1% accuracy. The value of the exponent shows no system atic evolution as the bosonic truncation parameter N_B [6] increases from 8 to 20.

These NRG results, which are consistent with $!=\!T$ scaling, are in stark contrast with the $!=\!T^{1=(2-2)}$ scaling and exponent $x=1\!=\!2$ found in the regime $1\!=\!2<<1$ of the classical Ising chain (with in nite winding). This disparity signals the failure of the quantum -to-classical m apping for the QCP of the Ising BFKM .

The most likely source of the breakdown lies in the replacement of the spin- ip (transverse K ondo-coupling) term in the quantum model by a (@)² term in the local ⁴ theory. In the BFKM, spin ips are essential for the form ation of the K ondo-screened state and, by extension, central to the nature of the QCP displaying a critical K ondo e ect. (Spin ips are the one-dimensional analog of the vortices in, for instance, the short-range XY m odel in two dimensions.) In the local ⁴ theory, how ever, the (@)² term (i.e., the $!_n^2$ coupling) is overtaken at low frequencies by the j! $n \frac{1}{2}$ term associated with the long-range interactions of non-spin- ip type.

To expand on this point, the short-range interaction term in the discrete Ising chain $\mathbb{E}q.(4)$] that arises from m apping the transverse K ondo coupling can be expressed

In the continuum lim it, the corresponding kinetic energy written in terms of $(0S^{z}=0)^{2}$ clearly requires regularization through a nite value of 0. The long-range interaction in Eq. (4) must also be regularized, either by reinstating $!_{c}$ in \sim_{0}^{1} (!) entering Eq. (8) or through enforcement of j 0 j > $_{c}$ in Eq. (9). Finally, $_{0}$ enforcem ent of j serves to regularize the dynam ically generated K ondo $(1=_0) \exp(1=_0)$, below which the quanscale, T_{K} tum scaling occurs. This scale vanishes when $_0$ (or $_c$) vanishes, making the quantum critical behavior inaccessible. These observations suggest that the continuum lim it, necessarily taken in the quantum -to-classicalm apping, fails to capture the the topological (vortex-like) effect encoded in the Kondo spin- ips. W hat results is a change in the tem perature dependence of the spin selfenergy, qualitatively sim ilar to that arising in the classical model from changing the maximum winding from M = 1 to M = 1.

A concurrent study [20] addresses the mapping of the dissipative spin-boson model using a Monte Carlo algorithm that explicitly takes the lim it $_{0}$! 0 of a classical Ising chain [21]. Ref. [20] focuses on the nite-size scaling exponents of the static m agnetic properties, rather than the scaling of the dynam ical susceptibility. Its results for the mapped classical action are compatible with, and com plem entary to, our own. R ef. [20] also speculates that a marginal coupling introduced by bosonic truncation invalidates the NRG results [5] for the spin-boson model. However, our NRG studies for the BFKM, carried out over an extended range of bosonic truncation param eters and covering m ore than 20 decades of tem perature, show evidence, neither for evolution in the exponent x away from its interacting value of 1 tow ards the mean-eld $x = \frac{1}{2}$, nor for the line of critical points that would be expected in the presence of a marginal operator. We also note that the NRG conclusion for the BFKM that = y cannot be vitiated by a dangerously irrelx = 1 evant coupling. The NRG result corresponds to a spin self-energy [see Eq. (11)] M (T) = 0^{1} f. 1= In the regime $\frac{1}{2}$ < < 1 of interest, this tem perature dependence dom inates any T¹⁼² term potentially generated by a dangerously irrelevant coupling, in a manner rem in iscent of what happens in the M onte C arlo calculations with no winding (M = 1). These considerations all point to the quantum -to-classical breakdown being a realphenom enon.

In summary, we have addressed the quantum-toclassical mapping of the Ising Bose-Ferm iK ondo im purity problem. The nite-size scaling for the spin susceptibility of the mapped classical chain demonstrates an intriguing dependence on the winding of the longranged interaction under periodic boundary conditions. Only for in nite winding does one recover the expected mean- eld behavior. The contrast between these scaling properties and those of the Bose-Ferm iK ondo model suggests a breakdown of the quantum-to-classical mapping for Ising-anisotropic quantum dissipative systems arising from the manner in which K ondo spin ips are treated in the continuum limit that is taken in such a mapping.
