In this supplementary material we rst provide additional details of our integration through transients approach to the constitutive equation and distorted microstructure, clarifying the approximations required to obtain Eqs.(11) and (12). We then present an exact result for the friction kernel and details of the approximations leading to Eqs.(13)-(15). Finally, we provide additional comments regarding two continuum mechanics principles from the standpoint of the present work.

I. INTEGRATION THROUGH TRANSIENTS

C entral to our integration through transients approach is Eq.(10) which enables averages of functions of the particle coordinates to be calculated [7]. Applying (10) to a general function f of the phase space coordinates yields the time-dependent average

The time-ordered exponential function e generalizes the exponential function for (di erential) operators [20]. Choosing $f = ^ =V$, where V is the system volume, yields directly an exact generalized G reen-K ubo relation for the stress tensor

This equation is nonlinear in (t) due to the appearance of y (t) in the exponent. The stress autocorrelation function h i appearing in the above expression is the overlap between a stress uctuation at time t⁰ and a second uctuation at later time t which has evolved under a com bination of shear-driven and internalm otion. This correlation function is approxim ated by calculating overlaps of the stress uctuations with density uctuations describing slow structural relaxation of the dense system. The low est order non-zero projection of the dynam ics is onto pairs of density uctuations and is achieved using the pair projector

Insertion of this projector either side of the tim e-ordered exponential function followed by factorization of a fourth m om ent in density uctuations into the product of second

m on ents (viz. the correlators) leads to an approximate expression for the stress tensor. The time evolution of stress uctuations is thus represented by the transient density correlator $_{\rm k}$ (t;t⁰). W ithin our approach the static structure factor $S_{\rm k}$ serves to represent the direct potential interactions. For glassy states ageing leads to a residual time dependence of $S_{\rm k}$ which cannot be resolved within our approach. We therefore employ an extrapolation of the equilibrium $S_{\rm k}$ when working above the glass transition.

In order to calculate the distorted structure factor we use our general result (10) to calculate the average of $\frac{1}{2}$

As for the stress we can apply the projection operator P_2 to approximate the average in the integrand, leading to the expression (11) for the distorted structure factor. We note that in calculating S_k (t;) we require Baxter's result $h_{k-k-0}i = N S_0 S_k + n \frac{\partial S_k}{\partial n}$ to treat the three point function which arises as a result of the projection operator steps [21].

II. EQUATION OF MOTION

In order to close our constitutive theory we require an equation of motion for the transient density correlator. The advected wavevector appearing in the de nition of $_{k}$ (t;t⁰) may be reformulated as

All results are at this stage form ally exact. Approxim ation of the friction kernel proceeds via two steps and is based on the assumption that $U_i(t;t^0;t_0)$ contains slow dynamics only because of coupling to higher density modes describing structural relaxation. Firstly, we project the average in the numerator onto density pairs using the time dependent projection operator

This reduces the problem to the calculation of a four point correlation function. The second step is to approximate this correlator, in the spirit of quiescent mode coupling theory, by a product of pair correlators. The modi ed correction function makes a negligable contribution for small accumulated strains which suggests the approximation $(t;t_0) = 0$ [22]. We thus arrive at Eqs.(14) and (15) given in the main text.

III. CONTINUUM MECHANICSPRINCIPLES

The principle ofm aterial objectivity states that the relationship between the stress and strain tensors should be independent of the rotational state of either the sam ple or the observer [11,16,17]. This is satisfied by the Smoluchow ski equation which neglects inertial elects. That this invariance is preserved in our approximate equations can be explicitly con meed by considering the imposition of a time dependent rotation onto an arbitrary ow. The shear gradient, deform ation gradient, left and right C auchy-G meen tensors in the rotating frame are thus given by

where R (t) is a time-dependent rotation matrix. It is a straightforward but laborious exercise to substitute the transform ed tensors into expressions (8), (9), (11-14) in order to obtain the required invariance result for the stress tensor $^{(t)}$ = R (t) (t) R^T (t):

A n invariance requirem ent often in plicitly employed in continuum modeling is 0 klroyd's principle of local action [11] which states that only neighbouring particles are involved in determ ining the stress at any given point. The k integrals in (11) and (12) are insensitive to the low-k behavior of the integrands. In this sense local action is substantiated by the present m icroscopic theory.
