The precursor state to superconductivity in CeIrIn₅: Unusual scaling of magnetotransport

W e present an analysis of the norm al-state H alle ect and m agnetoresistance in the heavy ferm ion superconductor C eIrIn₅. It is dem onstrated that the m odi ed K ohler's scaling | which relates the m agnetoresistance to the H all angle | breaks down prior to the onset of superconductivity due to the presence of a precursor state to superconductivity in this system . A m odel-independent, single-param eter scaling of the H all angle governed solely by this precursor state is observed. N either the H allcoe cient nor the resistivity exhibit this scaling in plying that this precursor state preferentially in uences the H all channel.

The variety of low temperature electronic ground states observed in heavy ferm ion system sprim arily arises from two competing fundamental physical processes: the Ruderm an-Kittel-Kasuya-Yosida interaction favoring m agnetic order and the K ondo e ect that screens the localmoments [1]. Of particular interest are systems in which the magnetic order can be driven to zero tem perature. If this takes place in a continuous fashion it is referred to as a Quantum Critical Point (QCP). The offen observed existence of unconventional superconductivity in the vicinity of such a QCP has added to the interest in these exotic phase transitions, as it suggests that C ooper pair form ation could be governed by the presence of (antiferro-) m agnetic uctuations 2]. The Ce-115 systems (of the form CeM In₅, with M = Co, Ir, or Rh) have proven to be an interesting playground where manifestations of these intrinsic energy scales are unam bigously observed [3]. For instance, in the ambient pressure superconductor $C \in C \circ In_5$, the Q C P can be approached with applied magnetic elds of the order of the superconducting upper critical eld H_{c2} (0) [4]. The antiferrom agnetic order observed in CeRhIn5 can be suppressed by applying pressure of the order of 1.6 GPa which, again, results in a superconducting ground state [5]. In $CeIrIn_5$, though the superconducting regime is reasonably separated from the (possibly m etam agnetic) QCP [6], signatures of the presence of antiferrom agnetic uctuations in the vicinity of superconductivity have been observed [7]. Besides unconventional superconductivity, experim ental signatures such as the presence of line nodes in the superconducting gap structure [8] and anom alous m agnetotransport have also brought into focus the rem arkable sim ilarities which these system s share with the high tem perature superconducting cuprates [9].

O ne of the outstanding puzzles presented by these com – plex materials is the changing low energy excitations of the normal state just prior to the formation of the superconducting state. In the cuprates for instance, it is

now understood that superconductivity is preceded by the opening of a pseudogap in the electronic density of states [10]. Typically, this state is associated with experim ental signatures like a deviation from the linear tem perature dependence of resistivity [11] or a decrease in the spin-lattice relaxation rate $(1=T_1)$ in nuclear magnetic resonance m easurem ents [12], and is now considered an intrinsic energy scale of these system s. Recently, experim ents have indicated that a precursor state to superconductivity may also exist in the Ce based heavy ferm ion metals. The Ce-115 systems have been exem plary in this aspect, with the presence of such a precursor state being inferred from measurements like resistivity [13], nuclear quadrapole resonance [14], the Hall angle [15] and the Nemste ect [6]. In this Letter, we report on the analysis of the norm al-state m agnetotransport data in $CeIrIn_5$. To this end, prior [15] and new simultaneous measurements of isothermal Halle ect and magnetoresistance in magnetic elds 0H 15 T and in the tem perature range 0.05 K < T < 2.5 K on highquality single crystals are evaluated. We dem onstrate that the modi ed K ohler's scaling relating the magnetoresistance to the Hallangle breaks down prior to the onset of superconductivity due to a change in the Hall scattering rate. Moreover, the critical eld H (T) of the precursor state to superconductivity alone has been used to scale the tem perature- and eld-dependent H all angle $_{\rm H} = \cot^1 (_{\rm xx} = _{\rm xy})$. The fact that a similar scaling procedure fails for the individual properties, i.e., the resistivity xx and the Hall coe cient $R_H = xy = _0H$, suggests that this precursor state preferentially a ects the Hall channel.

Fig.1(a) depicts the isotherm alHallcoe cient $\Re_{\rm H}$ jas a function of applied eld H for di erent temperatures. The sharp drop in $\Re_{\rm H}$ j corresponds to the onset of superconductivity. The magnetic eld dependence of the transverse resistivity xx is plotted in Fig.1(b). Besides the onset of superconductivity, a crossover in the sign

of the magnetoresistance corresponding to the onset of a coherent K ondo state is visible in the high-tem perature data sets. Though this crossover from an incoherent to a coherent K ondo scattering regime is a characteristic feature of the heavy ferm ion metals, many similarities in the norm al state m agnetotransport of the superconducting cuprates and the Ce-115 systems have recently come to light. For instance, the resistivity xx has a linear tem perature dependence, the Hall coe cient R_{H} varies approxim ately as 1=T, and the Hall angle follows a cot _H / T² dependence in these conceptually dierent classes of m aterials. In the cuprates, theoretical support for these experimental observations have relied on the rather extraordinary idea that, in contrast to conventional m etals, the transverse H all scattering rate $\left(\begin{array}{c} \mu \\ \mu \end{array} \right)$ in the cuprate metals is a distinct entity as compared to the transport scattering rate ($_{\rm tr}^{-1}$) [17, 18]. Since the resistivity is governed by ${}^{1}_{\mathrm{tr}}$ and R $_{\mathrm{H}}$ by the ratio $_{\rm H}$ / $_{\rm tr}$, it follows that cot $_{\rm H}$ is a manifestation of the transverse relaxation rate ${}_{\rm H}^{-1}$ alone. In conventional m etals (with an isotropic single scattering rate), the m agnetoresistance ($_{xx}$ (H) $_{xx}(0))/_{xx}(0)$ arising due to the orbitalm otion of charge carriers is known to scale as a function of $H = _{xx} (0)$ (Kohler's rule [19]). A natural consequence of the presence of two scattering rates was the re-form ulation of this scaling rule to relate the transverse magnetoresistance with the Hall angle [20]. This scaling of the form $(_{xx} = _{xx} (0)) / \tan^2 _{H}$ has been successfully applied to magnetotransport data in both

the cuprates as well as in all the C e-115 com pounds. In C eIrIn₅ for instance, it was recently demonstrated that this scaling works in a wide tem perature range down to about 2 K [21], but this study did neither extend down to the precursor nor the superconducting regime [cf. F ig. 2 (b)]. The vital question remained whether the superconducting condensate emerges from within the phase space where this scaling is obeyed. F ig. 2 (a) exhibits the m odi ed K ohler's scaling as determined from our new m agnetotransport data. C learly, the scaling procedure m entioned above is not applicable down to the lowest accessible tem peratures. This observation is in line with the inference that the form ation of the superconducting condensate in C eIrIn₅ is preceded by a precursor state as determined by a change in the H all m obility.

In the heavy ferm ion m etals, the crystal electric eld and the single ion K ondo e ect provide two fundam ental energy scales that crucially in uence its physical properties. An additional energy scale of importance [22, 23] is related to the intersite coupling between the localm om ents due to the Ruderm an-K ittel-K asuya-Yosida interaction. In this context, it is in portant to clarify whether this precursor state to superconductivity in CeIrIn5 represents an intrinsic energy scale of the system, and to discern the manner in which it in uences the norm al-state magnetotransport. One powerful tool of identifying intrinsic energy scales in strongly correlated system s is the quest for universal trends of, and relationships between, m easured physical quantities. In the heavy ferm ion system s, early attempts to scale physical properties using a single energy scaling parameter met with only limited success [24]. However, in the cuprates it has been dem onstrated [25, 26, 27] that a single-param eter scaling of experim ental data was possible by using the energy scale of the pseudogap alone. By norm alizing any m easured electrical or therm all transport quantity f(x)

along with its variable x by the corresponding values at the onset of the pseudogap [f (x) and (x), respectively] the measured data could be made to collapse into a single universal curve. Thus, the scaling is of the form f(x)=f(x) / F(x=x). Consequently, the norm alized Hallcoe cient $(\mathcal{R}_{H}(H) \neq \mathcal{R}_{H}(H))$ is plotted as a function of norm alized eld (H=H) for CeIrIn₅ in Fig. 3(a). Here, the values H [Fig. 2(b)] were determ ined earlier from the change in the Hall mobility [15]. Fig. 3(b) shows the equivalent scaling for the magnetoresistance, i.e. $_{xx}(H) = _{xx}(H)$ as a function of H=H. Interestingly, neither $R_{H}(H)$ nor $_{xx}(H)$ scale onto a universal curve im plying that both of these quantities have significant contributions which are not scaling-invariant.

A priori, there is no simple explanation of the nature of these non-scaling-invariant contributions to R_H and xx. One possibility which cannot be ruled out is the in uence of disorder in these system s, with impurity scattering not being scaling-invariant. This problem can be circum vented by the analysis of the Hall angle. From prior work on the cuprates it is known that the cotangent of the Hallangle (which is directly related to the charge carrier m obility) is a quantity of basic interest [18]. It has been shown that \cot_{H} follows a T² dependence, independent of the extent of im purity substitution as well as the charge carrier density [28]. This relative insensivity of \cot_{H} to material properties (which is related to the fact that it does not depend on $_{\rm tr}$) has led to the conjecture that it is an even m ore fundam ental property than R_H . Moreover, deviations from cot $_H$ / T^2 have

been used to identify the onset of the pseudogap state in the cuprates [29]. Fig. 4 (a) presents the isotherm s of the eld dependent H all angle as m easured in C eIrIn, indicating that $_{\rm H}$ is quasi-linear as a function of H . If the di erent electronic states in CeIrIn, are manifestations of a change in the geometry of the Ferm i surface, this should be visible in the eld dependence of the Hall angle which measures the e ective de ection of charge carriers in the material by the applied magnetic eld. However, the lack of any observable features at xed values of $_{\rm H}$ suggests that there is no abrupt change in the geometry of the Ferm i surface, at least in the range of our m easurem ents. Here, it is emphasized that $_{\rm H}\,$ attains a value of more than 30 at large elds which is substantially larger than what is commonly observed in the cuprates. In line with the earlier analysis, the normalized Hallangle cot $_{\rm H}$ (H)=cot $_{\rm H}$ (H) is plotted as a function of normalized eld H = H in Fig. 4(b). For com parison, the unscaled data are shown in the inset F ig. 4 (c). Only in the form er case a good scaling behavior is obtained, an observation which is remarkable in view of the fact that such a scaling procedure was found to be ine ective for both $_{xx}$ (H) and R_H (H), Fig. 3. This scaling of cot H unam biguously im plies that the precursor state observed in CeIrIn₅ represents an intrinsic energy scale of the system which in uences the magnetotransport in a substantial region of the eld-tem perature phase space. Note that the scaling of the critical eld H (T)

of the precursor state with the superconducting critical

eld $H_{\rm c2}$ (T) suggests that they m ay arise from the same underlying mechanism [15]. This provides a natural link between the norm al-state properties of CeIrIn₅ and the superconductivity in this system .

The fact that scaling is observed in \cot_{H} clearly suggests that the precursor state is prim arily associated with the transverse Hall scattering rate ${}_{\rm H}^{-1}$. However, it would be erronous to conclude that the precursor state is associated only with ${\ _{\rm H}}^1$, since this state is also identied by a subtle feature in the magnetoresistance [15]. Neverthe less, the lack of scaling in both $_{\rm xx}$ and R $_{\rm H}$ suggests that the magnetic eld seem ingly in uences $_{\rm H}^{-1}$ preferentially as compared to $\frac{1}{tr}$. Interestingly, this is also in agreem ent with prior results on underdoped cuprates where it was suggested that the form ation of a pseudogap primarily a ects the Hall channel, and has little effect on the diagonal conductivity [30]. Moreover, the observation of scaling only in cot $_{\rm H}$ re-emphasizes the presence of two distinct scattering processes which selectively in uence the resistivity and the Hall angle in this heavy ferm ion metal. The observed anisotropy in the magnetic eld response of the scattering rates may arise as a consequence of coupling of the quasiparticles to incipient antiferrom agnetic uctuations §1, 32]. Such a coupling might then renormalize the scattering rates along di erent directions of the Ferm i surface. There exists a body of work to imply that this m ight indeed be the case in the Ce-115 systems. For instance, investigations of the angular-dependent resistivity in CeCoIn5 have indicated the presence of two distinct regimes in their magnetic eld dependences, separated by a criticalangle c, which in turn is governed by the intrinsic anisotropy [33]. M oreover, recent therm al conductivity m easurem ents indicated that the superconducting gap of CeIrIn₅ m ay have a $d_{x^2 \ v^2}$ symmetry: a signature that the superconductivity is strongly in uenced by the presence of antiferrom agnetic uctuations 34]. These

uctuations are them selves inferred to be anisotropic in nature, with the magnetic correlation length along the basal plane being larger than along the c axis, $_{ab} > _{c}$ [7]. The two corresponding scattering rates appear to be in uenced by the low-lying precursor state in a disparate fashion. In CeIrIn₅, it has been observed that \cot_{H} increases anom alously in the precursor state [15]. Since $\cot_{H} = 1 = !_{c H}$ this suggests that $_{H}^{-1}$ is enhanced in the precursor state | provided, of course, that the e ective mass m remains constant. This is in contrast to observations in the cuprates as well as in the related system CeCoIn₅ [13], where it was found that $_{tr}^{-1}$ reduces at the onset of the precursor state.

In sum m ary, the analysis of the norm al-state m agnetotransport in $C eIrIn_5$ reveals that the m odi ed K ohler's plot (relating the m agnetoresistance to the H all angle) breaks down prior to the onset of superconductivity, presum ably due to the presence of a precursor state to superconducivity in this regime of the H {T phase space. M oreover, the H all angle obeys a single-parameter scaling unambiguously governed by this precursor state. The absence of scaling in $R_{\rm H}$ and $_{\rm xx}$ is clearly indicative of the presence of two distinct scattering times, in similarity with observations in the cuprate superconductors. This could very possibly be a generic feature of m any heavy ferm ion superconductors. The fact that only the H all angle is scaled by the precursor state also in plies that this state preferentially in uences the H all channel and has a relatively weaker in uence on the resistivity. It is imperative to m ap the evolution and symmetry of both the superconducting as well as the precursor state by m ore direct probes, e.g., in order to form ulate a theoretical basis for the observed phenom ena.
