1. Introduction

The Landau-Lifshitz (LL) model describes the dynamics of the classical Heisenberg spin chain, and has appeared in the past few years in both gauge and string theories as one of the rst indications of the underlying integrable structure β {15] of the AdS/CFT correspondence (for a review see [16{19}]). On the string theory side the LL model emerges in the R S³ subsector in the limit of large angular momentum β , 20{25}. A lternatively, the LL model can be derived from the Faddeev-Reshetikhin (FR) model in the low-energy limit [26,27]. The latter is aim ed to resolve the di culties of the quantization procedure [28{36}] inherent to all sigm a models. More recently, the LL model also emerged in the SU (2) SU (2) subsector of the strings on AdS₄ CP³ β 7] in the context of the new ly proposed duality between N = 6 superconform al Chem-Sim ons and the AdS₄ CP³ string theories in the t'H ooft limit β 8]. The integrable properties of the LL model have been extensively discussed from various points of view. The classical integrability was established for the isotropic case in β 9], and for the general anisotropic case in [29,40], and the quasi-classical analysis was perform ed in [41]. The classical equivalence between the LL and the non-linear Schrodinger (NLS) models was shown in [42] by constructing a gauge transform ation between the at currents of the corresponding models.

At the quantum level, on the other hand, the integrable properties of the LL and NLS models are quite di erent. In [43] Sklyanin has considered in detail the quantum inverse scattering method for the LL model (the su (1;1) case), and pointed out several subtleties of the quantization procedure, absent in the classically equivalent NLS model. One of the surprising di culties is that the standard methods to obtain the Yang-Baxter relation from its classical counterpart fail for the anisotropic LL model, and the algebra of observables, as well as the transferm atrix have to be modi ed by hand in order to construct the quantum R-matrix. More important implication of the Sklyanin's analysis is the problem of constructing the local integrals of motion in the quantum theory, underlying the quantum integrability of the model. In fact, the problem s already arise in constructing the local quantum H am iltonian for the two-particle sector, and to the best of our know ledge, the higher order charges have not been constructed so far. The di culties arise as a result of the ill-de ned operator product at the same point¹ and can, in principle, be resolved by the standard procedure of putting the m odel on the lattice [45,46]. A lthough this can be done for both FR and LL m odels [26,47,48], and the corresponding spectra can be found with the standard B ethe A neatz technique, the fullA dS₅ S⁵ string m odel is too com plicated, and in general putting a continuous theory on the lattice using the standard m ethods leads to a non-local quantum H am iltonian [45,49]. Thus, one has to deal with the quantization of the continuous m odels directly, and the LL m odel, despite its sim plicity, is a particularly interesting representative exam ple of the di culties associated with the continuous quantum inverse scattering m ethod.

The LL and FR m odels, as well as a num ber of other m odels, arising in various limits of the full $Ads_5 = S^5$ string, have recently been considered as two-dimensional eld theories, and the corresponding S-m atrices have been obtained by m eans of perturbative calculations [27,50{53}]. The idea of this m ethod and its relation to the inverse scattering m ethod is nicely reviewed for the NLS m odel in [54]. This m ethod m akes use of the integrability, which is believed to hold at the quantum level, and, in particular, the S-m atrix factorization property [55{62], which renders the N-particle scattering S-m atrix to be a product of the two-particle S-m atrices. The direct veri cation of the factorization property, by calculating the set of Feynm an diagram s, has only been possible to carry out for the NLS m odel in [1,2]. M ore recently, the three-particle S-m atrix factorization property was demonstrated for the AdS₅ S⁵ string in the near at space limit at one-bop order [53].

In this article we consider the three-particle scattering process for the LL m odel and, by computing the necessary Feynm an diagram s up to the second order, show that it is factorizable in the rst non-trivial order. There are several conceptual features that m ake the S-m atrix calculations for the LL m odel a non-trivial task. F irst, as we noted earlier, the LL m odel is the low energy lim it for the FR m odel, and as was shown in [36], the H am iltonian for the FR m odel is not diagonalizable in the class of the standard representation for the two-particle sector:

This representation is at the heart of the Bethe Ansatz and has the clear interpretation for the rst and second terms as the incoming and outgoing waves respectively, and where the S-m atrix S $(p_1;p_2) = e^{i}$ (p_1,p_2) is a phase-shift due to the scattering (we assume that $p_1 > p_2$). Proceeding in a similar manner to [36] it is not di cult to show that the H am iltonian for the LL model cannot be diagonalized for the class of functions (1.1), although the exact two-particle scattering S-m atrix for the FR model can be obtained using the perturbative calculations [27]. A lternatively, this can also be seen directly via the quantum inverse scattering method [43], where the two-particle wave function is shown to acquire an additional term to (1.1). One of the reasons why this happens is the extrem ely singular nature of the LL interaction [43]. In fact, it is not di cult to see that the interaction in the quantum mechanical picture corresponds to the second derivative of the delta-function, and dealing with it is not an easy task (see for exam ple [63]). In order to write the additional term to (1.1), one has to introduce a new creation operator, which for the two-particle state would correspond to a bound state. It is not di cult to see that the number of such terms increases with the number of particles in the scattering process. For exam ple, in the three-particle scattering process there will be two additional contributions, corresponding to three and two-particle clusters.

M ore importantly, the form (1.1) suggests that the particles created by the elds + (x) D i are those corresponding to the Bethe particles, and all the consequences of the integrability, such as the S-m atrix factorization, will hold as the consequence of the general argum ent of [55,56,59]. This is indeed the case for a num ber of models, e.g. the NLS model, where (1.1) is indeed the two-particle state, and the particles + (x) Di are the Bethe particles, for which one can obtain the S-m atrix either using the perturbative diagram matic calculations, or via direct diagonalization of the Ham iltonian. How ever, this a priori is not the case in general, and the particles created by the elds + (x) may not correspond to the Bethe particles. This is the case for the LL model, namely, the Bethe particles do not coincide with ⁺ (x) j)i. Let us emphasize that considering the scattering process and stating the S-m atrix factorization makes sense only in terms of the Bethe particles. The only reliable method for diagonalizing all the local conserved quantities simultaneously, including the Ham iltonian, and, as a consequence, constructing the eigenstates corresponding to the Bethe particles, is the quantum inverse scattering method. But as we mentioned above, this construction fails in the LL model, and the local conserved quantities cannot be derived from the trace identities due to the singular expressions. Thus, checking the quantum integrability, e.g., the factorization of the S-m atrix, as well as establishing a connection with the construction in the quantum inverse scattering method by using the standard eld theoretic methods is an important task that should prove useful when considering more complicated systems than the LL model. In this paper and [44] we make the rst steps towards this program, and as the rst result we show here the factorization in the lowest order.

There are other subtleties, making factorization for the LL model a non-trivial feature. The unconstrained two dimensional eld theory on the world-sheet corresponding to the LL model contains in nite number of vertices. This is in contrast with the simpler NLS model, where there is simply one vertex to deal with, and, thus, making the higher order calculations much simpler. In the LL model one has to correspondingly consider new types of vertices as the order of calculations increases. Let us recall, that to calculate the two-particle scattering S-matrix one only needs to keep the term s up to the quantum level. Namely, for the three-particle scattering S-matrix one has to consider the vertices of higher (up to 6) order. The quantum integrability manifests here in the S-matrix factorization for the three-particle scattering. Although the calculations to all orders, we are able to show in the rst non-trivial order that the higher order vertices are exactly of the form needed for the S-matrix to be factorizable. The mechanism behind factorization is not straightforward, and we show that the higher order term s cancel unwanted low er order term s to guarantee the factorization. Moreover, we show explicitly that there is no process corresponding to particle annihilation or creation, and the set of momenta before and after the scattering is the same, in agreement with our understanding of integrability.

O ur paper is organized as follows. In Section 2, we give a brief account of the perturbative S-m atrix calculations for the Landau-Lifshitz m odel in the two-particle sector. In Section 3, we present our analysis of the three-particle scattering for the LL m odel and show the factorization in the rst non-trivial order. In section 4, we give a brief sum m ary of our results. In the A ppendix we collect the set of the Feynm an graphs used in our calculations in order to avoid cluttering the m ain text.

2. Two-particle scattering S-m atrix

In this section we set up the notation and present the necessary form ulas for the subsequent section on the three-particles scattering. First we brie y review the necessary facts about the LL model, and then explain

the two-particle perturbative S-m atrix calculations, referring the reader to [27] for complete details of the calculations. Let also us note, that the two-particle scattering diagram m atic calculations for the LL m odel are quite sim ilar to those of the non-linear Schrodinger m odel [54]. Indeed, the only essential di erence is the presence of the derivatives in the interaction term s. In the context of the perturbative calculations this results in a slightly m ore complex combinatorial analysis in the LL m odel. A swe will see below, the essential di erences arise when considering the three-particle scattering am plitude.

2.1 Landau-Lifshitz m odel: prelim inary facts

The Landau-Lifshitz model is a non-relativistic sigm a model which describes the continuous Heisenberg ferrom agnet, and arises in the R S^3 subsector of the AdS₅ S^5 strings in the limit of the large angular momentum. The equations of motion for the isotropic LL model, on which we will focus in this paper, in term s of the spin variables $S(x) = (S^a(x); a = 1; 2; 3)$; have the form :

In the most general formulation, the equations of motion for the anisotropic LL model are modied by an anisotropy matrix $J = diag(J_1; J_2; J_3)$; and take the form :

As explained in [43] the isotropic and anisotropic cases should be considered separately when quantizing the theory. In the form er case, the standard inverse scattering procedure goes through without any changes, and the Yang-Baxter equation is satis ed with the appropriate choice of the R-m atrix, while in the later case the operators, and accordingly the operator algebra (2.4) have to be modiled by hand for the Yang-Baxter relation to have a solution. In this paper we will consider only the isotropic case J = 0, and the more general case is currently under investigation.

The corresponding action can be written in a manifestly covariant form as follows:

Following [27], it is convenient to resolve the constraint (2.2) and write the action (2.6) as an unconstrained (1 + 1)-dimensional quantum eld theory. This can be achieved by a change of variables, which get rid of the non-linearities in the kinetic term, as follows

The non-relativistic character of the LL m odel leads to signi cant simpli cations in the quantization procedure. In particular, it m akes diagram m atic calculations quite easy to deal with. This is mostly due to the property of the propagator in the LL m odel to be a retarded one. Let us also note, that in relativistic theories, such as the massive Thirring m odel, to have sim ilar simpli cations in diagram m atic calculations, one can choose the false vacuum by hand, and, therefore, m aking the Feynman propagators to be retarded.

The fact that the propagator is purely retarded leads to the following result: the two particle scattering S-m atrix is given by the sum of bubble diagram s, as in Fig. 1.

The diagram above is exactly the one that appears in the NLS model. For the LL model one has to properly take into account the presence of the derivatives in the interaction terms, which results in four di erent types of vertices, depending on the placement of the derivatives on the internal or external lines. Nevertheless, the calculations are still easy to carry out.



Figure 1: Typical bubble diagram for the two-particle S-m atrix.

2.2 D iagram m atic calculations

Since the only contributions to the two-particle scattering amplitude are the diagram s of the type Fig. 1, to calculate the two-particle S-m atrix it is enough to truncate the complicated action (2.10) up to the fourth order in the elds:

We introduced in the expansion (2.14) the form alparam eter g to keep track of the perturbative order, and it should be set to one at the end of the calculations. Let us note here, that this is very important for the three-particle scattering amplitude factorization, where several such form alparam eters will be introduced to take care of order counting for di erent types of vertices that arise in the LL m odel when expanding the action (2.10) up to the sixth order in the elds. A natural question arises whether setting the param eters to one at the end is consistent with the renorm alization properties of the LL m odel. A lthough we ignore here all the divergences associated with the loop calculations, this is an interesting question and is currently under investigation.

W e collect here the necessary expressions, referring the reader to [27] for complete details. Taking without any loss of generality the ordering $p > p^0$ for the scattering to take place, the two-particle S-m atrix is determined from the relation

To avoid the combinatorial analysis of [27], associated with placement of derivatives on internal and external lines, we will compute the full bubble diagram in the following manner. Using the complete interaction vertex, which in the momentum representation has the form:

This already includes the sum of all one-loop diagram swith all possible placement of derivatives on internal and external lines, with the correct combinatorial factors. Noting that the term inside the square brackets in (2.21) coincides with the expression for the interaction vertex (2.20), one can regard the one-loop scattering amplitude as the interaction vertex in momentum representation, with the momenta p and p^0 on-shell, multiplied by some function of this pair of momenta and the expansion parameter. So that the n-loop scattering amplitude corresponds to the product of n of these modi ed vertices.

3. Three-particle scattering S-m atrix

The direct veri cation of the S-m atrix factorization using the perturbative calculations is quite di cult to carry out, due to the com plicated diagram m atic analysis. The only m odel for which the factorization property was manifestly veri ed is the non-linear Schrodinger m odel. We refer to the details of the diagram m atic calculations for the case of the NLS m odel to [1,2]. Before presenting the concrete calculations for the LL m odel let us note that there is a signi cant di erence between the NLS and LL m odels, and the latter case is considerably m ore com plex. Indeed, the H am iltonian for the NLS m odel has the form :

Thus, while calculating the three-particle scattering am plitude, one has to deal with only one type of vertex. The same is true when considering the general N-particle scattering process. In the LL model the situation is di erent and to consider the three-particle scattering am plitude one has to truncate the full action (2.10) up to the sixth order in elds. The higher order vertices will not contribute as the consequence of the retarded propagator as well as the charge conservation [27]. The resulting Lagrangian has the form

where we have introduced, analogous to the two-particle scattering perturbative calculations, arbitrary coupling constants g_1 ; g_2 ; g_3 for each type of vertices to keep track of perturbative calculations. As in the two-particle scattering case, we should take the limit g_i ! 1, i = 1;2;3 in the end. As we will show below, this is a crucial point, making the S-matrix factorization possible. Clearly, dealing with more vertices in this case is not an easy task already for the three-particle case even at the one-loop level. As the number of particles considered in the scattering increases, one has to expand the action (2.10) to higher order, which, as a result, makes the complexity of the perturbative calculations and the combinatorial analysis practically im – possible. Nevertheless, we make the list step in this direction and show in the next section the three-particle S-matrix factorization in the rst order of perturbation.

3.1 D iagram m atic calculations

A ssum ing analyticity of the three-particle scattering amplitude in the coupling constants g_i it can be written as: ²

The tree level Feynm an graphs (connected and disconnected) in the rst order are pictured in Fig. 2, where the spatial derivatives are represented by the marks over the particle lines. We stress that each of these graphs denotes a sum over diagram s of the same topology but with dierent permutations of the external momenta.



F igure 2: The tree-level Feynm an diagram s for the three-particle scattering in the Landau-Lifshitz m odel.

The expression for the tree level (3.5) de nes the interaction vertex in the momentum representation, represented by Fig. 3.

U sing the interaction vertex in the momentum representation we are able to compute the second order scattering amplitude as depicted in Fig. 4.

To avoid cluttering we do not write the indices in the sum, and use the notation $P = x = \frac{P^3}{x_i}$.

It is easier to compute each term of (3.10) separately.

(a) Term proportional to g_1^2 :

M ost of the integrals are trivially calculated due to the delta functions in $f_1(x;q)$, and the remaining delta functions corresponding to the total energy and momentum conservation allow us to write these terms as a sum of the following contributions: i) the nite part, which is a function of the external momenta, and ii) the term proportional to $(p_3 k_3)$. It is the latter term that may lead to divergencies, which, however, could be regularized in the same manner as in [27]. Indeed, we notice that this term can be written in the following form :

We have denoted s $\frac{1}{2}^{P} p^{0}^{P} p^{2}$ and shifted the integration variable $q ! q + \frac{1}{2}(k_{1} + k_{2})$: The corresponding diagram s are presented in Fig. 5. Once again, we emphasize that each diagram corresponds to the sum over all diagram s with the same topology, but with distinct permutations over the external momenta and di erent placements of the derivatives. The rst diagram in Fig. 5 corresponds to the rst term in (3.13), and the second term is the nite part of the second diagram. The diagram s, corresponding to 5, but with explicit placement of the derivatives are depicted on Figs. 6 and 7 respectively.⁴

(b) Term proportional to g_2^2 :

Let us note, that in equations (3.13), (3.14), (3.16), (3.17) and (3.18) we have ignored the divergences and kept only the nite parts. 3.2 The S-m atrix factorization

Had we assumed the quantum integrability of the LL model, we could have obtained the S-matrix for three particle scattering by using the relation:

This relation, analogous to (2.15), underlines the fact that in the scattering process the particle annihilation and creation are not possible, and the set of momenta before and after the scattering is the same. This is not obvious from the calculations presented in the previous section. Indeed, although the non-scattering term clearly has the form (3.26), neither the tree level (3.5), nor the second order (3.25) term s are manifestly of this form. Nevertheless, we will show that this is indeed the case, and one can reduce the expressions for the tree level (3.5) and the second order (3.25) contributions to the form s that are proportional to ${}^{(3)}_{+}(p;k)$.

Let us 1st focus on the tree level term (3.5). Expanding explicitly the sym m etrization operator $S_{k,p}$; we nd:

We immediately notice that the two terms in above expression are quite dierent. Namely, the rst term of (3.27) is already in the form needed for the S-m atrix to satisfy (3.26), while the second term, on the other hand, does not satisfy this condition. Therefore, had we restricted ourselves only to this order, the condition (3.26), necessary for integrability to hold, would have failed. Sim ilarly, it is not dicult to see that the second order scattering amplitude also contains terms that are not proportional to $^{(3)}_{+}$ (p;k), such as the terms in the second and third square brackets in (3.25).

Let us note, however, that if the quantum integrability, and as a consequence, the S-m atrix factorization were true, the three-particle S-m atrix would have the exact form :

where we have expanded in the last line the exact expression up to the second order in g. Comparing the equations $(3\,27)$ and $(3\,28)$, we see that the unity in $(3\,28)$ corresponds to the non-scattering part hp ki; while the rst term in $(3\,27)$ corresponds to the rst order term of $(3\,28)$. We will now demonstrate, that the second term in $(3\,27)$ is such that it can be canceled out exactly with a term from the second order contribution $(3\,25)$.

A very similar expression for rst term of (3.25) appears in the NLS model (see formula (13) of [1]). In the latter case, the use of the formula

proved to be crucial to show the factorization (see also [53]). We, thus, expect that the usage of this form ula should play the same role in our case. However, while the principal value part has no contribution for the NLS model, in the LL model it plays a non-trivial role and leads to the cancellations which make the factorization possible. We draw all the Feynman graphs for this term in Fig. 6, where only the sum over topologically sim ilar diagram s with di erent permutations of the external momenta is implicit. Thus, there are four diagram s, which correspond to all possible placements of the derivatives.

We rem ind that we have chosen the momenta p to be arranged in the order $p_1 > p_2 > p_3$ for the threeparticle scattering to be possible. The principal value of the rst term in (3.25) can be computed if we take $k_i \in p_i, i; j \ge f_1; 2; 3g$ and use the identity

Only the rst and last diagram s on the R H S of the Fig. 6 will contribute to the principal value, while the other two vanish identically due to the momentum conservation. We note that in the limit $g_1 = g_2 = g_3 = 1$ the rst term of (3.33) has the opposite sign of the second term in (3.27). Thus, the unwanted term indeed cancels out and the remaining term s combine into the form :

The rst term in (3.35) is the three-particle scattering S-m atrix in the second order, consistent with the factorization relation (3.28). Thus, we conclude that to have the S-m atrix factorization already in the lowest order, the term s from the higher order contribution should be taken into account to cancel out the unwanted term s. D iagram m atically, by m aking use of the relation (3.29) we have found that the principal value of the Feynm an diagram s depicted in Fig. 6 cancels out the term s at rst order that prevented the factorizability of the S-m atrix at this order, while the contribution of the delta-function term of (3.29), added to the term in Fig. 7, gave the factorizable second order contribution to the S-m atrix. A though we left out the R (g²)

contribution in (3.35), this calculation provides us with a remarkable scheme in which the contributions of dierent orders cancel each other to yield S-m atrix factorizability.

It is not di cult to see that the diagram s that we had to sum up to obtain the three-particle S-m atrix in the rst order are of the order \sim^0 since neither the tree level, nor the diagram s in Fig. 6 contain any loops. C learly, the cancellation at higher orders m ay happen for the diagram s of the sam e order in \sim : E ven though we were able to prove the factorizability at the rst order, the com plexity of diagram m atic and com binatorial analysis m ake the com putations of higher orders practically im possible to carry out, and another approach has to be employed. This subject is currently under investigation.

4. Conclusion and discussion

In this paper we have shown the three-particle S-m atrix factorization at the rst order for the LL m odel. The calculations we have presented show the non-trivial mechanism behind the factorization even in the lowest order of perturbation. In the process we have also shown the absence of particle annihilation and creation in the scattering processes, and that the set of m om enta before and after the scattering, correspondingly, is unchanged. Our consideration was motivated by the di culties to analyze the quantum integrability of the LL m odel in the framework of the quantum inverse scattering method. The highly singular nature of the LL m odel does not allow the use of the trace identities and, as a result, the set of local operators in involution is in general hard to derive. In fact, only the action of the quantum H am iltonian on the two-particle sector is known. In addition, the standard two-particle state (1.1), underlining the clear meaning of the scattering process, is not valid for the LL m odel quantized in terms of the elds ' (x) (2.9), namely, the particles created by the operator ' + (x) are not the Bethe particles. A s the S-m atrix factorization, which expresses quantum integrability, relies on the presence of an in nite set of commuting local operators, it is in portant to independently verify quantum integrability using eld theoretic methods. Let us note, that unlike the LL m odel, these subtleties are absent in the classically equivalent NLS m odel, and the quantum inverse scattering method is easily shown to be consistent with the eld theoretic calculations.

The next obvious problem is generalizing the above construction to all orders of perturbation, as well as showing the factorization for the N-particle scattering amplitude. This is not an easy task, as even in the lowest order the di culties of diagram matic and combinatorial nature are quite complex. The essential di erence with the NLS model is the new vertices that appear in each order for the LL model. As we have shown, the factorization mechanism is such that the higher order term s cancel the unwanted term s via the use of the form ula (3.29). C learly, at higher orders the analysis will be too complicated to be carried out. Thus, an alternative framework is needed to perform the diagramm atic calculations. The latter have to be also carried out to understand the e ects of renorm alization. The reason is twofold. First, as we have show n, the coupling constants q_i ; i = 1; 2; 3, which we had introduced by hand to keep track of the perturbative order, had to be set to unity for the three particle S-m atrix to be factorizable. A though we have done so without properly taking care of the renorm alization, it is in portant to carry out all the necessary calculations to show the validity of this assumption. Secondly, it is clear that the singularities arising in the quantum inverse scattering method, when deriving the local commuting operators, should exhibit them selves in the renorm alization of the coupling constants and elds. Thus, it would be interesting to establish a direct map between the two methods. We stress the importance of this program in the context of the AdS/CFT correspondence, since the di culties present in the quantization of LL m odel will also be present in the higher sectors of the AdS₅ S^5 string.
