Resummation approach in FractionalAPT: How many loops do we need to calculate?

W e give short introduction to the Analytic Perturbation Theory (APT) [1] in QCD, describe its problem s and suggest as a tool for their resolution the Fractional APT (FAPT) [2, 3]. We also describe shortly how to treat heavy-quark thresholds in FAPT and then show how to resum perturbative series in both the one-loop APT and FAPT. As applications of this approach we consider the Higgs boson decay H<sup>0</sup>! bb, the Adler function D (Q<sup>2</sup>) and the ratio R (s) in the N<sub>f</sub> = 4 region. Our conclusion is that there is no need to calculate higher-order coe cients d<sub>n 5</sub> if we are interested in the accuracy of the order of 1%.

# 1 Basics of APT in QCD

In the standard QCD Perturbation Theory (PT) we know that the Renorm alization G roup (RG) equation  $da_s [L] = dL = a_s^2$  :::for the electric coupling  $_s (Q^2) = a_s [L] = f$  with  $L = \ln (Q^2 = {}^2)$ ,  $_f = b_0 (N_f) = (4) = (11 \quad 2N_f = 3) = (4)^1$ . Then the one-loop solution generates Landau pole singularity,  $a_s [L] = 1 = L$ .

In the Analytic Perturbation Theory (APT) we have di erent e ective couplings in M inkowskian (Radyushkin [4], and K rasnikov and Pivovarov [5]) and Euclidean (Shirkov and Solovtsov [1]) regions. In Euclidean domain,  $q^2 = Q^2$ ,  $L = \ln Q^2 = ^2$ , APT generates the following set of images for the elective coupling and its n-th powers,  $fA_n [L]g_{n2N}$ , whereas in M inkowskian domain,  $q^2 = s$ ,  $L_s = \ln s = ^2$ , it generates another

set,  $fA_n [L_s]g_{n2N}$ . APT is based on the RG and causality that guaranties standard perturbative UV asymptotics and spectral properties. Power series  $\begin{bmatrix} n \\ m \end{bmatrix} d_m a_s^m [L]$  transform s into non-power series  $\begin{bmatrix} n \\ m \end{bmatrix} d_m A_m [L]$  in APT.

By the analytization in APT for an observable f (Q  $^2$  ) we mean the  $\K$  allen {Lehm an "representation

Then in the one-loop approximation (note pole remover ( $e^{L}$  1) <sup>1</sup> in (2a))

whereas analytic im ages of the higher powers (n 2; n 2 N) are:

In the standard QCD PT we have also:

(i) the factorization procedure in QCD that gives rise to the appearance of logarithm ic factors of the type:  $a_s [L]L$ ;<sup>2</sup>

(ii) the RG evolution that generates evolution factors of the type: B ( $Q^2$ ) = Z ( $Q^2$ )=Z ( $^2$ ) B ( $^2$ ), which reduce in the one-loop approximation to Z ( $Q^2$ )  $a_s$  [L] with =  $_0$ =(2b<sub>0</sub>) being a fractional number.

All these means we need to construct analytic in ages of new functions:  $a_s; a_s L^m; \ldots$ 

In the one-loop approximation using recursive relation (2) we can obtain explicit expressions for A [L] and A [L]:

Here F (z; ) is reduced Lerch transcendental function, which is an analytic function in . Interesting to note that A [L] appears to be an entire function in , whereas A [L]

is determ ined completely in terms of elementary functions. They have very interesting properties, which we discussed extensively in our previous papers [2, 7]. Here we only display graphics of A [L] and A [L] in Fig.1: one can see here a kind of distorting m irror on both panels.



Figure 1: Graphics of A [L] (left panel) and A [L] (right panel) for fractional 2 [2;3].

Construction of FAPT with xed number of quark avors, N  $_{\rm f}$ , is a two-step procedure: we start with the perturbative result  $a_{\rm s}~(\!Q^2)$ , generate the spectral density () using Eq.(1), and then obtain analytic couplings A [L] and A [L] via Eqs.(2). Here N  $_{\rm f}$  is xed and factorized out. We can proceed in the same manner for N  $_{\rm f}$ -dependent quantities:  $_{\rm s}~(\!Q^2;\!N_{\rm f})$ ) (;N  $_{\rm f})$  = [L;N  $_{\rm f}]$  ()=  $_{\rm f}$ ) A  $[L;N_{\rm f}]$  and A  $[L;N_{\rm f}]$  here N  $_{\rm f}$  is xed, but not factorized out.

G lobal version of FAPT, which takes into account heavy-quark thresholds, is constructed along the same lines but starting from global perturbative coupling  ${}_{\rm s}^{\rm glob}$  (Q $^2$ ), being a continuous function of Q $^2$  due to choosing di erent values of QCD scales  ${}_{\rm f}$ , corresponding to di erent values of N $_{\rm f}$ . We illustrate here the case of only one heavy-quark threshold at s = m $_4^2$ , corresponding to the transition N $_{\rm f}$  = 3 ! N $_{\rm f}$  = 4. Then we obtain the discontinuous spectral density

with L  $\ln = \frac{2}{3}$ , L<sub>f</sub>  $\ln m_f^2 = \frac{2}{3}$  and <sub>f</sub>  $\ln \frac{2}{3} = \frac{2}{f}$  for f = 4, which is expressed in terms of xed-avor spectral densities with 3 and 4 avors, <sub>n</sub> [L;3] and <sub>n</sub> [L + 4;4]. However it generates the continuous M inkow skian coupling

and the analytic Euclidean coupling (for more detail see in [7])

2 Resummation in the one-loop APT and FAPT

W e consider now the perturbative expansion of a typical physical quantity, like the A dler function and the ratio R , in the one-loop APT

W e suggest that there exist the generating function P (t) for  $coe cients d_n = d_n = d_1$ :

To shorten our formulae, we use the following notation hhf (t)  $i_{P(t)}$   $\begin{pmatrix} R_1 \\ 0 \end{pmatrix}$  f (t)P (t) dt. Then coecients  $d_n = d_1 hht^{n-1}P$  (t) and as has been shown in [8] we have the exact result for the sum in (8)

The integral in variable there has a rigorous m eaning, ensured by the niteness of the couplings  $A_1[t] = 1$  and  $A_1[t] = 1$  and fast fall-o of the generating function P (t).

In our previous publications [7,9] we have constructed generalizations of these results, rst, to the case of the global APT, when heavy-quark thresholds are taken into account. Then one starts with the series of the type (8), where  $A_n$  [L] or  $A_n$  [L] are substituted by their global analogs,  $A_n^{\text{glob}}$  [L] or  $A_n^{\text{glob}}$  [L] on  $A_n^{\text{glob}}$  [L] or  $A_n^{\text{glob}}$  [L] on that due to di erent normalizations of global couplings,  $A_n^{\text{glob}}$  [L] '  $A_n$  [L] = f, the coe cients  $d_n$  should be also changed). The most simple generalization of the sum mation result appears in M inkow skidom ain:

The second generalization has been obtained for the case of the global FAPT. Then the starting point is the series of the type  $\int_{n=0}^{p} d_n A_{n+}^{\text{glob}}$  [L] and the result of sum m ation is a complete analog of Eq. (11) with substitutions

# 3 Applications to H iggs boson decay and Adler function

First, we analyze the Higgs boson decay to a bb pair. Here we have for the decay width

$$(H ! bb) = \frac{G_F}{4 2} M_H \mathcal{R}_s (M_H^2) \text{ with } \mathcal{R}_s (M_H^2) m_b^2 (M_H^2) R_s (M_H^2)$$

and  $R_s$  (s) is the R-ratio for the scalar correlator, see for details in [2, 10]. In the one-loop FAPT this generates the following non-power expansion<sup>3</sup>:

$$\Re_{s}[L] = 3 \Re_{(1)}^{2} A_{0}^{\text{glob}}[L] + d_{1}^{s} \frac{d_{n}^{s}}{n} A_{n+0}^{\text{glob}}[L]; \qquad (14)$$

where  $\mathfrak{m}_{(1)}^2$  is the renormalization-group invariant of the one-loop  $\mathfrak{m}_b^2$  (<sup>2</sup>) evolution  $\mathfrak{m}_b^2$  (Q<sup>2</sup>) =  $\mathfrak{m}_{(1)}^2$  s<sup>0</sup> (Q<sup>2</sup>) with  $_0 = 2_0 = b_0$  (5) = 1.04 and  $_0$  is the quark-mass anomalous dimension (for a discussion | see in [11]).

We take for the generating function P (t) the Lipatov-like model of [9, 12] with fc = 2:4; = 0.52g

It gives a very good prediction for  $d_n^s$  with n = 2;3;4, calculated in the QCD PT [10]: 7:50, 61:1, and 625 in comparison with 7:42, 62:3, and 620. Then we apply FAPT resummation technique to estimate how good is FAPT in approximating the whole sum

 $\mathbb{R}_{s}^{e}$  [L] in the range L 2 [11;13:8] which corresponds to the range M<sub>H</sub> 2 [60;170] G eV<sup>2</sup> with  $\frac{N_{f}^{e=3}}{OCD} = 172 \text{ M eV}$  and  $A_{1}^{\text{glob}}$  (m<sup>2</sup><sub>Z</sub>) = 0:120. In this range we have (L<sub>6</sub> = ln (m<sup>2</sup><sub>t</sub> = <sup>2</sup><sub>3</sub>))

w ith P  $_{0}^{s}$  (t) de ned via Eqs. (15) and (12). Now we analyze the accuracy of the truncated FAPT expressions

and compare them with the total sum  $\Re_s[L]$  in Eq. (16) using relative errors  ${}_N^S[L] = 1$   $\Re_s[L;N] = \Re_s[L]$ . In the left panel of Fig. 2 we show these errors for N = 2, N = 3, and N = 4 in the analyzed range of L 2 [11;13:8]. We see that already  $\Re_s[L;2]$  gives accuracy of the order of 2.5%, whereas  $\Re_s[L;3]$  of the order of 1%. That m eans that there is no need to calculate further corrections: at the level of accuracy of 1% it is quite enough to take into account only coe cients up to d<sub>3</sub>. This conclusion is stable with respect to the variation of parameters of the model P<sub>s</sub> (t).

Next, we analyze the Adler function of vector correlator. In the one-loop APT this generates the following non-power expansion:

$$D_{v} [L] = 1 + d_{1}^{v} \frac{d_{n}^{v}}{n} A_{n}^{\text{glob}} [L]; \qquad (18)$$

Here we use another Lipatov-like model for perturbative coe cients in the N  $_{\rm f}$  = 4 region

$$d_{n}^{v} = c^{n-1} \frac{\frac{n+1}{2} n}{2} (n); \quad P_{v}(t) = \frac{e^{t=c} (t=c) e^{t=c}}{c (2 - 1)}$$

with c = 3:456 and = 1:325, which gives a very good prediction for  $d_n^v$  with n = 2;3;4, calculated in the QCD PT [13]: 1:49, 2:60, and 27:5 in comparison with 1:52, 2:59, and 27:4. To estim ate how good is APT in approximating the whole sum  $D_s$  [L], we apply APT resum mation approach in the range Q<sup>2</sup> 2 [1:5;20] G eV<sup>2</sup>, corresponding to the N<sub>f</sub> = 4 value. Again we analyze the accuracy of the truncated APT expressions  $D_v$  [L;N] =  $1 + d_1^v = \frac{P_i}{n=1} \frac{d_n^v}{n} A_n^{glob}$  [L] and compare them with the total sum  $D_v$  [L], obtained by resum mation APT method, using relative errors  $V_N^v$  [L] =  $1 - D_v$  [L;N]= $D_v$  [L]. In the right panel of F ig. 2 we show these errors for N = 1;:::;4 in the analyzed range of Q<sup>2</sup>. We see that already  $D_v$  (Q<sup>2</sup>;2) gives the accuracy of the order of 0.05%, whereas taking into account higher-order corrections only worsen the accuracy:  $D_v$  (Q<sup>2</sup>;3) provides the accuracy of the order of 0.1% and  $D_v$  (Q<sup>2</sup>;4) | of the order of 0.2%. That means that the NLO approximation gives the best result and after that the series starts to reveal its asymptotic character.

## 4 Conclusions

In this report we described the resum mation approach in the global versions of the oneloop APT and FAPT and argued that it produces nite answers in both Euclidean and M inkowski regions, provided the generating function P (t) of perturbative coe cients d<sub>n</sub> is known. In the case of the Higgs boson decay an accuracy of the order of 1% is reached at N<sup>3</sup>LO approximation, when term d<sub>3</sub>A<sub>3</sub> is taken into account, whereas for the Adler function D (Q<sup>2</sup>) we have an accuracy of the order of 0:1% already at N<sup>2</sup>LO (i.e., with taking into account d<sub>2</sub>A<sub>2</sub> term).

The main conclusion is: In order to achieve an accuracy of the order of 1% we do not need to calculate more than four loops and  $d_4$  coe cients are needed only to estimate corresponding generating functions P (t).
