$O$ scillations of $D$ irac and $M$ ajorana neutrinos in $m$ atter and a $m$ agnetic eld

#### Abstract

$W$ e study the evolution of $m$ assive $m$ ixed $D$ irac and $M$ ajorana neutrinos in $m$ atter under the in uence of a transversalm agnetic eld. The analysis is based on relativistic quantum $m$ echanics. W e solve exactly the evolution equation for relativistic neutrinos, nd the neutrino wave functions, and calculate the transition probability for spin-avor oscillations. W e analyze the dependence of the transition probability on the extemal elds and com pare the cases of D irac and M ajorana neutrinos. The evolution of M ajorana particles in vacuum is also studied and correction term s to the standard oscillation form ula are derived and discussed. A s a possible application of our results we discuss the spin- avor transitions in supemovae.

I. IN TRODUCTION

If $m$ assive neutrinos possess nonzero transition $m$ agnetic $m$ om ents, transitions ${ }^{L}$ \$ ${ }^{R}$ that change both spin and avor of neutrinos can happen in electrom agnetic elds. Such transitions $m$ ay be realized, e.g., in astrophysicalenvironm ents where strong $m$ agnetic elds are present. O scillations of $D$ irac neutrinos in an extemal magnetic eld were studied in Ref. [1]. In this soenario one has a transition to the sterile neutrino state R. W hile considering oscillations ofM a jorana neutrinos $w$ ith transition $m$ agnetic $m$ om ents in an extemal $m$ agnetic eld (see, e.g., Refs. [2, 3, [4]), one has transitions between active neutrino states since ${ }^{R}=\left({ }^{L}\right)^{C}$ for a M a jorana particle.

N eutrino spin- avoroscillations in solarm agnetic elds have been earlier studied in connection to the solar neutrino problem (see, e.g., $R$ ef. [b]). It w as thought that th is neutrino oscillations channelcould explain at least partly the de cit of the electron neutrinos in the $m$ easured solar neutrino ux. It is now clear that such spin- avoroscillations cannot play any signi cant role and the de cit can be satisfactorily explained in term s of active-active conversions and the $M$ ikheyev-Sm imov-W olfenstein $m$ atter e ect [6].
$T$ he in uence ofstrong $m$ agnetic elds ofneutron stars on neutrino oscillations was studied in Refs. [7, [8, [9]. It was show $n$ that spin- avor transition $m$ ay have im portant e ects in the neutron star environm ent. In these investigations neutrino spin- avor oscillations were described for realistic pro les ofm atter densities and magnetic elds and the appearance of resonances in neutrino
oscillations w as exam ined. For further details on the neutrino oscillations in electrom agnetic elds as well as neutrino electrom agnetic properties the reader is referred to the recent review [10].

In this paperw e shallretum to the question of the spinavor oscillations using an approach that di ers from the one usually followed. It is usual to describe neutrino oscillations, including the spin- avortransitions, on the basis of the quantum $m$ echanicalevolution equation. Instead of this Schrodinger picture, we will apply relativistic quantum $m$ echanical picture based on the D irac theory. In this approach, we w ill study spin- avor oscillations of $D$ irac and $M$ a jorana neutrinos in $m$ atter and in an extemalm agnetic eld, extending our earlier use of the $m$ ethod [11, 12, 13, 14] to this new problem. W e should also $m$ ention that the $m$ ajority of the previous studies of neutrino spin- avor oscillations are restricted to the case of M a jorana neutrinos. W e will investigate both the D irac and M a jorana cases as the nature of neutrinos is still an open question [15].

The plan of this paper is as follow s. W e w ill start by w riting down the relativistic w ave equations that take into account the background $m$ atter and extemal $m$ agnetic eld. W e form ulate the in itialcondition problem for these system $s$ (see also Refs. [11, 12, 13, 14]). W e then derive for both $D$ irac and $M$ a jorana neutrinos a $H$ am iltonian analogous to that of the standard quantum me chanical approach and solve exactly the resulting evolution equation for relativistic neutrinos. W e then analyze the behavior of the transition probability for D irac and M a jorana neutrinos at various $m$ agnetic eld strengths and $m$ atter densities. O ur results $w i l l$ be sum $m$ arized and their applications to som e astrophysical situations discussed in Sec. V .

[^0]II. EVOLUTION OF D $\mathbb{R} A C N E U T R I N O S I N$ MATTERAND TRANSVERSALMAGNETIC FIELD

Let us study the evolution of two neutrino avor states $=$; , in a nonm oving and unpolarized $m$ atter under the in uence of an extemalm agnetic eld. We assum $e$ that the $m$ ass eigenstates $a, ~ a=1 ; 2$, are related to the avor eigenstate neutrinos through the transfor$m$ ation

where is a m ixing angle. In this section we shallassum e that the $m$ ass eigenstates are $D$ irac particles. $W$ e set the follow ing in itialconditions (see also R efs. [11, 12, 13, 14]):

where $k=(k ; 0 ; 0)$ is the initialm om entum and

This corresponds to a relativistic neutrino of the avor, $w$ ith its spin directed oppositely to the particle $m$ om entum, i.e. a left-handed neutrino ${ }^{\mathrm{L}}$. The system is taken not to contain the other neutrino avor initially.
$N$ ote that from the physical point of view it would be m ore realistic to choose a localized in space initial condition rather than that in Eq. (22). It is well known, how ever, that from the point of view of oscillations the plane w ave and wave packet approaches in practioe lead to equivalent results [16]. M oreover the initial condition problem (2.2) for the cases of avor and spin- avor oscillations in various extemal elds was solved in our previous publications [11, 12, 13, 14].
$T$ he $D$ irac equation for the $m$ ass eigenstates $w$ ave functions is of the form (see Refs. [13, 14]),

where $H_{a}=(p)+m_{a}+g_{a}(1 \quad 5)=2$ is the $m$ ass diagonalpart of the $H$ am iltonian, $m_{a}$ are them asses associated w th the states $a$, and $=0,=0$, and $=$ 50 are D irac $m$ atrices. The term $V_{m}=g(1 \quad 5)=2$ describes the interaction of neutrinos $w$ th particles in the background $m$ atter. The $m$ atrix ( $g_{a b}$ ), given below, is not diagonal in the m ass eigenstate basis. The term $V_{B}=B \quad 3$ is the energy operator associated $w$ ith the interactions of neutrinos $w$ ith the $m$ agnetic eld, and the $m$ agnetic $m$ om ent $m$ atrix ( ab ) is, like ( $\mathrm{g}_{\mathrm{ab}}$ ), in general nondiagonal. Them agnetic eld is taken to be transversal w th respect to the initial neutrino m om entum, i.e., $B=(0 ; 0 ; B)$. The $V_{m}$ and $V_{B}$ term $s$ are responsible for the possible $m$ ixing betw een di erent neutrino $m$ ass eigenstates.

where $n_{f}$ is the number density, $I_{3 L}^{(f)}$ the third isospin com ponent and $Q^{(f)}$ the electric charge of the background particle of the type $f$, $w$ is the weak $m$ ixing angle, and $G_{F}$ is the Ferm i constant. It is assum ed in Eq. (2.5) that $m$ atter consists of electrons, protons, and neutrons and that it is unpolarized and at rest.

As to the interactions of neutrinos $w$ ith the $m$ agnetic eld, we have assum ed when writing Eq. (2.3) that the $m$ agnetic $m$ om ent $m$ atrix in the $m$ ass eigenstates basis is antidiagonal, i.e., aa $=0$ and $12=21=60 . \mathrm{M}$ agnetic $m$ om ent $m$ atrices of this type were studied in our previous works [13, 14]. The situation $w$ th the values of $D$ irac neutrino $m$ agnetic $m$ om ents is disputable [18]; how ever, the existence of large o -diagonalm agnetic m o$m$ ents of $D$ irac neutrinos is not exchded. Let us note that the solution to the $D$ irac $P$ auliequation for a neutrino $w$ ith aa 0 propagating in an arbitrary m oving and polarized $m$ edium w as recently obtained in $R$ ef. [19]. H ow ever in that work the case ofonly one neutrino avor w as studied.

To obtain Eq. (2.8) we neglect the term $q^{2}$ com pared to the neutrino $m$ ass squared $\mathrm{m}_{\mathrm{a}}^{2}$. For the situation of neutrino propagation in the expanding envelope form ed after
the supemova explosion，which is studied below，the ef－ fective potentials are $g_{a} \quad 10^{12} \quad 10^{11} \mathrm{eV}$ ．A ccounting for the neutrino $m$ ass in the eV range，the approxim ation m ade is alw ays valid．

N ote that the coe cients $a_{a}^{( }{ }^{\prime}(t)$ and $b_{a}^{(1)}(t)$ in Eq．（2．6） are functions of time due to the presence of the non－ diagonal interactions $V_{m}$ and $V_{B}$ ．Ourm ain goal is to determ ine these coe cients so that both Eq．（2．3）and the initial condition（22）are satis ed．

It is in order at this stage to com pare the tim e evo－hution Eq．（2．13），which we obtained to in our approach
based on D irac equation, w ith the one obtained in the conventionalquantum $m$ echanicalform alism. To this end let us introduce a quantum $m$ echanical wave function ${ }_{Q M}^{T}=\left({ }_{1}^{\mathrm{L}} ;{ }_{2}^{\mathrm{L}} ;{ }_{1}^{\mathrm{R}} ;{ }_{2}^{\mathrm{R}}\right.$ ) for the neutrino m ass eigenstates. H ere ${ }_{a}^{L ; R}$ are one-com ponent ob jects. This wave function obeys the Schrodinger equation $w$ ith the follow ing e ective H am iltonian (see, e.g., Ref. [3]) :

It is easy to see that this $m$ atrix leads to the sam edynam ics as the $H$ am iltonian in Eq. (2.13). Indeed, w thout changing the dynam ics one can $m$ ake the follow ing replacem ent $\mathrm{H}_{\mathrm{Q}} \mathrm{M}$ ! $\mathrm{H}_{\mathrm{Q}} \mathrm{M}$ $\operatorname{tr}\left(\mathrm{H}_{\mathrm{Q}} \mathrm{m}\right)=4 \quad \mathrm{I}$, where I is the $4 \quad 4$ unit $m$ atrix. T he resulting H am iltonian is exactly the sam e H am iltonian we have derived in our approach.

To describe the evolution of the system (2.13) in a general case, one has to solve a secular equation which is the fourth-order algebraic equation (see also below ). A lthough one can express the solution to such an equation in radicals, its actual form appears to be rather cum bersom e for arbitrary param eters. If we, how ever, consider the case of a neutrino propagating in the electrically neutral isoscalarm atter, i.e. $n_{e}=n_{p}$ and $n_{p}=n_{n}$, a reasonable solution is possible to nd. W e will dem onstrate later that it corresponds to a realistic physical situation. As one can infer from Eq. (2.5) for the case of the ${ }_{e}^{L}!{ }^{R}$ oscillations channel, in a m edium $w$ ith this property one has the e ective potentials $\frac{f}{\mathrm{p}} \quad \mathrm{f}=$ $V=G_{F} n=\overline{2}$ and $f \quad f_{e}=V_{e}=G_{F} n=\bar{p}$, where $\mathrm{n} \quad \mathrm{n}_{\mathrm{e}}=\mathrm{n}_{\mathrm{p}}=\mathrm{n}_{\mathrm{n}}$. Let us point out that background $m$ atter $w$ th these properties $m$ ay w ell exist in som e astrophysical environ$m$ ents. The $m$ atter pro le of presupemovae is poorly know $n$, and a variety of presupemova $m$ odels $w$ ith di erent pro les exist in the literature (see, e.g. Ref. [21]). $N$ evertheless, electrically neutral isoscalar $m$ atter $m$ ay well exist in the inner parts of presupemovae consisting of elem ents heavier than hydrogen. Indeed, for exam ple, the m odel W 022 in Ref. [21] predicts that in a 15M presupemova one has $Y_{e}=n_{e}=\left(n_{p}+n_{n}\right)=0: 5$ in the $\mathrm{O}+\mathrm{N}$ e+ Mg g layer, betw een the $\mathrm{Si}+\mathrm{O}$ and He layers, in the radius range (0.007\{0 2) R .

It should be noted that Eq. (2.16) is the general solution of Eq. (2.13) satisfying the initial condition $(0)=0$.
$N$ ote that we received the solution (2.16) -(2.19) of the evolution Eq. (2.13) under som e assum ptions on the extemal elds such as isoscalar matter w ith constant density and constant $m$ agnetic eld. W e mentioned above that our $m$ ethod is equivalent to the quantum $m$ echanical description of neutrino oscillations [B] which is valid for a m ore general case of coordinate dependent external elds. T he advantage of our approach consists in the fact that one can derive neutrinos' $w$ ave functions for arbitrary initialm om enta, as it w as m ade in Refs. [11, 12], and study the propagation of low-energy neutrinos. T he assum ption ofconstant $m$ atter density and $m$ agnetic eld is quite realistic for certain astrophysical environm ents like a shock w ave propagating inside an expanding envelope after a supemova explosion (see also Sec.V) .

(2.17)]. N ote that in this case one can analyze the exact oscillation probability (221) analytically, which would be practically im possible in m ore general situations.

As one can infer from these expressions, the transition probability $P(t)$ is a rapidly oscillating function, $w$ ith the frequency, enveloped from up and down by the slow ly varying functions $\mathrm{P}_{\mathrm{u} ; \mathrm{d}}=\mathrm{P}_{0} \quad \overline{\mathrm{P}_{\mathrm{c}}^{2}+\mathrm{P}_{\mathrm{s}}^{2}}$, respectively.

The behavior of the transition probability for various $m$ atter densities and the values of $B$ and for a xed neutrino energy ofe $=10 \mathrm{M} \mathrm{eV}$ and squared m ass di erence of $\mathrm{m}^{2}=8 \quad 10{ }^{5} \mathrm{eV}^{2}$ is illustrated in Figs. [1-3).

A s these plots show, at low m atter densities the envelope functions give, at each propagation distance, the range of the possible values of the oscillation probability. At greater $m$ atter densities, where the probability oscillates less intensively, the envelope functions are not that useful in analyzing the physical situation.

O ne can nd the $m$ axim um value of the upper envelope function, which is also the upper bound for the transition probability, given as

for arbitrary values ofB. The values of these $m$ axim a depend on the size of the quantity $B$. These dependencies are plotted in $F$ igs. 1 (d) 3 ( $(\mathrm{d})$. In the case of rapid oscillations the physically relevant quantities, rather than the $m$ axim a, are the averaged values of the transition probabilly, which are also plotted in these gures.

As $F$ igs. 1 (d) 3 (d) show, the interplay of the $m$ atter $e$ ect and the $m$ agnetic interaction can lead, for a given $m$ agnetic $m$ om ent , to an enhanced spin-avor transition if the $m$ agnetic eld $B$ has a suitable strength relative to the density ofm atter. In ournum ericalexam ples this occurs at $B_{m a x}=1: 1 \quad 10{ }^{12} \mathrm{eV}$ for $=10 \mathrm{~g} / \mathrm{cc}$, at $\mathrm{B}_{\mathrm{max}}=6: 6 \quad 10{ }^{13} \mathrm{eV}$ for $=50 \mathrm{~g} / \mathrm{cc}$, and at $\mathrm{B}_{\mathrm{max}}=8 \quad 10^{13} \mathrm{eV}$ for $=100 \mathrm{~g} / \mathrm{cc}$. For these values of $B$ both the $m$ axim $a$ and the average of the transition probability becom e considerably larger than for any
other values of B.Figures (b) (b) (b) correspond to the situation of $m$ axim al enhancem ent, whereas $F$ igs. [1(a)3 (a) and F igs. [1(c) 3 (c) illustrate the situation above and below the optim al strength $\mathrm{B}_{\mathrm{m}}$ ax of the m agnetic eld.

It is notew orthy that the enhanced transition probability is achieved tow ards the low er end of the $B$ region where substantial transitions all occur, that is, at relatively $m$ oderate $m$ agnetic elds. At larger values of $B$ them axim um of the transition probability approachestow ards $\cos ^{2}(2)$. Indeed, if $\mathrm{B} \mathrm{max}(; \mathrm{V})$, the transition probability can be w ritten in the form (see Ref. [13]) $P(t)=\cos ^{2}(2) \sin ^{2}(B t)$. It was found in Ref. [22] that neutrino spin- avoroscillations can be enhanced in a very strong $m$ agnetic eld, w th the transition probability being practically equal to unity. This phenom enon can be realized only for $D$ irac neutrinos w ith sm allo -diagonal $m$ agnetic $m$ om ents and $s m$ all $m$ ixing angle. A s we can see from Figs. [1(d) 3 (d) the situation is com pletely different for big o -diagonalm agnetic m om ents.

O ne should notice that for long propagation distances

consisting of several oscillation periods of the envelope functions, the enhancem ent e ect would dim inish considerably due to averaging. In the num erical exam ples presented in $F$ igs. $1-3$ the period of the envelope function is of the order of $10^{3} \quad 10^{4} \mathrm{~km}$, which is a typical size of a shock w ave w th the $m$ atter densities we have used in the plots (see, e.g., R ef. [23]). T hus the enhanced spinavor transition could take place w hen neutrinos traverse a shock wave.

Let us recall that the above analysis was m ade by assum ing neutrinos to be D irac particles. W ew illsee below (see Sec.IV) that the corresponding results are quite different in the case of $M$ a jorana neutrinos.
III. EVOLUTION OF M A JORANA NEUTRINOS IN VACUUM

W e now move to consider Majorana neutrinos, and we shall start by applying our form alism to the ordinary vacuum oscillation of two M ajorana neutrinos. $T$ he left-handed chirality com ponent of a avor neutrino ${ }^{L}=(1=2)\left(1 \quad{ }^{5}\right) \quad$ is related to the $w$ ave functions of

(2.1).

W e study the evolution of this system with the follow ing initial condition [see also Eq. (22)]:

The leading term reproduces the fam iliar oscillation form ula ofP ontecorvo describing the transitionsbetw een active neutrinos ${ }^{\text {L }} \${ }^{\mathrm{L}}$. B efore $m$ oving to consider $M$ a jorana neutrinos in $m$ agnetic elds we make a general com $m$ ent conceming the validity of our approach based on relativistic classical eld theory. It has been stated [2] that the dynam ics of $m$ assive $M$ ajorana elds cannot be described within the classical eld theory approach due to the fact that the $m$ ass term of the Lagrangian, ${ }^{T} i_{2}$, vanisheswhen is represented as a c-num ber function. $N$ ote that Eq . (3.3) is a direct consequence of the $D$ irac equation if we suggest that the four-com ponent wave function satis es the M a jorana condition. Therefore a solution to Eq. (3.3), i.e., $w$ ave functions and energy levels, in principle does not depend on the existence of a Lagrangian resulting in this equation. The wave equations describing ele$m$ entary particles should follow from the quantum eld theory principles. H ow ever quite often these quantum equations allow classical solutions (see $R$ ef. [29] form any interesting exam ples). W e have also dem onstrated in Refs. [11, 12, 13, 14] that oscillations of $D$ irac neutrinos in vacuum and various extemal elds can be described in the fram ew ork of the classical eld theory. T he $m$ ain result of this section was to show that the quantum Eq. (3.3) for $m$ assive $M$ a jorana particles can be solved [see Eq. (3.11)] in the fram ew ork of the classical eld theory as well.

Let us note that the analogous e ective Ham iltonian has been used in describing the spin-avor oscillations of M ajorana neutrinos w thin the quantum m echanical approach (see, e.g., Ref. [ß]) if we use the basis ${ }_{Q M}^{T}=\left({ }_{1}^{L} ;{ }_{2}^{L} ;\left[\begin{array}{l}L \\ 1\end{array}\right] ;\left[\begin{array}{l}L \\ 2\end{array}\right]^{C}\right)$.
$N$ ote that the consistent derivation of the $m$ aster Eq. (4.1) should be done in the fram ew ork of the quantum eld theory (see, e.g., Ref. [2]), supposing that the
spinors a are expressed via anticommuting operators. $T$ his quantum eld theory treatm ent is im portant to explain the asym $m$ etry of the $m$ agnetic $m$ om ent $m$ atrix. H ow ever, it is possible to see that the m ain Eq. (4.1) can also be reduced to the standard Schrodinger evolution Eq. (4.5) for neutrino spin-avor oscillations if we suppose that the wave functions a are c-number objects. That is why one can again conclude that classical
and quantum eld theory $m$ ethods for studying $M$ a jorana neutrinos' propagation in extemal elds are equivalent.

Let us again consider the situation when $n_{e}=n_{p}=$ $\mathrm{n}_{\mathrm{n}}=\mathrm{n}$, which results in $\mathrm{g}_{1}=9$. In this case the eigenvalues of the H am iltonian (4.5) $=\mathrm{E}$ are given by

$N$ ote that form ally Eq. (4.10) corresponds to the transitions ${ }^{L}!{ }^{R}$. How ever, virtually it describes oscillations between active neutrinos $\mathrm{L} \$\left({ }^{\mathrm{L}}\right)^{c}$ since ${ }^{R}=\left({ }^{L}\right)^{C}$ for $M$ ajorana particles.
As in the previous case of Eq. (221), Eq. (4.10) can be treated analytically for relatively sm all values of the e ective potenfial V. The ensuing envelope functions $\mathrm{P}_{\mathrm{u} ; \mathrm{d}}=\mathrm{P}_{0} \quad \overline{\mathrm{P}_{\mathrm{c}}^{2}+\mathrm{P}_{\mathrm{s}}^{2}}$ depend on the coe cients C and $S$ in the sam eway as in Eq. (224). The transition probabilities at various values of the $m$ atter density and the $m$ agnetic eld are presented in $F$ ig. (4).

D espite the form alsim ilarity betw een D irac and M a jorana transition probabilities (see Eqs. (2.22) and (4.11)) the actualdynam ics is quite di erent in these tw o cases, as one can see by com paring Figs. 1(d) -3(d) and Fig. 4, panels (b), (d) and ( f ). In particular, in the M a jorana case $P_{u}{ }^{(m a x)}=4 j+C$ jfor arbitrary $B$, to be com pared w ith Eq. (2.26), while the function $P_{0}{ }^{(m \text { ax })}$ has the sam $e$ form as in the D irac case given in Eq. (227). In contrast w th the D irac case, the averaged transition probability does not achieve its $m$ axim al vahe at som e m oderate $m$ agnetic eld $B_{m}$ ax value, but both $P_{u}^{m}$ ax and $P_{0}^{m}$ ax are $m$ onotonically increasing functions of the strength of the $m$ agnetic eld $w$ th 1 and $1 / 2$ as their asym ptotic values, respectively. W e can understand this behavior when we recall that, at $B \quad \max (; V)$, the e ective H am iltonian Eq. (4.5) becom es

U sing Eqs. (3.1), (4.12) and (4.14) we then immediately arrive to the follow ing expression for the transition probability, $P(t)=j^{R} \jmath=\sin ^{2}(B t)$, which explains the behavior of the function $P_{u}{ }^{(m a x)}$ at strong $m$ agnetic elds. N ote that the analogous result w as also obtained in Ref. [22].

Finally, it is worth of noticing that in contrast to the D irac case, the behavior of the transition probability in the M ajorana case is qualitatively sim ilar for di erent $m$ atter densities and di erent magnetic elds [see Fig. 4, panels (a), (c), and (e)].

The problem of $M$ a jorana neutrinos' spin- avor oscillations was studied in Refs. [8, 9] w ith help of num erical codes. For exam ple, in Ref. [8] the evolution equation for three neutrino avors propagating inside a presupemova star w ith zero m etallicity, e.g., corresponding

to W 02Z m odel [21], was solved for the realistic $m$ atter and $m$ agnetic eld pro les. A though our analytical transition probability form ula (4.10) is valid only for the constant $m$ atter density and $m$ agnetic eld strength, it
is interesting to com pare our results $w$ ith the num erical sim ulations of $R$ ef. [8]. In those calculations the authors used magnetic elds B $\quad 10^{10} \mathrm{G}$ and magnetic $m$ om ents $\quad 10^{12} \quad B$ that give us the $m$ agnetic energy

B $\quad 10^{11} \mathrm{eV}$. This value is the m axim al m agnetic energy used in our work.

It was found in Ref. [8] that spin- avor conversion is practically adiabatic for low-energy neutrinos corresponding to $\mathrm{E} \quad 5 \mathrm{M} \mathrm{eV}$ inside the region where $Y_{e} \quad 0: 5$ and the averaged transition probability for the channel
! e is close $0: 5$. This big transition probability is due to the RSF $H$ and $R S F-\tau$ resonances at the distance
$0: 01 \mathrm{R}$. Even so that we study two neutrino oscillations schem e, we obtained the analogous behavior of $P_{0}{ }^{(m a x)}$ (see Fig. (4). H ow ever, in our case this big transition probability is due to the presence of the strong m agnetic eld (see Refs. [10, 22]). W e cannot com pare our transition probability form ula 4.10) w ith the results of $R$ ef. [8] for higher energies, $E>25 \mathrm{M} \mathrm{eV}$, since spinavor oscillations becom e strongly nonadiabatic for these kinds ofenergies and one has to take into account the coordinate dependence of the $m$ atter density which should decrease $w$ ith radius as $1=r^{3}$ [32].

## V. SUMMARY

W e have studied in this work the propagation ofm assive avor-m ixed $D$ irac and $M$ ajorana particles in $m$ atter under the in uence of an extemalmagnetic eld in an approach based on relativistic quantum mechanics. $T$ he $m$ agnetic $m$ om ent $m$ atrix is assum ed to be both in the $D$ irac and $M$ a jorana case nondiagonal in the $m$ ass eigenstate basis. Starting $w$ th Lorentz invariant wave equations, the interactions of neutrinos $w$ ith $m$ atter and $m$ agnetic elds included, we derived the e ective H am iltonians and solve the evolution equations for the electrically neutral $m$ atter $w$ ith $n_{n}=n_{p}$. $W$ e then found the probabilities for the spin-avor oscillation ${ }^{\mathrm{L}}$ ! ${ }^{\mathrm{R}}$
( ${ }^{\mathrm{L}}$ ! ( $\left.{ }^{\mathrm{L}}\right)^{\mathrm{c}}$ forM a jorana neutrinos) and exam ined their dependence on them atter density and the strength of the $m$ agnetic eld.

W e also studied in our approach the evolution ofm ixed m assive M a jorana neutrinos in vacuum, which is an exactly solvable problem. W e derived the wave functions of the neutrinos and the transition probabilities for the process ! . W e included the term $s$ quadratic in neutrino $m$ asses and discussed the origin of these corrections of the standard form ula for the probability.

These corrections to the Pontecorvo form ula, see Eq. (3.12), are rapidly oscillating functions suppressed by the ratio $\mathrm{m}_{\mathrm{a}}=\mathrm{k} j$ which is sm all for the relativistic neutrinos. It w as revealed in our previous w orks [11, 12, 13, 14] that the analogous term s originate from the accurate account of the Lorentz invariance in the study of oscillations of $D$ irac neutrinos. It is also known that in describing of evolution of M a jorana neutrinos in vacuum the transitions of the types ${ }^{\mathrm{L}}$ ! ${ }^{\mathrm{L}}$ and $\mathrm{L}^{\mathrm{L}}$ ! ( $\left.{ }^{\mathrm{L}}\right)^{\mathrm{C}}$ are possible [33], w th the transition probability of the latter case being suppressed by the factor $m_{a}=j \mathrm{j}$. T he transitions ${ }^{\mathrm{L}}$ ! ( $\left.{ }^{\mathrm{L}}\right)^{\mathrm{c}}$ can be interpreted as neutrino-to-antineutrino oscillations and $m$ anifest in the possible
neutrinoless double beta decay [34]. In our work on the basis of the relativistic quantum $m$ echanics we derived the transition probability forneutrino-to-antineutrino oscillations which is consistent $w$ ith the results of $R$ ef. [33].

O ur results can be used for analyzing the behavior of neutrinos in supemovae, in particular in the so-called zero $m$ etallicity presupemovae, where the condition $n_{n}=$ $n_{p}$ is ful lled [21] outside the Si+ $O$ layer. It is know $n$ that these stars can possess very strong $m$ agnetic elds, up to $10^{15} \mathrm{G}$, or even stronger [35].

W e found that large rates of transitions that change neutrino avors and chiralities are possible both in the $D$ irac and $M$ ajorana cases $w$ th a typical oscillation lengths of the order of $10^{3} \quad 10^{4} \mathrm{~km}$ for $m$ atter densities of the order of $10 \quad 100 \mathrm{~g} / \mathrm{cc}$, for typical supemova neutrino energies of 10 M eV and for B of the order of $10^{13} \quad 10^{12} \mathrm{eV}$. The param eters of a shock wave, the density and width, can vary in a rather wide range, but typically they $t$ w ith the param eter values we used in our analysis [36]. In particular, the w idth of the shock wave can be of about the same size as the oscillation length of the spin- avor oscillations. It would thus be possible that the transition probability achieves its maxim um value (can be as high as 0.8 in som e cases) when neutrinos pass through the shock wave on their way tow ards the outer layers of the star. If the ight distance were $m$ any oscillation lengths, the probability would be averaged to a sm aller value. The results of our work can have the im plication to the r-process nucleosynthesis since it is sensitive to the am ount of neutrinos of various species em itted in a supemova [37].

In the D irac case the $m$ axim um value of the transition probability is achieved for a speci c value of $B$, while in the M a jorana case the transition probability can be large for a w ide range of $B$ values. Supposing that the neutrino $m$ agnetic $m$ om ent is $3 \quad 10^{12} \mathrm{~B}$, allowed by the present astrophysical and cosm ologicaldata [38], the largest transition in the D irac case would occur when the strength of the $m$ agnetic eld is in the range $10^{8}$
$10^{9} \mathrm{G}$. A though a magnetic eld on the surface of a neutron star is typically stronger, $10^{12} \quad 10^{3} \mathrm{G}$, at outer parts of the envelope it $m$ ay have a suitable value for a large transition to take place. The di erence betw een the dynam ics of $D$ irac and $M$ a jorana particles under the in uence of the same extemal elds can be a smoking gun to reveal the nature of neutrinos.
$N$ ote that in the majority of the previous works devoted to the spin- avor oscillations the analytical transition probability form ulae were obtained only for M ajorana neutrinos. T he case of $D$ irac particles $w$ as studied only in connection $w$ th $s m$ all o -diagonalm agnetic m om ents. O ur work studies the opposite situation of big o -diagonal elem ents of the $m$ agnetic $m$ om ents $m$ atrix. The e ect of the appearance of the big transition probability at $m$ oderate $m$ agnetic eld strength has never been described earlier. A s for $M$ a jorana neutrinos the enhancem ent of the transition probability in strong $m$ agnetic elds is in agreem ent w ith the previous stud-
ies [10, 22]. N ote that spin- avoroscillations ofM a jorana neutrinos can be also resonantly enhanced in the $m$ oderate $m$ agnetic eld, see $R$ ef. [5]. H ow ever this e ect does not happen in isoscalarm atter w ith $n_{e}=n_{p}=n_{n}$. The condition for the resonant sp in - avorprecession reads 7], $G_{F}\left(\begin{array}{ll}n_{e} & n_{n}\end{array}\right)=m^{2} \cos 2=4 k$, which is not ful lled in isoscalar m atter.

The obtained analytical form ulae for the transition probabilities, Eqs. (221) and (4.10), are valid in the im portant case when $Y_{e}=0: 5$, which is realized in the zero $m$ etallicity presupemova stars. These kinds of stars w ere quite com $m$ on for early stages of the galaxies form ation. W e obtained that spin- avor oscillations of D irac neutrinos can be strongly in uenced by the moderate $m$ agnetic eld of a neutron star and the big transition probability can exist not only for M a jorana neutrinos [8, []]. Thus spin- avor oscillations of D irac neutrinos can signi cantly change the relic supemova neutrino background [39]. A though now no signal of relic neutrinos w as observed [40], there are still som e e orts
to calculate the ux of relic e for the Kam LAND and Super-K am iokande detectors [41]. The reliable sim ulation of the supemova explosion does not exist yet. For exam ple, the propagation of a shock wave can signi cantly change $m$ agnitude and shape of the $m$ agnetic eld which are very im portant in our calculations. N evertheless it is believed that the fiuture galactic supemova neutrino burst $m$ ight give som e clues to the physics of relic supemova neutrinos [9].
