# C osm ology w ith U nparticles

#### Abstract

W e discuss cosm ological consequences of the existence of physics beyond the standard m odel that exhibits B anks-Zaks and unparticle behavior in the $U V$ and $\mathbb{R}$ respectively. W e rst derive the equation of state for unparticles and use it to obtain the tem perature dependence of the corresponding energy and entropy densities. W e then form ulate the Boltzm ann and $K$ ubo equations for both the unparticles and the B anks-Zaks particles, and use these results to determ ine the equilibrium conditions betw een the standard $m$ odeland the new physics. W e conclude by obtain ing the constraints on the e ective num ber of degrees of freedom of unparticles im posed by B ig-B ang nucleosynthesis.

## I. INTRODUCTION

Recently $G$ eorgi [1],2] $]^{1}$ raised the interesting possibility that physics beyond the Standard M odel (SM ) m ay contain a sector that is conform ally invariant in the $\mathbb{R}$ region (guaranteed by a zero of the beta function), and classically scale-invariant in the UV; we refer to these as the unparticle ( $U$ ) and Banks-Zaks (BZ) phases, respectively. The transition region betw een the two phases is characterized by the scale of dimensional transm utation u A speci c realization of this idea can be found in [4]; follow ing this reference we will assum e that the new sector is described as an asym ptotically free gauge theory in the BZ phase.
$T$ his novel idea has received substantial attention within the high-energy com $m$ unity, mainly in connection with the phenom enology of such $m$ odels. H ere we discuss som e fundam ental issues in the evolution of the $U$ niverse in the presence of this type of new physics (though studies of the cosm ologicalconsequences of the proposal have appeared in the literature [5]-[9], these publications ignore severalessential aspects w hich are discussed below ). In sec. IT we derive an approxim ate equation of state for the NP sector. Then, in sec. ITI we use this together w th the expected SM -NP interactions [1, 2] to determ ine the conditions under which the $S M$ and $N P$ sectors were in equilibrium. In sec. IV, using the experim ental constraints derived from $B$ ig- $B$ ang $N$ ucleosynthesis ( $B B N$ ) we obtain non-trivial bounds on the param eters of the theory. The A ppendices A and B are devoted to presentation of two altemative derivation of the Boltzm ann equation.

## II. THERMODYNAM ICS OF UNPARTICLES

In order to understand the therm odynam ic behavior of the new sector ${ }^{2}$ we use the expression for the trace anom aly of the energy $m$ om entum tensor of a gauge theory where all the renorm alized $m$ asses van ish [11]:

[^0]where denotes the beta function for the coupling $g$ and $N$ stands for the norm alproduct.
$T$ he basic assum ption for the unparticle phase is that the function has a non-trivial $\mathbb{R}$ xed point at $g=g_{\text {? }} \in 0$. M odeling the unparticle sector by a gauge theory, we assum e that for low tem peratures ${ }^{3}$

$w$ here $u$ is an integration constant and is the renorm alization scale.
We look for the low est-order corrections to the conform al lim it (where $=0$ ) when the system is in therm al equilibrium at tem perature $T$, is isotropic and hom ogeneous, and does not have any net conserved charge. Since vanishes in the conform allim it, in (1) we can take hN $\mathbb{F}_{\mathrm{a}} \mathrm{F}_{\mathrm{a}}$ li equalto its conform alvalue (we denote the therm al average by $h \quad$ i); taking the renorm alization scale $=T$ we then expect

Combining (5) w ith the them odynam ic relation $d(V)+P d V=T d(s V)$ ( $s$ is the entropy density), when and $P$ are functions of $T$ only ${ }^{4}$, and integrating, we nd,

where is an integration constant and we assum ed $\in 0$.
It is w orth noticing that the term $\mathrm{s} / \mathrm{A}$ correspond to deviations from the standard relativistic relation $\mathrm{V} / \mathrm{T}{ }^{3}$. $T$ he behavior at low tem peratures depends on the sign of, we will assume $>0$. Then

exhibiting the low est-order corrections to the often-used expression $P=w, w=$ const. $T$ hise ect $m$ ight be of interest in the discussion of the possible dark-energy e ects contained in this m odel, but will not be discussed here.

E lucidating the cosm ologicale ects of the $m$ odi ed equation of state (6) lies beyond the scope of the present paper, we m erely rem ark that the NP increases the coe cient of the $T{ }^{4}$ term in and induces $O$ ( $T$ ) corrections; e.g. in the radiation-dom inated era the scale param eter behaves as $(1+C T \quad)^{1=3}=T \quad$ ( $c=$ const.).

In generalwe expect A / $u$ since $u$ is the scale associated w ith broken scale invariance; then the energy density for the new sector in the unparticle phase equals

where we replaced $=3 g_{\mathbb{R}}=2$ (hereafter we use the nom alization from $M$ axw ell-B oltzm ann statistics) and $g_{\mathbb{R}}$, the e ective num ber of relativistic degrees of freedom (RD F), will be estim ated below.

[^1]In the BZ phase we assum e the theory is asym ptotically free so that, up to logarithm ic corrections,

$w$ here $g_{B} z$ denotes the RDF in this phase.
For interm ediate tem peratures the explicit form of the therm odynam ic functions requires a com plete nonperturbative calculation and the choice of a speci c m odel; fortunately we will not need to consider the detailed behavior of the system. G iven that / $T^{4}$ in both the $\mathbb{R}$ and $U V$ regions, for our punposes it $w$ ill be su cient to use the interpolation

$w h e r e g_{U}=\left[g_{\mathbb{R}}+(T=u) f\right] w h i l e N P$ stands for hew physics'; $g_{N P} w i l l$ be continuous at $T=u$ when $f=$ $g_{B} \quad g_{R}, w h i c h$ we now assum $e$. It is $w o r t h$ noting that a $m$ ass distribution of unparticles $w$ ith the spectral density $/\left({ }^{2}\right)^{\left(d_{v}\right.}{ }^{2)}$ [1] generates the term $/ \mathrm{f}$ in (10) w ith $=2\left(\mathrm{~d}_{\mathrm{J}} \quad 1\right)$, assum ing that the contributions w ith $>\mathrm{T}$ decouple. W e em phasize that (10) will be used only as a rough but convenient approxim ation that reproduces the expected behavior at low and high tem peratures. In cases of interest we expect $g_{\mathbb{R}} \quad \mathscr{G}_{z} \quad f$ so that the term $s$ / T are subdom inant.

Estim ating $g_{\mathbb{R}}$ directly form the $m$ odel Lagrangian is a non-trivial exercise, due to the expected strong-coupling nature of the theory in the infrared. U sing, how ever, the AdS-CFT correspondence [12] we nd

where $L$ denotes the $A d S$ radius of curvature and $M_{P 1}$ is the $P$ lanck $m$ ass. $G$ iven that $L$ is expected [12] to be signi cantly sm aller than $1=\mathrm{M}_{\mathrm{P}}$, , it is justi ed to expect that

In the follow ing we will use this as our estim ate for the RDF in the unparticle phase.
In order to estim ate $g_{B Z}$ one $m$ ust specify the details of the non-A belian theory in the ultraviolet regim e. For the m odels considered in [4] we nd

This result is based on a m odel for which the couping constant stays w ithin the perturbative regim e throughout its evolution. There is also non-perturbative lattice evidence [13] that gauge theories exhibiting an infrared xed point obey (13). In the follow ing we w ill adopt this estim ate.

T he energy density $u$ w as also discussed in [8], how ever the expression presented in this reference agrees w ith (8) only when $g_{\mathbb{R}}=0$ and therefore does not include the leading low tem perature behavior of the theory.

## III. $\quad$ SM -NP INTERACTIONSAND EQUILIBRIUM

The presence of a NP sector of the type considered here can have im portant cosm ological consequences since, even when weakly coupled to the $S M$, its energy density will a ect the expansion rate of the universe; this can then be used to obtain useful lim its on the e ective num ber of degrees of freedom $g_{N P}$. This calculation requires a determ ination of the relationship betw een the tem perature of the $N P$ and $S M$ sectors to which we now tum.
$T$ he interactions we w ill consider have the generic form

where the rst term is a gauge invariant operator com posed of SM elds (possible Lorentz indices have been suppressed), while the second operator is either com posed of BZ elds or is an unparticle operator, depending on the relevant phase of the NP sector. The coupling in generalhas dim ensions and is assum ed to be sm all. For the speci c calculations presented below we w ill assum e for sim plicity that $\mathrm{O}_{\mathrm{SM}}$;N p are both scalar operators.

Leading interactions involve SM operators that can generate 2 particle states since states with higher particle num ber w illbe phase-space suppressed. From such interactions we obtain the NP \$ SM reaction rate, which willbe
precisely de ned below. The tw o sectors will then be in equilibrium whenever $>\mathrm{H}$, where H denotes the H ubble param eter [14], and decouple at the transition tem perature $\mathrm{T}_{\mathrm{f}}$ :

W e denote by $\mathrm{T}_{S M}$ and $\mathrm{T}_{\mathrm{N} P}$ the tem peratures for the SM and $N \mathrm{P}$ sectors which can be di erent when these sectors are not in equilibrium

The approach to equilibrium can be described using either the $K$ ubo form alism (appendix A) or a suitable extension of the Boltzm ann equation form alism (appendix B). It follow $s$ form the expressions derived in the appendiges that the conditions near equilibrium are determ ined by the equation

The Boltzm ann equation (BE) calculation also yields (17) w ith the rate given by

$w$ here $M$ is the $m$ atrix elem ent ( $w$ ith no spin averaging) derived form the $S M-N P$ interaction Lagrangian ${ }^{5}$, $E_{S M}$ and $E_{S M}^{0}$ denote the initial and nal energies of the Standard $M$ odel particles in the reaction, and $K$ SM ;N $P$ the total $4-\mathrm{m}$ om enta of each sector for the reaction; we have also assum ed the Boltzm ann approxim ation (neglecting Pauli blocking or B ose $E$ instein enhancem ent) and denoted by $d$ SM;NP the appropriate phase-space m easures (w thout any spin factors). In particular, for the unparticle phase we use [1]

The solutions to (17) yields / R ${ }^{4}$ in the absence of the collision term (proportional to ), as expected for a scale invariant theory. It is also im portant to note that, in contrast to other authors ([5]-[7]), [19) contains an unparticledecay term (see appendix (B), as we nd the argum ents (based on the deconstruction picture [15]) for neglecting these contributions un justi ed ${ }^{6}$.
$T$ he detailed calculation of requires a speci $C$ form of the interaction $O_{S M} O_{N P}$ (see above for a speci cexam ple). $H$ ow ever for the purposes of the rem aining calculations only the basic properties of , such as its dependence on $T$ and the relevant R D F w ill.be needed. These properties can be obtained using dim ensional analysis: if the dim ensions of the operators are, respectively $d_{S M}$ and $d_{N P}$ and if the num ber of degrees of freedom involved in this interaction are $g_{S M}^{0}$ and $g_{N P}^{0}$, then, including a phase-space factor we nd

[^2]$w$ here $n_{S M}$ and $n_{N P}$ denote num bers of $S M$ and NP elds in the corresponding operators; in the unparticle phase we take $g_{N P}^{0}=d_{U}$ and $n_{N P}=2\left(d_{U} \quad 1\right)$, where $d_{J}$ denotes the dim ension of $O_{U}$.
$T$ he value of depends on the details of the model. Above the $H$ iggs ( ) mass m (we assum em $m \quad h$ i) the $m$ ost im portant operator is $O_{S M}=y$; in this case $g_{S M}^{0}=4$, so $\left.\quad\left(4=g_{M}\right) \quad f g_{\mathrm{g}}=g_{N P}\right)$. Below $m \quad$ there are $m$ any dim ension 4 SM operators relevant for the $S M-N P$ equilibration, e.g. 'e (containing an extra suppression by the factor $\mathrm{V}=\mathrm{M}_{\mathrm{U}}$; '; e denote a lepton isodoublet and isosinglet respectively), or $\mathrm{B} \quad \mathrm{B}$ (where B is the hypercharge gauge eld), in this case we expect $g_{S M}^{0} \quad g_{M}$, so that $\quad q_{P}=g_{N P}$.

## A . The B anks-Zaks phase.

W ew illassum e that the B Z sector corresponds to an $S U\left(n_{C}\right) Y$ ang $M$ ills theory $w$ ith $n_{f}$ vector-likem assless ferm ions in the fundam ental representation (denoted by $q_{z}$ ). A ssum ing that $u>v$, the leading SM $\$ N P$ interaction is of the form

For $d_{U}<4: 5 \quad d_{M},=H$ has the singular property of increasing as $T$ drops, whence $S M$ and $N P$ will equilibrate for $T<T_{U-f}$ (thaw -in); due to the constraints ${ }^{7}$ on $d_{U}$ ( $d_{U}<1$ is excluded [17]) this can only happen for $O_{S M}=y^{y}$. The opposite occurs if $d_{U}>4: 5 \quad d_{M} \quad$ (freeze-out). For $d_{U}=4: 5 \quad d_{M M}$, the approxim ations (16), (21) are insu cient and a detailed calculation is required to determ ine freeze-out and/or thaw-in conditions; we will not consider this special case further.

There are various possible scenarios for decoupling of the NP sector. The situation in the very early Universe ( $\mathrm{T}>\mathrm{M}_{\mathrm{U}}$ ) depends on the UV com pletion (including the $m$ ediator interactions) of the NP and w ill not be considered

here. If (24) holds then we have a standard freeze-out scenario: the $S M$ and $N P$ sectors $w i l l$ be in equilibrium down to $T \quad T_{B Z-f}$ and decouple below this value; thereafter the two sectors evolve keeping their entropies separately conserved. Since no $m$ ass thresholds or phase transitions are crossed ${ }^{8}$ the $S M$ and $N P$ tem peratures rem ain equal down to $T \quad U$.
$T$ he situation for $U{ }_{U} T$ is more complicated. If (27) holds (which de nes a region in the $u M_{U} p l a n e$ ), decoupling occurs in the unparticle phase. For $\mathrm{T}>\mathrm{v}$ the m ost relevant operator is $\mathrm{O}_{\mathrm{SM}}=\mathrm{y}$, and both thaw -in (for $d_{U}<2: 5$ ) and freeze-out (for $d_{U}>2: 5$ ) m ay be present. For $v>\mathrm{T}$ all the relevant $S M$ operators have $d_{S M}=4$, and only freeze-out is possible; in this case $T_{U-f} m$ ay be signi cantly sm aller than $v$.

O ther param eter values lead to $m$ ore com plicated scenarios, e.g. a double decoupling: freeze-out in the BZ , thaw -in in the unparticle phase and then freeze out below v. In spite of the $m$ any possibilities, there is alw ays a tem perature below which the SM and NP decouple.

In F ig. 1 we show regions in the ( $\mathrm{U} ; \mathrm{M}_{\mathrm{U}}$ ) space that correspond to various freeze-out and thaw -in scenarios for a reasonable param eter choice. For this calculation we assum ed that $O_{S M}=y$ is responsible for maintaining the equilibrium betw een the $S M$ and NP (so $d_{S M}=2$ ). For consistency that choice im plied an additional constraint
 $w$ as adopted (in which case $d_{B Z}=3$ ).

[^4]IV. BIG BANGNUCLEOSYNTHESIS

T he light-elem ent abundances resulting from BBN are sensitive to the expansion rate that determ ines the tem perature of the universe (see e.g. [18]), which can be used to restrict possible additionalRD F , or, in our case, $g_{\mathbb{R}}$. These bounds should be com pared to $g_{\mathbb{R}}>100$ typical of speci cmodels [4] e.g. for an $S U$ (3) gauge theory $w$ ith 16 findam ental ferm ion $m$ ultiplets, and expected from AdS/CFT correspondence [12]. W e conclude that many unparticle $m$ odels $w$ ill have di culties accounting for the observed light-elem ent abundances.

U sing the trace anom aly we argue for a form of the equation of state for unparticles that contains pow er-like corrections to the expression for relativistic m atter; this allow s us to determ ine tem perature dependence of the energy and entropy density for unparticles. W e then derive the Boltzm ann equation for the BZ phase and postulate a plausible form for this equation for unparticles; using this we determ ine the conditions for $N P-S M$ equilibrium . $F$ inally we derive useful constrains on the NP e ective num ber of degrees of freedom im posed by the BBN.

In this case the de nition of (A 26) obtained through the $K$ ubo equation is preferable where the relevant $m$ atrix elem ents can, at least in principle, be obtained num erically.
