New properties of z-scaling: avor independence and saturation at low z

Experim entaldata on inclusive cross sections of particles produced in high energy proton-(anti)proton collisions at ISR, RH IC, and Tevatron are analyzed in the fram ework of z-scaling. New features of the scaling function (z) are established. These are avor independence of (z) including particles with heavy avor content and saturation at low z. The avor independence m eans that the shape of the scaling function

(z) is the same for di erent hadron species. The saturation corresponds to attening of (z) for z < 0.1. Relations of model parameters used in data z-presentation with some therm odynamical quantities (entropy, speci c heat, tem perature) are discussed. It is shown that behavior of the particle spectra at low z is controlled by a parameter c interpreted as a speci c heat of the created medium associated with production of the inclusive particle. The saturation regime of (z) observed at low z is assumed to be preferable in searching for phase transitions of hadron matter and for study of non-perturbative QCD in high energy proton-(anti)proton collisions at U 70, RH IC, Tevatron, and LHC.

I. IN TRODUCTION

The production of particles with high transverse momenta from the collision of hadrons and nuclei at su ciently high energies has relevance to constituent interactions at sm all scales. In this regime, it is interesting to search for new physical phenomena in elementary processes such as quark compositeness [1], extra dimensions [2], black holes [3], fractal space-time [4] etc. O ther aspects of high energy interactions are connected with sm all momenta of secondary particles and high multiplicities. In this regime collective phenomena of particle production take place. The search for new physics in both regions is one of the main goals of investigations at Relativistic Heavy Ion Collider (RHIC) at BNL and Large Hadron Collider (LHC) at CERN [5]. Experimental data on particle production at high energy and multiplicity provide constraints for di erent theoretical models. Processes with high transversem on enta of produced particles are suitable for a precise test of perturbative Q uantum C hrom odynam ics (Q CD). The soft regime is preferred for veri cation of non-perturbative QCD and investigation of phase transitions in non-A belian theoreties.

O ne of the m ethods allowing system atic analysis of data on inclusive cross sections over a wide range of the collision energies, multiplicity densities, transverse m on enta, and angles of the produced particles is based on the z-scaling observed in high energy proton-(anti)proton collisions (see R ef. [6] and references therein). The approach to the description of the inclusive spectra re ects the principles of locality, self-sim ilarity, and fractality of hadron interactions at a constituent level. It takes into account the structure of the colliding objects, interaction of their constituents, and processes of particle form ation over a wide scale range. The analyzed data include processes which take place at nucleon scales as well as at sm all scales down to 10⁻⁴ Fm. The presentation of experimental data in this approach is given in term s of the scaling function (z) and the scaling variable z. B oth are constructed using the kinem atical variables, the experimentally measured inclusive cross section E d³ = dp³, the multiplicity density dN = d, and som em odel parameters which allow physical interpretation.

It was shown [6] that the scaling behavior of (z) is valid for di erent types of the produced hadrons. The scaling function demonstrates two regimes. The rst one is observed in the high-and the second one in the low $-p_T$ region. The hard part of the inclusive spectra is described by the power law, (z) z , with a constant value of at large z. The self-sim ilar features of particle production dictated by the z-scaling at large z give strong restriction on the asymptotic behavior of the spectra in the high- p_T region. This provides suitable constraints on phenom enology of parton distribution functions and fragm entation functions which are needed to verify the perturbative QCD in hadron collisions. The soft regime of particle production demonstrates attening of the scaling function (z) for smallz. The behavior of (z) at smallz is of interest to study the non-perturbative QCD in the processes with low $-p_T$. We consider that this region is most preferable in searching for phase transitions and study of collective phenom ena in multiple particle system s.

In this paper we show that in the high energy pp- and pp-collisions the shape of the scaling function at low z is independent of the type of the inclusive hadron including production of the hadrons with heavy avor content. A saturation of (z) with decreasing z is observed. The single parameter c which controls the behavior of (z) at low z is interpreted as a speci c heat of the produced medium. The scaling in pp- and pp-collisions is consistent with a constant value of c. Search for a possible change in this parameter is of interest especially for soft processes with high multiplicities. Such a change could be an indication of a phase transition in the matter produced in high energy collisions of both hadrons and nuclei.

The paper is organized as follows. A concept of the z-scaling and the method of construction of the scaling function (z) are brie y described in Sec. II. The properties of energy, angular, and multiplicity independence of the scaling function are mentioned in Sec. III. The avor independence and saturation of (z) at low z are demonstrated in Sec. IV. A microscopic picture of the constituent subprocess is analyzed in Sec. V. A relation of the scaling variable z to some therm odynam ical quantities is discussed in Sec. VI. Here we consider possible manifestations of phase transitions and their elects to the parameters used in the z-presentation of inclusive spectra. Conclusions are sum marized in Sec. VII.

II.Z-SCALING

In this paper we follow the version of the z-scaling presented in Ref. [6]. Let us brie y rem ind the basic ideas of this concept. At su ciently high energies, the collision of extended objects like hadrons and nuclei is considered as an ensemble of individual interactions of their constituents. The constituents are partons in the parton m odel or quarks and gluons in the theory of QCD. A single interaction of constituents is illustrated in Fig. 1.



FIG.1.D iagram of the constituent subprocess.

Structures of the colliding objects are characterized by parameters $_1$ and $_2$. The constituents of the incoming hadrons (or nuclei) with masses M $_1$; M $_2$ and momenta P $_1$; P $_2$ carry their fractions x_1 ; x_2 . The inclusive particle carries the momentum fraction y_a of the scattered constituent with a fragmentation characterized by a parameter $_a$. A fragmentation of the recoil constituent is described by $_b$ and the momentum fraction y_b . Multiple interactions are considered to be similar. This property represents a self-similarity of the hadronic interactions at the constituent level.

A.M om entum fractions x_1 ; x_2 ; y_a , and y_b

The idea of the z-scaling is based on the assumption [7] that gross features of an inclusive particle distribution of the reaction

can be described at high energies in terms of the kinematical characteristics of the corresponding constituent subprocess. We consider the subprocess to be a binary collision

of the constituents (x_1M_1) and (x_2M_2) resulting in the scattered $(m_1=y_a)$ and recoil $(x_1M_1+x_2M_2+m_2=y_b)$ objects in the nalstate. The produced secondary objects transform into real particles after the constituent collisions. The registered particle with the mass m_1 and the 4-m om entum p and its hadron counterpart, moving in the opposite direction, carry the momentum fractions y_a and y_b of the scattered and recoil system s, respectively. The momentum conservation law of the constituent subprocess is connected with a recoil mass which we write in the form

The associate production of (m_2) ensures conservation of the additive quantum numbers. Equation (3) is an expression of the locality of the hadron interaction at a constituent level. It represents a kinematical constraint on the momentum fractions x_1 , x_2 , y_a , and y_b which determine a subprocess (2).

Structure of the colliding objects and fragm entation of the system s form ed in the scattered and recoil directions are characterized by the parameters $_1$; $_2$ and $_a$; $_b$, respectively. We connect the structural parameters with the corresponding momentum fractions by the function

P hysical interpretation of is given by its proportionality to relative num ber of all such constituent con gurations in the reaction (1) which contain the con guration dened by the fractions $x_1;x_2;y_a$; and y_b . The function plays the role of a relative volum e which occupy these con gurations in the space of the momentum fractions. It was found that the structural parameters $_1$, $_2$, $_a$, and $_b$ have constant values at high energies. They are interpreted as fractal dimensions in the corresponding space of the momentum fractions. For proton-proton collisions we set $_1 = _2$. In the case of nucleus-nucleus collisions there are relations $_1 = A_1$ and $_2 = A_2$, where A_1 , A_2 are atom ic num bers [3]. We assume that the fragmentation of the objects moving in the scattered and recoil directions can be described by the same parameter $_a = _b = _F$ which depends on the type (F) of the inclusive particle. For given values of and $_F$, we determ ine the fractions x_1 , x_2 , y_a , and y_b in a way to maximize the function $(x_1;x_2;y_a;y_b)$, simultaneously full ling condition (3). The momentum fractions x_1 and x_2 obtained in this way can be decomposed as follows

where $_{1;2} = _{1;2} (y_a; y_b)$ and $_{1;2} = _{1;2} (y_a; y_b)$ are simple specic functions [6] of y_a and y_b . Using the decomposition, the subprocess (2) can be rewritten into a symbolic form

This relation means that the -parts of the interacting constituents contribute to the production of the inclusive particle, while the -parts are responsible for the creation of its recoil. The maximum of the function (4) with the condition (3) can be obtained by searching for the unconstrained maximum of the function

of two independent variables y_a and y_b . There exists a single maximum of F ($y_a; y_b$) for every momentum p in the allowable kinematical region. Values of y_a and y_b corresponding to this maximum have been determined numerically. Having obtained the fractions x_1 , x_2 , y_a , and y_b , we evaluate the function according to (4). For xed numbers and $_F$ we obtain in this way the maximal value of for every momentum p of the inclusive particle.

Since the momentum fractions are determined by means of the maximization of the expression (4), they implicitly depend on and_F . The parameter $_F$ enables to take electively into account also prompt resonances out of which the inclusive particle of a given type may be created. At xed mass parameter m₂, larger values of $_F$ correspond to smaller y_a and y_b, which in turn give larger ratios m₂=y_b and m₁=y_a. In our phenom enological approach this means that production of the inclusive particle (m₁) and its counterpart (m₂) is a result of fragmentation from larger masses which m in ic in a sense processes with prompt resonances. Values of these parameters are determined in accordance with the experiment and are discussed in the next sections.

B. Scaling variable z and scaling function (z)

The self-sim ilarity of hadron interactions rects a property that hadron constituents and their interactions are sim ilar. This is connected with dropping of certain dimensional quantities out of the description of physical phenomena. The self-sim ilar solutions are constructed in terms of the self-sim ilarity parameters. We search for a solution

depending on a single self-sim ilarity variable z. Here $_{inel}$ is an inelastic cross section of the reaction (1) and N is an average particle multiplicity. The variable z depends on m om enta and m asses of the colliding and inclusive particles, structural parameters of the interacting objects, and dynam ical characteristics of the produced system . We denote the variable z as follows

and given by (4). For a given reaction (1), the variable z is proportional to the transverse kinetic energy $p_{\overline{s_2}}$ of the constituent subprocess (2) consumed on the production of the inclusive particle (m_1) and its counterpart (m_2) . The energy $p_{\overline{s_2}}$ is determined by the form ula

The term s

represent the energy for production of the secondary objects moving in the scattered and recoil direction, respectively. The quantity $dN_{ch}=d_{j}$ is the corresponding multiplicity density of charged particles in the central region of the reaction (1) at pseudorapidity = 0. The multiplicity density in the central interaction region is related to a state of the produced medium. The parameter c characterizes properties of this medium [6]. It is determined from multiplicity dependence of inclusive spectra. The mass constant m is arbitrary and we x it at the value of nucleon mass.

The scaling function (z) is expressed in term s of the experimentally measured inclusive cross section $Ed^3 = dp^3$, the multiplicity density dN = d at pseudorapidity , and _{inel}. Exploiting the de nition (8) one can obtain the expression [6]

where s is the square of the center-ofm ass energy and J is the corresponding Jacobian. The multiplicity density dN = d in the expression (14) concerns particular hadrons species. It depends on the center-ofm ass energy, on various multiplicity selection criteria, and also on the production angles at which the inclusive spectra were measured. The procedure of obtaining the corresponding values of dN = d from the p_T spectra is described in Ref. [6]. The function (z) is normalized as follows

The above relation allows us to interpret the function (z) as a probability density to produce an inclusive particle with the corresponding value of the variable z.

III. PROPERTIES OF THE SCALING FUNCTION

Let us rem ind the properties of the z-presentation of experim ental data already found in proton-(anti)proton collisions at high energies. These are the energy, angular, and multiplicity independence of the scaling function (z) for di erent types of hadrons, direct photons, and jets con rm ed by num erous data obtained at ISR, SppS, Tevatron, and RH IC.

A.Energy independence of (z)

The energy independence of the z-presentation of inclusive spectra means that the shape of the scaling function is independent on the collision energy so over a wide range of the transverse momentum p_T of the inclusive particle. Results on the energy independence of the z-scaling for hadron production in proton-proton collisions were presented in Ref. [6]. The analyzed data [9[17] include negative pions, kaons, and antiprotons measured at FNAL, ISR, and RHIC energies. The spectra were measured over a wide transverse momentum range $p_T = 0.1$ 10 GeV/c. The cross sections decrease from 10^2 to 10^{-10} m b/G eV² in this range. The strong dependence of the spectra on the collision energy increases with transverse momentum. The independence of the scaling function (z) on $\frac{10}{5}$ was found for the constant values of the parameters c = 0.25 and c = 0.5 for all types

of the analyzed hadrons (;K;p). The value of $_{\rm F}$ increases with the the mass of the produced hadron. None of these parameters depends on the kinem atical variables. This was demonstrated for charged particles, negative pions, kaons, and antiprotons in the range of $^{\rm P}$ ${\rm s}$ = 19 200 G eV. The z-presentation of particle spectra produced in proton-antiproton collisions was studied as well. In this case the energy independence of the scaling function was obtained for di erent set of parameters. The scaling functions for proton-(anti)proton collisions have sim ilar shapes but di er in the region of large z. The di erent values of the slope parameter ($_{\rm pp} > _{\rm pp}$) of the scaling function, (z) z , for charged hadron, direct photon, $^{\rm 0}$ -m eson, and jet production in pp and pp collisions

at high zwere found in Ref. [18].

B.Angular independence of (z)

The angular independence of the z-presentation of inclusive spectra m eans that the shape of the scaling function is independent of the angle cm s of the produced particles over a wide range of the transverse momentum p_T . Results on the angular properties of the z-scaling in proton-proton collisions are presented in Ref. [6]. The analyzed experimental data [19] on angular dependence of inclusive spectra include negative pions, kaons, and antiprotons measured at ISR energies. The angles cover the range $_{cm s} = 3^0 90^\circ$. The central and fragm entation regions are distinguished by a di erent behavior of di erential cross sections. The analysis included the transverse mom entum spectra of charged hadrons for $_{cm s} = 5^0$ and 13^0 [20] obtained by the BRAHMS Collaboration at RHIC. The data cover a wide range of the transverse momenta $p_T = 0.25$ 3.45 GeV/c of the produced hadrons at the collision energy $\overline{s} = 200 \text{ GeV}$. The angular independence of the scaling function (z) for charged particles, negative pions, kaons, and antiprotons was obtained for the same values of the parameters c_{1} , and F_{2} which give the energy independence of (z). This represents dierent values of $_{\rm F}$ for pions, kaons,... and the same values of $_{\rm F}$ and c for all of them . The scaling function is sensitive to the value of m $_2$ for small production angles $_{\rm cm \ s}$. This param eter was determ ined from the corresponding exclusive reactions at the kinem atical lim it (for $x_1 = x_2 = y_a = y_b = 1$). Using Eq. (3), this gives $m_2 = m$ (⁺), $m_2 = m$ (K⁺), and $m_2 = m$ (p), for the inclusive production of , K , and antiprotons, respectively. Note that the charged hadron multiplicity density dN $_{ch}=d$ $j_{=0}$ represents an angular independent factor in the de nition of the variable z which is the same for all particle species. On the contrary, the scaling function for pions, kaons, antiprotons,... is norm alized (14) to the angular dependent multiplicity density dN =d of the corresponding particles, respectively.

C.Multiplicity independence of (z)

The multiplicity independence of the z-presentation of inclusive spectra means that the shape of the scaling function (z) does not depend on the multiplicity selection criteria characterized by the di erent values of dN_{ch}=d. The multiplicity density in uences the shape of the inclusive spectra especially at high transverse momenta [21]. At low p_T the dependence of the cross sections on $dN_{ch}=d$ concerns mainly the absolute values and much less the shape. Results on the multiplicity independence of the z-scaling in proton-proton collisions were presented in Ref. [6]. The analysis was perform ed using the K⁰_S-m eson and -baryon spectra [22] obtained by the STAR Collaboration at $\frac{1}{s} = 200 \text{ GeV}$ for di erent multiplicity classes. The charged multiplicity density was varied in the

range dN_{ch}=d = 1.3 9:0. The transverse m om entum distributions were m easured in the central rapidity range j j< 0.5 up to the m om entum $p_T = 4.5$ GeV/c. The multiplicity independence of the scaling function provides a strong restriction on the parameter c. Both data favor the same value of c = 0.25 as was obtained from the energy independence of the z-scaling in proton-proton collisions. Similar applies to the p_T distributions of charged particles [21] associated with the di erent multiplicity criteria.

An analysis of the spectra of direct photons and jets gives som ewhat di erent results in the sense, that the energy, angular, and multiplicity scaling was obtained by other set of the parameters c, , and $_{\rm F}$. Nevertheless, the corresponding parameters do not depend on the kinematical variables, similarly as in the case of the z-scaling for identied hadrons produced in proton-(anti)proton collisions.

IV.NEW PROPERTIES OF Z-SCALING

In this section we study possibility of a uni ed description of the particle spectra of di erent hadrons using properties of their z-presentation. The analysis is based on the observation that simultaneous energy, angular, and multiplicity independence of the z-scaling for negative pions, kaons, and antiprotons produced in proton-proton collisions gives the same shape of the scaling function (z). This avor independence of (z) is con m ed here for other inclusive particles including the particles with heavy quarks. The independence in proton-antiproton interactions is observed with the exception of large z, where the functions (z) for pp- and pp-collisions mutually di er. The transverse momentum spectra of J= [23] and [24] mesons measured at the Tevatron energies s = 1800 and 1960 G eV make it possible to investigate the behavior of the scaling function in the region of very small z (up to 10⁻³). In this region we observe a saturation of (z) which can be approximated by a constant. The saturation and avor independence of the scaling function for di erent hadrons with light and heavy quarks are con-mation of the factorization

of the inclusive cross sections. This property of the z-scaling is valid for pp-collisions in a large range of kinem atical variables. The factorization of the di erential cross section in the variable z and the pseudorapidity was demonstrated [6] as the angular independence of the z-scaling for $_{\rm cm\ s}=3^0$ 90°. The scaling property at small angles gives strong restriction on the parameter m₂ which was found to be equal to the mass of the inclusive particle for the negative pions, kaons, and antiprotons. The same relation, m₂ = m₁, is used here for all types of the inclusive hadrons.

A.Flavor independence of (z)

Evidence of avor independence of z-scaling was for the rst time noted in Ref. [18]. It was found that the value of the slope parameter of the scaling function (z) at high z is the same for di erent types of produced hadrons (;K;p). The hypothesis was later supported by the results of an analysis of hadron (^{;0};K;p) spectra for high p_T in pp- and pA-collisions. Here we show that avor independence of the z-presentation of hadron spectra is valid for di erent hadrons over a wide range of the variable z. Hence we exploit the scaling transform ation

for com parison of the shape of the scaling function (z) for di erent hadron species. The param eter $_{\rm F}$ is a scale independent quantity. The transform ation does not change the shape of (z). It preserves the norm alization equation (15) and does not destroy the energy, angular, and multiplicity independence of the z-presentation of particle spectra.

Figure 2 (a) shows the z-presentation of the spectra of negative pions, kaons, antiprotons, and ⁰s produced in pp-collisions over the range $P_{s} = 19$ 200 G eV and _{cm s} = 3⁰ 90⁰. The symbols represent data on di erential cross sections measured in the central [9{11,13,15,16,25] and fragm entation [19] regions, respectively. The analysis comprises the inclusive spectra of particles [26,27]

m easured up to very small transverse m on enta (pr ' 45 M eV/c for pions and pr ' 120 M eV/c for kaons or antiprotons). One can see that the distributions of di erent hadrons are su ciently well described by a single curve over a wide z-range (0.01 30). The function (z) changes m ore than twelve orders of magnitude. The solid lines represent the same curve shifted by multiplicative factors for reasons of clarity. The same holds for the corresponding data shown with the di erent symbols. The indicated values of the parameter $_{\rm F}$ (=0.2; $_{\rm K}$ ' 0.3; $_{\rm p}$ ' 0.35; ' 0.4) are consistent with the energy, angular, and multiplicity independence of the z-presentation of spectra for di erent hadrons. The parameters were found to be independent of kinem atical variables (${\rm S}; {\rm pr}$, and $_{\rm cm s}$). The scale factors $_{\rm F}$ are constants which allow us to describe the z-presentation for di erent hadron species by a single curve. The estim ated errors of $_{\rm F}$ are at the level of 20%.

p Figure 2 (b) shows similar results for other hadrons (;!;; K;) produced in pp-collisions at s = 200 GeV and $cm s = 90^{\circ}$. The experimental data [28{32}] on inclusive spectra are compared with the pion distributions [15] measured at RH IC. The shape of (z) for these particles is described by the same curve (solid line) as depicted in Fig. 2(a). The black circle at the lowest z ' 0:007 corresponds to the STAR data [31] on K resonances measured in the region where the scaling function is saturated. Based on the obtained results we conclude that RH IC data on pp-collisions con m the avor independence of the z-scaling including the production of particles with very small p_T .

The inclusive spectra of heavier hadrons (J= ;D⁰;B;) [23,24,33] obtained at the Tevatron energies s = 1800 and 1960 G eV allow us to verify the new property of the z-scaling in pp-collisions. The data include m easurements up to small transverse m on enta (p_T ' 125 M eV/c for charmonia, p_T ' 290 M eV/c for bottom ia, and p_T ' 500 M eV/c for B-m esons). Figure 3 (a) shows the transverse m on entum spectra of J= ;D⁰;B, and m esons in the z-presentation. The scaling function is the same for hadrons with light and heavy avors produced in pp- and pp-collisions in the range z = 0.001 4. This is indicated by the same line as in Fig. 2. The corresponding values of the parameters F and F are found to be $_{J=} = 0.23$, $_{D^0}$ ' 0.23, $_{B}$ ' 0.12, $_{(1S)}$ ' 0.15 and $_{J=} = 1$; $_{D^0}$ ' 0.4, $_{B}$ ' 0.4, $_{(1S)}$ ' 0.4, respectively. Figure 3 (b) demonstrates results of combined analysis of the RHIC [34] and Tevatron [23] data on J= -m eson spectra m easured in pp- and pp-collisions at di erent energies s = 200;1800;1960 G eV and angles $_{cm s} = 22^0;90^0$ in the z-presentation. The solid line is the same one as shown in Figs. 2 and 3 (a).

From the perform ed analysis we conclude that ISR, R H IC, and Tevatron data on inclusive spectra manifest the avor independence of the scaling function (z) over a wide range of z. W e would like to stress that the obtained result is based on p_T distributions of the cross sections E d³ =dp³ which reveal strong dependence on the energy, angle, multiplicity, and type of the produced particle.

B.Saturation of (z)

The description of particle spectra in term s of the variable z depends on the parameters 1;2; F, and c. In the region of high z, the production of di erent hadrons is characterized by di erent values of F. A reliable estimation of this parameter requires processes with high p_T . The same applies to $_{1;2}$ which relates to the structure of the colliding particles in the initial state. On the contrary, the low -z region corresponds to the small values of p_T and low m om entum fractions x_1, x_2, y_a , and y_b . In this region z tends to zero as p_T decreases or $\frac{p}{s}$ increases. Here is ' 1 and the scaling variable can be approximated by z $s_2^{1=2} = (dN_{ch} = d_{-\frac{1}{2}})^c$. The behavior of (z) at low z is therefore governed by the single parameter c.

As seen from Figs. 2 and 3, the z-presentation of hadron distributions demonstrates weak dependence on the variable z in the soft (low p_T) region. The data on the pion, kaon, antiproton and especially on J= and spectra manifest saturation in the range z = 10⁻³ 10⁻¹. This regime is characterized by an approximate constant behavior of the scaling function, (z) ' const. The similar dependence is observed for other hadrons (K ;B; ,..) at low p_T . A characteristic of the saturation is the slope of the scaling function which is diminishing with the decreasing z. The value of is approximately zero for z = 10⁻³ 10⁻¹.

O ne can assume that the asymptotic behavior of (z) at z ! O is universal and re ects properties of the produced system consisting of its constituents (hadrons or quark and gluons). The universal scaling behavior in this region suggests that mechanism of particle production at low p_T is governed by soft self-sim ilar processes which reveal some kind of a mutual equilibrium leading to the observed saturation.

V.A M ICROSCOPIC PICTURE OF CONSTITUENT SUBPROCESSES

The approach based on the z-scaling concept allows us to develop a microscopic scenario of particle production in terms of the constituent interactions. Here we discuss some features of this scenario. We attribute the quantity z to any inclusive particle in the reaction (1). The scaling variable z has character of a fractal measure. It consists of the nite part z_0 and of the divergent ¹. The factor ¹ describes a resolution at which an underlying subprocess can be singled factor out of the inclusive reaction (1). The $(x_1; x_2; y_a; y_b)$ is proportional to num ber of all congurations containing the incoming constituents which carry the fractions x_1 and x_2 of the momenta P_1 and P_2 and which fragment to the inclusive particle (m_1) and its counterpart (m_2) with the corresponding m om entum fractions y_a and y_b . The parameters $_1$ and $_2$ have relation to fractal structure of the colliding objects (hadrons or nuclei). They are interpreted as fractal dimensions of the colliding objects in the space of the momentum fractions. The parameters a and b characterize the fractal behavior of the fragmentation process in the nal state. A common property of fractal measures is their divergence with the increasing resolution. The scaling variable has this property as the resolution ¹ goes to in nity,

It means that z is the scale dependent quantity. For an in nite resolution the whole reaction (1) degenerates to a single subprocess (2), all momentum fractions become unity ($x_1 = x_2 = y_a = y_b = 1$) and = 0. This kinematical limit corresponds to the fractal limit z = 1. In the general case, the momentum fractions are determined from a principle of a minimal resolution of the fractal measure z. The principle states that the resolution 1 should be minimal with respect to all binary subprocesses (2) in which the inclusive particle m_1 with the momentum p can be produced. It is the values of the corresponding momentum fractions $x_1; x_2; y_a$, and y_b and singles out the most elective binary subprocess which underlies the inclusive reaction (1).

A.M om entum fractions versus p_T and $p_{\overline{s}}$

The method of determ ination of the momentum fractions makes it possible to analyze kinematics of the constituent interactions in the fram ework of the developed approach. The study of $x_1 \quad x_2$ and $y_a \quad y_b$ correlations and their dependencies on the collision energy and transverse momentum of the inclusive particle gives us possibility to look at microscopic picture of the underlaying subprocesses.

The fractions x_1 and x_2 characterize amount of the energy (momentum) of the interacting protons (antiprotons) carried by their constituents which undergo the binary collision (2) that underlies the inclusive reaction (1). Figure 4 (a) shows the dependence of the fraction x_1 on the transverse momentum p_T of the negative pions, kaons, and antiprotons produced in pp-collisions at $rac{1}{s} = 19, 53, 200 \text{ GeV}$ and $_{\text{cm s}} = 90^{\circ}$. The fractions x_1 and x_2 are equal each other in that case. They increase nearly linearly with the transverse momentum p_T , for xed p_T , the fraction x_1 decreases as the collision energy $rac{1}{s}$ increases. The x_1 is larger for the production of heavy particles as compared with light ones. The kinem atical lim it of the reaction (1) corresponds to $x_1 = x_2 = 1$ at any collision energy and for any type of the inclusive particle. This can be seen in Fig. 4 (a) for $\overline{s} = 19 \text{ GeV}/c$ for all three particles.

r = 19 GeV where the fraction x_1 approximates unity at p_T ' 9 GeV/c for all three particles. The correlation $x_1 = x_2$ for the 'K', and p production at the energy r = 53 GeV and for various detection angles is shown in Fig. 4 (b). The central ($_{cm s} = 90^{\circ}; 58^{\circ}; 40^{\circ}$) and fragmentation ($_{cm s} = 2.86^{\circ}$) regions are distinguished by a di erent mutual behavior of x_1 and x_2 . The $x_1 = x_2$ correlation at $_{cm s} = 90^{\circ}$ is depicted as a strait line. For other angles belonging to the central interaction region, the correlation become smore complicated and depends on the particle type. Both tendencies diminish with the increasing p_T where the fraction x_2 demonstrates linear dependence on x_1 over a wide range. This is a common feature for all hadron species. The situation is di erent in the fragmentation region. The fraction x_2 is much less than x_1 and strongly depends on the type of the inclusive particle at the small angle $_{cm s} = 2.86^{\circ}$. The heavier particle the larger x_2 . The kinem atical limit (x_1 ' 1) where the fraction x_2 begins to grow larger.

The dependence of the momentum fractions y_a and y_b on the kinem atical variables (p_T ; c_{TT} ; r_{TT} ; r_{TT}) describes features of the fragmentation process. The fraction y_a characterizes dissipation of the energy and momentum of the object produced by the underlying constituent interaction into the near side of the inclusive particle. This electively includes energy losses of the scattered secondary partons moving in the direction of the registered particle as well as feed down processes from prompt resonances out of which the inclusive particle may be created. The fraction y_b governs the recoilm ass in the constituent subprocess. Its value characterizes the dissipation of the energy and momentum in the away side direction of the inclusive particle.

Figure 5 (a) shows the dependence of y_a on the transverse m on entum p_T for the negative pions, kaons, and antiprotons produced in pp-collisions at the energy $r_s = 19, 53, 200 \text{ GeV}$ and $r_{cm s} = 90^0$. A ll curves dem onstrate a non-linearm onotonic grow th with p_T . It means that the energy dissipation associated with the production of a high p_T particle is smaller than for the inclusive processes with lower transverse m on enta. This feature is similar for all inclusive reactions at all energies. D ecrease of the fractions y_a with the increasing collision energy is another property of the considered mechanism. It corresponds to more energy dissipation at higher energies. This can be due to the larger energy losses and/or due to the heavy prom pt resonances. The third characteristic is a slight decrease of y_a with the mass of the inclusive particle. It is plies more energy dissipation for creation of heavier hadrons as compared with hadrons with smaller masses. The asymptotic value of $y_a = 1$ is reached at the kinem atical limit for all particle species.

The dependence of y_b on p_T rejects kinemiatical properties of the recoil system. One can see from Fig. 5(b) that y_b is nearly independent of p_T . It is smaller than y_a and decreases with the increasing collision energy \bar{y} . The values of y_b are larger for particles with higher masses. The qualitative properties of the p_T dependence of y_b are similar for dimensional that the momentum balance in the production of an inclusive particle from a subprocess is more likely compensated with many particles with smaller momentum by a single particle with a higher momentum moving in the opposite direction.

The p_T -dependence of y_a and y_b for other hadrons produced in p_P -collisions have similar behavior. This is demonstrated in Fig. 6(a) on the data [15,16,25,28(32] at s = 200 GeV and $c_{m s} = 90^{\circ}$ obtained at RHIC. The hollow symbols demonstrate grow th of y_a with p_T . The full symbols show attening of y_b in the range of $p_T = 0.2$ 10 GeV/c. Note that both fractions become equal each other, y_a ' y_b , for heavier particles and low transverse momenta. This together with $m_1 = m_2$ m eans that, at low p_T , the objects produced in the constituent collision into the near- and away-side direction have equal masses. The feature is even more pronounced for particles with heavy quarks. It is well seen from Fig. 6(b) where the momentum dependence of y_a and $y_b p$ is demonstrated for J= ;D⁰;B, and -m esons produced in pp-collisions at the Tevaron energies s = 1800 and 1960 GeV. The spectra correspond to the central rapidity range. The p_T -dependence of y_a and y_b has similar behavior as for data obtained at the RHIC energy.

There is, how ever, a particularity in the absolute values of the m on entum fractions which concern the J= -m eson production. The corresponding curves for y_a and y_b ky m uch below than what one could expect when compared with other particles, even at high p_T . This is a consequence of the relatively large value of $_{J=}$ = 1 which follows from the requirement of the energy independence of (z) for the charm onium production (see Fig. 3). In our approach it m eans that J= -m eson is produced from larger masses accompanied with extra large dissipation of energy in the nal state. This exceptional property predestinate the J= -m eson to be a suitable probe in AA-collisions where the energy losses can be sensitive to di erent phases of the created matter.

A comparison of the momentum fractions y_a and y_b for the charmonium production in pp [34] and pp [23] collisions at rss = 200 and 1960 GeV is shown in Fig. 7(a). The fractions follow the general trend i.e. a decrease with the collisions energy, grow th of y_a , and approximate constancy of y_b with p_T . The equality of both fractions at low p_T remains preserved independent on rss. Another feature typical for all types of the inclusive particles is the angular dependence of the fractions. The y_a increases signi cantly with the decreasing angle cm s. It means that the energy dissipation from the constituent subprocess is much smaller in the fragmentation region as compared to the central interaction region. The change of the fraction y_b with the angle cm s is small. A levelling of y_b with p_T for small angles is observed.

The sensitivity of the transverse m om entum dependence of y_a and y_b to the m ass of the states (1S;2S;3S) is demonstrated in Fig. 7 (b). The sym bols correspond to the experimental data [24,35] on cross sections measured at FNAL. It turns out that the momentum fractions change visibly with the respective state of the bottom ium at sm aller collision energy. The heavier m ass the larger fractions. This is connected with di erent energy losses which seem to depend on the m ass state of the single states of this particle. The curves for the 1S, 2S, and 3S states coincide each other at $P_{\overline{s}} = 1800 \text{ GeV}$ in the momentum range $p_T = 0.5 = 17 \text{ GeV/c}$.

A nother characteristic of the constituent interactions is the recoil m ass

released in the underlying subprocess (2). It is defined by the right-hand side of Eq. (3). The quantity is proportional to the momentum fractions x_1 and x_2 of the interacting objects with the masses M₁ and M₂. Its relation to the fractions y_a and y_b is given by the simple dependencies $x_{1;2} = x_{1;2} (y_a; y_b)$ listed in Ref. [6].

The method of determination of y_a and y_b makes them implicitly dependent on and_F . These parameters are obtained from the z-scaling approach to analysis of experimental data on inclusive particle distributions. In such a way the recoil mass M_X has an internal connection to the structure of the colliding objects, constituent interactions, and process of formation of the individual hadrons. In the very vicinity of the kinematical limit, the recoil mass is kinematically bounded to approximate the value $M_1 + M_2 + m_2$.

Figure 8 (a) shows the dependence of the recoil mass on the transverse momenta of the negative pions, kaons, and antiprotons produced in pp-collisions at the energy $\overline{s} = 19;53$, and 200 GeV in the central rapidity region. For the sake of clarity, the values of M_X are presented on a log-scale with the multiplication factors 10 and 100 for K and p, respectively. All curves demonstrate sm all grow that low p_T followed by a successive attening. They reveal a characteristic increase with the collision energy and mass of the inclusive particle. The similar dependencies of M_X on p_T for other hadrons measured at the RHIC energy $\overline{s} = 200$ GeV are presented in Fig. 8 (b). The data correspond to the central interaction region. The dependence of M_X on p_T for J= ;D⁰;B, and -m eson production in pp-collisions at the Tevatron energies $\overline{s} = 1800$ and 1960 GeV is presented in Fig. 9(a).

We would like to draw attention to the large recoil mass for the J= -m eson production. It is approximately equal to the values of M_X for the -m esons with a small exception at low transverse momenta (p_T below 7 GeV/c). The mass increases with p_T and reaches the value of 95 GeV at p_T = 18 GeV/c. The curves for B - and D⁰-m esons lay considerably below. The extra large values of the recoil mass in the charm online production is connected with the abnormal small values of the corresponding momentum fractions y_a and y_b (see discussion to Fig. 6(b)). A comparison of the

m om entum dependence of M_x for J = -m eson at p = 200 and 1960 GeV is shown in Fig. 9(b). Here one can see the strong sensitivity of the recoil m ass to the collision energy p = 3. Its angular dependence at s = 200 GeV is rather weak. The approximate constancy of M_x at the angle $cm s = 22^0$ corresponds to the levelling of the fraction y_b with p_T shown in Fig. 7(a).

VI.DISCUSSION

A n analysis of ISR, RH IC, and Tevatron experimental data on inclusive cross sections for dierent hadron species performed in z-presentation shows the avor independence of the shape of the scaling function (z). This was demonstrated over a wide range of the kinematical variables for proton-proton and proton-antiproton collisions. A saturation of (z) was found in the region $z < 10^{-1}$ for hadrons with light and heavy quarks. The data on J=- and - meson production con m the saturation up to very small values of $z' = 10^{-3}$. The observed universality is a manifestation of the self-similarity of particle production at a constituent level. The dynamical behavior of the interacting system revealed in the distributions of the inclusive particles is described by the function

(z) which demonstrates attening in the experimentally achievable low z-region (Figs. 2 and 3). The slope (z) of the scaling function diminishes with the decreasing z and becomes zero when the scaling function attens out. It was found that for both asymptotic regimes, at low – and high-z, the interacting system is characterized by the equation

The obtained results give strong support that avor independence of (z) for variety of light and heavy hadrons and its behavior (20) at both asymptotic limits reject general trend of hadron production in the high energy proton-proton and proton-antiproton collisions over a wide range of transverse m om enta.

A.Variable z and entropy

In this part we discuss analogy between the parameters used in the z-scaling concept and some therm odynam ical quantities (entropy, speci cheat, chem ical potential) of a multiple particle system. There exists a connection between the variable z and entropy. The scaling variable is proportional to the ratio

of the transverse kinetic energy $p_{s_{2}}$ and the maximal value of the function

in the space of the momentum fractions. The quantity W is proportional to all parton and hadron con gurations of the colliding system which can contribute to the production of the inclusive particle with the momentum p. A coording to statistical physics, entropy of a system is given by a number of its statistical states as follows

The most likely microscopic conguration of the system is given by the maximal value of S. In our approach, the congurations comprise all mutually independent constituent subprocesses (2). The corresponding subprocesses which can contribute to the production of the inclusive particle with the 4-m omentum p are considered as subject to the condition (3). The underlying subprocesses, in terms of which the variable z is determined, is singled out from the corresponding subprocesses by the principle of maximal entropy S.

In therm odynam ics, entropy for an ideal gas is determ ined by the form ula

where c_V is a speci c heat and R is a universal constant. The temperature T and the volum e V characterize a state of the system . U sing (22) and (23), we can write the relation

Next we exploit analogy between (24) and (25). The analogy is supported by the plausible idea that interaction of the extended ob jects like hadrons and nuclei can be treated at high energies as a set of independent collisions of their constituents. Such concept justi es a division of the system into the part com prising the selected subprocess which underlies production of the inclusive particle and the rest of the system containing all remaining microscopic con gurations which lead to the produced multiplicity. The entropy (25) refers to the rest of the system . The multiplicity density dN $_{ch}$ =d $\frac{1}{2}$ of particles in the central interaction region characterizes a "tem perature" created in the system [36]. Provided that the system is in a local equilibrium, there exists a simple relation dN $_{\rm ch}$ =d j Т 3 for high tem peratures and sm all chem ical potentials. Using the mentioned analogy, the parameter c plays a role of a "speci c heat" of the produced matter. The second term in (25) depends on the volume of the rest of the system in the space of the momentum fractions $fx_1;x_2;y_a;y_bg$. The volume is a product of the complements of the fractions with the exponents which are generally fractional numbers, $V = l_1^{1} l_2^{2} l_3^{a} l_4^{b}$. This analogy emphasizes once more the interpretation of the parameters $_1$, $_2$, $_a$, and $_b$ as fractal dimensions. In accordance with common arguments, the entropy (25) increases with the multiplicity density and decreases with the increasing resolution 1 In the considered analogy, the principle of a minim al resolution ¹ with respect to all subprocesses satisfying the condition (3) is equivalent to the principle of a maxim alentropy S of the rest of the colliding system .

The entropy is determined up to an arbitrary constant $S_0 = \ln W_0$. D in ensional units entering the de nition of the entropy can be included within this constant. In particular, it allows us to account for a relation between the dimensionless multiplicity density $dN_{ch} = d_j$ and the temperature T. This degree of freedom is related to the transformation

In such a way the scaling variable and the scaling function are determined up to an arbitrary multiplicative constant. The constant W₀ is related to an absolute number of the microscopic states of the system. Its value is restricted by the positiveness of the entropy above some scale characterized by a maximal resolution ¹. For the resolution corresponding to the fractal limit, W₀ is in nity. Thus, the transformation (26) is connected with a renormalization of the fractal measure z in agreement with its physical interpretation (21). The renormalization represents a shift of the entropy by the corresponding constant,

B.Chem ical potential and phase space occupancy

Let us consider a system where the number of particles can change. A coording to the rst law of therm odynamics the internal energy U of such system can be expressed as follows

This shows how U depends on independent variations of the entropy S, volum e V, and num ber of particles (antiparticles) N_a ; (N_a). The parameters T and p are the tem perature and pressure of the system. The potentials $_a$ and $_a$ consist of two parts [37]

which are expressed via the chem ical potentials $_{a} = _{a}$ and the phase space occupancy $_{a} = _{a}$ of the system constituents. First one controls the net number of particles ($N_{a} = N_{a}$) arising from the particle and antiparticle di erence. Second term regulates the number of particle-antiparticle pairs ($N_{a} + N_{a}$). In statistical hadro-chem istry the factors are related to the relative and absolute chem ical equilibrium, respectively [37]. The chem ical potentials determ ine the statistical parameter $_{a}$ known as fugacity

which governs the yield of a corresponding particle type.

As shown in Sec. IV, the scaling functions of di erent hadrons coincide each other when applying the transform ation (17) with the appropriate values of $_{\rm F}$. The coe cient $_{\rm F}$ is ratio of the constants W $_0$ (27) for single hadrons. In principle, these properties can be used for estimation of the ratios of the corresponding phase space occupancy parameters $_{\rm a}$. In Boltzm ann approximation, the hadron yields are proportional to the chemical fugacities. If one assumes that at su ciently high energy the chemical potentials $_{\rm a}$ become negligible on the right-hand side of (29), then it is possible to write

The ratio describes the relative yields of hadron pairs with the avors F_1 and F_2 . Exploiting the connection between the temperature T and the multiplicity density $dN = d_j$ discussed after Eq. (25), we can rewrite the relation (29) into the form

Here g is a constant which does not depend on the particle type. Knowing the values of $_{\rm F}$ for di erent hadrons (they are quoted in Figs. 2 and 3 relative to mesons with = 1), one can obtain a hierarchy of the potentials $_{\rm F}$ for the individual hadron species. A system atic analysis of

 $_{\rm F}\,$ for m esons and baryons, its dependence on the m ass, avor content, and spin requires further, m ore detailed study.

C.z-Scaling and phase transitions

The self-sim ilarity of the particle form at ion at low transverse m om enta is a new speci c feature which can give inform ation on therm odynam ical characteristics of the colliding system and clarify its behavior. For su ciently low p T the scaling variable becom es resolution-independent function of the multiplicity density dN ch=d and the parameter c. Both quantities characterize medium produced in the high energy collisions. The multiplicity density of particles in the central interaction region can be connected with a "temperature" of the colliding system. The parameter c is interpreted as a "specic heat" of the produced medium. Its value c = 0.25 was found to be the same for di erent types of the inclusive hadrons. The estimated error is at the level of 10%. We expect that this parameter should change in consequence of a phase transition in the produced medium. The increase of the multiplicity (or energy) density should a ect the medium characteristics in that case. A possible violation of the z-scaling in the low-z region connected with a change of the "speci c heat" c m ight be considered as a manifestation of such phase transition. Measurements of the cross sections for hadrons with heavy quarks at higher energies allow to reach even lower values of z where the saturation of (z) could in principle change. We expect that such a change of the observed behavior of the scaling function could give indications on new physical e ects in this region.

There are quantities in therm odynam ics which are sensitive to phase transitions. A discontinuity of speci cheat, com pressibility factor and coe cient of therm alexpansion characterizes second order phase transition of the therm odynam ic system. The second derivative of the chem ical potential

is connected with a discontinuity of the speci c heat in such a case. The quantities c in (25) and $_{\rm F}$ in (32) signify a speci c heat and chem ical potential, respectively. Their potential dependence on multiplicity density can be studied from suitable experimental data. A discontinuity of cassociated with a jump in the second derivative of $_{\rm F}$, especially at high dN $_{\rm ch}$ =d j, could be considered as a signature of a second order phase transition in the medium produced in high energy hadron collisions.

It is usually assumed that bulk of the produced matter at low $-p_T$ (low -z) consists of multitude of the strongly interacting constituents. There is no direct information on the type of the constituents. Even at high collision energies \overline{s} , the single constituent processes at low transverse momenta are experimentally invisible. Only indirect signatures can reveal the nature of the constituents. We suggest to use the analogs of the therm odynam ical quantities such as the speci c heat and chem ical potentials which can be useful in the description of the produced matter. These quantities can be sensitive to phase transitions in the multiple particle system s.

A coording to the phase transition theory and theory of the critical phenom ena, an abrupt change in the speci c capacity, coe cient of therm al expansion and com pressibility with a sm all change in tem perature near to a critical point is typical for a second-order phase transition [38(40]. The second-order phase transitions have a discontinuity in the rst derivative of the entropy

In our case, such signature would correspond to a discontinuity or sharp grow th of the param eter c near some critical point z_c . One can speculate that the value of c should become dependent on the transverse momentum p_T and rise sharply enough with the multiplicity density at low p_T . It is usually considered that the increase of the multiplicity density is connected with a grow th of the energy density. Existence of the internal structure of the constituents would allow to store the energy into their internal degrees of freedom which is connected with a rise of the speci c heat. We consider therefore that study of the inclusive cross sections of hadron production in the low $-p_T$ region at high multiplicity densities $dN_{ch}=d$ and collision energies \overline{s} is most preferable in searching for signatures of phase transitions in hadron matter.

V II. C O N C LU S IO N S

Here we summarize the main results obtained in the paper. New properties of the z-scaling – the avor independence and the saturation of (z) at low z, were established. We have studied

the spectra of the inclusive particles produced in proton-proton and proton-antiproton collisions in z-presentation. The experimental data on inclusive cross sections of dierent hadrons obtained at ISR, RHIC, and Tevatron were used in the present analysis. The data cover a wide range of the collision energies $\overline{s} = 19$ 1960 GeV, the transverse momenta $p_T = 0.1$ 10 GeV/c, and the production angles $_{\rm cm \ s} = 3^0$ 90°. The variable z depends on the parameters , F, and c. The parameters and F characterize structure of the colliding (anti)protons and fragmentation process in the nalstate, respectively. Their values are xed by the energy, angular, and multiplicity independence of (z) in the high- p_T part of the spectra. The third parameter c is interpreted as "speci c heat" of the produced medium. The z-scaling is consistent with c = 0.25 and = 0.5 for all types of the analyzed inclusive hadrons. The value of F increases with the mass of the produced hadron. E stim ated errors of the determ ination of the parameters do not exceed 10%. It was found that the parameters are independent of kinem atical variables.

It was shown that renorm alization of the scaling variable z allows to reduce the scaling function of di erent hadrons to a single curve. The scaling function (z) was established to be avor independent in a vide range of z. It means that the shape of (z) is the same for di erent hadrons in this region. This includes hadrons with light and heavy quarks produced in high energy pp- and pp-collisions. A saturation regime of the function (z) was observed for z < 0:1. The approximate constancy of (z) was demonstrated up to z 10⁻³ for charmonia and bottom ia. We conclude that a violation of the asymptotic behavior of the scaling function in the region of low z could give inform ation on a phase transition of the produced matter. This should apply especially for the events with high multiplicity densities in both pp=pp- and AA-collisions at high energies.

A connection between the ingredients of the variable z allowing them odynam ical interpretation and the therm odynam ical quantities (entropy, tem perature, speci c heat, chem ical potential) characterizing multi-particle system s was discussed. The "speci c heat" c was suggested as a param eter useful for characterization of these system s near a phase transition point. A m icroscopic scenario of the constituent interactions in term s of the m om entum fractions was presented.

The universality of description of the spectra of di erent hadrons over a wide kinem atical region by the scaling function (z) re ects general features (sym metries) of the underlying physics phenom ena over a wide scale range. Both soft and hard regimes manifest self-sim ilarity of particle production at a level of hadron constituents. They are preferable to study collective processes and constituent substructure at low and high z, respectively.

The obtained results may be exploited to search for and study of new physics phenomena in particle production in the high energy proton-proton and proton-antiproton collisions at U $70, R \, H \, {\rm IC}$, Tevatron, and LHC.
