Correction to the Running of Gauge Couplings out of Extra Dim ensional Gravity

We study the gravitational correction to the gauge couplings in the extra dimension model where the gravity propagates in the (4+n)-dimensional bulk. We show by explicit calculation in the background eld method that the one-loop correction coming from graviton Kaluza-Klein states is nontrivial and tends to make the theory anti-asymptotically free. For the theory characterized with asymptotic freedom, the correction will induce a nontrivial UV-stable xed point. This may lead to an interesting possibility that the non-abelian gauge coupling constants g_2 and g_3 in the SM and that of the gravity g_1 unify at the xed point in the lim it of high energy scale.

General relativity is not renormalizable after quantization [1, 2]. This is one of the reasons that general relativity was considered to be incompatible to quantum mechanics. A modern point of view to the nonrenorm alizable theory is that it m ight be sensible and reliable predictions could still be made from it within the fram ework of e ective eld theories. From the value of the only dim ensional coupling constant G, New ton's constant, in Hilbert-Einstein Lagrangian, one can see that gravitational e ects are tiny at energies 10^{19} G eV= c^2 . It makes sense to treat general relativity as a low energy e ective eld theory of som e unknown fundam ental theory and consider its quantum e ects [3]. The e ects due to non-renormalizable terms are suppressed by inverse powers of M pl, the m ass scale of new physics.

The most promising candidate for such new physics is the string theory. A consistent string theory predicts a de nite number of extra dimensions. To make contact between string theory and our experienced four-dimensional spacetime, the most straightforward possibility is that the extra dimensions are compactified on an internal manifold whose size is su ciently small to escape being detected at present.

The eld theory with compactified extra dimensions is another example of the non-renormalizability different from the gravitation. When a renormalizable theory in four-dimensional spacetime is generalized to (4+n)-dimensions and reduced to the four-dimensional world, the elective lagrangian contains in nite Kaluza-Klein series, with every operator having mass dimension less than ve. Considering that the heavy Kaluza-Klein states are decoupled from the low energy physics of phenomenological interest, one can truncate the Kaluza-Klein tower at some energy scale. The truncated theory is renormalizable.

An interesting thing concerned with these two types of e ective theory is the quantum corrections to the gauge couplings. In [4], Robinson and Wilczek showed that gravitational corrections will cause gauge couplings to run quadratically. Although the elect is tiny in the regions where perturbative calculations are reliable, it's of theoretical interest on its own. Pietrykowski [5] redid the calculations and found that the result in [4] is gauge dependent. Up to one-loop order the gravitational contributions to the function are zero in the dimensional regularization (DR) scheme. Later on, Pietrykowski's result was veried by [6,7,8]. More recently, it was argued that the gravitational contribution to the function is nontrivial in a new regularization scheme [9].

The power law running exist in the theory of n extra dimensions. The one-loop correction to the gauge couplings from a tower of gauge boson Kaluza-Klein states is of order ⁿ [10]. It drives the theories to run fast so that the gauge coupling unication can be signicantly lowered to TeV scale in large extra dimension models.

In this work, we will calculate in DR scheme the oneloop correction to the gauge couplings from the extra dimensional gravity where the gravitons propagate in (4+ n) dim ensional spacetime while the gauge and matter elds live in the normal four dimensional world [11]. W e will show, by explicit calculations in the background eld method, that the one-loop correction coming from graviton Kaluza-Klein states is nontrivial. It is universal for all gauge couplings and tends to make the theory anti-asym ptotically free. Therefore for the theory characterized with asymptotic freedom, the correction will induce a nontrivial UV-stable xed point. This may lead to an interesting possibility that the non-abelian gauge coupling constants g_2 and g_3 in the SM and that of the gravity g unify at the xed point in the lim it of some high energy scale, if the numbers of the active Kaluza-K lein particles are properly selected.

W e start with the E instein-Yang-M ills theory. The extra dim ensions are compactied on a torus T $^{\rm n}$. The compactication scales of the extra n-dimensional spaces y_i are all assumed to be roughly equal to R, and they need not to be large extra dimensions in our present consider-

ation. The action of the theory has the form:

with 2 $\frac{16}{M_{\frac{p}{p_1(4+n)}}}$, and the relation $^2R^n = ^2$. The

symbols \hat{R} , $\hat{g}^{\hat{}}$ and M $_{pl(4+n)}$ are the R icci scalar, m etric tensor and P lanck m ass in (4+n) bulk. The index ^ extends over the full (4+n) dimensions and over the (3+1) dimensions. The gauge coupling g is included in the eld strength

where D is the spacetime covariant derivative operator. In the following we use the background eld method [12] and choose the background spacetime to be at. Since the theory respects Poincare invariance in at spacetime, the gauge coupling constant is universal everywhere and the following discussion is without ambiguity. As is well known, using the background eld method one is able to quantize a gauge eld theory without losing the explicit gauge invariance. In this framework, the

function of the gauge coupling constant can be calculated from the renormalization constant of the background gauge eld. This greatly simplifies the calculations, especially in the non-abelian and higher loop cases.

For later convenience, we illustrate the procedure for calculating the function of non-abelian gauge theories in curved spacetime. To renormalize the divergence, the bare and renormalized quantities are related by

where A^a are background gauge elds. Because explicit gauge invariance is retained, the gauge covariant form of the strength tensor in plies the relation

In DR scheme, we perform all loop momentum integrals in d=4 "dimensions. The bare coupling constants are not dimensionless. To use a dimensionless renormalized coupling constant, we introduce an arbitrary mass parameter and replace the Eq.(5) by

The renormalized constant g are functions of , while g_0 is independent of . By di erentiating both sides of Eq.(8), we not the function

The de nition of the function for gravity is the same as that of the gauge sector. It has the form

From Eqs.(7), (9) and (12) and taking the \lim it "! 0, one can nally have

where the rst term purely comes from the gauge and matter sector, and the second term results from the gravitational correction. It shows that the function can be determined from the coe cient of the 1=" term in the gauge eld two-point G reen's function.

Now we continue to calculate the correction to the two-point G reen's function of the gauge eld from n-extra dimensional gravity. Fields $\hat{g}_{\wedge \wedge}(x;y)$ and $A^a(x)$ can be written as sums of background elds $(^{\wedge_{\wedge}};A^a(x))$ and quantum uctuations $(\hat{h}_{\wedge \wedge};a^a(x))$:

To perform the Kaluza-Klein reduction to four-dimensional spacetime, we parameterize the eld \hat{h}_{n} as

To continue, one has to x gauges. Adding a special de Donder gauge xing term

for the graviton eld and the Lorentz gauge xing term $\frac{1}{2}$ (0 a^a) for the photon eld to the action, the propagators for the massive Kaluza-Klein states h^n , A_i^n , $_{ij}^n$ and the quantum gauge eld in momentum space are:

where $m_{_{R}}^{2}=\frac{4^{-2}n_{_{1}}n_{_{1}}}{R^{2}}$ is the mass of Kaluza-K lein graviton at n-th order excitations. O by iously the spin-2 state h^{n} is not a physical state. This can be seen explicitly from the numerator of its propagator. The physical massive spin-2 state with right polarization tensor is constructed from h^{n} , $A_{_{1}}^{n}$ and $_{_{1}j}^{n}$. However, the rearrangement of the physical spin-2, (n=1) spin-1, and n (n=1)=2 spin-0 states into h^{n} , $A_{_{1}}^{n}$ and $_{_{1}j}^{n}$ states shown above greatly simplies our calculations.




FIG.1: The one-loop gravitational correction to the two-point G reen's function of the gauge eld. The internal double, double wavy and double dashed lines represent the gravitons h^n , A^n_i and $^n_{ij}$ respectively. The internal zigzag lines represent the quantum gauge elds a^a . The external wavy lines are background gauge elds A^a .

Now we are going to calculate the one-loop gravitational correction in the DR scheme. In the present setup, we have the relevant interaction terms h^n a A , h^n h^m h^m h^n , h^n A_i^m A_j^n and h^n $_{ij}^m$ $_{k1}^n$ at order, and h^n $_h^m$ A A at 2 order. The Feynman diagrams are shown in Fig.1 up to 2 order. A tedious calculation shows that all of the rst three diagrams are zero, though they are not necessary vanished to all appearances because the Kaluza-K lein gravitons are massive.

The last two diagrams have nontrivial contribution to the function. By a straightforward calculation, it can be shown that the correction obtained in the fram ework of background eld method is independent of the gauge parameter , as it should be. The result of the diagram is

The contributions of the extra dimensions are embodied in the sum mation over the Kaluza-Klein states in a tower. In the lim it of four-dimensional spacetime, i.e. n=0, the second term is vanished because the graviton is massless.

As discussed in Refs. [6, 13], the <code>rst</code> term of Eq. (21) corresponds to a higher derivative operator <code>w</code> ith <code>m</code> as dimension six $\frac{1}{2}$ @ <code>F^a</code> @ <code>F^a</code> . It can generate a Lee-W ick gauge eld. The second term results from the sum <code>m</code> ation of the active <code>K</code> aluza-<code>K</code> lein states. It contributes to the one-loop—function of the gauge coupling

where b depends on the gauge and matter contents and is wholly independent of whether gravitation is included in the calculation. It comes from the rst term of Eq.(13). The second term in Eq.(22) is contributed by the exchange of graviton Kaluza-K lein states, and is universal for all gauge couplings since gravitons do not carry any gauge charge. It tends to make the theory antiasymptotically free.

In the theory where b is positive, such as QCD and the SU (2) gauge sector of the electroweak, there is a nontrivial ultraviolet-stable xed point at

In the $\lim_{n\to\infty} it$ of large m om entum, the coupling constant tends to q, and therefore runs along with.

The sum mation can be written as an integration in term of the mass m $_{\rm n}^2$ when the Kaluza-K lein states are near degenerate [14]

is the K aluza-K lein state density. As is well-known, using DR scheme, which is a mass-independent scheme, heavy states do not decouple. Thus we have introduced an explicit cuto to regularize the mass integration. That is, we include only a nite number of low-lying K aluza-K lein states whose masses are smaller than and assume all other states decouple from the low energy physics we are interested. This cuto does not break any gauge symmetry and our calculation is gauge independent. The near degenerate condition is satis ed when the energy scale R $^{\rm 1}$ characterized the rst K aluza-K lein excitations is much less than the physical scale .

In the literatures, there are two di erent scenarios for calculating the function from the Kaluza-K lein states, depending on how to treat the cuto scale and the evolution scale.

One is that the energy scales and are dierent, which in plies that, when $\,<\,$, the particles with mass larger than can contribute to the gauge coupling. This is the case for the QCD where the heavy quark avors are of signicance to the running of gauge coupling at low energy. In general, the cuto scale should be less than M $_{\rm pl(4+n)}$, since the elective theory is only expected to be valid below the fundamental scale M $_{\rm pl(4+n)}$. Unitarity requirement of some explicit extra dimensional models can play some stringent constraints on it [15].

The gauge coupling runs logarithm ically

The $(\frac{n}{2})^{-1}$ factor ensures that the gravitational correction is vanished in the lim it of four spacetime dimension, which is in agreement with the result in [5, 6, 7, 8].

An interesting possibility follows from the UV $\,$ xed point. When the Kaluza-Klein cuto $\,$ scales $\,$ 3 and $\,$ 1 = $\,$ 2 in the SM are elaborately set to

the non-abelian gauge coupling constants g_2 and g_3 and that of the gravity g unify at the UV-stable xed points $g_2=g_3=g$, where g is the dimensionless Newton constant, and $g^2^2=16$ [16]. If g_1 can evolve to the xed point at some high energy scale, the four coupling constants is unied.

The other scenario that the energy scales and are the same will lead to the power law running of the gauge coupling

It im plies that only the K aluza-K lein gravitons with mass less than make contributions to the running of the gauge couplings. Note that the one-loop correction to the gauge couplings from a tower of gauge boson K aluza-K lein states is of order $^{\rm n}$ [10]. Here we show explicitly that the correction coming from graviton K aluza-K lein states is of order (=M $_{\rm pl(4+\,n)}$)^{n+2}.
