# WIDTH OF SHAPE RESONANCES FOR NON GLOBALLY ANALYTIC POTENTIALS

#### Abstract

We consider the semiclassical Schrödinger operator with a well in an island potential, on which we assume smoothness only, except near infinity. We give the asymptotic expansion of the imaginary part of the shape resonance at the bottom of the well. This is a generalization of the result by Helffer and Sjöstrand HeSj1 in the globally analytic case. We use an almost analytic extension in order to continue the WKB solution coming from the well beyond the caustic set, and, for the justification of the accuracy of this approximation, we develop some refined microlocal arguments in $h$-dependent small regions.

## 1. Introduction

This paper is concerned with the quantum resonances of the semiclassical Schrödinger operator in $\mathbb{R}^{n}$,

$$
\begin{equation*}
P=-h^{2} \Delta+V(x) \tag{1.1}
\end{equation*}
$$

From the physical point of view, such resonances are associated to metastable states, that is, states with a finite life-time, and the life-time is given by the inverse of the absolute value of the imaginary part (width) of the corresponding resonance.
In the literature, many geometrical situations have been studied where the location of the resonances of $P$ has been determined up to errors of order $\mathcal{O}\left(h^{\infty}\right)$ : see, e.g., $\mathrm{BaMn}, \mathrm{BCD}, \mathrm{GeSj}$, HiSi, Sj22. In particular, when the approximated location is at a distance $\sim h^{N_{0}}$ of the real line with some fixed $N_{0}>0$, then such results automatically produce good estimates on the widths of such resonances, too. However, in the physically most interesting situations where the resonances are exponentially close to the real axis, only very few results give a lower bound on the width. To our knowledge, and apart from the one-dimensional case (see, e.g., Ha, FeLa), the only available results are $\overline{\mathrm{Bu}}, \overline{\mathrm{HeSj} 1}$. In $\overline{\mathrm{Bu}}$, a very nice and general estimate is obtained, independently of the geometrical situation presented by the potential $V$. In particular, because of its wide generality, such a result does not give any precise asymptotic of the width. On the contrary, the result of HeSj 1 gives a full asymptotic of the width when the (globally analytic) potential $V$ presents the geometric situation of a well in an island, at the origin of the creation of the so-called shape resonances.

The purpose of this article is to extend the results of HeSj1 to smooth potentials that are not assumed to be globally analytic, but only near infinity (allowing the definition of resonances by analytic distorsion). In that case, we obtain a classical expansion of the first resonance $\rho$ just as in the globally analytic case of HeSj 1 .

Roughly speaking, a quantum resonance is a complex energie $\rho$ for which the Schrödinger equation

$$
P u=\rho u
$$

admits a non-trivial solution called resonant state, which is outgoing for large $x$ (see $\S 2$ for a rigorous definition by analytic distorsion). In the case of shape resonances, the resonant state describes a quantum particle, concentrated in the well for a long period, but then escaping to the sea (classically allowed region outside the island) by tunneling effect. This effect is reflected by the width of the resonance $\rho$.

More precisely, let $\Gamma$ be the set of points on the boundary of the island $\ddot{\mathcal{O}}$ where the Agmon distance from the bottom of the well $x_{0}$ reaches its minimum $S$. In the semiclassical regime, it happens that almost all the tunneling occurs along a small neighborhood of the geodesic curves from $x_{0}$ to $\Gamma$. Then, the width of the resonance $\rho$ is determined by the amplitude of
$u$ near $\Gamma$, and the result is,

$$
\operatorname{Im} \rho(h) \sim-h^{\frac{1-n_{\Gamma}}{2}}\left(\sum_{j \geq 0} h^{j} f_{j}\right) e^{-2 S / h} \quad \bmod \mathcal{O}\left(h^{\infty}\right) e^{-2 S / h}
$$

where $n_{\Gamma}$ is some geometrical constant, and $f_{0}>0$ (see Theorem 2.3).
In order to prove this result for non globally analytic potentials, we mainly follow the strategy of HeSj1], with some additional technical difficulties that we explain now.

Let $W$ be a bounded domain and $(\cdot, \cdot)_{W},\|\cdot\|_{W}$ the scalar product and the norm in $L^{2}(W)$. Then, $\operatorname{Im} \rho$ can be represented in terms of the corresponding resonant state $u$ on $W$, by applying Green's formula to the identity $((P-$ $\rho) u, u)_{W}=0$. This leads to,

$$
\begin{equation*}
\operatorname{Im} \rho=-\frac{h^{2}}{\|u\|_{W}^{2}} \operatorname{Im} \int_{\partial W} \frac{\partial u}{\partial n} \bar{u} d S \tag{1.2}
\end{equation*}
$$

where $\partial / \partial n$ denote the exterior normal derivative on $\partial W$. The point is that if we take for $W$ a small neighborhood of $\ddot{O}$, then the contribution from the integral of the RHS of (1.2) is concentrated near $\Gamma$, and the problem is mainly reduced to the study of the asymptotic behavior of $u$ near $\Gamma$.

In the globally analytic case studied by Helffer and Sjöstrand in HeSj1, the first step in order to obtain this asymptotic behavior consisted in extending to the complex domain the WKB solutions coming from the well, in such a way that one could go round the caustic set (see HeSj1 Proposition 10.9). In our case, such an analytic extension is no longer possible but, by means of almost-analytic extensions, it is still possible to go round the caustic set on the condition of staying close enough to the real domain, namely, at a distance $\mathcal{O}\left(\left(h \ln h^{-1}\right)^{2 / 3}\right)$ of the caustic set. In this way, one can recover an (outgoing) WKB expression out of the island, but still at a distance of order $\left(h \ln h^{-1}\right)^{2 / 3}$ from the boundary (see Proposition 4.6).
The next step in the proof of HeSj1 was to use an argument of microlocal analytic propagation that, thanks to a suitable a priori estimate, permitted to compare the solution $u$ with the previous WKB constructions near $\Gamma$. In our case, the analogous a priori estimate can be obtained only at a distance $\mathcal{O}\left(\left(h \ln h^{-1}\right)^{2 / 3}\right)$ of $\Gamma$ (see Proposition 5.2). For this reason, the usual results of propagation do not apply, and we need to refine them in order to be able to work in $h$-dependent open sets (see Lemma 6.4). Then, after a suitable change of scale, and still using almost-analytic extensions, the comparison between $u$ and the WKB constructions is obtained up to a distance of order $\left(h \ln h^{-1}\right)^{2 / 3}$ of $\Gamma$ (see Proposition 6.8, and Proposition 6.1).

The final step in HeSj1 consisted in replacing $u$ by its WKB approximation into (1.2) (with $W$ a fixed small enough neighborhood of $\ddot{0}$ ), and in using a stationary phase argument in order to obtain the asymptotic of $\operatorname{Im} \rho$. In our case, a similar argument can be used with $W=\left\{d(x, \ddot{O})<|h \ln h|^{2 / 3}\right\}$, but this makes appear terms in $h^{j}(\ln h)^{k}$ in the integrand of the right-hand side of (1.2). However, by slightly changing the choice of $W$, and by observing that the left-hand side of (1.2) does not depend on this choice, we can prove
that, indeed, the final expansion does not contain terms in $(\ln h)^{k}, k \neq 0$ (see (7.2) and Lemma 7.3).

Summing up, the method consists in the three following parts:
(1) Extension of the WKB solution constructed at the bottom of the well $x_{0}$ up to a neighborhood of $\Gamma$.
(2) Estimate on the difference between the WKB solution $w$ and the resonant state $u$.
(3) Computation of the asymptotics of the integral (1.2) using $w$ instead of $u$.

Point 1 is performed by solving transport equations along the minimal geodesics, and then, by using an Airy integral representation of the solution near $\Gamma$. In order to recover a WKB asymptotic expansion outside $\ddot{O}$, almost-analytic extensions (or, more precisely, holomorphic approximations) are used as well as a stationary-phase expansion at a distance of order $|h \ln h|^{2 / 3}$ from $\Gamma$.

Point 2 is obtained by using three propagation arguments. At first, a standard $C^{\infty}$-propagation, exploiting the fact that $u$ is outgoing, gives a microlocal information on $u$ in the incoming region up to a small distance of $\Gamma$. Then, a refined $C^{\infty}$ propagation result permits to extend this microlocal information up to a distance of order $|h \ln h|^{2 / 3}$ of $\Gamma$. Finally, performing a change of scale both in the variables and in the semiclassical parameter, an analytic-type propagation argument gives the required estimate in a full neighborhood of $\Gamma$ of size $|h \ln h|^{2 / 3}$.
For Point 3, we take $W=\left\{d(x, \ddot{O})<|h \ln h|^{2 / 3}\right\}$ and we use Green's formula as we explained before. Then, by a deformation argument, we show that the final expansion does not contain terms in $\ln h$, and actually coincides with the expansion obtained in HeSj1.

The article is organized as follows: In $\S 2$, we assume conditions on the potential $V$ and state the main results. In $\S 3$, we prove Theorem [2.2, especially the global a priori estimate (2.7) of $u$. $\S 4$ is devoted to the above point 1 , and $\S 5, \S 6$ and $\S 7$ are devoted to the point 2 . In $\S 8$, we study the point 3 , and prove the main Theorem 2.3
We also refer to [LFM] for a shorter version of some aspects of this work.

## 2. Assumptions and Main Results

Let us state precisely the assumptions on the potential.
(A1) $V \in C^{\infty}$ is real-valued and there exists some compact set $K_{0} \subset \mathbb{R}^{n}$ such that $V$ is analytic on $K_{0}^{C}=\mathbb{R}^{n} \backslash K_{0}$ and can be extended as a holomorphic function on a sector

$$
D_{0}=\left\{x \in \mathbb{C}^{n} ;|\operatorname{Im} x|<\sigma_{0}|\operatorname{Re} x|, \operatorname{Re} x \in K_{0}^{C}\right\}
$$

for some constant $\sigma_{0}>0$. Moreover, there exists $\sigma_{1}>0$ such that

$$
|V(x)|=\mathcal{O}\left(|x|^{-\sigma_{1}}\right) \quad \text { as } \quad|\operatorname{Re} x| \rightarrow \infty, \quad x \in D
$$

This assumption enables us to define resonances near the real axis as complex eigenvalues of the distorted operator $P_{\theta}$ of $P$. Let $F(x) \in C^{\infty}\left(\mathbb{R}^{n}, \mathbb{R}^{n}\right)$ such that $F(x)=0$ on the compact set $K_{0}, F(x)=x$ for large enough $|x|$, and $|F(x)| \leq|x|$ everywhere. For small $\nu>0$, we define a unitary operator on $L^{2}\left(\mathbb{R}^{n}\right)$ by

$$
\begin{equation*}
U_{\nu} \phi(x)=\operatorname{det}(1+\nu d F(x))^{-1 / 2} \phi(x+\nu F(x)) . \tag{2.1}
\end{equation*}
$$

The conjugate operator $\tilde{P}_{\nu}=U_{\nu} P U_{-\nu}$ is analytic with respect to $\nu$ and we can define the distorted operator by $P_{\theta}=\tilde{P}_{i \theta}$ for positive small $\theta$. Then the essential spectrum is given by $\sigma_{\text {ess }}\left(P_{\theta}\right)=e^{-2 i \theta} \mathbb{R}_{+}$(Weyl's perturbation theorem) and the spectrum $\sigma\left(P_{\theta}\right)$ in the sector $S_{\theta}=\{E \in \mathbb{C} ;-2 \theta<\arg E<0\}$ is discrete (see $\overline{\mathrm{Hu}}$ ). The elements of $\sigma\left(P_{\theta}\right) \cap S_{\theta}$ are called resonances. This definition is independent of $\theta$ in the sense that $\sigma\left(P_{\theta^{\prime}}\right) \cap S_{\theta}=\sigma\left(P_{\theta}\right) \cap S_{\theta}$ if $\theta^{\prime}>\theta$, and also of the function $F(x)$. Moreover, if $u_{\theta}$ is an eigenfunction of $P_{\theta}$, it can be proved (see, e.g., HeMa ) that there exists $u \in C^{\infty}\left(\mathbb{R}^{n}\right)$, holomorphic in $D_{0}$, such that $u_{\theta}=U_{i \theta} u$. Such functions $u$ are called resonant states of $P$.
The next assumption describes the shape of $V(x)$ in the island:
(A2) There exist a bounded open domain $\ddot{O}$ with smooth boundary, a point $x_{0}$ in $\ddot{O}$ and a positive number $E_{0}$ such that

$$
V\left(x_{0}\right)=E_{0}, \quad \frac{\partial V}{\partial x}\left(x_{0}\right)=0, \quad \frac{\partial^{2} V}{\partial x^{2}}\left(x_{0}\right)>0
$$

and

$$
V(x)>E_{0} \quad \text { in } \quad \ddot{O} \backslash\left\{x_{0}\right\}, \quad V(x)=E_{0} \quad \text { on } \quad \partial \ddot{O}
$$

To the well $\left\{x_{0}\right\}$ of the potential, we can associate a Dirichlet problem. Let us denote by $d(x, y)$ the Agmon distance associated with the pseudo-metric $d s^{2}=\max (V(x), 0) d x^{2}, S=d\left(x_{0}, \partial \ddot{0}\right)$ the minimal distance from $x_{0}$ to the boundary of $\ddot{\mathcal{O}}$, and $B_{d}\left(x_{0}, S\right):=\left\{x ; d\left(x, x_{0}\right)<S\right\}$ the open ball centered at $x_{0}$ of radius $S$ with respect to the distance $d$. We consider a Dirichlet realization $P_{D}$ of the operator $P$ on the domain $\overline{B_{d}\left(x_{0}, S-\eta\right)}$ for sufficiently small $\eta$. The following result is due to Helffer and Sjöstrand HeSj2 (see also Simon [Si] for a partial version):
Theorem 2.1. (Helffer-Sjöstrand) Let $\lambda_{D}(h)$ be the first eigenvalue of $P_{D}$ and $u_{D}(x, h)$ the corresponding normalized eigenfunction. Then $\lambda_{D}(h)$ has a complete classical asymptotic expansion with respect to $h$ :

$$
\lambda_{D}(h)=E_{0}+E_{1} h+E_{2} h^{2}+\cdots,
$$

where $E_{1}=\operatorname{tr} \sqrt{\frac{1}{2} \frac{\partial^{2} V}{\partial x^{2}}\left(x_{0}\right)}$ is the first eigenvalue of the corresponding harmonic oscillator $-\Delta+\frac{1}{2}\left\langle\frac{\partial^{2} V}{\partial x^{2}}\left(x_{0}\right) x, x\right\rangle$. Moreover, in a neighborhood $\omega$ of $x_{0}, u_{D}(x, h)$ can be written in the WKB form:

$$
\begin{equation*}
u_{D}(x, h)=h^{-n / 4} a(x, h) e^{-d\left(x_{0}, x\right) / h} \tag{2.2}
\end{equation*}
$$

where $a$ is a realization of a classical symbol:

$$
\begin{equation*}
a(x, h) \sim \sum_{j=0}^{\infty} a_{j}(x) h^{j}, \quad a_{0}(0)>0 \tag{2.3}
\end{equation*}
$$

In the sea $\ddot{O}^{C}$, on the other hand, we assume the non-trapping condition on the energy surface $p^{-1}\left(E_{0}\right)=\left\{(x, \xi) ; p(x, \xi)=E_{0}\right\}$ :
(A3) For any $(x, \xi) \in p^{-1}\left(E_{0}\right)$ with $x \in \ddot{\mathcal{O}}^{C}$, the quantity $\left|\exp t H_{p}(x, \xi)\right|$ tends to infinity as $|t|$ tends to $\infty$.
Here $H_{p}$ is the Hamilton vector field

$$
H_{p}=\frac{\partial p}{\partial \xi} \cdot \frac{\partial}{\partial x}-\frac{\partial p}{\partial x} \cdot \frac{\partial}{\partial \xi}=2 \xi \cdot \frac{\partial}{\partial x}-\frac{\partial V}{\partial x} \cdot \frac{\partial}{\partial \xi} .
$$

If $x \in \partial \ddot{\theta}$, in particular, the only $\xi \in \mathbb{R}^{n}$ such that $p(x, \xi)=E_{0}$ is 0 , and $H_{p}=-\nabla V(x) \cdot \frac{\partial}{\partial \xi}$. Hence (A3) also implies,

$$
\begin{equation*}
\nabla V(x) \neq 0 \quad \text { on } \quad \partial \ddot{0} . \tag{2.4}
\end{equation*}
$$

Under the conditions (A1), (A2), (A3), we have the following theorem (it is an analog to our situation of a result due to Heffer and Sjöstrand in the globally analytic case):

Theorem 2.2. Assume (A1)-(A3). Then, there exists a unique resonance $\rho(h)$ of $P$ such that $h^{-1}\left|\rho(h)-\lambda_{D}(h)\right| \rightarrow 0$ as $h \rightarrow 0_{+}$, and it verifies,

$$
\begin{equation*}
\left|\lambda_{D}(h)-\rho(h)\right|=\mathcal{O}\left(e^{-(2 S-\epsilon(\eta)) / h}\right) . \tag{2.5}
\end{equation*}
$$

Moreover, denoting by $u(x, h)$ the corresponding (conveniently normalized) resonant state, one has,

$$
\begin{equation*}
\left|u_{D}(x, h)-u(x, h)\right|=\mathcal{O}\left(e^{-\left(2 S-d\left(x_{0}, x\right)-\epsilon(\eta)\right) / h}\right), \tag{2.6}
\end{equation*}
$$

uniformly in $\overline{B_{d}\left(x_{0}, S-\eta\right)}$, where $\epsilon(\eta) \rightarrow 0$ as $\eta \rightarrow 0$, and, for any $K \subset \mathbb{R}^{n}$ compact, there exists $N_{K} \in \mathbb{N}$ such that,

$$
\begin{equation*}
\left\|e^{s(x) / h} u(x, h)\right\|_{H^{1}(K)}=\mathcal{O}\left(h^{-N_{K}}\right), \tag{2.7}
\end{equation*}
$$

uniformly as $h \rightarrow 0$, where $s(x)=d\left(x_{0}, x\right)$ if $x \in B_{d}\left(x_{0}, S\right)$ and $s(x)=S$ otherwise.
Finally we assume some conditions on the set $\partial \ddot{\mathcal{O}} \cap \overline{B_{d}\left(x_{0}, S\right)}$ and on the caustic set $\mathcal{C}=\overline{\left\{x \in \ddot{O} ; d\left(x_{0}, x\right)=d(x, \partial \ddot{\mathcal{O}})+S\right\}}$.
The points of the set $\partial \ddot{O} \cap \overline{B_{d}\left(x_{0}, S\right)}$ are called points of type 1 in HeSj1]. Since they mainly concentrate the interactions between the well and the sea, here we prefer to call them points of interaction.
Our additional assumption is,
(A4) $\partial \ddot{O} \cap \overline{B_{d}\left(x_{0}, S\right)}$ is a submanifold $\Gamma$ of $\partial \ddot{\theta}$, and $\mathcal{C}$ has a contact of order exactly 2 with $\partial \ddot{\theta}$ along $\Gamma$.
We denote by $n_{\Gamma}$ ( $\leq n-1$ ) the dimension of $\Gamma$. Then, our main result is,
Theorem 2.3. Under Assumptions (A1)-(A4), there exists a classical symbol

$$
f(h) \sim \sum_{j \geq 0} h^{j} f_{j},
$$

with $f_{0}>0$, such that

$$
\operatorname{Im} \rho(h)=-h^{\frac{1-n_{\Gamma}}{2}} f(h) e^{-2 S / h}
$$

Remark 2.4. In the globally analytic case, it has been shown in HeSj1 that $f(h)$ is an analytic classical symbol. In the general case, however, such a property is no longer satisfied.

Remark 2.5. Our arguments can also be applied to resonances of $P$ with a larger real part, and give, as in HeSj1 Theorem 10.14, an upper bound on their width when the corresponding eigenvalue of $P_{D}$ is asymptotically simple.

## 3. Proof of Theorem 2.2

Proceeding as in CMR and Ma2, we consider the distorded operator $P_{\theta}$ with $\theta=h \ln (1 / h)$, constructed with the unitary operator $U_{\nu}$ as in (2.1), and with $F(x)=0$ on some arbitrary large compact set $K \subset \mathbb{R}^{n}$, that we can assume to contain $\ddot{O}$. Moreover, following the same idea as in HeSj1 Section 9 , we also consider the corresponding operator $\tilde{P}_{\theta}$ where the well has been filled-up, that is,

$$
\tilde{P}_{\theta}=P_{\theta}+W(x)
$$

where $W \in C_{0}^{\infty}(\ddot{O}), W\left(x_{0}\right)>0, W \geq 0$ everywhere, $\operatorname{Supp} W$ arbitrarily small around $x_{0}$ (in particular, the Hamilton flow of $p+W$ has no trapped trajectories with energy $E_{0}$ ).
Then, proceeding as in CMR] Section 7 (or Ma2] Section 4), one can construct a function $\psi_{0} \in C_{0}^{\infty}\left(\mathbb{R}^{2 n} \backslash \operatorname{Supp} W\right)$ such that,

$$
\begin{equation*}
-\operatorname{Im} \tilde{p}_{\theta}\left(x-t \partial_{x} \psi_{0}-i t \partial_{\xi} \psi_{0}, \xi-t \partial_{\xi} \psi_{0}+i t \partial_{x} \psi_{0}\right) \geq \frac{1}{C_{0}} h \ln (1 / h) \tag{3.1}
\end{equation*}
$$

for some constant $C_{0}>0$ large enough, where $t:=2 C_{0} \theta, \tilde{p}_{\theta}$ is the semiclassical principal symbol of $\tilde{P}_{\theta}$, and the inequality holds for $(x, \xi)$ such that $\left|\operatorname{Re} \tilde{p}_{\theta}(x, \xi)-E_{0}\right| \leq\langle\xi\rangle^{2} / C_{0}$.
In particular, by CMR Proposition 7.2, we easily obtain,

$$
\begin{equation*}
\left\|e^{t \psi_{0} / h} T v\right\|_{L^{2}\left(\mathbb{R}^{2 n}\right)}=\mathcal{O}\left(|h \ln h|^{-1}\right)\left\|e^{t \psi_{0} / h} T\left(\tilde{P}_{\theta}-z\right) v\right\|_{L^{2}\left(\mathbb{R}^{2 n}\right)} \tag{3.2}
\end{equation*}
$$

uniformly for $h>0$ small enough, $v \in L^{2}\left(\mathbb{R}^{n}\right)$, and $\left|z-E_{0}\right| \ll h \ln (1 / h)$. Here $T=T_{1}$ is the so-called FBI-Bargmann transform defined by (8.5). This means that the norm of $\left(\tilde{P}_{\theta}-z\right)^{-1}$ is uniformly $\mathcal{O}\left(|h \ln h|^{-1}\right)$ when we consider $\tilde{P}_{\theta}$ as acting on the space $H_{t}:=L^{2}\left(\mathbb{R}^{n}\right)$ endowed with the norm,

$$
\begin{equation*}
\|v\|_{t}:=\left\|e^{t \psi_{0} / h} T v\right\|_{L^{2}\left(\mathbb{R}^{2 n}\right)} \tag{3.3}
\end{equation*}
$$

From this point, one can proceed exactly as in HeSj1, Proof of Proposition 9.6 (that is, by considering a Grushin problem for $P_{\theta}$, the inverse of which is obtained by using the corresponding Grushin problem for $P_{D}$, and by using Agmon-type estimates inside the island $\ddot{O})$, and, working with $u_{\theta}:=U_{i \theta} u(=$ $u$ on $K$ ), one concludes (2.5). (Indeed, this proof never uses the analyticity of $V$, but just the fact that one has a good enough control on the resolvent of the "filled-up well"-operator.)
Similarly, (2.6) is obtained as in the proof of HeSj1 Theorem 9.9, mainly by considering the spectral projector of $P_{\theta}$ as in HeSj1 Formula (9.37) (in that case, $u$ must be normalized, e.g., by requiring that $\left\|u_{\theta}\right\|_{t}=1$ ).

Moreover, the same arguments also show that,

\left\|e^{t \psi_{0} / h} T u_{\theta}\right\|_{L^{2}\left(\left(\mathbb{R}^{n} \backslash B_{d}\left(x_{0}, S-\eta\right)\right) \times \mathbb{R}^{n}\right)}=\mathcal{O}\left(e^{-(S-\epsilon(\eta)) / h}\right),
$$

and thus, also,

\left\|u_{\theta}\right\|_{L^{2}\left(\mathbb{R}^{n} \backslash B_{d}\left(x_{0}, S-\eta\right)\right)}=\mathcal{O}\left(e^{-\left(S-\epsilon^{\prime}(\eta)\right) / h}\right)
$$

As a consequence, up to some constant factor of the type $1+\mathcal{O}\left(e^{-\delta / h}\right)$ ( $\delta>0$ ), the normalization of $u$ does not depend on the particular choices of $K, F$, and $\psi_{0}$.
Now, we come to the proof of (2.7).
Let $\chi_{1} \in C_{0}^{\infty}\left(B_{d}\left(x_{0}, S-\eta\right)\right)$, such that $\chi_{1}=1$ in $B_{d}\left(x_{0}, S-2 \eta\right)(\eta>0$ fixed arbitrarily small), and let $\chi_{2} \in C_{0}^{\infty}\left(B_{d}\left(x_{0}, \frac{1}{2}(S+\eta)\right)\right.$, such that $\chi_{2}=1$ in $B_{d}\left(x_{0}, \frac{1}{2}(S-\eta)\right)$. Setting,

R_{\theta}(z):=\chi_{1}\left(P_{D}-z\right)^{-1} \chi_{2}+\left(\tilde{P}_{\theta}-z\right)^{-1}\left(1-\chi_{2}\right), \tag{3.4}
\end{equation*}

one has (see HeSj1 Formula (9.39)),

\end{equation*}
$$

with,

\begin{aligned}
K_{\theta}(z): & =\left[P_{\theta}, \chi_{1}\right]\left(P_{D}-z\right)^{-1} \chi_{2}-W\left(\tilde{P}_{\theta}-z\right)^{-1}\left(1-\chi_{2}\right) \\
& =\left[-h^{2} \Delta, \chi_{1}\right]\left(P_{D}-z\right)^{-1} \chi_{2}-W\left(\tilde{P}_{\theta}-z\right)^{-1}\left(1-\chi_{2}\right) .
\end{aligned}
$$

Now, if $W$ is taken in such a way that $\operatorname{Supp} W \subset B_{d}\left(x_{0}, \eta\right)$, then, as in HeSj1 (in particular the proof of Lemma 9.4), Agmon estimates show that,

uniformly with respect to $h>0$ small enough and $z \in \gamma$, and where $\varepsilon(\eta) \rightarrow$ 0 as $\eta \rightarrow 0_{+}$(here, $K_{\theta}$ is considered as an operator acting on $H_{t}$ ). In particular, we deduce from (3.5),

uniformly for $z \in \gamma$ and $h>0$ small enough.
Now, we consider the Dirichlet realization $P_{h}$ of $P$ on the $h$-dependent domain,

We denote by $\lambda_{h}$ its first eigenvalue, and by $v_{h}$ the corresponding normalized eigenstate. We also denote by $d_{h}$ the Agmon distance on $M_{h}$, associated with the pseudo-metric $\left(V-\lambda_{h}\right)_{+} d x^{2}$ (so that, in particular, $d_{h}$ depends on $h$, too), and we set,

At first, with $\chi_{1}$ as before, we observe that $\left(P_{h}-\lambda_{D}\right) \chi_{1} u_{D}=\left(P_{D}-\right.$ $\left.\lambda_{D}\right) \chi_{1} u_{D}=\mathcal{O}\left(h^{\infty}\right)$, and thus, by the Min-max principle (and since $V \geq E_{0}$ on $M_{h}$ ), we have $E_{0} \leq \lambda_{h} \leq \lambda_{D}+\mathcal{O}\left(h^{\infty}\right)$ (in particular, $\lambda_{h}=E_{0}+\mathcal{O}(h)$ ). Moreover, since $x_{0}$ is the only point of $M_{h}$ where $V$ reaches its (nondegenerate) minimum $E_{0}$, and since $V-E_{0} \geq \delta k^{2 / 3} \gg h$ near $\partial M_{h}$, standard techniques (see, e.g., HeSj2, Si]) show that, actually, $\lambda_{h}=\lambda_{D}+\mathcal{O}\left(h^{\infty}\right)$, and the gap between $\lambda_{h}$ and the second eigenvalue of $P_{h}$ behaves like $h$.
Since $V-\lambda_{h} \leq V-E_{0}$, we also have,

where $\Gamma_{x}$ stands for the set of $C^{1}$ curves $\gamma:[0,1] \rightarrow U_{h}^{+}$with $\gamma(0) \in U_{h}^{-}$ and $\gamma(1)=x$. Moreover, since $\lambda_{h}=E_{0}+E_{1} h+\mathcal{O}\left(h^{2}\right)>E_{0}$, Assumptions (A2)-(A3) imply that $\nabla V \neq 0$ on $\left\{V=\lambda_{h}\right\}$ for $h>0$ small enough. Then, if $\varphi_{h}(x)<S_{h}:=d_{h}\left(x_{0}, \ddot{\mathcal{O}}\right)$, standard arguments of Riemannian geometry (exploiting the fact that, in that case, $\dot{\gamma}(t)$ remains colinear to $\nabla \varphi_{h}(\gamma(t))$ for any minimal geodesic $\gamma$ : see, e.g., Mi, HeSj2, and Ma3] Section 3) show that, for $V(x)>\lambda_{h}, \varphi_{h}(x)$ is reached at some minimal geodesic $\gamma$ that can be re-parametrized in such a way that the map $t \mapsto\left(\gamma(t), \frac{1}{2} \dot{\gamma}(t)\right)$ becomes a nul-bicharacteristic of $q_{h}(x, \xi):=\xi^{2}-\left(V(x)-\lambda_{h}\right)$. In particular, such a $\gamma$ verifies $|\dot{\gamma}(t)|=2 \sqrt{V(\gamma(t))-\lambda_{h}}$, and thus, we obtain,

where $T_{x}=T_{x}(h)>0$ represents the time employed to go from $U_{h}^{-}$to $x$ in the new parametrization. Writing $\lambda_{h}=E_{0}+h \mu_{h}$, where $\mu_{h}=E_{1}+\mathcal{O}(h)$, this gives,

& \geq \int_{\gamma} \sqrt{V(y)-E_{0}} d|y|-2 T_{x} h \mu_{h} \\
& \geq d\left(U_{h}^{-}, x\right)-2 T_{x} h \mu_{h} . \tag{3.9}
\end{align*}
$$

Moreover, since, for $x$ close to $x_{0}$, we have $d\left(x_{0}, x\right)=\mathcal{O}\left(\left|x-x_{0}\right|^{2}\right)$, we see that $d\left(U_{h}^{-}, x_{0}\right)=\mathcal{O}(h)$, and thus, by the triangular inequality, $d\left(x_{0}, x\right) \leq$
$d\left(U_{h}^{-}, x\right)+C h$ for some constant $C>0$. Combining with (3.9), we obtain,

still for $x$ verifying $\varphi_{h}(x)<S_{h}$. Thus, in that case, it remains only to prove that $T_{x}=\mathcal{O}\left(\ln \frac{1}{h}\right)$. To do so, we set $(x(t), \xi(t)):=\left(\gamma(t), \frac{1}{2} \dot{\gamma}(t)\right)=$ $\exp t H_{q}\left(x_{h}, 0\right)$, where $H_{q}(x, \xi):=(2 \xi, \nabla V(x))$ is the Hamilton field of $q_{h}$, and $x_{h}:=\gamma(0) \in U_{h}^{-}$. If $\varepsilon>0$ is any arbitrarily small fixed number, we see that $H_{q}(x, \xi)$ remains outside some fixed neighborhood of 0 on $\{(x, \xi) ; \mid x-$ $\left.x_{0} \mid \geq \varepsilon, q_{h}(x, \xi)=0\right\}$. As a consequence, if $\left|x-x_{0}\right| \geq \varepsilon$, the time employed by $\gamma$ to go from $x$ to the set $\left\{y ;\left|y-x_{0}\right|=\varepsilon\right\}$ is bounded, uniformly with respect to $h$. Therefore, it remains to estimate the time $\tilde{T}$ employed by $\gamma$ to go from $\gamma(0) \in U_{h}^{-}$to $\left\{y ;\left|y-x_{0}\right|=\varepsilon\right\}$. Since we stay in an arbitrarily small neighborhood of $x_{0}$, we can assume $x(t) \cdot \nabla V(x(t)) \geq 4 \delta^{2}|x(t)|^{2}$ for $t \in[0, \tilde{T}]$ and with some $\delta>0$ constant. Then, setting $f(t):=x(t) \cdot \xi(t) /|x(t)|^{2}$, we compute,

In particular, $\left(f(t)-\delta_{1}\right)^{-1}$ remains bounded on any finite interval $\left[t_{1}, T_{1}\right]$ where $f(t)>\delta_{1}$, and this means that $f(t)$ cannot take the value $\delta_{1}$ on $\left[t_{1}, \tilde{T}\right]$. Thus, in this case, $f(t)$ necessarily remains $\geq \delta$ on $\left[t_{1}, \tilde{T}\right]$. Summing up, we have proved,

and thus, on $[0, \tilde{T}]$,

with $\delta^{\prime \prime}=\delta^{\prime} e^{-C_{2}}, C_{2}:=\int_{0}^{+\infty} \frac{2 \delta d s}{1+e^{8 \delta s}}$. Since $\delta^{\prime \prime} \sqrt{h} e^{2 \delta t}=\varepsilon$ when $t=$ $(2 \delta)^{-1} \ln \left(\varepsilon / \delta^{\prime \prime} \sqrt{h}\right)$, we deduce from (3.12) that, necessarily, one has $\tilde{T} \leq$ $(2 \delta)^{-1} \ln \left(\varepsilon / \delta^{\prime \prime} \sqrt{h}\right)$, and, by (3.10), it follows that,

for $x$ verifying $\varphi_{h}(x)<S_{h}$, and some constant $C_{1}^{\prime}>0$, independent of $x$. On the other hand, $\varphi_{h}(x)$ reaches $S_{h}$ at some point $x_{h}$ verifying $V\left(x_{h}\right)=$ $\lambda_{0}=E_{0}+\mathcal{O}(h)$ (and $x_{h}$ away from some fix neighborhood of $x_{0}$ ), and thus $\operatorname{dist}\left(x_{h}, \ddot{\mathcal{O}}\right)=\mathcal{O}(h)$. As a consequence, $d\left(x_{h}, \ddot{\mathcal{O}}\right)=\mathcal{O}(h)$, too, and thus, $d\left(x_{0}, x_{h}\right) \geq S-C h$ for some constant $C>0$. Therefore, by continuity, (3.13) also proves that $S_{h} \geq S-C_{1} k$ with $C_{1}=C_{1}^{\prime}+C$, and it follows that (3.13) is still valid if $\varphi_{h}(x) \geq S_{h}$ (since, by definition, $s(x) \leq S$ everywhere).

Lemma 3.2. There exists a constant $N_{0} \geq 0$, such that,

\varphi_{h}(x)-C h \ln C \text { if } \varphi_{h}(x) \leq C h,
\end{array}\right.
$$

where $C \geq 1$ is some constant that will be fixed large enough later on. Then, we use the following identity (that is at the origin of Agmon estimates: see, e.g., HeSj2 Theorem 1.1),

Now, if $C$ is taken large enough, by (3.8) we see that $M_{h} \cap\left\{\varphi_{h}(x) \geq C h\right\} \subset$ $\left\{V \geq \lambda_{h}\right\}$. Moreover, on this set we have,

Writing again $\lambda_{h}=E_{0}+\mu_{h} h$ with $\mu_{h}=E_{1}+\mathcal{O}(h)$, and using again (3.8) and the fact that $d\left(x_{0}, x\right) \leq C_{0}\left(V(x)-E_{0}\right.$ near $x_{0}$ (for some $C_{0}>0$ constant), we deduce,

on $M_{h} \cap\left\{\varphi_{h}(x) \geq C h\right\}$, and thus, taking $C$ large enough,

on the same set. Inserting this estimate into (3.14), and using that the left-hand side is 0 , we obtain,

and thus, since $\phi \leq C h(1-\ln C) \leq 0$ on $\left\{\varphi_{h} \leq C h\right\}$, we conclude,

Then, observing that $e^{\phi / h} \geq(h / M)^{C} e^{\varphi_{h} / h}$ with $M:=\sup \varphi_{h}=\mathcal{O}(1)$, the result follows.
Now, let $\chi_{h} \in C_{0}^{\infty}\left(M_{h}\right)$, such that $\chi_{h}=1$ on $\left\{x \in \ddot{O} ; \operatorname{dist}(x, \partial \ddot{\partial}) \geq 2 k^{2 / 3}\right\}$ and, for all $\alpha, \partial^{\alpha} \chi_{h}=\mathcal{O}\left(k^{-2|\alpha| / 3}\right)$ (such a $\chi_{h}$ exists because $\partial \ddot{O}$ is a hypersurface of $\mathbb{R}^{n}$ ). In particular, $\chi_{h} v_{h}$ is in the domain of $P_{\theta}$, and one has,

Lemma 3.3. There exists a constant $N_{1} \geq 0$, such that,

uniformly for $h>0$ small enough.
Proof. Setting $w_{h}:=\chi_{h} v_{h}$, we have,
$P_{\theta} w_{h}=P_{h} w_{h}=\lambda_{h} w_{h}+\left[P, \chi_{h}\right] v_{h}=\lambda_{h} w_{h}-2 h^{2}\left(\nabla \chi_{h}\right)\left(\nabla v_{h}\right)-h^{2}\left(\Delta \chi_{h}\right) v_{h}$.
Moreover, on the support of $\nabla \chi_{h}$, we have $\operatorname{dist}(x, \partial \ddot{于}) \leq 2 k^{2 / 3}$, and thus, by standard properties of the Agmon distance near $\partial \mathcal{O}$ (see, e.g., below Lemma 4.1, and HeSj1] Section 10), we see that $s(x) \geq S-C k$ for some constant $C>0$. Therefore, by Lemma 3.1, we also have $\varphi_{h}(x) \geq S-C^{\prime} k$ $\left(C^{\prime}=C+C_{0}\right)$, and by Lemma 3.2, we deduce from (3.15),

\left\|\left(P_{\theta}-\lambda_{h}\right) w_{h}\right\|_{L^{2}}=\mathcal{O}\left(h^{-N} e^{-S / h}\right)

with some constant $N \geq 0$. As a consequence, since $\psi_{0}$ is bounded and $T$ is an isometry, $r_{h}:=\left(P_{\theta}-\lambda_{h}\right) w_{h}$ verifies,

\left\|r_{h}\right\|_{t}=\left\|h^{-2 C_{0} \psi_{0}} T r_{h}\right\|=\mathcal{O}\left(h^{-M}\right)\left\|r_{h}\right\|_{L^{2}}=\mathcal{O}\left(h^{-M^{\prime}} e^{-S / h}\right) \tag{3.16}

with $M, M^{\prime}>0$ constant. Then, writing,

& =\frac{1}{2 i \pi} \int_{\gamma} \frac{1}{z-\lambda_{h}}\left(z-P_{\theta}\right)^{-1} r_{h} d z \tag{3.17}
\end{align*}
$$

and using (3.7) and (3.16), the result immediately follows.
Using the equation $\left(P_{h}-\lambda_{h}\right) v_{h}=0$ and the ellipticity (in the standard sense) of $P_{h}$, it is not difficult to deduce from (3.16) and Lemma 3.2, that, for all $\ell \geq 0$, there exists $M_{\ell} \geq 0$ such that,

for all $\ell \geq 0$ and some $N_{\ell} \geq 0$ constant. Then, using the ellipticity of $P_{\theta}$ and the fact that, for all $u,\|u\|_{L^{2}}=\|T u\|_{L^{2}}=\mathcal{O}\left(h^{-M}\|u\|_{t}\right)$, we deduce from (3.19),

It also follows from Lemmas 3.2 and 3.3, that,

## 4. Extension of the WKB Solution

Let $x^{1} \in \Gamma$. In this section, we will extend to a neighborhood of $x^{1}$ the WKB solution,

that approximates both the eigenfunction $u_{D}(x, h)$ of $P_{D}$ near $x_{0}$ (see (2.2)) and the resonant state $u(x, h)$ (Theorem 2.2).
4.1. Extension up to the Caustic Set. The extension in the island will be done along the geodesic with respect to the Agmon distance from $x_{0}$ to $x^{1}$.
Let $q(x, \xi)=\xi^{2}-V(x)$ and $H_{q}=2 \xi \cdot \partial / \partial x+\partial_{x} V(x) \cdot \partial / \partial \xi$ its Hamilton vector field. Then, one can see as in HeSj1 that the integral curve $\tilde{\gamma}(t)=$ $(\tilde{x}(t), \tilde{\xi}(t))$ of $H_{q}$ starting at $(\tilde{x}(0), \tilde{\xi}(0))=\left(x^{1}, 0\right)$ verifies,

(x(-\infty), \xi(-\infty))=\left(x_{0}, 0\right)
$$

Moreover, its projection on the $x$-space is the unique minimal geodesic between $x_{0}$ and $x^{1}$ staying in $\ddot{O} \cup\left\{x^{1}\right\}$ (see HeSj1 Section 10 and HeSj2). If $\phi(x):=d\left(x_{0}, x\right)-S$, we learn from HeSj2 that $\phi$ is $C^{\infty}$ in a neighborhood $\Omega$ of $\tilde{x}([-\infty, 0))$, and the Lagrangian manifold,

\Lambda=\{(x, \nabla \phi(x)) ; x \in \Omega\}
$$

is the outgoing stable manifold of dimension $n$ associated to the fixed point $\left(x_{0}, 0\right)$ of $H_{q}$.

In particular, $\Lambda$ is $H_{q}$-invariant and contains $\tilde{\gamma}([-\infty, 0))$. Moreover, since $H_{q}$ does not vanish at $\tilde{\gamma}(0)=\left(x^{1}, 0\right)$ by (A3), $\Lambda$ can be extended by the flow of $H_{q}$ to a larger Lagrangian manifold (that we still denote by $\Lambda$ ) that contains $\tilde{\gamma}([-\infty, 0])$. The natural projection $\Pi: \Lambda \rightarrow \mathbb{R}_{x}^{n}$ is singular at $\tilde{\gamma}(0)$, and, as shown in HeSj1 Lemma 10.1, the kernel of $d \Pi\left(x^{1}, 0\right)$ is a one-dimensional vector space generated by $H_{q}\left(x^{1}, 0\right)$.
Let us choose Euclidian coordinates $x$ centered at $x^{1}$ such that $T_{x^{1}}(\partial \ddot{0})$ is given by $x_{n}=0$, and $\partial / \partial x_{n}$ is the exterior normal of $\ddot{\mathcal{O}}$ at this point. Then by Assumption (A3),

where $C_{0}>0$ is a constant and $W(x)=\mathcal{O}\left(|x|^{2}\right)$. In a neighborhood of the point $\tilde{\gamma}(0)$, the Lagrangian manifold $\Lambda$ is defined by a real-valued $C^{\infty}$ function $g\left(x^{\prime}, \xi_{n}\right)$ with $g(0)=0, d g(0)=0$, that is,

Moreover, there exist real-valued smooth functions $\xi_{n}^{c}\left(x^{\prime}\right), a\left(x^{\prime}\right), b\left(x^{\prime}\right)$ and $\nu_{0}\left(x^{\prime}, \xi_{n}\right), \nu_{1}\left(x^{\prime}, \xi_{n}\right)$, such that,

& \nu_{0}=\nu_{1}+\mathcal{O}\left(\left|\xi_{n}-\xi_{n}^{c}\left(x^{\prime}\right)\right|\right)=\frac{1}{C_{0}}+\mathcal{O}\left(\left|x^{\prime}\right|+\left|\xi_{n}\right|\right) ;  \tag{4.5}\\
& g\left(x^{\prime}, \xi_{n}\right)=a\left(x^{\prime}\right)+b\left(x^{\prime}\right)\left(\xi_{n}-\xi_{n}^{c}\left(x^{\prime}\right)\right)+\frac{1}{3} \nu_{0}\left(x^{\prime}, \xi_{n}\right)\left(\xi_{n}-\xi_{n}^{c}\left(x^{\prime}\right)\right)^{3} ;  \tag{4.6}\\
& \frac{\partial g}{\partial \xi_{n}}\left(x^{\prime}, \xi_{n}\right)=b\left(x^{\prime}\right)+\nu_{1}\left(x^{\prime}, \xi_{n}\right)\left(\xi_{n}-\xi_{n}^{c}\left(x^{\prime}\right)\right)^{2} . \tag{4.7}
\end{align*}

All these properties are proved in HeSj1 (pages 136-148) and do not require the analyticity of the potential.
Then, near $\left(x^{1}, 0\right)$, the caustic set $\mathcal{C}$ (that, by definition, is the set where $\phi$ fails to be smooth, and thus, the set of $x$ for which the roots $\xi_{n}(x)$ of the equation $x_{n}=-\partial_{\xi_{n}} g\left(x^{\prime}, \xi_{n}\right)$ are not smooth) is given by,

It is shown in HeSj1 Lemma 10.2, that there exists a positive constant $C$ such that

(The proof of (4.8) does not use the analyticity, but rather the fact that, since $\left.V\right|_{\mathfrak{e}} \geq 0$, one has $\left|\nabla\left(\left.V\right|_{\mathfrak{e}}\right)\right|=\mathcal{O}\left(\sqrt{\left.V\right|_{\mathfrak{e}}}\right)$.
This estimate together with the assumptions (A3) and (A4) mean that $\phi(x) \mid \mathbb{e}$ is non-negative and quadratic along $\Gamma$, with $\left.\phi\right|_{\Gamma}=0$.
Let $\tilde{\Omega}$ be a small neighborhood of $\gamma([-\infty, 0])$ and let

Then the phase function $-d\left(x_{0}, x\right)=-\phi(x)-S$ of (4.1) is a $C^{\infty}$ function defined in $\tilde{\Omega}_{-}$. The symbol $a(x, h)$ can also be extended to $\tilde{\Omega}_{-}$by solving successively for $a_{j}(x)$ in (2.3) the transport equations (that are first-order
ordinary differential equations along the integral curves of $H_{q}$ ), and by resumming the series $\sum_{j \leq 0} h^{j} a_{j}$.
More generally, the previous arguments also permit us to extend $w$ in the open set defined as the union of all smooth minimal geodesics included in $\ddot{O}$ and starting from $x_{0}$. We denote this set by $\boldsymbol{\Omega}$.
4.2. Extension Beyond the Caustic Set. In order to extend the WKB solution $w$ beyond the caustic set, we follow the idea of HeSj1] and represent $h^{n / 4} e^{S / h} w$ in the integral form,

For $x$ in $\tilde{\Omega}_{-}$close to $x^{1}$, the phase function $x_{n} \xi_{n}+g\left(x^{\prime}, \xi_{n}\right)$ has two real critical points (see (4.7)). The steepest descent method at one of these points gives us the asymptotic expansion of $I[c]$. Comparing this with the symbol $a$, we can determine $c\left(x^{\prime}, \xi_{n} ; h\right)$ so that the asymptotic expansion of $e^{S / h} w$ coincides with that of $I[c]$ in $\tilde{\Omega}_{-}$.
Hence, in order to determine a possible asymptotic expansion of $e^{S / h} w$ in $\tilde{\Omega}_{+}$, it is enough to compute it for $I[c]$.
If $g$ was analytic with respect to $\xi_{n}$, we would find two complex critical points for $x \in \tilde{\Omega}_{+}$, one of them corresponding to an outgoing solution (i.e. resonant state). In our $C^{\infty}$ case, however, $g$ is only defined for real $\xi_{n}$. So we will extend $g\left(x^{\prime}, \cdot\right)$ almost-analytically (see Appendix for the definition) to a ( $h$-dependent) small complex neighborhood of $\xi_{n}=0$. Then, we will apply the steepest descent method for $x \in \tilde{\Omega}_{+}$sufficiently close to $x^{1}$ so that the imaginary part of the critical point $\xi_{n}$ remains sufficiently small.
In the following, we carry out the above procedure in several steps.
4.2.1. Integral Representation in $\tilde{\Omega}_{-}$. We first determine the $C^{\infty}$ classical symbol $c\left(x^{\prime}, \xi_{n}, h\right) \sim \sum_{j=0}^{\infty} c_{j}\left(x^{\prime}, \xi_{n}\right) h^{j}$ and the integration contour $\gamma(x)$ for $x \in \tilde{\Omega}_{-}$.
Let $x^{3}$ be in $\tilde{\Omega}_{-}$close to $x^{1}$ and $\tilde{U}$ a small neighborhood of $x^{3}$. The critical points of the phase function $x_{n} \xi_{n}+g\left(x^{\prime}, \xi_{n}\right)$ are the zeros of the function $x_{n}+\frac{\partial g}{\partial \xi_{n}}\left(x^{\prime}, \xi_{n}\right)$. From (4.7), we see that for $x \in \tilde{U}$, there are two real critical points $\xi_{n}^{+}(x), \xi_{n}^{-}(x)$, and they verify,

as $\left|x_{n}+b\left(x^{\prime}\right)\right| \rightarrow 0$. We define a sufficiently small real open interval $\gamma(x)$ so that it contains $\xi_{n}^{+}(x)$ inside as the only non-degenerate minimal point of $x_{n} \xi_{n}+g\left(x^{\prime}, \xi_{n}\right)$. The minimal value is

Moreover, the map that associates a sequence of functions $\left\{b_{j}(x)\right\}_{j=0}^{\infty}$ on $\tilde{U}$ to a sequence of functions $\left\{c_{j}\left(x^{\prime}, \xi_{n}\right)\right\}_{j=0}^{\infty}$ on $U=\left\{\left(x^{\prime}, \xi_{n}^{+}(x)\right) ; x \in \tilde{U}\right\}$ is bijective, and we define the function $c\left(x^{\prime}, \xi_{n}, h\right)$ as a realization of the inverse image of $\left\{a_{j}(x)\right\}_{j=0}^{\infty}$ by this map. In particular,

4.2.2. Extension of $c\left(x^{\prime}, \xi_{n}, h\right)$ to a Neighborhood of $\left(x^{\prime}, \xi_{n}\right)=(0,0)$. The symbol $c\left(x^{\prime}, \xi_{n} ; h\right)$, previously defined in $U$, formally verifies,

(4.13) leads us to transport equations, which are also differential equations along the integral curves of $H_{q}$ on $\Lambda$. The flows emanating from $U$ covers a full neighborhood of $\left(x^{\prime}, \xi_{n}\right)=(0,0)$, and thus we have extended $c$ there.
4.2.3. Critical Points and the Extension of $\phi$. Let $N \geq 1, k=h \ln \frac{1}{h}$, and let $\tilde{\nu}_{0}$ be a holomorphic $(N k)^{1 / 3}$-approximation of $\nu_{0}$ with respect to $\xi_{n}$ (in the sense of Lemma 8.1), where $\nu_{0}$ is the function appearing in (4.6). Then, setting,

where, actually, $\tilde{\nu}_{1}\left(x^{\prime}, \xi_{n}\right)$ is a holomorphic $(N k)^{1 / 3}$-approximations in the $\xi_{n}$-variable of $\nu_{1}\left(x^{\prime}, \xi_{n}\right)$.
We set,

If $x \in \Omega\left(0, c_{1}(N k)^{2 / 3}\right)$, then by Lemma 4.1, $\left|\operatorname{Im} \xi_{n}^{-i}(x)\right| \leq(N k)^{1 / 3}$. We modify the integration contour $\gamma(x)$ in (4.10) within this complex strip so that it remains to be a steepest descent curve passing by $\xi_{n}^{-i}(x)$ for $x \in$ $\Omega\left(0, c_{1}(N k)^{2 / 3}\right)$. A careful observation of the real part of the phase as in HeSj1 gives the following lemma:

Lemma 4.2. Let $\delta>0$ be small enough. Then, for $x \in \Omega\left(-\delta, c_{1}(N k)^{2 / 3}\right)$, there exists a piecewise smooth curve $\gamma_{N}(x, h)$ in a small complex neighborhood of $\xi_{n}=\xi_{n}^{c}\left(x^{\prime}\right)$ satisfying the following properties:
(i): $\gamma_{N}(x, h)$ is included in a band $\left\{\xi_{n} \in \mathbb{C} ;\left|\operatorname{Im} \xi_{n}\right| \leq(N k)^{1 / 3}\right\}$ and the extremities are independent of $x$ (i.e. fixed when $h$ is fixed).
(ii): If $x \in \Omega(-\delta, 0), \gamma_{N}(x, h)$ contains $\xi_{n}^{+}(x)$, and along $\gamma_{N}(x, h)$, one has,
$\operatorname{Re}\left(x_{n} \xi_{n}+\tilde{g}\left(x^{\prime}, \xi_{n}\right)\right)-\phi(x) \geq \delta_{1}\left(\left|x_{n}+b\left(x^{\prime}\right)\right|^{\frac{1}{2}}+\left|\xi_{n}-\xi_{n}^{+}(x)\right|\right)\left|\xi_{n}-\xi_{n}^{+}(x)\right|^{2}$ for some constant $\delta_{1}>0$. Moreover, $\left|\xi_{n}-\xi_{n}^{+}(x)\right| \geq \delta_{1}(N k)^{1 / 3}$ at the extremities of $\gamma_{N}(x, h)$.
(iii): If $x \in \Omega\left(0, c_{1}(N k)^{2 / 3}\right), \gamma_{N}(x, h)$ contains $\xi_{n}^{-i}(x)$, and along the contour $\gamma_{N}(x, h)$, one has,

Now, we also define a holomorphic $(N k)^{1 / 3}$-approximation $\tilde{c}\left(x^{\prime}, \cdot ; h\right)$ of the $\operatorname{symbol} c\left(x^{\prime}, \cdot ; h\right)$ by writing $c \sim \sum_{j \geq 0} h^{j} c_{j}$, by taking a holomorphic $(N k)^{1 / 3}$ approximation $\tilde{c}_{j}$ of $c_{j}$, and by re-summing the formal symbol $\sum_{j \geq 0} h^{j} \tilde{c}_{j}$ (note that here, each $\tilde{c}_{j}$ depends on $h$, but in a very well-controlled way). With these $\tilde{c}\left(x^{\prime}, \cdot ; h\right)$ and $\gamma_{N}(x, h)$, we define the modified integral representation of $e^{S / h} w$ by the formula,

Then, modifying continuously $\gamma(x)$ into $\gamma_{N}(x, h)$ in $J_{N}(x)$, we recover $\tilde{I}_{N}[\tilde{c}](x, h)$ up to error terms coming from the fact that $\gamma(x)$ and $\gamma_{N}(x, h)$ do not have the same extremities. However, in view of Lemma 4.2 (ii) and the fact that, along $\gamma(x)$, the minimum of $\operatorname{Re}\left(x_{n} \xi_{n}+\tilde{g}\left(x^{\prime}, \xi_{n}\right)\right)-\phi(x)$ is non-degenerate, we see that the deformation can be done in such a way that these error terms are $\mathcal{O}\left(e^{-\left(\phi(x)+\delta_{2} N k\right) / h}\right)=\mathcal{O}\left(h^{\delta_{2} N} e^{-\phi(x) / h}\right)$, with $\delta_{2}=$ $\delta_{1}^{4}$.

F(x, \hat{\zeta}, h) \sim \sum_{\ell \geq 0} F_{\ell}(x, \hat{\zeta}) h^{\ell},
$$

with $F_{\ell}$ holomorphic with respect to $\hat{\zeta}$ in a fixed neighborhood of 0 , and $F_{0}(x, 0)=\tilde{c}_{0}\left(x^{\prime}, \xi_{n}^{-i}(x)\right)$. Actually, $F_{\ell}$ also depends on $N$, but using Lemma
8.1 (ii) and the fact that $|\tilde{r}(x)| \sim(N k)^{1 / 3}$, we easily obtain that the derivatives of $F_{\ell}$ verify,

for some constants $\delta_{4}, \delta_{5}>0$. As a consequence, using again that $|\tilde{r}(x)| \sim$ $(N k)^{1 / 3}$ and writing $F=\sum_{\ell=0}^{L} F_{\ell} h^{\ell}+\mathcal{O}\left(h^{L+1}\right)$, we obtain,

with some new positive constant $\delta_{6}$.
At this point, we can proceed with the usual Laplace method in order to estimate each term of the previous sum. Writing,

&\left.\quad+R_{L, M, N}^{(1)}(x)\right)
\end{align*} \begin{array}{r}
\frac{e^{-\tilde{\phi}(x) / h}}{\sqrt{h \tilde{r}(x)}}\left(\sum_{\ell=0}^{L} \sum_{m=0}^{M} F_{\ell, m}(x) h^{\ell} \int_{-\infty}^{+\infty} e^{-y^{2} / h}\left(\frac{y}{\tilde{r}^{3 / 2}}\right)^{m} d y\right. \\
\left.\quad+R_{L, M, N}^{(1)}(x)+R_{L, M, N}^{(2)}(x)\right) \\
=\frac{e^{-\tilde{\phi}(x) / h}}{\sqrt{h \tilde{r}(x)}}\left(\sum_{\ell=0}^{L} \sum_{m=0}^{[M / 2]} \Gamma\left(m+\frac{1}{2}\right) F_{\ell, 2 m}(x) \frac{h^{m+\ell+\frac{1}{2}}}{\tilde{r}^{3 m}}\right. \\
\\
\left.\quad+R_{L, M, N}^{(1)}(x)+R_{L, M, N}^{(2)}(x)\right), \tag{4.35}
\end{array}
$$

$$
\begin{aligned}
& \left|R_{L, M, N}^{(1)}(x)\right| \leq C_{N} h^{\delta_{6} N}+C_{L} h^{L+1}+C_{L}^{M+1}(h / N k)^{M / 2} M^{M / 2} \\
& \left|R_{L, M, N}^{(2)}(x)\right| \leq C_{N} h^{\delta_{6} N} \sum_{m=0}^{M} C_{L}^{m+1}(h / N k)^{m / 2} m^{m / 2}
\end{aligned}

for some positive constant $\delta_{6}$ independent of ( $L, M, N$ ), some positive constant $C_{N}$ independent of $(L, M)$, and some positive constant $C_{L}$ independent
of $(M, N)$. Similar estimates hold true for all the derivatives with respect to $x$ of $R_{L, M, N}^{(1)}$ and $R_{L, M, N}^{(2)}$.
Hence, we obtain (4.29) if we set,

Finally, substituting $M=2\left[N k / C_{L}^{\prime} h\right]$ into (4.30) with $\alpha=0$, (4.32) follows by taking $C_{L}^{\prime}>4 C_{L, 0}^{2}$, since in that case, we have,

4.3. Global WKB Solution near $\partial \ddot{O}$. The previous study shows that, for any point $x^{1}$ of $\Gamma$ and for any $N \geq 1$, the WKB solution $w=h^{-n / 4} e^{-S / h} I[c]$ can be extended in a neighborhood of $x^{1}$ of the form,

where $\omega\left(x_{1}\right)$ is a fixed small enough neighborhood of $x^{1}$ in the caustic set $\mathcal{C}$, and $f$ is such that $f=0$ is an equation of $\mathcal{C}$ near $x^{1}$, with $\{f>0\} \cap \ddot{\vartheta}^{C} \neq \emptyset$. Therefore, by using a standard partition of unity in a neighborhood $\omega(\Gamma)$ of $\Gamma$ in $\mathcal{C}$, we obtain an extension $w_{N}$ of $w$ in an open set of the form,

Moreover, by Assumption (A4) and (4.8) (see also HeSj1 Remarque 10.4), we see that, if $x \in \mathcal{C}$ is such that $\operatorname{dist}(\Gamma, x) \sim(N k)^{1 / 2}$, then $\operatorname{Re} \tilde{\phi}(x) \sim N k$, and thus $w_{N}(x)=\mathcal{O}\left(h^{-n / 4} e^{-(S+\operatorname{Re} \tilde{\phi}) / h}\right)=\mathcal{O}\left(h^{\delta N} e^{-S / h}\right)$ for some constant $\delta>0$. We also observe that, on $\mathcal{C}$, we have $d\left(x_{0}, x\right)-S=\operatorname{Re} \tilde{\phi}(x) \sim$ $\operatorname{dist}(\Gamma, x)^{2}$. As a consequence (thanks to (4.26)), if we set,

\end{aligned}

Then $\boldsymbol{\Omega}\left(\varepsilon, t_{0}\right)$ is an open set, and the previous discussion shows that $w_{N}$ is well defined and $C^{\infty}$ on $\boldsymbol{\Omega}\left(2 N k,(N k)^{2 / 3}\right)$,

Moreover, by construction, it satisfies $(P-\rho) w_{N}=\mathcal{O}\left(h^{\delta N} e^{-(S+\operatorname{Re} \tilde{\phi}) / h}\right)$ on $\boldsymbol{\Omega}\left(2 N k,(N k)^{2 / 3}\right)$, for some constant $\delta>0$.
As a consequence, if we take a cut-off function $\chi_{N}$ such that $\operatorname{Supp} \chi_{N} \subset$ $\boldsymbol{\Omega}\left(2 N k,(N k)^{2 / 3}\right), \chi_{N}=1$ on $\boldsymbol{\Omega}\left(N k, \frac{1}{2}(N k)^{2 / 3}\right), \partial^{\alpha} \chi_{N}=\mathcal{O}\left(k^{-N_{\alpha}}\right)$ (for some $N_{\alpha} \geq 0$ and all $\alpha \in \mathbb{N}^{n}$ ), then, setting,

we see that $\tilde{w}_{N}$ is $C^{\infty}$ on $\left\{\operatorname{dist}(x, \ddot{O})<\delta_{0}(N k)^{2 / 3}\right\}$ for some fixed $\delta_{0}>0$, and it verifies,

Summing up (and slightly changing the notations by writing $w_{N}$ instead of $\tilde{w}_{2^{3 / 2} N / \delta_{0}^{3 / 2}}$, we have proved,
Proposition 4.6. For any large enough $N$, there exists a smooth function $w_{N}(x, h) \in C^{\infty}\left(\ddot{\mathcal{O}}_{N}\right)$, with $\ddot{\mathcal{O}}_{N}:=\left\{\operatorname{dist}(x, \ddot{\mathcal{O}})<2(N k)^{2 / 3}\right\}$, verifying the following properties:
(i): There exists a constant $\delta>0$, independent of $N$, such that uniformly in $\ddot{\mathcal{O}}_{N}$, and for all $\alpha \in \mathbb{Z}_{+}^{n}$, one has,

for some $m_{\alpha} \geq 0$, and where $\tilde{\phi}$ is defined by $\tilde{\phi}(x)=d\left(x_{0}, x\right)-S$ for $x \in \boldsymbol{\Omega}$, by (4.16) for $x \in \omega^{+}\left(2 N k,(N k)^{2 / 3}\right)$;
(ii): In any compact subset of $\boldsymbol{\Omega}$, for any $M \in \mathbb{N}$, one has,

(iii): In $\left\{(N k)^{2 / 3}<\operatorname{dist}(x, \ddot{\mathcal{O}})<2(N k)^{2 / 3}\right\}$, for any large enough $L$, there exist $C_{L}^{\prime}>0$ and $\delta_{L}>0$ independent of $N$ such that

## 5. Comparison in the Island

In this section, we compare the WKB solution $w_{N}$ with the true resonant state $u$ inside $\ddot{O}$ near a point of interaction $x^{1}$. More precisely, we obtain an estimate on the difference up to a distance of order $(N k)^{2 / 3}$ of $x^{1}$.
We use the same notations as in Section 4. Let $x \in \tilde{\Omega}_{-}$be a point sufficiently close to $x^{1}$. Using the representation formula (4.11) for $\phi$ (see also HeSj1] Formula (10.22)), we see that,

\phi(x) \geq \phi\left(x^{\prime},-b\left(x^{\prime}\right)\right)+\left(x_{n}+b\left(x^{\prime}\right)\right) \xi_{n}^{c}\left(x^{\prime}\right)-C_{1}\left|x_{n}+b\left(x^{\prime}\right)\right|^{3 / 2} \tag{5.1}
\end{equation*}
$$

for some positive constant $C_{1}$. Moreover, thanks to Assumption (A4), we already know that $\phi\left(x^{\prime},-b\left(x^{\prime}\right)\right)=\phi \mid$ e $\left(x^{\prime},-b\left(x^{\prime}\right)\right) \geq \delta\left|x^{\prime}\right|^{2}$ with $\delta>0$ constant, and thus, using (4.4), we see that $\phi\left(x^{\prime},-b\left(x^{\prime}\right)\right)+\left(x_{n}+b\left(x^{\prime}\right)\right) \xi_{n}^{c}\left(x^{\prime}\right) \geq 0$ near $x^{1}$. As a consequence, we deduce from (5.1),

In particular, if $x \in \Omega\left(-(N k)^{2 / 3}, 0\right), k=h \log \frac{1}{h}$, we have,

The aim of this section is to show a local a priori estimate near a point of interaction $x^{1}$ (Proposition 5.1), and after then, as a direct consequence, a global a priori estimate in a neighborhood of $\partial \ddot{0}$ (Proposition 5.2).

Proposition 5.1. There exists $N_{2} \in \mathbb{Z}$ and $C>0$, such that, for any $N>0$, one has,

Proof. Recall (Theorem 2.2) that there exists $N_{0}$ such that

The WKB solution $w_{C N}$ also satifies the same estimate (see Proposition 4.6), and hence so does the difference,

$$

for some other constant $N_{0}^{\prime}$.
Now, we set,

\Omega_{1}=\Omega_{1}(h):=B_{d}\left(x_{0}, S-k\right)
$$

Since every point of $\Omega_{1}$ can be connected to $x_{0}$ by a smooth minimal geodesic (with respect to the Agmon distance), the arguments of the previous section show that the WKB solution $w_{C N}(x, h)$ is well defined in all of $\Omega_{1}$ (we use its integral representation when $x$ becomes too close to a point of interaction). Moreover, it is not difficult to construct $\chi_{h} \in C_{0}^{\infty}\left(\Omega_{1}\right)$, such that $\chi_{h}=1$ on $\left\{d\left(x_{0}, x\right) \leq S-2 k\right\}, 0 \leq \chi_{h} \leq 1$ everywhere, and, for all $\alpha \in \mathbb{N}^{n}$,

\partial^{\alpha} \chi_{h}=\mathcal{O}\left(h^{-N_{\alpha}}\right)
$$

for some constant $N_{\alpha} \geq 0$. Then, we set,

\hat{w}:=\chi_{h}(x) w_{C N}(x, h),
$$

and, for $N \geq 1$ arbitrarily large,

\phi_{N}(x)=\min \left(d\left(x_{0}, x\right)+C_{1} N k+\right. & k\left(S-d\left(x_{0}, x\right)\right)^{1 / 3} \\
& \left.\left.S+\left(1-k^{1 / 3}\right)\left(S-d\left(x_{0}, x\right)\right)\right)\right)
\end{aligned}
$$

On $\Omega\left(-(N k)^{2 / 3}, 0\right)$, by (5.2) we have $d\left(x_{0}, x\right) \geq S-C_{1} N k$. Therefore, $\phi_{N}(x) \geq S$ there, and it suffices to show that there exists $N_{0}$ such that, for any $N \geq 1$,

We prove it by using Agmon estimates (see lemma 8.2 in the appendix). At first, we observe that, by construction (and since $\phi_{N} \leq d\left(x_{0}, x\right)+\left(C_{1} N+\right.$ $\left.S^{1 / 3}\right) k$ ), we have (uniformly in $\Omega_{1}$ ),

Since $k\left(S-d\left(x_{0}, x\right)\right)^{-2 / 3} \leq k^{1 / 3} \ll 1$, for $h$ sufficiently small we easily deduce,

Now, since $\nabla V \neq 0$ on $\partial \ddot{O}$, a small examination of the Hamilton curves of $q=\xi^{2}-V(x)$ starting from $\partial \ddot{\mathcal{O}} \times\{0\}$, shows that, for $x \in \ddot{\mathcal{O}}$ close enough to $\partial \ddot{\mathcal{O}}$, one has $d(x, \partial \ddot{于})=\mathcal{O}\left(\left(V(x)-E_{0}\right)^{3 / 2}\right)$. Therefore, by the triangle inequality, we deduce,

Now, we estimate $u-w_{C N}$ globally in a $N, h$-dependent small neighborhood $U_{N}:=\left\{x ; \operatorname{dist}(x, \partial \ddot{0})<2(N k)^{2 / 3}\right\}$ of the boundary of the island. We show

Proposition 5.2. There exist $N_{2} \in \mathbb{Z}$ and $C>0$ such that for any $N$ such that, for any $N$, one has as $h \rightarrow 0$

Then Proposition [5.1, (2.7) and an estimate of $\tilde{I}[\tilde{c}]$ in the sea mean that there exists $N_{2}$ such that

## 6. Comparison in the Sea

In this section, we give a more precise estimate on $v_{N}=e^{S / h}\left(u-w_{C N}\right)$ ( $C>0$ being as in Proposition [5.1), in a neiborhood $U_{N}$ of $\partial \ddot{0}$. We will show

Proposition 6.1. For any $L>0$ and for any $\alpha \in \mathbb{Z}_{+}^{n}$, there exists $N_{L, \alpha} \geq 1$ such that, for any $N \geq N_{L, \alpha}$, one has,

\partial_{x}^{\alpha} v_{N}(x, h)=\mathcal{O}\left(h^{L}\right) \quad \text { as } \quad h \rightarrow 0, \tag{6.1}
\end{equation*}

uniformly in $U_{N}$.
Let $\hat{x}$ be an arbitrary point on $\partial \ddot{0}$. In the sequels, all the estimates we give are locally uniform with respect to $\hat{x} \in \partial \ddot{0}$ (and thus, indeed, globally uniform since $\partial \ddot{0}$ is compact).
Here again, we choose Euclidian coordinates $x$ as in 44.1 but centered at $\hat{x}$ such that $T_{\hat{x}}(\partial \ddot{\mathcal{O}})$ is given by $x_{n}=0$, and $\partial / \partial x_{n}$ is the exterior normal of $\ddot{\mathcal{O}}$ at this point.
Consider $h$-dependent neighborhoods of $\hat{x}$, of the form

Let $(x(t), \xi(t))=\exp t H_{p}(0,0)$ be the Hamilton flow passing by the origin at time 0 i.e.

Recall that, by the non-trapping condition (A3), there esixts, at any point $\hat{x}$ on $\partial \ddot{\mathcal{O}}$, a positive constant $C_{0}=C_{0}(\hat{x})$ such that the potential $V$ is written in the form (4.2). Hence $-\frac{\partial V}{\partial x}=\left(0, \ldots, 0, C_{0}\right)+\mathcal{O}(|x|)$, and the flow is tangent to the $\xi_{n}$-axis. As $t \rightarrow 0$, one has

When $t \rightarrow \pm \infty$, on the other hand, $|x(t)| \rightarrow \infty$ by assumption (A3), and $\xi(t) \rightarrow \xi_{\infty}^{ \pm}$for some $\xi_{\infty}^{ \pm} \in \mathbb{R}^{n}$ satisfying $\left|\xi_{\infty}^{ \pm}\right|^{2}=E_{0}$ by (A1). That is, as $t \rightarrow \pm \infty$,

6.1. Propagation in the Incoming Region. Here, we study the microlocal estimate of $e^{S / h} u$ and $e^{S / h} w_{C N}$ independently along the incoming Hamilton flow $\bigcup_{t<0}(x(t), \xi(t))$. For the estimate on $e^{S / h} u$, we use the fact that $u$ is outgoing at infinity and the propagation of frequency set. For that of $e^{S / h} w_{C N}$, we use the result of $\S 4$.
6.1.1. Microlocal Estimate of $e^{S / h} u$. We first study $\tilde{u}=e^{S / h} u$. Using the Bargmann-FBI transform $T_{\mu}$ of (8.5), we plan to prove that, for some convenient $\mu>0, T_{\mu} \tilde{u}(x, \xi, h)$ is exponentially small for $(x, \xi)$ close enough to $(x(-t), \xi(-t)), t>0$ sufficiently large. Actually, we prove something slightly better, namely,
Lemma 6.2. For any $S_{1}>0$, there exist $t_{1}>0$ and $\mu>0$, such that, for all $t \geq t_{1}$, one has,

T_{\mu} u(x, \xi, h)=\mathcal{O}\left(e^{-S_{1} / h}\right),
$$

uniformly for $(x, \xi)$ in a neighborhood of $(x(-t), \xi(-t))$.
Proof. Let $F(x)$ be the function used to define the distorded operator $P_{\theta}$ (see (2.11), and let $\chi \in C^{\infty}\left(\mathbb{R}_{+}\right)$verifying $\chi(|x|)=0$ on $\pi_{x}\left(\operatorname{Supp} \psi_{0}\right) \cup\{F(x) \neq$ $x\}, \chi=1$ on $[R,+\infty)$ for $R>1$ large enough, $\chi^{\prime} \geq 0$ everywhere.
For $\delta>0$ small enough, we consider the distortion,

In particular, one has $\langle A(x) y, y\rangle=\frac{\chi^{\prime}|x| \mid}{|x|}\langle x, y\rangle^{2} \geq 0$ for all $y \in \mathbb{R}^{n}$, and thus, it is not difficult to deduce that $\operatorname{Im}^{t} d G_{\delta}(x)^{-1} d G_{\delta}(x)^{-1} \leq 0$ for $\delta>0$ small enough. As a consequence, we see that, for $x \notin \pi_{x}\left(\operatorname{Supp} \psi_{0}\right) \cup\{F(x) \neq x\}$, one has,

for some constant $C>0$, and for $(x, \xi)$ such that $\mid \operatorname{Re} p_{\theta, \delta}(x, \xi)+W(x)-$ $E_{0} \mid \leq\langle\xi\rangle^{2} / C$. As for $\tilde{P}_{\theta}$ (see Section 2), this implies that $\left(P_{\theta, \delta}+W-\rho\right)^{-1}$ is well defined and has a norm $\mathcal{O}\left(k^{-1}\right)$ on $H_{t}$.
On the other hand, we also know that $u_{\theta, \delta}:=\tilde{U}_{\delta} u_{\theta}=\tilde{U}_{\delta} U_{i \theta} u$ is well defined, and is in $L^{2}\left(\mathbb{R}^{n}\right)$ (see, e.g., HeMa). Thus, we can write,

Moreover, if $|y-x| \leq|x| / 2$, we have $y \cdot \xi \leq x \cdot \xi+|x| \cdot|\xi| / 2$, and thus, by (6.6), and for $(x, \xi)$ close enough to $(x(-t), \xi(-t))$, we obtain (possibly by taking $t$ larger),

## 7. Asymptotics of the Width

We calculate the asymptotic formula of $\operatorname{Im} \rho(h)$ using the formula (1.2) and the results of the preceding sections.
Let $W_{\sigma} \subset \mathbb{R}^{n}$ be an $N, h$-dependent open domain containing $\ddot{\partial}$ defined by

for $1<\sigma<2$.
The boundary $\partial W_{\sigma}$ is in $U_{N}$ for $1<\sigma<2$. Hence, replacing $u$ by $w_{C N}$ in the formula (1.2) by using Proposition 5.2, and noticing that $\|u\|_{L^{2}\left(W_{N}(h)\right)}-1$ is exponentially small, we have

$$
\begin{equation*}
\operatorname{Im} \rho(h)=-h^{2} \operatorname{Im} \int_{W_{\sigma}} \frac{\partial w_{C N}}{\partial n} \overline{w_{C N}} d S+\mathcal{O}\left(h^{2 L} e^{-2 S / h}\right) . \tag{7.1}
\end{equation*}
$$

Moreover, the domain of integration $\partial W_{\sigma}$ can be replaced by $\partial W_{\sigma} \cap U_{N, 1}$ using the facts (4.37) and Proposition 4.6 (i).
Then we can substitute the asymptotic formula (4.38) into the integrand of (7.1); for any $L$ large enough, there exist $\delta_{L}, c_{L}\left(=1 / C_{L}^{\prime}\right)>0$ such that for all $N>L / \delta_{L}$, one has

\begin{aligned}
h^{2} \frac{\partial w_{C N}}{\partial n} \overline{w_{C N}}= & h^{1-n / 2} e^{-2(S+\operatorname{Re} \tilde{\phi}) / h} \times \\
& \left\{\sum_{j, k=0}^{L+c_{L} N|\ln h|}\left(\frac{\partial \tilde{\phi}^{2}}{\partial n} \tilde{a}_{j} \overline{\tilde{a}}_{k}+h \frac{\partial \tilde{a}_{j}}{\partial n} \overline{\tilde{a}_{k}}\right) h^{j+k}+\mathcal{O}\left(h^{L}\right)\right\} .
\end{aligned}
$$

The vector field $\frac{\partial \operatorname{Im} \tilde{\phi}}{\partial x} \cdot \frac{\partial}{\partial x}$ is transversal to the caustics $\mathcal{C}$ where $\operatorname{Im} \tilde{\phi}=$ $\operatorname{Im} \phi=0$. Let $\iota$ be the one-to-one map which associates to a point $x$ in $\partial W_{\sigma} \cap U_{N, 1}$ the point $y=\iota(x)$ on $\mathcal{C}$ such that the integral curve of $\frac{\partial \operatorname{Im} \tilde{\phi}}{\partial x} \cdot \frac{\partial}{\partial x}$ emanating from $y$ passes by $x$.

Lemma 7.1. On $\partial W_{\sigma} \cap U_{N, 1}$, the function $\operatorname{Re} \tilde{\phi}(x)$ reaches its (transversally non-degenerate) minimum $S$ at $\iota^{-1}(\Gamma)$ modulo $\mathcal{O}\left(h^{\infty}\right)$. More precisely, one has,

$$
\left.\operatorname{Re} \tilde{\phi}(x)\right|_{\partial W_{\sigma} \cap U_{N, 1}}=\phi(\iota(x))+\mathcal{O}\left(h^{\infty}\right),
$$

Proof. This is a direct consequence of (4.8) and (4.26).
Lemma 7.2. Let $x \in \partial W_{\sigma} \cap U_{N, 1}$, and $y=\iota(x) \in \mathcal{C}$. There exists a family of smooth functions $\left\{\beta_{m}^{\prime}(y, \operatorname{dist}(x, \mathcal{C}))\right\}_{m=0}^{\infty}$ defined in $\mathcal{C} \times\left[0,2(N k)^{2 / 3}\right)$, with $\beta_{0}^{\prime}(y, 0)>0$, such that, for any large $L$, there exist $\delta_{L}, c_{L}>0$ such that for all $N>L / \delta_{L}$, one has,

$$
\begin{aligned}
&-h^{2} \operatorname{Im} \frac{\partial w_{C N}}{\partial n} \overline{w_{C N}}=h^{1-n / 2} e^{-2(S+\phi(y)) / h} \times \\
&\left\{\sum_{m=0}^{2 L+2 c_{L} N|\ln h|+1} \beta_{m}^{\prime}\left(y, \delta(N k)^{2 / 3}\right)\left(N \ln \frac{1}{h}\right)^{-m}+\mathcal{O}\left(h^{L}\right)\right\} .
\end{aligned}
$$

Proof. We know by (4.17) and (4.39) that

$$
\frac{\partial \operatorname{Im} \tilde{\phi}}{\partial n}=\mathcal{O}\left(\operatorname{dist}(x, \mathcal{C})^{1 / 2}\right), \quad \tilde{a}_{j}=\mathcal{O}\left(\operatorname{dist}(x, \mathcal{C})^{-3 j / 2-1 / 4}\right) .
$$

It follows that, for $j+k=m$,

$$
\begin{gathered}
\frac{\partial \operatorname{Im} \tilde{\phi}_{\tilde{a}_{j}} \bar{a}_{k} h^{m} \sim \operatorname{dist}(x, \mathrm{C})^{-3 m / 2} h^{m}=\delta^{-3 m / 2}\left(\frac{h}{N k}\right)^{m},}{\frac{\partial \tilde{a}_{j}}{\partial n} \overline{\tilde{a}}_{k} h^{m+1} \sim \operatorname{dist}(x, \mathrm{C})^{-3(m+1) / 2} h^{m+1}}=\delta^{-3(m+1) / 2}\left(\frac{h}{N k}\right)^{m+1} .
\end{gathered}
$$

In particular, the principal term $\beta_{0}^{\prime}(y, 0)$ is positive. In fact,

$$
\beta_{0}^{\prime}\left(y, \delta(N k)^{2 / 3}\right)=\frac{\partial \tilde{\phi}}{\partial n}\left|\tilde{a}_{0}\right|^{2} .
$$

In local coordinates as in $\S 4, \partial / \partial n=\left(\mathcal{O}(|x|) \partial / \partial x^{\prime},(1+\mathcal{O}(|x|)) \partial / \partial x_{n}\right)$ by (4.4), and

$$
\begin{gathered}
-\frac{\partial \operatorname{Im} \tilde{\phi}}{\partial x^{\prime}}\left|\tilde{a}_{0}\right|^{2}=\mathcal{O}\left(\left|x^{\prime}\right|\right)+\mathcal{O}\left(x_{n}+b\left(x^{\prime}\right)\right) \\
-\frac{\partial \operatorname{Im} \tilde{\phi}}{\partial x_{n}}\left|\tilde{a}_{0}\right|^{2}=\frac{\pi c_{0}\left(x^{\prime}, \xi_{n}^{c}\left(x^{\prime}\right)\right)^{2}}{\nu_{1}\left(x^{\prime}, \xi_{n}^{c}\left(x^{\prime}\right)\right)}+\mathcal{O}\left(\sqrt{x_{n}+b\left(x^{\prime}\right)}\right)
\end{gathered}
$$

as $x_{n}+b\left(x^{\prime}\right)$ tends to 0 , by (4.36) and (4.17).
Now expanding $\beta_{m}^{\prime}$ in Taylor series with respect to $\operatorname{dist}(x, \mathcal{C})$, we obtain

$$
\begin{aligned}
& -\operatorname{Im} \rho=h^{1-n / 2} e^{-2 S / h} \sum_{m=0}^{2 L+2 c_{L} N|\ln h|+1}\left(N \ln \frac{1}{h}\right)^{-m} \sum_{j=0}^{[3 L / 2]+1} \delta^{j-3 m / 2}(N k)^{2 j / 3} \\
& \quad \times \int_{\mathbb{C} \cap U_{N, 1}} e^{-2 \phi(y) / h} \beta_{m, j}^{\prime}(y) d y+\mathcal{O}\left(h^{L+1-n / 2} e^{-2 S / h}\right) \int_{\mathcal{C} \cap U_{N, 1}} e^{-2 \phi(y) / h} d y .
\end{aligned}
$$

To the integrals of the RHS, we apply the stationary phase method using the assumption (A4), which means that the phase $\phi(y)$ attains its transversally non-degenerate minimum on the whole submanifold $\Gamma$. For any large $L$, we obtain,

$$
\int_{\mathcal{C} \cap U_{N, 1}} e^{-2 \phi(y) / h} \beta_{m, j}^{\prime}(y) d y=h^{\left(n-1-n_{\Gamma}\right) / 2}\left\{\sum_{l=0}^{L-1} d_{l, j, m} h^{l}+\mathcal{O}\left(h^{L}\right)\right\}
$$

where $\left\{d_{l, j, m}\right\}$ is a family of real numbers with $d_{0,0,0}>0$. Here $n_{\Gamma}=\operatorname{dim} \Gamma$. Hence we have

$$
-h^{-\left(1-n_{\Gamma}\right) / 2} e^{2 S / h} \operatorname{Im} \rho(h)=
$$

$$
\begin{equation*}
\sum_{(l, j, m) \in \mathcal{N}} d_{l, j, m} h^{l} k^{2 j / 3}\left(\ln \frac{1}{h}\right)^{-m}\left(N^{2 / 3} \delta\right)^{j-3 m / 2}+\mathcal{O}\left(h^{L}\right) \tag{7.2}
\end{equation*}
$$

where
$\mathcal{N}=\left\{(l, j, m) \in \mathbb{N}^{3} ; l \leq L-1, j \leq\left[\frac{3 L}{2}\right]+1, m \leq 2\left(L+c_{L} N|\ln h|\right)+1\right\}$.
Lemma 7.3. Let $(l, j, m) \in \mathcal{N}$. The real number $d_{l, j, m}$ vanishes if $j-$ $3 m / 2 \neq 0$.
Proof. Observing that $h \ll k^{2 / 3} \ll|\ln h|^{-1}$, we introduce an order relation in the set $\mathcal{N}$. We write $(l, j, m)<\left(l^{\prime}, j^{\prime}, m^{\prime}\right)$ if one of the following three conditions holds:

\text { (i) } l<l^{\prime} \text {, (ii) } l=l^{\prime} \text { and } j<j^{\prime}, \text { (iii) } l=l^{\prime}, j=j^{\prime}, \text { and } m<m^{\prime} \text {. }
$$

Suppose there exists $d_{l, j, m} \neq 0$ with $j-3 m / 2 \neq 0$ and let $\left(l_{0}, j_{0}, m_{0}\right)$ be the smallest among such $(l, m, j)$ 's. Then the RHS of (7.2) becomes

\begin{gathered}
\sum_{(l, j, m)<\left(l_{0}, j_{0}, m_{0}\right)} d_{l, j, m} h^{l+m}+d_{l_{0}, j_{0}, m_{0}} h^{l_{0}} k^{\frac{2 j_{0}}{3}}\left(\ln \frac{1}{h}\right)^{-m_{0}}\left(N^{2 / 3} \delta\right)^{j_{0}-\frac{3 m_{0}}{2}} \\
+\mathcal{O}\left(h^{l_{0}} k^{\frac{2 j_{0}}{3}}\left(\ln \frac{1}{h}\right)^{-m_{0}}\right)
\end{gathered}
$$

Here, $\delta$ is an arbitrary number varying between 1 and 2 and $d_{l, j, m}$ are independent of $\delta$. On the other hand, the LHS of (7.2) is independent of $\delta$. This is a contradiction and we have proved Lemma 7.3 ,
Then the proof of Theorem 2.3 follows from (7.2) and this Lemma 7.3, since for $j-3 m / 2=0$, one has

\left(\ln \frac{1}{h}\right)^{-m} k^{2 j / 3}=h^{m} .
$$

## 8. Appendix

8.1. Holomorphic $\delta$-Approximation. Let $f=f(x)$ be a smooth function on $\mathbb{R}^{n}$ uniformly bounded together with all its derivatives. A function $\tilde{f}(x, y)$ on $\mathbb{R}^{2 n}$ is said to be an almost-analytic extension of $f$ if,

$$
\tilde{f}(x, 0)=f(x),
$$

and, for all $\alpha \in \mathbb{Z}_{+}^{2 n}$,

$$
\begin{equation*}
\partial^{\alpha}\left(\frac{\partial}{\partial x}+i \frac{\partial}{\partial y}\right) \tilde{f}(x, y)=\mathcal{O}\left(|y|^{\infty}\right), \tag{8.1}
\end{equation*}
$$

as $|y| \rightarrow 0_{+}$, uniformly with respect to $x$. We can construct an almostanalytic extension (see, e.g., MeSj) by setting,

$$
\begin{equation*}
\tilde{f}(x, y)=\sum_{\alpha \in \mathbb{N}^{n}} \frac{(i y)^{\alpha}}{\alpha!} \partial^{\alpha} f(x)\left(1-\chi\left(\frac{\epsilon_{\alpha}}{|y|}\right)\right), \tag{8.2}
\end{equation*}
$$

where $\chi \in C_{0}^{\infty}(\mathbb{R})$ is a fixed cutoff function that is equal to 1 near 0 , and $\left(\epsilon_{\alpha}\right)_{\alpha \in \mathbb{N}^{n}}$ is a decreasing sequence of positive numbers converging to 0 sufficiently rapidly. More precisely, we choose $\varepsilon_{\alpha}$ such that, for any $\beta \leq \alpha$, one has,

$$
|y| \sup \left|\left(1-\chi\left(\varepsilon_{\alpha} /|y|\right)\right) \partial^{\alpha+\beta} f\right| \leq \alpha!.
$$

Then, the corresponding almost analytic extension have the following elementary properties:

Lemma 8.1. Let $f$ be as above.
(i): If $\tilde{f}(x, y)$ and $\hat{f}(x, y)$ are both almost-analytic extensions of $f(x)$, then, for any $\delta>0$, one has

$$
\begin{aligned}
& \tilde{f}(x, y)-\hat{f}(x, y)=\mathcal{O}\left(|y|^{\infty}\right) \\
& \sup _{|y| \leq \delta}|\tilde{f}(x, y)| \leq \min \{\sup |f|+2, \sup |f|+\delta(1+\sup |\nabla f|)\}
\end{aligned}
$$

(ii): Let $\tilde{f}$ be an almost-analytic extension of $f$ and let $I_{1}, \ldots, I_{n} \subset$ $\mathbb{R}$ be bounded open intervals. Then, for any $\delta>0$ there exists a function $f_{\delta}$, holomorphic in $\Gamma_{\delta}:=\left\{z \in \mathbb{C}^{n} ; \operatorname{dist}\left(z_{j}, I_{j}\right)<\delta, j=\right.$ $1, \ldots, n\}$, such that, for all $\alpha \in \mathbb{Z}_{+}^{2 n}, \beta \in \mathbb{Z}_{+}^{n}$, and $N \geq 1$, there exists $C(\alpha, N)>0$, such that,

$$
\begin{align*}
& \sup _{x+i y \in \Gamma_{\delta}}\left|\partial^{\alpha}\left(f_{\delta}(x+i y)-\tilde{f}(x, y)\right)\right| \leq C(\alpha, N) \delta^{N} ;  \tag{8.3}\\
& \sup _{z \in \Gamma_{\delta}}\left|\partial_{z}^{\beta} f_{\delta}\right| \leq \sup _{x+i y \in \Gamma_{2 \delta}}|\tilde{f}(x, y)| \delta^{-|\beta|} \beta!, \tag{8.4}
\end{align*}
$$

uniformly as $\delta \rightarrow 0_{+}$. (Such a function $f_{\delta}$ will be called a holomorphic $\delta$-approximation of $f$ on $I_{1} \times \cdots \times I_{n}$.)
(iii): Suppose $n=1$ and $f(x)$ is real valued. If $f^{\prime}\left(x_{0}\right) \neq 0$, then any almost-analytic extension $\tilde{f}(x, y)$ is one to one in a neighborhood of $(x, y)=\left(x_{0}, 0\right)$ and the inverse $\tilde{f}^{-1}(u, v)$ defined in a neighborhood of $(u, v)=\left(f\left(x_{0}\right), 0\right)$ is an almost-analytic extension of $f^{-1}(u)$.

Proof. The proof of (i) is easy and we proceed with that of (ii). We denote by $\gamma(\delta)$ the (positively oriented) $n$-contour,

$$
\gamma(\delta):=\left\{\zeta \in \mathbb{C}^{n} ; \operatorname{dist}\left(\zeta_{j}, I\right)=2 \delta, j=1, \ldots, n\right\}
$$

and, for $z \in \gamma(\delta)$, we set,

$$
f_{\delta}(z)=\frac{1}{(2 i \pi)^{n}} \int_{\gamma(\delta)} \frac{\tilde{f}(\operatorname{Re} \zeta, \operatorname{Im} \zeta)}{\left(z_{1}-\zeta_{1}\right) \ldots\left(z_{n}-\zeta_{n}\right)} d \zeta_{1} \ldots d \zeta_{n}
$$

Then, $f_{\delta}$ is clearly holomorphic in $\Gamma_{\delta}$, and since $\left|z_{j}-\zeta_{j}\right| \geq \delta$ for $\zeta \in \gamma(\delta)$ and $z \in \Gamma_{\delta}$, (8.4) is obtained in a standard way by differentiating under the integral-sign. Moreover, for $z=x+i y \in \Gamma_{\delta}$, we have,

$$
f_{\delta}(z)-\tilde{f}(x, y)=\frac{1}{(2 i \pi)^{n}} \int_{\gamma(\delta)} \frac{\tilde{f}(\operatorname{Re} \zeta, \operatorname{Im} \zeta)-\tilde{f}(x, y)}{\left(z_{1}-\zeta_{1}\right) \ldots\left(z_{n}-\zeta_{n}\right)} d \zeta_{1} \ldots d \zeta_{n}
$$

and, using the notations $\partial_{z}=\frac{1}{2}\left(\partial_{x}-i \partial_{y}\right)$ and $\bar{\partial}_{z}=\frac{1}{2}\left(\partial_{x}+i \partial_{y}\right)$, we see that,

$$
\begin{aligned}
& \tilde{f}(\operatorname{Re} \zeta, \operatorname{Im} \zeta)-\tilde{f}(x, y) \\
& =(\zeta-z) \int_{0}^{1}\left(\partial_{z} \tilde{f}\right)(t \zeta+(1-t) z) d t+(\overline{\zeta-z}) \int_{0}^{1}\left(\bar{\partial}_{z} \tilde{f}\right)(t \zeta+(1-t) z) d t
\end{aligned}
$$

where $\partial_{z} \tilde{f}(z)$ stands for $\partial_{z} \tilde{f}(x, y)$, and similarly for $\bar{\partial}_{z} \tilde{f}(z)$. Therefore, since $\tilde{f}$ is almost-analytic, and $|\operatorname{Im} z|+|\operatorname{Im} \zeta|=\mathcal{O}(\delta)$, we obtain,

$$
f_{\delta}(z)-\tilde{f}(x, y)=\sum_{j=1}^{n} \int_{\gamma(\delta)} \frac{F_{j}(z, \zeta)}{\prod_{\ell \neq j}\left(z_{\ell}-\zeta_{\ell}\right)} d \zeta_{1} \ldots d \zeta_{n}+r(x, y)
$$

with $F_{j}(z, \zeta):=\int_{0}^{1}\left(\partial_{z_{j}} \tilde{f}\right)(t \zeta+(1-t) z) d t$, and $\partial^{\alpha} r=\mathcal{O}\left(\delta^{\infty}\right)$ uniformly. Thus, since $F_{j}(z, \zeta) \prod_{\ell \neq j}\left(z_{\ell}-\zeta_{\ell}\right)^{-1}$ depends smoothly on $\zeta_{j}$ in the domain $A_{j}:=\left\{\zeta_{j} ; \operatorname{dist}\left(\zeta_{j}, I\right) \leq 2 \delta\right\}$, by the Stokes formula, we obtain,

$$
f_{\delta}(z)-\tilde{f}(x, y)=-i \sum_{j=1}^{n} \int_{\gamma_{j}(\delta)} \frac{\bar{\partial}_{\zeta_{j}} F_{j}(z, \zeta)}{\prod_{\ell \neq j}\left(z_{\ell}-\zeta_{\ell}\right)} d \zeta_{1} \ldots d \zeta_{n} \wedge d \bar{\zeta}_{j}+r(x, y)
$$

with $\gamma_{j}(\delta):=\left\{\zeta_{j} \in A_{j}, \operatorname{dist}\left(\zeta_{\ell}, I\right)=2 \delta, \ell \neq j\right\}$. Then, (8.3) follows from the fact that $\bar{\partial}_{\zeta_{j}} F_{j}=\mathcal{O}\left(\delta^{\infty}\right)$ together with all its derivatives.
Now, we prove (iii). Let us use the coordinates $(z, \bar{z})=(x+i y, x-i y)$, $(\zeta, \bar{\zeta})=(u+i v, u-i v)$ and regard $\tilde{f}$ and $g \equiv \tilde{f}^{-1}$ as functions of $(z, \bar{z})$ and $(\zeta, \bar{\zeta})$ respectively. Then

$$
\tilde{f}(g(\zeta, \bar{\zeta}), \overline{g(\zeta, \bar{\zeta})})=\zeta
$$

Differentiating by $\bar{\zeta}$, one gets

$$
\partial_{z} \tilde{f} \bar{\partial}_{\zeta} g+\bar{\partial}_{z} \tilde{f} \bar{\partial}_{\zeta} \bar{g}=0
$$

where $\partial_{z}=\frac{1}{2}\left(\frac{\partial}{\partial x}-i \frac{\partial}{\partial y}\right), \bar{\partial}_{z}=\frac{1}{2}\left(\frac{\partial}{\partial x}+i \frac{\partial}{\partial y}\right)$ and $\partial_{\zeta}=\frac{1}{2}\left(\frac{\partial}{\partial u}-i \frac{\partial}{\partial v}\right), \bar{\partial}_{\zeta}=$ $\frac{1}{2}\left(\frac{\partial}{\partial u}+i \frac{\partial}{\partial v}\right)$.
Since $\partial_{z} \tilde{f}$ does not vanish near $x_{0}$ by assumption, we can conclude that $\bar{\partial}_{\zeta} g=\mathcal{O}\left(|v|^{\infty}\right)$, i.e. $g$ is an almost-analytic extension of $f^{-1}(u)$ if $\bar{\partial}_{z} \tilde{f}$ is, as function of $(u, v)$, of $\mathcal{O}\left(|v|^{\infty}\right)$ as $v \rightarrow 0$.
First, $\bar{\partial}_{z} \tilde{f}=\mathcal{O}\left(|y|^{\infty}\right)$ since $\tilde{f}$ is almost-analytic. On the other hand, since $f(x)$ is real-valued, we see from (8.2) that $v=f^{\prime}(x) y+\mathcal{O}\left(y^{3}\right)$ as $y \rightarrow 0$, and since $f^{\prime}\left(x_{0}\right) \neq 0$, we also see that $y=\mathcal{O}(v)$ as $v \rightarrow 0$. Hence $\bar{\partial}_{z} \tilde{f}=\mathcal{O}\left(|v|^{\infty}\right)$.
8.2. A Priori Estimates. We recall some a priori estimates. The first is the so-called Agmon estimate (see for example [HeSj2, [Ma1]):

Lemma 8.2. For any $h>0, V \in L^{\infty}\left(\mathbb{R}^{n}\right)$ real-valued, $E \in \mathbb{R}, f \in H^{1}\left(\mathbb{R}^{n}\right)$, and $\phi$ real-valued and Lipshitz on $\mathbb{R}^{n}$, one has

$$
\begin{aligned}
& \operatorname{Re}\left\langle e^{\varphi / h}\left(-h^{2} \Delta+V-E\right) f, e^{\varphi / h} f\right\rangle \\
& =\left\|h \nabla\left(e^{\varphi / h} f\right)\right\|^{2}+\left\langle\left(V-E-|\nabla \varphi(x)|^{2}\right) e^{\varphi / h} f, e^{\varphi / h} f\right\rangle
\end{aligned}
$$

The second is a microlocal estimate originated by one of the authors (Ma2). For $u(x, h) \in S^{\prime}\left(\mathbb{R}^{n}\right)$ and $\mu>0$, we define the so-called FBI-Bargmann transform $T_{\mu}$ by the formula,

$$
\begin{equation*}
T_{\mu} u(x, \xi, h)=c_{\mu} \int_{\mathbb{R}^{n}} e^{i(x-y) \cdot \xi / h-\mu(x-y)^{2} / 2 h} u(y, h) d y, \tag{8.5}
\end{equation*}
$$

where $c_{\mu}=\mu^{n / 4} 2^{-n / 2}(\pi h)^{-3 n / 4}$. The operator $T_{\mu}$ is unitary from $L^{2}\left(\mathbb{R}^{n}\right)$ to $L^{2}\left(\mathbb{R}^{2 n}\right)$, and $e^{\xi^{2} / 2 \mu h} T_{\mu} u(x, \xi)$ is an entire function of $z_{\mu}:=x-i \xi / \mu$.
Proposition 8.3. Let $m \in S_{2 n}(1), d \geq 0, p \in S_{2 n}\left(\langle\xi\rangle^{2 d}\right)$, and denote by $p_{a}(x, \xi ; h)$ an almost-analytic extension of $p$. Let also $k:=h \ln \frac{1}{h}, \rho \in$ $[-1 / 3,1 / 3]$ and $\psi \in C^{\infty}\left(\mathbb{R}^{2 n} ; \mathbb{R}\right)$, possibly $h$-dependent, and verifying,

\begin{equation*}
\partial_{x}^{\alpha} \partial_{\xi}^{\beta} \psi=\mathcal{O}\left(k^{-(a|\alpha|+(1-a)|\beta|)}\right), \tag{8.6}
\end{equation*}
$$

for any $\alpha, \beta \in \mathbb{Z}_{+}^{n}$, with,

$$
\begin{equation*}
\frac{1}{3}-\min (\rho, 0) \leq a \leq \frac{2}{3}-\max (\rho, 0) . \tag{8.7}
\end{equation*}
$$

Then, taking $\mu=C k^{\rho}$ (with $C>0$ constant arbitrary), for $u, v \in L^{2}\left(\mathbb{R}^{n}\right)$, one has,

\begin{aligned}
\left.(8.8) h^{-\psi} T_{\mu} P u, h^{-\psi} T_{\mu} v\right\rangle= & \left\langle\tilde{p}(x, \xi ; h) h^{-\psi} T_{\mu} u, h^{-\psi} T_{\mu} v\right\rangle \\
& +\mathcal{O}\left(\frac{h}{\ln \frac{1}{h}}\left\|\langle\xi\rangle^{d} h^{-\psi} T_{\mu} u\right\| \cdot\left\|\langle\xi\rangle^{d} h^{-\psi} T_{\mu} v\right\|\right),
\end{aligned}
$$

with,

$$
\begin{array}{r}
\tilde{p}(x, \xi ; h)=m(x, \xi) p_{a}\left(x-2 k \mu^{-1} \partial_{z_{\mu}} \psi, \xi+2 i k \partial_{z_{\mu}} \psi\right) \\
+h \partial_{z_{\mu}}\left[m(x, \xi)\left(\frac{1}{\mu} \frac{\partial p_{a}}{\partial \operatorname{Re} x}-i \frac{\partial p_{a}}{\partial \operatorname{Re} \xi}\right)\left(x-2 k \mu^{-1} \partial_{z_{\mu}} \psi, \xi+2 i k \partial_{z_{\mu}} \psi\right)\right],
\end{array}
$$

where we have set $\partial_{z_{\mu}}=\left(\partial_{x}+i \mu \partial_{\xi}\right) / 2$.
In particular, if $p$ is real-valued, one obtains,

\begin{align*}
& \operatorname{Im}\left\langle h^{-\psi} T_{\mu} P u, h^{-\psi} T_{\mu} u\right\rangle  \tag{8.9}\\
& =k\left\langle\left(H_{p} \psi+q_{\psi}(x, \xi ; h)\right) h^{-\psi} T_{\mu} u, h^{-\psi} T_{\mu} u\right\rangle+\mathcal{O}(h)\left\|\langle\xi\rangle^{d} h^{-\psi} T_{\mu} u\right\|^{2}
\end{align*}
$$

with,

$$
\begin{aligned}
q_{\psi}(x, \xi ; h):= & h \mu \sum_{j, \ell=1}^{n}\left(\partial_{\xi_{j}} \partial_{\xi_{\ell}} p\right) \partial_{\xi_{j}} \partial_{x_{\ell}} \psi \\
& +\sum_{\substack{\alpha \in \mathbb{N}^{2 n} \\
2 \leq|\alpha| \leq 3}} \frac{2^{|\alpha|} k^{|\alpha|-1}}{\alpha!} \partial^{\alpha} p(x, \xi) \operatorname{Im}\left[\left(-\mu^{-1} \partial_{z_{\mu}} \psi, i \partial_{z_{\mu}} \psi\right)^{\alpha}\right]
\end{aligned}
$$

Proof. We follow the proof of Ma2 Proposition 3.1 (see also BoMi Theorem 3 ), and we do it for $d=0$ only (the general case $d \geq 0$ can be done along the same lines and is left to the reader). We have,

I:=\left\langle m h^{-\psi} T_{\mu} P u, h^{-\psi} T_{\mu} v\right\rangle=\frac{c_{\mu}^{2}}{(2 \pi h)^{n}} \int & e^{\Phi / h} m(x, \xi) p\left(\frac{y+x^{\prime}}{2}, \eta\right) \times \\
& \times u\left(x^{\prime}\right) \overline{v\left(y^{\prime}\right)} d\left(x^{\prime}, \eta, y, y^{\prime}, x, \xi\right), \tag{8.10}
\end{align*}
$$

where the integral runs over $\mathbb{R}^{6 n}$, and where we have set,

\begin{equation*}
\Phi=2 k \psi(x, \xi)+i\left(y^{\prime}-y\right) \xi-\frac{\mu}{2}(x-y)^{2}-\frac{\mu}{2}\left(x-y^{\prime}\right)^{2}+i\left(y-x^{\prime}\right) \eta \tag{8.11}
\end{equation*}
$$

Then we observe that, by construction of $p_{a}$, for all $Y=(y, \eta) \in \mathbb{R}^{2 n}$ and $X=\left(x-2 k \mu^{-1} \partial_{z_{\mu}} \psi(x, \xi), \xi+2 i k \partial_{z_{\mu}} \psi(x, \xi)\right) \in \mathbb{C}^{2 n}$ (and setting $X_{s}:=$ $s Y+(1-s) X, 0 \leq s \leq 1)$, we have,

\begin{aligned}
p(Y)-p_{a}(X) & =\int_{0}^{1}\left((Y-\operatorname{Re} X) \frac{\partial p_{a}}{\partial \operatorname{Re} X}\left(X_{s}\right)-\operatorname{Im} X \frac{\partial p_{a}}{\partial \operatorname{Im} X}\left(X_{s}\right)\right) d s \\
& =\int_{0}^{1}\left((Y-X) \frac{\partial p_{a}}{\partial \operatorname{Re} X}\left(X_{s}\right)+2 i \operatorname{Im} X \frac{\partial p_{a}}{\partial \bar{X}}\left(X_{s}\right)\right) d s \\
& =(X-Y) \cdot b_{1}(x, \xi, Y)+r_{1}(x, \xi, Y)
\end{aligned}
$$

where $b_{1}$ and $r_{1}$ are $C^{\infty}$ on $\mathbb{R}^{4 n}$ and verify,

$$
\begin{aligned}
& \partial_{x}^{\alpha} \partial_{\xi}^{\beta} \partial_{Y}^{\gamma} b_{1}=\mathcal{O}\left(1+k^{\tau-a|\alpha|-(1-a)|\beta|}\right) \\
& \partial_{x}^{\alpha} \partial_{\xi}^{\beta} \partial_{Y}^{\gamma} r_{1}=\mathcal{O}\left(\left(1+k^{\tau-a|\alpha|-(1-a)|\beta|}\right)|\operatorname{Im} X|^{\infty}\right)=\mathcal{O}\left(h^{\infty}\right)
\end{aligned}
$$

for all $\alpha, \beta \in\left(\mathbb{Z}_{+}\right)^{n}, \gamma \in\left(\mathbb{Z}_{+}\right)^{2 n}$, uniformly on $\mathbb{R}^{4 n}$, and with $\tau:=\min (1-$ $a, 1-a-\rho, a, a+\rho)$. (The last estimate comes from the fact that $|\operatorname{Im} X|=$ $\mathcal{O}\left(k^{1 / 3}\right)$.)
In the same way, one also has,

\partial_{x}^{\alpha} \partial_{\xi}^{\beta} \partial_{Y}^{\gamma} B_{2} & =\mathcal{O}\left(1+k^{\tau-a|\alpha|-(1-a)|\beta|}\right)  \tag{8.15}\\
\partial_{x}^{\alpha} \partial_{\xi}^{\beta} \partial_{Y}^{\gamma} r_{2} & =\mathcal{O}\left(h^{\infty}\right)
\end{align*}
$$

Inserting (8.12) and (8.14) into (8.10), we obtain,

I=\left\langle m p_{a}(X) h^{-\psi} T_{\mu} u, h^{-\psi} T_{\mu} v\right\rangle+R_{1}+R_{2}+R_{3} \tag{8.16}
\end{equation*}
$$

with,

\begin{array}{r}
R_{1}=\frac{c_{\mu}^{2}}{(2 \pi h)^{n}} \int e^{\Phi / h}\left(X-\left(\frac{y+x^{\prime}}{2}, \eta\right)\right) \frac{\partial p_{a}}{\partial \operatorname{Re} X}(X) u\left(x^{\prime}\right) \overline{v\left(y^{\prime}\right)} \\
\times m(x, \xi) d\left(x^{\prime}, \eta, y, y^{\prime}, x, \xi\right), \tag{8.17}
\end{array}
$$

$$
\begin{array}{r}
R_{2}=\frac{c_{\mu}^{2}}{(2 \pi h)^{n}} \int e^{\Phi / h}\left\langle B \cdot\left(X-\left(\frac{y+x^{\prime}}{2}, \eta\right)\right), X-\left(\frac{y+x^{\prime}}{2}, \eta\right)\right\rangle u\left(x^{\prime}\right) \\
\times \overline{v\left(y^{\prime}\right)} m(x, \xi) d\left(x^{\prime}, \eta, y, y^{\prime}, x, \xi\right), \tag{8.18}
\end{array}
$$

where we have set,

$$
B:=B_{2}\left(x, \xi, \frac{y+x^{\prime}}{2}, \eta\right)
$$

and,

$$
\begin{align*}
R_{3}=\frac{c_{\mu}^{2}}{(2 \pi h)^{n}} \int e^{\Phi / h} r & \left(x, \xi, \frac{y+x^{\prime}}{2}, \eta\right) u\left(x^{\prime}\right) \overline{v\left(y^{\prime}\right)} \\
& \times m(x, \xi) d\left(x^{\prime}, \eta, y, y^{\prime}, x, \xi\right) \tag{8.19}
\end{align*}
$$

where,

$$
r(x, \xi, Y):=(X-Y) \cdot r_{2}(x, \xi, Y)+r_{1}(x, \xi, Y)
$$

Then, as in [Ma2, BoMi], we observe that $\Phi$ verifies,

L(\Phi)=X-\left(\frac{y+x^{\prime}}{2}, \eta\right)
$$

with $L:=\frac{1}{2}\left(-\mu^{-1} \partial_{x}-i \partial_{\xi}-i \partial_{\eta}, i \partial_{x}-\mu \partial_{\xi}+2 i \partial_{y}\right)$. As a consequence,

e^{\Phi / h}\left(X-\left(\frac{y+x^{\prime}}{2}, \eta\right)\right)=h L\left(e^{\Phi / h}\right)
$$

and
$\left\langle B \cdot\left(X-\left(\frac{y+x^{\prime}}{2}, \eta\right)\right), X-\left(\frac{y+x^{\prime}}{2}, \eta\right)\right\rangle e^{\Phi / h}=h^{2}\langle B \cdot L, L\rangle e^{\Phi / h}=: h^{2} A e^{\Phi / h}$.
Thus, making an integration by parts in (8.17), we obtain,

R_{1}=h\left\langle p_{1}(x, \xi) h^{-\psi} T_{\mu} u, h^{-\psi} T_{\mu} v\right\rangle \tag{8.20}
\end{equation*}
$$

with

$$
\begin{aligned}
p_{1}(x, \xi ; h): & ={ }^{t} L\left(m(x, \xi) \frac{\partial p_{a}}{\partial \operatorname{Re} X}(X)\right) \\
& =\partial_{z_{\mu}}\left[m(x, \xi)\left(\frac{1}{\mu} \frac{\partial p_{a}}{\partial \operatorname{Re} x}(X)-i \frac{\partial p_{a}}{\partial \operatorname{Re} \xi}(X)\right)\right]
\end{aligned}
$$

(here ${ }^{t} L$ stands for the transposed operator of $L$ ). In the same way, making two integrations by parts in (8.18), we obtain,

R_{2}=h^{2}\left\langle h^{-\psi} T_{\mu, f} u, h^{-\psi} T_{\mu} v\right\rangle,
$$

where we have set,

$$
\begin{equation*}
f\left(x, \xi, \frac{y+x^{\prime}}{2}, \eta\right)={ }^{t} A \cdot(m(x, \xi)) \tag{8.21}
\end{equation*}
$$

and,

$$
T_{\mu, f} u(x, \xi):=c_{\mu} \int e^{i(x-y) \xi / h-\mu(x-y)^{2} / 2 h} \operatorname{Op}_{h}^{W}(f(x, \xi, \cdot)) u(y) d y
$$

In particular, by (8.15) and (8.7), we see that,

$$
\begin{equation*}
\partial_{x}^{\alpha} \partial_{\xi}^{\beta} \partial_{Y}^{\gamma} f=\mathcal{O}\left(k^{-1-a|\alpha|-(1-a)|\beta|}\right) . \tag{8.22}
\end{equation*}
$$

With the same notations, we also have,

R_{3}=\left\langle h^{-\psi} T_{\mu, m r} u, h^{-\psi} T_{\mu} v\right\rangle .
$$

Now, for $g \in\{f, m r\}$, we observe,

T_{\mu, g} u(x, \xi)=\left.\left[T_{\mu} \mathrm{Op}_{h}^{W}\left(g\left(x^{\prime}, \xi^{\prime}, \cdot\right)\right) u(x, \xi)\right]\right|_{\substack{x^{\prime}=x \\ \xi^{\prime}=x}}
$$

and thus, applying a slight generalization of Ma1 Proposition 3.3.1 to the case $\mu \neq 1$, we easily obtain,

where $\mathrm{Op}_{h}(\tilde{g})$ stands for the semiclassical pseudodifferential operator with symbol,

\tilde{g}\left(x, x^{\prime}, \xi, \xi^{\prime}, x^{*}, \xi^{*}\right):=g\left(x, \xi, \frac{x+x^{\prime}}{2}-\xi^{*}, x^{*}\right)
$$

Here, $x^{*}$ and $\xi^{*}$ stand for the dual variables of $x$ and $\xi$, respectively. Then, writing,

\psi(x, \xi)-\psi\left(x^{\prime}, \xi^{\prime}\right)=\left(x-x^{\prime}\right) \phi_{1}+\left(\xi-\xi^{\prime}\right) \phi_{2}
$$

(with $\phi_{j}=\phi_{j}\left(x, x^{\prime}, \xi, \xi^{\prime} ; h\right)$ smooth), applying Stokes formula and, in the expression of $h^{-\psi} \mathrm{Op}_{h}(\tilde{g}) h^{\psi}$, performing the change of contour,

\mathbb{R}^{2 n} \ni\left(x^{*}, \xi^{*}\right) \mapsto\left(x^{*}, \xi^{*}\right)+i k\left(\phi_{1}, \phi_{2}\right),
$$

we see that $h^{-\psi} \operatorname{Op}_{h}(\tilde{g}) h^{\psi}$ is an $h$-admissible operator with symbol,

$$
g_{\psi}\left(x, x^{\prime}, \xi, \xi^{\prime}, x^{*}, \xi^{*}\right):=g_{a}\left(x, \xi, \frac{x+x^{\prime}}{2}-\xi^{*}-i k \phi_{2}, x^{*}+i k \phi_{1}\right),
$$

where $g_{a}$ is an almost-analytic extension of $g$. Moreover, by (8.6), we see that $\phi_{1}$ and $\phi_{2}$ verify,

$$
\begin{aligned}
& \partial_{x, x^{\prime}}^{\alpha} \partial_{\xi, \xi^{\prime}}^{\beta} \phi_{1}=\mathcal{O}\left(k^{-(a+a|\alpha|+(1-a)|\beta|)}\right) \\
& \partial_{x, x^{\prime}}^{\alpha} \partial_{\xi, \xi^{\prime}}^{\beta} \phi_{2}=\mathcal{O}\left(k^{-(1-a+a|\alpha|+(1-a)|\beta|)}\right),
\end{aligned}
$$

and thus, using (8.15), (8.22), the fact that $k \geq h$, and the CalderónVaillancourt theorem (see, e.g., Ma1 Chapter 2, Exercise 15), we obtain,

\left\|h^{-\psi} \mathrm{Op}_{h}(\tilde{f}) h^{\psi}\right\|=\mathcal{O}\left(k^{-1}\right) ; \\
\left\|h^{-\psi} \operatorname{Op}_{h}(\widetilde{m r}) h^{\psi}\right\|=\mathcal{O}\left(h^{\infty}\right),
\end{gathered}
$$

and therefore,

R_{2}=\mathcal{O}\left(h^{2} k^{-1}\left\|h^{-\psi} T_{\mu} u\right\| \cdot\left\|h^{-\psi} T_{\mu} v\right\|\right) \\
\quad R_{3}=\mathcal{O}\left(h^{\infty}\left\|h^{-\psi} T_{\mu} u\right\| \cdot\left\|h^{-\psi} T_{\mu} v\right\|\right)
\end{array}
$$

so that, by (8.16) and (8.20), (8.8) follows.
To prove (8.9), we first observe, that, by a Taylor expansion, we have,

& p_{a}(x-2 k\left.\mu^{-1} \partial_{z_{\mu}} \psi, \xi+2 i k \partial_{z_{\mu}} \psi\right) \\
&=\left(p-k \mu^{-1} \nabla_{x} p \nabla_{x} \psi-k \mu \nabla_{\xi} p \nabla_{\xi} \psi\right)(x, \xi)+i k H_{p} \psi(x, \xi) \\
& \quad+\sum_{\substack{\alpha \in \mathbb{N}_{2 n} \\
2 \leq|\alpha| \leq 3}} \frac{(2 k)^{|\alpha|}}{\alpha!} \partial^{\alpha} p(x, \xi)\left(-\mu^{-1} \partial_{z_{\mu}} \psi, i \partial_{z_{\mu}} \psi\right)^{\alpha}+\mathcal{O}\left(k^{4 / 3}\right),
\end{aligned}
$$

and thus, in particular (since $k^{4 / 3}=\mathcal{O}(h)$ ),
(8.24) $\operatorname{Im} p_{a}\left(x-2 k \mu^{-1} \partial_{z_{\mu}} \psi, \xi+2 i k \partial_{z_{\mu}} \psi\right)$

$$
=k H_{p} \psi(x, \xi)+\sum_{\substack{\alpha \in \mathbb{N}^{2 n} \\ 2 \leq|\alpha| \leq 3}} \frac{(2 k)^{|\alpha|}}{\alpha!} \partial^{\alpha} p(x, \xi) \operatorname{Im}\left[\left(-\mu^{-1} \partial_{z_{\mu}} \psi, i \partial_{z_{\mu}} \psi\right)^{\alpha}\right]+\mathcal{O}(h) .
$$

Moreover, using (8.6), we also see that,

$$
\begin{aligned}
&\left(\frac{1}{\mu} \frac{\partial p_{a}}{\partial \operatorname{Re} x}\right.\left.-i \frac{\partial p_{a}}{\partial \operatorname{Re} \xi}\right)\left(x-2 k \mu^{-1} \partial_{z_{\mu}} \psi, \xi+2 i k \partial_{z_{\mu}} \psi\right) \\
& \quad=\mu^{-1} \partial_{x} p(x, \xi)-i \partial_{\xi} p(x, \xi)+2 k M(x, \xi) \partial_{z_{\mu}} \psi(x, \xi)+\mathcal{O}\left(k^{2 / 3}\right)
\end{aligned}
$$

where $M$ is the $n \times n$-matrix-valued function,

$$
\begin{aligned}
M & =-\mu^{-2}\left(\nabla_{x} \cdot \nabla_{x}\right) p+i \mu^{-1}\left(\nabla_{\xi} \cdot \nabla_{x}+\nabla_{x} \cdot \nabla_{\xi}\right) p+\left(\nabla_{\xi} \cdot \nabla_{\xi}\right) p \\
& =\left(\nabla_{\xi} \cdot \nabla_{\xi}\right) p+\mathcal{O}\left(k^{1 / 3}\right)
\end{aligned}
$$

(Here, we have used the notation $\left.\nabla_{x} \cdot \nabla_{\xi}=\left(\partial_{x_{j}} \partial_{\xi_{\ell}}\right)_{1 \leq j, \ell \leq n}.\right)$
Since applying $\partial_{z_{\mu}}$ makes lose at most $k^{-2 / 3}$, one also easily obtains,

$$
\begin{array}{r}
\partial_{z_{\mu}}\left[\left(\frac{1}{\mu} \frac{\partial p_{a}}{\partial \operatorname{Re} x}-i \frac{\partial p_{a}}{\partial \operatorname{Re} \xi}\right)\left(x-2 k \mu^{-1} \partial_{z_{\mu}} \psi, \xi+2 i k \partial_{z_{\mu}} \psi\right)\right] \\
=\frac{\mu}{2} \Delta_{\xi} p+2 k \sum_{j, \ell=1}^{n}\left(\partial_{\xi_{j}} \partial_{\xi_{\ell}} p\right) \partial_{z_{\mu}^{j}} \partial_{z_{\mu}^{\ell}} \psi(x, \xi)+\mathcal{O}(1)
\end{array}
$$

and thus, if $p$ is real-valued, one finds,
(8.25) $=k \mu \sum_{j, \ell=1}^{n}\left(\partial_{\xi_{j}} \partial_{\xi_{\ell}} p\right)\left(\partial_{x_{j}} \partial_{\xi_{\ell}} \psi\right)+\mathcal{O}(1)$.

Then, (8.9) immediately follows from (8.24)-(8.25).
