# Path integral approach to eikonal and next-to-eikonal exponentiation

A bst ract: W e approach the issue of exponentiation of soft gauge boson corrections to scattering am plitudes from a path integral point of view. W e show that if one represents the am plitude as a rst quantized path integral in a m ixed coordinatem om entum space representation, a charged particle interacting w ith a soft gauge eld is represented as a W irson line for a sem i-in nite line segm ent, together with calculable uctuations. C om bining such line segm ents, we show that exponentiation in an abelian eld theory follow s im mediately from standard path-integral combinatorics. In the non-abelian case, we consider color singlet hard interactions w ith tw o outgoing extemallines, and obtain a new view point for exponentiation in term $s$ of $\backslash w e b s "$, w ith a closed form solution for their corresponding color factors. W e investigate and clarify the structure of next-to-eikonal corrections.

## 1. Introduction

H igher order corrections arising from soft gauge bosons in perturbative gauge theory, be they real or virtual, have been the sub ject of $m$ any investigations. Such radiation generically leads to series of perturbative contributions to di erential cross-sections of the form
${ }^{n} \log ^{m}(\mathrm{I}=$, where is the coupling constant of the gauge theory, and is related to the energy carried aw ay by the soft particles. In the soft lim it ! 0 (in which the eikonal approxim ation $m$ ay be taken), it becom es necessary to resum these term $s$ to all orders in perturbation theory, as has been achieved by a variety of $m$ ethods $[1,2,3,4,5,6,7,8]$. C entral to resum $m$ ation is the exponentiation of eikonalized soft gauge boson corrections and it has been show $n$ for both abelian and non-abelian gauge theory that this indeed occurs $[9,10,11,12]$.

To form an exponential series for a cross-section, both the $m$ atrix elem ent and the phase spacem ust exhibit an appropriate factorized structure. $T$ he statem ent for the $m$ atrix

elem ents rests upon a thorough analysis of the general structure of higher order diagram s. The result for an am plitude A in abelian gauge theory is sim ply expressed in the eikonal approxim ation as

where A is the am plitude w thout soft radiation containing a num ber of hard outgoing extemal lines, and the sum in the exponent is over connected diagram $s G_{c}$ between the extemal lines, w th the Bom contribution $A_{0}$ factored out. Exam ples are show $n$ for the case of hard production of a particle-antiparticle pair in gure 1. The non-abelian case is com plicated by the nontrivial color structure of the Feynm an diagram s at successive orders in perturbation theory. N evertheless, in the case oftwo extemal lines ${ }^{1}$, exponentiation still holds provided one generalizes Eq. (1.1) to

Here W are so-called webs, and are diagram s which are tw o-eikonal irreducible. That is, one cannot partition $a$ web into webs of low er order by cutting both extemal lines exactly once $[10,11,12]^{2}$. Exam ples are show $n$ in gure 2 . Each web has an associated color factor $C_{W}$ which is not the same as the nom al color factor $C_{W}$ associated with the web graph. The color factors $C_{W}$ are given in term $s$ of $C_{W}$ by an iterative relation to all orders in perturbation theory.

The nature of Eq.(1.1) in term $s$ of disconnected diagram $s$ is rem in iscent of another well-known property of quantum eld theory, nam ely the exponentiation of disconnected Feynm an diagram $s$ in term sof connected ones. This latter property $m$ ost naturally em erges

[^0]using path integralm ethods (see appendix A for a brief proof), and thus the suggestion arises of whether it is possible to relate the exponentiation of soft radiative corrections to the gauge theory path integral. The aim of this paper is to show that this is indeed the case, and the result is im portant for a num ber of reasons. Firstly, it provides a new perspective on exponentiation. Secondly, it allow s one to straightforw ardly explore whidh properties ofexponentiation survive at next-to-eikonallim it and beyond (i.e. corresponding to subleading term $s$ in $a b o v e)^{3}$. A though at next-to-eikonal order ferm ion em issions also contribute (leading to avor-changing e ects), we restrict ourselves here to ghon em issions.

The essential idea of our approach is as follow s. O ne rst relates the eld theory path integral for a particle interacting w ith a gauge eld to a rst-quantized path integral w ith respect to the particle. T hat is, the extemal lines becom ew orldlines of particles in quantum $m$ echanics (rather than quantum eld theory). H ere we utilize the techniques of $[14,15,16]$ which have originally been applied in a di erent context (that of constructing string theoreticalanalogues of xed order eld theory am plitudes [17,18]). A rst-quantized approach to Sudakov resum $m$ ation has also appeared in [19]. W e w ill see explicitly that in this representation the eikonal lim it corresponds to the radiating particles $m$ oving classically, and next-to-eikonal term s originate from uctuations around the classical path. T he soft radiation em ission vertices can then be intenpreted as interactions of the gauge eld with a source, such that individualem ission vertices form disconnected diagram s . Then exponentiation of eikonal corrections follow s naturally from usual com binatoric properties of the path integral.

In the non-abelian case, exponentiation is com plicated by the fact that vertiges for the em issions of ghons do not com m ute. H ow ever, one can rephrase the problem using the replica trick of statistical physics (see e.g. [20]), such that a subset of diagram s arises whidh exponentiate. These are then precisely the webs of [10, 11]. Furtherm ore, we provide an explicit closed form solution for the m odi ed color factors, given in term $s$ of norm al (rather than m odi ed) color weights.

O ur form alism allow s one to straightforw ardly consider subleading e ects $w$ th respect to the eikonal lim 五, and we classify the possible next-to-eikonal corrections. This can be divided into a subset which exponentiate (involving NE generalizations of the webs discussed above), and a set of rem ainder term $s$ which do not form ally exponentiate, but have an iterative structure in that each order of the perturbation expansion is su cient to generate the next order.

Earlier attem pts to inchude certain sub-eikonale ects w ere done in practicalim plem entations of Sudakov resum $m$ ation, $m$ ostly in view of gauging the theoretical uncertainty of the resum $m$ ation [21]. Typically, this involved including subleading term $s$ in the collinear evolution kemel in the resum $m$ ation, which is particularly appealing for D rell- Y an, H iggs production and related cross sections [21, $22,23,24,25,26]$. M ore recently a study was perform ed [27] based on a proposal in Ref. [28].

In the rest of this introduction we review the derivation of the path-integral representation of propagators in quantum eld theory, forboth scalar and spinor particles and in the

presence and absence of an abelian gauge eld. These results $w$ ill be used in section 2 to dem onstrate the exponentiation of soft radiative corrections in the presence of an abelian gauge eld. W e also consider generalization of the results to beyond the eikonal lim it, and classify the resulting corrections into a subset which exponentiate and a rem ainder term which $m$ ixes w ith these at next-to-eikonal order. In section 3 we consider the extension to non-abelian gauge elds, recovering the properties of $w$ ebs and again exam in ing corrections to the eikonal lim it. W e conclude in section 4, and som e technical details are presented in the appendiaes.

### 1.1 P ropagators as rst quantized path integrals

Throughout this paper we will be concemed with extemal lines, nam ely hard extemal particles susceptible to soft radiation em ission. A given extemal line is created from a hard interaction process at tim et $=0$ at space-tim e point $x_{i}$, and and has a $m$ om entum $\mathrm{p}_{\mathrm{f}}$ at some naltime T ! 1 (see gure 3). Soft radiation corrections enter the twopoint function for the em ilting particle i.e. the propagator for the extemal line. In the follow ing subsections, we review the representation of eld theory propagators in term s of rst quantized path integrals $[14,15,16]$, which will later on be used in the derivation of $m$ atrix elem ent exponentiation at eikonal order and beyond. W e begin $w$ ith the sim plest case, that of a free scalar particle.

### 1.1.1 Free scalar particle

T he propagator for a free scalar particle betw een 4-positions $x$ and $y$ is the $G$ reen's function for the $K$ lein-G ordon equation

where S; $F$ are $H$ erm itian operators working on the $H$ ilbert space $H$ of square integrable functions of space-tim e, and we adopt the standard Feynm an i" prescription. N ote that we are using the $m$ etric ( $;+$;+;+). Schem atically the propagator $m$ ay be w ritten as

where the inverse operator can be de ned via an inverse Fourier transform from m om entum space. T he usual representation then reads

where the i" now ensures the convergence of the integral. The integrand contains the exponential $(T)=e^{i \frac{1}{2} S T}$, which is a unitary operator acting on the $H$ ilbent space $H$ and satisfying the Schrodinger equation

$W$ e can therefore interpret $\hat{H}$ as the $H$ am iltonian operator of a quantum system, with intemal tim e coordinate T. G iven we are considering extemal lines as shown in gure 3, we m ust calculate the expectation value of the evolution operator $U$ betw een a state of de nite position (at timet=0) and de nite momentum (at timet=T).To do this we introduce states jxi and ji in the H ilbert space H , and w rite the H am iltonian as

N ote we have expressed $\hat{H}$ in $W$ eyl ordered form, w ith all $m$ om entum operators to the left of position operators. O ne then nds, for $s m$ all tim e separations $t$

where $H(p ; x)$ is the c-num ber obtained by replacing the operators on the right-hand-side of Eq. (1.8) w ith their corresponding variables. $W$ e have absorbed factors of 2 into the $m$ easure, and $m$ ade the boundary conditions explicit. $T$ his is the well-know $n$ path-integral result for the evolution operator sandw idhed
betw een initialand nalposition states, w ith an additionalterm in the exponent involving $p(T) x(T)$ arising from considering a nal state of given $m$ om entum, rather than position. For the present case of a free $m$ assive scalar, the $H$ am iltonian function is given by

O ne can now perform the path integral as the continuum lim it of a product of $G$ aussian integrals in the interm ediate position and $m$ om entum variables. $T$ he $m$ easure is such that this gives unity, and one therefore nds

in agreem ent w ith Eq. (1.5). H aving reviewed the relationship betw een propagators and path integrals in a sim ple case, we now consider the extension to a scalar particle interacting with a gauge eld.
1.2 Scalar particle in an abelian background gauge eld

W e consider a charged scalar particle in an abelian background gauge eld. Such a system is described by the generating functional

$T$ his di ens from the free particle case due to the presence of the gauge eld in the exponent. W hen the strength of the gauge eld is weak, the classical path of the em itting particle is well approxim ated by the free particle solution of Eq. (1.14) ${ }^{4}$. O ne then nds

### 1.3 Spinor particle

W e now consider the case of an em 䜣ing ferm ion in the presence of a background gauge eld. T he system is described by the generating functional

where $=\frac{i}{4}[$; $]$ are the generators of the Lorentz group, and $F$ is the eld strength tensor for the gauge eld. C arrying out the path integralm anipulations as in the scalar case yields

The representation (128) is am ost identical to the case of a scalar eikonal line, apart from the coupling to the eld strength tensor. This is not surprising, as it is well known $[14,29]$ that one can cast ferm ion actions into a second-order form that gives rise to scalar-like vertices supplem ented by additionalseagullvertioes involving couplings to the eld strength (see e.g. [30,31]). T he latter correspond physically to them agnetic $m$ om ent of the spinning em itting particle, and thus have no analogue in the scalar case.

In this introduction, we have review ed the representation of particle propagators, including the possible presence of an abelian background gauge eld, as rst-quantized path integrals. The phase space variables $x$ and $p$ correspond to the position and $m$ om entum of the em itting particle, and the classical path is interpreted as an eikonal line. In the follow ing section we form alize these statem ents, and show how the above representations can be used to derive the exponentiation of soft radiative corrections.

## 2. Soft em issions in scattering processes

W e now tum to the description of soft radiation from extemal lines, considering $G$ reen's functions having the form shown schem atically in gure 4, and consisting of a hard interaction $H\left(x_{1} ;::: ; x_{n}\right)$ w th extemal lines em erging at positions $\mathrm{fx}_{\mathrm{i}} \mathrm{g}$. This is a sum of subdiagram $s$ containing gauge boson $m$ odes of as yet unspeci ed $m$ om entum. Each extemal line has a propagator associated with it sum $m$ ing the e ect of soft gauge boson em ission, and we call such diagram s eikonally factorized.

This is based upon the general analysis of [32], which characterizes the regions of infrared sensitivity in Feynm an diagram s in a num ber of scattering processes. The proofthat soft radiation contributions exponentiate now am ounts to show ing tw o things. F irstly, that for the eikonally factorized diagram s de ned above (and shown in Fig. 4), the contributions from soft radiation on the outgoing extemal lines exponentiates. Secondly, that all leading soft radiation term s originate from diagram s having this factorized structure. In this paper, we prove the rst property and assum e that the second indeed holds, as has been show n to be the case elsew here at eikonal level. W e retum to the issue of corrections to the above factorized form (at NE level) in Sec.2.4.

To m ake these statem ents $m$ ore direct, we begin by separating the path integral over the gauge boson eld into a product of integrals over hard and soft $m$ odes

(2.5), where H is a hard interaction w ith n outgoing extemal lines, and $S$ is a propagator for the eikonalparticle in the presence of the background soft gauge eld which, after the path integral over $A_{s}$, generates connections betw een the extemal lines.

The precise de nition of $A_{s}$ and $A_{h}$ am ounts to specifying a surface in the multi-boson m om entum space that separates it into tw o distinct regions corresponding to soft and hard m odes. Such a surface is, in general, very com plicated [32]. Its precise de nition does not concem us in what follow $s$, where we characterize soft radiation by the fact that one $m$ ay neglect the recoil of the eikonal particles ${ }^{6}$. H ow ever, the fact that such a surface exists allow s us to introduce the factorization of Eq. (2.1), given that the path integral is a product of integrals over gauge elds of de nite $m$ om entum .

The above separation is not gauge invariant, which can be easily seen as follow s. C onsider a given soft gauge eld $\mathrm{A}_{s}$, whose m om entum m odes live only in the soft region of $m$ om entum space. A general gauge transform ation has the form

where a propagator factor has been associated w ith each extemal line, and the path integral over $A_{s}$ inserted. $T$ his latter integral does tw o things. Firstly, it generates all possible subgraphs w ithin the hard interaction $H$ (ie. such that there are $n$ extemal lines em erging at $4-$ positions $f x_{i} 9$ ), containing both soft and hard gauge boson m odes. Secondly, it produces soft radiation, both real and virtual, from the extemal lines. This is show $n$ schem atically in gure 4, where real and soft radiation is included in the soft blobs attached to each external line. O ne thus sees that $G$ is a full $G$ reen's function of the theory, w ritten in eikonally factorized form. N ote that the propagator for the em itting particle in the presence of the background soft gauge eld is rem oved in Eq. (2.4), and replaced in Eq. (2.5) w th the propagator sandw iched betw een states of given initial position and nalm om entum.

To obtain the contribution to the scattering am plitude from the function $G\left(p_{1} ;::: ; p_{n}\right)$, one m ust truncate each extemal propagator. That is, for extemal leg i one multiplies by a factor $p_{i}^{2}+m^{2}$ to take account of the fact that the line is extemal and thus has no (free) propagator attached. In principle one $m$ ust also divide by the residue of the scalar propagator, arising from renom alization of the scalar eld. H ow ever, this residue is unity due to the absence of self-interactions for the eikonal particle, and also the fact that the gauge eld is treated as a background. As is clear from Eq. (2.5), one $m$ ay treat each extemal line separately. U sing the representation (121), one can rew rite each extemal line contribution as

### 2.1 E ikonal exponentiation

N ow that we have established that in the eikonal approxim ation the soft radiation is described by a W ilson line we can analyze what happens in pertunbation theory. Let us consider, w ithout loss of generality, an extemal line created at $x_{i}=0$ and in direction $\mathrm{n} \quad \mathrm{p}_{\mathrm{f}}$. Then Eq. (2.10) becom es

connect the extemal lines given that the source vertioes lie along the latter. T he collection of all diagram s exponentiates in term s of connected diagram s.

To illustrate this further, consider the case of a hard interaction with two outgoing eikonal lines, an exam ple of which is shown in gure 1. There one sees a num ber of connected subdiagram s connecting the extemal lines. O ne also nds disconnected diagram s, such as that show n in gure 5. H ow ever, given the usual property of exponentiation of disconnected diagram s in quantum eld theory, one has:

W e have thus succeeded in show ing that the exp onentiation of soft radiative corrections in the eikonal lim it can be related to the exponentiation of disconnected diagram s . We now consider what happens when next-to-eikonal corrections are considered.

### 2.2 N ext-to-eikonal exponentiation

The analysis of the previous section relied on the fact that the factors $f(1)$ describing soft radiation from the extemal lines are written as path integrals in $x$. This allowed the straightforw ard interpretation of the eikonal lim it as the lim it in which the em itting particle fillow s a classical free path. H ow ever, th is identi cation also allow s one to go easily beyond the eikonal approxim ation. If the em itted radiation is soft but w ith non-negligible $m$ om entum, the classical path is still a good approxim ation to the equations of $m$ otion for the eikonal particle, and one can exam ine deviations from the straight-line path in a system atic expansion. G iven that this does not a ect the interpretation of gauge boson em ission vertioes in term s of disconnected subdiagram s , one still expects such corrections to exponentiate.

To form alize this argum ent, we reconsider the extemal line given by Eq. (1.14), where again we take $x_{i}=0$ without loss of generality. $G$ iven that the extemal eikonal particles have light-like $m$ om enta, one $m$ ay write $p_{j}=n_{j}$, where $n_{j}^{2}=0$. Then Eq. (2.8) becom es

O ne now clearly sees that in the lim it ! 1 , one $m$ ay neglect all term $s$ involving $x, \underline{x}$ and @ A, leaving precisely the eikonal approxim ation discussed in the previous section. That is, uctuations about the classical free path are suppressed by inverse powers of . By expanding in , one keeps the rst subleading corrections to the eikonalapproxim ation, i.e. corresponding to the next-to-eikonal (NE) lim it.

For subsequent punposes it is $m$ ore conven ient to rescale the tim e variable $t!t=$,so that Eq. $(2.15)$ becom es

Firstly, NE graphs m ust have at m ost one propagator for the em itting particle $x(t)$, due to its being $O\left({ }^{1}\right)$ as rem arked above. There is also a NE vertex originating from the term in @ A, and a given NE graph containing such a vertex must then contain no propagator factors for $x(t)$. W e exam ine in detail the $N E$ Feynm an rules that result from Eq. (2.16) in appendix B, and show that they agree w ith the results one obtains in standard perturbation theory after expanding to NE order. T he advantage of the above representation, how ever, is that exponentiation of these corrections is $m$ anifest.

### 2.3 Exponentiation for spinor particles

W e have so far only considered the case of a scalar eikonal particle. For em itting ferm ions (w th a sim ilar expression for com binations of ferm ions and antiferm ions etc.), we w rite the de nition of the hard interaction as

N ote that, due to suppression by , the additional vertex is indeed of NE order, as expected given that in the strict eikonal lim 五, radiation is insensitive to the spin of the em itting particle.

O nem ay w orry about ordering ofD irac $m$ atrices w hen the exponential of Eq. (2.19) is expanded. H ow ever, this is not an issue due to the fact that the $m$ agnetic $m$ om ent vertex is NE and thus occurs in each diagram only once at this order.

T he preceding analysis has shown that in eikonally factorized G reen's functions, soft gauge boson corrections exponentiate up to NE order. This is not yet a proof that such corrections exponentiate in $m$ atrix elem ents them selves, whidh include $G$ reen's functions not having an eikonally factorized structure. At strictly eikonal level (as is well known),
 NE order, how ever, contributions arise from diagram $s$ in which a soft em ission connects an extemal line w ith the hard interaction. $T$ his is the sub ject of the follow ing section .

### 2.4 Low's theorem

In the previous section we have dem onstrated exponentiation for next-to-eikonal photon em issions from extemal lines. T hat is, the exponentiation holds for scattering am plitudes having the eikonally factorized form of gure 4. H ow ever, at NE order there are also corrections to the exponentiation arising from soft gluon em issions which land on an extemal line, having originated from inside the hard interaction. A given $m$ atrix elem ent then has the schem atic form (up to next-to-eikonal level) :

In what follow S , we refer to em issions from w thin the hard interaction as intemal em issions, and those originating from extemal lines as extemal. D iagram swith intemal em issions have been studied before in the literature. It has been shown for a xed num ber of scalar extemal

lines that, up to NE order, the sum of diagram scontaining a soft em ission (intemal or extemal) can be related to the scattering am plitude with no em issions [33]. This result is known as Low's theorem, and was generalized to the case of spinor extemal lines in [34], an extension known as the Low Bumett-K roll theorem . Generalization to higher orders was considered in [35]. The fact that graphs with an extra em ission can be related sim ply to those w ithout an em ission $m$ eans that, although the rem ainder term does not have a form al exponential structure, it has an iterative form to all orders in pertunbation theory. In this section we discuss these properties in the path integral form alism adopted in this paper, in order to com plete our discussion of NE exponentiation. This also allow sfor a generalization of the ideas presented in [33, 34, 35].

O ur starting point is the expression for the $n$-particle scattering am plitude (see also Eq. (2.9))

Both $H$ and the $f$ 's depend on the soft gauge eld A. As discussed in section 2, the separation between soft and hard gauge $m$ odes leaves a residual gauge invariance, given
by the usual form of Eq. (2 2), but where the function (x) has only soft modes when transform ed to $m$ om entum space. It is im plicitly assum ed that this in the case in the follow ing. U nder such a transform ation, the extemal line factors transform as

Taking this into account also leads to corrections of NE order (and beyond), which enter the above rem ainder term $M \mathrm{r}$. To see this, we w rite the eikonal one-photon source term as:

Som e com ments are in order regarding the form and interpretation of this result. The extemal line factors $\mathrm{f}\left(0 ; \mathrm{p}_{i} ; \mathrm{A}\right)$ contain exponentiated eikonal and NE term s , as discussed previously. C orrections to the N E exponentiation then arise due to the bracketed prefactor in Eq. (2.33), which contains a sum over di erent possible NE corrections. Such corrections contribute to the rem ainder term $M \mathrm{r}$ in Eq. (2.20), and do not exponentiate. H ow ever, Eq. (2.33) shows that they can be obtained as derivatives of the hard interaction w ith no soft em issions. Thus, the rem ainder term has an iterative structure to all orders in perturbation theory.

For scattering am plitudes, one $m$ ay sum $m$ arize this as follow $s$. Leading eikonal logarithm $s$ arising from soft ghon em ission exponentiate. NE logarithm s do not exponentiate,
but can be separated into the sum of a series which does exponentiate, and a rem ainder sum which does not exponentiate, but is obtainable in principle to allorders in the coupling constant.

To further clarify the above form ulae, it is instructive to consider the case where the hard interaction $H$ is a scalar. Then it can only depend on Lorentz invariant products of m om enta. T he derivatives w ith respect to the 4 m om enta in Eq. (2.33) can be reexpressed in term s of derivatives $w$ ith respect to products of 4 -vectors (corresponding to $M$ andelstam invariants in the hard scattering process). O ne m ay verify that derivatives $w$ r.t. $p_{i}^{2}$ vanish, and in the case of tw o extemal lines $(n=2)$ there is only one scalar $p_{1} \quad$ p. Eq. (2.33) then becom es

$T$ his is precisely the form one expects based on a conventionalFeynm an diagram treatm ent (see appendix C), and one m ay interpret the bracketed factor in Eq. (2.34) as an extra vertex describing soft em ission from w ithin the hard interaction.

## 3. N on-abelian gauge theory

So far we have considered an abelian background gauge eld. In the case where the gauge eld is non-abelian, the derivation of the scattering am plikude for eikonally factorized diagram sproceeds sim ilarly to Sec. 2 . H ere we consider the sim ple case of hard interaction w ith two outgoing extemal lines. T hat is, the analogue of Eq. (2.9) can be w ritten

i.e. sim ilar to before, but $m$ atrix-valued in color space due to the exponent being linear in the non-abelian gauge eld $A=A_{A} t^{A}$, where $t^{A}$ is a generator of the gauge group. Furtherm ore, there is a path ordering of the color $m$ atriges along the extemal line. As before, the extemal line factors act as source term $s$ for the soft gauge eld when the path integral over $A_{s}$ is perform ed. H ow ever, it is no longer im m ediately clear that the soft corrections exponentiate. In the abelian case, the exponentiation of soft gauge boson corrections was identi ed w ith the exponentiation of disconnected diagram s betw een sources. C rucial to the com binatorics of this result is the fact that in the abelian case, the source
term $s$ com $m$ ute w ith each other. This is no longer true in the non-abelian case, due to the $m$ atrix valued nature of the source term $s$, and also the path ordering of the exponential in Eq. (3 2). W e will see, how ever, that it is still possible to address exponentiation in the non-abelian case, by rephrasing the problem using the replica trick of statistical physics (see appendix A for another application i.e. the proofof the exponentiation ofdisconnected diagram $s$ in eld theory). O ne can then w rite the scattering am plitude in a form such that extra structure em erges in the exponent, whereby the contraction of soft ghon em issions betw een eikonal lines gives rise to a exponentiating subset of diagram s. These can then be identi ed w ith the webs of $[11,10]$.

To sim plify the discussion, we rst restrict ourselves to the strict eikonal lim it. Furtherm ore, we consider the case of a hard interaction w ith the color singlet structure

Such a structure arises in interactions where e.g. an incom ing color singlet particle gives rise to the pair production of tw o hard nal charged scalars (the scalar analogue of $e^{+} e$ pair production by a virtual photon), as shown in gure 2. Given that, up to the NE corrections discussed in section 2.4, one $m$ ay consider the extemal lines as being created at $x=0$, one $m$ ay take the hard interaction outside the path integral over $A_{s}$ in Eq. (3.1) to obtain (in this case)

$T$ he physical interpretation of this quantity is as follows. The extemal line factors, as in the abelian case, contain sources for the gauge eld. In this case, they generate diagram s containing any $m$ ixture of the $N$ replica gauge elds, which span the extemal lines of the hard interaction (w hich in this case have becom e a single extemal line). E ach of the vertioes for the em ission of a gauge eld replica has a non-trivial color structure, such that neither the extemal factors $f^{(i)}$ nor the vertiges they give rise to com $m$ ute. H ow ever, by de nition one has:

C rucially, we will nd that not all diagram $s$ in the theory have term $s$ of $O(\mathbb{N})$, so one recovers the property of exponentiation of soft radiative corrections in term $s$ of a subset of diagram $s w$ ith certain properties. The diagram $s$ in this case $w$ ill still contain replica elds. H ow ever, given that the gauge group of the replicated theory is the sam e as that in the standard theory, it m ust be true that the color structures of the subdiagram s which exponentiate are the sam e in the two theories.

W e now describe how to isolate the term linear in N in Eq. (3.12). The product of extemal line factors has the form :

w ith obvious generalization to higher num bers of operators. T hat is, R orders any product ofm atrix-valued elds into a sequence of increasing replica num ber. N ote that the resulting product is no longer strictly tim e ordered, although the $m$ atrix elds of any given replica num ber rem ain tim e ordered.

A s before (and by analogy w ith conventional Feynm an perturbation theory for nonAbelian gauge elds), the single exponent in Eq. (3.17) acts as a collection of sources for the soft gauge eld. The path integration over the soft gauge eld generates diagram s containing m ultiple replica em issions along the eikonal line, where the replica num bers are not necessarily ordered along the line (see gure 7). H ow ever, the expression for a given diagram, as dictated by the source term s arising from Eq. (3.16), involves replica ordered products of operators, each of which involves a color m atrix. Thus, the color structure associated w ith each diagram is not the sam e as that which would result from conventional perturbation theory, but rather that associated w ith the given replica-ordered product of $m$ atrix-valued elds. The subset of diagram $s$ which exponentiates then has a m odi ed color structure, as is known to be the case for webs [10, 11, 12]. To see which diagram s W actually contribute in Eq. (3.14), one m ust consider contracting ghons em itted from tw o or $m$ ore vertiges. G iven that the gauge eld replicas do not interact $w$ ith each other (i.e. are only tangled through color structure), one can clearly only contract gluons which have the sam e replica num ber i and adjoint color index A. H ere we consider this up to O ( $A^{4}$ ) in the scattering am plitude (i.e. up to two gluon lines). Firstly, we need only consider contributions from vertices on di erent segm ents of the combined $W$ ilson line $x(t)$, as those on the sam e segm ent ultim ately give contributions proportional to (at least in covariant gauges) $p_{1}^{2}=0$ or $p_{2}^{2}=0$. A lso, each diagram has a multitude of sim ilar diagram s obtained by perm uting the replica labels. The operator $R$ for each diagram orders the color $m$ atrices in the form

H ence, the color factor of a com plete diagram in the replica ordered perturbation theory is the product of the individual color factors associated w th the subdiagram $s$ form ed from each replica separately. Furtherm ore, the ordering of the factors in Eq. (3.18) is unim portant, so that the color factors associated $w$ ith the set of diagram $s$ obtained from a given diagram m erely by perm uting replica num bers are the same. There are ${ }_{N} \mathrm{P}_{\mathrm{m}}=$ $\mathrm{N}!(\mathbb{N} \quad \mathrm{m})$ ! such perm utations, where $m$ is the num ber of di erent replica species present in the diagram.

For one ghon em ission, there is only one possible diagram, shown in gure 8 (a). There is a sum over the replica num ber of the exchanged ghon, so that this diagram is clearly proportional to $N$, denoting a color structure that exponentiates. The color factor of th is diagram is

The above discussion can be sum $m$ arized as follows. Up to two ghon em issions, a subset of diagram s exponentiates. N am ely, the one ghoon em ission diagram of F ig. 8 (a), and the crossed ghon diagram of $F$ ig. 8 (c). Fig. 8 (b) does not contribute due to being $O\left(\mathbb{N}^{2}\right)$, and $F$ ig. 8 (c) has a color factor which di ens from that of conventionalperturbation theory, and indeed is precisely the m odi ed color factor associated w ith the know $n$ webs of $[10,11,12]$.
$N$ ote at this order in $s$ one also has diagram $s$ containing ghon self-interactions, of which there are two possibilities, show n in $F i g$. 9. T here are $N$ such diagram $s$ in each case, so that they also exponentiate (i.e. are webs) w ith a color factor equal to the ordinary one.

W e now consider the generalization of the above rem arks to higher orders in perturbation theory. T he subdiagram swhich exponentiate can be characterized by the fact that they are two-eikonal irreducible. That is, one cannot disconnect each diagram by cutting eikonal lines in two places. This property is well-known $[11,10]$, but we prove it in the follow ing using the $m$ ethods outlined above.

C onsider the general tw o-eikonal reducible diagram shown in $F$ ig. 10 (where each of the subdiagram scould itself be reducible). W e focus on a given gauge boson replica i in subdiagram H in Fig. 10, and consider rst the case where subdiagram $G$ contains no gauge bosons w ith replica num ber i. A ccording to the Feynm an nules of the replica-ordered perturbation theory described above, the diagram offig. 10 then gives a color factor
 contraction factor for replica i introduced above. T hat is, $\quad C$ ( $j$ ) contains the results of all contractions in $G$ as well as those of $H$ that do not involve replica num ber i. T he indices $f A_{k} g$ and $f B_{k} g$ denote em issions from the low er and upper eikonal lines respectively. N ow consider the case where $G$ as well as H contains em issions w ith replica number i. T hen (due to the reducible structure) one can write $K_{i}$ as a product of factors $S_{G_{i}}, S_{H_{i}}$ for each subdiagram, so that the color factor associated with Fig. 10 is

For each subdiagram this is at least / N , such that the contribution from diagram swhich are tw o-eikonal reducible is at least/ $\mathrm{N}^{2}$ (in general, $/ N^{M}$, where $M$ is the num ber of disconnected subdiagram s). Thus, tw o-eikonal reducible diagram s do not exponentiate.

In fact, one can proceed further and obtain a general solution for the color factors of the diagram s to all orders. C onsider a given diagram consisting of $n_{c}$ connected pieces (i.e. ghons connected by self interactions or ferm ion bubbles). For each such diagram, we then consider the set fP $g$ of partitions. These are sets containing a num ber $n(P)$ of subgraphs g, each of which contains only one replica (see Fig. 11). Perm uting the replica num bers (but keeping the subgraphs $g$ intact) corresponds to the sam e partition (see $F i g .12$ ), such that there $\operatorname{are}_{\mathrm{N}} \mathrm{P}_{\mathrm{n}(\mathbb{P})}$ distinct diagram s in each partition, each of which has the sam e color factor

where C ( g ) is the color factor associated w ith subgraph g . The total color factor of the com plete diagram is now given by

i.e. one sum s over allpossible partitions, each ofw hich has a color factor given by Eq. (3.30), and weighted by the num ber of diagram s represented by each partition. T he only dependence on the replica num ber resides in the factor ${ }_{N} P_{n(P)}$, which has the form

$T$ he bar on the left hand side denotes the fact that this is the m odi ed color factor associated w ith G, rather than the color factor one w ould obtain in conventional perturbation theory (i.e. w thout the R operator). T he color factors on the right hand side, $\mathrm{C}(\mathrm{g})$, are the ordinary color factors associated w th each replica subgraph g. Eq. (3.33) is a closed form solution for the modi ed color factor associated $w$ ith any given diagram, in that m odi ed color factors only appear on the left-hand side. It has the property, as it must do from the above considerations, of being zero if $G$ is not a web. As a simple example (already encountered above), consider the diagram of $F i g .8$ (c). There are two possible partitions. E ther the two ghons have the sam e replica num ber, i.e. one subgraph w th

color factor C ( ) , or they have di erent color factors i.e. tw o subgraphs w ith total color factor C ()C (). T hen Eq. (3.33) gives a totalm odi ed color factor

To further clarify the discussion, we consider here a pair of three loop exam ples. W e consider rst the diagram represented in the above shorthand notation by . From Eq. (3.33), one has schem atically

Reducibility im plies $C(X)=C() C(X)$, and thus $C(X)=0$, as expected for a non web.
To sum $m$ arize, the above replica tridk has allow ed us to determ ine the subset of diagram swhich exponentiate in non-abelian theory i.e. the diagram $s$ which exponentiate are those which have a term linear in the number of replicas N. This is related to the original gauge theory (w ith no replicas) as follow s. Firstly, the replica gluons all have the sam e self-interactions and scalar-ghon interactions, but do not interact with each other.

Thus in any diagram one can replace replica ghons w ith originalghons to yield the sam e kinem atic result. T hen the color w eights of the exponentiating diagram s are precisely those found above i.e. $m$ odi ed w ith respect to the original theory. T he structure of tw o-eikonal irreducible diagram s w ith m odi ed color factors is precisely that of web exponentiation, described in [11, 13].

T he above discussion proceeds sim ilarly in the case of ferm ionic em itting particles, given that the gauge boson em ission vertices which distinguish scalar from ferm ion em itters only appear at NE order. W e discuss subleading corrections in the next section.

### 3.1 N on-abelian exponentiation at N E order

T he signi cance of the above derivation of web exponentiation in term sof the path integral $m$ ethod is that one $m$ ay then easily extend the analysis to $N E$ order, using the -scaling technique discussed in section 2.2 . W e have already show $n$ that a subset of $\mathrm{N} E$ corrections exponentiate in the abelian case, and that eikonal corrections in the non-abelian case exponentiate. $T$ hus, it is not surprising that a subset ofnon-abelian NE term sexponentiates.

In this section we again consider the sim ple case of two extemal lines em erging from a hard interaction which has a color singlet structure. T hen the scattering am plitude factorizes as in Eq. (3.10), but w here the extemal line factor is given by

$H$ ere we have explicitly factored out colorm atrices from the non-abelian gauge elds. N ote that path ordering (i.e. tim e ordering in this case) has appeared in som e of the term $s$ in the exponent, due to the function occurring in the correlators of Eq. (B.18). There are two types of vertex occurring in Eq. (3.39) - those that depend on a single tim e (in the rst two lines), and those that depend on two di erent tim es (in the third and fourth lines). O f the form er type, there are one ghon vertioes and a tw o ghon vertex. For these vertioes, the argum ents of the previous section (involving the replica tridk) carry forw ard $w$ ith $m$ inim alm odi cation, and one has eikonal exponentiation up to $N E$ webs, where each NE vertex m ust occur only once per diagram. Theadditionalw ebs that appear at tw o ghon order are shown in gure 13. At higher orders, the NE webs again have the property of being tw o-extemal-line irreducible. The tim e ordered vertioes in the third line ofE q. (3 39) generate diagram s such as those shown in gure 14, which involve correlated em issions from di erent positions on the extemal line, but where additional eikonal em issions may occur in betw een. O ne m ust then sum over all possible correlations (pains of ghons). T here are

two types of such diagram s. Firstly, diagram swhose structure is such that they form a web at eikonal level (i.e. are two-eikonal irreducible in that case). The tim e ordered vertices then im plem ent correlations betw een pairs of ghons in the sam eweb. Secondly, one has diagram $s$ that would be tw o-eikonal reducible at eikonal level (ie. are a product of webs), but which becom e irreducible at NE level due to correlations betw een gluons in separate webs (e.g. Fig.14). The sum over all such diagram sthen enters the exponent ofEq. (3.14). To sum $m$ arize, the set of E corrections resulting from non-abelian gauge boson em ission outside of the hard interaction exponentiate. T he exponent involves a subset of diagram s , NE webs, som e of which are $m$ ore com plicated in structure than their eikonal equivalents. H ow ever, they still share the property of being tw o-extemal-line irreducible.

In the case of a spinor em itting particle, the additional vertex

B oth of these vertices depend on a single tim e, and thus are handled sim ilarly to those occurring in Eq. (3.39). N ote that the tw o-ghon vertex Eq. (3.42) has no abelian analogue, which can be seen from the fact that the com $m$ utator $\left.\mathbb{A}^{A} ; t^{B}\right]$ vanishes for an abelian gauge eld.

Som e com $m$ ents are in order regarding the color factors associated with the NE webs. W e note that the derivation of the form ula for m odi ed color factors in the eikonal case (Eq. (3.33)) is independent of the eikonal approxim ation. Thus, it also applies also in the NE case, where the color factors C ( $j$ ) associated with each subgraph involving replica num ber $j$ are the nom al color factors one obtains using the NE Feynm an rules.

The above discussion show s that, for the sim ple hard interaction considered above, a subset of corrections exponentiates up to NE order i.e. those associated with soft gauge
boson em ission outside the hard interaction. A s in the abelian case, one still has to w orry about corrections due to eikonal em issions from $w$ thin the hard interaction (which give rise to the rem ainder term in Eq. (2 20)). T his is the sub ject of the next section.

### 3.2 Internalem issions of non-abelian gauge elds

In the abelian case, we identi ed a subset of N E corrections which exponentiate (i.e. those arising from soft gauge boson em issions outside of the hard interaction). There were then rem ainder term $s$, which did not have an exponential structure but could be obtained iteratively to all orders in the perturbation expansion. Here we brie y discuss how this structure can be generalized to the case of a non-abelian gauge eld. As in the previous section, we consider the case where the $m$ atrix elem ent for the hard interaction $w$ th no intemalem issions has a color singlet structure, w ith two outgoing eikonal lines.
$W$ e begin $w$ th the non-abelian analogue of the abelian gauge transform ation law of Eq. (2 24), which is

$w$ here $g_{j}=+1$ for an eikonal particle, and 1 for an antiparticle. This has the sam e interpretation as in the abelian case i.e. the am plitude for an intemalem ission is related to the am plitudew ith no such em ission. In the non-abelian case, the am plitude for intemal em ission is proportional to the color m atrix $t^{A}$, as indeed it m ust be from group theory considerations (the quantity $H$ has one adjoint index and two fundam ental indices).

A s in the abelian case, Eq. (3.46) can be interpreted as an extra vertex for soft ghon em ission. This vertex is located on the $W$ ilson line at $t=0$ i.e. where the eikonal segm ents $\mathrm{x}_{1}$ and $\mathrm{x}_{2} \mathrm{~m}$ eet. $T$ here are term s (also by analogy w th the abelian case of Sec. 2.4) which correct for the fact that the extemal lines do not originate from $x=0$. H ow ever, these also take the form of an additional vertex localized at $t=0$. The diagram $s$ containing these additional vertioes do not necessarily exponentiate (as before), and form a rem ainder term analogously to that of Eq. (2 20).

Thus, the all-order structure ofm atrix elem ents up to NE order is conceptually equivalent to the abelian case. O ne has a subset of NE corrections which exponentiate (i.e. $N E$ webs), and a set of corrections which form a rem ainder term which $m$ ixes $w$ th the exponentiated NE corrections. The rem ainder term does not necessarily have a sim ple structure, but at least has an iterative structure due to the fact that diagram s w ith no intemal em ission are su cient to generate higher order diagram s involving an intemal em ission.

## 4. D iscussion

In this paper, we have considered the issue of soft gauge boson corrections for $m$ atrix ele$m$ ents in abelian and non-abelian gauge theories from a path integral point of view. This involves considering factorized diagram s involving hard interactions w ith a given num ber of extemal lines, each of which em its further soft radiation. $T$ he propagator for each extemal line can then be cast into a rst quantized path integral representation, where the integral is a sum over paths for the em itting particle. This path integral can be perform ed by expanding about the classical straight line path for the em itter, which corresponds to system atic corrections to the eikonal approxim ation. T he scattering am plitude then factorizes into a hard interaction plus factors for each extemal line which act as source term sfor the soft gauge eld $A_{s}$, where the sources are placed along the extemal lines. In the abelian case, exponentiation of eikonal corrections then follows from the usual exponentiation of disconnected diagram $s$ in quantum eld theory. Furthem ore, a subset of next-to-eikonal corrections can also be shown to exponentiate, and a set of e ective Feynm an rules for radiation in the NE lim it is obtained.

The case of a non-abelian gauge eld is m ore com plicated, but can be analyzed using the replica trick, in which one considens an ensemble of $N$ gauge elds. D iagram swhich have a term linear in N then exponentiate, and crucially only a subset of diagram s in the theory have such a property. We considered the sim ple case of two extemal lines, connected by a hard interaction with color singlet structure. Then the diagram swhich exponentiate contain sources arising from the replica ordered perturbation theory arising from Eq. (3.16). Those which contribute at $O(\mathbb{N})$ have the property ofbeing tw o-extemal line irreducible, and also have (in general) color factors which di er from those of the corresponding diagram $s$ in the original theory. T hese diagram s are then precisely the webs of $[11,13]$. As in the abelian case, a subset of $N E$ corrections also exponentiates, and the exponent contains a sum of webs up to NE level.

In both the abelian and non-abelian cases, there are NE corrections which do not exponentiate, and which form a rem ainder term such that the totalmatrix elem ent (up to NE order) has the form shown in Eq. (2 20). These term $s$ are associated w ith Low's theorem, and the relevant diagram $s$ involve contractions betw een eikonalphotons or ghons on the extemal lines, and a NE vertex localized at the cusp at which the outgoing eikonal lines $m$ eet. Furtherm ore, these term $s$ have an iterative structure in perturbation theory, in that the extra vertices that contribute can be related to diagram s at a low er order in the perturbation expansion.

A com $m$ ent is in order regarding the nature of $N E$ exponentiation. Up to NE order, Eq. (2 20) can be expanded to give

i.e. one m ay either consider the NE term s arising from eikonally factorized diagram s as being in the exponent, or kept to linear order. Thism asks the fact that the term $s$ in $M$ NE genuinely do exponentiate, whereas the rem ainder term $s$ in $M r$ do not. However, it is true that the exponentiated NE term s lead to NNE, NNNE etc. contributions which would then m ix w th higher order (in the eikonalexpansion) rem ainder term S . The exponentiated form of q . (4.1) is particularly usefulif the contribution from M NE (when exponentiated) gives the dom inant contribution to higher order term $s$ in the eikonal expansion. W hether or not this is the case is presum ably process dependent.

T he proof of exponentiation in the abelian case, as presented here, clearly generalizes to higher num bers ofeikonal lines. H ow ever, in the non-abelian case we considered only the sim plest possible hard interaction, nam ely that w th tw o extemal lines w ith a color singlet structure. This could be easily related to a single $W$ ilson line with a cusp. The general case of higher num bers of extemal lines is $m$ ore com plicated due to the color structures involved. N evertheless, the m ethods introduced in this paperm ay provide a usefulstarting point in addressing NE corrections in these situations.
$W$ e have only considered $m$ atrix elem ents in this paper. Thus, any exponentiation of NE corrections pertains only before any integration over the phase space of the nal state gauge bosons has been perform ed. In the strict eikonal approxim ation, the phase space factorizes into a product of single particle phase spaces (i.e. conservation of energy is a subleading e ect), thus exponentiation in them atrix elem ent im plies exponentiation of soft logarithm s in di erential (but partially integrated) cross-sections. This is not necessarily the case beyond the eikonal approxim ation, where one expects NE corrections resulting from the eikonal $m$ atrix elem ent $w$ ith integration over the full phase space. Na vely, one expects a given di erential cross-section (e.g. in som e variable related to the totalenergy fraction carried by soft ghons) to have the form
$H$ ere $M(\mathbb{E}, N E)$ denote the eikonal and next-to-eikonal $m$ atrix elem ents respectively, and $d P S{ }^{(E)}$ the eikonal phase space, consisting of a factorized product of one-particle phase spaces. The rst term in Eq. (4 2) is then of eikonal order, and the bracketed term is NE, where $d P S^{(N E)}$ represents that part of the $m$ ulti-ghuon phase space which im plem ents next-to-eikonal corrections (i.e. subleading term $s$ in ). The precise nature of this latter term is unclear, and an investigation of its e ect is deferred to a fiuture publication. N evertheless, all of the ingredients for the rst bracketed term in Eq. (42) are contained in this paper.

To conclude, the path integral m ethods used in this paper provide a new view point for the exponentiation of soft radiative corrections to $m$ atrix elem ents, in both abelian and non-abelian gauge theories. In particular, the discussion of webs is rephrased such that a
closed form solution for them odi ed color factors can be given. Furtherm ore, the approach naturally encom passes the exponentiation of classes of next-to-eikonal corrections. This approach should prove fruitful in the further investigation of soft radiative corrections to all orders in perturbation theory.

## A. Exponentiation of disconnected diagram s

H ere we brie y prove the exponentiation of disconnected diagram s in quantum eld theory, using the replica trick of statistical physics. A though we consider a single self-interacting scalar eld , the proof generalizes easily to other system s.

The G reen's functions of a given quantum eld theory are described by the generating functional

The Feynm an rules for each eld are sim ilar, and there are no interactions betw een the elds. Thus, there can be no m ore than one eld in each connected Feynm an diagram, and connected diagram s therefore have $N$ copies. By the sam e reasoning, disconnected diagram s containing $n \quad 2$ constituent parts have $N^{n}$ copies. It follow $s$ that

and sets $\mathrm{N}=1$. This is the statem ent that disconnected diagram s exponentiate, as required.
$T$ he above proof shortcuts the nontrivial com binatoric fact that the sym $m$ etry factor associated w ith a disconnected Feynm an graph is the product of the sym $m$ etry factors of each of the constituent connected graphs. T he results of this paper dem onstrate that the sam e com binatoric reasoning applies to the exponentiation of soft radiative corrections from fast-m oving extemal particles.

## B. N ext-to-eikonal Feynm an rules

In this appendix, we show how to derive e ective Feynm an rules for the eikonal and next-to-eikonal approxim ations in the path integral approach discussed in section 22 , and show explicitly that these agree $w$ th the rules one obtains by starting from exact perturbation theory before taking the NE lim it.

W e begin w the conventional perturbative approach, and consider the case of a charged scalar interacting w ith a background gauge eld. The theory and its $G$ reen functions are de ned via the generating functional

To do so, we shall take m $=0$ and use -scaling as discussed in section 2. That is, we consider an extemal particle of 4 m om entum $\mathrm{p}=\mathrm{n}$, and consider the lim it
! 1 . A s discussed in section 2, this corresponds to the eikonal approxim ation, w ith the rst subleading corrections in representing the NE approxim ation.

W e rst consider the propagator-vertex com bination for one-photon em ission. The diagram and corresponding expression is

W e have show $n$ that these vertices apply w hen tw o photons are em itted next to the on-shell eikonal line. From our analysis in this appendix, it does not necessarily follow that these vertioes apply to em issions anyw here on the extemal line, at all orders of perturbation theory. That this is indeed the case is clear when one rederives these vertioes using the path integralm ethods described in this paper, and we defer a fullproofw ithin conventional perturbation theory to a forthcom ing paper [36]. Here we will only dem onstrate that these term s are precisely reproduced in our path-integral form alism. The path integral representation ofa charged scalar coupled to a background gauge eld is given by Eq. (2.16) as

W e conclude that, to next-to-eikonal order, the one- and two-photon source term $s$ found by approxim ations in standard perturbation theory are precisely reproduced in our rst-quantized path-integral approach. T he considerations of section 2 then show that NE corrections from eikonally factorized diagram s exponentiate to all orders.

W e have considered the case of scalar em itting particles in the above discussion. H ow ever, things proceed sim ilarly for the spinor case, $w$ ith the only m odi cation arising due to the presence of an additional term in the exponent of Eq. (B.15)

$T$ his is $O(1=)$, as expected from the fact that a $m$ agnetic $m$ om ent vertex only contributes for particles having non-zero spin, and radiation in the strictly eikonal lim it is insensitive to the spin of the em itting particle.

## C. M atrix elem ents w ith internalem issions

In section 2.4, we show from our path integral representation of the scattering am plitude how NE corrections arising from soft photon em issions from w ithin the hard interaction can be related to the hard interaction w ith no em issions, which is part of the content of the Low Bumett-K roll theorem [33, 34] (see also [35]). To clarify this discussion, we here present how one w ould obtain a sim ilar result using traditionalFeynm an diagram $m$ ethods, in the case of two scalar lines. O ur presentation follow s that of e.g. [37].

W e consider the m om entum -space amplitude shown pictorially in Fig .16 , and corresponding to a single ghon em ission em ilted from a graph containing a given hard interaction w ith two extemal scalar particles. We rst de ne (p ${ }_{1}^{2} ; p_{2}^{2} ; p_{1} \quad$ p) to be the hard interaction am plitude w ith no photon em ission. T hen using the norm alFeynm an rules for scalar electrodynam ics, one $m$ ay w rite as
