# Magnetic Dipole, Electric Quadrupole and Magnetic Octupole Moments of the Baryons in Light Cone QCD Sum Rules

#### A bstract

Due to the very short life time of the baryons, a direct measurem ent on the electrom agnetic moments of these systems is alm ost impossible in the experiment and can only be done indirectly. Although only for the magnetic dipole moments of  $^{++}$  and  $^+$  systems there are some experimental data, the theoretical, phenomenological and lattice calculations could play crucial role. In present work, the magnetic dipole (), electric quadrupole (Q) and magnetic octupole (O) moments of these baryons are computed within the light cone QCD sum rules. The results are compared with the predictions of the other phenomenological approaches, lattice QCD and existing experimental data.

#### 1 Introduction

Study of the electrom agnetic properties of the baryons can give valuable information on their internal structure. Some of the main static electrom agnetic parameters of the baryons are their magnetic dipole (), electric quadrupole (Q) and magnetic octupole (O) moments. The  $r^{+}r^{+}r^{+}r^{0}$  baryons are the lowest and very well-known nucleon resonances. Because of their too short mean life time (  $10^{23}$  s), there is almost no direct experimental information about their form factors and electrom agnetic moments. An indirect measurement for the magnetic dipole moment of  $r^{+}$  was accurately done from the radiative pion-nucleon scattering [1] (see [2] for experimental values of the magnetic dipole moment of  $r^{+}$  obtained from various experiments). The magnetic moment of the  $r^{+}$  resonance has also been measured via P !  $r^{0}$  P reaction in [3].

The magnetic dipole m om ents of these baryons have been studied in the fram ework of the various theoretical approaches. The radiative pion production on the nucleon (N ! N  $^{0}$ ) with the aim of the determ ination of the magnetic dipole m om ent of the  $^{+}$  (1232) has been studied in the fram e work of Chiral e ective- eld theory in [4]. The magnetic dipole m om ent for baryons is calculated in the fram ework of the static quark m odel (SQM ) [5], relativistic quark m odels (RQM ) [6], QCD sum rules (QCD SR) [7, 8], Chiral quark-soliton m odels (ChQ SM ) [9], heavy baryon Chiral perturbation theory (HBChPT) [10, 11], a phenom enological quark m odel (PQM ) which nonstatic e ects of pion exchange and orbital excitation are included [12], Lattice QCD [13, 14, 15, 16] and Chiral e ective- eld theory [17]. The magnetic dipole, electric quadrupole and magnetic octupole m om ents of these baryons is also calculated in [18] in the spectator quark form alism based on a simple wave function corresponding to a quark-diquark system in an S-state. In [19], the

Quadrupole M on ent of the baryons are calculated in the fram e work of the consistituent quark m odel. Recently, the octupole m on ents of the light decuplet baryons are reported in [20] within the non-covariant quark m odel.

In the present work, we study the magnetic dipole, electric quadrupole and magnetic octupole moments of the baryons in light cone QCD sum rules (LCSR) approach. Note that, by calculating the electrom agnetic form factors, the electrom agnetic dipole moments of the nucleons have been studied in [21] in the same fram e work. The paper contains 3 sections. In section 2, the light cone QCD sum rules for the magnetic dipole, electric quadrupole and magnetic octupole moments are calculated. Section 3 is devoted to the num erical analysis of the sum rules, a comparison of our results with the predictions of the other approaches as well as the existing experimental data and also discussion.

2 Light cone Q C D sum rules for the magnetic dipole, electric quadrupole and magnetic octupole moments of the baryons

To calculate the m agnetic dipole, electric quadrupole and m agnetic octupole m om ents of the baryons, we start considering the basic object in LCSR m ethod (the correlation function), where hadrons are represented by the interpolating quark currents.

where is the interpolating current of the baryons and stands for the electrom agnetic eld. In QCD sum rules approach, this correlation function is calculated in two di erent languages: in the quark-gluon language (QCD or theoretical side), it describes a hadron as quarks and gluons interacting

in QCD vacuum. In the physical side, it is saturated by complete sets of hadrons with the same quantum numbers as their interpolating currents. The physical quantities, i.e., the electrom agnetic form factors and multipole moments are calculated equating these two diment representations of the correlation function.

The physical or phenom enological side of the correlation function can be obtained inserting the complete sets of the hadronic states between the interpolating currents in Eq. (1) with the same quantum numbers as the baryons, i.e.,

where  $p_1 = p + q$ ,  $p_2 = p$  and q is the momentum of the photon. The matrix element of the interpolating current between the vacuum and the baryon state is de ned as

where is the residue and u (p;s) is the Rarita-Schwinger spinor. The matrix element h ( $p_2$ ) j ( $p_1$ )i entering Eq. (2) can be parameterized in terms of some form factors as [18, 23, 24]:

where " is the polarization vector of the photon and  $F_i$  are the form factors as functions of  $q^2 = (p_1 \quad p_2)^2$ . In obtaining the expression for the correlation function, summation over spins of the particles is performed using

In deriving the expression for the phenom enological side of the correlation function appear two problems (see also [22]): 1) all Lorentz structures are not independent, 2) not only spin 3/2, but spin 1/2 states also contribute to the correlator, which should be elim inated. Indeed, the matrix element of the current between vacuum and spin 1/2 states is nonzero and is determined as

To remove the spin 1/2 contribution and obtain only independent structures in the correlation function, we order D irac matrices in a speci c form. For this aim, we choose the ordering for D irac matrices as  $\mathfrak{G} \mathfrak{G} \mathfrak{G}$ . With this ordering for the correlator, we obtain

The magnetic dipole ( $G_m$  ( $q^2$ )), electric quadrupole ( $G_Q$  ( $q^2$ )) and magnetic octupole ( $G_O$  ( $q^2$ )) form factors are de ned in term softhe form factors  $F_i$  ( $q^2$ ) in the following way [18, 23, 24, 25]:

where  $=\frac{q^2}{4m^2}$ . At  $q^2 = 0$ , the multipole form factors are obtained in term s of the functions  $F_i(0)$  as:

The static magnetic dipole ( ), electric quadrupole (Q) and magnetic octupole (O) moments in their natural magneton are dened in the following way:

The theoretical part of the correlation function can be calculated in light cone QCD sum rules via the operator product expansion (OPE) in deep Euclidean region where  $p^2 = 0$  and  $(p + q)^2 = 0$  in terms of the photon distribution amplitudes (DA's). To calculate the correlation function from theoretical or QCD side, the explicit expressions of the interpolating currents of the baryons are needed. The interpolating current for + is chosen as

where C is the charge conjugation operator and a, b and c are color indices. Here we should mention that in the present work, rst we calculate the correlation function for  $^+$  then with the help of the relations which we will present next, the correlators of ,  $^{++}$  and  $^0$  will be obtained using the correlation function of the  $^+$ . A fler contracting out the quark pairs in Eq. (1) by the help of the W ick's theorem, we obtain the following expression for the correlation function in terms of the quark propagators

where  $S^0 = C S^T C$  and  $S_{u,d}$  are the full light quark propagators, which their explicit expressions can be found in [26, 27] (see also [22, 28]). To calculate the above correlation function, we follow the same procedure as stated in [22, 28] and use the photon distribution amplitudes (DA's) calculated in [29]. For convenience, we present those DA's in the appendix {A.

U sing the expressions of the full light propagator and the photon DA's and separating the coe cient of the structures ("p)g , ("p)g ß ß, ("p)q ß and ("p)q q ß for the F<sub>1</sub>, F<sub>2</sub>, F<sub>3</sub> and F<sub>4</sub>, respectively, the expressions of the correlation function from the QCD side are obtained. Separating the coe cient of the same structures from phenom enological part and equating these representations of the correlator, sum rules for the F<sub>1</sub> functions are obtained. In order to suppress the contribution of the higher states and continuum, B orel transform ation with respect to the variables  $p_2^2 = p^2$  and  $p_1^2 = (p + q)^2$  is applied. The explicit expressions for F<sub>1</sub> are given in the appendix (B.

At the end of this section, we would like to present some relations between the correlation functions. Our calculations show that the coe cient of any structure in the correlation function of the + can be written in the form

where the function H (u;d) depends on the masses and condensates of the u and d quarks and it is independent of the charge of the quarks. Our calculations indicate that the 100,100,100 can be obtained from the  $1^{+}$  by the following replacements:

We consider the massless quarks,  $m_u = m_d = 0$ , and exact SU(2) avor symmetry implying huui = hddi. Under exact SU(2) avor symmetry, H (u;d) = H (d;u) = H (u;u) = H (d;d) = H and the following relations are obtained (see also [8]):

From above equation, by substituting the charge of the u and d quarks, the following exact relations between theoretical parts of the correlator of baryons are derived:

### 3 Num erical analysis

P resent section encom passes the num erical analysis for the, m agnetic dipole, electric quadrupole and m agnetic octupole m om ents of the baryons. The values for input parameters used in the analysis of the sum rules for the  $F_1$ ,  $F_2$ ,  $F_3$  and  $F_4$  are : huui(1 GeV) = hddi(1 GeV) = (0.243)^3 GeV^3, (1 GeV) = 0.8huui(1 GeV),  $m_0^2(1 GeV) = (0.8 0.2) GeV^2$  [30] and  $f_3 =$  $0.0039 GeV^2$  [29]. The value of the m agnetic susceptibility was obtained in various papers as  $(1 GeV) = 3.15 0.3 GeV^2$  [29], (1 GeV) = $(2.85 0.5) GeV^2$  [31] and  $(1 GeV) = 4.4 GeV^2$  [32]. The residue determ ined from m ass sum rules and is taken to be  $= 0.038 GeV^3$ [7, 33, 34]. From sum rules for the  $F_1$ ,  $F_2$ ,  $F_3$  and  $F_4$ , it follows that the photon DA's are also needed [29]. Their explicit expressions are also given in the appendix{A.

The sum rules for the magnetic dipole, electric quadrupole and magnetic octupole moments also contain two auxiliary parameters: Borel mass parameter M<sup>2</sup> and continuum threshold s<sub>0</sub>. The physical quantities, i.e., magnetic dipole, electric quadrupole and magnetic octupole moments, should be independent of these parameters. The working region for M<sup>2</sup> is determined requiring that the contributions of the higher states and continuum are electively suppressed. This condition is satisfied in the region  $1 \text{ GeV}^2$  M<sup>2</sup>  $1.5 \text{ GeV}^2$ .

The dependency of the magnetic dipole moment , electric quadrupole Q and magnetic octupole O moments on Borel parameter M<sup>2</sup> are presented in Figs. 1-3 at xed value of the continuum threshold  $s_0 = 4 \text{ GeV}^2$ . The magnetic dipole moment is presented in its natural magneton (e}=2m c) while the electric quadrupole (Q) and magnetic octupole (O) moments are shown in fm<sup>2</sup> and fm<sup>3</sup>, respectively. The conversion coe cient from the nat-

ural m agneton unit to the nucleon m agneton is  $\frac{m_N}{m}$ . Note that, our results are practically the same in the interval  $s_0 = (3.8 \quad 4.2) \text{ GeV}^2$  for continuum threshold. These gures present a good stability with respect to the Borel m ass parameter. We should also mention that our results practically don't change considering three values of the as presented at the beginning of this section.

Our nal results on the magnetic dipole moment for baryons are presented in Table 1. The quoted errors for the values are due to the uncertainties in the determ ination of the input parameters, the variation of  $M^2$  as well as the system atic errors in QCD sum rules approach. For comparison, the predictions of other theoretical approaches, lattice QCD as well as the experiment are also presented. From this Table, we see a good consistency among the various approaches especially when we consider the errors except the lattice QCD prediction [15] for magnetic moment of +.

We also depict the results of the electric quadrupole Q and magnetic

octupole 0 moments in Table 2. In comparison, the results of the other approaches are also presented. From this Table, we see that the values for the electric quadrupole and magnetic octupole moments are very small in comparison with the magnetic dipole moment. Our results on electric quadrupole moments are consistent with the predictions of the constituent quark model with con guration mixing but no exchange currents (in pulse approximation)[19] in order of magnitude, but about one order of magni-

tude smaller than the predictions of constituent quark model with exchange currents but no con guration mixing [19]. The [18] predicts no electric quadrupole and magnetic octupole moments for baryons. Our results on the magnetic octupole moments for these baryons are about four times smaller than the predictions of the non-covariant quark model [20]. The negative sign in the value of the quadrupole and octupole moments of  $^+$  shows that the quadrupole and octupole distributions are oblate and have the same geometric shape as the charge distribution.

In conclusion, due to the very short life time, a direct measurement on the electrom agnetic moments of systems is almost not possible in the experiment and can only be done indirectly in a three-step process, where they are created, emit a low-energy photon and then decay. A lthough only for <sup>+</sup> and <sup>++</sup> systems there are some data, the theoretical, phenom enological and lattice calculations could play very in portant role. In present work, we com puted the magnetic dipole, electric quadrupole and magnetic octupole moments of these baryons in the fram ework of the light cone QCD sum rules and compared their results with the predictions of the other phenom enologicalm odels, lattice QCD as well as the existing experimental data. The results depict that the electric quadrupole and magnetic octupole moments are very small in comparison with the magnetic dipole moment of these baryons.
