# B low up of sm ooth solutions to the barotrop ic com pressible $m$ agnetohydrodynam ic equations $w$ ith $n$ ite $m$ ass and energy

#### Abstract

W e prove that the sm ooth solutions to the $C$ auchy problem for the three-dim ensional com pressible barotropic magnetohydrodynam ic equations w ith conserved totalm ass and nite total energy lose the in itialsm oothness within a nite time. Further, we show that the sam e result holds for the solution to the C auchy problem for the $m$ ultidim ensional com pressible $N$ avierStokes system. M oreover, for the solution with a nite mom entum of inertia we get the tw o-sided estim ates of di erent com ponents of total energy.


## 1. The $n$ ite tim eblow up result

T he set ofequationsw hich describe com pressible viscousm agnetohydrodynam ics are a com bination of the com pressible N avier-Stokes equations of uid dynam ics and $M$ axwells equations of electrom agnetism. W e consider the system of partial di erential equations for the three-dim ensional viscous com pressible $m$ agnetohydrodynam ic ows in the Eulerian coordinates [1] for barotropic case:

A lthough the electric eld E does not appear in the M HD system (1.1)-(1.3), it is indeed induced according to the relation

T he local in tim e existence to the above $C$ auchy problem for the density separated from zero follow s from [B], how ever the results on global solvability are very scanty. For exam ple, even for the one-dim ensional case, the global existence of classical solutions to the full perfect M HD equations w ith large data rem ains unsolved (the sm ooth global solution near the constant state in one-dim ensional case is investigated in [2]). T he existence of global w eak solutions w as proved recently [4] (see also 5]] for references).
$T$ he system (1.1) $(1.3)$ is the di erential form ofbalance law $s$ for the $m$ aterial volume $(t)$; it expresses conservation ofm ass

$H$ ere $E_{k}(t) ; E_{m}(t)$ and $E_{i}(t)$ are the kinetic, $m$ agnetic and intemal com ponents of energy, respectively.

Ifwe regard $(t)=R^{3}$; the conservation ofm ass, $m$ om entum and non-increasing of totalenergy takes place provided the com ponents of solution decrease at in nity su ciently quickly.

O urm ain result is the follow ing:
Theorem 1.1.Assume $\frac{6}{5}$ : If the $m$ om entum $P \in 0$; then there exists no global in tim e classicalsolution to (1.1) \{ (1.5), (1.6) w ith conserved m ass and nite total energy.

If H $\quad 0$; we get the barotropic system of the com pressible N avier-Stokes equations. W e can consider it in any space dim ensions w ithout physical restriction $n=3:$ In this case the viscosity coe cients should satisfy the inequalities > $0 ;+\frac{2}{n}>0$ :The follow ing theorem is an extension of the result of [6] to the larger class of solutions.

Theorem 1.2. Assumen 3 and $\frac{2 n}{n+2}$ : If the $m$ om entum $P \& 0$; then there exists no global in tim e classical solution to the barotropic system of the com pressible N avier-Stokes equations with conserved m ass and nite totalenergy.

The next lem m a is proved in [6] for both barotropic and non-barotropic cases.

2. E stim ates of energy for solutions with $n$ ite $m$ om ent of inertia

In this section we are going to obtain $m$ ore speci ed estim ate for the decay rate of total energy for $m$ ore restricted classes of solutions.

Let us introduce the fiunctionals

where the rst one is the $m$ om entum of inertia, the inner product of vectors is denoted as (:; :) .

Taking into account the generalstokes form ula one can readily calculate that for classical com pactly supported solution to (1.1) \{ (1.5) the follow ing identities hold:

In fact, form ulas are obtained in [8] for gas dynam ics equations $w$ ith nite $m$ om ent of inertia (not especially com pactly supported). H ow ever, evidently that (2.1), (2 2) are satis ed for solutions decaying at in nity su ciently quickly togetherw ith their derivatives. O ne can im pose a special rate of decay on the solution and then prove (2.1), (2.2) as a lem m a (as in [6]). The altemative way is to take (2.1), (2.2) as a de nition of the rate of decay.

De nition 2.1. W e will call a solution ( $; u ; H$ ) to the C auchy problem (1.1) \{ (1.5), (1.6) highly decreasing at in nity, if ( $t ; x$ ) 0 and the identities (2.1), (2.2) hold.

Evidently, the integrals of $m$ ass, $m$ om entum and total energy are nite for highly decreasing at in nity solutions at any $x e d m$ om ent oftime.

W e rstly get two-sided estim ates of $G(t)$ :

for $>\frac{4}{3}$ : In both cases this contradicts to the non-negativity of $E(t)$ : H ow ever, the decay of total energy in the case of highly decreasing solutions is greater that follow s from inequality (1.13).
