# The Schrodinger equation with Hulthen potential plus ring-shaped potential.

A btract W e present the solutions of the Schrodinger equation with the Hulthen potential plus ring-shape potential for '  $\in$  0 states within the fram ework of an exponential approximation of the centrifugal potential. Solutions to the corresponding angular and radial equations are obtained in terms of special functions using the conventional Nikiforov-U varov method. The normalization constant for the Hulthen potential is also computed.

#### 1. Introduction.

The search for exact bound-state solutions of wave equations, relativistic or non-relativistic, has been an important research area in quantum mechanics. However, over the past decades, problems involving the multidimensional Schrodinger equation have been addressed by many researchers. For instance, Batem an investigated the relationship between the hydrogen atom and a harmonic oscillator potential in arbitrary dimensions [1]. Recently, the N-dimensional P seudoharmonic oscillator was discussed by A gboola et al [2]. The N-dimensional K ratzer-Fues potential was discussed by O yew um i [3], while the modied K ratzer-Fues potential plus the ring shape potential in D-dimensions by the N ikiforov-U varov method has also been considered [4].

The Hulthen potential is one of the important short-range potentials which behaves like a Coulomb potential for small values of r and decreases exponentially for large values of r. The Hulthen potential has received extensive study in both relativistic and non-relativistic quantum mechanics [5-9]. Unfortunately, quantum mechanical equations with the Hulthen potential can be solved analytically only for the s-states [5, 11, 12]. However, some interesting research papers [13-22] have appeared to study the 'state solutions of Hulthen-type potentials. Recently, an extension of this study to a multidimensional case was presented [23]. The main idea of the investigation relies on using an exponential approximation for the centrifugal term.

Recently, Chen and Dong [24] found a new ring-shaped (non-central) potential and obtained the exact solution of the Schrodinger equation for the Coulomb potential plus this new ring-shaped potential which has possible applications to ring-shaped organic molecules like cyclic polyenes and benzene. A lso, Cheng and Dai [25], proposed a new potential consisting from the modi ed Kratzer potential [26] plus the new proposed ring-shaped potential. They have presented the energy eigenvalues for this proposed exactly-solvable non-central potential. Very recently, the D-dimensional case of the potential has been studied by Ikhdair [] using the Nikiforov-U varov method [27].

It is therefore the aim of this paper to present the approxim ate solutions of the Schrodinger equation with the Hulthen potential plus ring-shape potential for '6 0 states using the conventional N ikiforov-U varov m ethod.

2. The Schrodinger equation for the Hulthen plus ring-shape potential.

The motion of a particle of mass in a spherically symmetric potential is described in spherical coordinate as

The Hulthen potential [5, 6, 7, 23] plus the ring-shape potential [4, 24, 25] in is given as

where is the screening parameter, is a positive real constant and Z is a constant which is identified with the atom ic number when the potential is used for atom ic phenomena.

If we substitute Eq.(2) into (1) and seperate the variable as follows

where we have introduced the seperation constants m and = '('+ 1) and 'is the orbital angular m om entum quantum number.

The solution to Eq.(8) is periodic and must satis es the periodic boundary condition

from which we obtain the solution

We are then left with the solutions of Eqs.(6) and (7) which we present in the later sections.

#### 3. The Nikiforov-U varov method.

In this section, we give a brief description of the conventional N ikiforov-U varov m ethod. A m ore detailed description of the m ethod can be obtained the following references [27]W ith an appropriate transformation s = s(r), the one dimensional Schrodinger equation can be reduced to a generalized equation of hypergeometric type which can be written as follows:

Where (s) and  $\sim$  (s) are polynomials, at most second-degree, and  $\sim$  (s) is at most a rst-order polynomial. To nd particular solution of Eq. (14) by separation of variables, if one deals with

The polynom ial (s) with the parameter s and prime factors show the differentials at rst degree be negative. However, determination of parameter t is the essential point in the calculation of (s). It is simply dened by setting the discriminate of the square root to zero [27]. Therefore, one gets a general quadratic equation for t. The values of t can be used for calculation of energy eigenvalues using the following equation

Furtherm ore, the other part  $y_n$  (s) of the wave function in Eq. (12) is the hypergeom etric-type function whose polynomial solutions are given by Rodrigues relation:

where  $B_n$  is a normalizing constant and the weight function (s) must satisfy the condition [10]

4.0 Solution to the angular equation.

In order to solve Eq.(6) using the Nikiforov-Uvarov method, we write it as follows

Introducing a new variable s = cos, Eq. (21) becomes an associated Legendre di erential equation [4, 25, 28]

W ith the condition that  ${}^0(s) < 0$ , we select the solution (s) = s for  $t = {}^2$ . This yields

## 4.1 Solution to the radial equation.

In this section, we obtain the solution to radial equation (6) using the N ikiforov-U varov m ethod F irst, we note that Eq.(6) is similar to the one dimensional Schrodinger equation for the Hulthen potential, expect for the addition of the term  $\frac{\text{'(+N-2)}}{r^2}$ , which is well known as the centrifugal term. To solve Eq.(6), one can consider the approximation of the centrifugal term which is valid for a small value of

W ith the use of Eq.(33) and the transform ation  $s = e^{-r}$ , Eq.(6) becomes

By comparing Eqs.(11) and (34), we can de ne the following

Inserting these expressions into Eq.(16), we have

The constant parameter t can be found in a sim ilar fashion with that of the angular equation. Thus, the two possible functions for each tare given as

which is in agreement with previous works [6,28].

To obtain the wave function, we substitute (s) and (s) into Eq.(14), and solving the rst order di erential equation to have

where  $C_n$  is the norm alization constant, and we have used the de nition of the Jacobi polynom ials  $\beta 0$ , given as

To compute the normalization constant  $C_{\,n}$ , it is easy to show with the use of Eq.(4) that

where we have also used the substitution  $s = e^{-r}$ . Putting Eq.(46) into Eq.(48) and using the following de nition of the Jacobi polynom ial[30]

Using the relations B  $(x;y) = \frac{(x)(y)}{(x+y)}$  and the Pochhammer symbol  $(a)_n = \frac{(a+n)}{(a)}$ , Eq.(54) can be written as

Eq.(55) can be used to compute the normalization constants for n=0;1;2;::: In particular for the gound state, n=0, we have

Finally, we can now write the complete orthonormalized energy eigenfunction of the Hulthen potential plus a ring-shape potential.

where  $U_n$ , (s), H ( ) and (') are give in Eqs.(46), (32) and (10) respectively and  $s = e^{-r}$ 

### 6. Conclusions.

In this paper, the Schrodinger equation was solved for its approximate bound-states with a Hulthen potential plus a ring-shaped potential for ' $\in$  0 by the conventional Nikiforov-U varov method. Solutions to the angular and radial equations were obtained using the Nikiforov-U varov method and the eigenvalues obtained were found to be in agreement with those obtained using the numerical integration method [31] and the PT-symmetric quantum mechanics [28]. The corresponding eigenfunctions were worked out in terms of the Jacobi polynomial and the normalization constant was also computed in terms of hypergeometric series. This research is an extension of the works presented by [24].

However, it is important to note that the approximation (33) is only valid for a small value of ; and as ! 0, the results obtained approach those of the Coulombic potential.

Finally, it is worth noting that the approxim ate solution obtained in the newly proposed form of potential (2) may have some signicant applications in the study of quantum mechanical systems in both atomic and molecular physics.
