# Inclusive hadronic distributions in jets and sub-jets with jet axis from color current

The hadronic  $k_{2}$  -spectrum and the gluon to quark average multiplicity ratio  $r = N_{q} = N_{q}$  inside a high energy sub-jet are determined from a precise de nition of the jet axis, including corrections of relative magnitude  $O\left(\frac{1}{s}\right)$  with respect to the M odi ed Leading Logarithm ic Approximation (M LLA), in the limiting spectrum approximation (assuming an infrared cut-o  $Q_{0} = Q_{0}$ ). The results for the  $k_{2}$  -spectrum in the limiting spectrum approximation are found to be, after normalization, in impressive agreement with measurements by the CDF collaboration and the ratio has not been measured yet.

#### 1. Introduction

The collimation of hadrons in jets is a basic phenom enon of high energy collisions and its quantitative understanding is an important task for QCD. Sim ple di erential characteristics of a jet are their energy and multiplicity angular pro-

les. The collimation of energy and multiplicity in the jet follows from the dominance of gluon brem sstrahlung processes in the parton cascade evolution. W hereas the form er is more sensitive to the hard processes inside a jet the second one is sensitive to the soft parton em issions from the prim ary parton.

The characteristics of soft particle production, such as particle multiplicities, inclusive distributions and correlation functions, are derived in QCD in the Double Logarithm ic Approxim ation (DLA) and the Modi ed Leading Logarithm ic Approximation (M LLA) (for review, see [1]), which takes into account the leading double logarithm ic terms and the single logarithm ic corrections. These azim uthally averaged quantities can be obtained from an evolution equation for the generating functional of the parton cascade. This equation provides also Next-to-M LLA (NM -LLA) corrections taking into account energy conservation of parton splittings with increased accuracy. The corresponding hadronic observables can be obtained using the concept of Local Parton

Hadron Duality (LPHD) [2], which has turned out a successful description of many hadronic phenomena (see, e.g. [3]).

The inclusive k, -distribution of particles inside a sub-jet with respect to the jet axis has been computed at M LLA accuracy in the limiting spectrum approximation [4], i.e. assuming an infrared cuto  $Q_0$  equal to  $_{0 \text{ cb}}$  (  $\ln (Q_0 = _{0 \text{ cb}}) = 0$ ) (for a review, see also [1]). M LLA corrections, of relative m agnitude 0  $\frac{P}{s}$ , were shown to be quite substantial [4]. Therefore, corrections of order 0 ( s), that is NM LLA, have been incorporated in [5,6].

A nother characteristic prediction of QCD is the asymptotic increase of the mean average particle multiplicity in a gluon jet over the quark jet by the ratio of color factors  $r = N_g = N_q ! N_c = C_F = 9=4$ , which is also modiled by the similar set of corrections 0  $\binom{p_{-s}}{s}$  [7,8,9]. In particular, this analysis has been extended to multiparticle production inside sub-jets with a precise prescription of the jet axis, which has been, for both observables, identiled with the direction of the energy ux [10].

The starting point of this analysis is the M LLA M aster Equation for the Generating Functional (GF) Z = Z (u) of QCD jets [1], where u = u (k) is a certain probing function and k, the fourmomentum of the outgoing parton. Together with the initial condition at threshold, the GF determ ines the jet properties at all energies. Within this logic, the leading (DLA, O ( $\frac{p}{s}$ )) and nextto-leading (MLLA, O ( $_{\rm s}$ )) approximations are complete. The next term s (NMLLA, O ( $_{\rm s}^{3=2}$ )) are not complete but they include an in portant contribution which takes into account energy conservation and an in proved behavior near threshold. Indeed, some results for such NMLLA term shave been studied previously for global observables and have been found to better account for recoil effects and to drastically a ect multi-particle production [11,12].

The main results of this work have been published in [5,6,10]. Experimentally, the CDF collaboration at the Tevatron reported on  $k_{z}$  - distributions of unidenti ed charged hadrons in jets produced in pp collisions at  $\frac{P}{s}$  = 1:96 TeV [13].

## 2. M LLA evolution equations

#### 2.1. Inclusive spectrum

We start by writing the MLLA evolution equations for the fragmentation function  $D_B^h \times z; zE_0; Q_0$  of a parton B (energy zE and transverse momentum  $k_2 = zE_0$ ) into a gluon (represented by a hadron h (energy xE) according to LPHD [2]) inside a jet A of energy E for the process depicted in Fig. 1. As a conse-

quence of angular ordering in parton cascading, partonic distributions inside a quark and gluon jet, Q;G (z) = x z D\_{Q;G}^{h} x z;zE\_{0};Q\_{0}, obey the system of two coupled equations [14] (the subscript y denotes @=@y) following from the M LLA m aster equation [1]

 $_{\rm A}^{\rm B}$  (z) denotes the Dokshitzer-Gribov-Lipatov-Altarelli-Parisi (DGLAP) splitting functions [1],

where  ${}_q^g(z) = z = 2$  and  ${}_g^g(z) = (z = 1)(2 = z(1 = z))$  are regular as z = 0,  $C_F = (N_c^2 = 1)=2N_c$ ,  $T_R = n_f=2$  ( $N_c = 3$  is the number of colors for SU (3)<sub>c</sub> and  $n_f = 3$  is the number of light avors we consider). The running coupling of QCD ( $_s$ ) is given by

where  $Q_0$  is the collinear cut-o parameter. Moreover,

At small x z, the fragmentation functions behave as

 $_{\rm B}^{\rm h}$  being a slowly varying function of two log-arithmic variables  $\ln(z=x)$  and y that describes

the \hump-backed" plateau [15]. Since recoil effects should be largest in hard parton splittings, the strategy followed in this work is to perform Taylor expansions (rst advocated for in [16]) of the non-singular parts of the integrands in (1,2) in powers of  $\ln z$  and  $\ln (1 - z)$ , both considered sm allw ith respect to `in the hard splitting region z - 1 - z = 0 (1)

with z \$ 1 z. Each 'derivative giving an extra  $p_{-s}$  factor (see [14]), the term  $sB \cdot (1) \ln z$  and  $B \cdot (1) \ln (1 z)$  yield NM LLA corrections to the solutions of (2). Making used of (5), after integrating over the regular parts of the DG LAP splitting functions, while keeping the singular term s unchanged, one gets after some algebra ( $\frac{2}{0} = 2N_{c} s =$ ) [5,6]

where the constants take the values  $a_1 = 0.935$ ,  $a_1 = 3=4$ ,  $a_2 = 0.08$  and  $a_2 = 0.42$  for  $n_f = 3$ . Dening F (';y) =  $\frac{2}{0}$  ('+ y)G (';y), we can exactly solve the self-contained equation (7) by performing the inverse M ellin transform :

As can be seen, the NMLLA coe cient  $a_2$  is very sm all. Therefore, the NM LLA solution (9) of (7) can be approximated by the M LLA solution of G (';y) (i.e. taking  $a_2$ 0), which is used in the following to compute the inclusive k, distribution. As dem onstrated in [14], taking the lim its a<sub>2</sub> 0 and 0 in 9), the integral representation can be reduced to the known M LLA formula, which can be written in terms of Bessel series in the lim iting spectrum approximation [1]. To get a quantitative idea on the di erence between M LLA and NM LLA gluon inclusive spectrum, the reader is reported to the appendix B of [5]. The m agnitude of  $a_2$ , how ever, indicates that the NM LLA corrections to the inclusive quark jet spectrum may not be negligible and should be taken into account. A fler solving (7), the solution of (6) reads

It diers from the MLLA expression given in [4] by the term proportional to  $G_{\nu\nu}$ , which can be deduced from the subtraction of ( $C_F = N_c$ ) (7) to Eq. (6).

## 2.2. Particle m ean average multiplicity

Integrating the system (1,2) over the energy fraction x leads the average multiplicity of particles produced in the jet:

where Y  $_{0}$  '+ y = ln (E  $_{0}=Q_{0}$ ). Therefore, an equivalent system of two-coupled evolution equations can be deduced and expanded, following the same logic that led to (6,7). However, in this case, the expansion in  $P_{s}$  is performed for Y ln z ln (1 z), where similarly, z 1. We lim it ourselves here to the NM LLA expression of r that reads

where the asymptotic value of r is  $r_0 = N_c = C_F = 9=4$ . The M LLA term  $r_1$  has been calculated in

[7]. The coe cients  $r_k$  can be obtained from the Taylor expansions of  $N_A^h$  (Y + hx) and  $N_A^h$  (Y + h (1 x)) for Y hx and Y h (1 x) in the evolution equations [16]. The values of  $r_k$  for  $n_f = 3$  read  $r_1 = 0.185$  and  $r_2 = 0.426$  [16]. The NM LLA solution for the mean multiplicity in a gluon jet is found as [16]

with  $c_1 = 0.28$ ,  $c_2 = 0.38$  for  $n_f = 3$  and K, the LPHD normalization factor. The pre-exponential term (Y)  $^{q=0}$  is the M LLA contribution to N $^{h}_{g}$ , while the one /  $c_2$ , the NM LLA one.

3. Single inclusive k<sub>2</sub> distribution of charged hadrons and the gluon to quark m ean average multiplicity ratio r at N M LLA

#### 3.1. Inclusive k<sub>2</sub> distribution

Computing the single inclusive  $k_2$ distribution and the ratio  $r = N_q = N_q$  inside a sub-jet requires the de nition of the jet axis. The starting point of our approach consists in considering the correlation between two particles (h1) and (h2) of energies  $E_1$  and  $E_2$  which form a relative angle inside one jet of total opening angle  $_0 >$ [17]. W eighting over the energy  $E_2$  of particle (h2), this relation leads to the correlation between the particle (h=h1) and the energy ux, which we identify with the jet axis (see Fig. 2) [4]. Thus, the correlation and the relative transverse momentum  $k_2$  between (h1) and (h2) are replaced by the correlation, and transverse momentum of (h1) with respect to the direction of the energy ux. Finally, we obtain the double di erential spectrum  $d^2N = dx d$  of a hadron produced with energy  $E_1 = xE$  at angle (or  $k_2$ ) xE )with respect to the jet axis. As dem onstrated in [4], the correlation reads

where  $F_{A_0}^h$  is given by the convolution of two fragmentation functions

u being the energy fraction of the interm ediate parton  $A \cdot D_{A_0}^{A}$  describes the probability to emit A with energy uE o the parton  $A_0$  (which initiates the jet), taking into account the evolution of the jet between  $_0$  and  $. D_A^{h}$  describes the probability to produce the hadron h o A with energy fraction x=u and transverse momentum  $k_2$  uE  $Q_0$  (see Fig. 2). As discussed in

[4], the convolution (14) is dominated by u 1 and therefore  $D_{A_0}^{A}$  (u; E \_0; uE ) is determined by the DGLAP evolution [1]. On the contrary, the distribution  $D_{A}^{h} \frac{x}{u}$ ; uE ;Q<sub>0</sub> at low x u reduces to the hum p-backed plateau,

where  $f_k$  follow from the DGLAP evolution equations [1] and can be symbolically written as

The exact formul of the color currents are reported in [4,5,6]. Indeed, since soft particles are less sensible to the energy balance, the correlation (14) disappears for these particles, leading to the sequence of factorized term swritten in (17). The rst two terms in Eq. (17) correspond to the M LLA distribution calculated in [4] when  $D_{h}^{h}$  is evaluated at NLO and its derivative at LO .NM -LLA corrections arise from their respective calculation at NNLO and NLO, and, mainly in practice, from the third term, which was exactly com puted in [5,6]. Indeed, since x=u is small, the inclusive spectrum  $D_{A}^{h}$  ('; y) with A = G; Q are given by the solutions (9) and (10) of the nextto-M LLA evolution equations (6) and (7) respectively. However, because of the sm allness of the coe cient a 2, G (';y) shows no signi cant di erence from MLLA to NMLLA. As a consequence, we use the M LLA expression (9) for G (';y) with  $a_2 = 0$ , and the NM LLA (10) for Q (';y). The functions  $F_q^h$  and  $F_q^h$  are related to the gluon distribution via the color currents hC iq;q which can be seen as the average color charge carried by the parton A due to the DGLAP evolution from A<sub>0</sub> to A.

This calculation has also been extended beyond the limiting spectrum,  $\notin$  0, to take into account hadronization e ects in the production of \massive" hadrons, m = 0 (Q<sub>0</sub>) [18]. We used, accordingly, the more general M LLA solution of (7) with a<sub>2</sub> = 0 for an arbitrary  $\notin$  0, which can only be performed numerically. The NM – LLA (normalized) corrections to the M LLA result are displayed in Fig. 3 for di erent values = 0;0:5;1. It clearly indicates that the larger , the smaller the NM LLA corrections. In particular, they can be as large as 30% at the lim – iting spectrum ( = 0) but no more than 10%

for = 0.5. This is not surprising since  $\notin$  0 (Q<sub>0</sub>  $\notin$  ) reduces the parton emission in the infrared sector and, thus, higher-order corrections.

The double di erential spectrum  $(d^2N = d'dy)$  can now be determined from the NM LLA color currents (17) by using the quark and gluon distributions. Integrating over ' leads to the single inclusive y-distribution (or  $k_{p}$ -distribution) of hadrons inside a quark or a gluon jet:

The M LLA fram ework does not specify down to which values of ' (up to which values of x) the double di erential spectrum  $(d^2N = d'dy)$  should be integrated over. Since  $(d^2N = d'dy)$  becomes negative (non-physical) at small values of ' (see e.g. [4]), we chose the lower bound  $m_{in}$  so as to guarantee the positiveness of  $(d^2N = d'dy)$  over the whole 'm in ١. Y<sub>0</sub> range (in practice, 1 and  $\frac{q}{m in}$ √g min 2). Having successfully com puted the single k, -spectra including NM LLA corrections, we now com pare the result with existing data. The CDF collaboration at the Tevatron recently reported on prelim inary measurements over a wide range of jet hardness,  $Q = E_{0}$ ,

in pp collisions at s = 1.96 TeV [13]. CDF data, including system atic errors, are plotted in Fig. 4 together with the MLLA predictions of [4] and the present NM LLA calculations, both at the limiting spectrum (= 0) and taking = 250 MeV. The experimental distribuосл tions su ering from large normalization errors, data and theory are norm alized to the same bin,  $\ln (k_2 = 1 \, \text{GeV}) =$ 0:1. The agreem ent between the CDF results and the NM LLA distributions over the whole k, -range is particularly good. In contrast, the M LLA predictions prove reliable in a much smaller k, interval. At xed jet hardness (and thus Y ,), NM LLA calculations prove accordingly trustable in a much larger x interval.

Finally, the kt-distribution is determ ined with respect to the jet energy ow (which includes a sum mation over secondary hadrons in energyenergy correlations). In experiments, instead, the

'et axis is determ ined exclusively from all particles inside the jet. The question of the matching of these two de nitions goes beyond the scope of this letter. The NM LLA k, -spectrum has also been calculated beyond the limiting spectrum, by plugging (9) with  $a_2 = 0$  into (19), as illustrated in Fig. 5. However, the best description of CDF prelim inary data is reached at the lim iting spectrum, or at least for sm all values of < 0.5, which is not too surprising since these inclusive m easurem ents mostly involve pions. Identifying produced hadrons would o er the interesting possibility to check a dependence of the shape of k, distributions on the hadron species, such as the one predicted in Fig. 5. M oreover, the softening of the k, -spectra with increasing hadron masses predicted in Fig. 5 is an observable worth to be measured, as this would provide an additional and independent check of the LPHD hypothesis beyond the limiting spectrum. This could only be achieved if the various species of hadrons inside a jet can be identi ed experim entally. Fortunately, it is likely to be the case at the LHC, where the ALICE [19] and CMS [20] experiments at the Large Hadron Collider have good identication capabilities at not too large transverse

m om enta.

3.2. Ratio  $r = N_g = N_q$ 

Integrating (14) over the energy fraction x yields the corresponding sub-jet multiplicity  $\hat{N}_{A_0}^h$  of hadrons inside the angular range  $< _0$  of the jet  $A_0$  [10]

where  $N_{A}^{h}$  is the number of hadrons (partons at scale  $Q_0$ ) produced inside the sub-jet A of total  $Q_0$  and  $u_0$  =  $Q_0 {=} E$  . W ithin virtuality uE the leading parton approxim ation, we expand the multiplicity N  $_{\rm A}^{\rm h}$  (uE ;Q  $_{\rm 0}$ ) in (20) at u 1. Sim – ilarly to the logic applied in (15) for the com putation of the  $k_2$  distribution, we take the logarithm ic dependence of the average multiplicity  $N_{A}^{h}$ , such that for  $\ln u$ Y  $\ln (E = Q_0)$  and , one obtains the average multiplicity Е  $\hat{N}_{\lambda}^{h}$  (Y; Y) of soft hadrons within the sub-jet of opening angle with respect to the energy ow

where  $N_g^h(Y)$  is written in (12) and hC  $i_{q,q}(Y_o;Y)$  is the average color current of partons forming the energy ux. We write the color current as

where  $f_k = f_k (Y_0; Y)$  follow from (11) and (18) and corrections 0 ( $\frac{n=2}{s}$ ) from the logarithmic derivatives of the average multiplicity (12):

$$\frac{1}{N_A}\frac{d^n N_A}{dY^n} \prime \quad s^{n=2}$$

The exact form ul of hC  $i_{q;g}$  (Y  $_{_{0}}$ ;Y ) are given in the appendix of [10]. The ratio of the gluon to the quark jet average multiplicity reads

$$\frac{\hat{N}_{g}^{h}}{\hat{N}_{g}^{h}}(Y_{0};Y_{0}) = \frac{hCi_{g}(Y_{0};Y_{0})}{hCi_{q}(Y_{0};Y_{0})};$$

For this quantity, in the limit ! 0, the appropriate ratio (11)  $r = \frac{N_q}{N_q} = r_0 (1 r_0 r_2^2)$  is recovered.

Next we study the consequences for the behavior of the ratio at full angles  $_0$  1 and for subjets at reduced angles . Results for the ratio using our form ulae for the color currents hC  $i_{qrg}$ [10] are depicted in Fig.6. The full line shows the ratio (11) for an isolated  $A_0$  jet as a function of Y  $_0 = \ln (E_{-0} = Q_0)$ . The three curves below cor-

respond to the sub-jet energies E = 50;100;1000G eV and the intersection points with (11) to the lim it ! 0. Therefore, the mixing of quark and gluon jets reduces the multiplicity in the gluon jet and increases it in the quark jet at sufciently high energies and the e ect from intermediate processes in the new de nition of multiplicity ratio amounts to about 20% at a reduced energy scale Y Y 2.

### 4. Conclusion

We have studied a de nition of the jet which arises from the 2-particle correlation. The jet axis corresponds to the energy weighted direction of particles in a given cone  $_0$ . In this way smaller angles (or transverse m om enta) can be m eaningfully determ ined. The new e ect from 2-particle correlations is the appearance of the \color current" in the result, which re ects the possibility of interm ediate quark-gluon processes. We then studied the consequences of this analysis on the m easurem ent of di erential ( $k_2$  -distribution) and global (particle multiplicity) observables, where we have added M LLA and NM LLA corrections to the known LO results [1].

The single inclusive  $k_{,}$  -spectra is determ ined within this logic and the agreem ent between NM – LLA predictions and CDF data in pp collisions at the Tevatron [13] is impressive, indicating very sm all overall non-perturbative corrections and giving further support to LPHD [2].

The main for the ratio  $r = N_g = N_q$  re ects the possibility of interm ediate quark-gluon processes. This e ect can be seen by the scale breaking between jets and sub-jets at the same scale E but di erent energies E and opening angles . Typicale ects are of the order of 20%. How ever, these e ects on this observable have not been measured yet.
