A system atic stability analysis of the renorm alisation group ow for the norm al-superconductor-norm aljunction of Luttinger liquid wires

We study the renorm alization group ow s of the two term inal conductance of a superconducting junction of two Luttinger liquid wires. We compute the power laws associated with the renorm alization group ow around the various xed points of this system using the generators of the SU (4) group to generate the appropriate param eterization of an S-m atrix representing sm all deviations from a given xed point S-m atrix (obtained earlier in Phys. Rev. B 77, 155418 (2008)), and we then perform a comprehensive stability analysis. In particular, for the non-trivial xed point which has interm ediate values of transm ission, rejections in which the system can be perturbed, which are relevant or intelevant, and ve directions which are marginal. We obtain power laws associated with these relevant and intelevant perturbations. Unlike the case of the two-wire charge-conserving junction, here we show that there are power laws which are non-linear functions of V (0) and V ($2k_F$) (where V (k) represents the Fourier transform of the inter-electron interaction potential at momentum k). We also obtain the power law dependence of linear response conductance on voltage bias or tem perature around this xed point.

E lectron-electron (e-e) interactions in low-dimensional systems (one-dimensional (1{D) quantum wires (QW) and dots) can lead to non-trivial low energy transport properties due to the Luttinger liquid (LL) ground state of the system. In this context, a geometry which has gained considerable attention in the recent past is the multiple LL wire junction. In general, junctions of multipleQW can be viewed as quantum in purities in a LL from which electrons get scattered at the junction. For the sim plest case of two-wires, the junction can be modeled as a back-scatterer while for the general case of multiple QW , the junction represents a more non-trivial quantum in purity which may not be as straightforw and to model m icroscopically.

For the two-wire system, it is well-known^{1,2} that in the presence of a scatterer, there are only two low energy xed points - (i) the disconnected xed point with no transm ission (i.e. the transm ission amplitude for incident electron or hole, t = 0 which is stable and (ii) the transmitting xed point with no relection (t = 1)which is unstable. M ore recently, the low energy dynam ics of multiple LL wires connected to a junction have also been studied in detail^{3,4,5,6,7,8,9,10} and several interesting xed points have been found, including continuous oneparam eter fam ilies of xed points¹¹. These studies have also been generalized theoretically^{12,13,14,15,16,17,18,19,20} to describe a junction of 1{D wires with superconductors and have also been generalized to include $spin^{21}$. Our recent work^{22,23,24} has generalized these studies to the case of superconducting junction of multiple QW . In such a system, due to the proximity of the superconductor, both electrons as well as holes take part in the transport which leads to very interesting transport properties at small bias resulting from the interplay of LL correlations and the proxim ity induced pair potential.

In this article, we study the case where two LL QW are coupled simultaneously to a bulk superconductor. The physical separation between the junctions of the twowires with the superconductor is of the order of the size of the Cooper-pair. This leads to the realization of a normal-superconductor-normal (NSN) junction which allows for direct tunneling of electrons from one wire to the other and also allows a nite am plitude for the crossed Andreev re ection (CAR) process^{25,26,27,28,29,30,31,32,33,34,35} in addition to the normal re ection and Andreev re ection (AR) processes.

In an earlier study of the NSN junction²³, we showed that the NSN junction hasm one than two xed points unlike the norm al two-wire junction (as mentioned above) or the junction of LL with a bulk superconductor (NS junction) which has only two xed points - (i) the Andreev xed point where the amplitude for Andreev re ection (AR), $r_A = 1$ and norm al re ection amplitude, r = 0 and which is unstable and (ii) the disconnected xed point where $r_A = 0$ and r = 1, and which is stable^{12,13}. We showed that there exists a xed point with intermediate values of transmission and re ection. Thus, the NSN junction is the minimum con guration which possesses non-trivial xed points with intermediate transmission and re ection amplitudes. In what follows, we will focus mainly on the NSN junction.

In the previous studies, a comprehensive analysis of the various possible perturbations allowed by symmetry around all the xed points of the NSN junction was lacking. In this article, we carry out a systematic stability analysis for each of the xed points obtained earlier in Ref. 23 for the NSN junction and we predict the power laws associated with all possible independent perturbations that can be switched on around these xed points. O ur analysis provides us with renorm alized values of the various transmission and re ection amplitudes around these xed point values which can then be used to obtain the Landauer-Buttiker conductances.

W e start with a brief review of the RG m ethod follow ed in R efs.2 and 4 where an S-m atrix form ulation was used to compute the linear conductance and inter-electron interactions inside the QW were taken into account by allowing the S-m atrix to ow as a function of the relevant energy scale (like temperature, bias voltage or system size) using an RG procedure. This m ethod works well when e-e interaction strength inside the QW is weak so that it can be treated perturbatively. This is usually referred to as the weak interaction renorm alization group (W \mathbb{R} G) procedure³⁶.

To benchm ark our calculation with known results, we rst calculate the complete set of all possible power laws associated with the independent perturbations that can be switched on around the time-reversal symmetry broken chiral xed points (CFP) and the time reversal symmetric G ri ths xed point (GFP) of a norm al junction of three LL wires⁴. Then we apply the same procedure to the case of the NSN junction. The strength of our formulations turned on around the various xed points lies in the fact that the same method is applicable to both norm alaswell as superconducting junctions of any number of QW.

Now, for the case of three LL wires meeting at a norm al junction, let us assume that the wires are param eterized by spatial coordinates x_i which go from zero to in nity with the junction being situated at $x_i = 0$ (i being the wire index). The junction can be param eterized by a 3 S-m atrix with diagonal elements r_{ii} and o diagonalelem ents tij. In the presence of e-e interactions, the RG equations can be derived^{2,4} by rst expanding the electron wave-function in each of the wires in term s of reected and transmitted electron waves (scattering wave basis). Then the amplitude of scattering of electrons from the Friedeloscillations in the wires can be deduced by using a Hartree-Fock decomposition of the e-e interaction term . Finally the RG equation is obtained by applying the poor-man's scaling approach³⁶. The RG equations for the entire S-m atrix can be written in a concise and compact from given by⁴

where, l = ln (L=d) is the dimension-less RG scale (L corresponds to the physical length scale or energy scale at which we are probing the system and d is the short distance or high energy cut-o). Here F is a diagonal matrix with $F_{ii} = r_{ii}=2$ and is the repulsive e-e interaction parameter which is related to the LL parameter K as $K = ((1)=(1 +))^{1=2}$.

A nalogously, the NSN junction can be described in terms of an S-matrix with elements describing transmission of both electrons and holes and their mixing at

the junction. The corresponding RG equation for the Smatrix was obtained by the present authors 22,23 which was an extension of Eq. 1 to the superconducting case. Here too for the NSN case, we will assume that the two wires are parameterized by spatial coordinates x_1 and x_2 where $x_1; x_2$ vary from zero to in nity and that the junction is at $x_1 = 0 = x_2$. The presence of the superconductor is encoded in the parametrization of the S-m atrix representing the junction. Of course, this way of accounting for the presence of the superconductor assum es that the superconductor in poses static boundary conditions on the two wires forming the NSN junction. This is a valid approximation as long as one is focusing on sub-gap transport properties of the junction. W e also assum e that the superconductor at the junction is a singlet superconductor; hence the spin of the incident electron or hole is conserved as it scatters o the junction. This results in a block diagonal form of the S-m atrix with each spin block being a 4 4 m atrix representing scattering of electrons and holes within the given spin sector.

The S-m atrix at the superconducting junction for the spin-up, spin-down, electron-hole and left-right sym metric (sym metry in wire index) case (suppressing the wire index) can be parameterized by r, the normal reection amplitude, r_A , the AR amplitude, t_A , the CAR amplitude^{25,26} and t, the transmission amplitude for both electrons and holes. The ferm ion elds can then be expanded around left and right Ferm i points on each wire as $_{is}(x) = _{I is}(x) e^{ik_F x} + _{O is}(x) e^{-ik_F x}$; where i is the wire index, s is the spin index which can be ";# and I(O) stands for incoming (outgoing) elds. Note that

 $_{I(O)}(x)$ are slowly varying elds on the scale of k_{F}^{-1} . Electrons with momenta k in vicinity of k_{F} , on each wire at position x is given by

where b_{ks} is the particle destruction operator and d_{ks} is the hole destruction operator and we have allowed for non-conservation of charge due to the proximity e ect induced by the superconductor. We then allow for shortrange density-density interactions between the ferm ions,

Following the procedure outlined in Ref. 23, we nd that the RG equation for the S-m atrix continues to be of the form given in Eq. 1, but now F is a non-diagonalm atrix,

where and ⁰ are the x-independent part of the mean eld amplitudes for Friedeloscillations and the proximity induced pair potential inside the QW respectively. Generalization to particle-hole non-symmetric situations will make this matrix asymmetric. It is worth pointing out that even though the expression for electron eld in Eq. 2 assumes particle-hole symmetry which leads to considerable simplication in the derivation for the RG equation (Eq. 1), our formalism is more general. The RG equation (with appropriate modication of the F matrix for the asymmetric case) will also hold for S-matrices representing situations where the wire index symmetry as well as the particle-hole symmetry is broken.

We will mainly focus on three di erent xed points – the CFP and GFP of a normal junction of three LL wires^{4,37} and the symmetric xed point $(SFP)^{23}$ of the NSN junction. First we discuss the stability around the CFP and GFP of a normal junction of three LL wires (Y - junction) to benchmark our calculation with known results⁴. As a rst step towards performing a system atic stability analysis, we need to obtain an S-m atrix which results from a very sm allunitary deviation from the xed point S-m atrix. Given the num ber of independent parameters of the S-m atrix dictated by symmetry and unitarity constraints, the most general deviation from the xed point S-m atrix can be obtained by multiplying the

xed point S-m atrix by another unitary matrix which is such that it allows for a straightforward expansion in terms of small parameters around the identity matrix. This is realized as follows -

where S_0 represents the xed point S-m atrix and j's (along with the identity $_0 = I$) are the eight generators of the SU (3) group which are traceless hem it ian m atrices. This can be straightforwardly generalized to the case of N wires by using SU (N) matrices. Perturbations around these xed points are characterized in terms of the j's. Of course, the resulting S-m atrix obtained in this way corresponds to a sm all unitary deviation when j's are sm all. To rst order in j's, Eq. 5 reduces to

Restricting the RHS of Eq.8 to linear order in j's, one then obtains nine coupled linear di erential equations. Next by applying a unitary rotation, we can decouple these coupled equations (Eq.8) and re-cast them in terms s of new variables 0_j (which are linear com binations of the original j). The equations are now given by

where _j is a real number corresponding to the power law' associated with perturbations turned on along each of the new nine eigen-directions ${}_{j}^{0}$. _j < 0 indicates that the given direction is stable and _j > 0 indicates that it is unstable. Here the non-diagonal _j are related to the diagonal ${}_{j}^{0}$ by _j = ${}_{i}U_{ji} {}_{i}^{0}$ where U is the diagonalizing rotation m atrix.

Hence we obtain all the power laws associated with the independent perturbations that can be switched on around a given xed point S-matrix. Now it is straightforward to show that the power laws associated with the CFP and GFP are given by [=2, =2, 0, =2, =2, =2, =2, =2, 0, 0] and [0, 0, 0, 0, 0, -=3, 2=3, 2=3,] respectively which is consistent with results obtained in Ref. 4⁴¹. The value zero corresponds to marginal directions while the values with positive or negative signs correspond to stable or unstable directions respectively. W e do not write the explicit form of the U matrix for the CFP and GFP as they are needed only for obtaining the explicit form of the power law correction to the xed point conductance which we do not calculate for these cases.

F inally, let us discuss the stability around the di erent RG xed points of the NSN junction. First we focus on the SFP of the NSN junction. In the presence of e-e interaction inside the QW , the incident electron (hole) not only scatters from the Friedel oscillations as an electron (hole) but also scatters from the proximity induced pair potential inside the QW as a hole (electron). Now the am plitude of both of these scattering processes are proportional to the e-e interaction strength inside the QW . The competition between these two scattering processes which actually arise due the same e-e interaction strength inside the QW leads to the presence of the new SFP where all the scattering am plitudes have interm ediate non-zero values. This fact is unique about this xed point and hence this xed point is the central focus of our discussion. Details of this xed point are further elaborated in the discussion at the end of this article.

We adopt the same procedure as described above for the three-wire junction but now with SU (4) generators. This is so because the full 8 8 S-m atrix describing the NSN junction has a block diagonal form with each spin block (up and down spin sectors) being represented by a 4 4 m atrix. Hence we have a unitary starting S-m atrix deviating from the xed point S-matrix (S₀), as given before by Eq.6, except that now the sum over j runs from 1 to 16 since j's now represent the fleen generators of the SU (4) group along with the identity matrix. The S₀ which describes the SFP²³ is given by $r = 1=2, t= 1=2, r_A = 1=2$ and $t_A = 1=2$. Note that the SFP is a particlehole, left-right symmetric xed point and hence the entire 4 4 S-matrix is determined completely by the above given four amplitudes for r;t;r_A;t_A.

We then solve Eq. 8 for this case with sixteen coupled equations up to the rst order in the small perturbations j's. We obtain the sixteen eigenvalues which correspond to the power laws around the sixteen eigendirections. These power laws around the various eigendirections can be listed as [0, 0, 0, 0, 0, 0], =2, =2, $\binom{0}{=2}$, $\binom{0$

Hence we note that there are ve marginal directions, two stable directions, four unstable directions and four other directions whose stability depends on the sign of

 0 . One of the most striking outcom es of this analysis is the fact that we obtain two power laws which are not just simple linear combinations of V (0) and V (2k_F). Instead, they appear as square roots of quadratic sum of these quantities. Our analysis actually leads to the rst demonstration of the existence of such power laws in the context of quantum in purity problems in LL theory and this is the central result of this article.

Having obtained the power laws the next task is to obtain an explicit expression for the Landauer-Buttiker conductance corresponding to perturbations around these

xed points along som e of the eigen-directions. Now note that the RG equation is expressed in term sof "swhereas the S-m atrix representing sm all deviations from the xed point is expressed in terms of 's. The two term inal linear conductance across the junction depends explicitly on the S-matrix element which are expressed in terms of 's (see Eq.6). Hence in order to obtain an expression for conductance in term s of the tem perature or the applied voltage dependence induced by e-e interaction, we need to st assign bare values to the various perturbations param eterized by ⁰s and then express the ⁰'s evolved under RG ow in terms of these bare values of 0 rs as 0 () = (= ${}_{0}$) ${}^{0}_{0}$ where corresponds to the energy scale at which we are probing the system (which can be either voltage bias at zero tem perature or tem perature at vanishing bias) and $_0$ is the high energy cuto expressed in terms of voltage or tem perature. Then by using the rotation m atrix which diagonalizes the coupled RG equations, we express 's in term s of ⁰'s written explicitly as a function of temperature or voltage. Finally plugging these renorm alized values of 's into the S-m atrix given by Eq. 6, we get all the transm ission and re ection amplitudes for the system as explicit functions of the tem perature or voltage carrying the specic power law sassociated with perturbations switched on along the eigen-directions. These amplitudes are now directly related to the linear conductances.

Now we will calculate expression for conductance for a simple case where only one of the ${}^{0} (= {}^{0}_{15})$ is turned on. For this we need the U matrix for this case which is given by

In the expressions of power law s given above, $= (g_2 \quad 2g_1)=2 \quad v_F$ and ${}_{0}^{0} = (g_1 + g_2)=2 \quad v_F$ where the bare values of g_1 (d) = V (2k_F) and g_2 (d) = V (0). In our stability analysis, we have assumed $< {}_{0}^{0}$ which is consistent with experimental observations³⁸. For the special case when $g_2 = 2g_1$, vanishes and only ${}_{0}$ survives.

It is very interesting to note that even though the Sm atrix corresponding to perturbation along $^{0}_{15}$ breaks both time reversal and electron-hole symmetry, the two term inal linear conductance restores particle-hole sym metry. Secondly it might be of interest to note the fact that the xed point conductance adm its correction along $^0_{15}$ which is linear in $^0_{15}$ and not quadratic. Normally when we perform a stability analysis around a xed point S-m atrix whose elements are constituted out of unim odular num bers (representing disconnected or perfectly connected xed points), it is always possible to identify various terms of the S-matrix, representing small unitary deviations from the xed point S₀-m atrix in term sofvarious tunneling operators which are perturbatively turned on around the xed point Ham iltonian. Hence a straight forward perturbative linear conductance calculation using the Ham iltonian along with the tunneling parts will suggest that the correction due to the S-m atrix representing sm all deviation from xed point S₀-m atrix must introduce correction to xed point conductance which are quadratic in terms of the deviation parameter. But this

argument applies only to those xed points which correspond to completely connected or disconnected wires and not to xed points which have intermediate values for various transmission and relation amplitudes like the SFP. In other words, an arbitrary deviation from SFP may not be easily representable as a tunneling operator. This explains why the linear dependence of the conductance on 0 and hence the corresponding power law dependence looks unconventional.

As a cross check, we see that we get back the power laws associated with the symmetric xed point⁴ of the four-wire junction once we substitute $^0 = 0$ in the expression for the power laws of the SFP for the NSN junction. A lthough our geometry does not correspond to the real junction of four LL wires, the presence of both electron and hole channelm in ics the situation of a four-wire junction. M ore speci cally, the symmetric xed point of the NSN junction (SFP) turns out to be identical to the symmetric xed point of the four-wire junction due to perfect particle-hole symmetry of the SFP when ⁰ is set to zero.

Next we enumerate and discuss the stability of the other xed points (RFP, AFP, TFP and CAFP) obtained in Ref. 23 for the NSN junction :

(a) $t = t_A = r_A = 0$; r = 1 (RFP) : This xed point turns out to be stable against perturbations in all directions. There are ten directions for which the exponent is - while two others with the exponents -(+ 0). The remaining four directions are marginal.

(b) $t = t_A = r = 0$; $r_A = 1$ (AFP) : This is unstable against perturbations in twelve directions. There are ten directions with exponent and two directions with exponent (+ ⁰). The remaining four directions are marginal, as for RFP.

(c) $r_A = t_A = r = 0$; t = 1 (TFP) : This xed point has four unstable directions with exponent , two stable directions with the exponent - ⁰ and the remaining directions are marginal.

(d) $r_A = t = r = 0$; $t_A = 1$ (CAFP) : This has four unstable directions with exponent and two stable directions with the exponent - ⁰ and the remaining directions are marginal.

Note the close similarity in stability between CAFP and TFP xed points. This can be attributed to the fact that both these xed points belong to the continuous family of marginal xed points de ned by the condition $\frac{1}{2}J^2 + \frac{1}{2}A J^2 = 1$. The entire family of xed points is marginal because for these xed points, the amplitudes for Friedel oscillation and pair potential in the wire vanish identically.

Hence, we notice that for the AFP only the scattering amplitude from the pair potential inside the QW is nonzero as only r_A is nonzero, and for RFP only the scattering amplitude from Friedel oscillations are non-zero as only r is nonzero. Furtherm ore, both for CAFP and TFP, the amplitude for scattering from the Friedeloscillations as well as from the pair potential is zero as in these cases both r and r_A are zero. So SFP is the only xed point for which both the amplitude for scattering from the Friedel oscillations and the pair am plitude are nite; hence, this xed point is nontrivial. Its very existence can be attributed to the interplay of these two di erent scattering processes arising from Friedel oscillations and the pair potential inside the wire. The conductance at this xed point gets contribution from both the elastic co-tunneling (CT) of electrons through the superconductor as well as through the crossed Andreev re ection (CAR) process. Since both electron and hole channels contribute with opposite signs to conductance, if we give a small perturbation around this xed point, we get an interesting non-monotonic behavior of the conductance $G_{\,\text{CT}}\,$. This e ect emerges due to the $G_{NSN} = G_{CAR}$ competition between the electron and the hole channel and it can be of interest from an experimental point of view. A loo note that at the SFP, CT amplitude of electrons t = 1=2 and the CAR amplitude $t_A = 1=2$. This m eans that if we have an incident spin-polarized beam of (say "up" polarized) electrons on the junction, when the junction is tuned to this xed point, 25% of the spin up

electrons get transm itted through the junction and 25% of the spin up electrons get converted to spin up holes as they pass through the junction. Hence the transm itted charge across the junction is zero on the average, but there is pure spin current owing out of the junction. E quivalently, we can think that the pure spin current is generated due to ow of two beam s of electrons of equal intensity, one with spin up electrons and the other with spin down electrons propagating in opposite directions. Therefore the SFP can be relevant for future spintronics applications. These points have been discussed in detail in R ef. 22.

To sum marize, we have laid down a scheme to perform a system atic stability analysis which works well for both norm al and superconducting junctions of multiple LL QW . Using our procedure, we reproduced the known power laws for the xed points of the three- and four wire junctions. Then we applied it to the NSN junction and established the existence of non-trivial power laws which are non-linear functions of V (0) and V ($2k_F$). Finally, we calculated the Landauer-Buttiker conductance associated with the perturbations switched on around these xed points and found the explicit voltage or temperature power law dependence.
