The possibility of Z (4430) resonance structure description in reaction

The possible description of Z (4430) as a pseudoresonance structure in 0 reaction, is considered. The analysis is performed with single-scattering contribution to 0 elastic scattering via D D₁ (2420) intermediate energy.

1. IN TRODUCTION

The resonance structure with mass M = 4433 4 2 M eV and width = $45^{+18+30}_{13} \text{ M eV}$ in the charged ⁰ was found by the Belle Colquarkonium system laboration [1]. On the other hand, BABAR Collaboration [2] did not see signi cant evidence for a Z (4430) signal in any of the processes investigated, neither in the total J= or (2S) m ass distribution, nor in the corresponding distributions for the regions of K mass for which observation of the Z (4430) signal was reported. Several mechanisms have been proposed to explain the properties of the new resonance [3]-[6]. In particular, Rosner [3] pointed out to the close by threshold of D₁ (2420)D (2010) state and suggested a mechanism of production of 0 in the decay B ! K Z (4430), Z (4430) ! + ⁰. The proximity of the threshold invokes a possible near-threshold singularity, either due to a pole of the amplitude (virtual or real loosely coupled bound state of D $_1\text{D}$) [3]–[5] or else due to the

In this letter we are trying to understand whether the Z (4430) resonance can be due to pseudoresonance mechanism known for d system [9]. We analyze the structure of the scattering am plitude for the reaction ⁰ ! ⁰ near the D₁D threshold in the same way as was done for d system near the 4 N resonance. It is well known that the peak in the cross section for pion-nucleon (N) scattering around T = 180 MeVis associated with the 4 (1232). An analogous peak is observed in the cross section for pion-deuteron (d) scattering near 4 N threshold shifted slightly in position and broadened with respect to the N peak (see Figure 1). Therefore, one can not exclude that the Z (4430) resonance, which lies near D_1D threshold could be connected to the D₁ (2420) resonance, as it takes place in the 4 (1232). The D₁ (2420) state with

threshold cusp [6].

m ass M = 2420^{+1+2}_{2} M eV and width = 20^{+6+3}_{53} M eV was observed in D (2010) invariant distribution. Therefore the dynam ical picture of the pion charmonium scattering in our approach is: the p-wave o - energy-shell charmonium decay to D D , then in the D scattering the creation of D₁ (2420) resonance. The diagram corresponding to this reaction is shown in Figure 2.

In our paper, rstly, we calculate the scattering am plitude for d system using a single B reit-W igner resonance for 4 (1232) and obtain a good description of 4 N resonance. Then we apply the same form ulas to

⁰ scattering in which the vertex of the ⁰! D D decay is calculated in the many channel form align developed in [8]. For simplicity reasons we didn't include rescattering terms which slightly shift the peak in the d case.

We pay a special attention to the in uence of different properties of deuteron and charmonium family. First of all its di erent size: the deuteron is a large object with size R_d 4.3 fm while charmonium ⁰ state has only R_0 0.5 fm. The analysis of the results and discussion are given in the last section.

2. THE AMPLITUDE FOR D SYSTEM

For the sake of sim plicity we neglect any spin dependence and write the single-scattering non-relativistic term for the d am plitude:

where $p = \tilde{k}^2 + m^2 + \tilde{k}^2 + m_d^2$ is the total invariant energy of the d system. In (1) the N amplitude depends on

The N amplitude will be truncated to include only the dom inant resonance p wave in the following way:

The deuteron wave function contains the deuteron pole:

with $= \frac{p_{m_N}}{m_D}$, m_D being the deuteron binding energy and c 0:4 G eV.

One can see in Figure 1 that the forward scattering $(k = k^0)$ amplitude has a quite good resonance form which agrees with the experiment result (see, for exam - ple [7]).

3. THE AMPLITUDE FOR ⁰ SYSTEM

The (p) in (1) for 0 system includes the propogator and overlapped integral of the process 0 ! D D

where $J(\mathfrak{g})$ is an overlapped matrix element between wavefunctions (nS) of the n-th charm onlum state and (1S) of D (D) mesons states, which were derived in the framework of many-channel formalism with decay channel coupling [8]:

here $c = \frac{1}{1+1}$ (, ! is the energy of heavy and light quarks in D meson); y_{123} is defined by the Dirac traces of the amplitude given in appendix. In eq. (7) (nS); (1S) are a series of oscillator wave functions which are tted to realistic wave functions. We obtain them from the solution of the Relativistic String Ham iltonian, described in [10], [11].

Figure 3 shows the squared ⁰ scattering am plitude averaging over vector polarization $\frac{1}{3}$ M f. As can be seen, the structure has a too large width and a peak located near energy $\frac{P}{s}$ 4:7 G eV and cannot be associated with Z (4430).

4. D ISCUSSION

A n important distinction between d and ⁰ is the di erence in the deuteron and charm onium sizes, p wave

decay 0 to D D is also signi cant. It is interesting that we can obtain a desirable resonance structure if 0 has admixture of the near-threshold state with size R 5 fm due to the coupling to the D D channel. In

this case the width turns out to be smaller p_{1} 60 M eV and the peak is shifted to the position p_{1} 4.5 G eV. This result is shown in Figure 4.

In our paper we have used dynam ical picture of pion interaction with heavy quarkonia corresponding to the diagram in Figure 2.0 ur analysis shows that there is no resonance near $\frac{P}{s}$ 4430 energy in the ⁰ system, unless an adm ixture of large size near-the-threshold state is taken into account.

APPENDIX

The vertex factor $y_{123} = \frac{p}{\sum_{1}\sum_{2}\sum_{3}}$ is calculated in the same way as in [8], namely from the D irac trace of the projection operators for the decay process, in our case this is (nS)! D D . Identify the creation operators as cic, cjd, ck d one has for the decay process

with the projection operators $= \frac{m_k !_{k-4} ip_1^{(k)} i}{2!_k}$, k= c,d. Here !_k is the average energy of quark in given meson (= 1:5 GeV, ! = 0:55 GeV), m_k is the pole mass of c and d quarks (m_c = 1:4, m_d 0). One can identifying the momenta of q; q; Q ; Q as in [8]:
