Electric Dipole M om ent of Dirac Fermionic Dark M atter

Abstract

The direct lim it of electric dipole m om ent (EDM) and direct search for dark m atter by EDM interaction are considered as including the electrom agnetic nuclear form factor, in case that the dark m atter candidate is a D irac particle. The W \mathbb{M} P electric dipole m om ent constrained by direct searches m ust be low er than 7 10²² e cm for W \mathbb{M} P m ass of 100 G eV to satisfy the current experim ental exclusion lim its at XENON10 and CDMS II. W e also consider the CP violation of EDM and the W \mathbb{M} P discovery by EDM intereaction in the future.

I. IN TRODUCTION

Dark matter (DM) has been postulated to explain various observations from gravitational e ects on visible matter and plays an important role to explain structure form ation and galaxy evolution. In recent years observations and the high precision analysis of the cosm ic m icrowave background radiation have provided spectacular con mation of the astrophysical evidence for DM, that is to say about quarter of the energy density of the universe is dark m atter. Dark m atter appears to be consisting of nonrelativistic particles that only interact gravitationally and perhaps by weak interaction. Mostly the coupling to photons is assumed to be nonexistent or very weak, so the electrom agnetic interactions have not been considered seriously. A possible scenario for electrom agnetic interaction of D irac ferm ionic dark m atter with nonzero magnetic dipolem om ent [1] has been considered in the standard model context. No additional particles are assumed except for the DM candidate near electroweak scale 1000 G eV). The various experim ental bounds was investigated [2, 3, 4] in the past and (10 a new experimental technique [5] for DM detection by electrom agnetic interaction has been suggested for nonzero dipoles. There is a DM scenario for the electrom agnetic interaction by the fractional or millie charged particles [7, 8], but the DM scenario is for the case that another m assless U (1) gauge boson, called paraphoton, exists beyond the standard m odel.

In this letter we consider electric dipole m on ent e ect of D irac ferm ionic dark m atter. The electric dipole m on ent (EDM) constrained by direct searches is investigated as considering the electron agnetic form factor of the nucleus. The W IM P-nucleus elastic scattering is due to spin independent interaction, that gives the W IM P electric dipole m on ent very strict bound since the W IM P-nucleus elastic scattering cross sections are enhanced by the square of nuclear charge (number of protons in the nucleus), Z^2 . The W IM P electric dipole m on ent constrained by direct searches m ust be lower than 7 10²² e on for W IM P m assolid GeV to satisfy the current experimental exclusion limits. W IM P electric dipole m on ent (EDM) [6] for the known D irac particles and the scenario that presented in Ref.[1] to investigate the W IM P detectability. A simple m odel (Lagrangian) with the com plex dipole coupling is also introduced. A lihough we consider that the interaction of EDM is suppressed by CP violation, the suppression could be compensated by the enhancement of spin independent interaction. W IM P could thus be detected by the EDM interaction in near future if the

suppression is not seriously sm all.

II. CONSTRAINTS FROM DIRECT SEARCHS

The detection of dark matter is controlled by their elastic scattering with a nucleus in a detector. In this case the t-channel exchange of a photon¹ is only possible as shown in Fig. 1, since the two interacting particles are distinguishable.

The e ective Lagrangian at the quark level m ay be described by

where d is the W IM P electric dipole m on ent, e is the electric coupling and e_q is an electric charge for the quark q.

In nonrelativistic case, the bi-spinor products m ay be expanded with respect to the low m om entum transfer. In the leading order of the m om entum transfer, only time component is taken.

The e ective interaction of W IM P with a nucleon is

where N stands for the proton (p) or neutron (n) and f_N is the elective coupling of W M P to nucleons. In this case, $f_p = 2e_u + e_d = 1$; $f_n = e_u + 2e_d = 0$. The contributions of the heavy quark (c; b and t) to W M P-nucleon cross section can be related to the gluon

contribution by QCD, but those appear in quark-antiquark pairs. So three valance quarks give the nucleon its global electric charge and the contributions of each valance quark in the nucleon add coherently.

The similar argument can be applied to the nuclei. The constructive coherent interactions give the squared scattering amplitude of the nucleus

where $S = \frac{1}{2}$ is the W IM P spin, Z is the nuclear electric charge (the number of protons in the nucleus) and $F^2(jq)$ is the electrom agnetic form factor that is related to the electric charge distribution in a nucleus. For the low momentum transfer, we cannot consider the large nuclei as a point particle. We need consider the charge distribution of the nucleons in a nucleus. We take the Helm form factor [10] that was introduced as a modi cation of the form factor for an uniform sphere multiplied by a gaussian to account for the soft edge of the nucleus.

where

is a spherical Bessel function of the rst kind, and where s ' 1 fm is the nuclear skin thickness and $R_1 = \frac{P}{R^2 - 5s^2}$ is an elective nuclear radius for nuclear radius R ' 12 fm A¹⁼³ for an atom ic nucleus of atom ic number A. This form factor is often referred as the "W oods-Saxon" form factor though this form factor is not that obtained from the Fourier transform of the W oods-Saxon density distribution.

The W IM P-nucleus di erential cross section results in

where $= e^2 = 4$ ' 1=137 is the electric ne structure constant. The cross section has the C oulom b-like singularity at $q^2 = 0$.

The expected event rate depends on $\mathbb{W} \mathbb{I} \mathbb{P}$ -nucleus cross section and the $\mathbb{W} \mathbb{I} \mathbb{P}$ ux on the Earth, so the event rate per unit target m ass and unit time is

where $_{\rm D}$ ' 0:3 GeV/cm³ is the local DM density in the solar vicinity and f (v) is the W IM P velocity distribution function in the frame of the detector.

W ith the relation $q^2 = 2m E_R$, the di erential event rate is

The nal form ula for the event rate per unit m ass and unit time is given by

with $v_{m in} = \frac{q}{\frac{E_{R}m}{2M_{r}^{2}}}$, $v_{0} = 220$ km/s is the circular speed of the Sun around the Galactic center and $v_{E} = 232$ km/s is the average velocity considered the Earth speed to the Sun. Considering the recoil energy ranges at Table I, the electric dipole moment of a W IM P constrained by direct searches must be lower than 7 10²² e cm for W IM P mass of 100 GeV.

III. ELECTRIC DIPOLE EFFECT

A. Theory of D ipole M om ents

The annihilation rates by EDM interaction are suppressed since the s-wave amplitude is zero due to CP violation, so EDM interaction cannot produce the right m agnitude of the relic density. To reach the therm all average of annihilation rate h $v_{rel}i'$ 0:62 pb, EDM has to be

very large (10¹⁶ e cm) and it is nuled out by direct searches for W IM P near electroweak scale. Simply, we give the relation between EDM and MDM, d =, where is MDM, and we consider the m inim alD irac ferm ionic dark m atter scenario with nonzero MDM [1]. W ith this relation, the parameter becomes a free parameter that would be constrained by EDM CP related phenom enology. The most simple model (Lagrangian) is with the complex dipole coupling. If the loop contributions to all the electrom agnetic dipole operators have very similar diagram atic structure², the electric Lagrangian m ay be represented with the complex dipole coupling D.

where P_L ; P_R are the left and right handed projectors and F is the electrom agnetic eld strength. The real part of the complex dipole coupling is consistent with m agnetic dipole and the imaginary part is for electric dipole. The relations with real dipoles are = p jcos and d = p jsin , where is the phase of electrom agnetic dipole operators. The relationship between dipoles is given by d = tan and = tan would account for all the phenom enology for CP violation of EDM.

The phase of dipole operators would be constrained by the exclusion limit of EDM [6] and anom alous MDM for the known D irac particles like muon or electron, = tan $2 \ 10^3$.

O ur candidate m ight not be am enable to this constraint, but we adopt this constraint to analyze EDM e ect for direct searches. Fig 2 shows the allowed parameter regions of EDM in m ass range 10 1000 G eV. The bold line on the border is for $= 2 \quad 10^3$, and M DM is taken in R ef.[1], that is constrained by the relic density.

B. W IM P D etectability

The cross sections are enhanced by the square of the nuclear charge Z^2 and this e ect m ight be able to compensate the suppression of EDM CP violation. Fig.3 shows the regions of the the expected event rates of Eq.(8) with the estimated EDM from the above agrument. The experimental exclusion limits of XENON10, CDM S II and SuperCDM S are included. The experimental sensitivities estimated by the current detectors, XENON10 [12] and CDM S II [13], are for 0.1 cpd/kg and the 1 10⁴ cpd/kg exclusion limit is considered for the planned detector, SuperCDM S [14], respectively. Traditionally, the results of the direct searches are presented in the form of the W IM P-nucleon cross section at the zero momentum transfer in the spin independent case, since such norm alized forms are useful to compare results for di erent types of nuclei. But the cross section is not de ned at the zero momentum transfer in this case, so we consider the predicted event rates and the experimental exclusion limits for event rates that estimated for the detectors.

The predictions are over exclusion limits for $= d = 2 \quad 10^3$ and W M P could be detected in near future by EDM interaction if CP violation of EDM is not seriously small. The discovery of W M P by EDM interaction can also be the key to disclose CP violation nature of EDM.

IV. CONCLUSION

The direct lim it of electric dipole m om ent (EDM) and direct search for dark m atter by EDM interaction has been considered in case that the dark m atter candidate is a D irac particle. The W \mathbb{M} P-nucleus elastic scattering is due to spin independent interaction, that gives the W \mathbb{M} P electric dipole m om ent very strict bound since the W \mathbb{M} P-nucleus elastic scattering cross sections are enhanced by the square of nuclear charge (num ber of protons in the nucleus), Z². The W \mathbb{M} P electric dipole m om ent constrained by direct searches m ust

be lower than 7 10^{22} e on for W IM P m ass of 100 G eV to satisfy the current experimental exclusion limits. A lthough we consider that the interaction of EDM is suppressed by CP violation, the suppression could be compensated by the enhancement of spin independent interaction. W IM P could thus be detected by the EDM interaction in near future if the suppression is not seriously small. The discovery of W IM P by EDM interaction can also be the key to disclose the nature of CP violation nature.
