# Soliton Solutions for ABS Lattice Equations: II: Casoratians and Bilinearization

#### Abstract

In Part I soliton solutions to the ABS list of multi-dimensionally consistent difference equations (except Q4) were derived using connection between the Q3 equation and the NQC equations, and then by reductions. In that work central role was played by a Cauchy matrix. In this work we use a different approach, we derive the $N$-soliton solutions following Hirota's direct and constructive method. This leads to Casoratians and bilinear difference equations. We give here details for the H -series of equations and for Q1; the results for Q3 have been given earlier.


## 1 Introduction

The analysis of integrability for discrete systems is now in active development. Discreteness introduces many complications in comparison with continuous integrability, mainly due to the lack of Leibniz rule for discrete derivatives. This also includes the fact that space-time itself has many discretizations.

The basic philosophy and definitions have been given in Part I [1], here we repeat only some essential ingredients. The underlying space is formed by a Cartesian square lattice and the dynamical equation is defined on an elementary square of this lattice. (There are other possible settings but even this case has not been fully analyzed.) As for the definition of integrability we choose "Consistency-around-the cube" (CAC) which is further explained in Section 2.1. With this choice of integrability many nice properties follow, including the existence of a Lax pair. Furthermore, with mild additional assumption one can classify the integrable models [2] and the "ABS list" is surprisingly short.

In this paper we construct multi-soliton solutions for the H -series of models in the ABS-list, as well as for the Q1 model. Our approach is constructive for each model and is

[^0]based on the approach of Hirota, as explained in Section 2.2. Some work on this problem already exists for the two highest members of the ABS-list, but the Q4 results in [3] is far from explicit and the result for Q3 [4] relied on a specific association with the NQC-model, which has been further elaborated in Part I.

We hope that the detailed analysis of the simpler models, for which everything can be made systematic and explicit, will provide further understanding on the soliton question and that it could be used for other models as well.

In the next section we will give the general background for our approach and then in subsequent sections we will go through the models H1, H2, H3 and Q1.

## 2 Generalities

### 2.1 Multidimensional consistency and the ABS list

As in Part I we only consider quadrilateral lattice equations defined by a multi-linear relation on the values at the four corners of an elementary square of Cartesian lattice, see Figure 2.1(a). Given a base point $u_{n m}=u$ we indicate the shifts in the $n, m$ directions by a tilde or a hat as described in Figure 2.1.

Multidimensional consistency is an essential ingredient in the construction of soliton solutions, the new dimensions standing for parameters of the solitons. The consistency is defined as follows: We adjoin a third direction and construct an elementary cube as in Figure2.1(b), the shifts in the new third direction are denoted by a bar, e.g., $u_{n, m, k+1}=\bar{u}$. On the base square we have the equation $Q(u, \widetilde{u}, \widehat{u}, \widehat{\widetilde{u}} ; p, q)=0$, and we now introduce the same equation with different variables on the sides and on the top, thus we will have altogether the following set of equations

Now considering Figure 2.1(b) we can have initial values given at black circles $(u, \widetilde{u}, \widehat{u}, \bar{u})$, and in order to compute the remaining four values we have six equations. We can use the

LHS equations in (2.1a), (2.1b), (2.1c) to compute $\widehat{\widetilde{u}}, \overline{\widetilde{u}}, \overline{\widehat{u}}$, respectively, and this leaves the three RHS equations from which we should get the same value for $\overline{\widetilde{\widetilde{u}}}$, and this implies two consistency conditions.

In [2] a classification of quadrilateral lattice equations was performed following the above definition of integrability, with two additional requirements on the equations: symmetry and the so called "tetrahedron property", which means that the computed value for $\overline{\widetilde{u}}$ should only depend on $\widetilde{u}, \widehat{u}, \bar{u}$ and not on $u$. The ABS list is the following:

where $h^{2}=f^{4}+\delta f^{2}+1$. This can be parameterized with Jacobi elliptic functions: $f(x)=k^{\frac{1}{4}} \operatorname{sn}(x, k), h(x)=\operatorname{sn}^{\prime}(x, k), \delta=-(k+1 / k)$. The simpler form of Q 4 given above was actually discovered later in [5].

The A-series is auxiliary in the sense that A1 goes to Q1 with $u \rightarrow(-1)^{n+m} u$ and A2 to $Q 3_{\delta=0}$ by $u \rightarrow u^{(-1)^{n+m}}$. We will not discuss them here.

### 2.2 Hirota's bilinear method

Our approach to soliton solutions is based on Hirota's bilinear method 6]. It has been very successful in the continuous case and it is expected to be equally fruitful in constructing discrete multi-soliton solutions. Hirota's idea was to make a dependent variable transform into new variables, for which the soliton solution would be given by a polynomial of
exponentials. In terms of these new dependent variables the dynamical equations were quadratic and derivatives appeared only in terms of Hirota's bilinear derivatives.

But what would be the natural discrete generalization? The essential property of an equation in Hirota's bilinear form seems to be its gauge invariance (cf., [7] in the continuous case) and it has a natural discrete extension, leading us to the following definition:

Definition 1. We say an equation is in Hirota bilinear (HB) form if it can be written as

where the index sums $\nu_{j}^{+}+\nu_{j}^{-}=\nu^{s}, \mu_{j}^{+}+\mu_{j}^{-}=\mu^{s}$ do not depend on $j$. (The functions $f, g$ may be the same.)

Proposition 1. Equations in HB form are gauge invariant, i.e., if functions $f_{j}, g_{j}$ solve a set of equations in HB form, then so do the gauge transformed functions

Proof. We find
$f_{j}^{\prime}\left(n+\nu_{j}^{+}, m+\mu_{j}^{+}\right) g_{j}^{\prime}\left(n+\nu_{j}^{-}, m+\mu_{j}^{-}\right)=A^{2 n+\nu_{j}^{+}+\nu_{j}^{-}} B^{2 m+\mu_{j}^{+}+\mu_{j}^{-}} f_{j}\left(n+\nu_{j}^{+}, m+\mu_{j}^{+}\right) g_{j}\left(n+\nu_{j}^{-}, m+\mu_{j}^{-}\right)$
but since the overall factor is the same in each term of the $j$-sum in (2.2) it can be taken out.

For integrable equations in HB form there is a perturbative technique which leads to multi-soliton solutions, more or less algorithmically. This is described in the next section.

### 2.3 Constructing background solutions

First we have to construct the background or vacuum or seed solution, on top of which the soliton solutions are constructed. To do this we use the fixed-point idea [3] in which the consistent equations (2.1) are used with the assumption that $u=\bar{u}$. However, since some equations are invariant under $u \rightarrow T(u)$ it is actually sufficient that $\bar{u}=T(u)$. We only consider global invariances (that is, the transformation $T$ is independent of $n, m$ ) and in order to keep the multi-linearity we assume that the transformation is linear fractional:

Depending on the equation there will be conditions on the parameters $c_{i}$. It is straightforward to find the invariances of the equations, they are given in Table 1. Note that the special cases with $\delta=0$ have a bigger invariance group. For Q4 there are various special cases depending on which limiting case of the elliptic parameterization one chooses.

For each invariance $T$ of a given equation we then need to solve

& Q(u, \widetilde{u}, T(u), T(\widetilde{u}) ; p, r)=0  \tag{2.5a}\\
& Q(u, \widehat{u}, T(u), T(\widehat{u}) ; q, r)=0 \tag{2.5b}
\end{align*}

in order to obtain the corresponding background solution (here $r$ is a parameter of the solution). Such a solution then automatically solves (2.1a) by virtue of CAC.

It may be possible to construct still further solutions that can be called "background solutions", but we will not consider them here.

### 2.4 Constructing 1-soliton solutions

Once the background solution is obtained we construct a one-soliton solution (1SS) using the CAC cube once more, with $\bar{u}$ now being the 1SS. This amounts, in fact, to a Bäcklund transformation (BT).

Thus the first task is to solve

where we take

\begin{equation*}
\bar{u}=\bar{u}_{0}+v . \tag{2.7}
\end{equation*}
$$

Here $\bar{u}_{0}$ is the background solution and the bar-shift stands for possible modifications to get the $v$-equations into a suitable form. Then solving for $\widetilde{v}$ and $\widehat{v}$ from (2.6) we get (for quadratic $Q$ )

where $E, F, G, H$ may depend on $n, m$. The bar-shift modification in $u_{0}$ is to be chosen so that the numerators have no constant term. By introducing $v=g / f$ and $\Phi=(g, f)^{T}$ we can write (2.8) as a matrix equation

where

where $E, F, G, H$ may depend on $n, m$. The constants of separation $\Lambda, \Lambda^{\prime}$ are to be chosen so that $\widehat{\widetilde{\Phi}}=\widetilde{\widetilde{\Phi}}$. In all cases studied in this paper it turns out that

where $S, T, \sigma, \tau, \Delta, \Omega$ are constants and $U_{n m}$ some function of $n, m$ (sometimes $U_{n m}=1$ ). If we now introduce $\Psi$ by

then for $\Psi$ we have

\end{array}\right) \Psi(n, m), \quad \Psi(n, m+1)=\left(\begin{array}{cc}
T & 0 \\
\tau & \Omega
\end{array}\right) \Psi(n, m)

These are compatible if

$$

\frac{\sigma}{S-\Delta}=\frac{\tau}{T-\Omega}, \tag{2.14}
\end{equation*}

and in that case it is easy to derive

\frac{\tau}{T-\Omega}\left(S^{n} T^{m}-\Delta^{n} \Omega^{m}\right) & \Delta^{n} \Omega^{m}

From this we can construct $\Phi(n, m)$ and then $v$ : Introduce

and then $v$ can be written as

v_{n, m}=\frac{U_{n, m} \frac{v_{0,0}}{U_{0,0}} \rho_{n, m} / \rho_{0,0}}{1+\frac{\tau}{T-\Omega} \frac{v_{0,0}}{U_{0,0}}\left(\rho_{n, m} / \rho_{0,0}-1\right)} . \tag{2.17}

Now redefining the constant $\rho_{0,0}$ we can also write this as

v_{n, m}=U_{n m} \frac{T-\Omega}{\tau} \frac{\rho_{n, m}}{1+\rho_{n, m}} . \tag{2.18}

### 2.5 N -soliton solutions and Casoratians

Having a 1 SS in the form mentioned above allows us to propose a change of dependent variables such that the original equation is given in terms of discrete equations in HB form. These equations will then be shown to have solutions given in Casorati determinant form, corresponding to the Wronskian form solutions for continuous HB equations. We will now discuss some generalities about the Casoratians.

In general the Casorati matrix is constructed as follows: given functions $\psi_{i}(n, m, l)$ we define the column vector

and then the generic $N \times N$ Casorati matrix is composed of such columns with different shifts $l_{i}$, with the determinant

\begin{equation*}
C_{n, m}\left(\psi ;\left\{l_{i}\right\}\right)=\left|\psi\left(n, m, l_{1}\right), \psi\left(n, m, l_{2}\right), \cdots, \psi\left(n, m, l_{N}\right)\right| . \tag{2.19b}
\end{equation*}
$$

Two typical Casoratians that will be used later are

$$
\begin{align*}
C_{n, m}^{1}(\psi) & :=|\psi(n, m, 0), \psi(n, m, 1), \cdots, \psi(n, m, N-1)| \\
& \equiv|0,1, \cdots, N-1| \equiv|\widehat{N-1}|  \tag{2.19c}\\
C_{n, m}^{2}(\psi) & :=|\psi(n, m, 0), \cdots, \psi(n, m, N-2), \psi(n, m, N)| \\
& \equiv|0,1, \cdots, N-2, N| \equiv|\widehat{N-2}, N| \tag{2.19d}
\end{align*}
$$

where we have also introduced the standard shorthand notation [9] in which only the shifts are given, and where furthermore sequential changes in the column index are indicated by a hat: $|0, \cdots, M, \ldots| \equiv|\widehat{M}, \ldots|$. We also denote $|\widetilde{N-1}|=|1,2, \cdots, N-1|$.

In the Casoratians used in this work the entries $\psi_{i}$ in the $N$ th-order vector (2.19a) are given by

\psi_{i}(n, m, l)=\varrho_{i}^{+}\left(a+k_{i}\right)^{n}\left(b+k_{i}\right)^{m}\left(c+k_{i}\right)^{l}+\varrho_{i}^{-}\left(a-k_{i}\right)^{n}\left(b-k_{i}\right)^{m}\left(c-k_{i}\right)^{l}, \tag{2.20}
\end{equation*}
$$

where $\varrho_{i}^{ \pm}$and $k_{i}$ are parameters (and in some cases $c=0$ ). In this form the shifts in $l$ (bar-shifts) are not in any way special and therefore we can equally well define Casoratians where the shifts are in $n$ (tilde-shifts) or in $m$ (hat-shifts). For later use we indicate these three different shifts by the shift operators $E^{\nu}, \nu=1,2,3$, respectively, i.e.,

E^{1} \psi \equiv \widetilde{\psi}, \quad E^{2} \psi \equiv \widehat{\psi}, \quad E^{3} \psi \equiv \bar{\psi}
$$

Down shifts are denoted by $E_{\nu}, \nu=1,2,3$, respectively.
We can now define a Casoratian w.r.t. the three different kinds of shifts,

|\widehat{N-1}|_{[\nu]}=\left|\psi, E^{\nu} \psi,\left(E^{\nu}\right)^{2} \psi, \cdots,\left(E^{\nu}\right)^{N-1} \psi\right|, \quad(\nu=1,2,3) . \tag{2.21}

we have

\left(E^{\nu}\right)^{j} \psi=\left[E^{\mu}-\left(\alpha_{\mu}-\alpha_{\nu}\right)\right]^{j} \psi, \quad \mu, \nu=1,2,3,
$$

and substituting this into (2.21) yields

When the Casoratians are constructed using $\psi$ of (2.20) the size on the matrix $N$ indicates the number of solitons and the set $\left\{k_{i}\right\}_{i=1}^{N}$ provides the "velocity" parameters of the solitons, while the parameters $\left\{\rho_{i}^{+}, \rho_{i}^{-}\right\}_{1}^{N}$ are related to the locations of the solitons (by gauge invariance only their ratio is significant).

We shall here mention that the bilinear equations we get in the paper are more or less similar to the Hirota-Miwa equation [11, 12 ]

(cf. (5.17|5.20)), or belong to the bilinear equations [13] which were derived by imposing the transformation [12]

on Sato's bilinear identity. The above transformation, referred to as Miwa transformation, provides a connection between continuous coordinates $\left\{x_{j}\right\}$ and discrete ones $\left\{l_{j}\right\}$, and transforms the basic continuous plane wave factor

into the discrete one

The discrete exponential function (2.28) corresponding to the plane wave factor $\rho_{i}$ (I-2.2), plays a central role in the discrete $\tau$ function in Hirota's exponential-polynomial form, while in Casoratians its counterpart has the form (2.20).

In most cases a bilinear equation that can be solved by an $N \times N$ Casoratian (or Casoratians) is reduced to a Laplace expansion of a $2 N \times 2 N$ determinant with zero value. For later convenience we give the following lemmas.
Lemma 1. [9]

$$
\begin{equation*}
\sum_{j=1}^{N}\left|\mathbf{a}_{1}, \cdots, \mathbf{a}_{j-1}, \mathbf{b a}_{j}, \mathbf{a}_{j+1}, \cdots, \mathbf{a}_{N}\right|=\left(\sum_{j=1}^{N} b_{j}\right)\left|\mathbf{a}_{1}, \cdots, \mathbf{a}_{N}\right| \tag{2.29}
\end{equation*}
$$

where $\mathbf{a}_{j}=\left(a_{1 j}, \cdots, a_{N j}\right)^{T}$ and $\mathbf{b}=\left(b_{1}, \cdots, b_{N}\right)^{T}$ are $N$-order column vectors, and $\mathbf{b} \mathbf{a}_{j}$ stands for $\left(b_{1} a_{1 j}, \cdots, b_{N} a_{N j}\right)^{T}$.

Lemma 2. [9] Suppose that $\mathbf{B}$ is an $N \times(N-2)$ matrix and $\mathbf{a}, \mathbf{b}$, c, d are $N$-order column vectors, then

$$
\begin{equation*}
|\mathbf{B}, \mathbf{a}, \mathbf{b}\|\mathbf{B}, \mathbf{c}, \mathbf{d}|-|\mathbf{B}, \mathbf{a}, \mathbf{c}\|\mathbf{B}, \mathbf{b}, \mathbf{d}|+|\mathbf{B}, \mathbf{a}, \mathbf{d} \| \mathbf{B}, \mathbf{b}, \mathbf{c}|=0 . \tag{2.30}
\end{equation*}
$$

In fact, the l.h.s. of (2.30) is just the Laplace expansion of the following $2 N \times 2 N$ determinant,

$$
\frac{1}{2}\left|\begin{array}{cccccc}
\mathbf{B} & \mathbf{0} & \mathbf{a} & \mathbf{b} & \mathbf{c} & \mathbf{d} \\
\mathbf{0} & \mathbf{B} & \mathbf{a} & \mathbf{b} & \mathbf{c} & \mathbf{d}
\end{array}\right| \equiv 0
$$

## 3 H1

### 3.1 Background solution and 1-soliton solution

### 3.1.1 The background solution

The H1 equation is given by

$$
\begin{equation*}
\mathrm{H} 1 \equiv(u-\widehat{\widetilde{u}})(\widetilde{u}-\widehat{u})-(p-q)=0 . \tag{3.1}
\end{equation*}
$$

Using the fixed point idea with transformation $\bar{u}=T(u)=u+c$ we get the side-equations of the CAC-cube in the form

$$
(\widetilde{u}-u)^{2}=r+c^{2}-p, \quad(\widehat{u}-u)^{2}=r+c^{2}-q .
$$

For convenience we absorb $r$ into $c^{2}$, and reparameterize $(p, q) \rightarrow(a, b)$ by

$$
\begin{equation*}
p=c^{2}-a^{2}, \quad q=c^{2}-b^{2} . \tag{3.2}
\end{equation*}
$$

and then the above equations factorize as

$$
\begin{equation*}
(\widetilde{u}-u-a)(\widetilde{u}-u+a)=0, \quad(\widehat{u}-u-b)(\widehat{u}-u+b)=0 \tag{3.3}
\end{equation*}
$$

Since the factor that vanishes may depend on $n, m$ we actually have to solve

$$
\begin{equation*}
\widetilde{u}-u=(-1)^{\theta} a, \quad \widehat{u}-u=(-1)^{\chi} b \tag{3.4}
\end{equation*}
$$

where $\theta, \chi \in \mathbb{Z}$ may depend on $n, m$. Furthermore, since the value of the exponent is only relevant modulo 2 and $n^{2} \equiv n \bmod 2$, the exponents must be linear combinations of $1, n, m, n m$ with coefficients 0 or 1 .

The integrability condition for (3.4) leads to

$$
b\left[(-1)^{\sigma}-(-1)^{\widetilde{\sigma}}\right]=a\left[(-1)^{\theta}-(-1)^{\widehat{\theta}}\right]
$$

and since $a, b$ are independent this just means that $\sigma=\sigma(m), \theta=\theta(n)$. Since these are defined modulo 2 we can have $\theta=t_{1} n+t_{0}, \sigma=s_{1} m+s_{0}$ where $t_{i}, s_{i} \in\{0,1\}$. Furthermore, since $a, b$ were only defined up to sign we may take $t_{0}=s_{0}=0$.

There are now two essentially different cases for each exponent, either $\theta(n)=0$ or $n$, and $\sigma(m)=0$ or $m$. The choice $\theta=0$ leads to a solution $u=a n+\ldots$ while $\theta=n$ leads to $u=-\frac{1}{2}(-1)^{n} a+\ldots$. These solutions can be combined, and thus we get the following set of possibilities for $u^{0 S S}$

$$
\begin{array}{r}
a n+b m+\gamma, \\
\frac{1}{2}(-1)^{n} a+b m+\gamma, \\
a n+\frac{1}{2}(-1)^{m} b+\gamma, \\
\frac{1}{2}(-1)^{n} a+\frac{1}{2}(-1)^{m} b+\gamma . \tag{3.5d}
\end{array}
$$

We could also try to get a background solution using the fixed point idea with the other transformation mentioned for H1 in Table 1, namely $\bar{u}=T(u)=-u+c$, but it produces the same set: with a reparameterization

$$
\begin{equation*}
p=r+\alpha^{2}, \quad q=r+\beta^{2}, \quad u=y+\frac{1}{2} c . \tag{3.6}
\end{equation*}
$$

the side-equations become

$$
\begin{equation*}
(\widetilde{y}-y-\alpha)(\widetilde{y}-y+\alpha)=0, \quad(\widehat{y}-y-\beta)(\widehat{y}-y+\beta)=0, \tag{3.7}
\end{equation*}
$$

which is as in (3.3). The constant $c$ can be absorbed into the constant $\gamma$ and the free parameter $r$ redefined when comparing (3.2),(3.6), and thus the background solutions are as in (3.5).

It seems that only (3.5a) leads to a soliton type solution so in the following we only consider it.

### 3.1.2 Constructing 1SS using a BT

The BT generating 1SS for H1 is

$$
\begin{align*}
& (u-\widetilde{\bar{u}})(\widetilde{u}-\bar{u})=p-\varkappa,  \tag{3.8a}\\
& (u-\widehat{\bar{u}})(\bar{u}-\widehat{u})=\varkappa-q . \tag{3.8b}
\end{align*}
$$

Here $u$ is the seed solution (3.5a), $\varkappa$ is the parameter in the bar-direction, and we search for a new solution $\bar{u}$ of the form

$$
\begin{equation*}
\bar{u}=\bar{u}_{0}+v, \tag{3.9}
\end{equation*}
$$

where $\bar{u}_{0}$ is the bar-shifted background solution (3.5a):

$$
\begin{equation*}
\bar{u}_{0}=a n+b m+k+\gamma, \tag{3.10}
\end{equation*}
$$

where $k$ is related to $\varkappa$ by

$$
\begin{equation*}
\varkappa=c^{2}-k^{2} . \tag{3.11}
\end{equation*}
$$

Substituting (3.5a), (3.9) and (3.10) into (3.8) yields the desired form

$$
\begin{equation*}
\widetilde{v}=\frac{E v}{v+F}, \quad \widehat{v}=\frac{G v}{v+H}, \tag{3.12}
\end{equation*}
$$

where

$$
E=-(a+k), \quad F=-(a-k), \quad G=-(b+k), \quad H=-(b-k)
$$

Now matrices $\mathcal{N}, \mathcal{M}$ defined in (2.10) are $n, m$ independent and since $E-F=G-H=$ $-2 k$ they commute and we can take $\Lambda=\Lambda^{\prime}=1$. Then, following the method presented in Section [2.4, we find

$$
\Phi(n, m)=\left(\begin{array}{cc}
E^{n} G^{m} & 0  \tag{3.13}\\
\frac{E^{n} G^{m}-F^{n} H^{m}}{-2 k} & F^{n} H^{m}
\end{array}\right) \Phi(0,0)
$$

and if we let

$$
\begin{equation*}
\rho_{n, m}=\left(\frac{E}{F}\right)^{n}\left(\frac{G}{H}\right)^{m} \rho_{0,0}=\left(\frac{a+k}{a-k}\right)^{n}\left(\frac{b+k}{b-k}\right)^{m} \rho_{0,0}, \tag{3.14}
\end{equation*}
$$

then we obtain

$$
\begin{equation*}
v_{n, m}=\frac{-2 k \rho_{n, m}}{1+\rho_{n, m}} \tag{3.15}
\end{equation*}
$$

Finally we obtain the 1 SS for H 1 :

$$
\begin{equation*}
u_{n, m}^{1 S S}=(a n+b m+\gamma)+k+\frac{-2 k \rho_{n, m}}{1+\rho_{n, m}} . \tag{3.16}
\end{equation*}
$$

### 3.2 Multi-soliton solutions

In an explicit form the 1 SS given above $[(3.16)$ with (3.14)] is

$$
\begin{align*}
u_{n, m}^{1 S S} & =a n+b m+\gamma+\frac{k\left(1-\rho_{n, m}\right)}{1+\rho_{n, m}} \\
& =a n+b m+\gamma-\frac{k\left[\varrho^{+}(a+k)^{n}(b+k)^{m}-\varrho^{-}(a-k)^{n}(b-k)^{m}\right]}{\varrho^{+}(a+k)^{n}(b+k)^{m}+\varrho^{-}(a-k)^{n}(b-k)^{m}}, \tag{3.17}
\end{align*}
$$

where we have separated $\rho_{0,0}$ to $\varrho^{-} / \varrho^{+}$.
The above suggests that the basic ingredient in constructing an NSS is $\psi$ of (2.20) with $c=0$, i.e.,

$$
\begin{equation*}
\psi_{i}\left(n, m, l ; k_{i}\right)=\varrho_{i}^{+} k_{i}^{l}\left(a+k_{i}\right)^{n}\left(b+k_{i}\right)^{m}+\varrho_{i}^{-}\left(-k_{i}\right)^{l}\left(a-k_{i}\right)^{n}\left(b-k_{i}\right)^{m} . \tag{3.18}
\end{equation*}
$$

Here the index $l$ is needed as a column index in the Casorati matrix.
The form of the 1SS (3.17) suggests a generalization to NSS, and after checking explicitly the 2 SS and 3 SS , we arrive at the following proposition:

Proposition 2. $N$-soliton solution for $H 1$ is given by

$$
\begin{equation*}
u_{n, m}^{N S S}=a n+b m+\gamma-\frac{g}{f}, \tag{3.19}
\end{equation*}
$$

where $f=|\widehat{N-1}|_{[3]}, g=|\widehat{N-2}, N|_{[3]}$, with $\psi$ given by (3.18).

Note that this solution is the same as (5.29) of Part I with $A=0$. Indeed using (I-2.1,2.3,2.8c) one finds that

$$
S^{(0,0)}-\sum k_{i}=\frac{g}{f},
$$

and the parameters $\varrho_{i}^{ \pm}$in (3.18) and $c_{i}$ in (I-2.3) are related by

$$
\begin{equation*}
\frac{\varrho_{i}^{+}}{\varrho_{i}^{-}}=\frac{c_{i}}{2 k_{i}} \prod_{j \neq i} \frac{k_{j}-k_{i}}{k_{j}+k_{i}} \tag{3.20}
\end{equation*}
$$

However, the solution (3.19) contains more freedom in the form of the additional parameter $c$, cf. (3.2) and (I-5.1d).

### 3.2.1 The bilinear form of H1

In order to prove Proposition 2 we write (3.1) in bilinear form. First we introduce a dependent variable transformation

$$
\begin{equation*}
u_{n, m}^{N S S}=a n+b m+\gamma-\frac{g_{n, m}}{f_{n, m}} . \tag{3.21}
\end{equation*}
$$

When this is substituted into (3.1) we get a rational expression quartic in $f, g$. In order to split this expression into bilinear equations we note that if $f=|\widehat{N-1}|_{[3]}, g=|\widehat{N-2}, N|_{[3]}$, then for $N=2$ one can quickly scan for possible equations solved by them from the set

$$
a_{0} g \widehat{\widetilde{f}}+a_{1} \widehat{g} \tilde{f}+a_{2} \widetilde{g} \widehat{f}+a_{3} \widehat{\widetilde{g}} f+a_{4} f \widehat{\widetilde{f}}+a_{5} \widehat{f} \tilde{f}+a_{6} g \widehat{\widetilde{g}}+a_{7} \widehat{g} \widetilde{g}=0
$$

and find the bilinear equations

$$
\begin{align*}
\mathcal{H}_{1} & \equiv \widehat{g} \tilde{f}-\widetilde{g} \widehat{f}+(a-b)(\widehat{f} \tilde{f}-f \widehat{\widetilde{f}})=0  \tag{3.22a}\\
\mathcal{H}_{2} & \equiv g \widetilde{\widetilde{f}}-\widehat{\widetilde{g}} f+(a+b)(f \widetilde{\widetilde{f}}-\widehat{f} \widetilde{f})=0 \tag{3.22b}
\end{align*}
$$

After this it is easy to show that
$\mathrm{H} 1 \equiv(u-\widehat{\widetilde{u}})(\widetilde{u}-\widehat{u})-p+q=-\left[\mathcal{H}_{1}+(a-b) f \widehat{\widetilde{f}}\right]\left[\mathcal{H}_{2}+(a+b) \widehat{f} \widetilde{f}\right] /(f \widehat{f} \widehat{\widetilde{f}})+\left(a^{2}-b^{2}\right)$, and thus the pair (3.22) can be taken as the bilinear form of (3.1).

### 3.2.2 Proof of the Proposition 2

Now it remains to show that the $f, g$ given in Proposition 2 solve equations (3.22). We prove (3.22a) in its tilde-hat-downshifted version,

$$
\begin{equation*}
\underset{\sim}{g} f\left(g{\underset{\sim}{x}}_{f}^{f}+(a-b)(\underset{\sim}{f} f \underset{\sim}{f}-f \underset{\sim}{f})=0 .\right. \tag{3.23}
\end{equation*}
$$

Comparing $\psi_{i}(n, m, l)$ given by (3.18) and (A.1), we can use the formulas given in Appendix A with $c \equiv 0$, and in this subsection we always have shifts in the $l$-index, i.e., we take $\kappa=3$ for the formulas in Appendix A. Let us write (3.23) as

$$
\begin{equation*}
-(a-b) f \underset{\sim}{f}+\underset{\sim}{f}(\underset{\sim}{g}+a \underset{\sim}{f})-\underset{\sim}{f}(\underset{\sim}{g}+b \underset{\sim}{f})=0 . \tag{3.24}
\end{equation*}
$$

In this formula, $f=|\widehat{N-1}|_{[3]}$, and for $\underset{\sim}{f}, f, \underset{\sim}{f}+a \underset{\sim}{f}, \underset{\sim}{f}$ and $g+b f$ we use (A.6k) with $\mu=1$ and $\nu=2$, (A.6a) with $\mu=2$, (A.7a) with $\mu=1$, (A.6a) with $\mu=1$ and (A.7a) with $\mu=2$, respectively. Then we have

$$
\begin{aligned}
& a^{N-2} b^{N-2}[-(a-b) f \underset{\sim}{f}+\underset{\sim}{f}(\underset{\sim}{g}+a \underset{\sim}{f})-\underset{\sim}{f}(g+b \underset{\sim}{f})] \\
= & -|\widehat{N-1}|_{[3]}|\widehat{N-3}, \psi(N-2), \underset{\sim}{\psi}(N-2)|_{[3]} \\
& +|\widehat{N-2}, \psi(N-2)|_{[3]}|\widehat{N-3}, N-1, \underset{\sim}{\psi}(N-2)|_{[3]} \\
& -|\widehat{N-2}, \underset{\sim}{\psi}(N-2)|_{[3]}|\widehat{N-3}, N-1, \psi(N-2)|_{[3]} \\
= & 0,
\end{aligned}
$$

where we have made use of Lemma 2 in which $\mathbf{B}=(\widehat{N-3})$, and $\mathbf{a}=\psi(N-2), \mathbf{b}=$ $\psi(N-1), \mathbf{c}=\psi(N-2)$ and $\mathbf{d}=\underset{\sim}{\psi}(N-2)$.

For (3.22b) we use its tilde-down-shifted version

$$
\begin{equation*}
\underset{\sim}{g} \widehat{f}-\widehat{g} \underset{\sim}{f}+(a+b)(\underset{\sim}{f} \widehat{f}-\underset{\sim}{\widehat{f}} f)=0, \tag{3.25}
\end{equation*}
$$

and rewrite it as

$$
-(a+b) f \underset{\sim}{f}+\widehat{f}(\underset{\sim}{g}+a \underset{\sim}{f})-\underset{\sim}{f}(\widehat{g}-b \widehat{f})=0,
$$

where $f=|\widehat{N-1}|_{[3]}$, and for $\widehat{f}, \widehat{f}, g+a \underset{\sim}{f}, \underset{\sim}{f}$ and $\widehat{g}-b \widehat{f}$ we use (A.61) with $\mu=2$ and $\nu=1$, (A.6c) with $\mu=2$, (A.7a) with $\mu=1$, (A.6a) with $\mu=1$ and (A.7b) with $\mu=2$, respectively. Then we have

$$
\begin{aligned}
& \frac{1}{\left|\Omega_{2}\right|} a^{N-2} b^{N-2}[-(a+b) f \underset{\sim}{f}+\widehat{f}(\underset{\sim}{g}+a \underset{\sim}{f})-\underset{\sim}{f}(\widehat{g}-b \widehat{f})] \\
= & -|\widehat{N-1}|_{[3]}\left|\widehat{N-3}, \psi(N-2), \stackrel{\circ}{E}^{2} \psi(N-2)\right|_{[3]} \\
& -\left|\widehat{N-2}, \dot{E}^{2} \psi(N-2)\right|_{[3]}|\widehat{N-3}, N-1, \underset{\sim}{\psi}(N-2)|_{[3]} \\
& +|\widehat{N-2}, \underset{\sim}{\psi}(N-2)|_{[3]}\left|\widehat{N-3}, N-1, \stackrel{\circ}{E}^{2} \psi(N-2)\right|_{[3]} \\
= & 0,
\end{aligned}
$$

where we have made use of Lemma 2 in which $\mathbf{B}=(\widehat{N-3})$, and $\mathbf{a}=\psi(N-2), \mathbf{b}=$ $\psi(N-1), \mathbf{c}=\underset{\sim}{\psi}(N-2)$ and $\mathbf{d}=\stackrel{\circ}{E}^{2} \psi(N-2)$.

## $4 \quad \mathrm{H} 2$

### 4.1 Background solution

The equation H 2 is given by

$$
\begin{equation*}
\mathrm{H} 2 \equiv(u-\widehat{\widetilde{u}})(\widetilde{u}-\widehat{u})-(p-q)(u+\widetilde{u}+\widehat{u}+\widehat{\widetilde{u}}+p+q)=0 . \tag{4.1}
\end{equation*}
$$

After reparameterization

$$
\begin{equation*}
p=r-a^{2}, \quad q=r-b^{2}, \tag{4.2}
\end{equation*}
$$

the equations on sides become

$$
\begin{equation*}
(\widetilde{u}-u)^{2}-2 a^{2}(\widetilde{u}+u)+a^{2}\left(a^{2}-2 r\right)=0, \quad(\widehat{u}-u)^{2}-2 b^{2}(\widehat{u}+u)+b^{2}\left(b^{2}-2 r\right)=0 . \tag{4.3}
\end{equation*}
$$

After the further substitution

$$
\begin{equation*}
u=y^{2}-\frac{1}{2} r \tag{4.4}
\end{equation*}
$$

the equations (4.3) factorize as

$$
\begin{array}{r}
(\widetilde{y}+y+a)(\widetilde{y}+y-a)(\widetilde{y}-y+a)(\widetilde{y}-y-a)=0 \\
(\widehat{y}+y+b)(\widehat{y}+y-b)(\widehat{y}-y+b)(\widehat{y}-y-b)=0 \tag{4.5b}
\end{array}
$$

Thus we have to solve

$$
\begin{equation*}
\widetilde{y}-(-1)^{\sigma} y=(-1)^{\theta} a, \quad \widehat{y}-(-1)^{\rho} y=(-1)^{\phi} b . \tag{4.6}
\end{equation*}
$$

where the exponents $\sigma, \theta, \rho, \phi \in \mathbb{Z}$ are again some linear combination of $1, n, m, n m$ with coefficients 0 or 1. Equations (4.6) are satisfied if
$\rho=n s_{2}+r_{1}, \quad \sigma=m s_{2}+s_{1}, \quad \theta=m \rho+\sigma+n\left(t_{n}+s_{1}\right)+t_{1}, \quad \phi=n \sigma+\rho+m\left(p_{m}+r_{1}\right)+p_{1}$,
but most of the freedom is superfluous: Since the sign of $y$ was left undetermined in (4.4) we can redefine

$$
y_{n, m} \rightarrow(-1)^{n m s_{2}+n s_{1}+m r_{1}} y_{n, m}
$$

and then the equations simplify to

$$
\widetilde{y}-y=(-1)^{n t_{n}+t_{1}} a, \quad \widehat{y}-y=(-1)^{m p_{m}+p_{1}} b,
$$

already analyzed after (3.4). Thus we find the possible background solutions $u_{n, m}^{0 S S}$ of the form

$$
\begin{align*}
& {[a n+b m+\gamma]^{2}-\frac{1}{2} r,}  \tag{4.7a}\\
& {\left[\frac{1}{2}(-1)^{n} a+m b+\gamma\right]^{2}-\frac{1}{2} r,}  \tag{4.7b}\\
& {\left[n a+\frac{1}{2}(-1)^{m} b+\gamma\right]^{2}-\frac{1}{2} r,}  \tag{4.7c}\\
& {\left[\frac{1}{2}(-1)^{n} a+\frac{1}{2}(-1)^{m} b+\gamma\right]^{2}-\frac{1}{2} r .} \tag{4.7d}
\end{align*}
$$

### 4.2 1-soliton solution

Note that H2 is invariant under simultaneous translation of $p, q$ by $t$ and $u$ by $-\frac{1}{2} t$. We use this freedom to eliminate $r$ in order to simplify the presentation.

Now we take (4.7a) as the seed solution to construct $u_{n, m}^{1 S S}$ for H 2 through its Bäcklund transformation

$$
\begin{align*}
(u-\widetilde{\bar{u}})(\widetilde{u}-\bar{u}) & =(p-\varkappa)(u+\widetilde{u}+\bar{u}+\widetilde{\bar{u}}+p+\varkappa),  \tag{4.8a}\\
(u-\widehat{\bar{u}})(\bar{u}-\widehat{u}) & =(\varkappa-q)(u+\bar{u}+\widehat{u}+\widehat{\bar{u}}+\varkappa+q) . \tag{4.8b}
\end{align*}
$$

where $u$ is the seed solution (4.7a) and we search for a new solution $\bar{u}$ of the form

$$
\begin{equation*}
\bar{u}=\bar{u}_{0}+v, \tag{4.9}
\end{equation*}
$$

where $\bar{u}_{0}$ is the bar-shifted background solution (4.7a):

$$
\begin{equation*}
\bar{u}_{0}=(a n+b m+k+\gamma)^{2}, \tag{4.10}
\end{equation*}
$$

with

$$
\begin{equation*}
\varkappa=k^{2} . \tag{4.11}
\end{equation*}
$$

Substituting these into (4.8) yields (2.10) with

$$
\begin{aligned}
E=-2(k+a)[(n+1) a+m b+\gamma], & F=-2(k-a)[n a+m b+\gamma], \\
G=-2(k+b)[n a+(m+1) b+\gamma], & H=-2(k-b)[n a+m b+\gamma] .
\end{aligned}
$$

and the corresponding matrices $\mathcal{N}, \mathcal{M}$ are compatible if we take

$$
\begin{equation*}
\Lambda=\Lambda^{\prime}=-1 /\left(2 U_{n m}\right), \quad U_{n, m}:=a n+b m+\lambda . \tag{4.12}
\end{equation*}
$$

With this $U$ we obtain (2.11) with

$$
\begin{equation*}
S=a+k, \quad \Delta=a-k, \quad T=b+k, \quad \Omega=b-k, \quad \sigma=\tau=-1 / 2 . \tag{4.13}
\end{equation*}

Proposition 3. The Casoratian type determinants $f, g$, $h$ and $s$ given in (4.20) with entries given by (3.18) solve the set of bilinear equations (4.21).

Since we only consider real $u$ the various possibilities can be represented as in (4.6). The analysis is then the same, especially since also here the sign of $y$ is undetermined in (5.3). Thus the solution for $y$ is as in (3.5) and for $u$ we have

= & (a+\delta)^{2} Z_{1}-(b+\delta)^{2} Z_{2}-(a+\delta)^{2}(b+\delta)^{2} Z_{3}
\end{aligned}
$$

with $Z_{j}$ defined in (6.15), which are zero in the light of Lemma 3.
Thus we have completed the proof for all bilinear equations.

## 7 Q1 with power background

### 7.1 Background solution with $T(x)=-x+c$

With fixed point defined by $T(x)=-x+c$ we use the reparameterization

$$
\begin{align*}
p & =\frac{1}{2} r\left(1-\cosh \left(\alpha^{\prime}\right)\right)=-\frac{1}{4} r(1-\alpha)^{2} / \alpha,  \tag{7.1}\\
q & =\frac{1}{2} r\left(1-\cosh \left(\beta^{\prime}\right)\right)=-\frac{1}{4} r(1-\beta)^{2} / \beta,  \tag{7.2}\\
x_{n m} & =A e^{y_{n m}}+B e^{y_{n m}}+c / 2, \quad \text { where } \quad A B=\delta^{2} r^{2} / 16, \tag{7.3}
\end{align*}
$$

and this leads to equations that factorize as in (5.4). Thus we get power type background solutions for $u$ :

$$
\begin{equation*}
u=\frac{1}{2} c+A \alpha^{n} \beta^{m}+B \alpha^{-n} \beta^{-m}, \quad A B=\delta^{2} r^{2} / 16 \tag{7.4}
\end{equation*}
$$

Here $c$ is related to translation freedom and $r$ to scaling freedom; in the following we take $c=0$.

### 7.2 1-soliton solution for $\mathrm{Q} 1^{\delta}$

In order to derive the 1 SS we use the BT (6.4) with the seed solution (7.4) with

\begin{equation*}
\bar{u}=\bar{u}_{0}+v \tag{7.5}
\end{equation*}
$$

where $\bar{u}_{0}$ is the bar-shifted background solution (7.4):

\begin{equation*}
\bar{u}_{0}=A \alpha^{n} \beta^{m} \kappa+B \alpha^{-n} \beta^{-m} \kappa^{-1}, \quad A B=\delta^{2} r^{2} / 16 \tag{7.6}
\end{equation*}
$$

and $\kappa$ is defined through

$$
\begin{equation*}
\varkappa=-\frac{r}{4}(1-\kappa)^{2} / \kappa . \tag{7.7}
\end{equation*}
$$

If we now define

$$
\begin{equation*}
U_{n, m}=A \alpha^{n} \beta^{m}-B \alpha^{-n} \beta^{-m} \tag{7.8}
\end{equation*}
$$

then it is straightforward to derive (2.11) from (6.4) with

$$
\begin{array}{lll}
S=\frac{r(1-\alpha)(1-\kappa)(1-\alpha \kappa)}{4 \alpha \kappa}, & \Delta=\frac{r(1-\alpha)(1-\kappa)(\alpha-\kappa)}{4 \alpha \kappa}, & \sigma=p, \\
T=\frac{r(1-\beta)(1-\kappa)(1-\beta \kappa)}{4 \beta \kappa}, & \Omega=\frac{r(1-\beta)(1-\kappa)(\beta-\kappa)}{4 \beta \kappa}, & \tau=q . \tag{7.10}
\end{array}
$$

On the basis of this we define $\rho$ as usual by

$$
\begin{equation*}
\rho_{n, m}=\left(\frac{S}{\Delta}\right)^{n}\left(\frac{T}{\Omega}\right)^{m} \rho_{0,0}=\left(\frac{1-\alpha \kappa}{\alpha-\kappa}\right)^{n}\left(\frac{1-\beta \kappa}{\beta-\kappa}\right)^{m} \rho_{0,0} \tag{7.11}
\end{equation*}
$$

where $\rho_{0,0}$ is some constant. Then it follows that

$$
\begin{equation*}
v_{n, m}=\frac{\frac{1-\kappa^{2}}{\kappa} U_{n, m} \rho_{n, m}}{1+\rho_{n, m}} \tag{7.12}
\end{equation*}
$$

and finally we obtain the 1 -soliton for $\mathrm{Q} 1^{\delta}$ :

$$
\begin{align*}
u_{n, m}^{1 S S} & =\bar{u}_{0}+v_{n, m}  \tag{7.13}\\
& =\frac{A \alpha^{n} \beta^{m}\left(\kappa+\kappa^{-1} \rho_{n, m}\right)+B \alpha^{-n} \beta^{-m}\left(\kappa^{-1}+\kappa \rho_{n, m}\right)}{1+\rho_{n, m}}  \tag{7.14}\\
& =\frac{A^{\prime} \alpha^{n} \beta^{m}\left(1+\kappa^{-2} \rho_{n, m}\right)+B^{\prime} \alpha^{-n} \beta^{-m}\left(1+\kappa^{2} \rho_{n, m}\right)}{1+\rho_{n, m}} \tag{7.15}
\end{align*}
$$

where $A^{\prime} B^{\prime}=A B=\delta^{2} r^{2} / 16$.

### 7.3 Bilinearization

In order to get $\rho$ of (7.11) into a nicer form we use the Möbius transformations

$$
\begin{equation*}
\alpha=\frac{a-c}{a+c}, \quad \beta=\frac{b-c}{b+c}, \quad \kappa=\frac{k-c}{k+c}, \quad \Rightarrow p=\frac{r c^{2}}{a^{2}-c^{2}}, \quad q=\frac{r c^{2}}{b^{2}-c^{2}}, \tag{7.16}
\end{equation*}
$$

which leads to the canonical form

$$
\begin{equation*}
\rho_{n, m}=\left(\frac{a+k}{a-k}\right)^{n}\left(\frac{b+k}{b-k}\right)^{m} \rho_{0,0} \tag{7.17}
\end{equation*}
$$

With the above Möbius transformations Q1 ${ }^{\delta}$ (6.1) can be written as

$$
\begin{equation*}
\mathrm{Q} 1^{\delta} \equiv\left(b^{2}-c^{2}\right)(u-\widehat{u})(\widetilde{u}-\widehat{\widetilde{u}})-\left(a^{2}-c^{2}\right)(u-\widetilde{u})(\widehat{u}-\widehat{\widetilde{u}})-\frac{r^{2} \delta^{2} c^{4}\left(a^{2}-b^{2}\right)}{\left(a^{2}-c^{2}\right)\left(b^{2}-c^{2}\right)}=0 \tag{7.18}
\end{equation*}
$$

Using (7.17) and rearranging the parameters $A$ and $B$ we write the 1SS (7.15) as

$$
\begin{equation*}
u_{n, m}^{1 S S}=A \alpha^{n} \beta^{m} \frac{\psi(n, m, l+2)}{\psi(n, m, l)}+B \alpha^{-n} \beta^{-m} \frac{\psi(n, m, l-2)}{\psi(n, m, l)}, \quad A B=\delta^{2} r^{2} / 16 \tag{7.19}
\end{equation*}
$$

where $\psi$ is as in (2.20).
This structure motivates us to bilinearize Q1 ${ }^{\delta}$ through the following transformation,

$$
\begin{equation*}
u_{n, m}^{N S S}=A \alpha^{n} \beta^{m} \frac{\overline{\bar{f}}}{f}+B \alpha^{-n} \beta^{-m} \stackrel{f}{\bar{f}}, \quad A B=\delta^{2} r^{2} / 16 \tag{7.20}
\end{equation*}
$$

where $f=|\widehat{N-1}|_{[\nu]}(\nu=1,2$, or 3$)$ with entries (2.20) and the bar-shift is the shift in the third index $l$, as discussed in Sec. 2.5,

The solution (7.20) with $r=1$ is the same as (I-5.11) with $B=0$. In fact, by a comparison (7.16) with (I-3.17) one has

$$
\rho(a)=\alpha^{-n} \beta^{-m}, \quad \rho(-a)=\alpha^{n} \beta^{m}
$$

and substituting $\rho_{i}$ in (I-2.2) by (5.16) we find from (I-3.17) that

$$
(1+2 a S(-a,-a)) \times\left(\prod\left(k_{j}-a\right)^{2}\right)=\frac{\overline{\bar{f}}}{f}, \quad(1-2 a S(a, a)) /\left(\prod\left(k_{j}-a\right)^{2}\right)=\frac{\underline{\bar{f}}}{f} .
$$

Surprisingly Q1 ${ }^{\delta}$ can also be bilinearized with the same bilinear equations as $\mathrm{H} 3^{\delta}$, namely (5.17), and we have already shown in Proposition 4 that $f=|\widehat{N-1}|_{[\nu]}$ solves the $\mathcal{B}_{i}$ in (5.17).

The representation of $\mathrm{Q} 1^{\delta}$ (7.18) in terms of $\mathcal{B}_{i}$ is as follows:

$$
\mathrm{Q} 1^{\delta} \equiv \frac{\alpha^{4 n+2} \beta^{4 m+2}(a+c)^{2}(b+c)^{2} A^{2} \bar{P}_{1}-\alpha^{2 n} \beta^{2 m} \delta^{2} / 4 P_{2}-(a+c)^{2}(b+c)^{2} B^{2} \underline{P}_{1}}{\alpha^{2 n+1} \beta^{2 m+1}(a+c)^{2}(b+c)^{2} f \tilde{f} \widetilde{f} \widetilde{f}}
$$

where

$$
\begin{aligned}
& P_{1}=Y \tilde{Y}-X \widehat{X}, \quad X=\mathcal{B}_{1}-2 c f \tilde{f}, \quad Y=\mathcal{B}_{2}-2 c f \widehat{f}, \\
& P_{2}=-(a+c)(a-c)(b+c)^{2}\left(\bar{X} \widehat{X}-4 c^{2} \bar{f} \widetilde{\bar{f}} \underline{\widehat{f}} \underline{\widetilde{\tilde{f}}}\right) \\
& -(a+c)(a-c)(b-c)^{2}\left(\underline{X} \widehat{\bar{X}}-4 c^{2} \underline{f} \underline{\tilde{f}} \widehat{\bar{f}} \widehat{\bar{f}}\right) \\
& +4 c^{2}(b+c)(b-c)\left(X \widehat{X}-4 c^{2} f \widetilde{f} \widehat{f} \widehat{\widetilde{f}}\right) \\
& +(b+c)(b-c)(a+c)^{2}\left(\bar{Y} \underline{\underline{Y}}-4 c^{2} \bar{f} \overline{\bar{f}} \underline{\tilde{f}} \underline{\tilde{\tilde{f}}}\right) \\
& +(b+c)(b-c)(a-c)^{2}\left(\underline{Y} \widetilde{\bar{Y}}-4 c^{2} \underline{f} \underline{\hat{f}} \widetilde{\bar{f}} \widehat{\bar{f}}\right) \\
& -4 c^{2}(a+c)(a-c)\left(Y \tilde{Y}-4 c^{2} f \widehat{f} \tilde{f} \widehat{\widetilde{f}}\right) \text {. }
\end{aligned}
$$

## 8 Conclusions

In this paper, companion to [1] we have analyzed the soliton solutions to the models H1, H2, H3, and Q1 in the ABS list [2] of partial difference equations. Our method is constructive, progressing in each case from background solution to 1SS to NSS and bilinearization.

Our approach is fairly algorithmic, and as such we hope that it will be usable also for other models with multidimensional consistency. One interesting feature is that in some cases we need several bilinear equations, some of which seem to have the same continuum limit. This is a remainder that there are several ways to discretize a derivative.

## B Proof for the formulas in Appendix A

The formulas (A.5) can directly be verified. In (A.6)- A.8), those only containing down shifts $E_{\mu}$ and $E_{\nu}$ can be proved by using the relations (A.5). Since $a, b$ and $c$ appear in $\psi_{i}$ equivalently, we take $\mu=1, \nu=2$ and $\kappa=3$ in the following proof.

From (A.5a) we have

Using (B.1) for $f_{[3]}$ we first find

and repeating this $N-1$ times we get

(a-c)^{N-1}{\underset{\sim}{[3]}}=|\psi(0), \ldots, \psi(N-2), \underset{\sim}{\psi}(N-1)|_{[3]}=|\widehat{N-2}, \underset{\sim}{\psi}(N-1)|_{[3]} .

This is formula (A.6b). Again using (B.1) and expressing $\underset{\sim}{\psi}(N-1)$ through $\psi(N-2)$ and $\underset{\sim}{\psi}(N-2)$ in the above formula yields

They are related to $f_{[3]}, g_{[3]}$ and $h_{[3]}$ through
