A two-dim ensional paradigm for symmetry breaking: the nonlinear Schrodinger equation with a four-well potential

We study the existence and stability of localized states in the two-dimensional (2D) nonlinear Schrodinger (NLS)/G ross-P itaevskii equation with a symmetric four-well potential. U sing a fourmode approximation, we are able to trace the parametric evolution of the trapped stationary modes, starting from the corresponding linear limits, and thus derive the complete bifurcation diagram for the families of these stationary modes. The predictions based on the four-mode decomposition are found to be in good agreement with the numerical results obtained from the NLS equation. A ctually, the stability properties coincide with those suggested by the corresponding discrete model in the large-amplitude limit. The dynamics of the unstable modes is explored by means of direct simulations. Finally, while we present the full analysis for the case of the focusing nonlinearity, the bifurcation diagram for the defocusing case is brie y considered too.

I. IN TRODUCTION

In the recent years, there has been a considerable e ort on experimental and theoretical studies of B ose-E instein condensates (BEC s) [1, 2]. Many of these studies were focused on macroscopic nonlinear structures that arise in BEC s, which often have counterparts in nonlinear optics [3]. One of the appealing features of this setting is the possibility to tailor the desirable geometry of magnetic, optical, or combined traps that con ne the ultracold bosonic atom s. For this reason, the analysis of the existence, stability and dynam ical properties of nonlinear boalized states trapped in these geometries have become a focal point of research. The theoretical analysis is enabled by the fact that a very accurate description of dilute atom ic BECs is furnished, in the mean-eld approximation, by the G ross-P itaevskii (GP) equation, which is a variant of the nonlinear Schrödinger (NLS) equation. The cubic nonlinearity in the GP equation originates from the interatom ic interactions, accounted for through an elditive mean-eld. The NLS equation in this, as well as in somewhat di erent form s, is relevant to a variety of alternative physical applications in nonlinear optics and other areas [3, 4, 5].

A m ong the trapping con gurations available in current BEC experiments, one that has drawn considerable attention is the double-well potential (DWP). Its prototypical realization is provided by the a strong parabolic (harmonic) trap combined with a periodic potential, which can be created as an \optical lattice", by a set of coherent laser beams illuminating the condensate [1, 2, 4]. The DWP was realized experimentally in [6], using the magnetic eld to induce the parabolic trap. The experiments reported in Ref. [6] revealed a variety of fundamental elects, including tunneling and Josephson oscillations for a small number of atoms, or macroscopic quantum self-trapping leading to a stable asymmetric partition of atoms between the wells for a su ciently large number of atoms. DWPs have also inspired theoretical studies of various topics, such as nite-mode reductions, nding exact analytical results for specially designed shapes of the potential, quantum elects [7, 8, 9, 10, 11, 12, 13, 14, 15], and a nonlinear DWP (alias double-well pseudopotential), which is induced by the respective spatial modulation of the nonlinearity coelise, including twin-core selfguided laser beams in Kerr media [17] and optically-induced waveguiding structures in photorefractive crystals [18].

The aim of the present work is to extend the analysis of the DWP to a two-dimensional (2D) setting. Unlike previous studies of the trapping of quasi-2D BECs under the combined action of harm onic traps and optical-lattice potentials [19], we implement a Galerkin-type few-mode reduction to deduce a discrete model, based on a symmetric set of four wells, which is the most natural conguration in the 2D case. The same model can also be realized in optics, using a bulk nonlinearm edium with a set of four embedded waveguiding rods. In that setting, we use numericalmethods to generate a bifurcation diagram for possible stationary states of the system. It is worth noting that all the states that are expected on the basis of a four-site discrete nonlinear Schrödinger (DNLS) reduction [20] are also obtained in the continuum model with the combined parabolic and periodic potential considered herein. Furtherm ore, their stability, in the large nonlinearity limit, coincides with what is expected from the DNLS model.

The paper is structured as follows. In section II, we present the model and the derivation of the four-mode approximation. Numerical results are reported in section III. We present complete bifurcation diagrams of the possible stationary states for both the underlying GP equation and for its four-mode reduction. Comparison between them demonstrates very good agreement. In addition to the study of the existence and stability, evolution of unstable

m odes is explored too by m eans of direct num erical simulations. Finally, we sum marize our ndings in section IV, where we also discuss possible directions for further work.

We start by presenting the basic model in the quasi-2D setting, namely the NLS/GP equation in (2+1)-dimensions, which is expressed in the following dimensionless form [1, 2, 4]:

where u(x;y;t) is the norm alized wave function, the chem ical potential (is the propagation constant in the optical realization of the model), s = 1 corresponds, respectively, to repulsive or attractive interatom ic interactions in BEC (alias self-defocusing or self-focusing K err nonlinearity, in terms of nonlinear optics), and \hat{L} is the single-particle operator given by:

In Eq. (2), $\theta_x^2 + \theta_y^2$ is the 2D Laplacian, while V (x;y) is the four-well potential, assumed to take the following form,

with $r^2 = x^2 + y^2$. It is clear that V (x;y) is composed of a harm onic trap of strength and a periodic (O L) potential with strength V₀ and period d = =k. In the following analysis below, we adopt the following representative values for parameters of the potential: = 0.21, V₀ = 0.5 and k = 0.3, in which case the four smallest eigenvalues of operator \hat{L} are found to be




FIG.1: (Color online) The wave functions of the ground state, u_0 , and the rst three excited states, u_1 , u_2 and u_3 , for the four-well potential of Eq. (3) with = 0.21, V₀ = 0.5 and k = 0.3. Note the di erence in the grayscale (color, in the online version) bars in the rst and three others panels, related to the fact that the wave function of the ground state is positive, while the excited states feature sign-changing patterns.

In a weakly nonlinear setting, we implement the natural possibility of a four-mode approximation, based on a G alerkin-type expansion of (x;y;t) and truncation of the higher-ordermodes. We denote the ground and rst three excited eigenstates of the linear operator \hat{L} , shown in Fig. 1, as u_0 and $u_{1;2;3}$. This set constitutes a natural minimum basis for the G alerkin approximation in the system of four potential wells coupled by tunneling. Eigenstates u_j (j = 0;1;2;3) can be chosen to be real, given the H erm itian nature of the operator \hat{L} . Then, solutions of Eq. (1) for values of the drem ical potential in a vicinity of linear eigenvalues (4), may be approximated by linear combinations of the four eigenflictions.




FIG.2: (C olor on line) Basis modes f $_0$, $_1$, $_2$, $_3$ g that are localized in each of the wells.

A ctually, it is more convenient to use a transform ed basis, f $_0$, $_1$, $_2$, $_3$ g, as shown in Fig. 2, which is based on populations of the four wells. This basis is generated from the original set by a linear transform ation:

where the appropriate transform ation m atrix is

Each mode j (j = 0;1;2;3) is localized in one of the four wells, with the four of them constituting an orthonormal set.

U sing the new basis, we can readily reform ulate the four-m ode decom position as

with time-dependent complex amplitude $c_j(t)$, j = 0;1;2;3. Substituting Eq. (7) into Eq. (1) and projecting onto the orthonormal basis f₀, 1, 2, 3g, we derive, by m eans of straightforward algebra, the following system of four ordinary dimensions (ODEs),

with the sum mation performed over k; l;m = 0; 1; 2; 3. To cast these equations in a more compact form, we have

where 0 $!_0 + !_1 + !_2 + !_3$, $1 = !_0 + !_1$ $!_2$ $!_3$, 2 $!_0$ $!_1 + !_2$ $!_3$, and 3 $!_0$ $!_1$ $!_2 + !_3$. Notice that, for the underlying eigenvalues (4), one has $1 = \mathbb{R}^2 = !_0$ $!_3$ and \mathbb{R} 0. Furtherm ore, Eqs. (8) involve nonlinear cents given by overlap integrals, viz., A n $\frac{4}{n}$ dxdy, B mn $2 = \frac{2}{n}$ dxdy, D mn $\frac{3}{m}$ n dxdy, E mn $\frac{2}{1}$ m n dxdy, G 0 = 1 - 2 - 3 dxdy, with 1; m; n = 0; 1; 2; 3; these indices must be mutually di erent wherever they appear in the coe cients before the nonlinear term s.

For our choice of the parameters of the potential, the overlapping between modes $_{i}$ is weak (see Fig. 2), therefore all the overlap integrals are much smaller than the A_{n} 's. Neglecting these small overlap terms leads to the following simplication of Eq. (8):

It has been checked that the latter reduction of the four-mode equations very slightly a ects the accuracy of the solutions, while it renders the identi cation of various bifurcation branches signi cantly easier. Furthermore, this reduction is more convenient in simulations as we may use these solutions as inputs for generating num erical solutions of the full GP system, as explained below.

In this 2D setting, we seek both real and complex stationary solutions to the ODE system. Substituting $c_j(t)$ $_j(t)e^{i'_j(t)}$ into Eq. (10), we split them into real equations for $_j$ and $'_j$:

with the equations for $_{2,3}$ and $'_{2,3}$ obtained by interchanging the indices, 0 ! 2 and 1 ! 3, except for in $_0$ and 1.

Looking for solutions with constant j and j which are integer multiples of , we reduce Eqs. (11) - (14) to a set of four algebraic equations for j, which can be used to derive a complete set of stationary solutions of the fourm ode truncation. These were further used as initial guesses to nd num erical solutions of the full system of the GP equations. Moreover, our analysis of the fourm ode system indicates that nontrivial complex solutions in this setting are only possible in the form of discrete vortices, i.e., solutions with phase sets j = j=2, j = 0;1;2;3 [22], which have been studied in detail in Refs. [19] and [21] (we also brie y consider them here).

III. NUMERICAL RESULTS

A. Attractive interactions




FIG.3: (Color online) Top panels: squared norm N (norm alized num ber of atom s in BECs or power in optics) of num erically found solutions of Eq. (1) (left), and their counterparts predicted by the four-mode approximation (right), for attractive interatom ic interactions (s = 1), as a function of , i.e., respectively, the chemical potential or propagation constant. The bottom panels are segments of the top left panel. The (blue) solid lines and (red) dashed lines denote stable and unstable solutions, respectively. The branches are explained in the text and their pro les and stability are detailed in Figs. 4-7.

Let us rst present results of num erical simulations pertaining to attractive interactions (alias self-focusing nonlinearity) case, i.e., s = 1 in Eq.(1). Our basic bifurcation diagram, shown in Fig. 3, displays the squared L^2 norm of the solution (which physically describes the num ber of atom s in BECs or the power in optics), $N = j_1(x;y;t) j_2^2 dxdy$, as a function of the chemical potential. The left panel of Fig. 3 presents the full num erical bifurcation diagram, which involves twelve real and one complex solutions (for the latter solution, N is the same as one of the real branches, hence this branch is not visible as a separate curve in the diagram). The companion diagram in the right panel is obtained from the above-mentioned algebraic system for stationary solutions produced by the the four-mode reduction, and dem onstrates good agreement with its num erical counterpart.

The twelve real branches are labeled mainly according to their relation to the populations of the four wells. To support our explanation, we introduce a symbolic representation that we developed in the form of 2 - 2 matrices,

by indicating that a particular well is or is not populated, and the phase of the wave function in it being 0 or in the cases of + 1 and 1, respectively, when populated. Symbol " denotes either a sm all (but nonzero) population in one of the wells, or a symmetry-breaking e ect (when some of the density peaks feature values 1 ", thus being slightly di erent from 1). The labeling is then de ned as follows: branches A 1-A 4 have the same am plitude at the four wells as long as they are populated, branches B 1-B 3 feature two pairs of peaks with di erent am plitudes, branches C 1-C 4 have three di erent am plitudes, while D 1 has all of its four peaks di erent. The waveforms in the top rows of F igs. 4-7 display prototypical realizations of the relevant branches. Their stability properties are illustrated, as a function of eigenvalue parameter , in the bottom rows.

W e will now explain in detail solutions appearing in the full bifurcation diagram, starting from the linear lim its (N ! 0). First, we look at the group of solutions related to branch A1, as shown in the bottom left panel of Fig. 3. This branch arises from the symmetric linearm ode at $= !_0$, i.e., the ground state in the linear lim it, u_0 . A coordingly, A1 features four identically populated wells. The analysis demonstrates that it is stable near the linear lim it, but is soon destabilized, due to the emergence of branches C1 and B1, through subcritical and supercritical pitchfork bifurcations, respectively, around = 0.355. In other words, there are two consecutive steady-state bifurcations, in the language of R ef. [29], in two di erent subspaces, in which one unstable solution, C1, collides with A1 and, sim ultaneously, a pair of eigenvalues emerges on the realaxis for the A1 branch with the decrease of (in a subcritical pitchfork); then, a super-critical pitchfork takes place in another subspace, in which B1 retains only one real pair, while another pair passes through the origin along the A1 branch. The actual \pitchfork" cannot be visualized here in the usual manner, because any of the four equivalent versions of B1 (obtained by =2 rotation) have the sam e value of N, and so are represented by the sam e branch in the graph. Branch B1, which is unstable due to a pair of




FIG. 4: (Color online) Top panels show the proles of wave functions of branches A1, A2, A3 and A4 (from left to right) at = 0.34. The bottom panels display real parts of the unstable eigenvalues of the respective branches as functions of the parameter .




FIG.5: (Color online) Top: prodes of wave functions that represent branches B1, B2 and B3 (from left to right) at = 0.34. Bottom: real parts of unstable eigenvalues of the corresponding branches as a function of . The dashed-dotted line in the bottom right panel indicates a complex quartet of eigenvalues.

real eigenvalues in the linearization around it throughout its dom ain of existence, features two of the wells on one side being less populated than the other two. Con guration B1 becomes increasingly more asymmetric as it deviates from A1. A noteworthy feature is shown by branch C1, which bifurcates from A1 at alm ost the same place as B1: after having emerged, it tends to be located on the left of A1 as are all other branches bifurcating from A1. How ever, within a narrow interval of , its norm decreases (dN = d > 0) slightly before starting to grow as usual (dN = d < 0). Naturally, when the norm decreases the solution is destabilized and then it remains stable after the turning point, which is explained by the well-known Vakhitov-K olokolov criterion [23]. Branch A1 is endowed with two identical pairs of real eigenvalues by B1 and C1 upon their bifurcation (which is shown as the dashed line in the bottom left panel of Fig. 4.) As N grows further, a subsequent bifurcation, at = 0.3519, leading to the emergence of branch B2, adds yet another real eigenvalue pairs to A1; this means that A1 possesses in total three real eigenvalue pairs for su ciently large vaues of N. B ranch B2 features two wells on the diagonal which are less populated than the other two, and it is unstable, with two pairs of real eigenvalues, near the point where it is generated by the bifurcation from A1; how ever, one of the pairs is elim inated by the emergence of a new branch, C2, from B2 through a pitchfork

shortly afterwards. Branch B2 then remains unstable with one realpair, while C2 (with three principal sites, one of which is of lesser amplitude than the other two) is unstable due to two real eigenvalue pairs.

This description encompasses all branches of stationary solutions which can be traced back to the ground state of the linear system. Detailed information for the wave function proles and the development of the real eigenvalues associated to them is presented in Figs. 4-6.




FIG.6: (Color online) Top: proles of wave functions of branches C1, C2, C3 and C4 (from left to right) at = 0:34. Bottom : real parts of unstable eigenvalues of the corresponding branches as a function of the eigenvalue parameter .




FIG.7: (Color online) Left: the prole of wave function of branch D1 at = 0:34. Right: real parts of its unstable eigenvalues as a function of the eigenvalue parameter. The dashed-dotted line in the right panel indicates a complex quartet of eigenvalues.

Next we turn to the states originating from the second linear mode, as shown in the bottom right panel of Fig. 3. Branch A2 starts from the respective eigenvalue, $= !_1 = !_2$, which pertains to the rst and second (degenerate at the linear limit) excited states. This branch emerges as an unstable one, carrying a real eigenvalue pair. The respective wave function prole features four wells populated with the same amplitude but out-of-phase between the two sides, see Fig. 4. Branch B3 emerges from A2 through a supercritical pitchfork at = 0.3623, lending another real eigenvalue pair to A2. Similar to the case of B1 (as it separates from A1), in the B3 state two wells on the one side tend to be less populated than the other two, as this branch m oves further from A2. Branch B3 remains unstable with one real eigenvalue pair, until getting stabilized by another pitchfork bifurcation which takes place at

= 0:3589; this simultaneously gives rise to a new unstable branch, D1, that has di erent populations in all four wells. Notice that both B3 and D1 pass through a Ham iltonian-Hopfbifurcation (alias 1:1 resonance, in term s of Ref. [29]), which means that, in the relevant parametric interval (0:3362 < 0:348 for B3; 0:3444 < 0:3553 for D1), B3 is destabilized by a complex quartet of sm all eigenvalues in the linearization around the stationary solution, while D1 remains unstable, but with one real eigenvalue pair and a complex quartet (the dashed-dotted lines in the bottom right panels of Figs. 5 and 7 refer to this e ect).

Furtherm ore, branch A 4 bifurcates from the same linear mode as A 2. It is unstable near the linear limit due to a H am iltonian H opfbifurcation, but with the increase of N it becomes stable. B ranch A 4 features a waveform in which only two wells lying on the diagonal are populated, with the same am plitude but opposite signs.

B ranch A 3 arises from the third excited linear mode at $= !_3$. In this case, two wells on the diagonal are populated with equal amplitudes, while in the other two the amplitudes are of opposite signs. It is the unique stationary solution which remains stable across the entire bifurcation diagram (despite the fact that it has three pairs of purely in aginary eigenvalues with negative K rein signature [30], which in principle, can give rise to H am iltonian-H opf bifurcations).

Finally, branches C 3 and C 4, which are located slightly below A 2 in Fig. 3, correspond to a pair of states which arise through a saddle-node bifurcation at some critical value of chem ical potential (0.348, for the m odel's parameters chosen in the present case.) B ranch C 4 (the one with higher values of N) is unstable with a real eigenvalue pair, while C 3 rem aims stable, except inside a short instability interval, which is accounted for by a H am iltonian-H opf bifurcation.




FIG.8: (Color online) The absolute value (left) and phase (right) of a vortex state for = 0.34.

In addition to the above real stationary states, we have also found complex solutions in the form of vortices [19, 21]. A typical example of such a solution is shown in Fig. 8. Throughout the regime of parameters considered herein, such solutions have been found to be linearly stable.

It is interesting to note that, for all the solutions considered herein, in the large-N lim it their stability characteristics coincide with what can be suggested by the DNLS model considered in Ref. [22] (see also Refs. [24, 25] for the corresponding 1D and 3D stability results). G ross features of these indings are that, whenever two adjacent sites are in-phase, a real eigenvalue pair is expected to emerge due to their interaction, while whenever such sites are out-of-phase, the relevant eigenvalue is expected to be imaginary [26], but with negative K rein signature [22], which im plies a potential for a Ham iltonian-Hopf bifurcation. It should also be noted that, in the lim it of the in nite lattice, it is naturally expected that the asymmetries observed herein in many of the branches will disappear (i.e., the am plitudes in di erent wells will be equal) { see also a relevant discussion in Ref. [27].

B. Repulsive interactions




FIG. 9: (Color online) The norm of the numerical (left) and approximate (right) stationary solutions to Eq. (1) with the selfdefocusing nonlinearity (s = +1), as a function of the parameter (the chemical potential in BECs or propagation constant in optics). The labels of the branches are explained in detail in the text.

We now brie y discuss the case of repulsive interactions (alias self-defocusing nonlinearity), corresponding to s = +1 in Eq. (1), with an objective to highlight its similarities with and di erences from the case of attractive interactions. The bifurcation diagram for the model is displayed in Fig. 9.

The solutions are labeled so as to m atch the self-focusing case, by m eans of the appropriate staggering transform ation [28]. The latter electively converts the defocusing nonlinearity into a focusing one by changing the relative phase of nearest-neighbors from 0 to and vice versa, while preserving the relative phase of next-nearest-neighbors. In this way, each solution in the defocusing case is linked to its counterpart in the focusing m odel through this transform ation. Following this relation, and adopting the same m atrix symbolic representation used for the focusing case in section

Thus, in this case, the symmetric ground state of the system is A 3, which is stable for arbitrary values of N. B ranch A 2 is immediately unstable, starting from the linear limit. B 3 bifurcates from A 2 and remains unstable before getting stabilized through giving birth to D 1 (and then becoming destabilized again). B ranch A 1 is stable near the linear limit, but is subsequently destabilized due to bifurcations that give rise to B 1 and C 1, and an additional real eigenvalue pair arises at higher value of N due to the emergence of B 2, from which another new branch, namely C 2, arises in turn. B ranches C 3 and C 4 exist for a while (when N is large enough), and then collide at = 0.389 (for the values of parameters adopted herein). The types of the bifurcations, the emergence of the corresponding solutions, and the corresponding stability properties were found to be in direct correspondence to the case of self-focusing nonlinearity,

provided that one takes into account the staggering transform ation relating the repulsive and attractive case m odels as indicated above.

C. Dynam ics




FIG. 10: (Color online) The spatiotem poral evolution of unstable states, represented by the respective density isosurface, $ju(x;y;t) \hat{f} = k$, where constant k is taken as half the maximum value of the density distribution at t = 0. The results are arranged as follows. Top panels: A1, A2, A4; m iddle panels: B1, B2, B3; bottom panels: C2, C3, C4, D1.

We now proceed to investigate the evolution of unstable states in the model with the self-focusing nonlinearity. To this end, for each unstable branch, a small perturbation is added to the most unstable eigendirection of the linearization near the original stationary solution, at = 0.335. Results of the simulations are presented in Fig. 10.

Panel (a) shows the behavior of solution A1, which, as a result of the instability, starts oscillating between a state where all four wells are populated and one in which only two diagonal wells are not empty. Panel (b) depicts a periodic oscillatory behavior of A2, also between four and two populated sites, but in this case the continuously populated sites are adjacent to each other. Unstable m ode A 4 (panel (c)) features only two non-empty wells, with the symmetry-breaking instability resulting in the enhanced population of one of the two. As explained in section IIIA, modes B1, B2 and B3 have two very weakly populated wells, in comparison with the other two. Since we employ isosurface ju (x;y;t) f = k (where k is the half of the maximum density at t = 0) to plot the dynamics in Fig. 10, the evolution in the weakly populated wells is not visible (which indicates that they play a minor role in the dynamics). Panel (d) shows that mode B1 sustains a symmetry breaking similar to that of A4, but between adjacent sites. On the other hand, modes B2 and B3 appear to be oscillating between the two dom inant wells roughly periodically, as shown in panels (e) and (f). Mode C2 [in panel (g)] oscillates between three and two populated sites (the seem ingly empty well is actually a weakly populated one, sim ilarly to the modes of type B, see above). Mode C 3, whose weak instability is caused by a quartet of eigenvalues, is also \breathing" within the respective set of three predom inantly populated wells, as shown in panel (h). Finally, mode C 4 [shown in panel (i)] involves a complex symmetry-breaking pattern, with di erent numbers of wells populated at di erent times, while mode D1 (panel (j)) oscillates between three-and two-well asymmetric con gurations.

IV. CONCLUSION

In this work, we have studied stationary and dynamical properties of the two-dimensional nonlinear Schrodinger/G ross-P itaevskii equation, including a four-well external potential, with both signs of the nonlinearity, self-attractive (focusing) and self-repulsive (defocusing). The model applies to a BEC con ned in a highly anisotropic harm onic trap, with the transverse con ning frequency being much smaller than the axial one, which results in a planar con guration. In this context, the four-well potential can be generated by a combination of the transverse part of the harm onic trap and an optical lattice. The same model may describe the propagation of an optical beam in a bulk nonlinear medium with an embedded four-channel guiding structure.

In our analysis, rst we developed a four-mode approximation, which strongly simplies the identication of stationary solutions. Using this approximation, we were able to not the four (two of which are identical) symmetric

and antisym metric linear modes, and all branches of asym metric solutions emerging from them in the model with the self-focusing nonlinearity. The linear-stability analysis demonstrated how pitchfork and saddle-node bifurcations change the stability of the branches. We have shown that in the lim it of strong nonlinearity, properties of localized modes in the model with either sign of the nonlinearity can be, roughly, understood on the basis of earlier results pertaining to the corresponding discrete NLS model. We have also described the evolution of all unstable solutions, observing, typically, the emergence of symmetry-breaking instabilities and the emergence of respective oscillating solutions.

It would be interesting to investigate how these four-site con gurations may be embedded into a larger potential pattern, with 9 or 16 wells, and exam ine whether the sym metry-breaking bifurcations considered above are sustained (or how they are modi ed) within the larger pattern. In this context, a conjecture that would be worthwhile proving is that, in an in nite periodic lattice form ed by potential wells, the nonlinearity can support 2D solitons and localized vortices with various sym metries, but not con ned asym metric states. This conjecture is suggested by results reported for in nite linear [31] and nonlinear [32] potential lattices.
