Cubic String Boundary Value Problems and Cauchy Biorthogonal Polynomials

A bstract

C auchy B iorthogonal Polynom ials appear in the study of special solutions to the dispersive nonlinear partial di erential equation called the D egasperis-P rocesi (DP) equation, as well as in certain two-m atrix random m atrix m odels. A nother context in which such biorthogonal polynom ials play a role is the cubic string; a third order ODE boundary value problem $f^{00} = zgf$ which is a generalization of the inhom ogeneous string problem studied by M.G. K rein. A general class of such boundary value problems going beyond the original cubic string problem associated with the DP equation is discussed under the assumption that the source of inhom ogeneity g is a discrete measure. It is shown that by a suitable choice of a generalized Fourier transform associated to these boundary value problems one can establish a Parseval type identity which aligns C auchy biorthogonal polynom ials with certain natural orthogonal systems on L $_{q}^{2}$.

1 An ordinary inhomogeneous string, the Degasperis-Procesi equation and a cubic string

1.1 DP equation

The vibrating string is one of the most fundam ental physical phenomena, whose mathematical foundations go back at least to the times of D.Bernoulli with important contributions of J.B. Fourier, B.Riemann, S. Sobolev and M.G. Krein and it appears that the heated discussion of more rened aspects of the problem has not subsided. Of multiple reasons for the special role of the vibrating string two stand out: 1) this is the simplest problem with in nitely many degrees of freedom and as such it inevitably leads to questions of analysis on function spaces, in particular the eigenvalue problems for in nitely large matrices; 2) the vibrating string problem is a prototype of hyperbolic problems and plays an important role in basic mathematical education. In its simplest, one dimensional, form, one studies the partial dierential equation

for the amplitude of the string u(x;t). The coe cient $\frac{1}{c^2}$ is proportional to the mass density of the string and in principle it does not have to be hom ogeneous (constant) in x. Thus, in general, $\frac{1}{c^2} = \frac{(x)}{T}$, where T represents the tension in the string and (x) is the linear mass density of the string. Then the fundamental modes, $u(x;t) = v(x) \cos(t)$, are given by solving:

subject to some boundary conditions, corresponding physically to how the string is tied. The most common are the D irichlet boundary conditions, v(0) = v(1) = 0 (the string is tied on both ends), and the Neumann conditions, $v_x(0) = v_x(1) = 0$ (the end points can slide in the vertical direction only). Once equipped with the boundary conditions, say the D irichlet conditions, the problem is turned into an eigenvalue problem of the Sturm-Liouville type:

where $z = \frac{!^2}{T}$. Such an inhom ogeneous string problem was studied in an in uential work by M G . K rein [1] in the 1950s as a generalization of Stielties' theory of analytic continued fractions [2].

The present paper addresses several aspects of K rein's theory for a third order equation:

subject to some boundary conditions specied later. We will refer to this equation as the cubic string. Since any third order problem is non-self adjoint one can seriously doubt any applicability of this type of equation to physical systems. Below we brie y sketch how the cubic string has arisen in a study of certain

nonlinear partial di erential equation modeling weekly dispersive waves. The equation in question is the Degasperis-Procesi (DP) equation [3]:

To solve the original DP equation requires solving the spectral and inverse spectral problem as explained in detail in [5] for the case of the nite discrete measure m. Our goal in the remainder of the paper is to present a few essential aspects of the spectral problem associated to the cubic string for a variety of boundary conditions with the view towards explaining the role of a novel class of C auchy biorthogonal polynomials introduced in [6, 7]. These polynomials can be dened for arbitrary positive measures d; d supported on the positive part of the real axis R₊ provided that all (C auchy) bim oments $I_{ij} = \frac{x^i y^j}{x+y} d$ (x)d (y) are nite. One then denes polynomials g(y); g(y); g(y) of degree g(y); g(y) ing the biorthogonality condition g(y) are g(y); g(y) and g(y) are refer to these as C auchy biorthogonal polynomials.

2 Discrete cubic strings

We slightly generalize the cubic string discussed in the previous section in connection with the DP equation. We recall that in an ordinary string problem dierent boundary conditions correspond to dierent ways of tying down the ends of the string. For us, dierent boundary conditions will eventually lead to dierent spectral measures with respect to which we will de ne biorthogonal polynomials. However, in all cases discussed by us the spectrum is positive and simple, as one would expect from any vibrating system.

R em ark 2.1. For simplicity we have adjusted the length of the string; it is now 1 rather than 2.

We are only interested in the case where the mass distribution consists of a nite collection of point-masses:

We will consider all three boundary value problems mentioned above with this mass distribution, as well as one degenerate case in which the last mass is placed at 1 (i.e. $_{\rm n}$ = 1: in the latter case we take the right hand \lim it to compute the derivatives of f at 1. Moreover, for that case, we consider only the BVP of type 2.)

W e will collectively refer to all these cases as the discrete cubic string problem.

Wewill also use an accompanying initial value problem,

The boundary value problems in De nition 2.1 are not self-adjoint and the adjoint boundary value problems play an important role.

Since all three boundary value problems for satisfy the same initial value problem we will use one letter, namely , to denote the solution. However, we will attach an index a=0;1;2 to to indicate the type of the BVP; for example, 0 will refer to the BVP/IVP of Type 0 etc.

In the process of integration by parts of expressions like ${R_1 \atop 0}$ f ()h()d one identi es the relevant bilinear sym m etric form:

Furtherm ore, we also de ne a natural L^2 space associated with g, denoted $L^2[0;1]_g$, equipped with the inner product: $(f;h)_g = {R_1 \atop 0} f()h()g()d$. Whenever for g depend on the spectral variables z and we write $(f(z);g())_g$ to display this dependence.

Since all initial value problem s 2–3, 2.3 can be solved for arbitrary z 2 C, and a are functions of the spectral parameter z. The following theorem establishes a relation between these two functions in terms of their concommitant and the relevant boundary value problem. The custom ary notation: f() $\frac{1}{0}$ = f(1) f(0) is used in the statem ent below.

Corollary 2.1. and a satisfy the following relations:

We give below a complete characterization of the spectra and the corresponding eigenfunctions for all three BVPs. We also select certain combinations of BVPs which reveal the origin of the relevance of the Cauchy kernel $\frac{1}{x+y}$ to the spectral theory of the cubic string.

Theorem 2.1. Consider a cubic string with a nite measure g as in (2-2).

- 1. Let $z_{a;j}$ denote the eigenvalues of the BVP of Type a=0;1;2. In each of the three cases, the spectrum is positive and simple.
- 2. For any pair of BVPs of Type 0,1,2 the spectra are interlaced in the following order:

3. For each a = 0;1;2 the eigenfunctions (;2;i) a;i () are linearly independent.

We prove the statement about the spectra by using the results obtained in [5]. By Theorem 3.5 in [5] (1;z) has n distinct positive zeros and so do (1;z) and (1;z) (denoted there $_{y}$; $_{yy}$). The second statement follows if one observes that $\frac{(1;z)}{z(1;z)}$ and $\frac{(1;z)}{z(1;z)}$ are strictly positive on the spectrum of Type 0 being the residues of $\frac{(1;z)}{(1;z)}$, $\frac{(1;z)}{(1;z)}$ respectively (Theorem 3.5 and Theorem 3.15 in [5]). It follows then that both (1;z) and (1;z) change signs n times, hence all three spectra are simple. Furthermore, (1;z) > 0, (1;z) > 0 for z 0, so the zeros of (1;z) and (1;z) are strictly positive. Since (1;z) and (1;z) change sign on every interval between two consecutive zeros of (1;z) the spectra of Type 0 and 1, as well as 0 and 2, interlace. To see that the spectrum of Type 1 interlaces with the spectrum of Type 2 we proceed as follows. By (2-11), after evaluating at $z = z_{2;i}$, we obtain

For z > 0, sgn((1; z)) = sgn((1; z)) = +1 because both are strictly positive there. Since the zeros of (1;z) interlace with the zeros of (1;z), $sgn((1;z_{2;i}))$ alternates, which in turn in plies that $sgn((1;z_{2;i}))$ alternates as well. Thus the zeros of (1;z) interlace with the zeros of (1;z).

The relative position of the spectra of the three types is best inferred from the fact that on the seigenvalue $z_{0;1}$ of Type 0, $(1;z_{0;1})$ and $(1;z_{0;1})$ are both negative since $\frac{(1;z)}{z(1;z)}$ and $\frac{(1;z)}{z(1;z)}$ are strictly positive on the spectrum of Type 0. Thus the spectra of Type 1 and 2 are shifted to the left relative to the spectrum of Type 0. In particular, $(1;z_{2;1}) > 0$ and so is $(1;z_{2;1})$ by (2-18). Thus, at least the street of occurs to the left of the zeros of and . So $z_{2;1} < z_{1;1} < z_{0;1}$. Suppose this holds for the (j-1)st eigenvalues. Then we know that both $z_{0;j-1} < z_{1;j} < z_{0;j}$ and $z_{0;j-1} < z_{2;j} < z_{0;j}$. If $z_{1;j} < z_{2;j}$, thus contradicting that the spectra of type 1 and 2 interlace.

As for the linear independence we observe that the cubic string boundary value problem 2.1 can be written as an integral equation:

where G (;) is the G reen function satisfying the boundary conditions of 2.1. Then the linear independence of eigenfunctions corresponding to distinct eigenvalues follows from the general result about the eigenfunctions of a linear operator.

Finally, the statements about the eigenfunctions follow im mediately from equation (2-11) after setting $z = z_{a;i}$; $z = z_{b;j}$.

We now brie y analyze the degenerate case with the mass m_n at the end point $x_n = 1$. We do it only to illustrate that even though the spectrum degenerates in this case the overall conclusions hold.

Theorem 2.2. Let us consider a cubic string with a nite measure g as in (2-2) with $x_n = 1$. Then

- 1. the spectra of Type 0, 1, and 2 are positive, simple and their cardinalities are n 1 for Type 0 and Type 1 and n for Type 2,
- 2. the spectra interlace

and they are linearly independent.

R em ark 2.2. We notice that deg $(1;z) = \deg (1;z) = n$ 1 while deg (1;z) = n. This is in contrast to the previous cases with all positions $x_1; :::; x_n$ inside the interval [0;1] for which all polynom ials have the same degree n.

where 1 0 refers to the right hand, the left hand lim it at 1 respectively. To see that the spectrum is simple we observe that if in the lim it two successive eigenvalues coalesce, namely $z_{2;i}=z_{2;i+1}$, then necessarily $z_{2;i}=z_{0;i}$ because of the interlacing property. However now equation (2-21) implies that $(1 \ 0; z_{0;i}) = (1 \ 0; z_{0;i}) = 0$ which contradicts Theorem 2.1 for the BVP of Type 0 for n 1 m asses. Thus, the zeros of (1;z) and (1 + 0;z) interlace and we have

Likewise, for the spectrum of Type 1, $z_{n;1}$! 1 and the remaining roots interlace according to the pattern valid for n 1 m asses.

To prove the statem ent about the eigenfunctions we use (2-11) and after setting $z=z_i$; $=z_j$ in that form ula we obtain the required identity. The linear independence is proven by the same type of argument as in the proof of Theorem 2.1.

We im mediately have several results about the adjoint cubic string 22.

Corollary 2.2. Given a discrete nite measure g

- 1. for each of the three types of the BVPs the adjoint cubic string (De nition 2.2) and the cubic string (De nition 2.1) have identical spectra.
- 2. the fam ilies of eigenfunctions f $_{a;j}g$ and f $_{a;j}g$ are biorthogonal, that is:

holds.

Proof. The rst equality in Corollary 2.1 implies that the spectra of the cubic string and its adjoint are identical. The biorthogonality follows immediately from equations (2-8), (2-9) and (2-10). For i = j we use Corollary 2.1. Finally, since the spectrum is simple the required derivatives with respect to z are nonzero.

We conclude this section with the de nition and some fundamental properties of two important functions which play a signicant role in the theory (Section 6 in 6]).

De nition 2.5. The following functions are called Weyl functions for their respective BVPs:

Remark 2.3. The de nition of the Weyl functions for the BVP of type 2 in the degenerate case is identical to the one given above for the BVP of type 2.

The Weyl functions W and Z are not independent, they are related by an identity which was originally formulated for the DP peakons in [5]. As an example we formulate such an identity for the BVP of type 2 (both the degenerate as well as the nondegenerate case).

Lem m a 2.2. Consider the BVP of type 2. Then the corresponding W eyl functions satisfy:

Upon dividing the last equation by (1;z) (1;z) we obtain the claim.

We state now the spectral representation theorem for W (z) and Z (z) for the BVP of Type 2 in the degenerate case, the remaining cases being merely variations of this, most transparent case. One recognizes again the presence of the C auchy kernel $\frac{1}{x+y}$ in the spectral representation of Z (z).

Theorem 2.3. Consider the BVP of type 2 (degenerate case). Then the W eyl functions W and Z have the following (Stieltjes) integral representations:

Proof. Since (1;z); (1;z) have simple, interlacing zeros, and deg (1;z) = n 1 while deg (1;z) = n, W (z) adm its a partial fraction decomposition with simple factors:

where, by the residue calculus, $b_i = \frac{(1;z_{2;1})}{z(1;z_{2;1})}$. Moreover the b_i s are all of the same sign because the zeros of (1;z) and (1;z) interlace and, consequently, it su ces to check the sign of $\frac{(1;z_{2;1})}{z(1;z_{2;1})}$ at the rst zero $z_{;1}$. By Theorem 2.1 sgn ($(1;z_{2;1}) = 1$, and thus $b_i > 0$ because on the rst zero z_i must be negative. Consequently, all $b_i > 0$.

Likewise, Z (z) admits a partial fraction decomposition:

and again, it follows from the second item in Theorem 2.1 that $c_i > 0$. Finally, by residue calculus, it follows from Lemma 2.2 that

which proves the integral representation for Z (z).

3 Generalized Fourier transform and biorthogonality

Remark 3.1.0 beerve that $\hat{f_a}(z) = ((1)^a_{a}(z);f)_g;$ and, in particular, $\hat{f_a}(z_{a;i}) = ((1)^a_{a;i};f)_g$ whenever z equals to one of the points of the spectrum of (2-1).

R em ark 3.2. A map of this type was introduced in the context of the inhomogeneous string problem by I.S. K ac and M.G. K rein in [8] as a generalization of the Fourier transform. A similar map known as a distorted Fourier transform is commonly used in Quantum Mechanics.

The main property of this map is captured in the following theorem.

Theorem 3.1. For every pair a; b for which $(a_{i,i}; b_{i,j})_g$ factorizes (item 3 in Theorem 2.1) the generalized Fourier transforms satisfy Parseval's identity, that is, for every f_i the $L_g^2[0;1]$

There are in general two measures associated with each type of the BVP, one generated by W the other by Z . One can use either one of the them instead of the measure d . Theorem 3.2. B iorthogonal polynomials Let us consider the sequence j = (n-j-j, n-j+1) of indicator functions enclosing points n-j of the support of the measure g appearing in the cubic string equation (2-1), with $-\infty$ small enough to ensure non overlapping supports. Furthermore, let us consider the generalized Fourier transforms for Types a; b as in Theorem 3.1 and de ne:

Then, fp; $q_k g$ are (un-norm alized) Cauchy biorthogonal polynom ials, that is $< ^a_{a;i}j^a_{b;j} >= 0; i \in j$ and $< ^a_{a;i}j^a_{b;i} > \in 0$.

Proof. Both $^{\circ}_{a;i}(x)$ and $^{\circ}_{b;j}(y)$ are polynomials in x, y respectively, whose degrees are deg $^{\circ}_{a;j}(x) = \deg ^{\circ}_{b;j}(y) = j$ by (2-5). The biorthogonality follows from Theorem 3.1.
