H eavy-quark pair production in polarized photon-photon collisions at next-to-leading order: Fully integrated total cross sections

W e consider the production of heavy-quark pairs in the collisions of polarized and unpolarized on-shell photons and present, in analytic form, the fully integrated total cross sections for total photon spins $J_z = 0$; 2 at next-to-leading-order in QCD. Phenom enological applications include bb production, which represents an irreducible background to standard-m odel interm ediate-m ass H iggs-boson production, as well as tt production.

I. IN TRODUCTION

It has been emphasized by many physicists that running a future e⁺ e linear collider (ILC) in the photonphoton mode is a very interesting option (see, e.g., Refs. [1, 2]). The high-energy on-shell photons can be generated by backward C om pton scattering of laser light o the high-energy electron and positron bunches of the collider with practically no loss in energy and lum inosity. In this respect, one of the most important reactions to consider is heavy-quark pair production in photoncollider becom es particularly im photon collisions. A portant for studies of the standard-model Higgs boson when itsm ass is below the W⁺W production threshold. Then, the predom inant decay is H ! bb. The dom inant background to this com es from ! bb, which receives contributions from direct and resolved photons. W e leave aside the latter for the time being and return to this in Sec.V. The use of longitudinally polarized photons of equal helicity (their angular momentum being $J_z = 0$) suppresses this background by a factor of $m_{\rm b}^2$ =s at the leading order in perturbation theory [3, 4]. Of course, the reason that the $J_z = 0$ channel is in portant is that the Higgs signal com es entirely from it. Nevertheless, the above-mentioned suppression should not necessarily hold in general, since QCD higher-order corrections involvegluon em ission, which perm its the bb system to have $J_z \in 0$. Therefore, the process of bottom -quark pair production in polarized-photon fusion would represent an irreducible background to interm ediate-m ass H iggs-boson production. Indeed, subsequent calculations of the nextto-leading-order (NLO) QCD corrections have con med these expectations [5, 6].

Furtherm ore, future photon colliders will become top-

quark factories. The data obtained there, when com - bined with data on top-quark production from other reactions, will certainly in prove our know ledge of the top-quark properties (see, e.g., Ref. [7]). It should also be noted that the NLO corrections have a large e ect on the threshold behavior and exhibit a peculiar spin dependence in this region.

Heavy-avor production in photon-photon collisions receives contributions from direct and resolved incident photons. In the rst case, photons behave as pointlike objects, interacting directly with the quarks in the hard scattering, while in the second case, the photon exhibits a com plex structure involving quarks and gluons that participate in the hard interaction. In this paper, we present analytical results for the total cross sections for heavyquark pair production by both polarized and unpolarized direct photons. The present work builds on the previous work of one of us [5, 8]. In Ref. [5], di erential cross sections were calculated analytically in dimensional regularization [9] and cast into a very compact form . We note that this is the only publication where com plete analytical results for polarized and unpolarized doubly di erential cross sections are presented. In Ref. [8], top-quark pair production for energies not too far above threshold was studied, and the fully integrated result for the socalled \virtual plus soft" part of the cross section was derived. W e also note that the results presented in the present work constitute the Abelian part of the gluoninduced hadroproduction of heavy-quark pairs.

This paper is organized as follows. Section II explains our notations. In Sec. III, we outline our general approach and discuss in detail our procedure and m ethodology. In Sec. IV, we present our analytically integrated total cross sections. Our conclusions are sum m arized in Sec.V. Finally, Appendix A elaborates on the calculation of one of the m ost di cult double integrals, Appendix B gives expressions for the various coe cient functions that appear in the main text, and Appendix C displays representations of our basis functions in term s of generalized N ielsen polylogarithm s.

II. NOTATION

For consistency, we closely follow the notations of Ref. [5]. The one-loop Feynm an diagram swith t-channel topology relevant for heavy- avorproduction by the scattering of two on-shell photons are depicted in Fig.1. The u-channel diagram s are obtained from the depicted ones by crossing the incoming photon lines. Single-gluon radiation, which arises from the tree-level diagram swith a gluon attached in all possible ways to the heavy-quark line, contributes at the sam e order. We assign the fourm om enta and helicities as

In Ref. [5], the four-momentum of the gluon was integrated out, the squared am plitudes were sum med over the spins and colors of the nal-state heavy quarks and averaged over the spins of the initial photons. The differential cross sections d =dvdw and d =dvdw for the polarized and unpolarized cases were presented analytically, while the total cross sections and were calculated numerically. In Ref. [3], these di erential cross sections were further integrated to obtain fully analytical result for all the terms proportional to (1 w), i.e., those that multiply the leading-order term. However, the hard-brem strahlung contributions were left out, for which a suitable set of parametrizations were constructed. It is the aim of the present work to analytically integrate these remaining contributions, e.g. the expression in Eq. (30) of Ref. [5], except for its last term, proportional to $d_{LO} = dvdw$.

III. EVALUATION

In order to obtain the analytical result for the total cross section, one has to perform double integrations over the variables v and w, as was already mentioned in Sec. II. The explicit forms of the relevant integrals I_i (i = 1;:::;16) are given in Appendix C of Ref. [5]. However, their direct analytical evaluation turns out to be very complicated in general and even an unfeasible task in som e cases. The integrals I_i contain logarithm s with square roots in their argum ents, and their coe cient functions also depend on the integration variables. In several cases where direct integration is possible, one obtains expressions in term softhe generalized N ielsen polylogarithm s [10]. These polylogarithm s, how ever, contain long and com plicated argum ents that look unnatural, so that we decided to nd som e other universal representation that would be valid for all the integrals under consideration.

In fact, we made use of another approach to obtain the results. The essence of our method consists in obtaining the integrated result from its expansion over the variable it depends on, as well as in the knowledge of the ba-

sis functions entering the integrated result. In the past, such an approach was used in Ref. [11] for vertex- and propagator-type two-loop diagram s and was also applied to some other problem s (see, e.g., Ref. [12]).

In our case, the result depends on the single variable m^2 =s. We nd it, however, more convenient to set up the expansion in the heavy-quark velocity

The procedure for obtaining the required expansions of the double integrals in the variable , by rst expanding and then integrating Eq. (30) of Ref. [5], was already discussed in detail in Ref. [8] and will not be addressed here. We only mention that, in Ref. [8], only the rst 11 term softhe expansions were obtained, which was all one could achieve at that time with available computer hardware resources. For our present purposes, we needed to greatly enlarge the depths of the expansions. A lthough this appears to be a straightforward task at rst sight, it turned out to be a major technical challenge in practice. W e actually needed hundreds of expansion terms to be able to rebuild the nal integrated results. For a given integral, the num ber of expansion terms is, of course, directly connected to the number of functions that makes up our basis. Thus, the main problem swere, on the one hand, to de ne the smallest possible basis and, on the other hand, to obtain su ciently many terms of the expansion. A nalyzing already integrated parts of the cross section presented in Ref. [8] and taking into account observations m ade in a num ber of previous phenom enological studies, we chose our set of basis functions to be the com plete set of harm onic polylogarithm sofR em iddi and Verm aseren [13]. Further detailed investigation revealed, how ever, that harm onic poly logarithm s alone are not sufcient, and that some nonharm onic functions should be added to the basis, as will be explained below. These functions fall into the class of multiple polylogarithms

[14]. It is wellknown that Feynm an am plitudes satisfy linear di erential equations (see, e.g., Ref. [15]). In order to establish the structure of the results, we found it very convenient to consider hom ogeneous di erential equations for the various integrals I_i, which are of the form

where $P_n^{(i)}$ () are some polynom ials and k is the order of the hom ogeneous di erential equation. Having typically 150{200 coe cients of an expansion in , we were able to establish the di erential equations of the above type for each of the I_i functions. As a result, we found that the degrees of the polynom ials $P_n^{(i)}$ () never exceed 14 and that the orders of the di erential equations do not exceed 7. A fler having obtained the polynom ials, one can try to solve the hom ogeneous di erential equations

by using the linear ansatz

where the sum runs over all the basis functions. We remark that the rst coe cients of the original expansions serve as boundary conditions for our di erential equations. Substitution of such an ansatz into Eq. (3.2)leads to an algebraic system of linear equations.

A salready mentioned, not all the integrals can be given in terms of harm onic polylogarithms. In particular, this was the case for the integral I_8 of Ref. [5], which is one of the most complicated ones. We explicitly integrated the doubly di erential distribution associated with this function. The details are presented in Appendix A . Nevertheless, such a direct integration would be rather tedious for a majority of our functions, and the changes of variables described in Appendix A are not universal and, therefore, not applicable to the other integrals. Another integral that cannot be expressed in terms of harm onic polylogarithms is I_6 .

O riginally, our ansatz contained m ore than 100 basis functions. To work with such an ansatz, we needed about 1000 expansion coe cients in the series. Finally, after some analysis, we constructed a nal set of 21 basis functions. They are harm onic polylogarithm s, except for three, which are discussed in Sec. IV. W ith this set of basis functions, the number of linear equations required varies from several tens to a couple of hundreds, depending on the function I_i considered. Typically, one needs about 150{200 coe cients of the expansion to nd the solution for the double integral I_i .

IV. IN TEGRATED RESULTS

The unpolarized and polarized cross sections are dened in terms of $$_{\rm 1\ 2}$$ as

W e parametrize the total cross section in terms of the polarization of the initial beams as

where j = 1 h₁ ₂i involves the average product of the photon helicities ₁ and ₂. According to Eq. (42), j = 1 corresponds to the unpolarized cross section _{unp}, while j = 0 and j = 2 correspond to ₊₊ and ₊, respectively.

where e_0 is the fractional electric charge of the heavy quark Q, N_c the number of colors, and the nestructure constant.

The Born result is well known and reads

The NLO result can be presented as a linear combination of universal basis functions F $_{\rm i}$,

where all the j dependence resides in the coe cients $c_i^{(j)}$. The coe cients $c_i^{(j)}$ are given in Appendix B. The choice of the basis functions F_i is not unique. We choose the 21 basis functions F_i as follow s:

We observe that only three basis functions F_{19} , F_{20} , and F_{21} of Eq. (4.6) are not expressible in terms of harmonic polylogarithms (4.7). We remark that the basis function F_{20} arises only from the virtual part of the cross section.

W e note that all the basis functions F_i of Eq. (4.6) can also be expressed via generalized N ielsen polylogarithm s,

with n + p = 2;3 and com plicated arguments. Special cases include the polylogarithm of order n, Li_n(y) = $S_{n-1;1}(y)$, and Riemann's zeta function $_{n} = (n) = Li_{n}(1)$ [10, 16]. We rewrite the functions F_{1} in terms of the standard generalized N ielsen polylogarithms in Appendix C. We note in passing that all the F_{1} functions can be expressed in terms of multiple polylogarithm s $L_{1;1;1}$ of depth and weight 3 [14] with simple linear arguments.

To verify our analytical results, we compared the numerical values for the function $f^{(1)}$ of Eq. (4.3) produced by our M at hematica program in the polarized and unpolarized cases with Table 1 of R ef. [8]. There, the values for $f^{(1)}$ are presented as functions of the variable

W e found agreem ent on the level of better than one part in 10000. Next, we compared our numbers with those for z = 1;2;3;4;5;10 presented in Table 1 of Ref. [17] dealing with the unpolarized case. The agreem ent was at the order of one part in 10000 or better. Finally, we also compared our numbers with the corresponding values for f⁽¹⁾(++) and f⁽¹⁾(+) from Ref. [6]. Generally, we were in good agreem ent; how ever, we found deviations for f⁽¹⁾(++) by about 3% at som e values of z.

The present results form an Abelian subset of the non-Abelian gluon-induced NLO contributions to heavyquark pair production. Recently, the total cross section of this subprocess was calculated analytically for unpolarized gluons in Ref. [18] using a completely di erent approach. By modifying the color structures, it is possible to extract the unpolarized cross section from their result. Comparing both numerically and analytically (after expanding in), we nd complete agreement. Speci cally, three nonharm onic functions $F_1(x)$, $F_2(x)$, and $F_3(x)$ appearing in Eqs. (13) { (15) of Ref. [18] can be expressed as linear combinations of our functions F_{19} , F_{20} , and F_{21} . For instance, for the most complicated function $F_3(x)$, one has

V. CONCLUSIONS

W e presented, in analytic form, the integrated total cross sections of heavy-quark production in polarized and unpolarized collisions at NLO in QCD. The result is written as a sum over bilinear products of j-dependent coe cient functions and j-independent basis functions, where j denotes the total angularm om entum of the photons.

We checked our analytical results by reproducing, with great accuracy, all the num erical values listed in the relevant tables of R efs. [8, 17]. Furtherm ore, we established agreem ent with the analytic NLO result for the total cross section of heavy-quark production via gg fusion, obtained just recently in R ef. [18], by taking the A belian lim it.

U sing the backscattering technique, it is straightforward to obtain polarized-photon beam s of high intensity at the option of the ILC by colliding low -energy laser light with polarized electron and positron beam s.

Of some concern are resolved-photon contributions. On the one hand, the unpolarized cross sections of the contributing subprocesses were already presented in Ref. [18] and the polarized ones may be deduced, e.g., from Ref. [19]. On the other hand, such contributions can be suppressed by operating close to the production threshold. In fact, we infer from Ref. [20] that, in the case of b-quark production close to threshold, the resolved contribution only makes up a fraction of a percent of the full cross section. Resolved contributions may also be reduced by identifying outgoing jets collinear to one of the photon beams, which are a signature of resolved-photon events. One can also require that the energy deposited in the detectors be equal to the total beam energy in order to account for m issed jets of the type m entioned above. From the experim ental side, we are assuming only that heavy-quark events can be clearly identied.

O ur computer program evaluates the total cross sections presented here in less than a second. It is publicly available [21] and uses the program package HPL [22]. Being im plemented in M athematica, it does not allow for calculations with arbitrary precision. However, with som e additional technicalm odi cations, arbitrary precision could be achieved.

It turns out the function \overline{e}_8 , when expressed in terms of the new variables r , is greatly simplied, and so is the integration over the variable w. Performing the integrals in Eq. (A 11), most of the terms contained in \overline{e}_8 yield harm onic polylogarithm sH and generalized N ielsen polylogarithm s $S_{a,b}$. Only the most complicated term s of \overline{e}_8 lead to the structures A_1 () and A_2 () in Eq. (4.8).
