# On C alogero $\mathrm{Fr}_{\text {rancoise-type }}$ Lax $m$ atrices and their dynam ical r-m atrices

#### Abstract

N ew classical integrable system sofC am assa-H olm peakon type are proposed. T hey realize them axim aleven piecew ise $-D_{2}$ generalization of the $C$ alogero $F$ rancoise ow S , yielding periodic and pseudoperiodic trigonom etric/hyperbolic potentials. T he associated r-m atrices are com puted. They are dynam ical and depend on both sets $\mathrm{fp}_{\mathrm{i}} \mathrm{g}$ and $\mathrm{fq}_{\mathrm{i}} \mathrm{g}$ of canonical variables.


## 1 Introduction

C lassical r-m atrioes for the Lax representation of $L$ iouville-integrable system S , depending on som e of the canonical variables (so called \dynam ical r-m atrices"), have been the sub ject of

[^0]a very extensive set of studies in these past years, starting with the rst mention of their relevance [1], and their use in non-ultra localP oisson algebras [2, 3].

M ost studies afterw ards have been concemed w ith a subset of such $m$ atrices, obeying the so-called \dynam icaly ang B axter algebra". A paradigm atic exam ple occurred in the C alogeroM oser r-m atrix form ulation [4], and classi cation theorem s were extensively developed, see for instance [5]. These $m$ atrices depend only on one half ofP oisson-com $m$ uting canonical variables (either $m$ om enta or positions), identi ed in the general theory [6] as coordinates on the dual of an A belian C artan algebra. T he non-abelian situation is discussed in e.g. [7].

The above $m$ entioned associated dynam ical classical Y ang B axter equation, obtained as a su cient consistency condition for associativity of the Poisson brackets, can then be related to dynam ical quantum algebras such as the $G$ ervais $N$ eveu Felder ( $G N F$ ) algebra $[8,6]$ or the dynam ical re ection algebras $[9,10,11]$.

M ore precisely: the clearest case is provided by the R uijsenaars-Schneider quadratic P oisson structure involving two $m$ atrices $[12,13]$. O ne is then able $[13,10,9]$ to identify the consistency equations as a classical lim it of the Yang Baxter equations for a dynam ical re ection algebra. They include in particular the quantum $G$ ervais $N$ eveu Felder cubic equation (sym bolically w ritten $R R^{h} R=R^{h} R R^{h}$ ) for e.g. Interaction $R$ ound a Face ( $\mathbb{R F}$ ) -type quantum $R-m$ atrioes, and its associated adjoint equation $R S S^{h}=S S^{h} R$. It is interesting to rem ark that the rst $m$ entioned exam ple, i.e. the scalar C alogero M oser r-m atrix, obeys in fact a consistent com bination of these two equations.

Even in such cases when the rmatrix orm atrioes depend on Poisson-com $m$ uting dynam ical variables, the precise derivation of the associated classical Yang Baxter equation is thus a subtle procedure requiring the explicit know ledge of the Lax $m$ atrix and $r-m$ atrix. O btaining the speci c form associated w th the GNF equation is not a prioriguaranteed.

By contrast there are few er results regarding $r$-m atrices depending on non -P oisson com m uting sets of dynam ical variables (hereafter loosely denoted $\backslash p ; q$ dependent r-m atrices"). Indeed few exam ples are known, even less explicitely so, no associated classical \dynam ical" Yang B axter equation has been derived, let alone any quantization thereof. N ote at this point that we expect any such quantization to have very unusual features com pared to the \standard" dynam ical case, involving as it should non-com $m$ utative deform ation param eters p, q (instead of the sole c-num ber param eters $q$ ) inside the generalized $R m$ atrix.

The study of such r-m atrioes is thus clearly a very challenging and prom ising issue in the dom ain of integrable system $s$ and this paper will present an attem pt at expanding the current state ofknow ledge about them by constructing new exam ples ofLax matrioes and their associated rm atrices.

To position the problem, let us rst recalla few known exam ples where the r-m atrix exhibits these dependanc: the com plex sine G ordon case [3] (explicit pair r;s but no decoupled Yang $B$ axter equation); the elliptic C alogero M oser m odel [14, 15] in its spectral param eter-free form ulation [16] (nonexplicit); the B $C_{n}$ Ruijenaars Schneider Lax matrix [17] (nonexplicit); and possibly the recently proposed $2 \times 2$ Lax matrix associated with special solutions of the Cam assa H olm equation [18].

The simplest exam ple (albeit nonexplicit yet) is provided by the Ragnisco-B ruschi [19] construction of the $r-m$ atrix for the Lax $m$ atrix yielding the $C$ alogero $\mp r a n c o i s e ~(C F) ~ H a m ~ i l t o-~$ nian [20]. The Lax m atrix reads:

The CF H am iltonian is $\operatorname{Tr}\left(\mathrm{L}^{2}\right)$. This dynam ical system $m$ ay be viewed as a generalization of both Cam assaH olm peakon integrable system (where $A(z)=\exp (\dot{z} j)$ ), describing the dynam ics of speci c singular \peaked" solutions to the fam ous Cam assa Holm shallow wave uid equation [21, 22, 23], and the related $C$ alogero system [24] (where $A(z)=\cos (z))$.

W e shallbe classifying here the Lax $m$ atriges a la C alogero Fran coise adm ilting an r-m atrix. $W$ e shall in this paper restrict ourselves to Lax $m$ atriges where the diagonalpotential $A_{\text {ii }}$ is a constant (we shall com $m$ ent upon this at the end) and A is an even function.

The problem will then be solved by rst im posing and solving a necessary condition on A derived from the vanishing of the Poisson bracket $f T r L ; T r L^{2} g$ and $f T r L^{2} ; T r L^{3} g$; then explicitely constructing the r-m atrix will show that any such solution be indeed integrable. Som e further com $m$ ents and perspectives shall be added at the end. N ot surprisingly the periodic peakon potential [25] w ill be obtained as one solution.

## 2 The m odel

W e assum $e$ the follow ing form for the Lax $m$ atrix:

As usual $e_{i j}$ denotes the $n \quad n m$ atrix representation of $g l(n)$. W e require that $A$ be an even com plex function of a real variable, $w$ ith isolated singularities ( $m$ ore precisely separated from any other such point by a distance strictly bounded from below ), at least $\mathrm{D}_{1}$ around regular points and such that $A^{2}$ be a piecew ise $D_{2}$ function.

### 2.1 N ecessary conditions

Starting from the form ulae for the rst three $H$ am iltonians de ned from $L$ :

we im pose sim ultaneous vanishing of all Poisson brackets between them as a necessary condition for integrability.
$W$ th the convention $\mathrm{fp}_{i} ; \mathrm{q}_{j} \mathrm{~g}={ }_{i ; j}$, one gets

$\mathrm{H}_{1}$ and $\mathrm{H}_{2}$ are in involution ifand only ifeither the potential is a piecew ise constant function (a trivialsolution, so we w ill solve excluding this case) or the diagonalpart of the potential is uniform : $a_{i}=a$. Setting all $a_{i}$ 's to a the P oisson bracket of $H_{2}$ and $H_{3}$, after som e rearrangem ents,
reduces to

Let us denote the di erences in positions in term $s$ of $x=q_{a} \quad q_{b}$ and $y=q_{E} \quad q_{a}$; the commutation of $\mathrm{H}_{2}$ and $\mathrm{H}_{3}$ yields:

$N$ ote that, if for $x$ and $y$ in the vicinity of som $e x_{0}$ and $y_{0}$ equation (2.3) is satis ed, then $A^{0}(x) A(y)=A(x) A^{0}(y)=a A^{0}(y+x)$ yielding also $A^{2}(x) A^{0}(y+x)=A A^{0}(x) A(y+x)$ and $A^{2}(y) A^{0}(y+x)=A A^{0}(y) A(y+x)$. So equation (2.4) has to be satis ed in the full plane x; $y$ except perhaps in som e isolated points (necessarily singular for A).

Introducing the variables $s=y+x$ and $d=y \quad x$, as well as the three functions

A ctually, by direct com putation, one obtains that the two rhs of equations (2.7) and (2.8) are equal. Let us denote them by aK with K the follow ing sym $m$ etric function:

w ith and two D -functions on the interval of s, respectively $d$, where they build $D . N$ ote that if we change the dom ain of the plane where we solve the equation the functions and are not necessarily the same functions as in the rst dom ain, even if they happen to be de ned at som ecom $m$ on value of $s$ (ord).

Rem ark that since $D(s ; d)=A^{2}(y) \quad A^{2}(x)$ and since $A^{2}$ has been supposed piecew isely $D_{2}$, and are actually $\mathrm{D}_{2}$, one thus gets piecew isely:

w ith some complex constant and $x, x$ and $x$ three piecew ise constant functions (to discrim inate between and wewill assume $\operatorname{Re}(x) 0$ ). Reinserting this form into (2.10) yields:

O ne obtains that x is actually a com plex constant, i.e. $\mathrm{x}=\mathrm{y}_{\mathrm{y}}$, that we will accordingly denote by in the follow ing, we can assum e that it is not zero since we have already discarded the piecew ise constant potential. $M$ ore interestingly the product $\mathrm{x} x$ is also constant and we shall now call it ${ }^{2}$ (up to a norm alization factor).

O ne then easily shows that $=0$ is essentially not com patible $w$ th the assum ption of an even potential and leads to A constant. In the follow ing we will thus assume 0 .

Let us now introduce another piecew ise constant function $x$, param etrize $\mathrm{x} \quad \mathrm{x}=\frac{2}{16}$ by $x_{x}={ }_{\overline{4}} \mathrm{e}^{\mathrm{x}}$ and $\mathrm{x}=\overline{4}_{4} \mathrm{e}^{x}$, and get:

The only other condition is the parity of A, im posing $x=x$. In particular this is true for $x=0$ where A is thus continuous, but generically not di erentiable.

So either $\mathrm{x}=0_{+}=\quad \mathrm{x}$ for all positive x , or it adm its a rst strictly positive discontinuity in $x_{1}$, and reads $x=\left(2 n_{x}+1\right) 0_{+}$, w ith $n_{x}$ the integer quotient of $x$ divided by $x_{1}$ $\left(\mathrm{x}=\mathrm{n}_{\mathrm{x}} \mathrm{x}_{1}+\mathrm{r}_{\mathrm{x}} ; \mathrm{r}_{\mathrm{x}} 2 \quad\left[0 ; \mathrm{x}_{1}\left[\right.\right.\right.$ and $\left.\mathrm{n}_{\mathrm{x}} 2 \mathbb{Z}\right)$.

F inally, we have established the follow ing proposition:

## Proposition 1

A Lax matrix of type (2.1) which de nes a com pletly integrable system can at m ost depend on three complex param eters ( $\mathrm{A}_{\circ}$; and $0^{+}$) and possibly a strictly positive real one ( $\mathrm{x}_{1}$ ) It has to be of the follow ing form :

The rst set of solutions with $x=\operatorname{sign}(x) \quad 0_{+}$corresponds exactly to the Calogero $\mp$ rancoise Lax $m$ atrix (1.1). N ote that $w$ ithin the new set of solutions, if one put $x_{1}=0_{+}$, one gets a non trivial continuous periodic potential.

### 2.2 The r-m atrix

We will now establish Liouville-integrability for the Ham iltonians associated with the Lax $m$ atrix (222) by explicitely constructing the $r-m$ atrix.

Follow ing closely the $r$-m atrix derivation in [19] it is easily seen that it hangs upon the follow ing technical lem ma:

Lem ma
If there exist two odd functions B and C, such that the even function A obey the consistency equation (labeled (2:10) in [19]) where again $s=x+y:$

P roof: P roof can be obtained from direct veri cation, once it is established that the P oisson brackets of $L \mathrm{w}$ th itself are given uniquely in term s of the function $@_{s}(A(x) A(y))$.

Rem ark 1
Existence of a solution $S$ to the algebraic equation (2 25) is obtained by rew riting the de n ing equation in an orthogonalbasis for the sym $m$ etric $m$ atrix $L$ when $L$ is real. If $L$ is com plex sym $m$ etric, one needs to assum e separately that it can be diagonalized (which is true if $L$ is in general position). In both cases one also needs to assum e that the eigenvalues are non degenerate. N ote that the issue of degenerate eigenvalues for a Lax m atrix is in any case a delicate one and needs a case-by-case treatm ent.

Rem ark 2
$S$ is in any case not unique, since in particular any polynom ial in $L$ yields a sym $m$ etric $m$ atrix com $m$ uting $w$ ith $L$ itself.

W e are currently working on an explicit form ulation of solutions to equation (2 25).

W e now state the key result of this section:

P roposition 2
The function $A(x)$ in (2 20) obeys the $r-m$ atrix consistency equation (2.23) w ith the functions:

O ddness of functions B and C follows from $x=x$. The proof proceeds by direct checking of the \addition" formula (223), paying due attention to the consistency of this addition for the step function x .

Hence all necessary potentials A yield a Lax m atrix which exhibits an r-m atrix structure of the form obtained by R agnisco-B ruschi, albeit w ith periodic or m ore generally pseudoperiodic coe cient functions B and C. W e have thus com pletely classi ed the integrable classical Lax operators of the C alogero Francoise form .

## 3 Rem arks and perspectives

1. W e have obtained a new set of pseudoperiodic potentials as a result of our system atic search for even Calogero Francoise type potentials. It would be interesting to know how to form ulate altematively algebraic integrability properties (extension of the A belm aps and associated hyperelliptic curves [25]) for such pseudoperiodic potentials. In principle the conserved H am iltonians should be m oduli of the associated curve. The possible connection w ith the pseudoperiodic solutions derived in e.g. [23] m ay also be interesting.

O f course am ong these potentials one recovers the fiully periodic peakon potential derived by Beals et al [25]. H ere we prove its r-m atrix (hence Liouville) integrability whereas [25] had proven algebraic integrability in the above sense.
2. Intenpretation of the pseudoperiodic \peakons" in the fram e of C am assa Holm equation $m$ ay be interesting, possibly as solutions for a system in a nite volume with som e speci c boundary conditions.
3. It is easily checked that a folding procedure exists w hich consistently yields new integrable system $s$ from these initial pseudoperiodic ones. Starting from the $N=2 n(+1)$-body system $w$ ith positions labeled now from $n$ to $+n$ ( $w$ thout/w ith 0 ) one proves im m ediately that the folding constraints $p_{i}=p i, q_{i}=q$ i are invariant by evolution under all even (resp. odd) degree H am iltonians. H ence the reduced dynam ical system itself has $n$ invariant P oisson com m uting H am iltonians under the reduced Poisson bracket. Its Lax $m$ atrix takes the form: $X^{n}$

H ere one rst (rather trivial) possibility of extension of the strict C alogero Fran coise fram ework is m ade explicit.
4. In order to proceed tow ards a deduction of the form for the Yang-B axter type equation one key point now is to get an explicit form for the $r-m$ atrix by solving the $m$ atrix equation for S. P artial results are now available and we hope to soon have the general form of this r-m atrix.
