A bstract

We classify generalised C am assa-H olm type equations which possess in nite hierarchies of higher symmetries. We show that the obtained equations can be treated as negative ows of integrable quasi-linear scalar evolution equations of orders 2, 3 and 5. We present the corresponding Lax representations or linearisation transform ations for these equations. Some of the obtained equations seem to be new.

1 Introduction

In recent years there has been a growing interest in integrable non-evolutionary partial di erential equations of the form

Here F is some function of u and its derivatives with respect to x. The most celebrated example of this type of equations is the C am assa{Holmequation [1]:

A nother equivalent form of the Cam assa{Holm equation is

The C am assa{H olm equation is integrable by the inverse scattering transform. It possesses an in nite hierarchy of local conservation laws, biH am iltonian structure and other rem arkable properties of integrable equations. Despite its non-evolutionary form the C am assa{H olm equation possesses an in nite hierarchy of local higher symmetries – indeed this equation can be viewed as an inverse ow of the equation $u = D_x (u = u_{xx})^{-\frac{1}{2}}$. Furthermore, the C am assa{H olm equation can be reduced via a reciprocal transformation to the rst negative of the K orteweg{de V ries hierarchy (see also [2]). The C am assa{H olm equation possesses multi-phase peakon solutions (peaked soliton solutions with discontinuous derivatives at the peaks).

Until 2002 the Cam assa-Holm equation was the only known integrable example of the type (1), which possesses peakon solutions, when D egasperis and Processi isolated another equation

which was also found to be integrable by the inverse scattering transform [5]. The Degasperis{Procesi equation also possesses in nitely many conservation laws, bi-Hamiltonian structure etc. It also possesses an in nite hierarchy of local higher sym metries and can be seen as a non-local sym metry of a local evolutionary equation $u = (4 D_x^2)D_x(u u_{xx})^{\frac{2}{3}}$. In fact, the Degasperis{Procesi equation can be reduced via a reciprocal transform ation to the rst negative ow of the Kaup-Kupershmidt hierarchy [3].

One may ask questions: are there other integrable equations of the form (1) and is it possible to classify all integrable equations of this type? The answer to both questions is positive.

The rst classi cation result of equations of type (1) was obtained in [6] using the perturbative sym m etry approach in the sym bolic representation. In the sym m etry approach the existence of in nite hierarchies of higher sym m etries is adopted as a de nition of integrability. The conditions of existence of higher sym m etries are very restrictive and result in algorithm ic and e cient integrability test. In particular, the following result was proved in [6]:

possesses an in nite hierarchy of (quasi-) local higher sym m etries then b = 2;3.

O by iously, the case b=2 corresponds to the C am assa{H olm equation, while b=3 gives the D egasperis{P rocesi equation.

In this paper we extend the classi cation result of [6] and apply the perturbative symmetry approach to isolate and classify more general class of integrable equations of the form (1). We assume that function F in the right hand side is a homogeneous dierential polynomial over C, quadratic or cubic in U and its U-derivatives. The obtained list comprises of 28 equations (see section 3) and some of these equations seem to be new to the best of our knowledge. The list includes an equation of the form

Integrability and multipeakon solutions of this equation have been recently studied in [7] and [11]. For all the obtained equations we present their rst non-trivial higher sym metries. We also give Lax representations or linearisation transform ations for most of the equations. We show that all the obtained equations can be treated as negative ows of integrable quasi-linear scalar evolution equations of orders 2, 3 or 5. The classication results of the latter ones can be found in [10].

2 Integrability test

In this section we brie y rem ind the basic de nitions and notations of the perturbative sym metry approach (for details see [6], [12]). We also present the integrability test [6], which we apply to isolate integrable generalisations of the C am assa{Holm equation.

2.1 Sym m etries and approxim ate sym m etries

In what follows we shall consider the C am assa {Holm type equation (1) with the right hand side being a dierential polynomial over C.

Symmetries and conservation laws of this equation, if they exist, may also contain operator in their structure and therefore we need an extension of the dierential ring R_+ with the operator. The construction of such extension was rst suggested in [9] for the evolutionary 2+1 dimensional equations. For the Camassa{Holm type equations it was rst applied in [6]. Namely, let us construct a sequence of spaces R_+^i ; i=0;1;2;::: as follows:

It is clear that (F) in the equation (2) belongs to $R^{\frac{1}{k}}$. The sym m etries of the equation m ay belong to $R^{\frac{k}{k}}$ for some appropriate k 0 and we introduce the following de nition of a sym m etry:

De nition 1. A function $G \ 2 \ R_+^k$; k 0 is called a generator of a sym metry of equation (2) if a dierential equation

W e adopt the following de nition of integrability:

De nition 2. Equation (2) is integrable if it possesses an in nite hierarchy of symmetries.

In addition to the de nition of a sym m etry we also introduce a de nition of an approxim at sym m etry:

Denition 3. A function G 2 R_+^k ; k 0 is called a generator of an approxim at sym m etry of degree p of equation (2) if G_t $F = o(R_p^k)$.

Any equation

possesses an in nite hierarchy of approxim ate sym m etries of degree 1 { these are sym m etries of its linear part $u_t = (F_1)$. The condition of existence of approxim ate sym m etries of degree 2 in posses strong restrictions on the equation. However an equation may possess in nitely many of approximate sym metries of degree 2, but fail to possess approximate sym metries of degree 3.0 n the other hand an integrable equation possesses in nitely many approximate sym metries of any degree. The degree of approximate sym metries of su ciently large degree in plies integrability. In many cases the existence of approximate sym metries of su ciently large degree in plies integrability.

In order to derive the conditions of existence of sym m etries and approxim ate sym m etries it is convenient to introduce the sym bolic representation of the ring $R_{\,+}\,$ and its extension.

2.2 Symbolic representation

We start by introducing the symbolic representation $\hat{R_+}$ of R_+ . We rst introduce the symbolic representation of spaces R_k ; k = 1;2;::::

2.3 Sym m etries and approxim ate sym m etries in the sym bolic representation

The proof follows from the compatibility conditions of equations (4) and u=G (for details see [6]). Proposition 1 gives necessary and su cient conditions of existence of an approximate symmetry of degree p. Indeed, if for a given equation (4) with the symbolic representation (5) $\hat{u}^i A_{i-1} (1; \dots; i)$ are symbolic representations of elements of R_i^n for all $i=1;2;\dots;p$ then G is an approximate symmetry of degree p. Note that if G is a symmetry then it is completely determined by its linear part G_1 . From proposition 1 it follows that to characterise a hierarchy of symmetries it is su cient to characterise a hierarchy of admissable linear terms.

However it is possible to derive the necessary conditions of existence of an in nite hierarchy of (approximate) symmetries without knowing the structure of admissible linear terms of the symmetries. To do so we introduce a notion of a formal recursion operator:

3 Lists of generalised Camassa { Holm type equations

To prove the theorem it is again necessary to check the quasi-locality conditions of the rst three terms of the corresponding formal recursion operator.

Let us consider now some properties of equations (13)-(22) and (23)-(30).

Cam assa-Holm equation (13). The equation (13) is the Cam assa-Holm equation. It can be rewritten as

Degasperis-Procesi equation (14). The equation (14) is the Degasperis-Procesi equation and it can be rewritten as

The Degasperis-Procesi equation also possesses an in nite hierarchy of local higher symmetries and the rst non-trivial such a symmetry is

Equations (17) and (18) are related by the transform ation u! $(1 + D_x)u$. It is clear that this transform ation does not preserve the locality of higher sym m etries of equation (17).

Equation (20). The rst non-trivial higher sym m etry of equation (20) is

This equation possesses an in nite hierarchy of local higher sym m etries. Note that equation (19) can be obtained from (20) by the transform ation $u ! (1 + D_x)u$. The Lax representation for this equation is not known yet.

Equation (21) is a local second order linearisable evolutionary equation [10], while equation (22) transform s into (21) as u ! $(1 + D_x)u$.

Equations (23)-(30) can be obtained from equations (13)-(20) via the potentiation transform ation u ! u_x .

3.2 Equations with cubic nonlinearity

Now we consider equations with cubic non-linearity:

The proof requires to check the quasi-locality conditions of the rst three terms of the formal recursion operator.

Equation (31) has been recently studied in detail in [7], where the Lax representation in a di erent form was constructed. The authors of [7], [11] also obtained the bi-H am iltonian structure and constructed the peakon solutions for equation (31), for which the positions and am plitudes of the peaks satisfy a nite-dimensional integrable H am iltonian system.

Equation (32). The rst local higher sym m etry of equation (32) is

$$u = m^{3} m_{x}; m = u^{2} u_{xx};$$

The equation (32) can be rewritten as

$$m_t = (^2u_x^2 \quad u^2)m_x \quad 2m^2u_x$$

This equation was recently derived from shallow water theory in [8], where the Lax reperesentation, and biH am iltonian structure were presented and dierent types of solutions were constructed; however, an equivalent form of this equation was given by Fokas in [13].

Equation (33). The higher sym m etries of this equation are quasi-local and the rst one reads as

Equation (33) can be rewritten as

Equation (34). Equation (34) possesses an in nite hierarchy of local higher sym m etries and the rst non-trivial one is

Equation (35). The rst local higher sym metry of this equation is

The latter equation is linearisable as it a second order integrable evolution equation (cf. equations (17), (18).)

E quations (37)-(40) correspond to local evolutionary equations of orders 3 and 2.

4 Conclusions

In this paper we have considered polynom ialhom ogeneous generalisations of the C am assa {H olm type equation with quadratic and cubic nonlinearity. We have classi ed allequations of the form (9), (10), (11), which possess in nite hierarchies of (quasi)—local higher sym metries. We have shown that the obtained equations can be treated as non-local sym metries of local scalar evolution quasi-linear integrable equations of orders 2, 3 and 5.

Some of the obtained equations seem to be new and are likely to provide more examples of solution phenomena (peakons, compactons, other weak/non-classical solutions) that do not appear in local evolution equations [14]. The study of multi-phase solutions of these equations remains out of the scope of this paper.
