# New Mechanism for Neutrino Mass Generation and Triply Charged Higgs Bosons at the LHC

#### A bstract

We propose a new mechanism for generating small neutrino masses which predicts the relation m  $v^4=M^3$ , where v is the electroweak scale, rather than the conventional seesaw form ula m  $v^2=M$ . Such a mass relation is obtained via electrice dimension seven operators LLH H (H <sup>y</sup>H)=M<sup>3</sup>, which arise when an isospin 3=2 H iggsmultiplet is introduced along with iso-triplet leptons. The masses of these particles are naturally in the TeV scale. The neutral member of acquires an induced vacuum expectation value and generates neutrino masses, while its triply charged partner provides the smoking gun signal of this scenario. These triply charged bosons can be pair produced at the LHC and the Tevatron, with <sup>+++</sup> decaying into W <sup>+</sup> v<sup>+</sup> or W <sup>+</sup> W <sup>+</sup>, possibly with displaced vertices. The leptonic decays of <sup>+++</sup> will help discrim inate between norm all and inverted hierarchies of neutrino masses. This scenario also allows for raising the standard H iggs boson mass to values in excess of 500 G eV.

### 1 Introduction

The existence of sm all neutrino m asses in the range  $(10^{2} 10^{1})$  eV has now been mm by established from a variety of neutrino oscillation experiments and serves as the only direct evidence for physics beyond the Standard M odel. A question of fundam ental importance is how such tiny m asses, m any orders of m agnitude below their charged ferm ion counterparts, are generated. An understanding of this question will also reveal if the neutrinos are D irac particles, very much like the charged leptons, or if they are M a jorana particles, very distinct from all other ferm ions.

The most compelling and popular explanation is the seesaw mechanism [1] which generates neutrino masses via e ective dimension ve operators LLH H = M, where L = (; e) is the lepton doublet,  $H = (H^+; H^0)$  is the SM Higgs doublet, and M is the scale of new physics. This leads to the mass relation for light neutrinos m  $v^2 = M$ , where hH<sup>0</sup>i = v. These operators can arise at tree level by integrating out heavy right {handed neutrinos transform ing as (1;1;0) U(1) (Type I seesaw), or (1;3;2) Higgs bosons (Type II seesaw) [2], under SU  $(3)_{c}$ SU (2) or (1;3;0) fermions (Type III seesaw) [3], all with mass of order M. Neutrino oscillation data suggests M  $10^4$  GeV, indicating that the associated new physics is likely to be not within reach of colliders such as the Tevatron and the LHC.W hile there are several indirect bene ts for the seesaw, especially the one m ediated by heavy right {handed neutrinos (uni cation of all m em bers of a fam ily in SO (10) grand uni ed theory, leptogenesis), it is di cult to fathom a direct veri cation of the mechanism in low energy experiments. We feel that it is important to explore alternative mechanisms [4, 5, 6] which may be more directly tested [7, 8].

In this paper we propose a new mechanism for generating tiny neutrino masses at tree level via e ective dimension seven operators LLH H (H  $^{\rm Y}$ H )=M  $^3$ . Such operators lead to a new formula for  $\sqrt[4]{=}M^3$ , which is distinct from the standard seesaw formula. Owing to the neutrino m asses, m higher dimensionality of these operators, neutrino mass generation will be more readily accessible to collider experiments in this case. Suppose that the (1;1;0) and (1;3;0) ferm ions as well as the (1;3;2) Higgs bosons are not present in the fundam ental theory. In this case d = 5 neutrino m ass operators will not be induced. (Such operators m ay still be induced by P lanck scale physics, but this will lead to extrem ely sm all neutrino m asses of order 10  $^5$  eV, which are not relevant for neutrino oscillation data.) In such a setup, the d = 7 operators can be the source of neutrino m asses. The simplest realization of this mechanism assumes the existence of an isospin 3=2 Higgs boson =  $(^{+++}; ^{++}; ^{+}; ^{0})$  and a pair of vector-like ferm ions transform ing as (1;3;2) + (1;3; 2)under the SM gauge symmetry. <sup>0</sup> acquires an induced vacuum expectation value (VEV) via its interactions with the SM Higgs doublet H, and induces small neutrino masses. Since the mass of the can naturally be in the TeV range, this new mass generation mechanism has interesting implications for the physics that will be explored at the LHC (and for sm aller m asses, at the Tevatron as well). We have analyzed the most interesting signals of this model, which occurs in

the production and decay of triply charged Higgs boson +++, with the possibility of displaced vertices.

### 2 M odel

O urm odel is based on the SM symmetry group SU (3)<sub>c</sub> SU (2)<sub>L</sub> U (1)<sub>K</sub>. In addition to the usual ferm ions, we introduce a pair of vector{like leptons, = (  $^{++}$ ;  $^{+}$ ;  $^{0}$ ) and = ( $^{-0}$ ; ; ) transform ing as (1;3;2) and (1;3; 2) respectively under the gauge group. The H iggs sector consists of an isospin 3=2 multiplet = (  $^{+++}$ ;  $^{++}$ ;  $^{0}$ ) (with Y = 3), in addition to the SM doublet H = (H  $^{+}$ ; H  $^{0}$ ).

Neutrino masses arise in the model from the renormalizable Lagrangian

$$L_{mass} = Y_{i}L_{i}H + \overline{Y}_{i}L_{i} + M + h \varepsilon;; \qquad (2.1)$$

where  $Y_i$ ;  $\overline{Y}_i$  are Yukawa couplings and i is the family index. Integrating out the ; ferm ions, one obtains an elective dimension veneutrino mass operator [6]

The tree level diagram generating this operator is shown in Fig. 1. A nalysis of the Higgs potential for <sup>0</sup> shows that it acquires an induced VEV h <sup>0</sup>i v =  ${}_{5}v^{3}=M^{2}$  where hH <sup>0</sup>i v. W hen this value is substituted in Eq. (2.2), we obtain the neutrino masses to be  $m_{ij} = 5 (Y_i \overline{Y}_j +$  $Y_{i}\overline{Y}_{i}v^{4} = (M M^{2})$ . This is the dimension seven mass generation mechanism. With  $(Y_{i}, \overline{Y}_{i}, 5)$ 10<sup>3</sup>, which are all in the dom ain of natural values, we obtain neutrino m asses in the (10<sup>2</sup> 10<sup>1</sup>) eV range, consistent with neutrino oscillation data, with M and M in the TeV scale. Eq. (2.2) implies that one of the light neutrinos is massless, which is consistent with current data. This ferm ions. (O ne can readily add m ore feature arises because we integrated a single pair of hierarchy and inverted hierarchy of neutrino masses can be realized with Eq. (22). Note that our neutrino m ass relation m M  $^3$   $\sqrt{4}$  is distinct from the traditional seesaw relation m M v (m odulo dim ensionless couplings). W hile d = 5 neutrino m asses are not induced at tree level, they do arise at 1-bop in our model via diagram s which connect two of the H legs in Fig. 1 [16]. We nd these nite corrections to be m = m  $\frac{3}{64^2} \frac{M^2}{w^2}$ , which is < 1 for M < 2 TeV. In the SUSY version of our model, the loop diagram swill be further suppressed.

Now we assert the claim that  $v = {}_5v^3 = M^2$  used for neutrino mass estimates by analyzing the Higgs potential. It is given by

where  $_{a}$  (T<sub>a</sub>) are the generators of SU (2) in the doublet (four-plet) representation. We choose, as usual in the SM,  $_{H}^{2}$  to be negative, so that the vacuum breaks electroweak symmetry. <sup>2</sup> will be chosen positive, yet due to the last term in Eq. (2.3), the neutral member of will acquire an induced VEV proportional to v<sup>3</sup>. Speci cally, we have

where  $M^2 = {}^2 + {}_3v^2 + {}^3_4 {}_4v^2$  is the mass of the neutral members in  ${}^0$ . (These expressions ignore small corrections proportional to  $v^2$ .) The mass splittings between the members of are given by

where  $q_i$  is the (non-negative) electric charge of the respective  $_i$  eld. We see that the mass splittings are equally spaced and that there are two possible mass orderings. For  $_4$  positive, we have the ordering M  $_{+++} < M _{++} < M _{++} < M _{-}$ , while for  $_4$  negative, this ordering is reversed. We de ne a (sm all) splitting parameter M  $^2$  ( $_4$ =4) $v^2$  which is approximately equal to (2M )(M).

The important phenom enological parameters of the model are v, M, M and M. In this paper, for simplicity, we shall assume that the triplet fermions + have masses beyond the reach of LHC, and focus on the signatures of the Higgs bosons from . We shall explore the entire range of 100 G eV to 1 TeV for M. As discussed, the VEV v can naturally be in the sub{M eV range for M; M in the TeV range. v € 0 m odi es the tree{level relation for the electroweak parameter, which is now modi ed from 1 to ' 1 ( $6v^2 = v^2$ ). Com paring with the experimental constraint of 1:0000 + 0:0011 ( 0:0007) on ], we obtain, at 3 level, v < 2:5 G eV. The mass splittings between the components of will induce an additional positive contribution to , given by ' (5 2)=(6) (M=m\_W)^2 [10]. This sets an upper limit of M < 38 G eV for the splitting

parameter. There is also a theoretical lower limit of M > 1.4 GeV, arising from (the nite parts) of electroweak corrections [11] which we shall comply with. (This is actually a naturalness lower limit, since these corrections are not nite, with the in nity absorbed in the renorm alization of the  $_4$  coupling.) There are experimental lower limits on the masses of M > 100 GeV [12] for a charged from LEP 2, and M > 120 GeV for a stable charged from the Tevatron [13].

P roduction and decay of the elds will depend on their gauge interactions. This is contained in the kinetic part of the Lagrangian for , given as  $L_{kinetic} = (D_{kinetic})^{\gamma} (D_{kinetic})^{\gamma}$  where

where  $T_a$  are the SU (2) generators for the isospin (3=2) representations, and Y is the hypercharge.

## 3 Phenom enological Im plications

Since the mass scale for the new physics responsible for light neutrino mass generation is naturally at the TeV, ourm odel connects neutrino physics to phenom ena that can be observed at high energy colliders, such as the LHC and the Tevatron. Specially, ourm odel has triply charged H iggs bosons which will have very distinctive phenom enology, such as displaced vertices in the detectors, and large number of W 's and/or charged multi-leptons in the nal states. Here we outline the decay characteristics of these bosons and their production cross sections, and the ensuing nal state signals.

As noted earlier, the mass ordering inside the multiplet has two options. Here we consider the case in which  $^{+++}$  is the lightest among the 's. This is the case in which phenom enological implications of our model are most distinctive. To study the signals of these bosons, we rst consider the various decay modes of 's and then the production cross section at the Tevatron and the LHC.

#### 3.1 Decay of

<sup>+++</sup> has two principal decay modes: <sup>+++</sup> ! W + W + W and <sup>+++</sup> ! W + v + v. These decays arise through the diagram swhere <sup>+++</sup> em its a real W and an o -shell <sup>++</sup> which subsequently decays to either two real W , or two same sign charged leptons. The relevant couplings are: <sup>+++</sup> W :  $3=2g(p_1 p_2)$ ; <sup>++</sup>W W :  $3g^2v$ ; <sup>++</sup> $v_iv_j$ :  $m_{ij}=(2^{p} 3v)$ . The decay rates are found to be

where I; J are dimensionless integrals. In the limit where M  $m_W$ , these integrals are approximately equal to one. In Eq. (3.7), in the leptonic decay,  $m_i$  stand for the light neutrino m asses, and

all avors of leptons have been sum m ed. For our num erical evaluation we have adopted the norm al hierarchy of neutrino m asses with  $m_3 = 0.05 \text{ eV}$ . Results for the inverted hierarchy spectrum can be obtained by multiplying the leptonic widths by a factor of 2.

The exact results for the partial decay widths in the W <sup>+</sup>W <sup>+</sup> W <sup>+</sup> m ode and W <sup>+</sup> \* <sup>+</sup> \* m ode are shown in Fig. 2 as a function of v for M = 500 G eV and 700 G eV. The same is shown in Fig. 3 as a function of M for v = 0.01 M eV and 0.05 M eV. There are several interesting characteristics for these decays. (i) Since the W W W m ode is proportional to v<sup>2</sup>, while the W <sup>+</sup> \* <sup>+</sup> \* m ode scales as  $1=v^2$ , the form er is the dom inant one for larger values of v , while the latter is dom inant for sm aller values of v. The two widths are equal at v 0.03 M eV for M = 500 G eV. (ii) For widths 10 <sup>12</sup> G eV or sm aller, <sup>+++</sup> w ill travel at least 0.2 mm, and thus will produce displaced vertex in the detector. For M = 500 G eV, the width for the W W W m ode equals 10 <sup>12</sup> G eV for v = 0.1 M eV, whereas for the W <sup>+</sup> \* <sup>+</sup> \* m ode, this happens for v = 0.005 M eV. Thus a 500 G eV <sup>+++</sup> will produce displaced vertex in the detector before in the detector for a v range of 0.005 M eV. For heavier (lighter) <sup>++++</sup>, this range in v is sm aller (larger). A few hundred G eV <sup>++++</sup> can travel as m uch as a m eter in the detector before it decays. (iii) If v is much larger 0.1 M eV, then it will decay immediately inside the detector into W W W.

Let us now brie y comment on the decays of the heavier 's.  $^{++}$  has three principal decay modes:  $^{++}$ ! W  $^+$ W  $^+$ ;  $^{+++}W$  ,  $^{+++}W$ . The rst two decay rates depend on the value of v , while the remaining two depend crucially on the value of M. The nal states are W W, two same sign charged leptons, W W W or W W W. For the singly charged Higgs  $^+$  (which

m ixes weakly with the SM Higgs), decay modes are  $^{+}! ^{++}W$ ;  $^{++}$ , with the subsequent decays of  $^{++}$  as above. Thus the nal states will be W W W, W W W W W,  $^{++}W$ , and so on. Finally for the neutral component,  $^{0}$  (which also m ixes weakly with the SM Higgs), the nal state decay products can have as many as six W 's (W W W W W ), or a combination of W 's and charged multi-leptons.

#### 3.2 Production of

At the Tevatron and the LHC, + + + and <sup>++</sup> are pair produced via s-channel W  $^+$ exchanges, while and W + + + are pair produced via the s-channel and Z exchanges. p), while the +++ Z coupling is  $(3e\cos 2w = \sin 2w)$  (p<sub>1</sub> The W vertex is  $p_2$ ). The cross sections for +++ production at the LHC (pp,  $p_s = 14 \text{ TeV}$ ) and 3=2 g (p<sub>1</sub> Tevatron (pp;  $rac{1}{5} = 2 \text{ TeV}$ ) are shown in Fig. 4 as a function of the mass. We have taken the masses of <sup>+++</sup> and to be the same. (The cross section for  $^{++}$ production is approxim ately a factor of ve smaller at the LHC). At LHC, for a mass of 500 GeV, +++ production cross section is about 5 fb, while it increase to about 60 fb for a mass of 250 GeV. For v in the range 0:1 M eV, this will produce very distinctive events with displaced vertices and ve W in of0:005 the nalstate. For very small values of v, the decay mode "+++ ! W + v+ will dom in ate, with the nalstate being W  $^+$   $^+$   $^+$   $^+$   $^+$   $^+$  , possibly with displaced vertex. Such events are not expected in the SM, and will be a clear signal for new physics. For the Tevatron, the cross sections are much smaller, how ever, there may still be such observable events. For example, for a mass of 200 G eV,

the cross section is about 2:6 fb corresponding to such displaced vertex events.

The cross sections for the  $^{+++}$  production are also shown in Fig.4. At the LHC, for a mass of 500 GeV,  $^{+++}$  production cross section is about 4 fb, while it increases to about 77 fb for a mass of 250 GeV. The nal states from these processes will produce 6W or 2W plus four charged leptons. If v is 0:005 MeV, the nal state with 2W plus four charged leptons will dominate. The SM background for such events will be negligible. For v in the range of

0:005 0:1 M eV, both 6W, and 2W plus 4 charged lepton nal states will compete. However, both nal states will have displaced vertices very distinctive of new physics. For v > 0.1 MeV, (W + W + W + W + W + W) nalstate will dom in ate. Leptonic decays of any two same-sign W's 6W will produce same sign charged dileptons with high  $p_T$ , with the nal state having 8 high  $p_T$  jets in addition (from the decays of the other four W 's). This will serve to reduce the SM background severely, making the signal observable above the background. Thus our model can be tested in the entire v range. It is also possible that the lifetimes are so long that +++, escape the detectors. This will produce two tracks in the detectors characteristic of heavy triply charged particles. If v is much larger, there will be no displaced vertex, but the nal states with multi-W and multi-leptons will be very distinctive. The cross sections for the + + + production for the Tevatron are also shown in Fig.4. These are somewhat larger than the +++ production

cross section. Both the D 0 and the CDF experiments have looked for long-lived charged massive particles which escape their detectors. Using the CDF upper limit on the cross sections against the masses, we get a lower limit on such a long-lived  $^{+++}$  mass of 120 GeV [3].

We now brie y discuss the production of some of the heavier states, and the ensuing nal state signals. The cross section for <sup>++</sup> , for the same mass, is larger by a factor (4=3) compared to that of <sup>+++</sup> because of slightly larger coupling, whereas the <sup>++</sup> pair production cross section is signi cantly smaller than that for <sup>+++</sup> . However, if the masses are small enough so that they are signi cantly produced, the nal states are very distinctive from their chain decays. For example, pair production and subsequent decays lead to <sup>+++</sup> ! 6W; <sup>++</sup> ! 8W; <sup>+</sup> ! 10W, and  $^{0}A^{0}$  ! 12W ( $A^{0}$  being the neutral pseudoscalar), where some of the W 's are o -shell. These are events with high charged lepton, or lepton plus jet multiplicity, all with high  $p_{T}$ , and are not expected in the SM .

### 3.3 Other Implications

Our model has interesting e ects for the SM Higgs signals. The isospin 3/2 Higgs multiplet with a tiny VEV essentially behaves like the inert Higgs [14]. SM Higgs boson (H) mass can easily be raised to the range 400-600 GeV in our model. The positive correction to the parameter proportional to M, along with sm all corrections to the S parameter, weakens the usual bound of 185 GeV on the H mass. In this case, there is an interesting possibility, which further enhances the

production rate. H can decay into a pair of triply charged bosons (for M of order 200 GeV). The H production cross section at LHC via gluon fusion for H m ass of 500 GeV is about 5 pb. W ith 1 inverse fb of data, there will be 5000 Higgs events. H will mostly decay, as in the SM, to 2 W 's. But the branching ratio into triple charged Higgs pair is of order 10-20 percent (depending on the actual values of the quartic couplings  $_3$  and  $_4$ ), im plying 500-1000 events with possibly displaced vertices. This will be a very unusual signal for the SM Higgs boson.

O ur model also makes very interesting connections between the neutrino mass hierarchy and collider physics. If the mass of the  $^{+++} < 3M_W$ , then the decay mode  $^{+++}$ !  $W^{+++} + w$  ill dom inate, leading to nal states with ee, e or (along with 's). The dom inance of events will indicate norm all hierarchy, while that of e (ee) will indicate inverted hierarchy corresponding to relative CP parity of the two heavier states being odd (even). Since CP symmetry is broken by the M a jorana phases, these decay modes can be used to measure these phases (see the rst paper of R ef. [7]). Thus high energy collider data will serve to distinguish between the models of neutrino masses and mixings.

### 4 Conclusion and Outlook

We have presented a new mechanism for the generation of neutrino masses via dimension seven e ective operators LLH H (H <sup>y</sup>H )=M <sup>3</sup>. This leads to a new formula for light neutrino masses, m  $\sqrt[4]$ =M <sup>3</sup>, which is distinct from the seesaw formula m  $\sqrt[2]$ =M. The scale of new physics can quite naturally be at the TeV scale. This microscopic theory that induces the d = 7 operator has an isospin 3/2 H iggs multiplet containing triply charged H iggs bosons. We have analyzed the signatures of these bosons at the LHC and the Tevatron. Multi-lepton and multi W nal states, with the possibility of displaced vertices, should facilitate clean observation of these bosons. The leptonic decays of these particles carry inform ation on the nature of neutrino mass hierarchy, which can be directly probed at colliders.

On a more theoretical side, the model presented here can be extrapolated from the weak scale all the way to the P lanck scale without any breakdown of perturbation theory. The isospin 3=2 Higgs representation can be readily embedded into the 35-dimensional representation of SU (5) grand united theory. In a forthcoming paper [15] we plan to present a more detailed analysis of the various observations made here.
