## Sem iclassical transport in nearly sym metric quantum dots II: sym metry-breaking due to asym metric leads

In this work | the second of a pair of articles | we consider transport through spatially sym m etric quantum dots with leads whose widths or positions do not obey the spatial sym m etry. We use the sem iclassical theory of transport to nd the sym m etry-induced contributions to weak localization corrections and universal conductance uctuations for dots with left-right, up-down, inversion and four-fold sym m etries. We show that all these contributions are suppressed by asym m etric leads, how ever they remain nite whenever leads intersect with their in ages under the sym m etry operation. For an up-down sym m etric dot, this means that the contributions can be nite even if one of the leads is completely asym m etric. We nd that the suppression of the contributions to universal conductance uctuations is the square of the suppression of contributions to weak localization. Finally, we develop a random -m atrix theory m odel which enables us to num erically con rm these results.

#### I. IN TRODUCTION

This is work | the second of a pair of articles | on m esoscopic transport through chaotic quantum dots with spatial symmetries (see R ef. [1] for part I). In both works we use recent advances in semiclassical techniques to address the e ect of spatial symmetries on weak localization (W L) corrections and universal conductance uctuations (UCFs). The aim of the rst article was to identify the microscopic origin of properties that were earlier only known from phenom enological random -matrix theory (RMT) [2, 3, 4, 5], and furtherm ore to extend the considerations to situations in which RMT is not easily applicable. In particular, this includes scenarios where symmetries are only partially preserved. To this end, the

rst article [] also considered the combined e ects of m agnetic elds, a nite Ehrenfest time, and dephasing on symmetric systems and also discussed the reduction of symmetry-related interference e ects by deformations of the dots.




Figure 1: (colour online). (a) A quantum dot with a left-right m irror sym m etry, coupled to leads which do not respect that sym m etry. The left lead (L) has width W<sub>L</sub>, the right lead (R) has width W<sub>R</sub>. The intersection between lead L and the m irror in age of lead R has width W<sub>\left</sub>. If the L and R leads have no intersection under the m irror-sym m etry then W<sub>\left</sub> = 0. (b) Same for a quantum dot with inversion sym m etry, (c) A quantum dot with up-down sym m etry, for which each sym m etry-respecting lead is m apped onto itself. In the gure, the left lead is displaced, which reduces the intersection W<sub>\Left</sub> of this lead with its m irror in age.

In the present paper, we contrast this 'internal' sym metry breaking with sym metry breaking which is due to the position or shape of the leads (for exam ples of such situations see Fig. 1). We ask what happens to the transport if we take a sym metric dot coupled to leads which respect the sym metry, and then start moving one of the leads. In the fully sym metric situation, the magnitude of UCFs is doubled for each independent sym metry, while the weak localization correction can be either increased or reduced (sometimes remain una ected) depending on the spatial sym metry in question [1, 2, 3]. A re these symmetryinduced e ects modi ed when the leads are deformed or displaced? If so, are they sensitive to displacement on a quantum scale (of order of a Ferm i wavelength) or a classical scale (of order of a lead width)?

The present literature does not o erm uch guidance to answer these questions indeed, the know ledge on trans-

port in spatially sym metric system s with displaced leads is rather limited. Reference [6] reports that the distribution of transmission eigenvalues of a left-right sym metric dot with completely asym metrically-placed leads diers slightly from the distribution of a completely asym metric dot. Because the dierence is small, sym metric system s (such as stadium billiards) with displaced leads are indeed offen used as representatives of completely asym metric system s (see, e.g., Refs. [4, 5]). Recent works of one of the authors, on the other hand, identify a huge conductance peak in weakly coupled mirror-symmetric double-dots which still remains large even when the leads are not placed symmetrically [7, 8].

A simple consideration of weak localization quickly convinces us that it could never be as robust as the abovem entioned huge conductance peak in double dots. In system swithout spatial symmetries, weak localization is the counter-part of coherent backscattering | particle conservation guarantees that one cannot have one without the other. Systems with spatial symmetries have addition coherent back- and forward-scattering contributions (as discussed in the st of this pair of articles []). These contributions rely on interference between paths that are related by spatial symmetry. If those paths do not both couple to the leads, they cannot generate an interference contribution to conductance. Thus, if we displace one lead so much that there is no intersection with its spatially symmetric partner ( $W_{1} = 0$  in Fig. 1) then the contributions to coherent forward scattering due to the spatial sym m etries m ust vanish.

The precise distance by which one has to move the lead to substantially suppress the sym metry-related contributions depends on the detailed position dependence of the otherent forward- and backscattering peaks. In principle, these coherent interference patterns could oscillate on a scale of a wavelength, and thus one might im agine that a small displacement of that order would succe. The calculations and num erical computations presented by us here show that this is not the case. Instead, the coherent forward-and backscattering peaks have a width of order the lead width, and do not oscillate on the scale of a wavelength.

These considerations entail that the displacement of leads in internally symmetric systems o ers a unique means to study coherent forward- and backscattering processes. From photonic systems it is known that the shape of the coherent backscattering cone provides valuable information on the multiple scattering in a sam ple [9, 10]. Based on the results of the present work, transport measurements with gradually displaced leads promise to give similar insight into the dynamics of electronic systems.

This work is organized as follows. Section II introduces notation and provides a condensed review of the basic sem iclassical concepts elaborated in more detail in the rst of this pair of articles []. The following sections describe the consequences of displaced leads for the weak localization correction in system swith left-right symmetry (Sec. III), inversion symmetry (Sec. IV), up-down symmetry (Sec.V) and four-fold symmetry (Sec.VI). In Sec. VII we study the magnitude of universal conductance uctuations for all types of symmetry. Finally, in Section VIII we generalize the phenom enological RM T m odelof sym m etry breaking (presented in [1]) to the case of displaced leads, and com pare the results of num erical computations to the sem iclassical predictions. Our conclusions are collected in Section IX. The appendix contains som e further details on the sem iclassical calculation of universal conductance uctuations.

## II. BACKGROUND


To make this article self-contained we here  $rst \times no-$ tation and then brie y sum marize the main concepts of the theory of sem iclassical transport in system s with spatial sym metries, developed in the <math>rst of this pair of articles [1].

#### A. Characteristic scales


W e consider chaotic quantum dots of size L [area A = 0 (L<sup>2</sup>) and circum ference C = 0 (L)] which m ay possess any of the following three types of spatial symmetry; a left-right m irror-symmetry, an inversion symmetry, and an up-down m irror-symmetry. We also consider four-fold symmetric systems which simultaneously possess all the above symmetries. The quantum dot is perfectly coupled to two leads, labelled left (L) and right (R) and carrying N<sub>L</sub> and N<sub>R</sub> modes, where N =  $p_FW = (\sim)$  1 for

2 L;R (here  $p_{\rm F}$  is the Ferm im om entum ; we also denote the Ferm ivelocity by  $v_{\rm F}$ ). The quantum dynam ics in the dot is characterized by a number of time scales, given by the time of tight  $_0$  =  $A=\!C\,v_{\rm F}$  between successive

(c) Up-down symmetric dot with asym. left lead

re ections o the boundaries, the dwell time  $_{\rm D} = _{\rm 0}$ C = (W  $_{\rm L}$  + W  $_{\rm R}$ ), the dephasing time = 1= (where is the dephasing rate), and a time scale  $_{\rm B} = (B_{\rm 0}=B)^2_{\rm 0}$  on which a magnetic eld destroys time-reversal symmetry. Here,  $B_{\rm 0}$  h=(eA) is a characteristic eld strength at which about one ux quantum penetrates the quantum dot. In transport, the e ect of a magnetic eld is felt at a smaller magnetic eld

where a is a system -speci c parameter of order one [11]. Furtherm ore, the quantum -to-classical crossover is characterized by the open-system Ehrenfest time  $_{E}^{\circ}$  =

 $^{1} \ln [M^{2}=(L_{F})]$  and the closed-system E hrenfest time  $^{c}_{E} = ^{1} \ln [L=_{F}]$ , where is the classical Lyapunov exponent and  $_{F}$  is the Ferm i wavelength [12].

In contrast to R ef. [1], we here consider the possibility that the leads do not respect the symmetry of the dot. As shown in Fig.1, the displacem ent from the symmetryrespecting position is characterized by the overlap of leads under the relevant symmetry operation. For leftright m irror symmetry and inversion symmetry, this is the width W  $_{\rm V}\,$  of the intersection of a lead with the im age of the other lead. An up-down symmetry maps each symmetry-respecting lead onto itself. The displacement of lead L (R) is then characterized by the width W  $_{\rm \ L}$  $(W \setminus_R)$  of the intersection of this lead with its own m irror in age. In a four-fold sym m etric system, the displacem ent is characterized by the various widths of intersections with respect to the individual symmetries (M  $_{\rm LR}$ for left-right m irror sym m etry, W  $_{inv}$  for inversion sym metry, W \uD : for up-down m irror symmetry of lead L and  $W_{\setminus UD,R}$  for up-down m irror symmetry of lead R).

#### B. Sem iclassical theory of transport

The sem iclassical theory of transport [13, 14] expresses the transport through a quantum dot in terms of classical paths ; <sup>0</sup> which connect point  $y_0$  lead L to point y on lead R. Summing over lead modes as in Ref. [15], the dimensionless conductance (conductance in units of  $2e^2=h$ ) is given by

where  $S = {}^{R}$  pdr denotes the classical action of a path, and the am plitude A is related to the square-root of the path's stability.

For most pairs of and <sup>0</sup> the exponential in Eq. (2) oscillates wildly as one changes the energy or the dotshape. Thus they make no contribution to the average conductance (where one averages over energy, dotshape, or both). The contributions that survive averaging are those where the pairs of paths have similar actions S ' S  $_{\circ}$  for a broad range of energies and dot-shapes. In particular, this is the case for the \diagonal contributions" to the above double sum (with <sup>0</sup> = ), which can be analyzed using the sum rule (in the spirit of Eq. (B 6) of R ef. [13])

Here we de neP  $(Y;Y_0;t)$  y tas the classical probability for a particle to go from an initial position and momentum angle of  $Y_0$   $(y_0; _0)$  on lead L to within (y; ) of Y = (y; ) on lead R in a time within t of t. The average of P over an ensemble of dots or over energy results in a smooth function. If the dynamics are mixing on a timescale  $_{\rm D}$ , one can approximate P (Y;Y<sub>0</sub>;t) = e  $^{\rm t= \ D} \cos = [2 (W_{\rm L} + W_{\rm R})_{\rm D}]$ , which results in the classical D rude conductance


Q uantum corrections to this result originate from correlations of paths and  $^{0}$  which are not identical, but closely related by additional discrete sym metries in the system. For asymmetric quantum dots the only possible additional symmetry is time-reversal symmetry, which results in the ordinary weak localization correction [16, 17, 18] and associated coherent-backscattering peak [15, 17, 19] for systems whose classical dynamics exhibit hyperbolic chaos. The identication of possible pairings is also at the heart of the calculation of the magnitude var(g) of universal conductance uctuations, which in the semiclassical theory naturally takes the form of a quadruple sum over classical paths [20, 21].

Spatial sym m etries in such chaotic system s induce further possible pairings both for the average conductance as well as for its variance, which are discussed in detail in the rst article in this series []. In the following sections we revisit these results and extend them to the case of displaced leads, which is far richer than the case of sym m etry-respecting leads.


### III. LEFT-RIGHT SYMMETRIC QUANTUM DOT W ITH DISPLACED LEADS





Figure 2: (colour online). List of interference contributions to the conductance for a dot with left-right m incor-sym m etry when the leads are asym m etric. Here the leads have widths  $W_L$  and  $W_R$  and are centred at di erent places. The intersection of the L lead and the R lead's m incor in age has a width  $W_{\setminus}$  and is indicated by the unshaded part of the L lead. The sketches on the left are all contributions to transm ission from the L lead to the R lead (hence the contributions to conductance). The sketches on the right are all contributions to re ection from the L lead back to the L lead.




Figure 3: (colour online). To nd the non-trivial path pairings, and to evaluate the phase di erence between the paths, we use the folding procedure introduced in R ef. [1] (for sym – m etric leads). Here we consider the extra contributions generated by the fact the leads are asym metric (i.e., contributions 2i-iv in Fig. 2). For each spatial sym metry, we give one example of the folding procedure for an unsuccessful coherent forward-scattering (or backscattering). The ellipses mark the e ective encounters, where paths interchange their pairing. The other contributions are easily analyzed in the sam e way.

We rst consider a left-right m irror-sym m etric system with leads that are (partially or fully) displaced from the symmetry-respecting con guration. As shown in Fig. 1(a), the leads are of di erent widths and centred at di erent places. The am ount of sym m etry-breaking is characterized by the (possibly vanishing) width W  $_{\rm V}$  of intersection between lead L and the m irror im age of lead R. In Fig. 2 we show the path-pairings for all sym m etryinduced interference corrections to the average conductance. (There is a strong resem blance between these contributions and the weak localization correction for system swith leads that contain tunnel barriers; in particular com pare the failed coherent forward scattering contributions in Fig. 2 of this article with the failed coherent backscattering contributions in Fig. 4 of Ref. [22].) None of the contributions listed in Fig. 2 are particularly di cult to calculate using the method presented in the st of this pair of article [1]. This method involves folding paths under the spatial sym metry to nd ways in which one can construct pairings between paths or their in ages, with pairings switching at e ective" encounters; see Fig. 3. The di culty is to nd all contributions. One crucial check is to verify that the sum of all interference contributions to transmission and re ection gives zero, thereby ensuring particle conservation.

The main di erence from the equivalent calculation for a system with symmetric leads (cf. Ref. [1]) is that here a pair of symmetry-related paths has a shorter joint survivaltime than the pairs of identical paths in the diagonal

contribution. W hen the leads are sym m etrically placed, the probability of a path staying in the dot (not hitting a lead) is strictly identical to the probability of its m ir-

ror in age staying in the dot. This ceases to be the case when the leads are not symmetric. We deal with this by explicitly considering all situations where a path hits a lead (in which case it escapes from the system) or the

mirror in age of a lead (in which its mirror in age will

escapes from the system). The probability that either of

of the dot. We therefore de neamodi ed dwelltime



which characterizes the probability  $\exp[t=_{D}^{0}]$  that a path and its m informing age are both still in the dot at time t. We use this probability in place of  $\exp[t=_{D}]$  in evaluating all parts of contributions 1 and 2 in Fig. 2 where the paths are the m informing age of each other.

(c) Folding procedure in dot with up-down symmetry

# A. Successful and failed forw ard-scattering contributions

The contribution of paths of the type labelled 1 and 2i-2iv in Fig.2 have an elective encounter close to a lead. These contributions are similar to certain contributions in an asymmetric system with tunnel barriers [22], and hence we use a similar method to analyze them here. The behavior of path  $^{0}$  is completely determined by that of path , so the two paths have the same amplitudes, A  $^{o} =$  A. The action di erence between them is (S S  $^{o}$ ) = ( $p_{02} + m - r_{02}$ )  $r_{02}$ , where ( $r_{02}$ ;  $p_{02}$ ) is the component of (Y  $Y_{0}$ ) which is perpendicular to the direction of path

at Y [23]. Using the sum rule in Eq. (3), we see that the contribution 1 in Fig. 2 is given by (cf. contribution LR a in Ref. [1])

The lim its on the integral indicate that we only integrate over the region of the leads which have an overlap with each other under the left-right m irror symmetry (the regions of width W  $_{\rm V}$  m arked in Fig.2).

The survival probability hP<sup>0</sup>(Y;Y<sub>0</sub>;t)i  $\exp[t=_{D}^{0}]r = [(W_{L} + W_{R} - W_{N})_{D}^{0}]$  is that of a path and its mirror im age. The probability per unit time for path to hit within (r; ) of a given point in the region of phase space de ned by the union of leads and theirm irror in ages is hP <sup>0</sup> (Y;Y<sub>0</sub>;t) i Y where Y r . Note that it is  ${}^0_D$  rather than  ${}_D$  which gives the decay rate of hP  ${}^0$ (Y;Y $_0$ ;t)i. We express the Y $_0$ integral in terms of the relative coordinates  $(r_{0?}; p_{0?})$ and de ne  $T_{W}^{0}$  ( $r_{0?}$ ;  $p_{0?}$ ) and  $T_{L}^{0}$  ( $r_{0?}$ ;  $p_{0?}$ ) as the time between touching the lead and the perpendicular distance between and <sup>0</sup> becoming of order W and L, respectively. For times less than  $T_{W}^{0}$  ( $r_{0?}$ ;  $p_{0?}$ ), the path segments are almost mirror images of each other, and their joint survival probability is the survival probability of a path and its mirror im age. For times longer than this the path-pairs escape independently, but since the pairs are made of a path and its mirror image, the escape rate is  $_{\rm D}^0$  not  $_{\rm D}$ . The t-integral in Eq. (6) must have a lower cut-o  $\operatorname{at} 2T_L^0(r_{0?};p_{0?})$ , because that is the minimum time for reconvergence. (For shorter times and <sup>0</sup> m ust there is no contribution, because path separate to a distance of order the dot size, if they are going to reconverge at the other lead). Thus we have

where  $T_{L,W}^0$  are shorthand for  $T_{L,W}^0$  ( $r_{0?}$ ; $p_{0?}$ ). Note that the  $_D^0$  in the denom inator of hP  $^0$  (Y; Y  $_0$ ;t) is was cancelled when we integrated over all times longer than  $2T_L^0$ . For small ( $p_{0?}$  + m  $r_{0?}$ ) we nd

and  $T_W^0$  ( $r_{0?}$ ;  $p_{0?}$ ) is given by the same form ula with L replaced by W. Evaluating the integrals over the relative coordinates ( $r_{0?}$ ;  $p_{0?}$ ) as in Ref. [1], we nally obtain

The failed coherent forward-scattering contributions labelled 2i and 2ii in Fig. 2 come from the window of width W  $_L$  W  $_{\rm l}$  in the L lead. This causes an enhanced probability of hitting the mirror im age of that part of

lead L. However, the lead R is not there, so this constructive interference peak gets re ected back into the dot, and has a probability of  $N_R = (N_L + N_R)$  of going to lead R and a probability of  $N_L = (N_L + N_R)$  of going back to lead L [23]. The form er is a contribution to transm ission (and hence to the conductance) while the latter is a contribution to re ection. Thus we have

By inspection of Fig. 2 it follows that  $h gi_{LR,2iii}$  is given by Eq. (10) with N<sub>R</sub> and N<sub>L</sub> interchanged, while  $h R i_{LR,2iv} = h R i_{LR,2ii}$ .

## B. Uniform contributions to transm ission and re ection

To evaluate the uniform contributions to transm ission and re ection, labelled 3i and 3ii in Fig.2, we divide the pairs of paths in this contribution into three regions. The rst part is when and  $^{0}$  are the same, and are far from the encounter (a time  $T_W = 2$  or more away from the encounter). Here the probability for the paths to escape is 1 = D per unit time. The second region is where <sup>0</sup> and are the mirror in age of each other and far from the encounter (a time  $T_W = 2$  or more from the encounter). Here the probability of one or both paths to escape is  $1 = D^{0}$  per unit time. Finally, the third region is close to the encounter (less than a time  $T_W = 2$  away from the encounter). Here the probability for the paths to escape the st time they pass through this region surrounding the encounter is  $exp[T_W = D]$ . Since the paths are paired with their m irror in age between time  $t_1$  and time  $t_2$ , the survival rate is  $_D^0$  during this time, but it is  $_D$  at all other times. Evaluating this integral with these survival times gives

This has two di erences from the result for symmetric leads in Ref. [1]. The exponent contains  $_{D}^{0}$  not  $_{D}^{0}$ , and the prefactor contains  $_{D}^{0}$  not  $_{D}^{2}$ . When integrating over ,we obtain a factor of [ $_{D}^{0}$ ] <sup>1</sup> exp[ $_{E}^{c} = _{D}^{0}$ ] in place of [ $_{D}$ ] <sup>1</sup> exp[ $_{E}^{c} = _{D}^{c}$ ]. Thus the  $_{D}^{0}$  in the prefactor is cancelled [25]. Evaluating the integrals, we get

These results are of the same form as the weak localization correction except that the exponent contains  $_{\rm D}^0$  in place of  $_{\rm D}$ . In particular, we recover the fam iliar factor of  $N_{\rm L}N_{\rm R}$  = (N $_{\rm L}$  +  $N_{\rm R}$ )<sup>2</sup> even though the joint survival time is reduced when the paths are m irror im ages of each other.

O ne can next include other suppression e ects such as asym m etry in the dot and dephasing, which we discussed for dots with sym m etric leads in Ref. [1]. The only difference caused by asym m etric leads is that now the parts of contributions a ected by asym m etries and dephasing (parts where paths are paired with their m irror in age) decay with a rate  $_{\rm D}^{0}$  instead of  $_{\rm D}$ . Thus we nd that all the contributions listed in Fig. 2 are then multiplied by a factor

where the expression for the decay rates  $_{asym}$ , and timescales ~,  $\sim_{asym}$  are the same as for a dot with sym - m etric leads [1].

# C . Conductance of a left-right sym m etric quantum dot w ith asym m etric leads

A s required by particle num ber conservation, the seven contributions in F ig.2 sum to zero. In order to obtain the conductance, we sum the four contributions to transm ission from the left lead to the right lead (contributions 1, 2i, 2iii and 3i), and add them to the D rude conductance and the weak localization correction. This gives the conductance of a chaotic left-right symmetric quantum dot with m any-m odes on each lead ( $N_L$ ;  $N_R$ ;  $N_L$  1),

where  $Z_{LR}^{0}$  ( $_{asym}$ ; ) is given by Eq. (16). The second term in the square brackets is the usual weak localization correction, which is suppressed by magnetic elds and dephasing according to the function Z (B; ) =

~] 1 + (B = B<sub>c</sub>)<sup>2</sup> +  $_{D}$  <sup>1</sup>. For symmetric leads exp [ we have  $N_{\ \ }=N_{\ \ }=N_{\ R}$  (and hence  $_{\ \ D}^{\ \ 0}=_{\ \ D}$ ), and this result im m ediately reduces to the one in R ef. [1].

It is worth considering two special cases. The rst case is when the leads are of equal width but not centred at the m irror in age of each other, such that N  $_{\rm N}$  < N  $_{\rm L}$  = N  $_{\rm R}$ N. Taking w = 1  $w_{\setminus} = W = 1$   $N_{\setminus} = N$  as the relative distance (in units of the lead width  $W = W_{L} = W_{R}$ ) by which lead L is displaced with respect to the mirror in age of lead R, and assuming there is no dephasing, magnetic eld, or internal asym metry, we nd

The second special case is when the lead R is narrow er but situated entirely within the mirror in age of lead L; we then have N  $_{\rm V}~=~$  N  $_{\rm R}~<~$  N  $_{\rm L}$  . A ssum ing again that there is no dephasing, magnetic eld, or internal asymmetry,

As one could scan the narrow lead R across the mirror in age of the wide lead L, this scenario can be thought of as a probe of the shape of the coherent forw ard-scattering peak. The fact that our result Eq. (19) is independent of the position of lead R tells us that the forward-scattering peak is uniform ly distributed over the region de ned by the mirror im age of lead L.

## IV. INVERSION-SYMMETRIC QUANTUM DOT W ITH ASYMMETRIC LEADS

For systems with inversion symmetry the calculation followsmuch as for a left-right symmetry. The one signi cant di erence is the magnetic-eld dependence of the contributions, which was treated in Ref. [1]. The displacem ent of the leads simply requires us to replace  $\mbox{}_{\rm D}$ with  $\frac{0}{D}$  in the suppression of contributions by magnetic

elds, asymmetries in the dot, and dephasing. The suppression factor therefore takes the form

1) has a total average conductance of

W ith the exception of the magnetic-eld dependence of the second term , this form ula is the same as Eq. (17) for a left-right symmetric dot. Thus the two special cases discussed below Eq. (17) are directly applicable here.

### V. UP-DOWN SYMMETRIC QUANTUM DOT W ITH ASYMMETRIC LEADS

For up-down symmetric systems, there are a number of im portant di erences with the case of left-right sym m etry discussed in Section III. Firstly, a pair of paths related by the mirror symmetry decays pintly at a rate

where N  $_{\ \ L}$  is the number of modes in the intersection of lead L with its own mirror image, and N  $_{\rm \ R}$  is the number of modes in the intersection of lead R with its own mirror image. Secondly, the successful and failed forward-scattering contributions for left-right symmetry are converted into successful and failed backscattering contributions for up-down symmetry. In particular, successful backscattering makes no contribute to the conductance. The other contributions to transm ission are not very di erent from those for left-right symmetry, except that one must distinguish N  $_{\rm LL}$  from N  $_{\rm NR}$ , and one must replace  $D_D^0$  by  $D_D^{(UD)}$ . Summing up the contributions to conductance induced by the spatial sym metry, we nd

where  $Z_{UD}^{0}$  (asym; ) has the same form as  $Z_{LR}^{0}$  (asym; ) given in Eq. (16), but with  $_{D}^{0}$  replaced by  $_{D}^{(UD)}$ . Like for left-right mirror-symmetry (but unlike for inversion symmetry) this contribution is una ected by a magnetic eld.

The average conductance of an up-down m irror-symmetric dot with m any m odes on each lead is therefore

It is worth noting that the spatial sym m etry induces a reduction of conductance whenever one lead is close to sym m etric, even if the other lead is com pletely asym – m etric (i.e. when  $N_{\setminus L} = 0$  but  $N_{\setminus R} \notin 0$ , or vice versa). For example, when both leads have the same w idth ( $N_L = N_R = N$ ) and the right lead is perfectly on the sym m etry axis ( $N_{\setminus R} = N_R$ ), but the left lead is a long way from the sym m etry axis ( $N_{\setminus L} = 0$ ), Eq. (24) reduces to

assuming no dephasing, magnetic eld and no asymmetry in the dot. If the Ehrenfest time is much shorter than  $_{\rm D}$  and  $_{\rm D}^{\rm UD}$ , the average conductance of the system with one displaced lead is therefore simply  ${\rm hgi}_{\rm UD} = {\rm N}=2$  1=3.

R em arkably, the conductance from the L lead to the R lead is therefore a ected by the symmetry of the dot even when the L lead is completely asymmetric. this result is perhaps less counterintuitive when one considers re ection (rather than transmission). If one lead is on the symmetry axis, then re ection back to that lead will be enhanced even if the other lead is a long way from the symmetry axis. Since we have particle conservation, there must be an associated reduction in transmission from one lead to the other (compared to transmission in a completely asymmetric situation).

### VI. FOUR FOLD SYM M ETRIC QUANTUM DOT W ITH ASYM M ETRIC LEADS

A quantum dot with four-fold symmetry simultaneously possesses all three of the spatial symmetries that we discuss in this article. The interference corrections to the conductance of such a system are simply the sum of the corrections due to each of these three symmetries (i.e., the presence of the extra symmetries has no elect on the contributions which do not respect those symmetries),

where h gi is the contribution to the average conductance induced by spatial sym m etry 2 LR; inv; UD. The explicit form of this result is easily extracted from the expressions in the previous sections. Instead of writing it out in full, we consider the special case where the two leads have the same width,  $N_L = N_R = N$ , the Ehren-fest time is negligible and there is no dephasing, magnetic eld or asymmetry in the dot. The average conductance

in the square-bracket is the usual weak localization con-  
tribution.

Since the presence of two of the above mentioned sym m etries always im plies the presence of the third, it is not possible to move the leads such that only one of the  $N_{\rm M}$ parameters changes. Without a ecting the integrity of the leads there are only two possible modi cations for which only two of the parameters change; starting with perfectly symmetric leads one can (a) move both leads upwards by the same amount so that  $N_{LR}$  is unchanged, or (b) move both leads by the same amount in opposite directions (one up and one down) so that N  $_{\rm \setminus\,inv}$  is unchanged. In principle, it is also possible to break up a single lead (say L) in the middle and move the two parts into opposite directions (both parts would still be contacted by the sam e source or drain electrode); this preserves  $N_{\Lambda L}$  and  $N_{\Lambda R}$  but a ects the other parameters. However, the latter deform ation is di cult to realize in practice.

### VII. UNIVERSAL CONDUCTANCE FLUCTUATIONSWITH DISPLACED LEADS

Now we turn to the magnitude of universal conductance uctuations (UCFs) in symmetric dots with asymmetric leads. Their calculation is generally farm ore complicated than the calculation of the average conductance. This is illustrated by the fact that there is as yet no sem iclassical theory of UCFs for leads with tunnel barriers, a problem which has many similarities to the problem we need to solve here. Thus we restrict ourselves to the sim plest case of quantum dots with negligible Ehrenfest




Figure 4: (colour online). A sketch of sem iclassical contributions to UCFs (m ore speci cally, contributions to covar [R; R<sup>0</sup>]) for an up-down symmetric dot with asymmetric leads. There are analogous contributions to UCFs for left-right or inversionsymmetric dots (see explanation in the text). In each contribution, paths 1 and 1' go from L lead to L lead, while paths 2 and 2' go from R lead to R lead. In the sketches, solid lines indicate paths 2 and the image (m infor image or image under the inversion symmetry) of paths 1. Path 2' and the image of path 1' are indicated by the dashed lines (only shown at the encounters). Thus when paths 2 and 2' are not paired with each other they are paired with the image of 1' and 1 respectively (indicated by solid arrow heads). If the system has a time-reversal symmetry then path 2 and 2' can also be paired with the time-reverses of the image of 1' and 1, respectively (indicated by the open arrow heads).

time and negligible dephasing, and only consider magnetic elds which are either negligibly small (B  $B_c$ ), or su ciently strong to break time-reversal symmetry in the asymmetric system (B  $B_c$ ).

The magnitude of the UCFs (with conductances measured in units of  $e^2 = h$ ) is given by var[g] = var[T], where = tr[t<sup>y</sup>t] and t is the block of the scattering ma-Т r t<sup>0</sup> trix S = associated with transmission from t r<sup>0</sup> lead L to lead R. For practical calculations it is bene cial to exploit the unitarity of the scattering matrix (i.e., current conservation), which results in the rela- $R = N_R$  $R^0$  with  $R = tr[r^y r]$  and tions  $T = N_L$  $R^{0} = tr[r^{0y}r^{0}]$ , where r is the block of the scattering m atrix associated with re ection back to lead L, and r describes re ection back to lead R.As a result we can write the magnitude of the UCFs in any of the following ways,

As for conventional UCFs without spatial symmetries [20, 21], the sem iclassical calculation of  $covar[R; R^0]$  is most straight-forward, thus we base our calculations on

this quantity. For the expert reader, Appendix A contains an outline of the calculation of var $\mathbb{R}$  ] and var $\mathbb{R}^{0}$ ], show ing that they equal covar $\mathbb{R}$ ;  $\mathbb{R}^{0}$ ].




Figure 5: (colour online). A sketch of additional sem iclassical contributions to UCFs (m ore speci cally, contributions to covar R; R°]) for left-right or inversion-symm etric dots with asymmetric leads. The contributions listed here must be added to those listed in Fig. 4 (once one sets L = R =) to get the full set of contributions for left-right or inversion-symmetric dots. The manner in which the contributions are sketched is explained in the caption of Fig. 4.

A llsym m etry-induced contributions to  $\operatorname{covar}[R; R^0]$  for an up-down symmetric dot are listed in Fig. 4. For a left-right or inversion-symmetric dot there are additional contributions, which are listed in Fig. 5. In all cases, when paths 2 and 2' are not paired with each other, they are paired with the images of paths 1' and 1 under the appropriate symmetry operation. To keep the sketches in Figs. 4 and 5 as clear as possible, we only show these images of paths 1 and 1' (rather than paths 1 and 1' them selves). Then the resulting contributions look very much like the usual contributions to UCFs in a system without a spatial symmetry [20, 21].

In analogy to the situation in asymmetric systems, one would also expect contributions in which paths wind around periodic orbits (see Figs. 1b,c in Ref. [21]). For example, a symmetric quantum dot will have contributions in which path 1' is the same as path 1 except that it winds around a periodic orbit p when path 1 does not (thus path 1 must come very close to the periodic or-

bit in phase space), while path 2 is the same as path 2' except that it winds around the image of the orbit p. These contributions are proportional to those analyzed for UCFs in asymmetric dots, the only modi cation being that the pint survival probability of a periodic orbit and its image is again changed to exp [  $t=_{D}^{0}$ ]. Drawing on the results of R efs. [20, 21], it follows that the contributions involving windings around periodic orbits will be negligibly small when the Ehrenfest time is small. (This observation makes the calculation of the UCFs in the present problem signi cantly simpler than for the case with tunnel barriers, where one cannot rule out contributions from periodic orbits which touch the barriers on the leads.)

#### A. E ect of tim e-reversal sym m etry

Inspecting the sketches in Figs. 4 and 5 we see that all contributions are doubled when the magnetic eld is negligible, because path 2 can either follow the image of path 1' or the time-reverse of path 1'. Thus we can multiple all terms by 2=, where = 1 for a system with  $B_c$  and = 2 for a system negligible magnetic eld, B with a nite magnetic eld, B B. In the latter case the presence of mirror-re ection symmetries allows one

to de ne a generalized tim e-reversal sym m etry; how ever, this is already accounted for in the construction of all diagrams (see Appendix A of Ref. [1]).

#### B. UCFs in an up-down sym metric dot

The general rules for constructing all contributions to the UCFs are the following. Each segment where path 2 or 2' is paired with the image of path 1' or 1 gives a factor of  $(2N_{L} + 2N_{R} N_{L} N_{R})^{-1}$ , which arises from the survival time  $D^{D}$  given in Eq. (22). Each segment where paths 2 and 2' are paired (or paths 1 and 1' are paired) gives a factor of (N  $_{\rm L}$  + N  $_{\rm R}$  )  $^{1}$  , which com es from the conventional survival time  $_{\rm D}$  . Each segment that touches a lead gives a factor equal to the num ber of lead modes that the path could couple to; i.e., a lead labelled \R R " gives a factor of  $N_R$  $N_{R}$ ), while a lead labelled R "simply gives a factor of  $N_R$ . An encounter which touches a lead gives the same factor as a simple path-segm ent that touches a lead, so again if it is labelled R " then it gives a factor of  $N_{\rm R}$ \R  $N_{N}$  (this rule is proven by applying the sam e analysis as was used for the successful and failed forward-scattering processes in Section IIIA.) Finally, encounters deep in the dot (i.e., those which do not touch the leads) give a factor of  $(2N_{\rm L} + 2N_{\rm R} N_{\rm L} N_{\rm NR})$  (this rule can be proven by applying the same analysis as was used for the uniform contributions to transmission in Section IIIB). With this

set of rules we can easily see that contribution (i) in Fig. 4 gives

The totalm agnitude of the UCFs is given by the UCFs of an asymmetric dot, var[g]\_{asym}, plus the sum of the term s above, i.e., var[g] = var[g]\_{asym} + C\_i + C\_{ii} + C\_{iii} + C\_{iv}. In the lim it of perfectly symmetric leads (N  $_{L}$  = N  $_{L}$  and N  $_{R}$  = N  $_{R}$ ), only C  $_{iv}$  survives and the UCFs have double the magnitude as those for an asymmetric dot. In the lim it of completely asymmetric leads (N  $_{L}$  = N  $_{R}$  = 0), one has C  $_{i}$  + C  $_{ii}$  + C  $_{iv}$  = 0, and the UCFs have the same magnitude as those for an asymmetric dot.

To express var[g] for arbitrary N<sub>L</sub>, N<sub>R</sub>, N<sub>\L</sub>, and N<sub>\R</sub>, we nd it bene cial to introduce the quantities n = N = (N<sub>L</sub> + N<sub>R</sub>) and w = 1 N<sub>\</sub> = N, where = L;R. Making use of the fact that  $n_L + n_R = 1$ , we nd

In terms of the original quantities N  $_{\rm L}$  , N  $_{\rm R}$  , N  $_{\rm L}$  , and N  $_{\rm NR}$  , Eq. (32) takes the form

where  $\operatorname{var}[g]_{asym} = (2=)N_L^2 N_R^2 (N_L + N_R)^4$ . Comparison with Eq. (24) shows that lead displacement suppresses the symmetry-induced contributions to UCFs by a factor that is the square of the suppression of the symmetry-induced contributions to the average conductance.

## C. UCFs in a left-right or inversion-sym m etric quantum dot

For a system swith a left-right or an inversion symmetry, we once again nd the magnitude of the UCFs by evaluating covar[R; R<sup>0</sup>]. For these symmetries, we must consider the contributions in Fig. 5 in addition to those in Fig. 4. The origin of the extra contributions in Fig. 5 ism ost clearly understood by considering the case of perfectly symmetric leads. Then the left-right and inversion sym m etries m ap lead L onto lead R, which m eans that if path 2 is paired with path 1' then path 2 will hit lead R when path 1' hits lead L (meaning the image of path 1' hits lead R). One can thereby immediately see that the contribution  $C_v$  in Fig. 5 contributes to covar[ $R_L$ ;  $R_R$ ] (this was not the case for up-down symmetry, since there path 1' hits the same lead as the image of path 1'). For asymmetric leads a similar situation occurs. If path 1' hits the intersection region of width W  $_{\backslash}\,$  on lead L then its in age hits lead R; thus path 2 will also hit lead R if it is paired with 1' over this segment.

The rules to evaluate each contribution are the same as for up-down symmetry, with now necessarily N $_{\rm L}$  = N $_{\rm R}$  = N $_{\rm L}$ . Using these rules, we  $\,$  nd that

Adding this set of contribution to those already calculated in the previous section, we nd that the UCFs of a left-right or inversion-symmetric dot with asymmetric leads is given by

By comparing this with Eq. (17), we nd that the suppression of symmetry-induced contributions to UCFs is the square of suppression of the symmetry-induced contributions to the average conductance (just as we already found for an up-down symmetric system).

## D . UCFs in a 4-fold sym metric

For completeness, we now brie y discuss UCFs in a 4-fold sym metric dot with asym metric leads. A 4-fold dot has all three of the sym metrics discussed above. Thus the UCFs in a four-fold sym metric system are given by the sum of all possible sym metry-induced contributions (just as with sym metric leads [1]). G iven the results in the preceding sections, the general form ula is easily determ ined. Here we give the result for the special case N  $_{\rm L}$  = N  $_{\rm R}$  = N ,

where  $N_{LR}$  is the intersection between leads L and R under the left-right symmetry,  $N_{inv}$  is the intersection between leads L and R under the inversion symmetry, and  $N_{UD:L}$  ( $N_{UD:R}$ ) is the intersection of lead L (R) with itself under the up-down symmetry. The nalterm in the square-bracket represents the usual UCFs for an asymmetric dot.

Note that the suppression of each symmetry-induced term goes like the square of the equivalent term in the average conductance, Eq. (27).

## VIII. COM PARISON TO RANDOM -MATRIX THEORY

In this section we com pare the sem iclassical predictions derived in the previous sections to num erical results obtained from a phenom enological random -m atrix m odel. This m odel generalizes the construction discussed in Section 9 of part I (R ef. [1]).

The general fram ework is the same as in part I: The conductance is obtained from the Landauer form ula  $g = tr[t^yt]$ , where t is the transm ission block of a scattering




Figure 6: Left panel: M odel of a scatterer (central circle) with internal evolution operator F, coupled to ports to which m odes of the leads can be attached. The labels identify four segments, in which the ports are numerated in the direction of the arrow (port 1 to M =4 in segment 1, port M =4+1 to M =2 in segment 2, port M =2+1 to 3M =4 in segment 3, and port 3M = 4 + 1 to M in segment 4). The dashed lines indicate the possible lines of relation symm etry. M iddle and right panels: Filled circles indicate ports coupled to the left lead, shaded circles indicate ports coupled to the right lead. Show n are a fully symmetry-respecting arrangement and an arrangement in which both leads are displaced, respectively.

Here, F is an internal unitary evolution operator of dimension M while P is an M 2N dimensional matrix speci ed below, and Q = 1 P  $P^{F}$ .

In part I we assumed that the leads respect the geom etrical sym m etries, which allows to fully desym m etrize the system. One can then introduce a xed form of the matrix P and attribute the e ects of symmetries solely to the internal dynamics (the resulting RM T ensembles for F are given in Table 2 of R ef. [1]). It is clear that this full desymmetrization fails when leads are to be displaced. For up-down symmetry, for instances, desymmetrization identi es two e ectively separate systems (consisting of modes of even and odd parity) which do not couple to each other. Shifting lead modes in this representation has no e ect since RMT is invariant under the permutation ofm atrix indices. A real displacem ent of leads, how ever, m ixes the states of even and odd parity. The reason for this discrepancy is that leads are de ned locally in real space, while parity is a global symmetry which connects rem ote parts of the system .

It is therefore necessary to de ne both the internal evolution operator F as well as the coupling to the leads P in a way which resembles modes in a real-space basis. In principle, this can be done, e.g., based on the sinusoidal transverse mode proles of a strip resonator. We adopt a similar, but more elected procedure, whose principle idea is shown in Fig.6. The illustration shows an abstract scatterer with M ports which serve as possible contacts to the system. For each lead we select N ports (with index in for lead L and jn for lead R); the remaining ports are closed o . The internal evolution operator F describes the transport from port to port. The scattering matrix is then given by Eq. (39) where  $P_{m,n} = m_{jin} + m_{jin,N}$ .

A crucial point of the illustration in Fig. 6 is the numeration of ports, which are grouped into 4 segments that m ap in speci c ways onto each other when symmetry operations are applied. (i) Left-right symmetry maps

segm ent 1 onto segm ent 3 and segm ent 2 onto segm ent 4. (ii) Up-down sym m etry m aps segm ent 1 onto segm ent 2 and segm ent 3 onto segm ent 4. (iii) Inversion sym m etry m aps segm ent 1 onto segm ent 4 and segm ent 2 onto segm ent 3. (iv) Four-fold sym m etry m aps all segm ents onto each other.

In the basis of these ports, the explicit symmetries of the internal evolution operator F are speci ed in Table I. Since up-down and left-right symmetry are both manifestations of a re ection symmetry, they are now simply related by a interchanging segments 2 and 3 (as described by the matrix C de ned in TableI); this is a consequence of the fact that we do not fully desymmetrize the updown symmetry (the left-right symmetric case can never be fully desymm etrized because one has to keep track of the identity of the leads). A nite magnetic eld breaks these symmetries, but still allows one to de ne a generalized tim e-reversal sym metry. Sim ilarly, for vanishing magnetic eld, inversion symmetry is obtained from re ection symmetry by interchanging segments 3 and 4 (as described by the matrix D de ned in the table caption). The slightly di erent system atics in the presence of a magnetic eld arises because the orientation of the segm ents m atters; consequently, for inversion sym m etry, tim e-reversal symmetry is e ectively broken but the geom etric symmetry itself is still present in the dynamics (trajectories still occur in symmetry-related pairs).

A convenient choice of a fully sym m etry-respecting arrangem ent of leads which applies to all internal sym m e-

where N = N = 2 and M = M = 4 N = 2. The case of a four-fold sym metry in principle allows two sym metryrespecting arrangements (aligned along each of the two sym metry lines of releast ection); these two arrangements are equivalent in RMT and again related by a reshuing of the 4 segments. The form of P for generally placed leads is easily read o Fig.6.

Figures 7 (for B B<sub>c</sub>) and 8 (for B B<sub>c</sub>) show how the weak localization correction and universal conductance uctuations are a ected when the leads are moved away from the symmetry-respecting positions. The degree of displacement is quantiled by a variable = 1 W = W (= 0 in the symmetric arrangement, = 1 in the asymmetric arrangement). The data points are based on an ensemble average over 5000 RM T matrices with M = 1000 and N = 50, while the curves are the predictions of our semiclassical theory, which can be written as

Starting from a four-fold symmetry, leads can be displaced in a manner which still preserves left-right, inversion, or up-down symmetry. To preserve up-down symmetry alone, one can imagine splitting one lead in two





Figure 7: (colour online). Weak localization correction (W L, left panels) and universal conductance uctuations (UCF, right panels) as a function of the displacement of both leads from their symmetry-respecting positions for systems with xed internal symmetry. The displacement is measured in terms of = 1 W  $\$  The data points (circles with a variety of lling styles) are obtained from an average over 5000 realizations of the RMT model described in the text (M = 1000, N = 50). The curves show the sem iclassical prediction (41) for W L and (42) for UCF. Labels A ! B' specify the symmetry of the lead arrangement at = 0 (symmetric arrangement) and = 1 (where at least one of the symmetries is fully removed). In these labels, the subscript 4 on A or B indicates that the internal symmetry is four-fold; if this subscript is not present the internal symmetry is identical to the one specified by A. In this gure, the magnetic eld is set to B = 0.

and moving the two parts in opposite directions (both parts would remain contacted to the same source or drain electrode). The remaining symmetry of the lead arrangement can then be broken by further displacement of the leads. In the gures, the subscript is used to distinguish these situations (in which the underlying internal symmetry is four-fold) from the symmetry breaking in systems with only a single internal symmetry. ! asymmetric' refers to the displacement of leads out of a left-right symmetric position where the internal symmetry is itself only left-right symmetric. A coording to our theory, the weak localization correction should behave identically in both situations; this also applies to the UCFs. This statement is validated by the numerical data. Indeed, excellent agreement of the numerical data with the sem iclassical predictions is observed in all cases.

As discussed earlier in this paper, in the up-down sym metric case it is interesting to displace only one lead while the other lead remains on the symmetry line (the






Figure 8: (colour online). Same as Fig. 7, but for a nite magnetic eld.




Figure 9: (colour online). Same as Figs. 7 and 8, but com paring the displacem ent of both leads for internal up-down symm etry (solid circles) to the displacem ent of the rst lead (circles lled on the right), followed by the displacem ent of the second lead (circles lled on the left).

sym m etry-preserving positions in the up-down sym m etric case are absolute, in contrast to the left-right sym – m etric case where these positions are relative to each other). The e ect on the transport is shown in Fig.9, along with the e ect of the consecutive displacem ent of the second lead, and the simultaneous displacem ent of both leads. A coording to our theory, the e ects of consecutive displacem ent of the leads are cumulative: The displacem ent of the rst lead is described by Eqs. (1), (42) with ! =2 (covering the range [0,1/2]), while the displacem ent of the substitution ! (1 + )=2 (covering the range [1/2,1]). The num erical results are in perfect agreem ent with this prediction.

We conclude with some additional remarks on the RMT model. For leads which respect the sym metries, the construction presented here is equivalent to the model presented in part I (which then is more e cient); this equivalence also extends to the symmetry breaking in the internal dynamics, which then requires to interpolate between ensembles of Table I. Following earlier works, the RMT model can be further utilized to include the e ects of dephasing and a nite Ehrenfest time. For dephasing, this is achieved by opening additional ports which couple to a voltage probe [26] or a dephasing stub [27]. A nite Ehrenfest time is obtained when F represents a dynamical system, such as the kicked rotator [12] (which also possesses discrete symmetries). This strategy can also be used to probe the case of dynamics which are not fully chaotic (which in the kicked rotator is achieved for moderate values of the kicking strength).

#### IX. CONCLUDING REMARKS

The transport calculations perform ed here assume that the classical dynamics is uniform ly chaotic, and in particular do not apply to system with islands of stability in phase space (such as the annular billiard studied in Refs. [28, 29]), or networks of chaotic dots inter-connected by narrow leads (such as the double dot in Ref. [7]). It would be intriguing to study the shape of the back- and forward-scattering peaks for such system s.

## Appendix A:OBTAIN IN G UCFS FROM THE VARIANCE OF REFLECTION

In Section V II we pointed out that unitarity implies  $\operatorname{covar}[R_{L}; R_{R}] = \operatorname{var}[R_{L}] = \operatorname{var}[R_{R}]$ . Here we outline a sem iclassical calculation of  $\operatorname{var} \mathbb{R}_L$ ], which acts as a check of the sem iclassical calculation of  $\operatorname{covar} \mathbb{R}_L$ ; $\mathbb{R}_R$ ] in Section V II. The rules to calculate each contribution rem ain the same as for  $\operatorname{covar} \mathbb{R}_L$ ; $\mathbb{R}_R$ ]. However, the contributions that we consider di er by the requirement that all paths start and end on the same lead L.

We know that the result must be invariant under the interchange of labels \L" and \R", and this invariance is manifestly obvious in the contributions to  $covar[R_L;R_R]$ . In contrast, this invariance is hidden in the contributions to  $var[R_L]$  that we discuss here. Thus the simplest check that one has not missed any contributions is that this invariance is present when one sum s the contributions.

### 1. Up-down symmetric dot

In the case of an up-down symmetric dot, all contributions in both Fig.4 and Fig.5 contribute to var $\mathbb{R}_L$ ] once we change all lead labels so that  $\mathbb{R}$ "!  $\mathbb{L}$ " and  $\mathbb{R}$ "!  $\mathbb{L}$ " and  $\mathbb{R}$ "!  $\mathbb{R}$  [ but not vice versa). Writing contributions to var $\mathbb{R}_L$ ] with a "prime" (to distinguish them from contributions to covar $\mathbb{R}_L$ ;  $\mathbb{R}_R$ ]) we nd

As in section V II, we nd that this sum is most easily evaluated by re-writing the contributions in terms  $n = N = (N_L + N_R)$  and  $w = 1 N_{\setminus} = N$  for = L;R. Performing a little algebra using  $n_L + n_R = 1$ , we then recover Eq. (32), and therefore  $var R_L$ ] =  $covar R_L;R_R$ ]. Furthermore, expression Eq. (32) is invariant under the interchange of labels L and R, which entails  $var R_R$ ] =  $var R_L$ ]. Thus the sem iclassical method obeys the relations  $var R_L$ ] =  $var R_R$ ] =  $covar R_L;R_R$ ], as required by the unitarity of the scattering matrix. This strongly suggests that we have not missed any contributions and gives us condence in the result; particularly, it is notew orthy that the individual contributions in  $var R_L$ ] and  $covar R_L;R_R$ ] combine in very di erent ways to give the invariance under the interchange of L and R.

#### 2. Left-right or inversion-sym m etric dot

The evaluation of  $var \mathbb{R}_{L}$  ] for a left-right or inversionsymmetric dot is very similar to that for an up-down symmetric dot. However, here, when a path hits the L

lead then its image hits the R lead. This means that there are no contributions to  $\operatorname{var} \mathbb{R}_L$  ] of the form shown in Fig. 5, since all paths must go from the L lead to the L lead. Thus to get  $\operatorname{var} \mathbb{R}_L$  ] for a left-right or inversionsymmetric dot, we need to subtract those contributions from the result for  $\operatorname{var} \mathbb{R}_L$  ] in an up-down symmetric dot. The sum of these contributions to  $\operatorname{var} \mathbb{R}_L$  ], written with the same denom inator as in Eq. (33), is

This only di ers by an overall sign from the sum of contributions in Eq. (36). Subtracting this from the result Eq. (33), we get  $var R_L$ ] for a left-right or inversionsymmetric dot. The result equals  $covar R_L; R_R$ ] given by Eq. (37), thus we have  $covar R_L; R_R$ ] =  $var R_L$ ] =  $var R_R$ ], as required by the unitarity of the scattering matrix.
