## G eneralization of O kam oto's equation to arbitrary 2 2 Schlesinger system s

#### A bstract

The 2 2 Schlesinger system for the case of four regular singularities is equivalent to the Painleve VI equation. The Painleve VI equation can in turn be rewritten in the symmetric form of 0 kam oto's equation; the dependent variable in 0 kam oto's form of the PVI equation is the (slightly transformed) logarithmic derivative of the Jimbo-M iwa tau-function of the Schlesinger system. The goal of this note is twofold. First, we note a symmetric uniform formulation of an arbitrary Schlesinger system with regular singularities in terms of appropriately dened Virasoro generators. Second, we note analogues of 0 kam oto's equation for the case of the 2 2 Schlesinger system with an arbitrary number of poles. A new set of scalar equations for the logarithmic derivatives of the Jimbo-M iwa tau-function is derived in terms of generators of the Virasoro algebra; these generators are expressed in terms of derivatives with respect to singularities of the Schlesinger system.

#### 1 Introduction

The Schlesinger system is the following non-autonomous system of dierential equations for N unknown matrices  $A_j 2 sl(M)$  depending on N variables  $f_j g$ :

The system (1.1) determines isomonodromic deformations of a solution of matrix ODE with meromorphic coecients

The solution of this system normalized at a xed point  $_0$  by  $(_0) = I$  solves a matrix R iem ann-H ilbert problem with some monodrom y matrices around the singularities  $_1$ .

The Schlesinger equations were discovered almost 100 years ago [1]; however, they continue to play a key role in many areas of mathematical physics: the theory of random matrices, integrable systems, theory of Frobenius manifolds, etc.. The system (1.1) is a non-autonomous ham iltonian system with respect to the Poisson bracket

where  $f^{ab}_{c}$  are structure constants of sl(M );  $_{jk}$  is the K ronecker symbol. Obviously, the traces trA $_{j}^{n}$  are integrals of the Schlesinger system for any value of n. The commuting H am iltonians de ning evolution with respect to the times  $_{j}$  are given by

The generating function  $_{\rm JM}$  (f  $_{\rm j}$ g) of the ham iltonians H  $_{\rm j}$ , de ned by

was introduced by Jimbo, M iwa and their co-authors [2, 3]; it is called the —function of the Schlesinger system. The —function plays a key role in the theory of the Schlesinger equations; in particular, the divisor of zeros of the —function coincides with the divisor of singularities of the solution of the Schlesinger system; on the same divisor the underlying R iem ann-H ilbert problem looses its solvability.

In the sim plest non-trivial case when the matrix dimension equals M=2 and the number of singularities equals N=4, the Schlesinger system can equivalently be rewritten as a single scalar dierential equation of order two | the Painleve VI equation

where t is the cross-ratio of the four singularities  $a_1$ ;:::;  $a_1$ , and  $a_2$  is the position of a zero of the upper right corner element of the matrix  $a_1$ ;:::;  $a_1$ , and  $a_2$  is the position of a zero of the matrices  $a_2$  by  $a_3$ =2 and  $a_3$ =2. Then the constants  $a_2$ ;  $a_3$ ;  $a_4$  and  $a_4$  from the Painleve VI equation (1.6) are related to the constants  $a_2$  as follows:

It was further observed by 0 kam oto [4,5], that the Painleve VI equation (and, therefore, the original 2 2 Schlesinger system with four singularities) can be rewritten alternatively in a simple form in terms of the so-called auxiliary ham iltonian function h(t). To de ne this function we need to introduce rst four constants  $b_j$ , which are expressed in terms of the eigenvalues of the matrices  $A_j$  as follows:

The auxiliary ham iltonian function h (t) is de ned in terms of solution y of equation (1.6) and the constants  $b_i$  as follows:

In terms of the function h, the Painleve equation (1.6) can be represented in a remarkably symmetric form as follows:

O kam oto's form (1.11) of the Painleve VI equation turned out to be extremely fruitful for establishing the hidden symmetries of the equation (the so-called O kam oto symmetries). These symmetries look very simple in terms of the auxiliary ham iltonian function h, but are highly non-trivial on the level of the solution y of the Painleve VI equation, the corresponding monodromy group and the solution of the associated fuchsian system [6,7].

The goal of this paper is twofold. First, we show how to rewrite the Schlesinger system in an arbitrary matrix dimension in a symmetric universal form. Second, we use this symmetric form to not natural analogues of the 0 kam oto equation (1.11) for 2 2 Schlesinger systems with an arbitrary number of simple poles. Our approach is similar to the approach used by J.H amad to derive analogues of the 0 kam oto equation for Schlesinger systems corresponding to higher order poles (non-fuchsian systems) [8].

Namely, introducing the following dierential operators (which satisfy the commutation relations of the Virasoro algebra):

for all n 0 and m 1. The in nite set of equations (1.12) is of course dependent for any given N . To derive the original Schlesinger system (1.1) from (1.12) it is su cient to take the set of equations (1.12) for n N and m N . The advantage of the system (1.12) is in its universality: its form is independent of the number of the poles; the positions of the poles enter only the de nition of the di erential operators L  $_{\rm m}$  .

Consider now the case of 2 2 m atrices. To form ulate the analog of the 0 kam oto equation for the case of an arbitrary number of poles we introduce the following \ham iltonians":

which can be viewed as sym m etrised analogues of the H am iltonians (1.4); they coincide with  $L_m$  log  $_{\text{JM}}$  up to an elementary transformation. The simplest equation satisfied by  $P_m$  in the case of 2 2 system is given by

as we shall show in the following.

Since the  $P_m$  them selves are combinations of the rst order derivatives of the tau-function, this equation is of the third order; it also has cubic non-linearity. In the case N = 4 the equation (1.13) boils down to the standard O kam oto equation (1.11).

The paper is organized as follows. In Section 2 we derive the sym m etrised form of the Schlesinger system. In Section 3 we derive the generalized 0 kam oto equations. In Section 4 we show how the usual 0 kam oto equation is obtained from the generalized equation (1.13) in the case N = 4. In section 5 we discuss some open problems.

# 2 Sym m etrisation of Schlesinger system in term s of V irasoro generators

#### 2.1 Variation of a Riem ann surface by vector elds on a contour

The  $\times$  j of the Schlesinger system can be viewed as coordinates on the space of genus zero Riemann surfaces with N punctures (we do not speak about the moduli space since we

do not identify two con gurations of punctures related by a M objus transform ation). The vectors  $\emptyset=\emptyset$  j span the tangent space to the space of N -punctured spheres. However, there exist m any di erent ways to param etrize the tangent space to the space of R iem ann surfaces of given genus with a xed number of punctures.

One example is the variation of a Riemann surface by vector elds on a chosen closed contour lenclosing a disc D (see [9]). To vary an unpunctured Riemann surface L of genus g by a vector eld v on the contour lone cuts the disc D and attaches it back with in nitesimal shift of the boundary along the vector eld v. The complex structure of the Riemann surface also changes in nitesimally (or remains the same). The in nite-dimensional space V of vector elds on l can be represented as direct sum of three subspaces,  $V_{in}$  (which consists of vector elds which can be analytically continued inside of the disc D),  $V_{out}$  (which consists of vector elds which can be analytically continued outside of the disc D) and  $V_{0}$  (which consists of vector elds whose analytical continuation is impossible neither inside nor outside of the disc D). The moduli of Riemann surface L are not changed by vector elds from  $V_{in}$  and  $V_{out}$ ; the dimension of  $V_{0}$  turns out to be equal to  $V_{0}$  as i.e. to dimension of the moduli space, and the vector elds from  $V_{0}$  do change the complex structure of the Riemann surface.

If the R iem ann surface L has punctures (which are assumed to lie outside of D), the vector elds from  $V_{\text{out}}$  should not only adm it analytical continuation to the exterior of D, but also vanish at all the punctures.

To apply this general scheme in our present framework we choose the contour 1 to be a circle around = 1 (such that all points  $_j$  lie \outside" of this circle). The standard basis in the space of vector elds on 1 is given by  $v_m := ^{m+1}d=d$ ,  $m \ge 2$ ; the vectors  $v_m$  satisfy standard commutation relations  $[v_m; v_n] = (n - m)v_{m+n}$ . How to relate variation of positions of the punctures  $_j$  to variation along vector elds  $v_m$ ? Notice that the elds  $v_m$  with m - 3 can be holomorphically continued in a neighbourhood of = 1, and, therefore, do not vary the singularities  $_m$ ; they span the vector space  $V_{in}$  in our case. The vector elds  $v_m$  with  $m = 2;0;1;\dots$  can not be analytically continued in the neighbourhood of 1. Being analytically continued in the neighbourhood of 0, these elds do not vanish at  $_m$ ; however, there exists an in nite-dimensional space (this is  $V_{out}$  in our case) of linear combinations of these  $v_m$ 's which vanish at all points  $_m$ . The space  $V_0$  can be chosen in dierent ways. For example,  $V_0$  can be chosen to be spanned by all linear combinations of  $v_0$ ::::; $v_0$  2.

However, our goal will be to describe all Schlesinger equations (independently of the number of singularities) within one setting. Therefore, we shall vary  $_{j}$  by all  $v_{m}$  with m=1;0;1;2;::: in spite of the fact that for any given N all these vectors can be expressed as linear combinations of N vectors  $\emptyset=\emptyset$   $_{j}$ .

N am ely, the action of the vector  $\,$  eld  $v_m$  on f  $\,_jg$  is given by the following linear combination of the tangent vectors 0=0  $\,_m$  :

 $L_m$  and  $v_m$  coincide as tangent vector to the space of N -punctured spheres. The vectors  $L_m$  also satisfy commutation relations of V irasoro algebra:

#### 2.2 Schlesinger system in terms of Virasoro generators

To sym m etrise the Schlesinger equations we also introduce the sym m etric dependent variables:  $_{\rm X}$

The new variable

plays a distinguished role: it vanishes on-shell (i.e. on solutions of the Schlesinger system); however, o -shell it plays the role of a generator (with respect to the Poisson bracket (1.3)) of constant gauge transform ations (i.e. constant simultaneous similarity transform ations of all matrices  $A_i$ ).

To describe the dynam ics under the action of the di erential operators L  $_{\rm m}$  we introduce the sym m etrised H am iltonians H  $_{\rm m}$  :

We note that form ally the second term can be absorbed into the sym plectic action  $fH_m$ ;  $B_ng$  upon extending the a ne Poisson structure (2.16) by the standard central extension.

### 3 G eneralized O kam oto equations

Here we shall use the sym metric form (2.11) of the Schlesinger equations to derive an analog of 0 kam oto's equation (1.11) for an arbitrary 2 2 Schlesinger system. In fact, one can write down a whole family of scalar dierential equations for the tau-function in terms of the Virasoro generators  $L_{\rm m}$ . In the next theorem we prove two equations of this kind.

C om bining this equation with (3.3) we can thus express also tr ( $B_k \mid B_m ; B_n \mid$ ) entirely in term s of the action of the operators  $L_m$  on the H am iltonians  $P_n$ , which can further be simplified upon using the commutation relations (2.1) and (2.15). This leads to the closed expression

To derive from these relations the desired result, we make use of the following algebraic identity

valid for an arbitrary set of six m atrices M  $_{\rm j}$  2 sl(2), where the dots on the right-hand side denote complete antisymmetrisation of the expression with respect to the indices 1;2;3. In terms of the structure constants of sl(2), this identity reads

where adjoint indices a;b;::: are raised and lowered with the Cartan-Killing form. Setting in (3.8) M  $_1$  = M  $_4$  = B $_1$ , M  $_2$  = M  $_5$  = B $_2$  and M  $_3$  = M  $_6$  = B $_3$ , and using (3.3), (3.7), we arrive (after some calculation) at (3.1).

Equation (3.2) descends from another algebraic identity

valid for any four sl(2)-valued m atrices M  $_{\rm j}$ . In term s of the structure constants of sl(2), this identity reads

The lhs. of this equation can be reduced by (3.5) while the rst terms on the rhs. are reduced by means of the algebraic relations (3.10) together with (3.3). As a result we obtain equation (3.2).

#### 4 Four simple poles: reproducing the 0 kam oto equation

As rem arked above, the explicit form of the diemential equations (3.1), (3.2) for the —function  $_{\rm JM}$  is obtained upon expressing the modi ed H am iltonians  $P_{\rm m}$  in terms of  $_{\rm JM}$  by virtue of (2.5), (2.8). As an illustration, we will work out these equations for the Schlesinger system with four singularities and show that they reproduce precisely 0 kam oto's equation (1.11). For N = 4, the modi ed —function ~ from (2.9) depends only on the cross-ratio

Then equation (3.1) in terms of S after lengthy but straightforward calculation gives rise to the second order di erential equation

Finally, it is straightforward to verify that with h (t) S (t)  $\frac{1}{12}$  (1 2t)  $_1$  [C], equation (4.3) is equivalent to 0 kam oto's equation (1.11).

In turn, equation (3.2) leads to the following quadratic, third order di erential equation in the function S:

Indeed, this equation can also be obtained by straightforward di erentiation of (4.3) with respect to t. In term s of the function h equation (4.4) takes the following form

#### 5 Discussion and Outlook

We have shown in this paper that the symmetric form (2.11), (2.12) of the Schlesinger system gives rise to a straightforward algorithm that allows to translate the algebraic sl(2) identities (3.9), (3.11) into dierential equations for the —function of the Schlesinger system. In the simplest case of four singularities, the resulting equations reproduce the known 0 kam oto equation (1.11). In the case of more singularities, the same equations (3.1), (3.2) give rise to a number of non-trivial dierential equations to be satisfied by the —function.

A part from this direct extension of 0 kam oto's equation, the link between the algebraic structure of sl(2) and the Schlesinger system 's —function gives rise to further generalizations. Note, that in the proof of Theorem 2, with equation (3.6) we have already given the analogue of (3.7) to arbitrary values of k; m; n. Combining this equation with the identity (3.8) thus gives rise to an entire hierarchy of third order equations that generalize (3.1). Likewise, the construction leading to the fourth order equation (3.2) can be generalized straightforwardly upon applying (3.10) to other V irasoro descendants of the cubic equation.

As an illustration, we give the st three equations of the hierarchy generalizing (32):

O by iously, these equations are not all independent, but related by the action of the lowest V irasoro generators  $L_{-1}$ , using that

etc., since  $P_1 = 0$ . The number and structure of the independent equations in this hierarchy is thus organized by the structure of representations of the Virasoro algebra. For the case of N = 4 singularities, the explicit form of all the equations of the hierarchy reduces to equivalent forms of (1.11) and (4.5). With growing number of simple poles, the number of independent dierential equations induced by the hierarchy increases.

Therefore, we arrive to a natural question: which set of derived equations for the tau-function is equivalent to the original Schlesinger system? We stress that all dierential equations for the tau-function are PDE with respect to the variables  $_1;:::;_N$ . However, if one gets a su ciently high number of independent equations, one can actually come to a set of ODE's for the tau-function. This situation resembles the situation with the original form of the Schlesinger system (1.1): if one ignores the second set of equations in (1.1), one gets a system of PDE's for the residues  $A_j$ ; only upon adding the equations for  $@A_j = @_j$  one gets a system of ODE's with respect to each  $_j$  (the ows with respect to dierent  $_j$  commute).

Let us nally note that the construction we have presented in order to derive the differential equations (3.1), (3.2) suggests a number of interesting further generalizations that deserve further study.

At the origin of our derivation have gured the algebraic s(2) identities s(3), s(3,11) that we have translated into di erential equations. Similar identities exist also for higher rank groups (e.g. s(3,1)) where the number of independent tensors s(3,1), s(3,2) can be derived from such higher rank algebraic identities. Is it possible to combine our present construction applicable to Schlesinger systems with simple poles only with construction of [8] which requires the presence of higher order poles? What would be the full set of equations for the tau-function with respect to the full set of deformation parameters in presence of higher order poles?

The Schlesinger system  $\ 1.1)$  has also been constructed for various higher genus R iemann surfaces [10, 11, 12, 13]. It would be interesting to rst of all nd the proper generalization of the symmetric form (2.11), (2.12) of the Schlesinger system to higher genus surfaces which in turn should allow to derive by an analogous construction the non-trivial dierential equations satisfied by the associated —function. We conjecture that in some sense the form (2.11) should be universal: it should remain the same, although the denition of the Virasoro generators  $L_m$  and the variables  $B_m$  may change.

As we have mentioned above, the extra term  $nB_{m+n}$  in the Ham iltonian dynam ics of the sym metrised Schlesinger system (2.17) can be absorbed into the sym plectic action upon replacing the standard a ne Lie-Poisson bracket (2.16) by its centrally extended version. However, this central extension is not seen in any of the nite-N Schlesinger system s. This seems to suggest that the system (2.11) should be considered not just as a sym metric form of the usual Schlesinger system with nite number of poles, but as a \universal\* Schlesinger system which involves an in nite set of independent variables  $B_n$ . Presum ably, this full system involves the generators  $L_n$  and coe cients  $B_n$  not only for positive, but also for negative n.

In this setting, the centrally extended version of the bracket (2.16) should appear naturally. The most interesting problem would be to not the geometric origin of such a generalized system; a possible candidate could be the isom onodrom ic deform ations on higher genus curves.
