Zeros of Airy Function and Relaxation Process

A bstract

One-dim ensional system of Brownian motions called Dyson's model is the particle system with long-range repulsive forces acting between any pair of particles, where the strength of force is =2 times the inverse of particle distance. When = 2, it is realized as the Brownian motions in one dimension conditioned never to collide with each other. For any initial conguration, it is proved that Dyson's model with = 2 and N particles, $X (t) = (X_1(t); :::; X_N(t)); t 2 [0;1); 2$ N < 1 , is determ inantal in the sense that any multitime correlation function is given by a determinant with a continuous kernel. The Airy function Ai(z) is an entire function with zeros all located on the negative part of the real axis R. We consider Dyson's model with = 2 starting from the rst N zeros of Ai(z), à √aN 2. In order to properly control the e ect of such initial con nem ent of particles in the negative region of R, we put the drift term to each Brownian motion, which increases in time as a parabolic function : $Y_{j}(t) = X_{j}(t) + t^{2} = 4 + fd_{1} + \int_{t=1}^{t} (1 = a_{1})gt_{j} = 1$ N, where $d_{1} = A_{1}(0) = A_{1}(0)$. We show that, as the N ! 1 $\lim_{t\to\infty} f(x) = (Y_1(t); \dots; Y_N(t)); t \ge [0;1),$ we obtain an in nite particle system, which is the relaxation process from the con guration, in which every zero of Ai(z) on the negative R is occupied by one particle, to the stationary state Ai. The stationary state Ai is the determ inantal point process with the Airy kernel, which is spatially inhom ogeneous on R and in which the Tracy-W idom distribution describes the rightmost par-

1 Introduction

1.1 Dyson's model: One-Dimensional Brownian Particle System Interacting through Pair Force 1=x

To understand the time-evolution of distributions of interacting particle systems on a large space-time scale (therm odynamic and hydrodynamic limits) is one of the main topics of statistical physics. If the interactions among particles are short ranged, the standard theory is useful. If they are long ranged, however, general theory has not yet been established and thus detailed study of model systems is required [26].

In the present paper, we consider B row nian particles in one dimension with long-ranged repulsive forces acting between any pair of particles, where the strength of force is exactly equal to 1=x when the particle distance is x. If the number of particles is nite N < 1, the system is described by (t) = $\frac{N}{j=1} \times_{j}(t)$, 2 N < 1, where X (t) = (X 1 (t);:::;X N (t)) satisfies the following system of stochastic differential equations (SDEs);

with independent one-dimensional standard Brownian motions B_j (t); 1 - j - N. The SDEs obtained by replacing the 1=x force in (1.1) by = (2x) with a parameter > 0 were introduced by Dyson [4] to understand the statistics of eigenvalues of herm itian random matrices as particle distributions of interacting Brownian motions in R. Corresponding to the special values = 1;2 and 4, herm itian random matrices are in the three statistical ensembles with dierent symmetries, called the Gaussian orthogonal ensemble (GOE), the Gaussian unitary ensemble (GUE), and the Gaussian symplectic ensemble (GSE), respectively [5]. In particular for = 2, that is the case of (1.1), if the eigenvalue distribution of N N herm itian random matrices in the GUE with variance 2 is denoted by $^{\rm GUE}_{\rm SE}$, we can show

where $_{\rm sin}$ denotes the determ in antal (Ferm ion) point process [24, 23] with the so-called sine kernel

That is, $_{\sin}$ is a spatially hom ogeneous particle distribution, in which the particle density is given by $_{\sin}=\lim_{x \to 0}K_{\sin}(x)=1$ and any N $_{1}$ -point correlation function $_{\sin}(x_{N_{1}});x_{N_{1}}=(x_{1};:::;x_{N_{1}})$ 2 $R^{N_{1}};N_{1}$ 2, is given by a determinant of an N $_{1}$ N $_{1}$ real symmetric matrix;

Based on this fact known in the random matrix theory [17], Spohn [25] studied the equilibrium dynamics obtained in the in nite-particle limit N ! 1 of Dyson's model (1.1). Since the 1=x force is not summable, in the in nite-particle limit N ! 1 the sum in (1.1) should be regarded as an improper sum, in the sense that for X $_j$ (t) 2 [L;L] the summation is restricted to k's such that X $_k$ (t) 2 [L;L] and then the limit L ! 1 is taken. It is expected that the dynamics with an in nite number of particles can exist only for initial con gurations having the same asymptotic density to the right and left [25, 13].

The problem, which we address in the present paper, is how we can control Dyson's model with an in nite number of particles starting from asymmetric initial con gurations. The motivation is again coming from the random matrix theory as follows. Consider the Airy function [1,30]

Then in the particle lim it diesent from (1.2) and is called the soft-edge scales.

It is another in nite-particle lim it di erent from (12) and is called the soft-edge scaling lim it, since $x^2=2t'$ (2N $^{2=3}$) $^2=(2N ^{1=3})=2N$ m arks the right edge of sem icircle-shaped pro le of the GUE eigenvalue distribution (see, for example, [12]). The particle distribution $_{A\,i}$ with the A iry kernel (1.7) is highly asymmetric: A s a m atter of fact, the particle density $_{A\,i}(x)=K_{A\,i}(x)$ decays rapidly to zero as x! 1, but it diverges

Let R be the position of the rightm ost particle on R in $_{Ai}$. Then its distribution is given by the celebrated Tracy-W idom distribution [28]

satisfying the boundary condition q(x) ' Ai(x) in x! 1 . Prahofer and Spohn [22] and Johansson [11] studied the equilibrium—uctuation of this rightm ost particle and called it the Airy process. Tracy and W idom derived a system of partial dierential equations, which govern the Airy process [29]. See also [2, 3]. How can we realize Ai as the equilibrium—state of Brownian in nite-particle system—interacting through pair force 1=x? The initial congurations should be asymmetric, but what kinds of conditions should be satisted by them? How should we modify the SDEs of original Dyson's model (1.1), when we provide—nite-particle approximations for such asymmetric in nite particle systems?

In the present paper, as an explicit answer to the above questions, we will present a relaxation process with an in nite number of particles converging to the stationary state $_{\rm A\,i}$ in t! 1 . Its initial con guration is given by

in which every zero of the Airy function (1.4) is occupied by one particle. This special choice of the initial con guration is due to the fact that the zeros of the Airy function are located only on the negative part of the real axis R,

(x) of $\lim_{N \to 1} N$ will show the same asymptotic in x! but the particle density 1 as (1.8). Because of the strong repulsive forces acting between particle pairs in (1.1), such con nement of particles in the negative region of R at the initial time causes strong positive drifts of Brownian particles. The coe cient (1.13) of the drift term D_{A_N} t added in (1.12), however, negatively diverges

We will determ in eaclass of asymmetric initial conqurations denoted by X_0^A , which includes A as a typical one, such that the e ect on dynamics of asymmetry in con guration will be compensated by the additional drift term D $_{\rm A_{\, N}}$ t in the in niteparticle lim it N ! 1 and the dynam ics with an in nite number of particles exists. Note that we should take N $\,!\,\,$ 1 $\,$ lim it for nite t < 1 $\,$ in our process (1.12) to discuss non-equilibrium dynamics with an in nite number of particles. In the class X_0^A , when the initial conguration is specially set to be A, (1.9), we can prove that the dynam ics shows a relaxation in the long-term $\lim it t!$ 1 to the equilibrium dynamics in Ai. In the proof we use the special property of the systems (1.1)

and (1.14) such that the processes have space-time determ inantal correlations. This feature comes from the fact that if and only if the strength of pair force is exactly equal to 1=x when the particle distance is x, i.e., i=2, D yson's model is realized as the B row nian motions conditioned never to collide with each other [10, 12].

In order to explain the importance of the notion of entire functions for the present problem, we rewrite the results reported in our previous paper [13] for Dyson's model with symmetric initial congurations below. Then the changes which we have to do for the systems with asymmetric initial congurations are shown. There the origin of the quadratic term $t^2=4$ in (1.12) will be clarified.

1.2 Processes with Space-time Determinantal Correlations and Entire Functions

In an earlier paper [13], we studied a class of a non-equilibrium dynam ics of D yson's model with = 2 and an in nite number of particles. As an example in the class, we reported a relaxation process, denoted here by ((t); P_{sin}), which starts from a con guration

The nite dimensional distributions of the process ((t); P_{sin}) are determined by K_{sin} through (1.18). It is expected that the correlation kernel K_{sin} is described by using the sine function as is the correlation kernel K_{sin} of the stationary distribution S_{sin} given by (1.3). x;y 2 R. We denote by ($_A$ (t); P_{Ai}) the in nite particle system, which is determinantal with the correlation kernel K_{Ai} [9, 19, 15, 12]. The Airy kernel (1.7) of $_{Ai}$ is given by $K_{Ai}(y;x) = K_{Ai}(0;y;x)$ and thus ($_A$ (t); P_{Ai}) is a reversible process with respect to $_{Ai}$. The process ($_A$ (t); P_{Ai}), which is determinantal with the correlation kernel K_{Ai} , is a non-equilibrium in nite particle system exhibiting the relaxation phenomenon from the initial con guration $_A$ to the stationary state $_{Ai}$.
