# On the localized wave patterns supported by convection $\{$ reaction $\{d i$ usion equation

#### Abstract

A set of traveling wave solution to convection-reaction-di usion equation is studied by $m$ eans ofm ethods of localnonlinear analysis and num erical sim ulation. It is show $n$ the existence of com pactly supported solutions as wellas solitary waves $w$ ith in th is fam ily for $w$ ide range of param eter values.

## 1 Introduction

W e consider evolutionary equation

where ; $U_{1}$ are positive constants,' (u) is a sm ooth fiunction nullifying at the origin and $m$ aintaining a constant sign $w$ ithin the set ( $0 ; \mathrm{k} U_{1}$ ) for som e $k>1$. Equation (1) referred to as convection \{reaction\{di usion equation is used for sim ulating transport phenom ena in active m edia. D ue to its practical applicability and a num ber of unusual features, equation (1) was intensely studied in recent decades [1, 2, 3, $3,4,[5,6,7,8]$.
$P$ resent investigations are $m$ ainly devoted to qualitative and num erical study of the fam ily of traveling wave (TW ) solution to equation (1). O ur aim is to show that under certain conditions the set of TW solutions contains periodic regim es, solitary waves and com pactons $w$ th special em phasis put on the existence of com pactons. Solitary wave solutions (or solitons) are exponentially localized wave packs moving with constant velocity without change of their shape. They are $m$ ostly associated $w$ ith the fam ous $K$ orteveg de Vries ( $K$ dV ) equation and $m$ em bers of $K$ dV hierarchy having the form

where $V$ stands for the wave pack velocity.
In 1993 P hilip R osenau and John Hym an put forw ard the follow ing generalization to $\mathrm{K} d V$ hierarchy [10]:

M odi cation in the higher-derivative term causes that $m$ em bers of $K(m ; n)$ hierarchy possess solutions w ith com pact support. Form $=\mathrm{n}=2$ com pactly supported solution (or com pacton) has the form

B oth solitons and com pactons are the TW solutions, depending in fact on a single variable $=\mathrm{x} \quad \mathrm{V} t$, are described by ODEs appearing when the TW ansatz $\mathrm{u}(\mathrm{t} ; \mathrm{x})=$ $U()$ is inserted into the source equations (for details see e.g. [11]). Therefore it is possibile to give a clear geom etric intenpretation of solitons and com pactons. To both of them correspond hom oclinic trajectories in the phase space of the factorized equations. The $m$ ain di erence betw een the solitary wave and com pacton is that the rst one is nonzero for any while the last one is nonzero only upon som e com pact set. This is because the soliton corresponds to the hom oclinic loop usually bi-asym ptotic to a sim ple saddle. H ence the "tim e" needed to penetrate the close loop is in nite. C om pacton corresponds to the hom oclinic loop bi-asym ptotic to a topological saddle lying on a singular line. A consequence of this is that the corresponding vector eld does not tend to zero as the hom oclinic tra jectory approaches the stationary point, hence the "tim e" required to penetrate the trajectory rem ains nite. Let us note that the com pacton in fact is a conjunction of the nonzero part corresponding to the hom oclinic loop and the trivial constant solution represented by the saddle point [11].

For the sake ofbrevity we m aintain the notation traditionally used in m ore speci c sense. T hus, soliton is usually associated w ith the localized invariant solution to any com pletely integrable PD E , possessing a num ber of unusual features [9]. Som e of these features are inherited by com pactons as well [10, [12, 13]. H ere we m aintain this notion to those solutions to [1]), which $m$ anifest sim ilar geom etric features as "tnue" wave pattems known under these nam es, not pretending that they inherit all features of their fam ous precursors.

The structure of the article is follow ing. In section 2 we present the dynam ical system describing the TW solutions to (1) and $m$ ake its qualitative analysis, obtaining conditions that contribute to the hom oclinic loop appearance. At the end of this section we form ulate the conditions enabling to $m$ ake a distinction betw een com pactons and solitons. Conditions form ulated in section 2 contribute but not guarantee the
hom oclinic loop appearance. The follow ing section contains the results of num erical sim ulations revealing that expected scenarios of solitons' and com pactons' appearance really take place. In section 4 we perform a briefdiscussion of the results obtained and outline directions of further investigations.

## 2 Factorized system and its qualitative analysis

### 2.1 Statem ent of the problem

W e are going to analyze the set of TW solutions to (1), described by the follow ing formula:

Inserting ansatz (4) into the GBE one can obtain, after som e manipulation, the follow ing dynam ical system :

where $(U)=U{ }^{n}$. We are going to form ulate the conditions contributing to solitonlike and com pacton-like solutions to equation (1) by analyzing the factorized system (5). Let us note that in the case of both $K d V$ and $K(m ; n)$ hierarchies' $m$ em bers the procedure of factorization lead to the H am iltonian dynam ical system s for which distinguishing the presence ofhom oclinic loops ism ore or less trivial [11]. The situation w ith system (5) is not so simple since it is not $H$ am iltonian. A nd we cannot expect that the hom oclinic loops will form a one-param etric fam ily as this is the case w th the H am iltonian system s. C ontrary, the hom oclinic loop in our case can appear as a result of one or several successive bifurcations taking place at speci c values of the param eters. Let us stress that existence of the hom oclinic loop corresponding to com pacton is possible due to the presence of the factor (U) at the LHS of system (5). Since the function (U) contains the origin, which is the stationary point of system (5), then the naturalw ay of proceedings is follow ing. W e state the condition that guarantee the appearance of the stable lim it cycle in proxim ity of the stationary point ( $\mathrm{U}_{1} ; 0$ ), and ensure that sim ultaneously the stationary point $(0 ; 0)$ is a saddle and rem ain so as the param eter ofbifurcation is changed. By proper change of the bifurcation param eterwe can cause the grow th of size of the lim it cycle and in presence ofnear-by saddle it nally could give way to the hom oclinic bifurcation. Since the latter bifurcation is nonlocal, we cannot trace its appearance using the $m$ ethods of local nonlinear analysis, as this is the case w ith A ndronov $H$ opfbifurcation. Therefore on the nal step we are forced to resort to num erical sim ulations. A nd of course answ er the question on whether the hom oclinic loop corresponds to com pacton-like solution or not needs special treatm ent based upon the asym ptotic analysis. This and other issues are analyzed in the follow ing subsections.

### 2.2 A ndronov H opfbifurcation in system (5)

To form ulate the conditions which guarantee the stable lim it cycle appearance in vicinity of the stationary point ( $\mathrm{U}_{1} ; 0$ ), let us consider the Jacobim atrix

The rst condition im mediately gives us the critical value of the wave pack velocity $\mathrm{V}_{\mathrm{cr}}=\mathrm{U}_{1}: T$ he second one is equivalent to the statem ent that ${ }^{\prime}\left(\mathrm{U}_{1}\right)$ is positive.

The next thing we are going to do is a study of the stability of lim it cycle appearing. A $s$ is well known [14, [15], this is the real part of the rst Floquet index $<\mathrm{C}_{1}$ that determ ines whether the cycle is stable or not.

For $\left(\mathrm{U}_{1}\right)=\mathrm{U}_{1}^{\mathrm{n}}>0$ condition $<\mathrm{C}_{1}<0$ assures that the lim it cycle, appearing in system when V < $\mathrm{V}_{\text {cr }}$, w ill be stable.

To obtain the expression for $<\mathrm{C}_{1}$, the standard form ula contained e.g. in [15] could be applied providing that system in vicinity of the center is presented in the form

### 2.3 Study of the stationary point ( 0 ; 0)

From now on we shall investigate system with $(U)=U^{m}$ :

O ur next step is to state the conditions assuring that the stationary point ( $0 ; 0$ ) is a topological saddle or at least contains a saddle sector in the right halfplane. The standard theory [16] can be applied for this purpose. O ur system can be written dow n in the form

U sing the classi cation given in [16] we are now able to form ulate the follow ing result.

## Theorem 2.

1. If $m+n$ is an odd natural num ber then the origin of system (17) is a topological saddle having a pair of separatrices tangent to the vertical axis and the other pair tangent to the horizontalaxis when $\mathrm{m}>1$ and to the line $\mathrm{W}=\frac{\mathrm{U}_{1}}{\mathrm{~V}} \mathrm{U}$ when $\mathrm{m}=1$. For even $m+n$ the stationary point is a saddle-node with tw o saddle sectors lying in the right half-plane. Two of its three separatrices are tangent to the vertical axis while the rem aining one is tangent to the horizontalaxis in case when $m>1$ and and to the line $W=\frac{U_{1}}{V} U$ when $m=1$. The nodal sector lying in the left half-plane is unstable.
2. If $n$ is an odd num ber then the origin of system corresponding to (18) is a topological saddle identical w ith that of the previous case. For even $n$ the stationary point is a saddle-node identical w ith that of the previous case
3. For any n 1 the origin of system (20) is a saddle-node geom etrically identical with that from the previous two cases.

The crucial fact appearing from this analysis is that the stationary points ( $0 ; 0$ ) of the canonical system s (17) \{ (20) depending on the values of the param eters $m$; $n$ are either saddles or saddle-nodes $w$ th the saddle sectors placed at the right halfspace. The retum to the original coordinates does not cause the change the position of the saddle sectors but changes the orientation of vector elds and the angle at which the outgoing separatrice leaves the stationary point. T he local phase portraits corresponding to three distinct cases are show n on gure 1 reconstructed on the basis if the analysis of relation betw een (17) \{ (20) and system (15).

Before we start to discuss the results of num erical study of system (15), let us consider the question on when the presum ably appearing hom oclinic loop corresponds to the com pacton-like solution to the source equation (1). To answ er this question we are going to nd the solution $W(U)=1 U^{1}+{ }_{2} U^{2}+::$ of equation

H om oclinic loop will correspond to com actly-supported solution if K is nite or in nite and also if it tends to zero not quidker than $U$; where $1=2 \ll 1$ :

The procedure of solving (23) is pure algebraic: we collect the coe cient of di erent powers of $U$ end equalize them to zero. The lowest power in the RHS is either $U{ }^{1}$ or $U^{1}$ or $U^{n+2} 1^{1}$. The num ber $n+2 \quad 1 \quad 1$ cannot be less or equal to $1_{1}$ because it involves the inequality $0<1 \quad 1 \quad n$ which is im possible for any natural $n$. On the other hand if $n+21 \quad 1 \quad m$ then 1 becom es an "orphan" and 1 should be nulli ed.

So $U^{n+2} 1^{1}$ cannot be the low est $m$ onom ial. From this im $m$ ediately appears that the only choice leading to the nontrivialsolution is $1=m . N$ ext im portant observation is such that the rst nonzero m onom ial at the RHS should have as a counterpart at the LH S the least $m$ onom ial, that is $U^{n+2} 11 \quad U^{n+2 m} \quad 1$. This in tum is su cient to estim ate the lim it (22). In fact,

A nd now we are ready to form ulate the $m$ ain result of this subsection.
Proposition 1 H om oclinic loop bi-asym ptotic to stationary point $(0 ; 0)$ of system (15) corresponds to com pacton-like solution to the initialPDE ifm $\frac{1}{2}$.
$P$ resented above result delivers su cient but not necessary condition for the hom oclinic loop corresponding to com pacton. Basing on the local asym ptotic analysis it is possible to show that for $0<m<1$ and any natural $n$ trajectory bi-asym ptotic to stationary point $(0 ; 0)$ w ill also correspond to com pactly \{supported traveling wave. The proof is som ew hat cum bersom e and we shall not present it here.

W e would like to know, what sort of TW corresponds to the hom oclinic loop in case when $\mathrm{m} \quad 1$ and $\mathrm{n} \quad$ 1. Presently we are not able to answer this question rigorously. N evertheless, we bring som e argum ents evidencing that the "tail" of TW in this case spreads up to 1 whereas the front sharply ends. This is so because the "tail" corresponds to the outgoing separatrix which is tangent to either horizontal axis (if $m>1$ ) or the line $W=\frac{U_{1}}{V} U$ (if $m=1$ ). On the other hand, the incom ing separatrix enters the origin at the angle $\frac{2}{3}$. From these observations conclusions can be $m$ ade conceming the shape of TW. C orresponding argum ents $w$ ill be delivered for the case $m=n=1$.

A nalysis of form ula (18) enables to state that outgoing separatrix is tangent to the straight line $W=\frac{U_{1}}{V} U$. So the rst coordinate of the saddle separatrix in vicinity of the origin satis es the equation

having the approxim ated solution $U()=A \exp \left(\frac{U_{1}}{V}\right)$. This form of approxim ate solution tells us that separatrix reaches the origin as ! 1 .

N ow let us consider the incom ing separatrix, which is tangent to the vertical axis and lies at the fourth quadrant. This enables us to assum e that $W=B U+\circ$ (U ), where $0 \ll 1$ and $B>0$. Approxim ate equation describing the rst coordinate of incom ing separatrix is then as follow $s$

A nalysis of this form ula show s that tra jectory reaches reaches the origin in nite "tim e".

## 3 R esults of num erical sim u lation

$N$ um erical sim ulation of system (15)) were carried out for di erent values of the param eters. Let us consider rst the results of sim ulation obtained for $=n=1 ; \mathrm{U}_{1}=3$ and $m=\frac{1}{2}$. Experim ents show that at $V$ slightly less then $V_{c r}=U_{1}$ a stable lim it cycle is softly created in system (15).

Its radius grow sas $V$ decreases. A s the left end of the periodic tra jectory approaches the origin, it becom es asym m etric ( g. 2) . At V 2:5397975 periodic trajectory destroys giving way to the hom oclinic bifurcation (g.3). C orresponding com pactonlike solution to the equation (1) is shown on g. 4. C om pacton, moving from left to right, is gently sloping tow ards the tail. It is worth noting that the com pacton-like solution is alw ays sym $m$ etric in case it is solution to H am iltonian system .

A nother num erical sim ulations were put up for $=1 ; m=1 ; n=1 ; U_{1}=3$ : Scenario is the same as in the previous case. Lim it cycle appearing at $\mathrm{V}<\mathrm{U}_{1}$ grow s as V decreases ( g . 5 ). Periodic trajectory is destroyed at $\mathrm{V}=2: 48225$, giving way to hom oclinic trajectory ( g .(6). C orresponding TW solution to source equation (1) is shown on g.7.

Let us nally show pattems corresponding to stronger nonlinearity of the source term. W e take $m=3$ and the rem aining param eter the sam e as in the previous case. Such a change leads to larger asym $m$ etry of the hom oclinic contour, g. 809 and appearance of w ave pattem w ith sharp front and very long relaxing tail, rem inding shock or detonation wave, g. 10 .

## 4 Final rem arks

So we have show n that, depending on the values of the param eters convection-reactiondi usion m odel described by equation (1) possesses com pacton-like TW solutions or m ixed solutions having the soliton-like tails and sharp fronts. The m ere existence of com pacton-like solutions is possible ifthe di usion coe cient is a function ofdependent variable $u$. In all cases considered wave pattems have been obtained as the result of two bifurcation. First we perform ed the local nonlinear analysis of dynam ical system (5) describing the whole set of TW solution and stated conditions making possible the stable lim it cycle creation in proxim ty ofcriticalpoint ( $\mathrm{U}_{1} ; 0$ ). T he other criticalpoint, placed at the origin, is shown to possess sim ultaneously a saddle sector in the right half-plane, $m$ aking possible the hom oclinic loop appearance. N ext we studied num erically the evolutions of periodic solutions, observing how they undergo the hom oclinic bifurcation. A nalytical results obtained in subsection 2.3 enable us to state w hen the hom oclinic loop obtained in num erical experim ents correspond to com pacton.

The results obtained here are not com pletely rigorous. In particular it is rather unknown the precise value of wave pack velocity $V$ corresponding to the hom oclinic bifurcation.

To obtain the solutions in question analytical $m$ ethods based on the generalized sym $m$ etries [17] and related to them anasatz-based methods [18, 19, 20, 21] can be applied. Yet it is little chances to obtain them for allpossible values of the param eters for the source equation is not com pletely integrable. So it would be desired to apply som e other m eans, such as the rigorous com puter-assisted proofs for this problem .

In connection $w$ ith the results obtained a natural question arises about the bene $t$ of solutions existing $m$ erely at selected values of the param eters. So rst let us mention that the velocity of wave pack, being chosen as the bifurcation param eter, is an "extemal" in som e sense param eter and its value is rather connected w th the portion of "energy" delivered at the initialm om ent of tim e, which is easily controlled, while the param eters characterizing system rem ain unchanged.

O fprim e im portance is also the well know $n$ fact that invariant wave pattems such as kinks, solitons, com pactons etc., very often play role of asym ptotics, attracting in the long range close near-by solutions [22, [23, [11]. Study of the stability and attracting properties of the invariant solutions to (1) is very non-trivial issue going far beyond the soope of this article.
