# Vertex operator for the ultradiscrete $K d V$ equation

A bstract. W e propose an ultradiscrete analogue of the vertex operator in the case of the ultradiscrete $\mathrm{K} d V$ equation, which m aps N -soliton solutions to $\mathrm{N}+1$-soliton ones.

The ultradiscrete $K d V$ equation (udK dVeq)

was rst proposed in [6] to describe the dynam ics of the Box and Ball System (BBS) [5], which is a cellular autom aton w ith soliton-like behaviour. It has a rich structure, including the existence of N -soliton solutions and an in nite am ount of conserved quantities [3] like m ost ordinary soliton equations.

A procedure to obtain a new solution of a soliton equation from a given one, is known under the nam e of Backlund transform ation (BT) and is generally expressed in the form of the di erentialequations. The ultradiscrete analogue of the $B T$ for the $K d V$ equation in the case of the udK dVeq is presented in [2].

The vertex operator is an operator representation of a BT and was rst presented in [1] to describe the structure of the solutions and the sym $m$ etries of soliton system s . It maps N -soliton solutions to $\mathrm{N}+1$-soliton ones and all soliton solutions can in fact be generated by repeated application for the vertex operator.

In this letter, we propose an ultradiscrete analogue of vertex operator in the case of the ultradiscrete $K d V$ equation and prove that the functions generated by this operator indeed solve the udK dVeq.

First, we de ne the vertex operator and consider the functions generated by this operator.

De nition 1 The multi-variable function $F$ and the vertex operator $X$ are de ned as follows:
(i) The null variable function $F(;)$ is de ned as:

(ii) The vertex operator X depends one real param eter $1 \quad 0$ and a function $1_{1}(1)$ of ${ }_{1}$, and $m$ aps the null variable function $F(;)$ to

A ccordingly, the one variable function $F\left(1 ;{ }_{1}\right)$ is de ned as:

(iii) For general $N$ 1, the vertex operator $X \quad m a p s$ an $N$ variable function F ( 1 ;:::; ${ }_{\mathrm{N}} ;{ }_{1} ;::: ;_{\mathrm{N}}$ ) (written as $\mathrm{F}(;)$ for brevity) to the $\mathrm{N}+1$ variable function as:
where

The param eters and the functions in the vertex operator $X$ are in fact the am plitudes and phase param eter of the new soliton, inserted by the operator. The de nition (5) indicates that all pre-existing solitons described by $F$, have their phases shifted by inserting a new soliton.

H ere we present the basic properties of the operator X and the corresponding function $F$.

P roposition 1 The action of the vertex operators are com m utative.

From this relation it is clear that interchanging the subscripts a and b does not change its overall value.

Rew riting this proposition in the language of the function F , yields the follow ing corollary:

C orollary 2 The N variable functions F (; ) are invariant under the perm utation of their param eters, i.e.:
$N$ ext, let us prove that these fiunctions are indeed solutions of the $u d K$ dVeq, by $m$ eans of the recursive form (5). This property indicates that the vertex operator de ned in (5) is nothing but the operator, well known from soliton theory, which maps an N soliton solution to an $N+1$-soliton solution.

Theorem 3 The N variable function $F(;)$ solves the udK dVeq (1) for

Proof By virtue of corollary 2, we can $x$ the labels of the param eters

w ithout loss of generality. By virtue of this ordering, the phase shifts in de nition (5) sim plify to

It should be noted that the phase shifts
are equivalent to the time shifts $t$ ! $t$ 1.TheN variable function $F(;)$ is then reduced to $\left.F_{j}{ }^{N}\right)$,t written as

W e shall prove the theorem inductively. It is clear that $\mathrm{F}_{\mathrm{j}}{ }^{(0), t}$ solves the equation (1) because of the positivity of $R$. N ow, let us assume that the theorem holds for $\mathrm{N} \quad 1$. By substituting (13)) in the udK dVeq (1), the left hand side can be rew ritten as

In this expression it looks as if the $m$ axim um in (15) has four argum ents. H ow ever, the third argum ent cannot be the $m$ axim um because it is alw ays less than the fourth one by virtue of the follow ing lem $m$ a, in cases $l=1 ; m=2$.

Proof $P$ roof of (18) : the right hand side of the equation (18) can be expanded to yield $m a x(a+c ; a+d ; b+c ; b+d), w h i c h$ includes all candidates of the left hand side. Proof of (19) : put $a=z ; b=w ; c=x \quad z ; d=y \quad w$ in (18) respectively.

If we now apply

By taking into account the relation $N_{N} \quad{ }_{N} \quad 1$, it can be shown inductively that the four argum ents in this $m$ axim um are all less than $2\left(\mathbb{K}_{N}+m \quad{ }_{N}\right)$.

By $m$ eans of the sam e procedure, the right hand side of equation (1) is rew ritten as

$T$ here are three argum ents in the principalm axim um. The rst and second argum ents are the same as those on the left hand side because $F_{j}{ }^{(N)}$ 1), solves the equation (1) by the assum ption. It can also be shown that the last argum ent is also the sam e by em ploying the m ethod which was used to prove lem m a 4.

The condition which expresses the equality of the last argum ent to that of the left hand side then reduces:

it can be shown inductively that all argum ents are less than $2\left({ }_{N} K_{N}\right)$.
The positivity of $\tilde{H}_{j}^{(N)}$ )t is proven by a sim ilar evaluation by means of corollary 6.
$F$ inally, we give an explicit exam ple of the action of the vertex operator $X$, in case of the B ox and BallSystem. TheBBS corresponds to the udK dVeq (1) by m eans of the dependent variable transform ation

TheBBS is required to satisfy the follow ing boundary conditions: for su ciently large j, $B_{j}^{t}=0$. U nder these conditions, it can be shown that the possible values of the variable $B_{j}^{t}$ that correspond to the $N$-soliton solutions of theorem 3 (ie. constructed by $m$ eans of the vertex operator X ) are restricted to the set $f 0 ; 1 \mathrm{~g}$.

In the follow ing gures we depict the j-lattice by a row of boxes, containing a ball when $B_{j}^{t}$ is equal to 1 , and empty whenever $B_{j}^{t}=0$. The lattices depicted in $F$ igure. 1 are the vacuum lattioe, and the lattioes that obtained from vacuum by the successive application of the vertex operator $X$ with param eter values $\left(1 ; C_{1}\right)=(1 ; 0)$, $\left(2 ; C_{2}\right)=(3 ; 2)$, and $\left(3 ; C_{3}\right)=(2 ; 0)$.

In this letter we proposed an ultradiscrete analogue of the vertex operator for the ultradiscrete $K d V$ equation and discussed its properties. W e presented a recursive representation of the N -soliton solution generated by this operator and proved that it indeed solves the udK dVeq.

In [4], a dierent technique for describing the $u d K d V \mathrm{~N}$-soliton solutions was introduced, relying on signature-free C asorati-type determ inants or perm anents. A though these perm anents describe the sam e solutions (already proposed in [6]) as those constructed by recursive application of the ultradiscrete vertex operator, we would like to stress that the tw o aproaches are quite di erent. In fact, the vertex operator approach is closely related to the existence of œertain sym $m$ etry algebras for integrable system $s$ and the exact relation of our ultradiscrete operator to the sym $m$ etries of ultradiscrete system $s$ is an especially interesting problem we want to address in the future. It would also be interesting to nd vertex operators for other ultradiscrete soliton equations, as for exam ple the ultradiscrete analogue of the K P equation.
