## A b stract

$T$ he $D$ arboux $\{D$ ressing $T$ ransform ations developed in [1] are here applied to construct soliton solutions for a class of boom eronic\{type equations. The vacuum (i.e. vanishing) solution and the generic plane wave solution are both dressed to yield one soliton solutions. The form ulae are specialised to the particularly interesting case of the resonant interaction of three waves, a well-known m odelwhich is of boom eronic $\{$ type. For this equation a novel solution which describes three locked dark pulses (sim ulton) is introduced.

## 1 Introduction

$M$ any phenom ena of wave propagation in one dim ensionalm edia in various physical contexts are m odelled by system s of Partial D i erential Equations (PDEs). Am ong them, integrable $m$ odels are of special interest and are the focus of our investigation. In fact the present article follow s our w ork [1] to which we refer the reader for the generalbackground and $m$ otivations. O ur interest in this sub ject is particularly $m$ otivated by the introduction and investigation of boom eron solutions in $m$ odels of interest in nonlinear optics. These solutions are soliton solutions whose behavior di ers from that of standard solitons (such as for the $\mathrm{K} d V$ and NLS equations). In fact they have di erent asym ptotic velocities at $t=+1$ and $t=1$. They were rst introduced long tim e ago in [2] (see also [3]) in connection with the hierarchy of the $m$ atrix $K$ ortew $e g\{d e V$ ries equation, and $m$ ore recently boom erons appeared again in geom etry [4] and optics [5], [6], [7], [8], [9]. T he special properties ofboom erons stem from the fact that they are solutions ofm ulticom ponent eld equationswhose integrability requires a $m$ atrix form ulation of the corresponding Lax pair (see below) together w ith a richer (non com m utative) algebraic structure. T he characteristic property of this structure is that the ow $s$ of the attached hierarchy may not com $m$ ute $w$ th each others (see [10] and [11]). T he technique of constructing soliton solutions we adopt here goes via the $D$ arboux $\{D$ ressing $T$ ransform ations (D D T) which yield a new (dressed) solution from a given (naked or seed) solution of the system of wave equations of interest. $T$ his $m$ ethod $m$ ay be form ulated as a change of the Lax pair of linear equations via a transform ation which adds one pole to the dependence of its solution on the com plex spectral variable. T hough the form al setting of this construction is well known ([12] \{[15]), the actual construction is detailed in [1] w here the explicit algorithm ic procedure is given. In particular, there we show that the position of the pole, whether it lies o or on the realaxis, leads to di erent expressions of the dressed solution. In its tum, as we show here, this di erence plays a crucial role in accounting for di erent boundary values of the w ave elds, nam ely boundary values w hidh are appropriate to bright solitons (localised pulses w ith exponential decay) or dark solitons (localised pulses in a non vanishing background).
To the aim of $m$ aking this article as much self\{contained as possible, in this rst section we set up the general form alism of $m$ atrix evolution equations we have introduced in [1] by keeping the sam e notation as introduced there. In Section 2 the DD T construction, which is discussed in details in [1], is tersely reported. Section 3 is devoted to the soliton expressions of both bright and dark type in the generalm atrix form. H ow ever, as for the investigation of these expressions, we prefer to focus on one particular reduction. Th is and other reductions lead to $m$ odels which seem to deserve special attention because of their potential applicability. T hus Section 4 is devoted to novel sim ulton solutions of the well know system which describes the interaction of three waves in quadratic $m$ edia $w$ th the resonant condition ! ${ }_{2} \quad!_{1}=!3$ and $k_{2} \quad k_{1}=k_{3}$ on their frequencies and $w$ ave num bers, respectively. The last Section 5 contains few rem arks and conclusions.
$T$ he starting point of our investigation is the follow ing Lax pair of $m$ atrix $O$ rdinary $D$ ifferential Equations (ODEs) :

where,$X$ and $T$ are $N \quad N$ square $m$ atrices, $=(x ; t ; k)$ being a com $m$ on solution of the two linearODEs (1), while $X=X(x ; t ; k)$ and $T=T(x ; t ; k)$ depend on the coordinate
$x$, the tim e $t$ and the com plex spectral param eter $k$ according to the de nitions

where $[A ; B]$ stands for the com m utator A B B A. W e notioe that, in order to sem plify our analysis, we have chosen the $X$ and $T \mathrm{~m}$ atrices to be rst degree in the spectral variable $k$. This choice has tw o consequences, nam ely it lets the tw $O$ independent variables $x$ and $t$ play a sim ilar role so that their interpretation as space and tim e can change according to the physical application, and, secondly, it leads to w ave equations w hich are dispersion less when linearized around the vanishing solution. D ispersion term s can be easily introduced w ith only technicalchanges of them ethod (see [1] w here the dispersive term ofSchrodinger type has been considered). In the equations (1) is the diagonal constant $m$ atrix

where $C^{(+)}$, respectively $C(1)$, are $N^{(+)} N^{(+)}$; respectively $N^{()} N^{()}$; constant square $m$ atriges, $w$ ith $N=N^{(+)}+N^{()}, N^{(+)}$and $N^{()}$being arbitrary positive integers. The potentials $Q=Q(x ; t)$ and $W=W(x ; t)$ are the $o$-diagonal and, respectively, diagonal block $m$ atriges (a superim posed dagger stands for H erm itian con jugation)
where the block $U=U(x ; t)$ is a rectangular $N() N^{(+)}$m atrix while the twoblocksW () are square $N^{(1)} N^{(1)}$ matrioes. M oreover $S^{(+)}$and $S^{(1)}$ are, respectively, $N^{(+)} N^{(+)}$ and $N^{(~) ~} N^{(1)}$ diagonalm atrices whose diagonalelem ents $S_{n}^{()}$, w ith no loss of generality, are just signs, nam ely

$T$ he reduced form (5) of the $m$ atrix $Q(x ; t)$ is $w$ ell $m$ otivated by the fact that it captures several interesting $m$ odels ofm ultioom ponent w ave interactions in w eakly nonlinearm edia, see [10], [11] and Sections 4 and 5.

## 2 The D D T algorithm

T hem ethod of construction of explicit solutions of the Lax equations (1), and therefore of the nonlinear evolution equations (7), $m$ ay be form ulated in $m$ ore than one way [12]\{ [15]. $H$ ere we sketch the schem e we developed in [1] w here full details are given.
Let $Q^{(0)}(x ; t)$ and $W^{(0)}(x ; t)$ be a pair of $m$ atriges $w$ ith the sam e block structure (5) of $Q(x ; t)$ and $W(x ; t)$. This assum ption de nes therefore also the block $m$ atrioes $U{ }^{(0)}(x ; t)$ and $W^{(0)()}(x ; t)$. Let then ${ }^{(0)}(x ; t ; k)$ be a corresponding nonsingular (ie. $w$ th nonvanishing determ inant) $m$ atrix solution of

where $X^{(0)}(x ; t ; k)$ and $T^{(0)}(x ; t ; k)$ have the expressions (2al) and (2b) whit $Q$ and $W$ replaced by $Q^{(0)}$ and $W^{(0)}$. Since both com patibility conditions, ${ }^{(0)}={ }^{(0)}{ }^{(0)}$ and $x t=t x$ are satis ed, $U^{(0)}(x ; t) ; W^{(0)()}(x ; t)$ and $U(x ; t) ; W()(x ; t)$ are just two di erent solutions of the sam e matrix evolution equations (7). C onsider now the matrix $D=$ (0) $^{1}$ or, equivalently, the relation

which can be view ed as a transform ation (0)!. TheD D T m ethod consists in searching for the dressing $m$ atrix $D(x ; t ; k)$ for a given ${ }^{(0)}$. The expression ofthem atrix $D(x ; t ; k)$ is found by assigning a priori its explicit dependence on the spectralparam eter $k$. $W$ e assum e that this transform ation is near identity and adds one simple pole to the $k$ dependence of the solution ${ }^{(0)}(x ; t ; k)$, nam ely

where $R(x ; t)$ is the residue $m$ atrix and the param eter is the pole position in the com plex plane of the spectral variable $k$. In [1] w e derive the expression of the residuem atrix $R$ ( $x$; $t$ ) and we show that this expression crucially depends on the position of the pole $k=\quad$, the distinction being betw een the case in which the pole is o the realaxis, 6 , and the case in which the pole is on the real axis, $=$. In the next section we show that this distinction is relevant when constructing soliton solutions w ith vanishing or non vanishing asym ptotic values of $U(x ; t)$ as $j x j!1$. Here we m erely report the follow ing expression of the new solution $U(x ; t), W()(x ; t)$ in these two cases:

$\left.S^{( }\right)$is the sign $m$ atrix (6), $C$ ( ) is the $N^{(1)} N^{()}$constant $m$ atrix as de ned in (4) w th the condition (8) and the $\mathrm{N}^{(1)}$ \{dim ensional vector $\left.\mathrm{z}^{( }\right)$is de ned below, see (18). $T$ he di erence betw een the two cases is $m$ ainly in the expression of the real denom inator function $E(x ; t)=E \quad(x ; t)$. Thuswhen the pole is complex w ith non vanishing im aginary part (i.e. \& ), the denom inator becom es [1]

A s for the expression (15), we observe that, because of the conservation law $g_{t}=2 \mathrm{~m}_{\mathrm{x}}$, the di erential form $g d x+2 m d t$ is exact and therefore the denom inator expression (15) can be com puted as the integral
along any curve in the $(x ; t)$ plane.
W e end this section noticing that these explicit form ulas are $m$ eant to serve as the $m$ ain tools to construct soliton \{ and, by repeated application of D D T s, m ultisoliton \{solutions of those system $s$ of $m$ ulticom ponent wave equations which can be obtained by reduction of the generalm atrix PDEs 77. H ow ever, they have been obtained by algebra and local integration of di erential equations by leaving out two im portant ingredients of solutions of applicative interest, nam ely their boundary values and their boundedness. T hese two issues w illbe addressed in the next sections w here explicit expressions of solutions w ill be displayed.

## 3 Soliton solutions

W e construct now explicit solutions of the generalm atrix equation 7) by m eans of D T's. $T$ he general expressions we derive here $w$ ill be investigated in $m$ ore details in particular cases in the next section. In the present analysis, the $m$ atrix \{valued function $U(x ; t)$, which appears in the spectral equation $x=X \quad, w$ ith (2a) and (5), is restricted to be in one of two di erent functional classes. The rst one is the class $B$ of those (bounded) functions $U(x ; t)$ which vanish su ciently fast, for any $t$, as $\bar{x} j$ ! 1 :

B right solitons are in this class. W e point out here that, if $U(x ; t)$ is in $B$, the $m$ atrices $W^{()}(x ; t)$ which satisfy the equations (7b) and (7d) are necessarily $x\{$ independent (possibly t\{dependent) when jxj! 1 . In particular we choose

F ( ) being tw o arbitrary constant matrioes. W e lim it our construction to the one soliton solution which obtains by choosing in the D D T algorithm the seed solution as the trivial solution $U^{(0)}(x ; t)=0 ; W^{(0)()}(x ; t)=F^{()}$.
$T$ he second class, $D$, is the class of those (bounded) functions $U$ ( $x ; t$ ) which do not vanish as $\mathfrak{j} j!1$, as they asym ptotically behave like plane waves:

$w$ here the functions $U_{+P W}(x ; t)$ and $U_{P W}(x ; t)$ are two generally di erent plane wave solution of (7). IfU ( $x ; t$ ) is in this class, also the tw o m atrices $W$ ( ) ( $x ; t$ ) which satisfy the equations (7b) and (7d) behave as plane waves, as show n below. T he explicit expression of plane wave solutions is reported below, but its com putation requires som e tedious algebra which is not reported here. In fact, it tums out that the plane wave solutions can be solutions only of tw o special cases of the general evolution equations (7). The rst (second) case obtains by requiring that the constant $m$ atrix $C^{(+)}\left(C^{()}\right)$is proportional to the identity $m$ atrix $W$ ith the consequence that the $m$ atrix $\left.W^{(+)}(x ; t)(W)(x ; t)\right)$ is constant, see (7b) (see (7d)). H ow ever in this case both $C^{(+)}$and $W^{(+)}(x ; t)(C)^{()}$and $\left.\left.W^{( }\right)(x ; t)\right)$ can be easily transform ed aw ay so that setting $C^{(+)}=W^{(+)}=0$ reduces the system (7) to the two coupled equations

In its tum, the DDT introduces additionalparam eters in the new solution, one being the pole in the com plex $k$ \{plane, while other param eters com e from the residue $m$ atrix. In this respect, a w ord of waming is appropriate. A generic choioe of these param eters does not necessarily yield a solution $U(x ; t), W()(x ; t)$ which is acceptable in the sense that i) it is bounded (i.e. it is singularity \{ free in the whole ( $x$; t) plane) and ii) it is localized (i.e. it belongs to the sam e class, either B or $D$, of $\left.U^{(0)}(x ; t)\right)$. M eeting these acceptability requirem ents is a property of the new solution $U(x ; t), W()(x ; t)$ that has to be checked, depending on all param eters which enter in the construction, including the sign $m$ atriges $S^{(+)}$and $\left.S^{( }\right)$. $T$ his analysis is quite simple in the scalar case, while in the matrix case, which we are presently dealing w ith, it requires som e e ort. H ere we lim it our attention to the case in which the seed solution $U^{(0)}(x ; t), W^{(0)()}(x ; t)$ is the simplest solution of the functional class to which $U^{(0)}(x ; t)$ belongs. A s a consequence, we obtain explicit expressions of the one\{soliton solution. Even so, the acceptability requirem ents m entioned above will be investigated only a posteriori and in particularly interesting cases (see section 4) .

A s for the pole introduced by the D D T, see (12), we point out that its position, whether on the real axis or o the real axis, depends on the boundary values of $U(x ; t)$ which characterize the fiunctionalclasses B and D. Indeed, in the construction ofsoliton solutions the pole has a spectralmeaning since it belongs to the discrete spectrum of the Lax operator $L(U)=i \varrho_{x}+i Q$, see the spectral equation (1) with (2a). In general, if $U(x ; t)$ belongs to the class B , then the discrete spectrum of the operator $L(U)$ cannot be on the real axis and only $D$ arboux $m$ atrioes $D$ with $\& \quad m$ ay give rise to physically $m$ eaningfiul solutions. On the other hand, if $U(x ; t)$ belongs instead to the class $D$, then the correspending operator $L(U) m$ ay have gaps of the continuum spectrum on the real axis. In this case, the D arboux transform ation, w ith $=$ lying in one of these gaps, yields $m$ eaningfiul solutions. T he com putation in this last case, which is precisely the one of dark solitons, is $m$ ade di cult by the gap structure of the spectrum which gets more and $m$ ore com plicate the higher the two integers $N^{(+)}$and $N^{()}$are.

### 3.1 B right solitons

This special solution has been introduced in [10] for the system (7) w ith an additional dispersive term of Schrodinger\{ type. There it has been shown that these solutions exhibit a rich phenom enology as a consequence of the intenplay of the $m$ atrioes $C$ ( ) and $\mathrm{F}^{(1)}$. These solition solutions may well feature processes such as decay, excitation, pair creation and annihilation, and they are know $n$, according to theirbehavior, as boom erons, trappons, sim ultons (see also section 4 for additional references).

### 3.2 D ark solitons

W e now tum our attention to the one soliton solution which asym ptotically behaves as a plane wave and is therefore in the class D. We lim it the present construction of this solution to the evolution equations [24), nam ely to the special case $C^{(+)}=W^{(+)}=0$. For this reason, and to sim plify the notation, in this subsection we drop the superscript ( ) wherever reasonable, nam ely we set C () $C ; C_{j}^{(1)} \quad C_{j} ; K() \quad K ; k_{j}^{()} k_{j} ;()$

By decreasing the value of $k$ tw o real eigenvalues $m$ ay collide $w$ ith each other and create a pair of com plex conjugate eigenvahues. T hese collisions of eigenvalues give rise to a complicate gap structure of the spectrum of the di erentialoperator $L(U)=i @_{x}+i Q$. $T$ herefore, for a given realvalue ofk, the generic vector solution of the Lax pair ofequations (1) is a supenposition of bounded oscillating solutions corresponding to real eigenvalues
(k) and (k), and of exponentially unbounded solutions corresponding to eigenvalues
(k) and (k) which are instead com plex. In order to construct a soliton solution in the class D, only a linear com bination of these last unbounded solutions can enter the D D T form ulae of section 2 .

## 4 The 3W R I m odel

The sim plest and yet celebrated system of partial di erential equations which serves as particular exam ple of the results presented in the previous sections is the one describing the resonant interaction of three waves in a m edium with quadratic nonlinearity. It should be pointed out that this system , being rst order, is covariant $w$ ith respect to arbitrary linear transform ations of the coordinate plane ( $x$; t) in itself. This implies that one can give it the form, and attach to the independent variables $x ; t$ the physical m eaning, which is appropriate to the particular application of interest. Therefore we discuss the system (88) w ith the understanding that all form ulae we display here can be easily translated into corresponding results for any other form of the 3W R I equations which is covariantly related to it.
Let us consider rst the one soliton solution in the class B. This solution is constructed

In the particular case in which the param eter $f$ vanishes, $f=0$, this solution has been rst introduced in [16] and fiully investigated in [17]\{ [20]. It describes the interaction of three bright-type pulses, and its experim entalobservation in optics hasbeen recently reported [21]. The case corresponding to $f(0$ has been discovered and investigated later in [1]] where the soliton behavior has been show $n$ to be ofboom eron ic type [22]. T hese soliton solutions describe the interaction of two bright pulses $u_{1}(x ; t)$ and $u_{2}(x ; t)$ and a third pulse, $w(x ; t)$, which is instead of dark type as it does not vanish when x ! 1 . C orresponding to various choices of the linear group velocities $c_{1} ; c_{2}$, this solution features a rich phenom enology which has been recently show n to be of applicative interest in optical processes in quadratically nonlinear $m$ edia [5] \{ [8]. The properties of this soliton solution do not need to be reported here since they have been detailed in the literature quoted above.
Let us tum our attention to the soliton solution in the class D. W e consider only those solutions which are obtained by applying the DDT technique with a real pole $=$, see (12), and this am ounts to dressing a plane wave solution. Thus we apply to the 3W R I system (88) the general form ulae displayed in subsection 32 as follow s . Indeed, since the three eigenvalues, nam ely the roots of $P$ ( ), are all real if the discrim inant is negative, $D$ IS $(k)<0$, while two of them are com plex conjugate if the discrim inant is positive, D IS $(\mathrm{k})>0$, the three eigenvalues are certainly all real for large enough $\mathrm{k} j$ because the coe cient of the highest power of D IS (k) is negative (see also P roposition $6)$. Therefore, if the four roots of D IS (k) are all com plex (i.e. w ith a non vanishing im aginary part) then there are no gaps in the spectrum. If instead only tw o roots are real, D IS $(k)=D I S\left(k_{+}\right)=0, k<k_{+}$, the spectrum has one gap $k \quad k \quad k_{+} w$ th these two roots $k$ being the endpoints of the gap interval. Finally, if all roots of $D$ IS ( $k$ ) are real, D IS $\left(\mathrm{k}^{(1)}\right)=\mathrm{D}$ IS $\left(\mathrm{k}_{+}^{(1)}\right)=\mathrm{D}$ IS $\left(\mathrm{k}^{(2)}\right)=\mathrm{D}$ IS $\left(\mathrm{k}_{+}^{(2)}\right)=0, \mathrm{k}^{(1)}<\mathrm{k}_{+}^{(1)}<\mathrm{k}^{(2)}<\mathrm{k}_{+}^{(2)}$, the spectrum has tw o gaps, $\mathrm{k}^{(1)} \mathrm{k} \quad \mathrm{k}_{+}^{(1)}$ and $\mathrm{k}^{(2)} \mathrm{k} \quad \mathrm{k}_{+}^{(2)}$ (see Fig . 1).

In order to proceed further $w$ th our construction of the soliton solution, we assum e the given data $k_{1}, k_{2}, A_{1}, A_{2}, s_{1}, s_{2}$ are such that the continuous spectrum has at least one gap $I_{g}$ and that the realpole of the DDT lies inside this gap, $2 I_{g}$.

W e specialize further the expressions (81) to the present case, nam ely

This solution is a dark sim ulton as it describes three pulses travelling on a non vanishing

Figure 2 show $s$ an example in which only one gap is present. If two gaps $I_{g}^{(1)}$ and $I_{g}^{(2)}$ exist, where $I_{g}^{(i)}$ is characterised by $\mathrm{k}^{(\mathrm{i})} \mathrm{k} \quad \mathrm{k}_{+}^{(\mathrm{i})}$; $i=1 ; 2$, the results are sim ilar, e.g. in the case of $s_{1}=s_{2}=1$ the velocity of the sim $u$ lton $V$ lies in an intervalwhen varies in the gaps; how ever the function V ( ) (together with its range of values) is di erent in the two gaps (see Figure 3).

Finally, it should be pointed out that this solution, as explicitly show $n$ by (103), describes the nonlinear interaction of three plane waves whose am plitudes asym ptotically, nam ely
at $t=1$, acquire a phase\{shift. The expression of these phase\{shifts is explicitly given by the general form ula (86) w hich now reads

A s an instance, the dependence of the phase\{shifts 1 and 2 on the param eter inside the gap, $\mathrm{k} \quad<\quad<\mathrm{k}_{+}$, is plotted in Figure 4.

Sim ilarly, if there exist tw o gaps $I_{g}^{(1)}$ and $I_{g}^{(2)}$ we observe that the behaviour of the phases 1 and 2 as functions of is di erent in the two gaps. A $n$ exam ple of such dependence is displayed in $F$ igure 5.

## 5 C onclusions and rem arks

T he Zakharov \{Shabat spectral problem, which leads to an im portant class of integrable partial di erential equations, f.i. the $N$ onlinear Schrodinger, Sine\{G ordon and $m$ odi ed $K$ ortew eg \{de V ries equations, has been generalized to dealw ith m atrix and vector dependent variables long tim e ago. T his m atrix generalization has been recently revisited in [10] and [11] and further generalized in order to derive integrable matrix partial di erential equations $w$ ith $m$ atrix, rather than scalar, coe cients. This generalization generates new
 as boom eronic and are di erent from those of standard solitons. In a previous paper [1] we have adapted the standard D arboux dressing $m$ ethod to construct soliton solutions for a class ofboom eronic\{type equations. In this paper we have carried out this construction and obtained explicit expressions by dressing both the vacuum (i.e. vanishing) solution and the generic plane w ave solution. W e have specialized our form ulae to the particularly interesting case of the resonant interaction of three waves, a well-known modelwhich is of boom eronic\{type. For this equation we have constructed a novel solution which describes three locked dark pulses. The stability of this solution, $w$ ith respect to the sign of the coupling constants, is not investigated here and rem ains to be veri ed. O ther potentially applicable integrable $m$ odels are inchuded in the present schem e. O ne of them, the D ouble three $W$ ave Resonant Interaction (D 3W R I) equation, seem s particularly interesting in both uid dynam ics and nonlinear optics. In our present schem e, this system of ve partial di erential equations takes the form

W hile these equations are obviously integrable, they $m$ ay also follow , via them ultiscale (alias slow ly varying am plitude) approxim ation, from the resonant interaction of tw o triads of quasi\{plane $w$ aves ( $w$ th a com $m$ une m ode), whose wave num bers $\mathrm{k}_{1} ; \mathrm{k}_{2} ; q_{1} ; q_{2} ; \mathrm{k}_{3}$ and frequencies $!_{1} ;!_{2} ; 1 ; 2 ;!3$ satisfy the resonance condition

Regarding the 3W R I and the D 3W R Iequations, the follow ing rem ark is appropriate. Since they are rst order di erential equations any nonsingular linear coordinate transform ation of the ( $x$; $t$ ) plane in itself leaves these equations form ally covariant. A s a consequence, in di erent applications the coordinates $x$ and $t m$ ay be given di erent physicalm eaning. Since we have constructed special solutions, this m eaning is irrelevant in our present context. On the contrary, the $m$ eaning of these coordinates $x$ and $t$ becom es relevant if one addresses the initial value problem, since one has to single out the evolution variable. Indeed in our present dressing construction, the tw o linear equations of the Lax pair (1) have been treated on the same foot. Instead, the solution of the initial value problem requires that one of the two Lax equations plays the role of the spectral problem which provides the spectral Fourier\{type data, while the other linear equation entails the evolution of such data. In this respect we point out that the initial value problem associated to the
variable t as evolution variable (tim e in the usualphysicalm eaning) is still unsolved. This is due to the fact that them atrix $T(x ; t ; k)$, see (2b), depends asym ptotically, as $x!1$, on the unknown $m$ atrix $U$ through the asym ptotic values of the $m$ atriges $W$ ( ), see the system (7). Finding the solution of this open problem is left to future investigation.
