A bstract

The D arboux {D ressing Transform ations developed in [1] are here applied to construct soliton solutions for a class of boom eronic (type equations. The vacuum (i.e. vanishing) solution and the generic plane wave solution are both dressed to yield one soliton solutions. The form ulae are specialized to the particularly interesting case of the resonant interaction of three waves, a well-known m odel which is of boom eronic (type. For this equation a novel solution which describes three locked dark pulses (sim ulton) is introduced.

1 Introduction

M any phenom ena of wave propagation in one dimensional media in various physical contexts are modelled by systems of Partial Dierential Equations (PDEs). Among them, integrable models are of special interest and are the focus of our investigation. In fact the present article follows our work [1] to which we refer the reader for the general background and m otivations. Our interest in this subject is particularly m otivated by the introduction and investigation of boom eron solutions in models of interest in nonlinear optics. These solutions are soliton solutions whose behavior di ers from that of standard solitons (such as for the KdV and NLS equations). In fact they have di erent asymptotic velocities at t = +1 and t = 1. They were rst introduced long time ago in [2] (see also [3]) in connection with the hierarchy of the matrix Korteweg (de Vries equation, and more recently boom erons appeared again in geometry [4] and optics [5], [6], [7], [8], [9]. The special properties of boom erons stem from the fact that they are solutions of multicom ponent eld equations whose integrability requires a matrix form ulation of the corresponding Lax pair (see below) together with a richer (non commutative) algebraic structure. The characteristic property of this structure is that the ows of the attached hierarchy may not commute with each others (see [10] and [11]). The technique of constructing soliton solutions we adopt here goes via the Darboux (D ressing Transform ations (DDT) which yield a new (dressed) solution from a given (naked or seed) solution of the system of wave equations of interest. This method may be form ulated as a change of the Lax pair of linear equations via a transform ation which adds one pole to the dependence of its solution on the complex spectral variable. Though the form al setting of this construction is well known ([12] { [15]), the actual construction is detailed in [1] where the explicit algorithm ic procedure is given. In particular, there we show that the position of the pole, whether it lies o or on the realaxis, leads to di erent expressions of the dressed solution. In its turn, as we show here, this di erence plays a crucial role in accounting for di erent boundary values of the wave elds, namely boundary values which are appropriate to bright solitons (localised pulses with exponential decay) or dark solitons (localised pulses in a non vanishing background).

To the aim of making this article as much self{contained as possible, in this rst section we set up the general form alism of matrix evolution equations we have introduced in [1] by keeping the same notation as introduced there. In Section 2 the DDT construction, which is discussed in details in [1], is tersely reported. Section 3 is devoted to the soliton expressions of both bright and dark type in the general matrix form. However, as for the investigation of these expressions, we prefer to focus on one particular reduction. This and other reductions lead to models which seem to deserve special attention because of their potential applicability. Thus Section 4 is devoted to novel simulton solutions of the well know system which describes the interaction of three waves in quadratic media with the resonant condition $!_2 \quad !_1 = !_3$ and $k_2 \quad k_1 = k_3$ on their frequencies and wave numbers, respectively. The last Section 5 contains few remarks and conclusions.

The starting point of our investigation is the following Lax pair of matrix Ordinary Differential Equations (ODEs):

where , X and T are N N square matrices, = (x;t;k) being a common solution of the two linear ODEs (1), while X = X (x;t;k) and T = T (x;t;k) depend on the coordinate

x, the time t and the complex spectral parameter k according to the de nitions

where [A;B] stands for the commutator AB BA.W enotice that, in order to sem plify our analysis, we have chosen the X and T matrices to be rst degree in the spectral variable k. This choice has two consequences, namely it lets the two independent variables x and t play a similar role so that their interpretation as space and time can change according to the physical application, and, secondly, it leads to wave equations which are dispersionless when linearized around the vanishing solution. D ispersion terms can be easily introduced with only technical changes of the method (see [1] where the dispersive term of Schrodinger type has been considered). In the equations (1) is the diagonal constant matrix

The potentials Q = Q (x;t) and W = W (x;t) are the o -diagonal and, respectively, diagonal block matrices (a superim posed dagger stands for H erm itian conjugation)

where the block U = U (x;t) is a rectangular N $^{()}$ N $^{(+)}$ m atrix while the two blocks W $^{()}$ are square N $^{()}$ N $^{()}$ m atrices. M oreover S $^{(+)}$ and S $^{()}$ are, respectively, N $^{(+)}$ N $^{(+)}$ and N $^{()}$ N $^{()}$ diagonal matrices whose diagonal elements $s_n^{()}$, with no loss of generality, are just signs, namely

The reduced form (5) of the matrix Q(x;t) is well motivated by the fact that it captures several interesting models of multicomponent wave interactions in weakly nonlinear media, see [10], [11] and Sections 4 and 5.

2 The DDT algorithm

The m ethod of construction of explicit solutions of the Lax equations (1), and therefore of the nonlinear evolution equations (7), m ay be formulated in m ore than one way $[12]{[15]}$. Here we sketch the scheme we developed in [1] where full details are given.

Let Q ⁽⁰⁾ (x;t) and W ⁽⁰⁾ (x;t) be a pair of matrices with the same block structure (5) of Q (x;t) and W (x;t). This assumption de nest herefore also the block matrices U ⁽⁰⁾ (x;t) and W ⁽⁰⁾⁽⁾ (x;t). Let then ⁽⁰⁾ (x;t;k) be a corresponding nonsingular (i.e. with nonvanishing determinant) matrix solution of

where X ⁽⁰⁾ (x;t;k) and T ⁽⁰⁾ (x;t;k) have the expressions (2a) and (2b) whit Q and W replaced by Q ⁽⁰⁾ and W ⁽⁰⁾. Since both compatibility conditions, $_{xt}^{(0)} = _{tx}^{(0)}$ and $_{xt} = _{tx}$ are satis ed, U ⁽⁰⁾ (x;t);W ⁽⁰⁾⁽⁾ (x;t) and U (x;t);W ⁽⁾ (x;t) are just two di erent solutions of the same m atrix evolution equations (7). Consider now the matrix D = ^{(0) 1} or, equivalently, the relation

which can be viewed as a transform ation ${}^{(0)}$!. The DDT method consists in searching for the dressing matrix D (x;t;k) for a given ${}^{(0)}$. The expression of the matrix D (x;t;k) is found by assigning a priori its explicit dependence on the spectral parameter k. We assume that this transform ation is near identity and adds one simple pole to the k dependence of the solution ${}^{(0)}$ (x;t;k), namely

where R (x;t) is the residue matrix and the parameter is the pole position in the complex plane of the spectral variable k. In [1] we derive the expression of the residue matrix R (x;t) and we show that this expression crucially depends on the position of the pole k = , the distinction being between the case in which the pole is o the real axis, \Leftrightarrow , and the case in which the pole is on the real axis, \Leftrightarrow , and the case in which the pole is on the real axis, \Leftrightarrow , and the distinction is relevant when constructing soliton solutions with vanishing or non vanishing asymptotic values of U (x;t) as jxj! 1. Here we merely report the follow ing expression of the new solution U (x;t), W ⁽⁾(x;t) in these two cases:

 $S^{()}$ is the sign matrix (6), $C^{()}$ is the $N^{()} N^{()}$ constant matrix as defined in (4) with the condition (8) and the $N^{()}$ {dimensional vector $z^{()}$ is defined below, see (18). The difference between the two cases is mainly in the expression of the real denominator function E(x;t) = E(x;t). Thus when the pole is complex with non-vanishing imaginary part (i.e. \Leftrightarrow), the denominator becomes [1]

The bracket (a;b) in the previous form ulae stands for the (nonsymmetrical) scalar product of two vectors,

As for the expression (15), we observe that, because of the conservation law $g_t = 2m_x$, the di erential form gdx + 2m dt is exact and therefore the denom inator expression (15) can be computed as the integral

W e end this section noticing that these explicit form ulas are meant to serve as the main tools to construct soliton { and, by repeated application of DDTs, multisoliton { solutions of those systems of multicom ponent wave equations which can be obtained by reduction of the general matrix PDEs (7). However, they have been obtained by algebra and local integration of di erential equations by leaving out two important ingredients of solutions of applicative interest, namely their boundary values and their boundedness. These two issues will be addressed in the next sections where explicit expressions of solutions will be displayed.

3 Soliton solutions

We construct now explicit solutions of the general matrix equation (7) by means of DDT's. The general expressions we derive here will be investigated in more details in particular cases in the next section. In the present analysis, the matrix (valued function U (x;t), which appears in the spectral equation $_x = X$, with (2a) and (5), is restricted to be in one of two di erent functional classes. The rst one is the class B of those (bounded) functions U (x;t) which vanish su ciently fast, for any t, as jxj! 1:

Bright solitons are in this class. We point out here that, if U (x;t) is in B, the matrices W () (x;t) which satisfy the equations (7b) and (7c) are necessarily x{independent (possibly t{dependent) when ixj! 1. In particular we choose

 $F^{()}$ being two arbitrary constant matrices. We lim it our construction to the one soliton solution which obtains by choosing in the DDT algorithm the seed solution as the trivial solution U⁽⁰⁾(x;t) = 0;W⁽⁰⁾⁽⁾(x;t) = F⁽⁾.

The second class, D, is the class of those (bounded) functions U (x;t) which do not vanish as jxj! 1, as they asymptotically behave like plane waves:

where the functions U_{+PW} (x;t) and U_{-PW} (x;t) are two generally different plane wave solutions of (7). If U(x;t) is in this class, also the two matrices $W^{(-)}(x;t)$ which satisfy the equations (7b) and (7c) behave as plane waves, as shown below. The explicit expression of plane wave solutions is reported below, but its computation requires some tedious algebra which is not reported here. In fact, it turns out that the plane wave solutions can be solutions only of two special cases of the general evolution equations (7). The first (second) case obtains by requiring that the constant matrix $C^{(+)}$ ($C^{(-)}$) is proportional to the identity matrix with the consequence that the matrix $W^{(+)}(x;t)$ ($W^{(-)}(x;t)$) is constant, see (7b) (see (7c)). However in this case both $C^{(+)} = W^{(+)} = 0$ reduces the system (7) to the two coupled equations

We complete the denition of the class D of solutions for the special case (24) of the general equation (7) by adding the requirement that the asymptotic plane wave solutions U $_{PW}$ at x = 1 and U_{+PW} at x = +1, see the denition (23), have the same wave num bers $k_{j}^{(\)}$ and frequencies $!_{j}^{(\)}$ and may dier from each other only because they have dierent amplitudes A $^{(+)}$ and A $^{(\)}$. The main ingredients of the algebraic construction of solutions U (x;t), W () (x;t) are the seed solutions U $^{(0)}$ (x;t), W $^{(0)}$ (x;t) together with the corresponding solution $^{(0)}$ (x;t;k) of the Lax equations (10) to which the DDT applies (see (11)). In its turn, the DDT introduces additional parameters in the new solution, one being the pole in the complex k {plane, while other parameters come from the residue matrix. In this respect, a word of warning is appropriate. A generic choice of these parameters does not necessarily yield a solution U (x;t), W () (x;t) which is acceptable in the sense that i) it is bounded (i.e. it is singularity (free in the whole (x; t) plane) and ii) it is localized (i.e. it belongs to the same class, either B or D, of U $^{(0)}$ (x;t)). Meeting these acceptability requirements is a property of the new solution U (x;t), W () (x;t) that has to be checked, depending on all parameters which enter in the construction, including the sign matrices $S^{(+)}$ and $S^{(-)}$. This analysis is quite simple in the scalar case, while in the matrix case, which we are presently dealing with, it requires som e e ort. Here we lim it our attention to the case in which the seed solution $U^{(0)}(x;t), W^{(0)(-)}(x;t)$ is the simplest solution of the functional class to which $U^{(0)}(x;t)$ belongs. As a consequence, we obtain explicit expressions of the one (soliton solution. Even so, the acceptability requirements mentioned above will be investigated only a posteriori and in particularly interesting cases (see section 4).

As for the pole introduced by the DDT, see (12), we point out that its position, whether on the real axis or o the real axis, depends on the boundary values of U (x;t) which characterize the functional classes B and D. Indeed, in the construction of soliton solutions the pole has a spectral meaning since it belongs to the discrete spectrum of the Lax operator L (U) = i $@_x + i Q$, see the spectral equation (1) with (2a). In general, if U (x;t) belongs to the class B, then the discrete spectrum of the operator L (U) cannot be on the real axis and only D arboux matrices D with € may give rise to physically meaningful solutions. On the other hand, if U (x;t) belongs instead to the class D, then the corresponding operator L (U) may have gaps of the continuum spectrum on the real axis. In this case, the D arboux transform ation, with = lying in one of these gaps, yields meaningful solutions. The computation in this last case, which is precisely the one of dark solitons, is made di cult by the gap structure of the spectrum which gets more and more complicate the higher the two integers N ⁽⁺⁾ and N ⁽⁾ are.

3.1 Bright solitons

This special solution has been introduced in [10] for the system (7) with an additional dispersive term of Schrodinger{ type. There it has been shown that these solutions exhibit a rich phenom enology as a consequence of the interplay of the matrices C ⁽⁻⁾ and F ⁽⁻⁾. These soliton solutions may well feature processes such as decay, excitation, pair creation and annihilation, and they are known, according to their behavior, as boom erons, trappons, sim ultons (see also section 4 for additional references).

3.2 Dark solitons

We now turn our attention to the one soliton solution which asymptotically behaves as a plane wave and is therefore in the class D. We lim it the present construction of this solution to the evolution equations (24), namely to the special case C⁽⁺⁾ = W⁽⁺⁾ = 0. For this reason, and to simplify the notation, in this subsection we drop the superscript () wherever reasonable, namely we set C⁽⁾ C; $c_j^{()}$ c_j; K⁽⁾ K; $k_j^{()}$ k_j; ⁽⁾; ; $j^{()}$! j and B⁽⁾ B. Therefore, as displayed by our notation, the U and W parts of the solution are asymptotically plane waves of the expected form exp[i(K x t)]A ${}^{()}A^{(+)y}$ and, respectively, $ie^{i(K \times t)}B e^{i(K \times t)}B e^{i(K \times t)}$ as x ! 1 where the asymptotic constant vectors $A_{+}^{()}$ and $A^{()}$ and matrices B_{+} and B are related to each other by the unitary transformation (85), namely $A^{()} = A_{+}^{()}$, and, similarly, $B = B_{+}^{y}$, where y = 1. In the following section we apply the DDT one solution construction to the simplest case N $^{(+)} = 1$, N $^{()} = 2$, in both classes B and D. The choice N $^{(+)} = 1$, N $^{()} = 2$ leads to the three wave resonant interaction model.

4 The 3W RIm odel

The simplest and yet celebrated system of partial di erential equations which serves as particular example of the results presented in the previous sections is the one describing the resonant interaction of three waves in a medium with quadratic nonlinearity. In our notation of section 2 this system is obtained by choosing, for instance, N⁽⁺⁾ = 1; N⁽⁾ = 2; C⁽⁺⁾ = 0; C⁽⁾ = C = C = diagfc₁; c₂g; c₁ \in c₂; S⁽⁺⁾ = 1; S⁽⁾ = S = diagfs₁; s₂g, and by asking that the solution be of the form

In this case the general matrix PDEs (7) reduce to the following system of three coupled rst order equations (3W RI equations)

whose integrability was rst proved in [16]. It should be pointed out that this system, being rst order, is covariant with respect to arbitrary linear transform ations of the coordinate plane (x;t) in itself. This implies that one can give it the form, and attach to the independent variables x;t the physical meaning, which is appropriate to the particular application of interest. Therefore we discuss the system (88) with the understanding that all form use we display here can be easily translated into corresponding results for any other form of the 3W RI equations which is covariantly related to it.

Let us consider st the one soliton solution in the class B. This solution is constructed

by mere application of the DDT formulae corresponding to a complex pole = a + ib, namely (48), (49) and (50) which in this case read

The constant complex parameters which characterize this solution are: $z_0^{(+)}$, the twodimensional vector $z_0^{(-)}$ and f which comes from the naked solution (see (49))

and the notation M $_{21}$ in the right hand side of (90) indicates the matrix element M $_{21}$ of the matrix M. From the expression (91) of the denominator function (x;t) it follows that this solution solution is singular, due to the zeros of this denom inator, if the signs s_1 and s_2 are $s_1 = s_2 = 1$, $s_1 = s_2 = 1$ and $s_1 = s_2 = 1$ and it is instead regular, i.e. bounded in the entire (x;t) plane, only if $s_1 = s_2 = 1$. In the particular case in which the parameter f vanishes, f = 0, this solution has been rst introduced in [16] and fully investigated in [17] [20]. It describes the interaction of three bright-type pulses, and its experim ental observation in optics has been recently reported [21]. The case corresponding to f 6 0 has been discovered and investigated later in [11] where the soliton behavior has been shown to be of boom eronic type [22]. These soliton solutions describe the interaction of two bright pulses $u_1(x;t)$ and $u_2(x;t)$ and a third pulse, w(x;t), which is instead of dark type as it does not vanish when x !1 . Corresponding to various choices of the linear group velocities c_1 ; c_2 , this solution features a rich phenom enology which has been recently shown to be of applicative interest in optical processes in quadratically nonlinear m edia [5] [8]. The properties of this solution solution do not need to be reported here since they have been detailed in the literature quoted above.

Let us turn our attention to the soliton solution in the class D. We consider only those solutions which are obtained by applying the DDT technique with a real pole = , see (12), and this amounts to dressing a plane wave solution. Thus we apply to the 3W RI system (88) the general form ulae displayed in subsection 3.2 as follows. By setting A $^{(+)} = 1$ and A $^{(-)} = A$, this being a 2{dim ensional constant com plex vector, in (82a), (82b) and (33), the naked plane wave solution takes the expression

The continuous spectrum of the spectral problem $x^{(0)} = X^{(0)} x^{(0)}$, see (10), which corresponds to this plane wave may either coincides with the entire real k{axis, or may be the real axis with one or two gaps (see below). A gap $I_g = fk : k \quad k \quad k_+ g$ of the continuous spectrum is de ned as an interval of the real axis such that, for k 2 I_g , the 3 3 m atrix X (k), see (58),

has one real eigenvalue and two complex (conjugate) eigenvalues, in contrast with the continuous spectrum where the three eigenvalues are all real. The very existence of a gap depends on the given data $k_1, k_2, A_1, A_2, s_1, s_2$. For instance if $s_1 = s_2 = 1$ the m atrix (96) is Herm itian and therefore no gap m ay occur. In the present case the eigenvalues, which solve the equation (66), are the roots of the third degree polynom ial

and the eigenvalues m ay be explicitly given by C ardano form ulae. However we skip such details and we lim it our present discussion to the observation that the spectrum can have at m ost two gaps. This result follows from the expression D IS (k) of the discrim inant of the equation P () = 0 which comes to be a fourth degree polynom islof the spectral variable k, namely




Figure 1: One or two gaps of the spectrum. In both pictures $s_1 = s_2 = 1$. On the left: $k_1 = \frac{k_2}{p} = \frac{1}{13 + 16} A_1 = A_2 = 2$ and the gap is given by $k = k_1$, where $k = \frac{1}{2} \frac{p}{13 + 16} A_2$. On the right: $k_1 = 7$, $k_2 = 2$, $A_1 = 1$, $A_2 = 1=2$ and the two gaps are characterised by $k^{(1)} = 4.5$, $k_+^{(1)} = 2.6$ and $k^{(2)} = 1.5$, $k_+^{(2)} = 0.5$.

where the real coe cients D_n depend only on the given data $k_1, k_2, A_1, A_2, s_1, s_2$. Indeed, since the three eigenvalues, namely the roots of P (), are all real if the discriminant is negative, D IS (k) < 0, while two of them are complex conjugate if the discriminant is positive, D IS (k) > 0, the three eigenvalues are certainly all real for large enough k_j because the coe cient of the highest power of D IS (k) is negative (see also Proposition 6). Therefore, if the four roots of D IS (k) are all complex (i.e. with a non vanishing in aginary part) then there are no gaps in the spectrum. If instead only two roots are real, D IS (k) = D IS (k_+) = 0, k < k_+, the spectrum has one gap k k k_+ with these two roots k being the endpoints of the gap interval. Finally, if all roots of D IS (k) are real, D IS (k^{(1)}) = D IS (k_+^{(2)}) = D IS (k_+^{(2)}) = 0, k^{(1)} < k_+^{(2)} < k_+^{(2)}, the spectrum has two gaps, $k^{(1)}$ k $k_+^{(1)}$ and $k_+^{(2)}$ k $k_+^{(2)}$ (see Fig. 1).

In order to proceed further with our construction of the soliton solution, we assume the given data k_1 , k_2 , A_1 , A_2 , s_1 , s_2 are such that the continuous spectrum has at least one gap I_g and that the realpole of the DDT lies inside this gap, $2 I_g$.

W e specialize further the expressions (81) to the present case, nam ely




Figure 2: $k_1 = k_2 = 1$, $A_1 = A_2 = 2$, $c_1 = 1.5$, $c_2 = 1.6$. On the left: $s_1 = s_2 = 1$ and $c_1 < V = V = V = 1$. V $V_1 < c_2$. On the right: $s_1 = s_2 = 1$ and $1 < V = V = V_1 < c_1$.

this being just the present case form of (66). We also note that the relation (108) shows again that this solution does not exists if $s_1 = s_2 = 1$.




Figure 3: $k_1 = 7$, $k_2 = 2$, $A_1 = 1$, $A_2 = 1=2$, $c_1 = 1.5$, $c_2 = 1.6$; $s_1 = s_2 = 1$. On the left: $k^{(1)} = 4.5$, $k_+^{(1)} = 2.6$; on the right: $k^{(2)} = 1.5$, $k_+^{(2)} = 0.5$. In both gaps $c_1 < V = V = V + c_2$.

Figure 2 shows an example in which only one gap is present. If two gaps $I_g^{(1)}$ and $I_g^{(2)}$ exist, where $I_g^{(i)}$ is characterised by $k^{(i)}$ k $k_+^{(i)}$; i = 1; 2, the results are similar, e.g. in the case of $s_1 = s_2 = 1$ the velocity of the simulton V lies in an interval when varies in the gaps; however the function V () (together with its range of values) is di erent in the two gaps (see Figure 3).

F inally, it should be pointed out that this solution, as explicitly shown by (103), describes the nonlinear interaction of three plane waves whose am plitudes asymptotically, namely

at t = 1, acquire a phase{shift. The expression of these phase{shifts is explicitly given by the general form ula (86) which now reads




Figure 4: $k_1 = k_2 = 1$, $A_1 = A_2 = 2$. On the left: $s_1 = s_2 = 1$. On the right: $s_1 = s_2 = 1$. Here $c_1 = 1.5$, $c_2 = 1.6$

As an instance, the dependence of the phase{shifts $_1$ and $_2$ on the parameter inside the gap, $k < k_+$, is plotted in Figure 4.




Figure 5: $s_1 = s_2 = 1$, $k_1 = 7$, $k_2 = 2$, $A_1 = 1$, $A_2 = 1=2$; $k^{(1)} = 4.5$, $k_+^{(1)} = 2.6$; $k^{(2)} = 1.5$, $k_+^{(2)} = 0.5$. On the left: $k^{(1)} < < k_+^{(1)}$. On the right: $k^{(2)} < < k_+^{(2)}$.

Similarly, if there exist two gaps $I_g^{(1)}$ and $I_g^{(2)}$ we observe that the behaviour of the phases 1 and 2 as functions of is dimension in the two gaps. An example of such dependence is displayed in Figure 5.

5 Conclusions and rem arks

The Zakharov (Shabat spectral problem, which leads to an important class of integrable partial di erential equations, f.i. the Nonlinear Schrodinger, Sine{G ordon and m odi ed K ortew eq{de V ries equations, has been generalized to deal with m atrix and vector dependent variables long tim e ago. This matrix generalization has been recently revisited in [10] and [11] and further generalized in order to derive integrable matrix partial di erential equations with matrix, rather than scalar, coe cients. This generalization generates new integrable system s whose soliton dynam ics m ay have peculiar properties which are known as boom eronic and are di erent from those of standard solitons. In a previous paper [1] we have adapted the standard D arboux dressing m ethod to construct soliton solutions for a class of boom eronic (type equations. In this paper we have carried out this construction and obtained explicit expressions by dressing both the vacuum (i.e. vanishing) solution and the generic plane wave solution. We have specialized our form u lae to the particularly interesting case of the resonant interaction of three waves, a well-known m odel which is of boom eronic (type. For this equation we have constructed a novel solution which describes three locked dark pulses. The stability of this solution, with respect to the sign of the coupling constants, is not investigated here and remains to be veried. O ther potentially applicable integrable m odels are included in the present scheme. One of them, the Double three W ave Resonant Interaction (D 3W R I) equation, seems particularly interesting in both uid dynamics and nonlinear optics. In our present scheme, this system of ve partial di erential equations takes the form

where $s_1 = 1$; $s_2 = 1$; s = 1 are just signs. While these equations are obviously integrable, they may also follow, via them ultiscale (alias slow ly varying amplitude) approximation, from the resonant interaction of two triads of quasi{plane waves (with a commune mode), whose wave numbers k_1 ; k_2 ; q_1 ; q_2 ; k_3 and frequencies $!_1$; $!_2$; $_1$; $_2$; $!_3$ satisfy the resonance condition

R egarding the 3W R I and the D 3W R I equations, the follow ing rem ark is appropriate. Since they are rst order di erential equations any nonsingular linear coordinate transform ation of the (x;t) plane in itself leaves these equations form ally covariant. As a consequence, in di erent applications the coordinates x and t m ay be given di erent physical meaning. Since we have constructed special solutions, this meaning is irrelevant in our present context. On the contrary, the meaning of these coordinates x and t becomes relevant if one addresses the initial value problem, since one has to single out the evolution variable. Indeed in our present dressing construction, the two linear equations of the Lax pair (1) have been treated on the same foot. Instead, the solution of the initial value problem requires that one of the two Lax equations plays the role of the spectral problem which provides the spectral Fourier{type data, while the other linear equation entails the evolution of such data. In this respect we point out that the initial value problem associated to the variable t as evolution variable (tim e in the usual physical meaning) is still unsolved. This is due to the fact that the matrix T (x;t;k), see (2b), depends asymptotically, as x ! 1, on the unknown matrix U through the asymptotic values of the matrices W $^{()}$, see the system (7). Finding the solution of this open problem is left to future investigation.
