The X-ray B inary Analogy to the First AGN QPO

ABSTRACT

The N arrow Line Seyfert 1 galaxy REJ1034+ 396 is so far unique am ongst AGN in showing a Quasiperiodic oscillation (QPO) in its variability power spectrum. There are multiple types of QPO seen in black hole binary (BHB) systems, so we need to identify which BHB QPO corresponds to the one seen in the AGN. A key hint is the hot disc dom inated' energy spectrum of REJ1034+ 396 which is su ciently unusual that it suggests a mildly super-Eddington ow, also favoured by the most recent m ass estim ates for the AGN. This suggests the 67H z QPO seen occasionally in the mildly super-Eddington BHB GRS 1915+ 105 as the most likely counterpart, assuming m ass scaling of the QPO frequency. This is supported by the fact that these data from GRS 1915+ 105 have an energy spectrum which is also dom inated by a hot disc' com ponent. Here we show that the underlying broad band power spectral shape and norm alisation are also sim ilar, providing further consistency checks for this identi cation. Thus the AGN QPO adds to the growing evidence for a simple m ass scaling of the accretion ow properties between stellar and superm assive black holes.

1 IN TRODUCTION

Active galaxies (AGN) and accreting Black hole binaries (BHB) are the most energetic and dynamic systems in the Universe, with intrinsic variability seen over a broad range of tim escales. This variability is most often quanti ed via a power spectrum, showing the (squared) am plitude of variability as a function of frequency. For BHB this spectrum can be very approximately described as band limited noise, with a 'attop' in P () (equal variability power per decade in frequency) i.e. P () / ¹. This extends between a low and high frequency break, b, below which the PDS isP()/ , and h, above which the spectrum steepens 2 . W hile this is adequate to describe the \lim – toP()/ ited statistics of AGN power spectra (see the com pilation of M arkow icz et al. 2003), the excellent data from BHB show that band lim ited noise is intrinsically bum py, and is better represented by a series (generally 4{5) of peaked noise com ponents (Belloni & Hasinger 1990; Psaltis, Belloni & van der K lis 1999; N ow ak 2000; B ellon i, P saltis & van der K lis 2002). Superimposed on this continuum are a series of narrower features, referred to as Quasi-periodic oscillations (QPOs). These QPOs come in two distinct categories, term ed low and high frequency QPOs respectively, and their properties depend strongly on mass accretion rate (see e.g. the review s by van der K lis 2004; R em illard & M cC lintock 2006; D one, Gierlinski & Kubota 2007, hereafter DGK07).

There is now considerable evidence to suggest that AGN and BHB are mass-scaled analogies and share the same underlying physics of accretion, notably the Radio/X-ray fundam ental plane relations (Merloni, Heinz & di Matteo 2003; Falcke, Kording & Marko 2004), variability scaling (M cH ardy et al. 2006; M cH ardy 2009) and m ass-accretion rate dependant spectral behaviour (Pounds, Done & Osborne 1995; Middleton, Done & Schurch 2008; Middleton, Done & Gierlinski 2007). If this is the case then we would naturally expect QPOs to be visible in the power spectra of AGN at frequencies inversely scaled with the mass. However, these much longer timescales make detecting such QPOs in AGN very challenging (Vaughan & Uttley 2006). Many claims for such periodic signals have been made, but these all failed to properly determ ine the signi cance of the QPO on top of the (uncertain determ ination) of the underlying red noise power spectrum (see the discussion in Vaughan 2005). By contrast, our discovery of a 1 hour periodic signal from a Narrow Line Seyfert 1 (NLS1), REJ1034+396 is highly signi cant (> 99%) with correct modelling of the red noise spectrum (Gierlinski et al. 2008). This gives the rst detected AGN QPO to compare with the BHB.

2 MASS SCALING

Beyond simply detecting the QPO, we need to identify it with one of the multiple BHB QPOs. Up until recently this has been a problem as the mass of the AGN black hole was not well constrained, with di erent techniques (H line width, stellar velocity dispersion) giving mass estimates which di er by a factor of 30-50 (G ierlinski et al. 2008). How ever, a recent reanalysis of the SD SS data from this object shows that both these black hole mass tracers can give consistent estimates for the black hole mass with careful decom position of the di erent spectral components, giving 1-4 10^6 M (B ian & Huang 2009). This predicts an analogous signal from a 10M BHB between 27 and 108 Hz if a simple linear mass scaling holds for this QPO.

P lacing thism assestim ate together with the bolom etric hum inosity of 5 1^{64} ergs s 1 im plies $1 < L/L_E _{dd} < 4$. This is supported by the distinctive nature of the optical/UV/X-ray SED of REJ1034+396, where the bolom etric hum inosity is dom inated by a very hum inous component peaking in the EUV (Puchnarew icz et al. 2001; M iddleton, D one & G ierlinski. 2007). This cannot be t by standard disc m odels, but can be approxim ated by the super-Eddington shim disc m odels (M ineshige et al. 2000; W ang & N etzer 2003, H aba et al. 2008).

The type and characteristic frequency of QPOs seen from BHB depend on mass accretion rate as well as BHB mass. Thus we need to study a super-Eddington BHB in order to nd an analogue with the AGN QPO.GRS 1915+105 is the only BHB which spends signi cant time at (probably) super-Eddington accretion rates (Done, W ardzinski & Gierlinski 2004). This has a mass of 14M (G reiner, Cuby

& M cC aughrean 2001; H arlaftis & G reiner 2004), so a sim – ple m ass scaling of the AGN QPO predicts the counterpart is between 19 and 77H z. GRS1915+105 does indeed occasionally show a QPO at 67 H z (with a probable harm onic at 41 H z), m aking this the m ost likely candidate.

This means that the data are consistent with the simplest model, which is that the QPO seen at a given lum inosity/spectral state in BHB scales linearly with m ass up to AGN. However, this only makes use of the information on the QPO frequency. This QPO sits on top of an underlying broad band continuum noise power spectrum, and the shape and normalisation of this broadband noise is likewise dependent on lum inosity/spectral state in BHB. Here we use the additional information from this noise power to check the QPO identication.

3 POW ER SPECTRAL PHENOM ENOLOGY IN BHB

3.1 Low -frequency QPOs

These are subdivided into 3 classes, types A, B and C (see e.g.Casella et al. 2005), not to be confused with the spectral states in GRS 1915+105 which are given the same name (Belloniet al. 1997)!

The C class LFQPO is almost always present in the low/hard state of BHB. It has frequency which increases between 0.01-6 Hz as the spectrum softens from a dim, harder, low/hard state to a bright, softer low/hard state, through to the hard interm ediate state (Belloniet al. 2005). There is a correlated increase in strength, coherence and harmonic structure of the QPO (van der K lis 2004; R em illard & M cC lintock 2006). Its spectrum closely follows that of the harder X-ray C om ptonisation com ponent rather than the soft disc em ission (Rodriguez et al. 2002; Sobolew ska & Zycki 2003; 2006), so it is most probably produced by som e fundam entalm ode of the corona, not of the disc.

The changes in underlying power spectral shape are correlated with the energy spectral changes and the QPO frequency changes. Very approxim ately, the type C Q PO frequency increases together with the low frequency break, b, (P saltis et al. 1999), while the high frequency break rem ains constant. Thus the broad band power spectrum progressively narrows, losing the low frequency power (Gierlinski, Nikolajuk & Czerny 2008). The normalisation of the 'at top' remains roughly constant at P() 0:01 when the power spectrum is normalised to the fractional uctuation power $(=I)^2$ at high energies. The bandpass is important as the disc component becom esprogressively stronger as the spectrum softens. The disc remains mostly constant on the short tim escales of the power spectrum , so dilutes the variability of the higher energy tail (Churazov et al. 2001; D one & Gierlinski 2005).

In the context of the truncated disc/hot inner ow models for the low /hard state, all these observations can be interpreted if the inner edge of the thin disc decreases as a function of mass accretion rate. The increasing overlap between the disc and hot ow means more seed photons from the disc intercept the hot ow, giving stronger Compton cooling and softer spectra. The moving inner radius means that the section of the hot ow which is unconstrained by the disc gets sm aller, so increasing all its characteristic variability frequencies, while the smaller radial extent means the QPO can become stronger and more coherent (DKG 07). This qualitative picture can be made quantitative, using vertical (Lense-Thirring) precession of the hot ow to make the QPO (Ingram, Done & Fragile 2009), and turbulence in the hot ow to make the broadband power (Ingram & Done 2009), but such m odels are still at the speculative stage.

The type B LFQPO is seen as the source continues to soften after the highest type C LFQPO from the hard interm ediate state to the soft interm ediate state. This is a rather subtle change in spectrum, but triggers an abrupt collapse of the underlying broad band noise power spectrum, keaving the QPO (and its multiple harm onics) dram atically enhanced in prominence (Rem illard et al. 2002; Belloni et al. 2005).

A sthe spectrum continues to soften in the soft interm ediate state, class A LFQPOs can be seen. These are weaker and much broader (so there is no harm onic structure discernible) than the type B LFQPOs, but appear at sim ilar frequencies, and again are seen against a very low continuum noise power (Rem illard et al. 2002). Then the QPOs disappear altogether as the spectrum continues to soften into a com pletely disc dom inated state (Rem illard & M cC lintock 2006; C asella et al. 2005).

W hile the type C LFQPO is ubiquitous in the low /hard and hard interm ediate states, types B and A are m uch rarer, seen only in the soft interm ediate state.

3.2 High-frequency QPOs

Transient high-frequency QPOs (HFQPOs) are detected in several BHB sources (GRO J1655-40, XTE J1550-564, GRS 1915+105, 4U 1630-47 and XTE J1859+226). These appear to be constant in frequency despite changes in lum i-

nosity by a factor of 3-8, so these m ay be a stable signature of the accretion system . The values are consistent with being directly proportional to the m ass of the black hole, though there are only 3 data points and the m asses on ly range from 6 14M (R em illard & M cc lintock 2006). They are offen seen in 3.2 ratio, in plying som e sort of resonance sets the frequencies, but the exact nature of this resonance is yet to be clearly determ ined (A bram ow icz & K luzniak 2001; K luzniak et al. 2004; T orok et al. 2005; K ato et al. 2004; R ezzolla et al. 2003; Fragile et al. 2005).

These seem to be detected only in the soft interm ediate state i.e. are seen simultaneously with type B and A LFQ -POs and not with type C LFQPOs (Rem illard et al. 2002). It is extremely dicult to accurately assess the underlying noise power spectral shape at such high frequencies as this is dom inated by the statistical white noise, but the coadded spectra of R em illard et al. (2002) suggest that these high frequency QPOs sit on a broad band continuum which ¹ shape (most probably another Lorentzian com has a ponent) but with a norm alisation which is over an order of m agnitude below that seen for the lower frequency 'at top' noise which accompanies the type C LFQPOs (Rem illard et al. 2002). W hile the norm alisation of the power spectrum strongly depends on the energy bandpass in BHB due to the di erent variability of disc and C om ptonisation com ponents (e.g. Churazov et al. 2001; Done & Gierlinski 2005), the study of R em illard et al. (2002) used only data above 6 keV where the disc makes little contribution. Hence this di erence in normalisation is probably intrinsic rather than due to dilution of the variability by the constant disc.

3.3 AdditionalQPOs seen only in GRS 1915+105

GRS 1915+105 is highly lum inous, so never gets to the low /hard state. Instead it ranges between the hard interm ediate state, soft interm ediate state and disc dom inated states. However, it also shows spectra which are unlike any of the standard states, being dom inated by low tem perature C om ptonisation of the disc together with a very weak hard tail (Zdziarski et al. 2003; Done, W ardzinski & Gierlinski 2004; Belloni 2009). In this state it can show some particularly unique QPOs, including very strong, narrow QPOs with complex harm onic structure at tens of milliHertz (M organ, Rem illard & Greiner 1997). These are startlingly sim ilar to the QPO frequencies seen in the Ultra-Lum inous X ray sources M 82 X-1 (Strohm ayer & M ushotzky 2003) and NGC 5408 X-1 (Strohm ayer at al. 2007). W hile these low frequencies clearly in ply interm ediate m ass black holes if they are identied with the standard LFQPO, it is plain from the data of GRS 1915+105 that such low frequencies can also be form ed from super-Eddington accretion onto a 14 M black hole (Heil, Vaughan & Roberts 2009). Simultaneously with this very low frequency QPO, GRS 1915+105 can also show an occasional QPO at 67 Hz. This has only been strongly detected in a few datasets (Morgan, Rem illard & Greiner 1997) plus a few other weaker detections (M organ, Rem illlard & Greiner 1997; Ueda et al. 2009), together with a (potential harm onic) feature at 41 H z (M cC lintock & R em illard 2006). The statistical noise is not so dom inant as for the HFQPOs as these are at lower frequencies, so the underlying continuum noise power is som ew hat easier to constrain. This has a complex shape, but the norm alisation underneath 10⁴ from Morgan et al. the QPO appears to be P() (1997). How ever, this used power spectra across the fullen-

ergy bandpass. Concentrating instead on the high energy band gives P () 0.001 (R em illard & M cC lintock 2006).

4 LIGHTCURVE SIMULATIONS

The analytical method of tting the broadband shape of the power spectrum of Vaughan (2005) is only applicable to a single power-law continuum noise shape, so does not include intrinsic breaks or the e ects of statistics (white noise at high frequencies). Instead we simulate an ensemble of lightcurves with given power spectral properties using the method of D one et al. (1992), using the corrected power spectral statistics (T immer & K oenig 1995), as developed by Uttley et al. (2002).

The real data are evenly sampled and binned on timescale t and span a total time of T data. This has mean, I, total variance, $\frac{2}{data} = \frac{2}{int} + \frac{2}{err}$, where $\frac{2}{int}$ is due to the intrinsic variability of the source and $\frac{2}{err}$ is the additional variance added by statistical uncertainties. W e generate a lightcurve using the fast Fourier transform method of Timmer & Koenig (1995), spanning a timescale NT_{data} (where N 1) with some intrinsic power spectral shape, P (f) \sin^2 (2 f t)=2 f t, where the \sin^2 term accounts for the suppression of high frequency power due to binning (Done et al. 1992). We snip this up into N separate lightcurves of length ${\rm T}_{\rm data}$. For each lightcurve we measure $_{\rm ijint}^2$ and ${\rm I}_{\rm i}$, and then scale so that the average m ean and variance of the ensemble is the same as that in the real data. W e then add white noise with the sam e properties as in the realdata, take the power spectra of the simulated lightcurves and use these to de ne the statistics of the power spectral distribution.

One key problem with this method is that it is linear while the real data are known to be non-linear. The physical process which generates the noise keeps $_{int}$ =I con-

stant as the source varies (Uttley & M cH ardy 2001). This is quite unlike the simulated lightcurve properties e.g. for P(f) / > 1 (red noise) there is no well dew ith ned mean, so no well de ned i;int=Ii. Thus the snipped lightcurves made from this power spectrum have large dispersion in int=I, sp a large range in power spectral norm alisation, de ned as $P(f)df = (int=I)^2$. This wide dispersion is unlike that of the real data, where the noise process is self-similar. An exponential transform of the simulated linear lightcurve can recover approximately the required statistical properties (Uttley, M cH ardy, & Vaughan 2005) but instead we simply choose to put a break in the input power spectrum at 0:5=T_{data}. At frequencies below the break the spectrum is at (=0) and above the break the spectrum follows the desired input power spectral shape. The result is a set of snipped lightcurves of the sam e length and statistical properties as the real data, with a well de ned mean and dispersion.

5 THE UNDERLYING CONTINUUM POWER SPECTRAL SHAPE OF REJ1034+396

XMM -Newton observed REJ1034+ 396 on 2007-05-31 and 2007-06-01 for 91 ks (observation id. 0506440101, revolution no. 1369). Details of the data extraction are given in Middleton et al. (2009). This resulted in 84.3 ks of clean data starting on 2007-05-31 20:10:12 UTC. The QPO is very coherent over 16 periods in a 59ks segment of this total lightcurve, hereafter called the 'in phase' data. The resulting power spectrum of this 'in phase' data is shown in gure 3, where the QPO is present at > 99.9% signi cance above the red noise (Gierlinksi et al. 2008). The index of the total (i.e. including the QPO) power spectrum over the frequency range not dom inated by statistical noise (i.e.

above 10 3 Hz) was estimated using the analytical method of Vaughan (2005) to be -1.35 0.18 (G ierlinskiet al. 2008)

5.1 Simulations of the in-phase segment

We rst check that our simulations reproduce the analytical result. Fig 1 shows the 2 versus power spectral index for a single power-law t to the entire power spectrum above 10 3 Hz. The simulations are inherently stochastic so there are uctuations. We smooth these by tting a quadratic which gives a minimum at -1.45 $^{+0.20}_{0.21}$, consistent with the analytical result.

However, here we are more interested in the shape of the power spectrum which underlies the QPO, so we remove the single point at the QPO frequency, replacing it with the fractional m s of the bin directly preceding it. We then redo the single power-law simulations with this reduced $(_{int}=I)^2$. We show the results from this in Fig 2, again tted with a quadratic to sm ooth over the inherent stochasticity. This gives $-1.35 \, {}^{+0.22}_{-0.21}$ similar to the previous result as the QPO is fairly central in the tted section of the power spectrum, so does not greatly distort the average power spectral slope. The t is obviously better in term sof overall reduced 2 , and is an acceptable description of the data at 97% con dence. This best-t average power spectrum is shown together with residuals in Fig 3.

W e repeat the analysis using a broken power-law, xing the slope below and above the break to -1 and -2 respectively, and then varying the break frequency. Fig 4 shows that there is a minimum in ² for such a break at a frequency close to the QPO. However, the value of ² is slightly (though not signi cantly) higher than that for a single power-law description of the underlying power spectrum, so this is not a better description of the power spectrum than a single power-law. The best-t, average broken power-law together with errorbars from statistical uncertainties is shown in g-

ure 5 together with the residuals to the real power spectrum (m inus the QPO) in the panel below .

5.2 Full lightcurve

The longer timescale spanned by the 'full' lightcurve extends the power spectrum down to slightly lower frequencies so may give tighter constraints on any power spectral break. However, the QPO is now not so coherent, so is spread overm ore frequency bins. W e simulate the underlying power spectrum by excluding 5 frequency bins around the QPO frequency, and replacing them with the preceding bins. Figure 6 shows the resulting 2 distribution for the single power-law, which has index $1.08 + 0.18_{0.18}^{+0.18}$. The overall reduced 2 1, showing that this is a good description of the data. Figure 7 shows the best-t average single power-law t to the real power spectrum . Error bars com e from statistical un certainties and, as before, the residuals to the tare shown in the panelbelow.

W e again test for the presence of a break in the underlying red noise (excluding the QPO) by simulating a broken power-law with indices xed at -1 and -2. The resulting chisquared plot (gure 8) again shows that such a spectrum with break frequency slightly above the QPO is consistent with the data, but is not required by it. A s before, the bestt broken power-law is plotted in gure 9.

5.3 Sum mary of constraints from the power spectral shape

The underlying power spectral shape is consistent with a single power-law with index -1.3. This is inconsistent with the

² shape seen at high frequencies in the sub-Eddington states of C yg X -1 (R evnivtsev et al. 2000), but m ay be consistent with the (poorly constrained) noise power shape un-

derlying the HFQPO or 67 HzQPO .W hile this supports our tentative identi cation of the QPO with the 67 Hz feature, the power spectral shape is also consistent with that expected underneath the LFQPO, i.e. with a power spectrum ¹ to ² at a frequency just above the which breaks from LFQPO frequency. However, this can be ruled out by the power spectral norm alisation, which is an order of magnitude below the at-top norm alisation of P () 0:01 seen ubiquitously under the LFQPO. Thus the power spectrum norm alisation precludes an identi cation with the LFQPO. This supports the conclusions from the source spectrum and lum inosity, which favour a mildly super-Eddington accretion ow, whereas the LFQPOs are characteristic of sub-Eddington states.

Instead, the power spectral norm alisation is similar to that seen from the HFQPOs and the 67 Hz QPO from GRS 1915+105. However, the HFQPOs are again seen from sub-Eddington states, so the 67 Hz QPO from GRS1915+105 is our most likely candidate (see Section 2). Thus we explore the power spectral correspondence in more detail below.

6 ENERGY SPECTRA

B andpass e ects are very in portant, as di erent com ponents have di erent variability, and this can substantially a ect the derived norm alisation of the power (C hurazov et al. 2001; D one & G ierlinski 2005). Hence we now look in detail at the energy spectra for GRS 1915+105 at the time when it shows the 67 H z QPO, our most likely candidate for the AGN QPO, and com pare com ponents and bandpass with REJ1034+396.

The data from GRS 1915+105 which show the 67 Hz QPO are the RXTE observations on April the 20th (OB-SID:10408-01-04-00), April the 29th (OBSID:10408-01-05-

00) and M ay 5th (OBSID: 10408-01-06-00) 1996 (M organ, R em illard & G reiner 1997). The energy spectra of these observations are shown in Fig 10, t with a disc black-body com ponent (diskbb) and a low-tem perature, optically thick therm al C om pton com ponent (comptt). This is accom panied by a tail to higher energies, which we m odel as high tem perature therm alC om ptonisation, with power-law index xed at 2.2 and electron tem perature at 100 keV. The tail is probably m uch m ore com plex (see e.g Zdziarskiet al. 2005), but this gives an adequate description of the RX TE data. W e show the data with its corresponding best tm odel, corrected for absorption (xed to the variable abundance m odel used in D one, W ardzinski& G ierlinski 2004), superim posed

Fig 11 shows the spectrum of REJ1034+396 t by the same three component model. This has a ratio of inferred (bolom etric) disc ux to Comptonised ux of 3.0, and a ratio of disc to power-law ux of 19, similar to that of GRS 1915+105 (4.3/38, 3.0/24 and 4.3/33 for the 04, 05 and 06 ObsIDs respectively). However, the ratio of electron temperature to disc temperature is rather higher for REJ1034+396 than for GRS 1915+105 (6.6 versus 1.6, 1.8 and 1.7), making the approximately power-law section of the soft excess' rather than W ien shape of this component. There are other energy spectra in GRS 1915+105 which m atch this aspect m ore closely (M iddleton et al. 2009), but these data do not show a signi cant high frequency QPO.

We can now quantify the bandpass e ects. In GRS 1915+105, Rem illard et al. (2004) show the 41/67 Hz QPO computed from the lightcurve in the 13-30 keV bandpass range, rather than the 2{20 keV in M organ et al (1997). We overlay this energy range on the spectra in Fig 10 to show that this sam ples mostly the low tem perature C om ptonisation com ponent, excluding m ost of the disc com ponent which dilutes the variability, as well as most of the higher energy power-law. To be dom inated by the corresponding spectral com ponents in REJ1034+396 requires a bandpass of 0.3-1.5 keV.

Fig 12a shows the resulting power spectrum from 0.3-

on the data in Fig 10.

1.5 keV. Unlike all the other power spectra, this one has statistical noise subtracted, so has less power at high frequencies. How ever, the intrinsic power is very similar to that of the total lightcurve in both shape and norm alisation. Fig 12b shows the 13–30 keV power spectrum of GRS 1915+105 of R em illard et al. (2004), again with statistical noise subtracted. This is plotted using the same scale in P() over 1.5 decades in frequency (10–300H z in GRS 1915+105, scaled by the putative m ass di erence of 3 10^6 =14 corresponding

to 4:66 10 ⁵ 1:4 10 ³ H z in RE J1034+ 396). W hile the power spectrum of the AGN has very poor statistics compared to GRS 1915+ 105, these data are startlingly similar in both shape and normalisation for both the QPO and underlying power spectrum . M uch better data would be required in order to constrain the existence of any 3.2 harm onic corresponding to the 41 H z QPO in GRS 1915+ 105 (it is barely signi cant in GRS 1915+ 105!). The slight excess of power at this frequency in the AGN is not at all signi cant.

7 CONCLUSION

The discovery of an AGN QPO allows us to test whether the physics of the accretion ow scales linearly with black hole mass if we can identify the corresponding BHB QPO.We use the variability power spectral shape and norm alisation to show that the continuum noise underlying the AGN QPO is consistent with that seen underneath the HFQPO seen in BHB and 67 Hz QPO seen in GR S1915+105, but not with the LFQPO.

The distinctive shape of the energy spectrum of REJ1034+396 argues strongly for a mildly super-Eddington accretion ow in this AGN, supported by recent m assestimates for the black hole (B ian & Huang 2009). This favours the 67 Hz QPO as the BHB counterpart, as this is seen in super-Eddington states of GRS 1915+105, whereas the HFQPO same seen in sub-Eddington states. The spectra seen from the 67 Hz QPO observations of GRS 1915+105 are similar to that the REJ1034+396 in being dominated by low tem perature, optically thick C om ptonisation of the disc. This spectral shape m ay well be the new 'ultra-lum inous

state' proposed by G ladstone et al. (2009) for the broad curvature seen in the X-ray spectra of the U ltra-Lum inous X-ray sources. Conversely, the disc is seen without strong distortion by C om ptonisation in the spectra corresponding to the HFQPOs.

The identi cation of the AGN QPO at 2:7 10^{4} Hz with the 67 Hz QPO in GRS 1915+105 is consistent with a simple linear mass scaling of the QPO frequency, energy spectral components and variability power spectra from stellar to supermassive black holes accreting at the same $L=L_{\rm E\,dd}$.
