Solitons, peakons and periodic cusp wave solutions for the Fornberg-W hitham equation

A bstract

In this paper, we employ the bifurcation method of dynamical systems to investigate the exact travelling wave solutions for the Fomberg-W hitham equation u_t $u_{xxt} + u_x + u_x = u_{xxx} + 3u_xu_{xx}$. The implicit expression for solitons is given. The explicit expressions for peakons and periodic cusp wave solutions are also obtained. Further, we show that the limits of soliton solutions and periodic cusp wave solutions are peakons.

K eywords: Fomberg-W hitham equation, soliton, peakon, periodic cusp wave solution

1 Introduction

The Fomberg-W hitham equation

$$u_t \quad u_{xxt} + u_x + uu_x = uu_{xxx} + 3u_x u_{xx};$$
 (1.1)

has appeared in the study of qualitative behaviors of wave breaking [1,2]. It is a nonlinear dispersive wave equation. Since Eq.(1.1) was derived, little attention has been paid to studying it. In [3], Fomberg and W hitham obtained a peaked solution of the form $u(x;t) = A \exp(\frac{1}{2}x + \frac{4}{3}t)$, where A is an arbitrary constant. In [4], we constructed a type of bounded travelling wave solutions for Eq.(1.1), which are called kink-like and antikink-like wave solutions. Unfortunately, the results in [3,4] are not complete. In the present

paper, we continue to derive more travelling wave solutions for Eq.(1.1), so that we can supplement the results of [3,4].

The remainder of the paper is organized as follows. In Section 2, we discuss the bifurcation curves and phase portraits of travelling wave system. In Section 3, we obtain the implicit expression for solitons and the explicit expressions for peakons and periodic cusp wave solutions. At the same time, we show that the limits of solitons and periodic cusp wave solutions are peakons. A short conclusion is given in Section 4.

2 B ifurcation and phase portraits of travelling wave system

Let u = '() with = x of be the solution for Eq.(1.1); then it follows that

Integrating Eq. (2.1) once we have

where h is a constant.

Note that (2.3) has a singular line ' = c. To avoid the line temporarily we make transformation d = (' c)d. Under this transformation, Eq.(2.3) becomes

System (2.3) and system (2.5) have the same rst integral as (2.4). Consequently, system (2.5) has the same topological phase portraits as system (2.3) except for the straight line ' = c.0 by iously, ' = c is an invariant straight-line solution for system (2.5).

For a xed h, (2.4) determ ines a set of invariant curves of system (2.5). As h is varied, (2.4) determ ines di erent families of orbits of system (2.5) having di erent dynamical behaviors. Let M ($'_e; y_e$) be the coe cient matrix of the linearized version of (2.5) at the equilibrium point ($'_e; y_e$); then

and at this equilibrium point, we have

By the theory of planar dynam ical system s (see [5]), for an equilibrium point of a planar dynam ical system, if J < 0, then this equilibrium point is a saddle point; it is a center point if J > 0 and p = 0; if J = 0 and the Poincare index of the equilibrium point is 0, then it is a cusp.

By using the rst-integral value and properties of equilibrium points, we obtain the bifurcation curves as follows:

O by iously, the three curves have no intersection point and g_3 (c) < g_2 (c) < g_1 (c) for arbitrary constant c.

U sing the bifurcation m ethod for vector elds (e.g., [5]), we have the following result which describes the locations and properties of the singular points of system (2.5).

Theorem 2.1 For given any constant wave speed c € 0, let

Then we have

(1) If $g < g_3$ (c), then system (2.5) has two equilibrium points ($'_1$;0) and ($'_{1+}$;0), which are saddle points.

(2) If $g = g_3$ (c), then system (2.5) has two equilibrium points (c 2;0) and (c;0). (c 2;0) is a saddle point and (c;0) is a cusp.

(3) If g_3 (c) < $g < g_2$ (c), then system (2.5) has four equilibrium points (' $_1$;0), (' $_{1+}$;0), (c; y_1) and (c; y_{1+}). (' $_1$;0) is a saddle point and (' $_{1+}$;0) is a center point enclosing the orbit which connects the saddle points (c; y_1) and (c; y_{1+}).

(4) If $g = g_2(c)$, then system (2.5) has four equilibrium points (c $\frac{4}{3}$;0), (c $\frac{2}{3}$;0), (c; $\frac{2}{3}$) and (c; $\frac{2}{3}$), which satisfy H (c $\frac{4}{3}$;0) = H (c; $\frac{2}{3}$) = H (c; $\frac{2}{3}$) and form a triangular orbit which encloses the center point (c $\frac{2}{3}$;0).

(5) If g_2 (c) < $g < g_1$ (c), then system (2.5) has four equilibrium points (' $_1$;0), (' $_{1+}$;0), (c; y_1) and (c; y_{1+}). (' $_{1+}$;0) is a center point enclosing the orbit which is hom oclinic for the saddle point (' $_1$;0).

(6) If $g = g_1$ (c), then system (2.5) has three equilibrium points (c 1;0), (c; $\frac{p}{2}$) and (c; $\frac{p}{2}$). (c 1;0) is a cusp. (c; $\frac{p}{2}$) and (c; $\frac{p}{2}$) are two saddle points.

(7) If $g > g_1$ (c), then system (2.5) has two equilibrium points (c; y_1) and (c; y_{1+}). They are saddle points.




Fig. 1. The phase portraits of system (2.5). (a) $g < g_3(c)$; (b) $g = g_3(c)$; (c) $g_3(c) < g < g_2(c)$; (d) $g = g_2(c)$; (e) $g_2(c) < g < g_1(c)$; (f) $g = g_1(c)$; (g) $g > g_1(c)$.

The phase portraits of system (2.5) are given in Fig.1.

3 Solitons, peakons and periodic cusp wave solutions




Fig. 2. The orbits of system (2.3). (a) The hom oclinic orbit (corresponding to g_2 (c) < $g < g_1$ (c)). (b) The lim it curve of hom oclinic orbit and periodic orbit (corresponding to $g = g_2$ (c)). (c) The periodic orbit (corresponding to g_3 (c) < $g < g_2$ (c)).

graphs of the hom oclinic orbit, periodic orbit and their \lim it cure are shown in Fig.2.

The following lem magives the relationship of soliton solutions of Eq.(1.1) and hom oclinic orbits of system (2.3).

Lem m a 3.1 Assume that is a homoclinic orbit of system (2.3) and its parameter expression is '=' () and y=y(); then u='() with =x ct is a soliton solution for Eq.(1.1).

Proof. From Fig.1 (e), we can see that the hom oclinic orbit encloses ($^{\prime}_{1+}$;0) and connects ($^{\prime}_{1}$;0). Therefore, $\lim_{j \to j-1} {}^{j}_{1}$ () = $^{\prime}_{1}$.

On the other hand, u='() is the solution for system (2.3). This implies that u='() is the solution for Eq.(2.1). Thus, u='(x) ct) is the solution solution for Eq.(1.1).

In Fig 2 (a), the hom oclinic orbit of system (2.3) can be expressed as

Substituting Eq.(3.1) into the rst equation of system (2.3) and integrating along the homoclinic orbits, we have




Fig. 3. The solitons for Eq.(1.1). (a) c = 2, g = 0.4999999; (b) c = 2, g = 0.49; (c) c = 2, g = 0.46; (d) c = 2, g = 0.45.

(3.6) is the implicit expression for solitons for Eq.(1.1). We show the graphs of the solitons in Fig.3 under some parameter conditions. From Fig.3, we can see that when g_2 (c) < g < g_1 (c) and g tends to g_2 (c), the solitons lose their sm oothness and tend to peakons.

Note the following facts: when g_2 (c) < $g < g_1$ (c) and g tends to g_2 (c), the limit curve of such homoclinic orbit of system (2.3) is a triangle with the following three line segments (see Fig.2 (b)):

Let us have g_2 (c) < $g < g_1$ (c) and g tends to g_2 (c); then we obtain that

which implies that for arbitrary constant c € 0, Eq.(1.1) has peakons




Fig. 4. The peakons for Eq.(1.1). (a) c = 1; (b) c = 2.

O by iously, u has peaks at x ct = 0.W e show graphs of the peakons in Fig.4 under som e param eter conditions.

Remark 3.1 (1) If we take $c = \frac{4}{3}$ in (3.17), then we can see that (3.17) agrees with the result in [3].

(2) In the phase portaits, the triangle curve corresponds to a peakon solution.

We have the following $\operatorname{lem} m a$, $\sin \operatorname{ilar} to \operatorname{Lem} m a 3.1$, which indicates the relationship of periodic wave solutions for $\operatorname{Eq.}(1.1)$ and periodic orbits of system (2.3).

Lem m a 3.2 Assume that is a periodic orbit of system (2.3) and that its parameter expression is \prime = \prime () and y = y(); then u = \prime () with = x ct is a periodic wave solution for Eq.(1.1).

In Fig 2 (c), the periodic orbit can be expressed as

Substituting (3.18) into the rst equation of system (2.3) and integrating along the periodic orbit, we have



are periodic cusp wave solutions for Eq.(1.1) with 2T period. C learly, when g_3 (c) < g < g_2 (c) and g ! g_2 (c), T ! 1 , $\frac{3}{4}$, 1 ! 0, and u (x;t) in (3.26) tends to

$$u(x;t) = \frac{4}{3} \exp(\frac{1}{2}x + ct) + (c + \frac{4}{3})$$

(3.27) is identical with (3.17). The graphs of som e periodic waves for Eq.(1.1) are shown in Fig.5 under som e parameter conditions. From Fig.5 we can see that g_3 (c) < $g < g_2$ (c) and g tends to g_2 (c), the periodic cusp wave solutions tend to peakons.



Remark 3.2 (1) In the phase portaits, the sem i-elliptic closed curve with one side on the singular line ' = c corresponds to a periodic cusp wave solution.

(2) In [4], we dealt with the case g_1 (c), and obtained the kink-like and antikink-like wave solutions for Eq.(1.1).

4 Conclusion

In this work, by using the bifurcation method, we obtain the analytic expressions for solitons, peakons and periodic wave solutions for the Fornberg-W hitham equation, given as (3.6), (3.17) and (3.26), respectively. We also show the relationships among the solitons, peakons and periodic cusp wave solutions.
