Complex Dynam ics and Synchronization of Delayed-Feedback Nonlinear Oscillators

We describe a exible and modular delayed-feedback nonlinear oscillator that is capable of generating a wide range of dynam ical behaviours, from periodic oscillations to high-dimensional chaos. The oscillator uses electrooptic modulation and bre-optic transmission, with feedback and litering implemented through real-time digital-signal processing. We consider two such oscillators that are coupled to one another, and we identify the conditions under which they will synchronize. By examining the rates of divergence or convergence between two coupled oscillators, we quantify the maximum Lyapunov exponents or transverse Lyapunov exponents of the system, and we present an experimental method to determ ine these rates that does not require a mathematical model of the system. Finally, we demonstrate a new adaptive control method that keeps two oscillators synchronized even when the coupling between them is changing unpredictably.

1. Introduction

P rivate com m unications, fast physical random num ber generators and spatiotem – porally distributed sensor networks have provided the context for possible new applications of chaotic dynam ical system s. A key requirement for such applications is the development of reliable and robust generators of chaotic waveforms with broad spectral bandwidths. By reliable, we mean that given parameters of the system, the dynam ical properties are reproducible, both experimentally and theoretically. Robust in plies that the system exhibits chaotic behaviour over a region of parameter space (i.e., with few periodic windows.) There have been several realizations of delayed-feedback optoelectronic oscillators that meet these criteria. Systems that can be con gured for integrated optoelectronic fabrication and can function at frequency ranges from tens of G H z down to kH z m ay ind applications in acoustic, biological, chemical, electrom agnetic, and mechanical scenarios on nano- to m acroscopic spatial scales (A rgyris et al. 2007, Reidler et al. 2009, Sorrentino & O tt 2008, 2009, C ohen et al. 2008, Youse et al. 2008, A rgyris et al. 2008).

Our focus in this paper is on the dynam ics of delayed-feedback nonlinear oscillators constructed from modular optoelectronic components. Delayed feedback enables such systems to generate a wide variety of waveforms, with diering degrees of complexity that depend on the parameters used. In particular, the time-delay, feedback strength, and liter parameters can be tuned to produce highly stable periodic waveforms (Yao & Maleki 1996) as well as complex waveforms that are characteristic of robust, high-dimensional chaos (Peil et al. 2009).

In x2 we introduce the basic optoelectronic system and the delay-di erential equations used for a continuous-tim e description of the dynam ics (K ouom ou et al. 2005, C ohen et al. 2008). The intrinsic nonlinearity of the system arises from the integrated optical M ach-Zehnder m odulator which changes the intensity of light transm itted depending on the cosine squared of a m odulation voltage applied to its electrodes. We then chart the dynam ical behaviour of the system, using bifurcation diagram s, as the feedback strength and delay time of the feedback loop are varied. The com plexity of the waveform s generated is assessed by the Lyapunov dimension, and we illustrate the wide range of dynam ics accessible.

In x3 we rst m otivate and then show how to incorporate digital signal processing (D SP) capabilities in the delayed-feedback system. This enables precise, real time control of system parameters, such as the time-delay and liter characteristics, in a exible manner well-suited for applications in communications and sensor networks. The transition from continuous-time to discrete-time equations is outlined; the system is now governed by nite difference equations that describe its time evolution in terms of the system state as sampled at discrete times by an analogue to digital converter (Toom ey et al. 2009). Even though our D SP implementation was aimed at kHz frequencies, such systems can be extended easily into the G Hz range.

The question of isochronal synchronization of these nonlinear oscillators (F ischer et al. 2006, K lein et al. 2006, R ogers-D akin et al. 2006, Schwartz & Shaw 2007, Zhou & R oy 2007, Franz et al. 2008) is central to possible applications in sensor networks (Sorrentino & Ott 2008, 2009). We thus consider coupled oscillators next in x4, where the m any di erent con gurations in which even two oscillators m ay be coupled are outlined. We then restrict ourselves to the schemes that we have explored in some detail. A di usive-coupling scheme that allows the coupled systems is of particular interest. Several results on the dependence of synchronization error on coupling strength that have been obtained m athematically are veried through num erical simulations and tested experimentally. In particular, we emphasize that, in the experiments, noise and di erences in nom inally m atched system parameters are unavoidable. We iden ty parameter regimes for the coupling strength where stable synchronization is observed.

W hile the steady-state synchronization error is an important quantity to measure with regards to sensor and communications applications, the transients towards synchrony and away from synchrony are important as well, and we study these in x5. The time scales for these transients set the limits on communication rates and detection of environmental perturbations. One may determ ine the maximum Lyapunov exponent for a dynamical system by measurement of transients away from synchrony (Cohen et al. 2008). When a mathematical model is available, one may predict the dynamics of an experimental system for several delay tim es by perform ing data assim ilation of experim ental data using synchronization of the m athem atical m odel to the data (C ohen et al. 2008, M arino et al. 2009, Q uinn et al. 2009, So et al. 1994, Sorrentino & Ott, 2009b). Further, it is possible to estim ate distributions for nite-time Lyapunov exponents of the system. It should be noted that given two replicas of a dynam ical system, one m ay estim ate Lyapunov exponents from transients even when one does not have a m athem atical m odel of the system.

For applications of synchronized chaotic systems to sensor networks a novel adaptive synchronization approach has been recently conceived by Sorrentino & 0 tt (2008, 2009). When the coupling channels between di usively coupled chaotic dynamical systems serving as nodes of the network are perturbed at time scales slow compared to those of the chaotic uctuations, they showed that it is possible to not only maintain synchrony between the systems. In the process of doing so, it is also possible to estimate and track the time-varying perturbations of the coupling strengths. In the illustrative case of two coupled systems, we have recently shown (R avoori et al. 2009) that this scheme can be implemented experimentally. In x6 we describe the scheme as implemented in the DSP based system described in x3, and we exam ine its electiveness in maintaining synchrony and tracking the time-dependent perturbations of the coupling channel.

In x7 we sum m arize our results and discuss future directions of research.

2. C haotic optoelectronic oscillator

Figure 1 (a) shows a diagram of the chaotic optoelectronic oscillator considered here, com posed of a laser, electrooptic intensity m odulator, photoreceiver and electrical liter, all connected together in a time-delayed feedback loop. This system was originally considered by Neyer and Voges (1986), who recognized its potential for bistability and chaos. The system was later adapted for use as a high-quality m icrow ave oscillator, by incorporating a narrow electrical bandpass liter (Yao & M aleki 1996). M ore recently, there has been renewed interest in using this architecture as a m eans for generating high-dimensional chaotic waveform s (K ouom ou et al. 2005).




Figure 1.Experimental setup and corresponding mathematical block diagram of chaotic optoelectronic oscillator.

The electrooptic m odulator is a commercially-available lithium -niobate Mach-Zehnderm odulator, identical to those commonly used in optical telecommunication system s. The input is a continuous-wave optical signal from a distributed feedback laser, which is split into two separate waveguide paths and then recombined, forming an interferom eter. A voltage applied to the modulator induces an optical phase shift

between two arm softhe interferom eter through the linear electrooptic e ect. W hen the optical signals recombine, the degree to which they interfere constructively depends on the applied voltage. The optical power emerging from the modulator is then described by (Heism ann et al. 1997):

where P_0 is the continuous-wave optical power entering the modulator, v(t) is the voltage applied to the modulator electrodes, V is the half-wave voltage', or the voltage required to produce a relative phase shift of between the arm s of the interferom eter, and $_0$ is an angle describing the bias point of the modulator. The bias point is controlled either by intentionally making one arm of the interferom – eter longer or by adding a DC o set to the applied voltage v(t). The modulators described in this work had a half-wave voltage of V = 5:7 V and were operated at a bias point of $_0 = = 4$.

The modulator converts the applied voltage v(t) into an optical intensity modulation P (t), through the nonlinearm odulation function given in equation (2.1). We note that this \cos^2 () modulation function applies to several other optical modulator structures, including liquid crystal modulators, Pockels cells (Hopfet al. 1982), and acoustooptic modulators (Valee & Delisle 1985). The same nonlinearity can also be achieved by transmitting an electrically tunable laser through an optical

Iter that has periodic spectral transm ission, such as a single-stage birefringent leter (G oedgebuer 1998) or any other single-pass interferom etric liter (B lakely et al. 2004).

The photoreceiver and transin pedance amplier produce an output voltage v_{out} (t) that is proportional to the optical power P (t),

where R is the responsivity of the photodiode (with units of A/W) and G is the net transim pedance gain of the system (with units of V/A.)

The accompanying block diagram in gure 1(b) shows an equivalent mathematical diagram of the system , including the modulator, photoreceiver, ampliers,

lter, and time-delayed feedback. To simplify the analysis, the voltage applied to the modulator is expressed in norm alized units as

and we collect all of the remaining proportionality constants into a single dimensionless factor that describes the round-trip gain of the loop,

In terms of these dimensionless variables, the feedback loop relates the liter input r(t) to the liter output x(t) by the following nonlinear transformation and time delay:

For the m easurem ents reported here, the electrical lter is a two-pole bandpass lter that is characterized by the linear transfer function

where $_{\rm L}$ and $_{\rm H}$ are the time constants describing the low pass and high-pass lters, respectively. In the time domain, a linear lter can be represented by state-space di erential equations of the form :

where r(t) is the input to the lter, x(t) is the output, u(t) is a state vector of the lter system, and A, B, C and D are matrices that describe the bandpass lter. For the two-pole bandpass lter described by equation (2.6), u(t) is a two-dimensional vector and the state space matrices can be expressed as

C om bining equations (2.7), (2.8), (2.9) and (2.5), the system can be described by the following state-space delay di erential equation

We note that if the bandpass lter is replaced by a simple low pass lter, then equation (2.10) simpli es to a scalar delay di erential equation that is equivalent to the classic Ikeda system, originally introduced to describe bistability in optical cavities (Ikeda & M atsum oto 1987).

Table 1 lists allofthe parameter values used in the experiments and simulations. To simplify the experimental implementation, we consider here a low-frequency system that operates at audio frequencies, but this system can also be scaled to RF orm icrowave frequencies (K ouom ou et al. 2005, G oedgebuer et al. 2002, C ohen et al. 2008). In practice the round-trip gain () and time delay () were measured experimentally by interrupting the fædback loop at the input to the modulator and measuring the round-trip small-signal gain and group delay using a vector network analyser. The gain was controlled by varying the optical power P₀ entering the modulator.

In gure 2 we show calculated and measured time traces of this system, for three dienent values of the feedback strength, with the time delay and Iterparameters given in Table 1. The system exhibits periodic behaviour for small values of, but the dynamics become more complex as the feedback strength is increased. Figure 3 plots the measured and simulated bifurcation diagrams with as an adjustable parameter, showing the evolution from periodic to chaotic dynamics. Peilet al. (2009) reported a detailed experimental and theoretical study of the various regimes of operation of this system. In Figure 4, we plot the calculated K aplan-Yorke dimension




Figure 2. Typical measured and calculated time traces for the nonlinear optoelectronic oscillator system, for feedback strengths of = 1.5, 3.0, and 4.5.

vs. and vs. , showing the progression from simple to high-dimensional chaotic dynamics. The Kaplan-Yorke dimension (Kaplan & Yorke 1979) was calculated from the spectrum of Lyapunov exponents, which were numerically computed by solving a linearized version of equation (2.10) (Farm er 1982).

3. D iscrete tim e im plem entation

The optoelectronic oscillator described in x2 was introduced using a continuoustime delay-di erential equation, but in practice, we implemented the system using discrete-time digital signal processing (DSP) technology. DSP provides a exible platform for program mable litering and delay operations, and o ers a number of advantages over conventional analogue liters, especially when high-speed perfor-




Figure 3.M easured and num erically simulated bifurcation diagram, with as an adjustable parameter, for the system parameters given in Table 1.




Figure 4.C alculated K aplan-Y orke (Lyapunov) dimension (a) as a function of the feedback strength for xed feedback delay = 230 s and (b) as a function of the the feedback delay , for xed = 4.5. The remaining system parameters are given in Table 1.

mance is not required. For example, it is easy to program two digital liters to have identical characteristics, whereas matching of analogue liters relies on nding identical components such as resistors, capacitors and ampliers. DSP systems are especially advantageous in synchronization experiments, where m ismatched param eters between nom inally identical systems can otherwise impair the synchrony between the two systems.

A nalogue delay lines typically use either optical bre or coaxial cables to achieve a time delay of L=v, where L is the length of the transmission medium and v is the propagation speed. Such systems cannot be scaled to large time delays because the required delay lines are either in practically long or prohibitively lossy. D SP systems, by contrast, can produce a lossless time delay that is limited only by the available mem ory and sam pling rate. The use of digital processing in nonlinear dynam ical systems dates to 1982, when H opfet al. used a computer and ADC/DAC to achieve long delay times for a similar optoelectronic oscillator. Since then, digital signal processing system s have dram atically in proved in perform ance and cost, and are now commonplace in consumer electronics.

Perhaps the most compelling argument in favor of DSP is that it allows realtime adjustment of the the gain, delay and liter coecients { parameters that are typically static in analogue liter systems. In x6, we describe an adaptive control scheme that takes advantage of this exibility provided by digital processing.




Figure 5. (a) Experim ental setup showing the use of digital signal processing hardware to im plem ent bandpass liter and delay. (b) Equivalent discrete-time m athem atical block diagram of dynam ical system.

Figure 5(a) shows how the original experimental apparatus (gure 1(a)) was adapted to incorporate digital signal processing. The system uses the same laser, electrooptic modulator and photoreceiver as its continuous-time counterpart, but the ltering and delay are performed using a digital signal processing board. The DSP board uses an analogue-to-digital converter (ADC) to sam ple and digitize the input signalr(t), forming a discrete-time input sequence,

where n is an integer and T_s denotes the sampling period. The discrete-time signal p[n] is stored in a memory bu er to produce the desired delay and then digitally

Itered. The output signal x[n] is then routed through a complementary digitalto-analogue converter (DAC) to yield the analogue output signal x(t) that drives the electrooptic modulator. The complete system is therefore a hybrid discrete / continuous-time system that retains the advantages of optical signal transmission, while exploiting the exibility of discrete-time signal processing.

The DSP board used in these experiments contains a 225 MHz oating-point DSP processor, 64 MB RAM, and a 16-bit ADC/DAC. The maximum sampling frequency was limited by the ADC/DAC chip, which was designed for audio signals. Except where noted, we used a sampling rate of $1=T_s = 96$ kS/s in these experiments, although the system could be scaled to higher frequencies by replacing the

ADC/DAC hardware. The low pass liter in the feedback loop restricts dynam ical behaviour to frequencies well below the Nyquist frequency, ensuring that the sam pling does not contribute sign cantly to the litering. Higher-perform ance eldprogram m able gate array (FPGA) boards could perform the same operations at sam pling rates as high as 1 GS/s.

Figure 5 (b) shows a mathematical block diagram of the discrete-time system. In this system, k denotes the feedback delay, which we take to be an integer num – ber of timesteps, and the dynamical liter is described by discrete di erence equations rather than di erential equations. The digital liter was designed to act as a two-pole bandpass liter that approximates the response of the continuous-time

Iter described in equations (2.6) { (2.8). The discrete-time transfer function H (z) is obtained from the continuous-time transfer function H (s) by applying a bilinear transform with frequency pre-warping (Oppenheim et al. 1999). This process yields the following equivalent discrete-time transfer function

where r[n] is the lter input, x[n] is the output, and u[n] is a two-dimensional state vector. For the lter described in equation (3.2), the state space matrices can be expressed as

The lter input is related to the lter output through a nonlinearity and delay,

where is the round-trip gain de ned in equation (2.4) and the delay is chosen to be k = 22, which, at a sampling rate of 96 kS/s, corresponds to a feedback delay of 830 s.

4. Coupled system s and synchronization

An interesting property of chaotic systems is that two systems, when properly coupled together, can synchronize with one another and evolve along the same chaotic orbit (Fujisaka & Yam ada 1983, Pecora & Carroll 1990, Pikovsky et al. 2001, B occaletti 2008). M any proposed applications of chaos, including secure com – munication systems, sensor networks, and data assimilation and prediction, rely on this phenom enon of synchronization between chaotic oscillators (K anter et al. 2008, A rgyris et al. 2005, G olubitsky et al. 2005, B occaletti et al. 2006, A renas et al. 2008). There have been some analytical studies of the coupling threshold required for synchronization in delayed-feedback systems (P yragas 1998, B unner & Just 1998). Peil et al. (2007) reported som e experimental measurements and theoretical models of synchronization between time-delayed optoelectronic oscillators like those discussed here. W e seek in the this section to more thoroughly investigate how two such systems can be coupled together, and the conditions under which they can synchronize.




Figure 6. (a) Block diagram of two linearly-coupled optoelectronic chaotic oscillators, where the coupling and delays are taken to be in the optical path connecting the two systems. (b) Equivalent system, obtained by commuting the coupling and delay with the bandpass liter. In practice, the coupling is implemented optically as in (a), but for convenience, we analyse the equivalent scenario depicted in (b).

The block diagram in gure 6 (a) shows the most general type of linear optical coupling between two systems. In this case, we imagine that the optical signal emerging from the modulator in system 1 is split and fed back into both systems. The constants $_{11}$ and $_{11}$ denote the self-feedback gain and delay for system 1, and $_{12}$ and $_{12}$ describe the coupling from system 1 ! 2.Sim ilarly, $_{22}$, and $_{22}$ are the self-feedback parameters of system 2, and $_{21}$ and $_{21}$ describe the coupling from 2 ! 1.W e assume that the bandpass liters between the two systems are identical.

The lter (H (s)), gain ($_{ij}$) and delay ($_{ij}$) are all linear, tim e-invariant operations, and they can therefore be freely permuted without changing the dynam ics of the system . Using these arguments, one can transform the optically coupled system shown in gure 6a to the equivalent system shown in gure 6b, where the coupling instead applies to the electrical signals x_j (t) emerging from the bandpass lters. This coupling con guration can be described by the following coupled delay

di erential equations:

where u_1 and u_2 are the state-vectors for the bandpass liters in oscillators 1 and 2, respectively.

To understand the conditions under which synchrony can occur, we begin by assuming that a synchronous solution exists,

where we have allowed for lag synchrony with a time delay $_0$. Upon substituting this assumption into equations (4.1) and (4.2), we obtain self-consistent dynam ical equations for u (t) only under the following conditions:

W hile these conditions are necessary for a synchronous solution to exist, they do not guarantee the stability of this solution.

We now further restrict our attention to cases in which the system s synchronize in a state that obeys the same dynam ical equation as that of an uncoupled, isolated system described by parameters , and $_0$. This lifts the constraint that $_{11} = _{22}$ and $_{12} = _{21}$, but in poses the following additional conditions for synchrony:

In this scenario, which is term ed di usive coupling', the constraint on the coupling conditions (equation (4.5)) can be cast in terms of two dimensionless parameters $_1$ and $_2$, de ned through the relations

W ith this de nition, $(1 \ _1)$ and $\ _1$ describe relative proportions of self-feedback vs. cross-coupled feedback, respectively, entering system 1, and $\ _2$ has a similar interpretation for system 2.




Figure 7.B lock diagram of two di usively-coupled oscillators. The coupling is constructed in a way that guarantees that the resulting system admits a synchronous solution of the form x_1 (t) = x_2 (t) x (t) where x (t) exhibits the same dynam ical behaviour as that of an isolated system.

Figure 7 presents the block diagram of two di usively-coupled oscillators. In order to make the equations comparable in form to the single-oscillator system described in x2, we have factored out a common scale factor from all four of the coupling terms and commuted this scale factor with the bandpass liter H (s).

The diusively coupled oscillator system shown in gure 7 is described by the following coupled equations

These equations can be seen to adm it an isochronally synchronized solution that, when synchronized, satis as the same equation (2.10) given earlier for an isolated system.

To investigate the stability of the synchronized solution, we perform following change of variables

where the di erence u (t) is expected to converge to zero for a stable synchronous solution. Expressing equations (4.11) and (4.12) in term s of the u , and linearizing about the synchronous state, we nd

C om paring equations (4.14) and (2.10), we see that u_+ (t) satisfies the same dynamical equation as isolated system, as expected. The two coupling parameters appear in the second equation only in the combination (1 + 2). We therefore conclude that for a given , and 0, the stability of the synchronous solution depends only on the sum (1 + 2), but not on the values of 1 and 2 individually. Furthermore, in the special case that 1 + 2 = 1, equation (4.15) simplifies to

Because the linear bandpass liter is stable (i.e., A has negative eigenvalues) the di erence vector u (t) will always converge to zero according to the liter time-constants $_{\rm L}$ and $_{\rm H}$ whenever $_1 + _2 = 1$.




Figure 8.M easured and simulated normalized synchronization error as a function of for = 6 and = 8. The measurements and simulations were conducted using symmetric bidirectional coupling, ($_1 = _2$).

Figure 8 plots the m easured and simulated normalized root-mean square (RMS) synchronization error as a function of the coupling strength for the case of bidirectional symmetric coupling, i.e., 1 = 2, showing the regimes in which the

two systems synchronize.We de ne the normalized synchronization error as

$$\frac{(x_1(t) \quad x_2(t))^2}{hx_1^2(t) + x_2^2(t)i}; \qquad (4.17)$$

where h i indicates a time average. The norm alized error $_{\rm x}$ is zero in the case of a synchronized solution, but approaches 1 in the limit that the two signals are identically distributed, but uncorrelated. W hile the experimental measurements and simulations were performed by taking $_1 = _2$, the results can be generalized to other combinations of $_1$ and $_2$ because the synchronization condition depends only on the sum $_1 + _2$.

As indicated in gure 8, the two systems synchronize unconditionally for the special case that $_1 + _2 = 1$, and they synchronize for a range of ($_1 + _2$) centered symmetrically about this point. The range of values over which the system synchronize is found to depend on the feedback gain . In general, we observed that the higher values of (and higher Lyapunov dimension) yield a narrower synchronization regime.

5. Synchronization { Transient dynam ics

In addition to know ing whether two systems synchronize, it is also in portant to understand the rate at which they converge to a synchronous state, which is quantiled by the transverse Lyapunov exponent (Fujisaka & Yam ada 1983, Pecora & Carroll 1998). The transverse Lyapunov exponent (TLE), denoted $_{\rm T}$, denotes the average exponential rate at which a pair of coupled identical oscillators converge or diverge in phase space. A negative TLE corresponds to converging trajectories, indicating

stable synchronization, while a positive exponent indicates diverging trajectories that do not synchronize.

The TLE de nes an important timescale in applications such as chaotic communication and sensor networks that rely on synchronization. In chaotic sensor networks with time-varying coupling, the TLE limits the speed of perturbations that the system can track. In a chaotic communication system, the TLE limits the attainable bit-rate that can be successfully decoded.

Equally important is the (positive) maximal Lyapunov exponent, which describes the rate at which initially synchronous solutions diverge from one another when they are decoupled. This divergence rate is important in data assimilation and prediction applications, which use synchronization to predict the future behaviour of a dynamical system. Here we present a numerical and experimental study of the transient synchronization and desynchronization dynamics of two coupled chaotic optoelectronic oscillators.

O nem ethod to determ ine the transverse Lyapunov exponent is to suddenly couple two independent and identical chaotic oscillators. By analysing the transition from the initially uncorrelated dynam ics to a synchronous state, we can determ ine the (nite time) transverse Lyapunov exponent of the system. Conversely, if the two systems are initially synchronized, the coupling can be suddenly turned o , allow ing the trajectories to exponentially diverge. By measuring the rate of exponential divergence, we nd the maximal Lyapunov exponent of the system (Cohen et al. 2008). Unlike conventional methods, which require numerical solution of a linearized system of equations, this approach can be applied even in cases when an exact model of the physical system is unavailable or im practical. As long as two experimental systems can be made to synchronize, the Lyapunov exponents describing synchronization and desynchronization can be determined from transient tim e-series analysis.

This method of determining the Lyapunov exponent is illustrated in Figure 9, which shows the exponential convergence and divergence of two coupled chaotic optoelectronic oscillators. In qure 9(a)-(b), the two oscillators were initially uncoupled for t < 0, but the coupling was suddenly enabled at t = 0. Speci cally, for t > 0 the systems were bidirectionally coupled as shown in gure 7 with = 0:4375. Figure 9(a) plots the measured outputs x_1 (t) and x_2 (t) 1 = 2 for one representative case, showing the transition from uncorrelated to synchronized dynam ics. Figure 9 (b) shows the absolute di erence $\dot{\mathbf{x}}_1$ (t) \mathbf{x}_2 (t) $\dot{\mathbf{j}}$ sm oothed with a 100 soliding window average, and plotted on sem ilogarithm ic axes to clearly show the exponential convergence. By tting an exponential relation to this curve, we determ ine the (negative) transverse Lyapunov exponent. Figure 9(c)-(d) show sim ilar data obtained when two initially synchronized systems are decoupled at t = 0, allowing them to exponentially diverge. In this case, the (positive) maximum Lyapunov exponent 1 is similarly determined by nding the best-tted slope to the sm oothed logarithm ic di erence between the two traces.

W hen determ ining the Lyapunov exponent using this method, the exponential convergence or divergence is estim ated only over a nite tting interval T. In practice, the allowable tting interval is restricted by the synchronization error oor, which is caused by noise and m ism atches between the two systems (Shahverdiev et al. 2005). In num erical simulations, the convergence/divergence can be observed over many orders of magnitude, and we can therefore t the exponential relation




Figure 9. (a) Experimentally measured time series showing synchronization of two coupled chaotic oscillators. The two systems were uncoupled for t < 0 and symmetric bidirection coupling was abruptly enabled at t = 0. (b) Measured absolute dimense jx_1 (t) x_2 (t) j plotted on a logarithm ic scale, and smoothed to show exponential convergence of trajectories. By thing a line to this slope, one can estimate the nite-time transverse Lyapunov exponent $_T$, which characterizes the timescale over which synchronization occurs. (c) Experimentally measured time series showing divergence of two initially synchronized systems, when the coupling is disabled at t = 0. (d) The nite-time maximal Lyapunov exponent $_1$ is estimated by measuring the average exponential divergence rate.

over a larger tim e window T. If the tting window is long enough to span the entire chaotic attractor, this calculation reveals the 'global' or 'asym ptotic' Lyapunov exponent. For a short tting interval, the trajectory remains only in a localized portion of the chaotic attractor, and thus we obtain only a 'local' Lyaponov exponent. The local Lyapunov exponents vary about an attractor, and their statistical distribution depends upon the dynam ical nature of the coupled system .

In gure 10, we show distributions of localLyapunov exponents for three choices of tting time T for 10^5 simulated time-series. The histogram s labeled (a) show the distribution of transverse local Lyapunov exponents, obtained by simulating two initially independent system s that are suddenly coupled togetherw ith $_1 = _2 = 0.4$ at t = 0. The histogram s labeled (b) histogram s show the distribution of maximum Lyapunov exponents, obtained by simulating two initially synchronized system s that are suddenly to initially synchronized system s that are suddenly coupled togetherw if $_1 = _2 = 0.4$ at t = 0. The histogram s labeled (b) histogram s show the distribution of maximum Lyapunov exponents, obtained by simulating two initially synchronized system s that are suddenly released at t = 0. In all cases, the histogram is G aussian near its peak and has non-G aussian tails. The mean of each distribution converges to the global or average (transverse) Lyapunov exponent , and the standard deviation




Figure 10. Histogram showing the distribution of nite-time transverse Lyapunov exponents, measured over time intervals of 2, 4, and 8 m s. The transverse and maximal Lyapunov exponents were determ ined by numerically simulating the coupled system and tting the convergence or diverence to an exponential relation, as depicted in gure 9(b) and (d).

narrows in proportion to T $^{1=2},$ as expected (Prasad & Ram aswam y 1999, Ott 1993).

W hen a m athem aticalm odelof the system is available, the transverse Lyapunov exponents can also be calculated using the master stability function technique (Fujisaka & Yam ada 1983, Pecora & Carroll 1998); i.e., by linearization about the synchronized chaotic solution. Figure 11 com pares the distribution of local transverse Lyapunov exponents obtained using both m ethods. In gure 11 (a) we plot (in grayscale) the distribution of local transverse Lyapunov exponents as a function of the coupling strength (= $_1 = _2$). These histogram s were obtained using tim e-series analysis to estim ate the exponential convergence, as illustrated in gure 9(b). Because the time traces were initially uncorrelated, this method only applies when the TLE is negative, corresponding to convergent time series. As anticipated from equation (4.15), the system's converge unconditionally when 1 = 2 = 0.5. Figure 11(b) plots the same distribution of TLEs, obtained by num erically solving the linearized system of equations. Here, the linearized equations are sensitive to both positive and negative phase space grow th, so the distributions can go above zero. A part from this expected di erence, the correspondence between these two methods is remarkably good.

In gure 11 (c), we plot the transverse Lyapunov exponents obtained from experim entally measured converging time-series of coupled systems. At each value of , we measured the convergence rates $_{\rm T}$ for 100 pairs of time-series. The mean $_{\rm T}$ and standard deviation obtained by thing the data to a Gaussian distribution are shown as the dots and bars on the gure respectively. For comparison, the line indicates the 'global' TLE computed using the linearized system of equations. The




Figure 11.D istribution of transverse Lyapunov exponents as a function of the coupling strength , determ ined (a) by time-series analysis of converging transients and (b) by directly solving the linearized transverse equations of the coupled system . (c) C om parison of calculated global transverse Lyapunov exponent and the m easured nite-time transverse Lyapunov exponent, determ ined by m easuring the transient convergence. The data points and error bars indicate the average and standard deviation of the m easured statistical distribution of $_{\rm T}$, using a nite tting time of 4 m s.


experim ental data agree well with the num erical simulations, which dem onstrates that time series analysis of converging experim ental signals is a powerful technique for quantifying the transverse Lyapunov exponents of a system, even if a num erical m odel were unavailable.

6. A daptive synchronization

A s shown in x5, synchronization can depend on the coupling between oscillators. In a practical network consisting of spatially separated chaotic oscillators, time-varying environmental conditions can cause the coupling to vary unpredictably. Then, in order to maintain synchronization it is essential to dynamically compensate for these variations. Recently, several algorithm shave been developed to maintain or produce synchrony in a network of chaotic oscillators (Zhou & Kurths 2006, Ito & Kaneko 2001, De Lellis 2008, Feki 2003). Somentino & Ott (2008, 2009) proposed and simulated an adaptive algorithm to estimate and track a priori unknown coupling changes in a network of chaotic oscillators. The estimate is then used to compensate for the environmental perturbations thereby ensuring synchrony. In this section, we present an experimental demonstration of this scheme using a pair of nonlinear timedelayed optoelectronic feedback loops described in x2. A D SP board, incorporated as part of the feedback loop (see gure 5), enables us to perform real time computations allow ing the implementation of the adaptive tracking algorithm.

In our experimental setup, shown in gure 12 (a), we consider two optoelectronic feedback loops that are unidirectionally coupled through a time-varying communication channel, which is described by a coupling factor (t). An adaptive control scheme is implemented in the receiver in order to maintain synchrony between the two systems and, in the process, determine an estimate of the channel condition.

Figure 12(b) shows an equivalent discrete time mathematical block diagram of the two unidirectionally coupled systems with a time-varying channel. Here we de-






Figure 12. (a) Experimental setup of unidirectionally coupled feedback loops, in which the coupling factor is allowed to vary slow ly, to simulate the elect of an atmospheric perturbation or environmental disturbance. (b) Equivalent discrete-time block diagram of two oscillators, unidirectionally coupled over a time-varying channel. The receiver has no prior knowledge of [n], and must therefore form an estimate, denoted [n] in order to keep the two systems sychronized.

note the channel coupling by [n]. The receiving system has no a priori know ledge of [n] and must therefore form an estimate, denoted [n], in order to maintain isochronal synchrony. As before, the discrete time bandpass liters H (z) are gov-

erned by the state-space equations

where $r_i[n]$; (i = 1;2) are the lter inputs, $x_i[n]$ are the corresponding lter outputs, and A, B, C and D describe the bandpass lter. The lter outputs are fed back to the inputs through a nonlinearity and time delay according to

where [n] is the local estim ate of the channel coupling.

O ne can clearly see that these equations adm it a synchronous solution in the case that [n] = [n], i.e., provided the receiver tracks the coupling strength [n]. The analysis presented in x4 showed that for static coupling, i.e., when [n] = [n], the synchronous solution is stable over a continuous range of values of . This result suggests that if [n] varies slow by, while remaining within the bounds required for synchrony stability, the system s could stay synchronized as long as the receiver is able to track the variation with su cient accuracy. We emphasize that the receiver does not have direct know ledge of [n] but only receives the product $[n]k_1[n]$, as shown in gure 12(b).

Somethino & Ott (2008, 2009) prescribed a strategy in which the local factor [n] is adjusted in a way that m inim izes the average synchronization error. This yields the following estimate [n],

where h $\frac{1}{L_{PF}}$ denotes an exponentially-weighted moving average, which is equivalent to a discrete-time low-pass lter. This averaging process can be implemented with the following discrete-time iterative equations:

where the forgetting factor z_0 is the pole of the discrete-time low-pass liter. The time-window overwhich the averaging is performed is approximately $T_s (1 z_0)^{-1}$, where T_s is the sampling period. We note that, as required, the adaptive scheme described by equation (6.5) relies only on the product $[n]x_1[n]$ and $x_2[n]$ to form the estimate [n]. In a high-speed application, the low pass liter could easily be implemented using an electrical mixer in place of discrete-time averaging liter.

We experimentally demonstrated the adaptive synchronization scheme using a pair of coupled nonlinear optoelectronic oscillators, as shown in gure 12(a). For these experiments, the bandpass liters were adjusted to have a passband of 100 Hz { 2.5 kHz, the DSP sampling frequency was reduced to 24 kS/s, and the time delay was measured to be k = 36 timesteps, or 1.5 ms. We chose a feedback strength of = 3:58, which, under these conditions, was found to yield robust

chaotic behaviour. The low pass liter used in the adaptive synchronization rule was implemented with a forgetting factor of $z_0 = 0.95$, which corresponds to a liter response time of 208 s.




Figure 13. (a) M easured and (b) simulated response of adaptive coupling system to a sudden change in . In these experiments, the coupling strength was changed abruptly from 0.80 to 1.13 at t = 0. The adaptive synchronization scheme automatically adjusts in response to this variation. Here we plot both the tracking signal (t) and the difference x_1 (t) x_2 (t), showing the initial loss of synchrony followed by recovery.

Figure 13 presents experimental measurements and numerical simulations showing how both the synchronization error and tracking signal [n] respond to an abrupt change in the coupling from = 0.8 to = 1.13. For t < 0 the coupling strength was held constant at = 0.80.0 under these conditions the receiver form s the correct estimate = 0.8, which gives a small synchronization error. Att = 0 the coupling strength was switched abruptly to = 1.13, which causes the two loops to brie y lose synchrony. However, the receiver adaptively readjusts the parameter

to track [n] and the synchrony is regained. The numerical simulations shown in gure 13 (c) and (d) exhibit similar behaviour. The response time of the adaptive synchronization method was found to be limited primarily by the exponentially-weighted moving average liter. In a separate work we studied the ability of this adaptive scheme to track sinusoidal variations in coupling, and we quantied the limitations on the magnitude and frequency of the perturbation that can be tracked (R avooriet al. 2009).

7. Conclusion

M any potential applications such as secure communication, sensor networks, spreadspectrum communication, chaotic radars and random number generators could bene t from a nonlinear dynamical system that is simple to model, easy to implement, and capable of generating robust, high-dimensional, chaotic waveforms. This paper presents a comprehensive analysis and characterization of a nonlinear optoelectronic feedback system that meets these criteria. The system uses electrooptic modulation and optical transmission, and it can therefore take advantage of the vast array of low-cost, high-speed, widely available components originally developed for breoptic communication networks. We describe a new approach in which the delayed electrical feedback and litering is implemented using real-time digital signal processing. This greatly facilitates matching of liter characteristics between system s, and also allows for real-time control and adjustment of the feedback parameters { something that could not be easily accomplished with traditional analogue signal processing.

B ecause m ost of the aforem entioned applications of chaotic signals require synchronization between two or m ore system s, we explore the conditions under which coupled system will synchronize. We present a new technique to experim entally quantify the rate of convergence when two systems are coupled and the rate of divergence when they are released. Finally, we demonstrate an adaptive technique that autom atically m aintains synchronization between coupled systems, in the presence of an unknown and tim e-varying coupling between the two.
