The Konkoly B lazhko Survey: Is light-curve m odulation a common property of R R ab stars?²

ABSTRACT

A system atic survey to establish the true incidence rate of the Blazhko m odulation am ong short-period, fundam ental-m ode, G alactic eld RR Lyrae stars has been accomplished. The Konkoly Blazhko Survey (KBS) was initiated in 2004. Since then m ore than 750 nights of observation have been devoted to this project. A sam ple of 30 RR ab stars was extensively observed, and light-curve modulation was detected in 14 cases. The 47% occurrence rate of the modulation is much larger than any previous estimate. The signi cant increase of the detected incidence rate is mostly due to the discovery of sm all-am plitude m odulation. Half of the B lazhko variables in our sam ple show modulation with so small amplitude that de nitely have been missed in the previous surveys. We have found that the modulation can be very unstable in some cases, e.g. RY Com showed regular modulation only during one part of the observations while during two seasons it had stable light curve with abrupt, sm all changes in the pulsation am plitude. This type of light-curve variability is also hard to detect in other Survey's data. The larger frequency of the light-curve m odulation of RR ab stars makes it even more important to nd the still lacking explanation of the B lazhko phenom enon.

The validity of the $[Fe/H](P;'_{31})$ relation using the mean light curves of B lazhko variables is checked in our sample. We have found that the formula gives accurate result for small-modulation-amplitude B lazhko stars, and this is also the case for large-modulation-amplitude stars if the light curve has complete phase coverage. How ever, if the data of large-modulation-amplitude B lazhko stars are not extended enough (e.g. less than 500 data points from less than 15 nights), the formula may give false result due to the distorted shape of the mean light curve used.

1 IN TRODUCTION

The light-curve m odulation of R R Lyrae stars, the so called B lazhko e ect, is a hundred-year-old puzzle of stellar pulsation. The Fourier spectra of the light curves of B lazhko variables are characterized by m odulation frequency series appearing in the vicinity of the pulsation frequency (f_0) and

its harm onic frequencies $(kf_0; k > 1)$. B ased on the location and number of the independent m odulation frequency com – ponents som e attem pts have been m ade to introduce di erent subtypes of the m odulation ($_1$, $_2$, BL1, BL2, BL2x2, etc. A lock et al. (2003); M oskalik & Poretti (2003)), these classi cation schemes, however, do not indeed help to disclose the unknown triggering m echanism of the m odulation, which is m ost probably com m on in each B lazhko star. B oth observational and theoretical e orts are still needed to understand the m odulation of RR Lyrae stars. Though the

incidence rate of the m odulation was estim ated to be about 25-30% based on visual, photographic and photoelectric observations of G alactic eld and globular cluster variables (Sm ith 1981, 1995; Szeidl 1988), in a sum m ary paper on RR Lyrae stars P reston (1964) w rote: "There is no sharp distinction between singly and multiply periodic variables. W hen observed with su cient precision or for long enough intervals of tim e, allRR Lyrae m ay be or m ay becom e m ultiply periodic" { quoting B alazs-D etre & D etre (1962).

More recently, the large CCD surveys e.g. MACHO (A loock et al. 2003) and OGLE (Moskalik & Poretti 2003; M izerski 2003; Soszynski et al. 2003; Collinge et al. 2006) found a similar or even smaller fraction of variables exhibiting light-curve modulation than determ ined by photographic and photoelectric observations. The incidence rates of the modulation in the Large Magellanic Cloud (LMC) and in the Galactic bulge were estimated to be 12-15% and 23-27% , respectively. These statistics on B lazhko variables m ay, how ever, be biased due to the lim its of the photom etric accuracy and/or the de ciencies in data sam pling. O bservation in longer wavelength band, where the amplitude of the m odalation signal is small, may also reduce the detection rate of the modulation. The incidence rates determined so far are only lower lim its for the occurrence of the modulation according to Collinge et al. (2006). The metal de ciency of the variables was suggested to explain the small fraction of Blazhko stars in the LMC, but Smolec (2005) could not detect any signi cant di erence between the metallicities of RR Lyrae stars in the LMC and in the Galactic bulge.

H ipparcos (ESA 1997), NSVS (W ozniak et al. 2004), and ASAS (Pojm anski2005) data bases also provide a large num ber of RR Lyrae observations but these data are not suitable to estim ate the true percentage of variables showing light-curvem odulation.Based on the NSVS and ASAS data, W ils et al. (2006) and Szczygiel & Fabrycky (2007) found m odulations in an unrealistically sm all fraction, about 5% of RR ab stars, RR Lyrae variables pulsating in the fundam ental m ode, also designated as RRO stars. M any of the w ell-known B lazhko variables have not even been detected to show light-curvem odulation in the H ipparcos, NSVS and ASAS data.

No system atic survey that aim ed to determ ine the frequency of light-curvem odulation of R R ab stars in the G alactic eld has been perform ed previously. These variables are bright enough to obtain accurate light curves even with sm all telescopes. E arlier photom etric program s concerning eld R R ab stars focused on either the light-curve variations of known B lazhko variables or the multicolour light curves of large sam ples of variables (e.g. Sturch 1966; F itch et al. 1966; B ookm eyer et al. 1977; Lub 1977; Schm idt & R eisw ig 1993) in order to determ ine their physical param eters (tem perature, m etallicity, reddening, etc.). Though these latter studies covered a large fraction of the brighter G alactic eld variables, the tim e span, data num ber, phase coverage, and photom etric accuracy of the m easurem ents were

not suitable to detect long-period and/or sm all-am plitude light-curve variations.

The knowledge of the true incidence rate of Blazhko stars has a great importance in nding the correct explanation of the phenomenon, as it shows how common the circum stances that favour the appearance of the modulation are. Exploiting the potential of our full access to an autom ated photom etric telescope, we initiated a system atic study of RRab stars to get an estim ate of the incidence rate of the modulation. Though our survey concerns a much more limited sample of variables than were measured in the MACHO and OGLE projects, the photom etric accuracy and the denseness of our data sampling allow us to detect the occurrence of light-curve modulation more reliably than in those surveys. The main results concerning the incidence rate of the modulation of the Konkoly Blazhko Survey are sum marized in the present paper.

R esults for variables with unstable light curves observed in the KBS that do not have data suitable to discuss in separate papers (RY Com, BD Her and FK Vul) are also published here.

C om paring the photom etric and spectroscopic m etallicities of B lazhko RR ab stars of the KBS sample we also draw some conclusions on the correctness of the photom etric m etallicity (Jurcsik & K ovacs 1996) derived from the mean light curves of B lazhko variables.

2 OBSERVATIONS AND TARGET SELECTION

The observations of the KBS began in 2004 using an autom ated 60 cm telescope (Budapest, Svabheqy) equipped with a W right Instrum ents 750x1100 CCD cam era (FoV 17'x24') and standard BVR $_{\rm C}$ I $_{\rm C}$ $\,$ lters. D at awere corrected for atm ospheric extinction and were transform ed to the standard BVR_CI_C photom etric system . We obtained accurate, extended, multicolour light curves of fundam ental-m ode RR Lyrae stars with pulsation periods shorter than half a day. About 4000 hours of measurements were gathered for 30 variables on 750 nights during the past ve years. Each variable was observed at least as long as it could be undoubtedly decided whether the light curve was stable on about 20-100 days tim e base or it was modulated. The typical accuracy of the observations was about 5-20mm ag, depending mainly on the brightness of the object and on weather conditions. The apparent maximum V brightness of the observed variables was in the 10.5-13.5 m ag range. The accuracy, extension, and denseness of the data enabled us to detect light-curve m odulations with sm all m axim um brightness variations (som e hundredths of a m agnitude), i.e., with Fourier amplitudes of the modulation frequency components in the m m ag regim e.D ata are utilized twofold; accurate m ulticolour light curves of monoperiodic RRab stars and detailed analyses of individual B lazhko variables have already been and are going to be published.

W hen selecting stars to observe, special care was taken to choose variables with good com parison stars (close to the variable in projected distance, brightness, and colour) in order to gain the possible m ost accurate photom etry with our instrum ent. M agnitude di erences of the variable relative to a single com parison star were determ ined and analyzed for m ost of the stars. The constancy of the com parison stars were veri ed by m easuring several relatively bright stars in the ekls. D etails for the constancy of the com parison stars are given in the papers discussing the light curve variability of the individual objects (see e.g., Fig. 7 in Jurcsik et al. 2008c). The ensemble m ean brightnesses of ve, three and two neighbouring stars were calculated, and used as com parison stars' m agnitudes for U Z U M a, SS C nc and D M C yg, respectively.W e applied the Im age Subtraction M ethod (ISIS; A lard 2003) for the photom etry of CZ Lac in order to elim - inate the additional light of its close companion.

W e have observed only short-period RR ab stars (P < 0.5 days) to have a sam ple with som ewhat hom ogeneous physical param eters, as m ost of the physical properties of RR ab stars relate, to som e degree, to the period of the pulsation. The con nem ent of our survey to short-period variables also m ade the observation e ective, it assured to reach a good coverage of the entire possible sam ple within a few years of observations. No star with declination below 5 was selected to be observed in order to obtain extended data sets.

The philosophy of the target selection was to choose variables with poor quality photom etric observations available and to clear up som e questionable cases. W e endeavoured to obtain the possible most una ected sample in order to get an unbiased estimate of the incidence rate of the modulation. None of the observed stars was de nitely known to show Blazhko modulation previously. In three cases (RR Gem, MW Lyr, and DM Cyg) light-curve modulation was announced based on photographic or visual observations, but these results were in con ict with further observations and/or the reanalysis of the original data could not con m the formerly detected modulation (Sodor & Jurcsik 2005; Sodor et al. 2007b). Our observations revealed that these stars do indeed show light-curve m odulation, but with signi cantly di erent m odulation period, am plitude, and type (am plitude or phase m odulation) than that was found previously.RY Com was suspected to show Blazhko modulation (Jurcsik & Kovacs 1996), however, the scatter around m in im um brightness shown by the available observations (Jones 1966; Bookm eyer et al. 1977) m ight have arisen from photom etric inaccuracy. Four of the targets (TZAur, SSCnc, RRGem, and FHVul) were used by Jurcsik & K ovacs (1996) to calibrate the m etallicity versus light-curve param eters' relation assum ing that their light curves were stable. Our accurate m easurem ents show that, in fact, two of these stars, SS Cnc and RR Gem are Blazhko variables.

The 30 RR ab stars for which extended photom etric data were obtained in the K onkoly Survey comprise about 60% and 80% of the possible targets of the N orthern H em isphere sum m er and w inter seasons' RR ab stars m atching our selection critetia.

3 THE KONKOLY BLAZHKO SURVEY

A bout half of the 30 observed R R ab stars (14 variables, 47%) were found to exhibit light-curvem odulation. This is a much larger percentage than was given by any previous estimate. N one of the discovered B lazhko variables could have been undoubtedly identied to show light-curvem odulation from the H ipparcos, N SV S, A SA S or any other previous photom – etry. A s examples, our observations are compared to the published light curves for two R R Lyrae stars discovered to show B lazhko m odulation in our survey in Figs. 1 and 2.

AQ Lyrae, one of the stars measured in the survey, was previously supposed to have stable light curve. Castellanietal. (1998) observed AQ Lyron six consecutive nights in 1995 and found no light-curve modulation. The

earlier photoelectric observations of Sturch (1966) m atched the CCD light curve observed by Castellani et al. (1998) within the lim its of the photom etric accuracy. Our extended data have reveled, how ever, that in fact AQ Lyr shows largeam plitude m odulation. A lthough the variation in its m axim um V brightness is 0:3 m ag, its light curve does not change signi cantly on a few days time base due to the 65 days length of its B lazhko period. In Fig. 1 our V light curve of AQ Lyr is com pared to the previous observations.

In Fig. 2 the K onkoly photom etry is com pared with the A SA S-3 and N SV S light curves of U Z V ir. The K onkoly light curve shows about 0.3 m ag variation in m axim um brightness, and corresponding to the $P_{B1} = 68$ d period of the m odulation m any triplet com ponents can be identi ed w ith 0.015 cd¹ (cycle per day) separation from the pulsation com ponents in the prew hitened spectrum .D espite its strong maximum brightness variation, UZ V ir has not been found to be a Blazhko variable either from the ASAS or the NSVS data. These data show scattered light curves and very high noise level of the residual spectra. A lthough the f_0 fm m odulation side-frequency appears in the residual spectrum of the ASAS data, this is not the largest am plitude frequency and there is no other signal in the residual spectrum with the same separation from any of the other pulsation com ponents.

Table 1 sum m arizes the observations and the results of the 30 R R ab stars m easured in the K onkoly B lazhko Survey. The identi cation of the com parison stars are given in the

second colum n.The third, fourth, and ffh colum ns list the lters, the num ber of nights, and the tim e interval of the observations, respectively.P revious photom etric light-curve inform ation on the targets are given in the 'light-curve history' colum n.Pulsation periods are taken either from the GCVS (K holopov et al. 1985) or from our works (6th, 7th colum ns in Table 1).The references given in the last colum n give inform ation on the access to the K onkoly photom etric ${\rm data\,}^2$

The basic parameters of the modulation of the 14 Blazhko stars discovered in the Konkoly Blazhko Survey are listed in Table 2. The modulation periods and amplitudes were determined from our observations. The modula-

tion am plitudes listed in Table 2 give di erent m easures of the strength of the m odulation. The full am plitude of the m axim um -light variation (A (V)_{m ax}) and the Fourier am - plitude of the largest m odulation peak in V band (A (V)) are listed. To be comparable with the OG LE-II results, the last column gives the I_c amplitude of the highest m odulation peak in the vicinity of the main pulsation frequency (A (I_c)). This frequency is not always identical with the largest-amplitude m odulation-frequency component, as our sample shows that the highest-amplitude m odulation com - ponent appears in the vicinity of the rst or second harm onic components of the pulsation ($2f_0$, and $3f_0$) in about the half of the B lazhko variables.

The observations of the 16 m onoperiodic RR ab stars of the sample were published by Jurcsik et al. (2006a, 2008a,b); K un et al. (2008), and Sodor et al. (2007a). These stars were observed on 8-26 nights, spanning 19-443 days tim e intervals. W ithin the lim its of our observational accu-

racy the light curves of these stars were stable. How ever, we cannot exclude the possibility that these stars m ay also show short-or long-period "micro-modulation" with 1-2 mmag am plitude of the modulation side frequencies, which is below our detectability lim it. A coording to the com pilation of B lazhko stars by Sm ith (1995) about half of the short-period B lazhko stars have m odulation periods longer than 50 days. Therefore, it cannot be excluded either that some of the stars claim ed here to be m on operiodic m ay have long m odulation periods, longer than 3-4 tim es the tim e interval of the observations. M oreover, there is a third possibility for the non-detection of the modulation of these stars, namely the tem poralbehaviour of the modulation as shown for RR G em by Sodor et al. (2007b) and for RY Com in the next section of this paper. These stars can be regarded as monoperiodic only with these restrictions in m ind.

Detailed analyses of RR G em , SS C nc, and DM C yg, three B lazhko variables show ing sm all-am plitude light-curve

m odulation that was not detected previously were published by Jurcsik et al. (2005a, 2006b, 2009b). The doubly periodic m odulation of UZ UM a was shown by Sodor et al. (2006), while the rst really detailed analysis of the light curve and colour behaviour of a large-m odulation-am plitude B lazhko variable, MW Lyrae, was presented by Jurcsik et al. (2008c, 2009a). The observations of AQ Lyr, V 759 Cyg, BR Tau, XY And, CZ Lac and UZ V ir are extended enough to perform detailed analyses of their B lazhko behaviour, which will be the subjects of further separate papers. R esults for the rem aining three m odulated stars, RY Com, FK Vul, and BD Her are presented in this paper.

Only the half of the new B lazhko variables (XY And, BD Her, CZ Lac, AQ Lyr, MW Lyr, UZ V ir, and FK Vul) have m odulation am plitudes large enough to be detectable with less accurate and/or less extended observations. N evertheless, even though the variation in m axim um V brightness is larger than 0.15 m ag and the largest-am plitude m odulation-frequency component has an am plitude larger than 0.02 m ag for these stars, they were not detected to show B lazhko m odulation in the H ipparcos, A SA S and N SV S data.

Based on the maximum timings collected in the GEOS data base³ and our observations, we have found that there is no indication for any strong, irregular period change in any of the mono-periodic RR ab stars in the sam ple.UU Boo, SW CVn and probably EZ Cep show steady period increase, while the period of FH Vulis probably decreasing. The periods of the other 12 m ono-periodic RR ab stars are stable with very sm all if any changes detected.On the contrary, strong,

irregular changes are evident in some of the B lazhko stars (e.g., AQ Lyr, RR G em, BD H er, V 759 Cyg). We thus conclude that the pulsation periods of B lazhko variables tend to be less stable than the periods of unm odulated RR ab stars. A sim ilar result was derived from the study of the period changes of RR Lyrae stars in M 3 by Szeidl (1965).

3.1 The special case of RY Com

W e followed the light-curve variation of RY Com in three consecutive seasons, in 2007, 2008 and 2009.

The Konkoly light curve of RY Com between JD 2454205 and 2454283 (2007 season) is compared with the available photoelectric (Jones 1966; Bookm eyer et al. 1977) and CCD (NSVS, ASAS) observations in Fig. 3. The scatter of these latter measurem ents is much larger than the amplitude of the detected light-curve variation in the Konkoly observations. The residual spectra of the four data sets show di erent characteristics, after prewhitening the data for the mean pulsation light curves. The highest peaks in the residual spectrum of the Konkoly data are modulation frequency components at $f_0 = f_m (f_m = 0.03 \text{ cd}^{-1})$ with small,

0:01 m ag am plitudes, whereas the residual spectra of the ASAS, NSVS and the old photoelectric data show peaks higher than 0.04 m ag at di erent frequencies. Peaks close to integer frequencies dom inate the spectra of the old photoelectric and the NSVS data, indicating long-term trends in the observations, while the residual spectrum of the 4-year long ASAS data shows multiple peaks in the close vicinity of the pulsation frequency com ponents. This is a typical feature if the pulsation period is changing during the time base of the observations. In the ASAS data this is indeed the case, the pulsation period of the variable was 0.00001 d longer during the rst 2 years of the ASAS observations than during the second part of the data. Any light-curve m odulation of RY C om was de nitely hidden in the noise and other biases in all the previous observations.

Hoping to re ne the modulation properties of RY Com, we continued its observation in 2008. However, in this season we could not nd any sign of a regular modulation, instead, the maximum brightness of the pulsation light curve dropped by about 0.08 mag in a very short period (about a week) at around JD 2 454 530. Though the scatter of the phased light curves before and after JD 2 454 530 was larger than typical for our observations especially around m in im um light, we could not nd any de nite modulation period in the data. The star behaved sim larly in 2009, a sudden jump was detected again in maximum brightness in this season, too, at around JD 2 454 905, and no clear modulation was evident. The observed light-curve variations were consistent in the B ;V;I_c bands in each season. In Fig. 4 the light curve history of RY Com between 2007 and 2009 is documented.

Fig. 5 shows the O C variation of RY C om based on archive data collected in the GEOS data base and on our recent observations. The plots indicate that the pulsation period of RY C om varies irregularly, showing both abrupt and continuous changes. D uring the K onkoly observations a period increase of 0.00007 d occurred. Unfortunately, it cannot be resolved from our data whether the period change occurred abruptly at around the drop of maximum brightness (JD 2 454 530) or it was continuous.

RY Com is the second star in our sample with tem -

porarily occurring m odulation. For RR G em it was found that during the 70 years of the observations the m odulation properties of the star changed signi cantly and that the m odulation was not detectable in the 1970-80s (Sodor et al. 2007b). The photographic data of RR G em showed that the change of the m axim um brightness of the m ean light curve wasmost probably connected to an abrupt period change. A 0.00006 d period increase was followed by a 0.1 m ag brightening of the B_{pg} mean maximum magnitude of RR Gem, while the 0.08 m ag drop of the mean maximum V brightness of RY C om was accompanied by a 0.00007 d pulsation period increase in 2008.

3.2 FK Vuland BD Her

FK Vuland BD Herwere observed in the course of the KBS in 2008. Both stars were observed on more than 10 nights. A coording to these observations large-amplitude modulations of the light curves are evident (see Fig. 6). The observations indicate that the modulation periods of FK Vul and BD Her are about 56 and 22 days, respectively. As we do not plan to continue to observe these stars, and the ob-

tained data are not extended enough to allow us to perform detailed analyses of these B lazhko variables, their observations are presented here.

The photom etric observations and maximum timings of RY Com, FK Vul, and BD Her are available in the online version of the journal as Supplem entary M aterial (see Tables 3, and 4 as samples of the electronic data).

4 COMPARISON W ITH THE MACHO, OGLE-I, AND OGLE-II STATISTICS

We compare our results with the MACHO LMC (A look et al. 2003), OGLE-I (M oskalik & Poretti 2003), and OGLE-II (Collinge et al. 2006) G alactic bulge statistics, as only these publications give enough details on the variables. These surveys are based on the observations of 6158, 150, and 1888 fundam ental-m ode RR Lyrae stars, am ong them 944, 51, and 544 have periods shorter than half a day. The detected incidence rates of the m odulation of these short-period variables are 16%, 27%, and 30%, while 47% of the K onkoly sam ple exhibit the B lazhko e ect.

W e do not make any distinction between the dierent types of modulation according to the location of the detected modulation frequency components (1, 2, BL1, BL2, BL2x2, etc.), which were used in the other surveys. Our previous results showed that the 1, BL1 variables, which are characterized by only one modulation frequency component close to the main pulsation frequency, exhibit, in fact, Blazhko type modulation (BL2, showing equidistant triplet frequencies) with high asymmetry in the amplitudes of the side lobe frequencies (Jurcsik et al. 2005b).We have also shown that the side lobe frequencies of an am plitude and phase modulated harm onic signal can naturally have highly asym m etric am plitudes (Szeidl & Jurcsik 2009). Collinge et al. (2006) obtained a signi cantly higher ratio of BL2 stars to BL1 stars than what had been found in the previous surveys. This was attributed mainly to the robustness and sensitivity of the method they applied to detect additional sym m etrical frequency com ponents. Their result also indicates that the detection of equidistant frequency components on both sides of the pulsation frequency depends on the accuracy of the data and the e ciency of the analysis perform ed. It seems that characterizing the modu-

lation with frequency doublets instead of triplets does not re ect real di erences of the modulation. The 2, BL2x2 variables show multiperiodic modulation, which is probably also a common feature of B lazhko stars.

The distribution of the m odulation am plitude of shortperiod (P_{puls} < 0.5 days) B lazhko variables are shown for the MACHO, OGLE-I, OGLE-II, and Konkoly data in Fig. 7. The am plitude corresponds to the largest-am plitude m odulation-frequency component in V band. In order to have hom ogeneous data, the I_c band am plitudes of the OGLE-I and OGLE-II data are transform ed to V am plitudes according to the form ula: A (V)=A (I_c) = 1.58 (Jurcsik et al. 2005c). Here we stress again that am plitudes of m odulation frequency components only in the vicinity of the m ain pulsation frequency were published for the OGLE-II data, but the largest-am plitude m odulation-frequency component occurs in the vicinity of the higher harm onics of the pulsation frequency in som e B lazhko variables.

W hile the MACHO and OGLE data show sim ilarm odulation am plitude distributions with the most frequent am – plitude of the modulation being between $0.050\{0.075 \text{ mag}, \text{sm all-am plitude modulations (A (V) < 0.025 \text{ mag}) are the most frequent in the K onkoly sam ple.B lazhko variables with such sm all modulation am plitudes constitute only 1%, 7%, and 10% of the MACHO, OGLE-I, and OGLE-II B lazhko sam ples, respectively, but 50% of the modulated RR ab stars discovered in the K onkoly Survey belong to this group.$

The V and I_C Fourier am plitudes given in the last two colum ns in Table 2 can be directly compared with the m odulation am plitudes measured in the MACHO and OGLE-II surveys. In our sample of fourteen B lazhko stars, six variables have A (V) 6 0.015 m ag and A (I_C) 6 0.009 m ag modulation am plitudes. M odulations with similarly sm all am plitudes were not detected in the MACHO and OGLE-I surveys at all, and were detected only in 2% of the short-period RR ab stars of the OGLE-II data.

If only Blazhko variables with at least one largeamplitude modulation-frequency component (A (V) > 0:025 m ag) were considered in the Konkoly data, the incidence rate of the modulation would be 23%, similarly to the MACHO and OGLE results. Consequently, the di erences in the observed incidence rates of the modulation between our and the MACHO and OGLE statistics do not arise from the sm all num ber of objects and/or any bias in the target selection of our survey but from the fact, that the latter surveys could not detect sm all-amplitude light-curve modulations.

A sour survey concerns only 30 ob jects, which is statistically a small number, it is important to verify the signi – cance of the results obtained on this sam ple. In the OG LE – II data used by Collinge et al. (2006) there were 544 R R ab stars with $P_{puls} < 0.5$ days and among them 30.5%, 166 variables were detected to show light-curve modulation. A ssum – ing that the true incidence rate of the modulation among R R ab stars equals to this ratio, the likelihood of detecting 14 out of 30 variables to show light-curve modulation would be only 4.6%. Therefore, the small sam ple size of the K B S cannot be accounted for the large percentage of B lazhko variables detected.

W e have also checked whether the selection procedure that Collinge et al. (2006) applied to detect Blazhko variables could or could not identify small-amplitude modulations. The last column in Table 2 lists the $I_{\mbox{\scriptsize C}}$ amplitudes of the highest modulation-peaks in the vicinity of the main pulsation frequency of the Blazhko variables observed in the K onkoly Survey. To classify a variable to BL1, this peak has to be as large as 2.4 times the noise level. For a BL2 variable two peaks with symmetrical frequencyseparations are required, each with an amplitude larger than 1.1 tim es the noise level according to the selection applied by Collinge et al. (2006). The average noise level of the light curves of the short-period B lazhko variables in the OGLE-II sam ple is 16.7 mm ag 8.3 mm ag. A coording to the data in Table 2 the A (I_c) amplitudes of the small-modulationam plitude variables are about the half of the average noise level of the OGLE-II data.

The probability of detecting RR G em -type, smallamplitude modulation in the OGLE-II survey was also tested using di erent subsets of our observations. The same number of data points (250) as the OGLE-II light curves contain were random ly selected from the $I_{\rm C}$ band light curve of RR G em .Following the method of Collinge et al. (2006) we searched for modulation frequency components in the vicinity of the main pulsation component in the test data sets. As RR G em has a modulation period of 7.2 days, modulation frequency components were searched in a wider frequency range (f_0 0.2 cd⁻¹) than it was done by Collinge et al. (2006).RR G em was detected only twice from 1000 random selections to be a Blazhko variable according to the criteria of Collinge et al. (2006). Therefore, we conclude that week m odulations like RR G em has were de nitely m issed in the OGLE-II survey.

A nother reason of the underestim ation of the num ber of B lazhko variables in the OG LE-II data lies in the detection criteria that Collinge et al. (2006) applied. They searched only for modulations with $P_{m\ od} > 10$ days period. Taking into account that in our survey 2 of the 14 new B lazhko stars have modulation periods shorter than 10 days, this selection lim it also leads to m iss som e fraction of the B lazhko variables.

Concerning the MACHO data, the standard deviations of the residuals after the rem oval of the pulsation and m odulation components from the light curves are in the 0.03-0.20 m ag range. This very high noise level m akes the detection of sm all-am plitude m odulations very unlikely. U sing the light-curve solution of RR Gem and the tim ings of the MACHO observations we generated articial time series to test the detection probability of RR Gem -like m odulation in the MACHO data. To m in ic the noise properties of the MACHO data, Gaussian noise was added with 0.03, 0.06, and 0.09 m ag rm s statistics. Fourier analysis of the test data (prew hitened for the pulsation) showed that the higherm odulation peak in the vicinity of the main pulsation frequency had an amplitude larger than 2 of the spectrum only if the sm allest (0.03 m ag) rm s noise was added. If the rm s was 0.06 m ag, there was none among 500 test time series that had a modulation peak reaching 2 am plitude. For com parison, only 5% of the MACHO light curves have m s residual sm aller than 0.06m ag.

Our survey is con ned only to short-pulsation-period variables, which tends to bias the sam ple in favour of m etalrich disk RR Lyraes. Therefore our conclusion that the true incidence rate of the m odulation is signi cantly larger than it was estimated in the previous surveys is valid only for this population of RR ab stars. As the MACHO and OGLE surveys do not show, how ever, large di erences in the occurrence rates of the m odulation at di erent pulsation periods, it is a sound guess that the situation is the sam e for longer period variables, too. To con m this supposition accurate photom etric data are needed for longer period RR ab stars, as well.

5 THE PHOTOM ETRIC METALLICITY OF BLAZHKO VARIABLES

The m etallicity of RR ab stars can be derived from the period of the pulsation and the '₃₁ epoch independent phase di erence of the V light curve with sim ilar accuracy to that determ ined from low dispersion spectroscopic observations (Jurcsik & Kovacs 1996; Kovacs 2005). However, we do not know whether this relation also holds for the mean light curves of B lazhko variables. If the phase coverage of both the pulsation and the modulation cycles is not complete enough then the mean light curves of large-modulation-amplitude B lazhko variables can be seriously distorted, giving rise to spurious value of the Fourier parameters. For instance, using the ASAS data of SS For Kovacs (2005) found that the photom etric metallicity deviates signi cantly from the spectroscopic value, how ever, the recent, extended photom etric data (K clenberg et al. 2008) de ne a mean light curve with

Fourier parameters well matching the $\ensuremath{\mathbb{F}e/H}\]\ensuremath{(\!P\,;'_{31})}\ \ensuremath{\text{relation}}\)$ relation.

The extended data we obtained for B lazhko variables enable us to check the accuracy of the photom etric m etallicities derived from the m ean light curves of these variables. Am ong the 14 new B lazhko variables nine have spectroscopic abundance determ inations. Table 5 lists these variables and sum m arizes their spectroscopic and photom etric m etallicities. In this sam ple there are four and ve stars showing sm all- and large-am plitude m odulations, respectively. The photom etric m etallicities of the sm all-m odulation-am plitude variables calculated from well de ned m ean light curves are in very good agreem ent with the spectroscopic values. W e thus conclude that the photom etric m etallicity of sm allm odulation-am plitude B lazhko variables is correct, and it has the sam e accuracy as for unm odulated RR ab stars if the light variation is sam pled properly.

The situation for Blazhko variables showing largeam plitude m odulations is, how ever, not so obvious. Unfortunately, the spectroscopic inform ation on these stars is less certain than for the sm all-m odulation-amplitude variables. For those variables that have good data coverage (AQ Lyr, XY And and CZ Lac) the spectroscopic and photom etric m etallicities agree reasonably well. A sim ilar result was derived by Smolec (2005) too, using published photom etric and spectroscopic data of ve large-modulation-amplitude B lazhko stars. For the two large-m odu lation-am plitude variables in our sample, which have only 400-600 m easurem ents (FK Vuland BD Her), however, the discrepancy between the photom etric and spectroscopic m etallicities is large. The m ean light curves used to calculate the Fe/H bhot for FK Vul and BD Herare also drawn in the middle panels of Fig. 6. It can bee seen that the descending branch of the light curve of FK Vul is undersampled, which may result in improper shape of the m ean light curve. A lso, the m ean light curve of BD Her, especially around m in im um light, has an unusual shape most probably due to unequal data sam pling. It is an open question, however, that if the light curves of FK Vul and BD Herwere better sampled, then their photom etric [Fe/H] would or would not match their spectroscopic values better. The good agreem ent between the photom etric

and spectroscopic m etallicities of those large-m odulationam plitude B lazhko variables which have good light-curve coverage indicates, how ever, that if the light variation is well sam pled then the Fourier param eters of the m ean light curve can be safely used to calculate the m etallicity. N evertheless, to m ake this statem ent better grounded, both extended photom etric data of other large-m odulation-am plitude variables and spectroscopic m etallicities of these variables (e.g. for M W Lyr) are needed.

6 SUMMARY

We have shown that with the inclusion of smallam plitude modulations the incidence rate of the modulation increases to about 50% for short-period RRab stars. The Konkoly Blazhko Survey showed that, in fact, sm allam plitude m odulations are equally frequent as large am plitude ones. The distribution of the amplitudes of the modulation show an increase towards smaller amplitudes according to our data. It suggests that the light curves of those R R ab stars that are now supposed to be stable m ay also be m odulated but with very small amplitude, below our present detection limit. Moreover, we may have missed detecting sm all-am plitude m odulations with long m odulation periods in our sam ple. Therefore, it is likely that the incidence rate of the modulation we detected is still a lower lim it to the true fraction of the RR ab stars showing the Blazhko e ect. M odulations with amplitudes of the maximum brightness variation in the millim agnitude regime may still have escaped detection. The observations of recent space m issions (MOST, CoRoT, Kepler) will clear this question soon.

There is another embarrassing feature of the Blazhko m odulation, nam ely its tem poraloccurrence as docum ented recently in the study of the long term behaviour of RR G em inorum (Sodor et al. 2007b) and in the case of RY C om in the present paper. The m odulation of RR Lyrae is also known to cease for a short period in every fourth year (Szeidl1988). B ased on these results there is a good chance that the m odulation is a comm on feature of the pulsation of fundam entalm ode RR Lyrae stars, it m ay be even a universal property of these variables. This possibility warms that understanding the Blazhko modulation is crucial in the knowledge of the pulsation of RR Lyrae stars.

Detecting small-amplitude light-curve modulation of RRab stars is also relevant from the theoretical point of view.Kovacs (1995) used the lack of sm all-am plitude modulations as an argum ent against the oblique m agnetic rotator model of the Blazhko phenom enon (Shibahashi 2000). He says "Assuming random distribution [of the aspect anqle], we should see some small- and some large-amplitude m odulations. This is apparently not the case." The discovery of sm all-amplitude modulation contradicts this argument. W hatever the cause of the B lazhko m odulation, it m anifests itself in the full possible range of am plitudes. At the same time, simultaneous multi-periodic modulation with similar m odulation amplitudes were also detected in the KBS. The signi cant di erence between the modulation periods observed in these stars is a strong argument against those explanations of the B lazhko phenom enon that connect the m odulation period to the rotation of the star.

B ased on our photom etric data and spectroscopic inform ation on B lazhko stars we have found that the photom etric m etallicity determ ined from the m ean light curves of B lazhko variables are correct if the light curve is properly sam pled, i.e., them ean light curve is not distorted by uneven data sam pling of the di erent B lazhko phases.

In the K onkoly B lazhko Survey we obtained extended data on 30 RR ab stars with fundam ental periods shorter than 0.5 days, 14 of them showing the B lazhko e ect. This is a signi cantly larger incidence rate of the modulation than found previously. We cannot exclude the possibility, how – ever, that the large percentage of B lazhko stars in the sam ple of the KBS is related to the short pulsation period of these stars. If this were the case, the incidence rate of the modulation would also depend on the metallicity of the stars as short period RR ab stars are, in general, less metalpoor than longer period variables. In order to decide whether there is a period and/or metallicity dependence of the occurrence rate of the modulation we initiated a similar survey focusing on RR ab stars of longer periods in 2009.

The Konkoly B lazhko Survey: Is light-curve m odulation a common property of R R ab stars?²

ABSTRACT

A system atic survey to establish the true incidence rate of the Blazhko m odulation am ong short-period, fundam ental-m ode, G alactic eld RR Lyrae stars has been accomplished. The Konkoly Blazhko Survey (KBS) was initiated in 2004. Since then m ore than 750 nights of observation have been devoted to this project. A sam ple of 30 RR ab stars was extensively observed, and light-curve modulation was detected in 14 cases. The 47% occurrence rate of the modulation is much larger than any previous estimate. The signi cant increase of the detected incidence rate is mostly due to the discovery of sm all-am plitude m odulation. Half of the B lazhko variables in our sam ple show modulation with so small amplitude that de nitely have been missed in the previous surveys. We have found that the modulation can be very unstable in some cases, e.g. RY Com showed regular modulation only during one part of the observations while during two seasons it had stable light curve with abrupt, sm all changes in the pulsation am plitude. This type of light-curve variability is also hard to detect in other Survey's data. The larger frequency of the light-curve m odulation of RR ab stars makes it even more important to nd the still lacking explanation of the B lazhko phenom enon.

The validity of the $[Fe/H](P;'_{31})$ relation using the mean light curves of B lazhko variables is checked in our sample. We have found that the formula gives accurate result for small-modulation-amplitude B lazhko stars, and this is also the case for large-modulation-amplitude stars if the light curve has complete phase coverage. How ever, if the data of large-modulation-amplitude B lazhko stars are not extended enough (e.g. less than 500 data points from less than 15 nights), the formula may give false result due to the distorted shape of the mean light curve used.

1 IN TRODUCTION

The light-curve m odulation of R R Lyrae stars, the so called B lazhko e ect, is a hundred-year-old puzzle of stellar pulsation. The Fourier spectra of the light curves of B lazhko variables are characterized by m odulation frequency series appearing in the vicinity of the pulsation frequency (f_0) and

its harm onic frequencies $(kf_0; k > 1)$. B ased on the location and number of the independent modulation frequency com – ponents som e attem pts have been made to introduce di erent subtypes of the modulation (1, 2, BL1, BL2, BL2x2,etc. A lock et al. (2003); M oskalik & Poretti (2003)), these classi cation schemes, however, do not indeed help to disclose the unknown triggering mechanism of the modulation, which is most probably com m on in each B lazhko star. B oth observational and theoretical e orts are still needed to understand the modulation of RR Lyrae stars. Though the

incidence rate of the m odulation was estim ated to be about 25-30% based on visual, photographic and photoelectric observations of G alactic eld and globular cluster variables (Sm ith 1981, 1995; Szeidl 1988), in a sum m ary paper on RR Lyrae stars P reston (1964) w rote: "There is no sharp distinction between singly and multiply periodic variables. W hen observed with su cient precision or for long enough intervals of tim e, allRR Lyrae m ay be or m ay becom e m ultiply periodic" { quoting B alazs-D etre & D etre (1962).

More recently, the large CCD surveys e.g. MACHO (A loock et al. 2003) and OGLE (Moskalik & Poretti 2003; M izerski 2003; Soszynski et al. 2003; Collinge et al. 2006) found a similar or even smaller fraction of variables exhibiting light-curve modulation than determ ined by photographic and photoelectric observations. The incidence rates of the modulation in the Large Magellanic Cloud (LMC) and in the Galactic bulge were estimated to be 12-15% and 23-27% , respectively. These statistics on B lazhko variables m ay, how ever, be biased due to the lim its of the photom etric accuracy and/or the de ciencies in data sam pling. O bservation in longer wavelength band, where the amplitude of the m odalation signal is small, may also reduce the detection rate of the modulation. The incidence rates determined so far are only lower lim its for the occurrence of the modulation according to Collinge et al. (2006). The metal de ciency of the variables was suggested to explain the small fraction of Blazhko stars in the LMC, but Smolec (2005) could not detect any signi cant di erence between the metallicities of RR Lyrae stars in the LMC and in the Galactic bulge.

H ipparcos (ESA 1997), NSVS (W ozniak et al. 2004), and ASAS (Pojm anski2005) data bases also provide a large num ber of RR Lyrae observations but these data are not suitable to estim ate the true percentage of variables showing light-curvem odulation.Based on the NSVS and ASAS data, W ils et al. (2006) and Szczygiel & Fabrycky (2007) found m odulations in an unrealistically sm all fraction, about 5% of RR ab stars, RR Lyrae variables pulsating in the fundam ental m ode, also designated as RRO stars. M any of the w ell-known B lazhko variables have not even been detected to show light-curvem odulation in the H ipparcos, NSVS and ASAS data.

No system atic survey that aim ed to determ ine the frequency of light-curvem odulation of R R ab stars in the G alactic eld has been perform ed previously. These variables are bright enough to obtain accurate light curves even with sm all telescopes. E arlier photom etric program s concerning eld R R ab stars focused on either the light-curve variations of known B lazhko variables or the multicolour light curves of large sam ples of variables (e.g. Sturch 1966; F itch et al. 1966; B ookm eyer et al. 1977; Lub 1977; Schm idt & R eisw ig 1993) in order to determ ine their physical param eters (tem perature, m etallicity, reddening, etc.). Though these latter studies covered a large fraction of the brighter G alactic eld variables, the tim e span, data num ber, phase coverage, and photom etric accuracy of the m easurem ents were

not suitable to detect long-period and/or sm all-am plitude light-curve variations.

The knowledge of the true incidence rate of Blazhko stars has a great importance in nding the correct explanation of the phenomenon, as it shows how common the circum stances that favour the appearance of the modulation are. Exploiting the potential of our full access to an autom ated photom etric telescope, we initiated a system atic study of RRab stars to get an estim ate of the incidence rate of the modulation. Though our survey concerns a much more limited sample of variables than were measured in the MACHO and OGLE projects, the photom etric accuracy and the denseness of our data sampling allow us to detect the occurrence of light-curve modulation more reliably than in those surveys. The main results concerning the incidence rate of the modulation of the Konkoly Blazhko Survey are sum marized in the present paper.

R esults for variables with unstable light curves observed in the KBS that do not have data suitable to discuss in separate papers (RY Com, BD Her and FK Vul) are also published here.

C om paring the photom etric and spectroscopic m etallicities of B lazhko RR ab stars of the KBS sample we also draw some conclusions on the correctness of the photom etric m etallicity (Jurcsik & K ovacs 1996) derived from the mean light curves of B lazhko variables.

2 OBSERVATIONS AND TARGET SELECTION

The observations of the KBS began in 2004 using an autom ated 60 cm telescope (Budapest, Svabheqy) equipped with a W right Instrum ents 750x1100 CCD cam era (FoV 17'x24') and standard BVR $_{\rm C}$ I $_{\rm C}$ $\,$ lters. D at wwere corrected for atm ospheric extinction and were transform ed to the standard BVR_CI_C photom etric system . We obtained accurate, extended, multicolour light curves of fundam ental-m ode RR Lyrae stars with pulsation periods shorter than half a day. About 4000 hours of measurements were gathered for 30 variables on 750 nights during the past ve years. Each variable was observed at least as long as it could be undoubtedly decided whether the light curve was stable on about 20-100 days tim e base or it was modulated. The typical accuracy of the observations was about 5-20mm ag, depending mainly on the brightness of the object and on weather conditions. The apparent maximum V brightness of the observed variables was in the 10.5-13.5 m ag range. The accuracy, extension, and denseness of the data enabled us to detect light-curve m odulations with sm all m axim um brightness variations (som e hundredths of a m agnitude), i.e., with Fourier amplitudes of the modulation frequency components in the m m ag regim e.D ata are utilized twofold; accurate m ulticolour light curves of monoperiodic RRab stars and detailed analyses of individual B lazhko variables have already been and are going to be published.

W hen selecting stars to observe, special care was taken to choose variables with good com parison stars (close to the variable in projected distance, brightness, and colour) in order to gain the possible m ost accurate photom etry with our instrum ent. M agnitude di erences of the variable relative to a single com parison star were determ ined and analyzed for m ost of the stars. The constancy of the com parison stars were veri ed by m easuring several relatively bright stars in the ekls. D etails for the constancy of the com parison stars are given in the papers discussing the light curve variability of the individual objects (see e.g., Fig. 7 in Jurcsik et al. 2008c). The ensemble m ean brightnesses of ve, three and two neighbouring stars were calculated, and used as com parison stars' m agnitudes for U Z U M a, SS C nc and D M C yg, respectively.W e applied the Im age Subtraction M ethod (ISIS; A lard 2003) for the photom etry of CZ Lac in order to elim - inate the additional light of its close companion.

W e have observed only short-period RR ab stars (P < 0.5 days) to have a sam ple with som ewhat hom ogeneous physical param eters, as m ost of the physical properties of RR ab stars relate, to som e degree, to the period of the pulsation. The con nem ent of our survey to short-period variables also m ade the observation e ective, it assured to reach a good coverage of the entire possible sam ple within a few years of observations. No star with declination below 5 was selected to be observed in order to obtain extended data sets.

The philosophy of the target selection was to choose variables with poor quality photom etric observations available and to clear up som e questionable cases. W e endeavoured to obtain the possible most una ected sample in order to get an unbiased estimate of the incidence rate of the modulation. None of the observed stars was de nitely known to show Blazhko modulation previously. In three cases (RR Gem, MW Lyr, and DM Cyg) light-curve modulation was announced based on photographic or visual observations, but these results were in con ict with further observations and/or the reanalysis of the original data could not con m the formerly detected modulation (Sodor & Jurcsik 2005; Sodor et al. 2007b). Our observations revealed that these stars do indeed show light-curve m odulation, but with signi cantly di erent m odulation period, am plitude, and type (am plitude or phase m odulation) than that was found previously.RY Com was suspected to show Blazhko modulation (Jurcsik & Kovacs 1996), however, the scatter around m in im um brightness shown by the available observations (Jones 1966; Bookm eyer et al. 1977) m ight have arisen from photom etric inaccuracy. Four of the targets (TZAur, SSCnc, RRGem, and FHVul) were used by Jurcsik & K ovacs (1996) to calibrate the m etallicity versus light-curve param eters' relation assum ing that their light curves were stable. Our accurate m easurem ents show that, in fact, two of these stars, SS Cnc and RR Gem are Blazhko variables.

The 30 RR ab stars for which extended photom etric data were obtained in the K onkoly Survey comprise about 60% and 80% of the possible targets of the N orthern H em isphere sum m er and w inter seasons' RR ab stars m atching our selection critetia.

3 THE KONKOLY BLAZHKO SURVEY

A bout half of the 30 observed R R ab stars (14 variables, 47%) were found to exhibit light-curvem odulation. This is a much larger percentage than was given by any previous estimate. N one of the discovered B lazhko variables could have been undoubtedly identied to show light-curvem odulation from the H ipparcos, N SV S, A SA S or any other previous photom – etry. A s examples, our observations are compared to the published light curves for two R R Lyrae stars discovered to show B lazhko m odulation in our survey in Figs. 1 and 2.

AQ Lyrae, one of the stars measured in the survey, was previously supposed to have stable light curve. Castellanietal. (1998) observed AQ Lyron six consecutive nights in 1995 and found no light-curve modulation. The

earlier photoelectric observations of Sturch (1966) m atched the CCD light curve observed by Castellani et al. (1998) within the lim its of the photom etric accuracy. Our extended data have reveled, how ever, that in fact AQ Lyr shows largeam plitude m odulation. A lthough the variation in its m axim um V brightness is 0:3 m ag, its light curve does not change signi cantly on a few days time base due to the 65 days length of its B lazhko period. In Fig. 1 our V light curve of AQ Lyr is com pared to the previous observations.

In Fig. 2 the K onkoly photom etry is com pared with the A SA S-3 and N SV S light curves of U Z V ir. The K onkoly light curve shows about 0.3 m ag variation in m axim um brightness, and corresponding to the $P_{B1} = 68$ d period of the m odulation m any triplet com ponents can be identi ed w ith 0.015 cd¹ (cycle per day) separation from the pulsation com ponents in the prew hitened spectrum .D espite its strong maximum brightness variation, UZ V ir has not been found to be a Blazhko variable either from the ASAS or the NSVS data. These data show scattered light curves and very high noise level of the residual spectra. A lthough the f_0 fm m odulation side-frequency appears in the residual spectrum of the ASAS data, this is not the largest am plitude frequency and there is no other signal in the residual spectrum with the same separation from any of the other pulsation com ponents.

Table 1 sum m arizes the observations and the results of the 30 R R ab stars m easured in the K onkoly B lazhko Survey. The identi cation of the com parison stars are given in the

second colum n.The third, fourth, and ffh colum ns list the lters, the num ber of nights, and the tim e interval of the observations, respectively.P revious photom etric light-curve inform ation on the targets are given in the 'light-curve history' colum n.Pulsation periods are taken either from the GCVS (K holopov et al. 1985) or from our works (6th, 7th colum ns in Table 1).The references given in the last colum n give inform ation on the access to the K onkoly photom etric ${\rm data\,}^2$

The basic parameters of the modulation of the 14 Blazhko stars discovered in the Konkoly Blazhko Survey are listed in Table 2. The modulation periods and amplitudes were determined from our observations. The modula-

tion am plitudes listed in Table 2 give di erent m easures of the strength of the m odulation. The full am plitude of the m axim um -light variation (A (V)_{m ax}) and the Fourier am - plitude of the largest m odulation peak in V band (A (V)) are listed. To be comparable with the OG LE-II results, the last column gives the I_c amplitude of the highest m odulation peak in the vicinity of the main pulsation frequency (A (I_c)). This frequency is not always identical with the largest-amplitude m odulation-frequency component, as our sample shows that the highest-amplitude m odulation com - ponent appears in the vicinity of the rst or second harm onic components of the pulsation ($2f_0$, and $3f_0$) in about the half of the B lazhko variables.

The observations of the 16 m onoperiodic RR ab stars of the sample were published by Jurcsik et al. (2006a, 2008a,b); K un et al. (2008), and Sodor et al. (2007a). These stars were observed on 8-26 nights, spanning 19-443 days tim e intervals. W ithin the lim its of our observational accu-

racy the light curves of these stars were stable. How ever, we cannot exclude the possibility that these stars m ay also show short-or long-period "micro-modulation" with 1-2 mmag am plitude of the modulation side frequencies, which is below our detectability lim it. A coording to the com pilation of B lazhko stars by Sm ith (1995) about half of the short-period B lazhko stars have m odulation periods longer than 50 days. Therefore, it cannot be excluded either that some of the stars claim ed here to be m on operiodic m ay have long m odulation periods, longer than 3-4 tim es the tim e interval of the observations. M oreover, there is a third possibility for the non-detection of the modulation of these stars, namely the tem poralbehaviour of the modulation as shown for RR G em by Sodor et al. (2007b) and for RY Com in the next section of this paper. These stars can be regarded as monoperiodic only with these restrictions in m ind.

Detailed analyses of RR G em , SS C nc, and DM C yg, three B lazhko variables show ing sm all-am plitude light-curve

m odulation that was not detected previously were published by Jurcsik et al. (2005a, 2006b, 2009b). The doubly periodic m odulation of UZ UM a was shown by Sodor et al. (2006), while the rst really detailed analysis of the light curve and colour behaviour of a large-m odulation-am plitude B lazhko variable, MW Lyrae, was presented by Jurcsik et al. (2008c, 2009a). The observations of AQ Lyr, V 759 Cyg, BR Tau, XY And, CZ Lac and UZ V ir are extended enough to perform detailed analyses of their B lazhko behaviour, which will be the subjects of further separate papers. R esults for the rem aining three m odulated stars, RY Com, FK Vul, and BD Her are presented in this paper.

Only the half of the new B lazhko variables (XY And, BD Her, CZ Lac, AQ Lyr, MW Lyr, UZ V ir, and FK Vul) have m odulation am plitudes large enough to be detectable with less accurate and/or less extended observations. N evertheless, even though the variation in m axim um V brightness is larger than 0.15 m ag and the largest-am plitude m odulation-frequency component has an am plitude larger than 0.02 m ag for these stars, they were not detected to show B lazhko m odulation in the H ipparcos, A SA S and N SV S data.

Based on the maximum timings collected in the GEOS data base³ and our observations, we have found that there is no indication for any strong, irregular period change in any of the mono-periodic RR ab stars in the sam ple.UU Boo, SW CVn and probably EZ Cep show steady period increase, while the period of FH Vulis probably decreasing. The periods of the other 12 m ono-periodic RR ab stars are stable with very sm all if any changes detected.On the contrary, strong,

irregular changes are evident in some of the B lazhko stars (e.g., AQ Lyr, RR G em, BD H er, V 759 Cyg). We thus conclude that the pulsation periods of B lazhko variables tend to be less stable than the periods of unm odulated RR ab stars. A sim ilar result was derived from the study of the period changes of RR Lyrae stars in M 3 by Szeidl (1965).

3.1 The special case of RY Com

W e followed the light-curve variation of RY Com in three consecutive seasons, in 2007, 2008 and 2009.

The Konkoly light curve of RY Com between JD 2454205 and 2454283 (2007 season) is compared with the available photoelectric (Jones 1966; Bookm eyer et al. 1977) and CCD (NSVS, ASAS) observations in Fig. 3. The scatter of these latter measurem ents is much larger than the amplitude of the detected light-curve variation in the Konkoly observations. The residual spectra of the four data sets show di erent characteristics, after prewhitening the data for the mean pulsation light curves. The highest peaks in the residual spectrum of the Konkoly data are modulation frequency components at $f_0 = f_m (f_m = 0.03 \text{ cd}^{-1})$ with small,

0:01 m ag am plitudes, whereas the residual spectra of the ASAS, NSVS and the old photoelectric data show peaks higher than 0.04 m ag at di erent frequencies. Peaks close to integer frequencies dom inate the spectra of the old photoelectric and the NSVS data, indicating long-term trends in the observations, while the residual spectrum of the 4-year long ASAS data shows multiple peaks in the close vicinity of the pulsation frequency com ponents. This is a typical feature if the pulsation period is changing during the time base of the observations. In the ASAS data this is indeed the case, the pulsation period of the variable was 0.00001 d longer during the rst 2 years of the ASAS observations than during the second part of the data. Any light-curve m odulation of RY C om was de nitely hidden in the noise and other biases in all the previous observations.

Hoping to re ne the modulation properties of RY Com, we continued its observation in 2008. However, in this season we could not nd any sign of a regular modulation, instead, the maximum brightness of the pulsation light curve dropped by about 0.08 mag in a very short period (about a week) at around JD 2 454 530. Though the scatter of the phased light curves before and after JD 2 454 530 was larger than typical for our observations especially around m in im um light, we could not nd any de nite modulation period in the data. The star behaved sim larly in 2009, a sudden jum p was detected again in maximum brightness in this season, too, at around JD 2 454 905, and no clear modulation was evident. The observed light-curve variations were consistent in the B ;V;I_c bands in each season. In Fig. 4 the light curve history of RY Com between 2007 and 2009 is documented.

Fig. 5 shows the O C variation of RY C om based on archive data collected in the GEOS data base and on our recent observations. The plots indicate that the pulsation period of RY C om varies irregularly, showing both abrupt and continuous changes. D uring the K onkoly observations a period increase of 0.00007 d occurred. Unfortunately, it cannot be resolved from our data whether the period change occurred abruptly at around the drop of maximum brightness (JD 2 454 530) or it was continuous.

porarily occurring m odulation. For RR G em it was found that during the 70 years of the observations the m odulation properties of the star changed signi cantly and that the m odulation was not detectable in the 1970-80s (Sodor et al. 2007b). The photographic data of RR G em showed that the change of the m axim um brightness of the m ean light curve wasmost probably connected to an abrupt period change. A 0.00006 d period increase was followed by a 0.1 m ag brightening of the B_{pg} mean maximum magnitude of RR Gem, while the 0.08 m ag drop of the mean maximum V brightness of RY C om was accompanied by a 0.00007 d pulsation period increase in 2008.

3.2 FK Vuland BD Her

FK Vuland BD Herwere observed in the course of the KBS in 2008. Both stars were observed on more than 10 nights. A coording to these observations large-amplitude modulations of the light curves are evident (see Fig. 6). The observations indicate that the modulation periods of FK Vul and BD Her are about 56 and 22 days, respectively. As we do not plan to continue to observe these stars, and the ob-

tained data are not extended enough to allow us to perform detailed analyses of these B lazhko variables, their observations are presented here.

The photom etric observations and maximum timings of RY Com, FK Vul, and BD Her are available in the online version of the journal as Supplem entary M aterial (see Tables 3, and 4 as samples of the electronic data).

4 COMPARISON W ITH THE MACHO, OGLE-I, AND OGLE-II STATISTICS

We compare our results with the MACHO LMC (A look et al. 2003), OGLE-I (M oskalik & Poretti 2003), and OGLE-II (Collinge et al. 2006) G alactic bulge statistics, as only these publications give enough details on the variables. These surveys are based on the observations of 6158, 150, and 1888 fundam ental-m ode RR Lyrae stars, am ong them 944, 51, and 544 have periods shorter than half a day. The detected incidence rates of the m odulation of these short-period variables are 16%, 27%, and 30%, while 47% of the K onkoly sam ple exhibit the B lazhko e ect.

W e do not make any distinction between the dierent types of modulation according to the location of the detected modulation frequency components (1, 2, BL1, BL2, BL2x2, etc.), which were used in the other surveys. Our previous results showed that the 1, BL1 variables, which are characterized by only one modulation frequency component close to the main pulsation frequency, exhibit, in fact, Blazhko type modulation (BL2, showing equidistant triplet frequencies) with high asymmetry in the amplitudes of the side lobe frequencies (Jurcsik et al. 2005b).We have also shown that the side lobe frequencies of an am plitude and phase modulated harm onic signal can naturally have highly asym m etric am plitudes (Szeidl & Jurcsik 2009). Collinge et al. (2006) obtained a signi cantly higher ratio of BL2 stars to BL1 stars than what had been found in the previous surveys. This was attributed mainly to the robustness and sensitivity of the method they applied to detect additional sym m etrical frequency com ponents. Their result also indicates that the detection of equidistant frequency components on both sides of the pulsation frequency depends on the accuracy of the data and the e ciency of the analysis perform ed. It seems that characterizing the modu-

lation with frequency doublets instead of triplets does not re ect real di erences of the modulation. The 2, BL2x2 variables show multiperiodic modulation, which is probably also a common feature of B lazhko stars.

The distribution of the m odulation am plitude of shortperiod (P_{puls} < 0.5 days) B lazhko variables are shown for the MACHO, OGLE-I, OGLE-II, and Konkoly data in Fig. 7. The am plitude corresponds to the largest-am plitude m odulation-frequency component in V band. In order to have hom ogeneous data, the I_c band am plitudes of the OGLE-I and OGLE-II data are transform ed to V am plitudes according to the form ula: A (V)=A (I_c) = 1.58 (Jurcsik et al. 2005c). Here we stress again that am plitudes of m odulation frequency components only in the vicinity of the m ain pulsation frequency were published for the OGLE-II data, but the largest-am plitude m odulation-frequency component occurs in the vicinity of the higher harm onics of the pulsation frequency in som e B lazhko variables.

W hile the MACHO and OGLE data show sim ilarm odulation am plitude distributions with the most frequent am – plitude of the modulation being between $0.050\{0.075 \text{ mag}, \text{sm all-am plitude modulations (A (V) < 0.025 \text{ mag}) are the most frequent in the K onkoly sam ple.B lazhko variables with such sm all modulation am plitudes constitute only 1%, 7%, and 10% of the MACHO, OGLE-I, and OGLE-II B lazhko sam ples, respectively, but 50% of the modulated RR ab stars discovered in the K onkoly Survey belong to this group.$

The V and I_C Fourier am plitudes given in the last two colum ns in Table 2 can be directly compared with the m odulation am plitudes measured in the MACHO and OGLE-II surveys. In our sample of fourteen B lazhko stars, six variables have A (V) 6 0.015 m ag and A (I_C) 6 0.009 m ag modulation am plitudes. M odulations with similarly sm all am plitudes were not detected in the MACHO and OGLE-I surveys at all, and were detected only in 2% of the short-period RR ab stars of the OGLE-II data.

If only Blazhko variables with at least one largeamplitude modulation-frequency component (A (V) > 0:025 m ag) were considered in the Konkoly data, the incidence rate of the modulation would be 23%, similarly to the MACHO and OGLE results. Consequently, the di erences in the observed incidence rates of the modulation between our and the MACHO and OGLE statistics do not arise from the sm all num ber of objects and/or any bias in the target selection of our survey but from the fact, that the latter surveys could not detect sm all-amplitude light-curve modulations.

A sour survey concerns only 30 objects, which is statistically a small number, it is important to verify the signi – cance of the results obtained on this sam ple. In the OG LE – II data used by Collinge et al. (2006) there were 544 RR ab stars with $P_{puls} < 0.5$ days and among them 30.5%, 166 variables were detected to show light-curve modulation. A ssum – ing that the true incidence rate of the modulation among RR ab stars equals to this ratio, the likelihood of detecting 14 out of 30 variables to show light-curve modulation would be only 4.6%. Therefore, the small sam ple size of the KBS cannot be accounted for the large percentage of B lazhko variables detected.

W e have also checked whether the selection procedure that Collinge et al. (2006) applied to detect Blazhko variables could or could not identify small-amplitude modulations. The last column in Table 2 lists the $I_{\mbox{\scriptsize C}}$ amplitudes of the highest modulation-peaks in the vicinity of the main pulsation frequency of the Blazhko variables observed in the K onkoly Survey. To classify a variable to BL1, this peak has to be as large as 2.4 times the noise level. For a BL2 variable two peaks with symmetrical frequencyseparations are required, each with an amplitude larger than 1.1 tim es the noise level according to the selection applied by Collinge et al. (2006). The average noise level of the light curves of the short-period B lazhko variables in the OGLE-II sam ple is 16.7 mm ag 8.3 mm ag. A coording to the data in Table 2 the A (I_c) amplitudes of the small-modulationam plitude variables are about the half of the average noise level of the OGLE-II data.

The probability of detecting RR G em -type, smallamplitude modulation in the OGLE-II survey was also tested using di erent subsets of our observations. The same number of data points (250) as the OGLE-II light curves contain were random ly selected from the I_C band light curve of RR G em . Following the method of Collinge et al. (2006) we searched for modulation frequency components in the vicinity of the main pulsation component in the test data sets. As RR G em has a modulation period of 7.2 days, modulation frequency components were searched in a wider frequency range (f₀ 0.2 cd⁻¹) than it was done by Collinge et al. (2006). RR G em was detected only twice from 1000 random selections to be a Blazhko variable according to the criteria of Collinge et al. (2006). Therefore, we conclude that week m odulations like RR G em has were de nitely m issed in the OGLE-II survey.

A nother reason of the underestim ation of the num ber of B lazhko variables in the OG LE –II data lies in the detection criteria that Collinge et al. (2006) applied. They searched only for modulations with $P_{m\ od} > 10$ days period. Taking into account that in our survey 2 of the 14 new B lazhko stars have modulation periods shorter than 10 days, this selection lim it also leads to m iss som e fraction of the B lazhko variables.

Concerning the MACHO data, the standard deviations of the residuals after the rem oval of the pulsation and m odulation components from the light curves are in the 0.03-0.20 m ag range. This very high noise level m akes the detection of sm all-am plitude m odulations very unlikely. U sing the light-curve solution of RR Gem and the tim ings of the MACHO observations we generated articial time series to test the detection probability of RR Gem -like m odulation in the MACHO data. To m in ic the noise properties of the MACHO data, Gaussian noise was added with 0.03, 0.06, and 0.09 m ag rm s statistics. Fourier analysis of the test data (prew hitened for the pulsation) showed that the higherm odulation peak in the vicinity of the main pulsation frequency had an amplitude larger than 2 of the spectrum only if the sm allest (0.03 m ag) rm s noise was added. If the rm s was 0.06 m ag, there was none among 500 test time series that had a modulation peak reaching 2 am plitude. For com parison, only 5% of the MACHO light curves have m s residual sm aller than 0.06m ag.

Our survey is con ned only to short-pulsation-period variables, which tends to bias the sam ple in favour of m etalrich disk RR Lyraes. Therefore our conclusion that the true incidence rate of the m odulation is signi cantly larger than it was estimated in the previous surveys is valid only for this population of RR ab stars. As the MACHO and OGLE surveys do not show, how ever, large di erences in the occurrence rates of the m odulation at di erent pulsation periods, it is a sound guess that the situation is the sam e for longer period variables, too. To con m this supposition accurate photom etric data are needed for longer period RR ab stars, as well.

5 THE PHOTOM ETRIC METALLICITY OF BLAZHKO VARIABLES

The m etallicity of R R ab stars can be derived from the period of the pulsation and the '₃₁ epoch independent phase di erence of the V light curve with sim ilar accuracy to that determ ined from low dispersion spectroscopic observations (Jurcsik & Kovacs 1996; Kovacs 2005). However, we do not know whether this relation also holds for the mean light curves of B lazhko variables. If the phase coverage of both the pulsation and the modulation cycles is not complete enough then the mean light curves of large-modulation-amplitude B lazhko variables can be seriously distorted, giving rise to spurious value of the Fourier parameters. For instance, using the A SA S data of SS For K ovacs (2005) found that the photom etric metallicity deviates significantly from the spectroscopic value, how ever, the recent, extended photom etric data (K clenberg et al. 2008) de ne a mean light curve with

The extended data we obtained for B lazhko variables enable us to check the accuracy of the photom etric m etallicities derived from the m ean light curves of these variables. Am ong the 14 new B lazhko variables nine have spectroscopic abundance determ inations. Table 5 lists these variables and sum m arizes their spectroscopic and photom etric m etallicities. In this sam ple there are four and ve stars showing sm all- and large-am plitude m odulations, respectively. The photom etric m etallicities of the sm all-m odulation-am plitude variables calculated from well de ned m ean light curves are in very good agreem ent with the spectroscopic values. W e thus conclude that the photom etric m etallicity of sm allm odulation-am plitude B lazhko variables is correct, and it has the sam e accuracy as for unm odulated RR ab stars if the light variation is sam pled properly.

The situation for Blazhko variables showing largeam plitude m odulations is, how ever, not so obvious. Unfortunately, the spectroscopic inform ation on these stars is less certain than for the sm all-m odulation-amplitude variables. For those variables that have good data coverage (AQ Lyr, XY And and CZ Lac) the spectroscopic and photom etric m etallicities agree reasonably well. A sim ilar result was derived by Smolec (2005) too, using published photom etric and spectroscopic data of ve large-modulation-amplitude B lazhko stars. For the two large-m odu lation-am plitude variables in our sample, which have only 400-600 m easurem ents (FK Vuland BD Her), however, the discrepancy between the photom etric and spectroscopic m etallicities is large. The m ean light curves used to calculate the Fe/H bhot for FK Vul and BD Herare also drawn in the middle panels of Fig. 6. It can bee seen that the descending branch of the light curve of FK Vul is undersampled, which may result in improper shape of the m ean light curve. A lso, the m ean light curve of BD Her, especially around m in im um light, has an unusual shape most probably due to unequal data sam pling. It is an open question, however, that if the light curves of FK Vul and BD Herwere better sampled, then their photom etric [Fe/H] would or would not match their spectroscopic values better. The good agreem ent between the photom etric

and spectroscopic m etallicities of those large-m odulationam plitude B lazhko variables which have good light-curve coverage indicates, how ever, that if the light variation is well sam pled then the Fourier param eters of the m ean light curve can be safely used to calculate the m etallicity. N evertheless, to m ake this statem ent better grounded, both extended photom etric data of other large-m odulation-am plitude variables and spectroscopic m etallicities of these variables (e.g. for M W Lyr) are needed.

6 SUMMARY

We have shown that with the inclusion of smallam plitude modulations the incidence rate of the modulation increases to about 50% for short-period RRab stars. The Konkoly Blazhko Survey showed that, in fact, sm allam plitude m odulations are equally frequent as large am plitude ones. The distribution of the amplitudes of the modulation show an increase towards smaller amplitudes according to our data. It suggests that the light curves of those R R ab stars that are now supposed to be stable m ay also be m odulated but with very small amplitude, below our present detection limit. Moreover, we may have missed detecting sm all-am plitude m odulations with long m odulation periods in our sam ple. Therefore, it is likely that the incidence rate of the modulation we detected is still a lower lim it to the true fraction of the RR ab stars showing the Blazhko e ect. M odulations with amplitudes of the maximum brightness variation in the millim agnitude regime may still have escaped detection. The observations of recent space m issions (MOST, CoRoT, Kepler) will clear this question soon.

There is another embarrassing feature of the Blazhko m odulation, nam ely its tem poraloccurrence as docum ented recently in the study of the long term behaviour of RR G em inorum (Sodor et al. 2007b) and in the case of RY C om in the present paper. The m odulation of RR Lyrae is also known to cease for a short period in every fourth year (Szeidl1988). B ased on these results there is a good chance that the m odulation is a comm on feature of the pulsation of fundam entalm ode RR Lyrae stars, it m ay be even a universal property of these variables. This possibility warms that understanding the Blazhko modulation is crucial in the knowledge of the pulsation of RR Lyrae stars.

Detecting small-amplitude light-curve modulation of RRab stars is also relevant from the theoretical point of view.Kovacs (1995) used the lack of sm all-am plitude modulations as an argum ent against the oblique m agnetic rotator model of the Blazhko phenom enon (Shibahashi 2000). He says "Assuming random distribution [of the aspect anqle], we should see some small- and some large-amplitude m odulations. This is apparently not the case." The discovery of sm all-amplitude modulation contradicts this argument. W hatever the cause of the B lazhko m odulation, it m anifests itself in the full possible range of am plitudes. At the same time, simultaneous multi-periodic modulation with similar m odulation amplitudes were also detected in the KBS. The signi cant di erence between the modulation periods observed in these stars is a strong argument against those explanations of the B lazhko phenom enon that connect the m odulation period to the rotation of the star.

B ased on our photom etric data and spectroscopic inform ation on B lazhko stars we have found that the photom etric m etallicity determ ined from the m ean light curves of B lazhko variables are correct if the light curve is properly sam pled, i.e., them ean light curve is not distorted by uneven data sam pling of the di erent B lazhko phases.

In the K onkoly B lazhko Survey we obtained extended data on 30 RR ab stars with fundam ental periods shorter than 0.5 days, 14 of them showing the B lazhko e ect. This is a signi cantly larger incidence rate of the modulation than found previously. We cannot exclude the possibility, how – ever, that the large percentage of B lazhko stars in the sam ple of the KBS is related to the short pulsation period of these stars. If this were the case, the incidence rate of the modulation would also depend on the metallicity of the stars as short period RR ab stars are, in general, less metalpoor than longer period variables. In order to decide whether there is a period and/or metallicity dependence of the occurrence rate of the modulation we initiated a similar survey focusing on RR ab stars of longer periods in 2009.
