M IGRATION OF EXTRASOLAR PLANETS: EFFECTS FROM X-W IND ACCRETION DISKS

ABSTRACT

M agnetic elds are dragged in from the interstellar medium during the gravitational collapse that form s star/disk system s. Consideration of mean eld m agnetohydrodynam ics (MHD) in these disks shows that magnetic e ects produce subkeplerian rotation curves and truncate the inner disk. This letter explores the ram i cations of these predicted disk properties for the migration of extrasolarplanets. Subkeplerian ow in gaseous disks drives a new migration mechanism for embedded planets and modil es the gap opening processes for larger planets. This subkeplerian migration mechanism dom inates over Type Imigration for suf-

ciently small planets (m_P . 1M) and/or close orbits (r . 1AU). A lthough the inclusion of subkeplerian torques shortens the total m igration time by only a moderate amount, the mass accreted by m igrating planetary cores is signi – cantly reduced. Truncation of the inner disk edge (for typical system parameters) naturally explains nalplanetary orbits with periods P 4 days. P lanets with shorter periods P 2 days can be explained by m igration during FU-O ri outbursts, when the mass accretion rate is high and the disk edge m oves inward. F inally, the m idplane density is greatly increased at the inner truncation point of the disk (the X-point); this enhancement, in conjunction with continuing ow of gas and solids through the region, supports the in situ form ation of giant planets.

1. IN TRODUCTION

The population of observed extrasolar planets exceeds 350, with m any objects found in short-period orbits (U dry et al. 2007). Trem endous progress has been m ade in our theoretical understanding of the m igration m echanisms that allow planets to m ove (usually inward) as they form (Papaloizou & Terquem 2006, hereafter PT 06). Parallel advances have been m ade in our understanding of star form ation processes (R eipurth et al. 2007), which produce the circum stellar disks that provide birth places for planets. How ever, these latter developments have not been fully integrated into theories of planet form ation/m igration. This letter explores the implications of the predicted disk properties for planet m igration.

During the collapse phase of star form ation, magnetic elds are dragged inward and retained by the nascent disk. These magnetic elds, along with those generated by the star, can drive powerfulout ows (B landford & Payne 1982, Shu et al. 1994), provide channels for accretion of disk material onto the star (Bouvier et al. 2007), and produce a back reaction on the structure (Shu et al. 2007, hereafter S07). In particular, circum stellar disks are predicted to display subkeplerian rotation curves. We parameterize the rotation speed of the gas through the ansatz $_{gas} = f$, where $^2 = GM = r^3$. Recent M HD calculations indicate that f 0:66 for disks around T Tauri stars and f 0:39 for disks undergoing FU-O rion is outbursts (S07). The relative velocity between the gas and orbiting planets is thus a substantial fraction of the Keplerian rotation speed, and f \in 1 over much of the disk.

P lanetary m igration is altered when the circum stellar gas moves at subkep lerian speeds. In K ep lerian disks, em bedded planets drive wakes into the disk, and asym m etric gravitational interactions of these wakes drive planets inward (G oldreich & Trem aine 1979), a process called Type Im igration (W and 1997ab). In subkep lerian disks, em bedded planets orbit with K ep lerian speeds and experience a headwind from the gaseous disk (which m oves slower). This velocity m ism atch results in energy loss from the orbit and inward m igration. This paper explores thism echanism (Section 2), including an assessment of the conditions necessary for it to compete with Type Im igration. A weaker version of this e ect occurs in nearly K ep lerian disks, where 1 $f = O(H^2 = r^2)$ 1=400, where H is the disk scale height. The headwind produced by this small departure from K ep lerian ow a ects dust grains as they coagulate into larger bodies, but does not a ect planets (V eidenschilling 1977b). The departures from K ep lerian speeds due to m agnetic e ects are larger by two orders of m agnitude.

The second feature of magnetic disks is that their inner edge is truncated. D isk material accretes onto the star by moving along magnetic eld lines in a \funnel ow ". In one theory, the disk truncation point, the start of the funnel ow, and the origin point for out ows occur at a location known as the X-point (Cai et al. 2008, hereafter C 08). This \point" has a nite extent, comparable to the disk scale height. In competing theories, the wind

originates from an extended disk region (Pudritz & Norm an 1983), but the disk retains an inner truncation point; disk wind models also predict subkeplerian ow, which might inhibit wind launching (Shu et al. 2008). Because the disk does not extend to the star, migration is naturally halted at the truncation point (r 0.05AU), as recognized Lin et al. 1996) soon after the discovery of extrasolar planets (M ayor & Queloz 1995, M arcy & Butler 1996). This paper argues that observed ultra-short-period planets (P 1 2day, r 0.02AU) can be understood through disk truncation at the X-point combined with FU-O rioutbursts (Section 3).

2. SUBKEPLER IAN M IGRATION

This section presents a migration mechanism driven by subkeplerian ow in magnetically controlled disks. To illustrate the properties of this mechanism, we consider power-law disks, where the surface density and tem perature distributions take the form $(r) = (r_1 = r)^p$ and T (r) = T₁ (r₁=r)^q. We take $r_1 = 1AU$, so the coe cients 1 and T₁ correspond to values at 1AU. The power-law index for the surface density lies in the range 1=2(Cassen & Moosman 1981). For the Minimum Mass Solar Nebula (MMSN), the surface 4500 g/cm² (Kuchner 2004). The power-law index for the tem density constant 1 perature pro le lies in the range 1=2 < q < 3=4. V iscous accretion disks le ringle 1981) at reprocessing disks Adams & Shu 1986) have q 3=4; ared reprocessing disks and (Chiang & Goldreich 1997) and the early solar nebula (Weidenschilling 1977a) have q 1=2. P lanetary orbits are taken to be circular, with orbital angular momentum $J = m_P (GM r)^{1=2}$. The disk scale height $H = c_s =$, where c_s is the sound speed, which is determined by the disk tem perature pro le. The radial dependence of H =r is thus H =r = (H =r) $(r=r_1)^{(1-q)=2}$, where $(H = r)_1$ 1=20 (S07).

2.1. Torques

For circular orbits, the torque $T_{\rm X}\,$ exerted on the planet by gas in the subkeplerian disk takes the form

where r is the orbital radius, v_{rel} is the relative velocity between the gas and planet, $_{gas}$ is the gas density, and R_P is the planetary radius. The dimensionless drag coecient C_D 1 for planets (W eidenschilling 1977b), but can be enhanced by gravitational focusing (O htsukiet al. 1988). The gas density $_{gas}$ =2H. Because the gaseous disk orbits with subkeplerian speeds $_{gas}$ = f, the relative velocity takes the form v_{rel} = (1 f) (G M =r)¹⁼², and the

torque becom es

The time evolution of the sem im a jor axis obeys the di erential equation

where we assume that the orbit remains circular. The migration timescale is given by

For typical parameters, M = 1.0M, $m_P = 1.0M$, $R_P = 1.0R$, $_1 = 4500$ g/cm², f = 0.66, and $(H = r)_1 = 0.05$, the timescale t_0 70;000yr.

For com parison, Type I torque strengths are given by

where the dimensionless constant C_{I} (1:364 + 0:541p)= 0:606 (W ard 1997a, Tanaka 2002). The ratio of the torque T_{X} to the Type I torque is given by

For an Earth-like planet (m_P = 1M , R_P = 1R) orbiting a solar mass star, $C_D = C_I$, and H = r = 1=20, the two torques have almost the same magnitude at r = 1AU when $(1 \quad f) = 0.34$. Since the torque ratio grows with decreasing sem imajor axis, subkeplerian torques T_X are stronger for r. 1AU. The ratio decreases with the planetary mass, so that larger planets are more a ected by Type Imigration. This torque ratio also depends on the stellar mass, so that subkeplerian torques are more important for systems associated with more massive stars. Figure 1 shows the regions of parameter space ($r;m_P;M$) for which subkeplerian migration dominates over Type Imigration. Subkeplerian torques are relatively stronger in the inner disk, where magnetic e ects ($f \in 1$) are most likely to arise.

Note that this treatment is approximate: The T_I expression neglects magnetic e ects, which can be important in these systems (Terquem 2003). In general, T_I should be a function of f. Moreover, this Type I torque is derived for isothermal disks, whereas X -wind disks have temperature gradients, which can a ect migration (Paardekooper & Mellem a 2006). Finally, the two torques (T_I ; T_X) are not fully independent | both mechanisms produce disk wakes that can interfere with each other. The comparison shown in Figure 1 is thus subject to future corrections.

2.2. Gaps

In standard treatments of gap formation, parcels of gas owing past the planet are scattered by its gravitational potential, and de ected through the angle = $(2G m_P = bv_{rel}^2)$, where b is the impact parameter of the encounter (PT06). This de ection changes the parcel's speci c angularmom entum by the increment

where the constant K includes corrections arising from the rotating reference fram e (Goldreich & Tremaine 1980). The disk angular momentum changes at a rate determined by the integral of J.

In the Keplerian case, the planet moves faster (slower) than disk material on its outside (inside). The planet thus transfers angular momentum to the outer disk and negative angular momentum to the inner disk, and opens a gap from both directions. However, in a subkeplerian disk, the planet moves faster than the disk material on both sides of the potential gap; this complication modil es the gap form ation process.

A lthough supersonic ow $(y_{el} g)$ alters this picture, we start by estimating the angular momentum transferred by \scattering" gas parcels and compare the result to that transferred by viscosity. Consider the disk exterior to the planetary orbit. The planet moves faster than the gas, and angular momentum is transferred outward at the rate

where the integral's support is concentrated (by assumption) near the minimum impact parameter b_{min} . This expression neglects disk shear term s, which must be included to recover the standard result in the limit f! 1 (compare equation [8] with PT06).

G ap form ation requires that the rate of angular m om entum transfer to the disk from \scattering" exceeds the rate at which angular m om entum is transferred by viscosity. This condition requires

where the viscosity is parameterized as = (2=3) $\rm c_s H$, and the viscosity coe cient is dimensionless.

G ap formation requires a second condition: The planet's sphere of in uence must be large enough, e.g., the Roche radius $R_R = r (m_P = 3M_{-})^{1=3}$ must exceed the scale height H.

The requirement $R_R > H$ places another constraint on the planet mass required for gap opening:

This condition allows the ow to experience nonlinear deviations \mathbb{W} and 1997a), including shock form ation in the vicinity of the planet (K orycansky & Papaloizou 1996). Since this requirement could be modiled for high M ach numbers, equation 10) should be considered as approximate. This constraint allows us to use $b_{min} = R_R / r$ to evaluate the angular momentum transfer rate in equation (8), and solve equation (9) to not the planet mass required for gap opening:

G aps form when both constraints (10) and (11) are satisfied (see also C rida et al. 2006). For 10^{-3} , f = 0:66, and H = r = 1=20, the nonlinear constraint (10) and the viscous constraint (11) are comparable, and the mass required for gap clearing is 100M (about one Saturn mass). Because the planet moves faster than the gas on both sides of the gap, the planet readily transfers angular momentum to the outer gap edge, but tends to draw disk material outward from the inner edge. When the planet has su cient mass (equation [10]), this material shocks against the wake of the planet. The planet will thus be located closer to the inner gap edge.

2.3. Orbital Evolution

To consider orbital evolution of the planet, we de nead in ensionless angularmom entum variable J=J, where $J=m_P$ r^2 and J_1 is the orbital angularmom entum at r = 1AU. We also de ne reduced torque parameters through the ansatz $_I$ T_I $(J_1)=J_1$ and $_X$ T_X $(J_1)=J_1$. The equation of motion then becomes

where the indices a = 2 (p - q) and b = 2p + 3 - q. For typical values p = 3=4 and q = 1=2, the torque indices become a = 1=2 and b = 4. Since the two torques are nearly equal for Earth-m ass planets at 1AU, $x = 10 (M \text{ yr})^{-1} = 1=(0.1M \text{ yr})$. Keep in m ind that both torque expressions are approximate (see Section 2.1).

For subkeplerian torques acting alone, the time required to migrate from a starting location $_0 = J_0 = J_1 = (r_0 = 1AU)^{1=2}$ to the central star is given by $_x t_x = _0^{b+1} = (b+1)$.

Similarly, the time required for Type I torques to move the planet from $_0$ to the star is given by $_{\rm I}t_{\rm I} = _0^{a+1} = (a + 1)$. Since we expect b a, subkeplerian migration is much faster than Type I migration for planets starting inside 1AU. For planets starting at larger radii, however, Type I torques dom inate until the planet reaches r 1AU, where subkeplerian torques take over.

The above results assume that the planetary core mass remains constant. However, the core mass must increase with time for giant planets to form, and the torque strengths change as the mass increases. To illustrate this behavior, we use a simpli ed treatment of planetesim al accretion where the planetary core grows according to

where $_{z}$ / is the surface density in solids (Papaloizou & Terquem 1999, Laughlin et al. 2004a). G iant planet form ation typically requires $_{z}$ 130 g cm 2 at r = 1AU, som ew hat larger than the M M SN value (Lissauer & Stevenson 2007). For a given density of planetary cores, $_{c}$ 32 g cm 3 , the planetary radius R_{p} is determined by the mass. A fler de ning a scaled radius $R_{p} = R$, we write the core accretion process in dimensionless form,

where 20 (M yr)^{1} . We can combine planetary growth with orbital evolution. As the planet grows according to equation (14), the torques vary with planetary radius, and the equation of motion for $(r=1AU)^{1=2}$ becomes

where $\hat{I} = I$ (= 1) and $\hat{X} = X$ (= 1).

W hen m igration reaches r . 1AU, subkeplerian torques become larger than Type I torques and planetary m igration takes place m ore rapidly. If m igration starts at larger radii, how ever, m ost of the evolution time is spent at larger radii where Type I m igration torques prevail. Consequently, subkeplerian torques don't substantially change the total m igration time for starting radii beyond r 2AU. How ever, the m ass accreted during the m igration epoch is signi cantly altered due to acceleration of the latter stages. These trends are illustrated by Figure 2, which shows m igration times and nalm asses for planets starting at varying locations r_0 with xed initial m ass $m_P = 1M$. Here, the equations of m otion (14,15) are integrated using the standard param eter values quoted above.

For completeness, we note that subkeplerian ow occurs only in magnetically active disk regions. The ow becomes Keplerian in \dead zones" G ammie 1996), where this migration

mechanism will not operate. However, ordinary Type Im igration continues to act within dead zones, so that migration occurs at the standard Type I rate.

3. DISK TRUNCATION

This section considers the implications of disk truncation. In X -wind theory, this inner cuto radius is given by

where is the magnetic dipole moment of the star, M is the stellar mass, M_{-D} is the mass accretion rate, and d_x 1 is a dimensionless parameter (O striker & Shu 1995, S07). Because r_X marks the inner disk boundary, planets cannot migrate inside the X-point through standard migration mechanisms involving disk torques because there is no disk material. The X-point location r_X 0:05AU for typical parameters (C 08), and is coincident with the sem im a praces of \hot Jupiters". D isk truncation through magnetic e ects thus provides a natural mechanism for ending migration and explains the observed planets in 4-day orbits. However, extrasolar planets have recently been discovered with signi cantly smaller sem im a praces¹, r 0:02AU. A though some variation in r_X is expected, the presence of extrasolar planets in these extrem ely tight orbits represents some tension with expectations from X-wind theory, and suggests the possibility of an additional mechanism .

The presence of these short-period planets can be understood as follows: The location of the X-point depends on the mass accretion rate through the disk. During FU-O rioutburst events, the mass accretion rate is greatly enhanced (Hartmann 2001), and the X-point moves inward (S07). Equation (16) indicates that M_{-D} must increase by a factor 25 to move the X-point to $r_X = 0.02AU$ as required. Since outburst phases have $M_{-D} = 10^{-4}M$ yr ¹, planets can (in principle) migrate inward during these FU-O riphases.

This simple picture has two complications. First, FU-O rioutbursts are relatively shortlived. The time-averaged mass accretion rate is M_{-D} 10 ⁷M yr ¹. During outbursts, the M_{-D} is 100 times larger, so that the outburst duty cycle is correspondingly shorter, and each event lasts only 100 1000 years. During the outburst phase, the disk extends inward to the desired radii, and m igration can take place. However, the planets will not necessarily have enough time to m igrate inward far enough during the (short) outburst phases. This issue is made more urgent by the timing of the events: The planets take a relatively long time

to form and m igrate inward to the \standard" location of the X-point (3 10M yr). Thus, relatively few FU-O rioutbursts will take place after the planets arrive at $r = r_x$ 0.05AU.

On the other hand, m igration will be aided by the fact that the planets m ight not have time to open up gaps in the disk. As a result, we expect that the m igration rates will be faster than the standard Type II m igration rates (for giant planets with gaps). The m igration rate will be closer to the Type I m igration rates, which are fast, and are even faster for larger m ass planets (that usually open up a gap).

The second complication is that, because FU-Ori outbursts are short, the star has di culty adjusting its rotation period to co-rotate with the disk: During the quiescent phase, the star rotates every 4 days, in sync with the inner disk edge at r 0:05AU. During an outburst, the large accretion rate suddenly pushes the disk edge to r 0:02AU. For the star to co-rotate with the new disk edge, it needs four times its angularm om entum. However, the maximum rate for the star to gain angular momentum is J- $M_{-D} r_{X}^{2} x$. For $M_{-D} = 10^{4} M$ yr ¹ and $r_{X} = 0.02 AU$, it takes 2000 3000 years to spin up the star, som ewhat longer than the tim escale for each outburst. As a result, the inner disk edge generally rotates faster than the star, and the magnetic funnel form sa leading spiral. A ngular m om entum ows into the star and makes the truncation radius sm aller than its equilibrium value (equation [16]). These departures from equilibrium thus allow migrating planets to m ove even farther inward.

Next we note that the density of gaseous material in the disk midplane is enhanced over the expected value =2H. Because disk truncation by the funnel ow increases the density by a factor r=H 40 at the X-point shu et al. 1994), the expected density x r =2H². This density enhancement has important ram i cations:

[1] G iant planets that successfully m igrate to the X-point at r = 0.05AU can be pushed further inward (perhaps to r = 0.02AU) during FU-O ri outburst events. W ith the density enhancement at the disk m idplane, the timescale for inward movement can be short (. 40yr), so that m igration can take place during a single outburst.

[2] P lanetary cores can m igrate inward to the X-point on a short tim escale, often fast enough that they cannot become gas giants before they reach the inner disk edge. If planetary cores are large enough, they continue to accrete gaseous material while they orbit at the Xpoint. The density enhancement considered herein provides a corresponding enhancement in the supply of available material. One issue associated with forming hot Jupiters in situ is the lack of gaseous material in the inner disk. This gas shortage is largely alleviated for planets at the X-point, both from this density enhancement and from the continuing ow of material into the region (W ard 1997b). On the negative side, high temperatures at the X -point m ake the gas essentially dust-free. G as accretion onto planets is limited by cooling processes, which will be compromised if the opacity is too low.

4. CONCLUSION

This letter presents a new migration mechanism for embedded planets. These bodies experience a headwind due to the subkeplerian rotation curve of the gas in magnetically controlled disks, and drag forces drive inward migration. This mechanism dominates over Type Imigration (Figure 1) for su ciently small planets (m_P . 1M) and/or close orbits (r. 1AU). The totalm igration time moderately decreases due to subkeplerian torques, but the mass accreted by planetary cores during the migration epoch changes more substantially (Figure 2).

The gap opening process is modiled in subkeplerian disks because the planet moves faster than the gas (supersonically) both inside and outside its orbit. Gap opening thus requires nonlinear interactions (approximately given by equation [10]). The estimated mass threshold for gap opening is $m_p = 100M$, and the planet resides near the inner gap edge.

For typical parameters, magnetic truncation of the inner disk occurs at $r_X = 0.05 \text{AU}$, and thus naturally explains observed extrasolar planets in 4-day orbits. M igration of planets to smaller orbits, as sometimes observed, requires an additional mechanism. D uring FU-O rioutbursts, the X-point moves inward to the required location $r_X = 0.02 \text{AU}$ due to the large accretion rate, which also allows fast inward m igration. X-wind theory (S07,C08) thus provides a viable explanation for all of the currently observed short-period planets (long-period planets require additional considerations).

Finally, planetary cores that halt m igration at the X-point ($r_X = 0.05AU$) can be subjected to a signi cantly enhanced gas density and a continuing supply of material (including inwardly m igrating solids). These features help proto-hot-Jupiters mish form ing in their observed 4-day orbits.

This letter shows that magnetic e ects drive subkeplerian migration and produce nal orbits with r $_{K}$ 0.02 0.05AU (from disk truncation). These processes must compete with other mechanisms acting on embedded planets, including Type I migration (W ard 1997ab), stochastic migration from turbulence (N elson & Papaloizou 2004, Laughlin et al. 2004b, N elson 2005, Johnson et al. 2006, A dam s & B bch 2009), runaway migration (M asset & Papaloizou 2003), torques exerted by toroidal elds (Terquem 2003), opacity transitions (M enou & G oodm an 2004), and radiative (non-barotropic) e ects (Paardekooper & M ellem a 2006, Paardekooper & Papaloizou 2008). Future work should study how these processes

interact with each other to ultim ately form giant planets.
