The radii of M -dwarfs in the young open cluster NGC 2516

ABSTRACT

U sing a novel technique, which combines previously determ ined rotation periods with new spectroscopic determ inations of projected rotation velocity, we have determ ined radii for fast rotating, low-m ass $(0.2\{0.7M)$ M -dwarfs in the young, solar-m etallicity open cluster, NGC 2516. The mean radii are larger than model predictions at a given absolute I or K magnitude and also larger than the measured radii of magnetically inactive M -dwarfs; the di erence increases from a few per cent, to 50 per cent for the low est lum inosity stars in our sample. We show that a simple two-tem perature starspot m odel is broadly capable of explaining these observations, but requires spot coverage fractions of about 50 per cent in rapidly rotating M -dwarfs.

1 INTRODUCTION

The radius of a star is am ong the most fundam ental properties that can be predicted by a stellar model. Yet recent m easurem ents of radii for K - and M -dwarfs in eclipsing binary system s reveal signi cant discrepancies between m odels and observations. For a given mass, the radii of stars with 0:3 < M = M < 0:8 are up to 20 per cent larger than predicted by evolutionary models, and so the e ective tem perature at a given lum inosity is over-predicted by up to 10 per cent (L opez-M orales 2007; M orales et al. 2009). Attempts to explain these discrepancies have focused on the role of magnetic elds in suppressing convection and producing cool starspots (D 'Antona et al. 2000; M ullan et al. 2001; Chabrier, Gallardo & Bara e 2007). Strong, dynam ogenerated m agnetic elds are expected in the tidally locked, rapidly rotating components of eclipsing binaries, but if these e ects are important they should also cause larger radii for active, single stars. C on m ing this is challenging because (i) the sm all num ber of low -m ass stars close enough to m easure precise interferom etric radii are m agnetically inactive, and (ii) m etallicity variations, which are di cult to accurately assess in cool eld dwarfs, could be a signi cant source of radius scatter (Berger et al. 2006).

In this letter we present radius estimates for rapidly rotating, and hence magnetically active, single, cool dwarfs in the young, open cluster NGC 2516, which has a close-to-solarm etallicity. Our novel, purely geometric technique uses spectroscopic measurements of projected equatorial velocities along with rotation periods from light curve modulation to infer projected stellar radii. Our targets have masses 0.2 < M = M < 0.7, covering spectral types M 0{M 5, reach-

ing m asses at which stars are expected to be fully convective. W e show that, like the low -m ass components of eclipsing binaries, these stars have signi cantly larger radii than m odel predictions and that widespread coverage with dark, m agnetic starspots is a plausible explanation.

2 OBSERVATIONS OF NGC 2516

NGC 2516 is a young open cluster with a large population of low -m ass stars (H aw ley, Tourtellot & Reid 1999; Je nies, Thurston & H am bly 2001). It has a close-to-solar metallicity, spectroscopically determ ined as $[Fe/H] = 0.01 \quad 0.07$ or photom etrically as $[M/H] = 0.05 \quad 0.14$ (Temdrup et al. 2002). The same a uthors give an intrinsic distance m odulus of 7.93 $\quad 0.14$ based on m ain sequence tting. The cluster age is ' 150M yr based on the nuclear turn-o in its highm ass stars and the lithium depletion and X -ray activity seen in cooler stars (Je nies, Jam es & Thurston 1998; Lyra et al. 2006). The cluster reddening is E (B V) = 0.12 $\quad 0.02$ (Temdrup et al. 2002).

Targets in NGC 2516 were observed using the VLT (UT-2Kueyen) FLAMES instrum ent feeding the GIRAFFE and UVES bre spectrographs. Prim ary targets were chosen from 362 candidate cluster members reported by Inwin et al. (2007), that have measured rotation periods in the range 0.1-15 days and 14:5 < I < 18:5, corresponding approximately to 0.2 < M = M < 0:7 (Bara e et al. 2002). Spare bres were placed on \blank" sky positions and on other photom etric candidates for which no rotation periods were known. The GIRAFFE spectrograph was used with the HR 20A grating, covering the wavelength range 8000{8600A

at a resolving power of 16000. Bright blue stars in the sam e eld were used for telluric compensation and observed simultaneously using UVES. Eight observation blocks (OBs) were recorded in service mode between 27 N ovem ber and 30 D ecem ber 2007. Each OB consisted of two 1280 s exposures

with G IRAFFE and three 800 sUVES exposures. One of the OBs was performed twice sequentially with no change in instrument setup. Some targets were also observed in multiple OBs.A total of 867 spectra were recorded of 678 unique targets.

2.1 Extraction of the target spectra

M any of the spectra were faint, requiring optim alextraction to provide su cient signal-to-noise ratio (SNR) for useful analysis. There was also signi cant telluric absorption and strong sky em ission lines in the spectra. For these reasons we used purpose-built software for data reduction rather than pipelines supplied by the European Southern O bservatory.

The method used for optimal extraction is described by Home (1986). This applies non-uniform weight to pixels in the extraction sum, m in im ising statistical noise w hilst preserving photom etric accuracy. In our case, weighting pro les were determ ined from a boxcar average along the wavelength axis of tungsten-lamp at eld im ages. W avelength calibration was based on thorium -argon lam p spectra recorded during the day. Fine o sets were applied to the calibration of individual bres to compensate for any drift with time. These o sets were determ ined by com paring the positions of em ission lines in the median sky spectra of each OB to their position in sky spectra averaged over all OBs. The o set per bre varied between 0.001A and 0.008A. To deal with variations in bre e ciency, the proportion of the median sky spectrum subtracted from each target spectrum was tuned to m in im ise the peak am plitude of the cross-correlation between the sky-subtracted target spectrum and the median sky spectrum . Spectra from each OB were averaged and corrected for telluric absorption using the co-tem poral UVES spectra of bright blue stars, which were broadened to m in ic

2.2 M easurem ent of radial and projected equatorial velocities

the GIRAFFE spectral resolution.

Heliocentric radial velocities (RV s) were measured by crosscorrelation with stars from the UVES atlas (Bagnulo et al. 2003). Tem plates of type K 4.5V (HD 209100) and M 6V (HD 34055) were used. Projected rotation velocities (v sin i, where i is an unknown inclination) were estimated from the cross-correlation function widths. Translation from these to v sin i was calibrated by arti cially broadening standard star spectra. This was done in two stages. The standards were broadened with a Gaussian to match the cross-correlation function widths to the average width obtained from 40 slow rotating targets (period, P > 5 days), which we expect to have negligible vsin i (com pared with the spectral resolution). These broadened spectra were then convolved with a rotational broadening kernel at many vsin i values. A linear lim b darkening coe cient of 0.6 was used (C laret, D iaz-Cordoves & G im enez 1995), but our results are quite insensitive to this parameter. The v sin i values found using the

two tem plates did not di er signi cantly, either on average or as a function of colour, so we adopted the average value.

Uncertainties in RV and the width of the crosscorrelation function were measured empirically. Uncertainties due to noise in the target spectra were estimated, as a function of SNR, by comparing results for the two sequential OBs. A constant representing other error sources was determined by comparing observations of the same targets through di erent bres in di erent OBs. TypicalRV uncertainties were 0.2{0.6 km s 1 and the norm alised uncertainty in v sin i was typically ' 10 per cent for v sin i > 20 km s 1 but larger for sm aller v sin i.

3 AVERAGE RADIIOF CLUSTER MEMBERS

The NGC 2516 photom etric candidates used for the radius estimates have $v \sin i > 8 \text{ km s}^{-1}$, and most have periods < 3 days (see below). This sample is unlikely to contain many eld stars, because fast rotators are rare among the general late-K to m id-M -dwarf eld population (D elfosse et al. 1998). Nevertheless, som e candidates might be tidally locked binaries seen at an unfortunate phase or have low quality measurements of vsini. To avoid contamination of the sample we excluded: stars with spectra of average SNR less than 5; targets with cross-correlation functions with no clear single peak, orm ultiple peaks characteristic of a binary pair; stars with measured vsin i less than 8 km s¹ or less than twice their uncertainty. Stars were also excluded with RV more than 2 $\left(\frac{2}{v} + \frac{2}{c} \right)^{1-2}$ from the mean ensemble RV (for all the included stars with measured v sin i), where v is the individual RV uncertainty and c is the intrinsic cluster RV dispersion, determ ined to be $_{c} = 0.66$ 0.13 km s¹. The latter step was perform ed iteratively.

The remaining 147 targets were used to determine projected radii using the formula R sin i=R = $0.124 (P=2) v \sin i$, where P is in days and v sin i is in km s¹. Figure 1 shows projected radii as a function of I-m agnitude. The photom etry com es from Irw in et al. (2007), with a a sm all connection ($I = 0.080 \ 0.0076 \, \text{Im}$ ag) added, to put Inw in et al.'s magnitudes onto the better-calibrated photom etric scale established by Je ries et al. (2001) for low -m ass stars in NGC 2516.

A ssum ing stellar spin axes are random ly orientated, then the mean value of R sin in easured over a small range of I-m agnitudes can be divided by the average value of sin i to determ ine the mean radius. A complication is that it is not possible to measure the period of stars, or determ ine v sin i values if they are viewed at small inclination angles, resulting in an upward bias in the mean sin i (see Je ries 2007). If we consider a cut-o inclination, , such that stars with sin i < yield no period or R sin i value, then the norm alised probability density of i becomes

Equation 2 can be used to determ ined the m ean radius from a set of R sin i values providing is known. Here is estim ated by form ing a cum ulative distribution of the m easured values of R sin i norm alized with a regression line against I m agnitude. This is compared with the cumulative distribution predicted (by M onte C arlo simulation) from the product of the modi ed sin i distribution of equation 1 and a norm al distribution representing the measurement uncertainties in R sin i, which is dominated by the error in v sin i. A K olm ogorov-Sm innov test is used to com pare the m easured and predicted distributions for various values, yielding a best-t = 0.40° $_{0.08}^{\circ.06}$, and hence an average value of sin i of $0.832^{+0.015}_{0.013}$ from equation 2. This compares with a value of 0.785 if this e ect were neglected, showing that it is a small correction with an even sm aller uncertainty when com pared with the size of the e ects we will subsequently discuss.

3.1 Variation of radius with Im agnitude

Figure 1 shows individual R sin i measurements and the average radius estimated in ve equally spaced bins for 14:8 < I < 182. Uncertainties in the binned mean radii are the quadrature sum of uncertainties in the average R sin i and uncertainty in the mean sin i. A few stars were excluded from the binning process (but are still shown in Fig. 1), because they either fell outside these magnitude ranges, or were more than 2 standard deviations away from the regression line between R sin i and I discussed in the last subsection. Several of the latter have long periods > 4 days and m ay have incorrect periods at a 1-day alias of the correct period (see Irw in et al. 2007), or over-estimated v sin i because of unresolved binarity (see below).

A lso shown in Fig. 1 is a solar metallicity 158M yr isochrone from the Bara e et al. (2002) models, which use a convective mixing length of 1 pressure scale height. The absolute I magnitudes of the isochrones were shifted according to a distance modulus (7:93 0:14 { Temdrup et al. 2002) and extinction ($A_{\rm I} = 1.78 \ge$ (B V) = 0.213 m ag), with a net uncertainty of about 0:15 m ag. From this diagram it appears that the cool stars observed in NGC 2516 have larger radii (at a given I) than predicted by the models, by

a factor increasing from a few per cent at I ' 15 (corresponding to M ' 0.6M), to about 50 per cent at I ' 18 (M ' 0.2M). A plot can be constructed for R sin i versus K m agnitude and a sim ilar discrepancy between observed and predicted radii is present.

3.2 Colour m agnitude diagram

The cluster may contain spectrally unresolved binary systems that are seen at a phase/velocity-separation that results in them having the cluster RV, but an over-estim ated v sin i and hence over-estim ated R sin i. Conversely, unresolved binaries will be shifted by up to 0.75 m ag leftward in Fig. 1, which would articially reduce the discrepancy between observed radii and models.

To check this, Fig. 2 shows the I vs I K colour magnitude diagram (CMD) for all target stars with SNR > 5, where we identify stars with R sin i above or below the m ean of their bins in Fig. 1. K magnitudes from the 2M ASS catalog (Cutri et al. 2003) are transformed to the CIT system using the correction ($K_{CIT} = K_{2MASS} + 0.024$) given by C arpenter (2001). C om pared to a 158M yr isochrone from B ara e et al. (2002), both classes of object lie redward by an average of 0.06m ag and are statistically indistinguishable. B ecause we know that binaries where both com ponents contribute to the magnitude and observed spectrum should be shifted up and to the right in this CMD, we can say that the R sin i distribution appears una ected by binarity.

4 D ISC U SSION

Figure 3 shows the mean radii for our NGC 2516 sample, binned as a function of absolute I and intrinsic I K, com – pared with various isochrones (from Bara e et al. 2002, with a mixing length of 1 pressure scale height) and with data for single eld stars. Interferom etric radii and parallaxes for these stars are from D em ory et al. (2009), I m agnitudes are from Leggett (1992) and K m agnitudes are from 2M ASS, converted to the C II system . The eld stars have low m agnetic activity levels as judged from their coronal X -ray em is-

sion, but a range of metallicities (L opez-M orales 2007). The 5G yr isochrone for solar metallicity stars is in reasonable agreement with the radii of inactive eld stars (D em ory et al. 2009). C om parison of the measured and predicted radii as a function of I K shows more scatter, but the majority of this scatter can be interpreted as a metallicity e ect. The 5G yr isochrone for $[Fe/H] \models -0.5$ in Fig. 3b, shows that metallicity strongly a ects I K, since, at a given radius, the I magnitude is more sensitive to metallicity than K.

Turning now to NGC 2516, the m etallicity com plication is not present { we know it has a close-to-solar m etallicity (Temdrup et al. 2002). The mean radii (as a function of I, K or I K) show an increasing departure from the 158 M yr solar m etallicity isochrone with decreasing lum inosity and increasing colour (decreasing $T_{\rm e}$). Even reducing the assum ed cluster age to 100 M yr (a fairly m low er lim it), does little to m itigate the discrepancy (see Fig. 3). Uncertainties in the assum ed extinction and reddening produce the equivalent of only 3 per cent system atic error in the observed radii and the distance uncertainty is limited to shifting the models in Fig. 3a by 0:14 m ag along the x-axis. W e conclude that the radii of low -m ass stars in NGC 2516 do show departures from model predictions and from the observed radii of in-active stars. The radius discrepancies grow as we m ove to lower lum inosities and m ass, becom ing as much as 50 per cent larger at M $_{\rm I}$ ' 10; M $_{\rm K}$ ' 7:5, corresponding to M ' 0:2M in the Bara e et al. (2002) models.

D irect comparison with other models of stellar evolution is more di cult since these use empirical bolometric corrections to convert T_e /luminosity to predicted colour/magnitudes. However, the low-mass models of D'Antona & Mazzitelli (1997) and Siess, Dufour & Forestini (2000) predict similar or even slightly smaller radii for a given luminosity than Bara e et al. (2002), so the discrepancy does not just exist for this latter set of models.

4.1 E ect of spot coverage

The m easured radii of the coolNGC 2516 stars are signi cantly higher than predicted by evolutionary m odels. Sim ilar discrepancies as large as 20{30 per cent are reported for active stars in binary systems (L opez-M orales 2007). Chabrier et al. (2007) discussed two possible causes for this observed increase in radius. The rst was a change in m ixing length in m agnetically active stars a ecting heat transfer. The second was high levels of m agnetic starspot coverage. They show ed that reductions in m ixing length had only sm all e ects for fully convective stars where convection is nearly adiabatic. Here we nd larger radius anom alies for the cooler, fully convective stars, leading us to consider surface spotting.

The NGC 2516 stars with m easured R sin i have median rotation periods of 0.76 days, with 95 per cent less than 3 days. In either single or binary M -dwarfs, this rotation should lead to saturated levels of magnetic activity (e.g. Jam es et al. 2000). C ross-correlating our sam ple with the NGC 2516 targets in Haw ley et al. (1999), we nd 27 m atches. Of these, 11 stars have m easured periods and R sin ivalues. A ll11 show H in em ission e ectively de ning the upper envelope of magnetic activity in the cluster.

To quantify spot coverage e ects, a simple model assuming a xed luminosity is used to predict changes in magnitude and colour with spot temperature and area. We start from the assumption that the Bara e et al. (2002) models do a reasonable job in predicting the radii, temperature and I K of inactive and presum ably unspotted stars (see Fig. 3 and the discussion in Bara e et al. 1998). If the surface temperature of the star is reduced from T₀ to T then to maintain a xed luminosity the radius increases as $R = R_0 (T_0=T)^{1=2}$. W hilst this does not e ect the bolom etric corrections, B C_I and B C_K, are functions of T and R. Changes in B C_I and B C_K with T are found from the 158M yr isochrone. The second order e ect due to larger R (and hence lower surface

gravity) is estimated by interpolating model isochrones for M-dwarfs from 15.8 to 158 M yr. Bolom etric corrections at T are used to determ ine modi ed isochrones and hence M_I and M_K for a star at the spot temperature. A fraction , of this star is combined with a fraction (1) of an unspotted star of similar radius to determ ine the magnitude and colour of the spotted star as a function of radius.

Two dashed histogram s in Fig. 3 present results for representative experiments. Calculated radii at the measured M $_{\rm I}$ and (I K) $_{\rm 0}$ are binned to compare with the measurements. The rst model shows the result of a uniform 15 per cent tem perature reduction in the models (i.e. = 1). This provides a reasonable m atch for radius vs M $_{\rm I}$, but fails to predict the correct stellar colours in Fig. 3b, because the tem perature dependence of B C $_{\rm K}$ is very di erent to that of BCI. Instead we simulate the radii of heavily spotted stars with = 0.5 and spots that are 30 per cent cooler than the unspotted photosphere; at the upper end of spectroscopically deduced spot coverages for active stars (e.g. 0 'N ealet al. 2004). The m atch between predicted and m easured radii is much improved in the radius vs M $_{\rm I}$ plot and the radius vs (I K)₀ plot. Even better agreement to the lower lum inosity bins can be achieved using ' 0:75 and 45 per cent spot tem perature reductions. Such high lling factors are suggested by investigations of Zeem an broadening due to magnetic elds in rapidly rotating M -dwarfs (e.g. Johns-Krull& Valenti2000; Reiners, Basri& Browning 2009) However, this level of precision is probably over-interpretation at this stage. The remaining discrepancies could also be due to uncertainties in the cluster metallicity or inaccuracies in the unspotted model isochrone of radius versus (I $\,$ K $)_0$.

5 SUMMARY

The results reported here show that the radii of young, single, rapidly rotating M -dwarfs in NGC 2516 are signi cantly larger, at a given lum inosity, than predicted by evolutionary models and hence their e ective tem peratures must be cooler than predicted. The discrepancy becom es larger for stars less lum inous than the predicted transition to fully convective structures, reaching a radius anom aly of 50 per cent. These results are consistent, although more extrem e for the low est m ass stars in our sam ple, with radius anom alies found for the components of older, tidally locked eclipsing binary system s. Evolutionary models correctly predict the radii of m agnetically in-active stars, suggesting that the increased radii in our sample is caused by rapid rotation and/orm agnetic activity. A simple, two-temperature starspot model could explain the overall radius increase, but only if spots cover > 50 per cent of the surface for the lowest lum inosity objects in our sam ple.

Cool stars may be rapidly rotating and magnetically active as a consequence of their youth or membership of tidally locked binary systems. An altered relationship between mass, radius and e ective temperature for these stars calls for improvements in low-mass models in order to intempret observations of young clusters, star form ing regions and close binary systems.
