The open cluster Berkeley 53

Abstract: W e present a photom etric study of the neglected open cluster Berkeley 53. W e derived its fundam ental param eters, such as the age, the interstellar reddening, and the distance from the Sun, based on BV photom etry combined with near-infrared JHK_S data. The structure and the mass function of the cluster were also studied and the total number of members and the total mass were estimated. The cluster was found to be a rich and massive stellar system, located in the Perseus Arm of the Milky W ay, 3:1 0:1 kpc from the Sun. Its age exceeds 1 G y but it seems to be very young in the context of its dynam ical evolution. The analysis of the two-color diagram s and color-magnitude diagram s indicates that the cluster is signi cantly reddened. How ever, both methods resulted in di erent values of E (B V), i.e. 121 0:04 and 1:52 0:01, respectively. This discrepancy suggests the presence of an abnorm al interstellar extinction law toward the cluster.

1 Introduction

The open cluster Berkeley 53 (C 2055+ 508) was discovered by Setteducati & W eaver (1960). Ruprecht (1966) classi ed it as a poor, concentrated open cluster of Trum pler type II3p. A coording to the New catalogue of optically visible open clusters and candidates by D ias et al. (2002), the cluster's apparent diam eter is 12⁰ and Trum pler type is III2m. No dedicated studies of this object have been perform ed to date.

Berkeley 53 consists of stars fainter than V = 18 m ag and is located in the vicinity (3!1 from the cluster center) of the bright (V = 6.6 m ag) foreground star HD 199578. This makes photom etric observations of the cluster di cult.

In this paper we present a photom etric study of Berkeley 53 resulting in the determ ination of its basic parameters, such as the age, the interstellar reddening, and the distance from the Sun. The structure and the mass function of the cluster are also studied and the total num ber of members and the total mass are estimated.

This work is based on observations made with the 2-m telescope of the Rozhen National Astronom ical Observatory, which is operated by the Institute of Astronom y, Bulgarian Academ y of Sciences.

2 Observation and data reduction

O bærvations were perform ed with the 2/16 m R itchey-Chretien telescope of the Rozhen N ational A stronom ical O bærvatory (NAO, Bulgaria), operated by the Institute of A stronom y, Bulgarian A cadem y of Sciences. The instrum ent was used in a direct in aging m ode and was equipped with a Princeton Instrum ents VersA rray 1300B CCD cam era mounted in the Ritchey-Chretien focus. The eld of view was 5.% 5.% with a scale of 0.26 arcsec per pixel. O bærvations were carried out on August 19, 2007. Two exposures in the B liter and three fram es in the V band were acquired. The exposure tim e was 600 s and 300 s, respectively. Four exposures in the U liter with 900 s exposure tim e were also acquired but they occurred to be not deep enough to detect the cluster stars.

The eld around Berkeley 53 is presented in Fig. 1 where the fragment of the sky covered by our observations is also sketched. The telescope was not pointed on the cluster center due to the nearby bright star HD 199578. The B band exposures were a ected by a narrow strip of its rejected light passing horizontally through the center of frames.

CCD frames were processed using a standard procedure that included subtraction of bias frame, at-elding with twilight ats, aperture and point spread function (PSF) photom etry, transform ation to the standard system, and astrom etric calibration. The aperture photom etry and astrom etric calibration were perform ed with the software pipeline developed for the Sem i-Autom atic Variability Search sky survey (Niedzielski et al. 2003). Exposures in a given band were averaged. The PSF m agnitudes were obtained with IRAF¹ package DAOPHOT. A second-order variable PSF was used to compensate for variability of stellar process frames. A perture corrections were determined using aperture photom etry of 13 isolated stars that were used while building the PSF procle.

The raw instrum entalm agnitudes were corrected for the scattered light e ect (M arkov 2008). The following correction form ulae were obtained by us:

where b, v are the additive m agnitude corrections in the corresponding lters and d is the distance of a star from the CCD m atrix center norm alized by the detector half-size.

The calibration coe cients that transform instrum ental magnitudes into standard ones were determined using 16 stars from the Messier 92 eld (Majewski et al. 1994, see their Table 1) and 40 stars from the eld of NGC 7790 (O dewahn et al. 1992). The magnitude range was between 13:144 and 18:315 mag in V and the (B V) color index coverage was in the range between 0:111 and 1:918 mag. The following equations were derived:

- $b = (0.58 \ 0.03)X \ (0.17 \ 0.01)(B \ V) \ 23.06;$ (3)
- $v V = (0.33 \ 0.02)X \ (0.16 \ 0.01) (B \ V) \ 23.67;$ (4)

where b, v are the corrected instrum entalm agnitudes, B, V are the m agnitudes in the standard system, and X is the airm ass.

The nallist of stars contains equatorial coordinates, V m agnitudes, and (B V) color indices. It is available in electronic form at the survey web site² and the W EBDA³ database (M erm illiod 1996).

The optical data were com plem ented with near-infrared JH K $_{\rm S}$ photom etry extracted from the 2-M icron A ll Sky Survey (2M ASS, Strutskie et al. 2006). The extraction radius was set to 30⁰ around the cluster center (see Sect. 3.1). Optical photom etry was combined with near-infrared data to perform a comprehensive photom etric study of the cluster (e.g. M aciejew ski 2008).

3 Data analysis and results

3.1 Cluster structure

The cluster structure was investigated with the radial density prole (RDP). For this purpose only the 2M ASS data set was used for constructing RDP due to unlimited eld of view. We started with redetermining the cluster center. The algorithm was adopted from Maciejewski & Niedzielski (2007) and started from a tentative position determined by eye. Two perpendicular stripes were cut along declination and right ascension starting from the approximate cluster center and the histogram of star counts was built along each stripe. The bin with the maximum value in both coordinates was taken as a new cluster center what resulted in RA = $20^{h}55^{m}56^{s}$ and DEC = $+51\ 02.98$ for epoch J2000.0 (l= 90:29, b= 3:75). As one can see in Fig. 1, these values do not point to the center of the eld of view. Next, the proles were constructed by counting stars inside concentric rings of width 1^{0} , centered at the redetermined cluster center. The density uncertainty in each ring was estimated assuming Poisson statistics. The RDP is plotted in Fig.2.

To param etrize the density distribution, a two-param eterK ing (1966) density pro lewas tted with the leastsquares m ethod in which the uncertainties were used as weights. We derived the core radius (the distance where

the stellar density drops to half its maximum value) $r_c = 2.5$ 0:1 arcm in, the central density $f_0 = 18.0$ 0:5 stars/arcm in², and the background density level $f_{bg} = 6.9$ 0:1 stars/arcm in². The tted pro le is sketched with a solid line in Fig. 2 while the dashed line marks the level of f_{bg} . The cluster limiting radius r_{lim} was roughly estimated by eye-inspection in the RDP. The stellar density excess is visible up to at least 11^0 (a value alm ost two times greater than the literature one.

The RDP allowed us to estim ate number of observed stars belonging to the cluster to be 900. That suggests that Berkeley 53 is a very rich and massive stellar system.

3.2 Two-color diagram s

 $(H K_S)$ vs: (B V) and (J H) vs: $(H K_S)$ two color diagrams (TCDs) were constructed to estimate the interstellar reddening toward the cluster. Only stars located within the core radius from the cluster center were considered to minimize the in uence of the background star contamination. Among them only stars forming the

main sequence of the cluster were taken for the further analysis. They are marked with lled circles in Fig. 3 where the TCD s are plotted.

The theoretical main sequence was extracted from the Padova isochrones for solar metallicity Z = 0.019 (G irakliat al. 2002). The reddenings E (B V) = 1.18 and E (H K_S) = 0.26 were obtained by shifting the main sequence (a continuous line in Fig. 3) along the reddening vectors whose norm allopes were calculated assuming the universal interstellar extinction law by Schlegel et al. (1998). To obtain an independent determination of the color excess in (B V) color index, the value of E (H K_S) was transformed into E (B V) applying the relation $\frac{E(H K_S)}{E(B V)} = 0.209$ taken from Schlegel et al. (1998). We derived $E^0(B V) = 1.24$. The results seem to be consistent with a mean value of her (B V) i= 1.21 0.04.

3.3 Color-m agnitude diagram s

A prelim inary J vs: (J K_S) colorm agnitude diagram (CMD) for overall cluster region ($r < r_{lim}$) is presented in Fig. 4. We applied a decontam ination procedure to remove background-star contam ination. The details of this procedure can be found in Maciejewski & Niedzielski (2007). The CMDs were built for the cluster region and for an o set eld. A concentric o set eld of width 10° and starting at $r = r_{lim} + 2°$ from the cluster center was used. Then the CMDs were divided into two-dimensional bins and the number of stars within each box was counted. The cleaned (decontam inated) cluster CMD was built by subtracting the number of stars in the o set box from the number of stars in the corresponding cluster box. The latter number was weighted by the cluster to o set eld area ratio. K now ing the number of cluster stars occupying each box, the algorithm random ly chose the required number of stars located in the cluster area and with the adequate magnitude and color index.

As one can see in Fig. 4, a rich main sequence is clearly visible, as well as a red giant clum p. The estim ated number of observed cluster stars is 1000 after rejecting stars with outstanding magnitudes and colors. This value is comparable with the one obtained from the RDP analysis. We found 200 evolved stars constituting the red clum p.

To determ ine fundam ental astrophysical param eters of the cluster, we built 8 CMDs combining V and J m agnitudes with (B V), (V J), (V H), and (V K_S) color indices. The broad color baselines were expected to m inim ize photom etric errors and to determ ine precisely the reddening. Only stars located within the core radius around the redeterm ined cluster center were considered to m inim ize the in uence of the background star contam ination on further analysis. The diagram s are plotted in Fig. 5.

Initially, we tried to derive the distance modulus and the age of the cluster via tting a set of theoretical Padova isochrones (G irakli at al. 2002). Since there is no information about the cluster metallicity, the solar metallicity of Z = 0.019 was assumed. The tting algorithm is based on the least-squares method and uses stellar magnitudes as weights. Stars with extremal color indices or magnitudes were rejected manually before running the isochrone-tting procedure. The tting and decontamination procedures were run independently for each diagram with a xed value of reddening. The latter quantity was calculated for a given color using he (B V) i from the two-color diagram analysis and assuming the universal interstellar extinction law by Schlegel et al. (1998). However, we were unable to nd a convergent and satisfactory nal solution and the reddening was found to be underestimated.

To explain this discrepancy, we ran the isochrone- tting algorithm with reddening as a third free parameter. The results of individual ts are collected in Table 1 and the respective isochrones are drawn with solid lines in Fig.5. The dereddened distance modulus $(m \ M)_0$ was calculated assuming the universal interstellar extinction

law by Schlegelet al. (1998) with a total-to-selective absorption ratio of R = 3:315. The value of E (B V) was found to be about 0.3 m ag greater than the two-color diagram analysis suggested. One can note that E (B V) tends to be slightly smaller for colors including m ore reddish bands. We obtained $\frac{E(V - J)}{E(B - V)} = 2:414 - 0.025$, $\frac{E(V - H)}{E(B - V)} = 2:707 - 0.017$, and $\frac{E(V - K - s)}{E(B - V)} = 2:893 - 0.023$. Comparing to the values given by Schlegelet al. (1998), i.e. 2.413, 2.739, and 2.948, respectively, a discrepancy can be noted in bands H and K s and increasing with wavelength. This e ect explains the low er value of the interstellar reddening obtained from the TCD s analysis. A dopting redeterm ined reddening vectors, we obtained consistent results of TCD s and CMD s analysis. In the absence of photom etric observations in the U band, it is in possible to answer the question about the nature of the observed e ect. It m ay be caused by an abnorm al interstellar extinction law toward Berkeley 53 or by system atics in 2MASS photom etry.

Finally, the following mean results were obtained from the CDM s analysis: $\log(age) = 9:09 \quad 0:02, E (B \quad V) = 1:52 \quad 0:01, (m \quad M)_0 = 12:45 \quad 0:05, and a distance of 3:1 \quad 0:1 kpc. The linear diameter was found to be 19:8 \quad 0:5 pc. The main possible cause of system atic error in the values given above is the unknown metallicity of the cluster. To estimate its in uence on the results, we repeated the isochrone- tting procedure for the super$ $and sub-solar metallicities of Z = 0:030, Z = 0:008, and Z = 0:004. We noticed the increase of the reddening with the decrease of the metallicity (E (B \ V) 0:07 for each metallicity step, including Z = 0:019) while the age and the apparent distance modulus remained stable. It is also worth noting that the discrepancy between the TCD s and CMD s values of the reddening cannot be justiled by non-solar metallicity of the cluster.$

3.4 Totalm ass and num ber ofm em bers

Studies of the m ass function (M F) were carried out to estim ate the total m ass of the cluster and the number of its m embers. The analysis is based on the 2M ASS photom etry due to the wide eld of view available and uses the algorithm adopted from M acie jew ski & N iedzielski (2007). The rst step was to build a lum inosity function (LF) for overall ($r < r_{lim}$) cluster region. The bright end of the LF was determined by the main-sequence turn-o point while the faint end was set for J = 15.8 m ag { the value of the 99.9% Point Source Catalogue

C om pleteness Lim t^4 . W e used bins as sm all as 0.1 m ag due to cluster richness. Another LF was built for a concentric o set eld of width 10° and starting at $r = r_{lim} + 2^{\circ}$. The LF of the o set eld was subtracted, bin by bin, from the cluster LF, taking the area proportion into account. The resulting LF was converted into an MF using the respective isochrone. It is woth noting that the cluster area, especially the core ($r < r_c$), m ay su er signi cant incom pletness due to stellar crow ding. Therefore, our further results m ust be treated as a low er lim it.

The mass function (m) was approximated by a standard relation of the form log (m) = $(1 +)\log m + b_0$ where m is the stellar mass, is the mass-function slope, and b_0 is a constant. The derived parameters allowed us to estimate the total mass M_{tot} and the total number of stars N_{tot}. These quantities were calculated extrapolating the MF from the main-sequence turn-o point down to the H-burning mass limit of 0.08 M (see Maciejewski & Niedzielski 2007 and references therein for details). The mass function is plotted in Fig. 6. We obtained = 1:7 1:6, a value comparable within error bars to the universal initial mass function (IMF) $_{\rm IMF} = 1:3$ 0:3

given by K roupa (2001). The high uncertainty is caused by a sm all range of covered stellar m asses. The cluster was found to be in fact very rich and m assive with N $_{tot}$ = 31000 and M $_{tot}$ = 12000 M .

To describe a state of cluster dynam ic evolution, the dynam ical-evolution parameter was calculated in the form $=\frac{age}{t_{relax}}$ where t_{relax} is the relaxation time (see Maciejewski & Niedzielski 2007 for details). We derived $\log = 0.3$ which suggests that the cluster is dynam ically younger than its relaxation time.

4 Summary

Berkeley 53 was found to be a rich and massive open cluster belonging to the Perseus A m. Its age exceeds 1 Gy, but it seems to be very young in the context of its dynamical evolution. A subtle discrepancy in the interstellar extinction law toward the cluster in the H and K_S bands was detected. That suggests the presence of an abnorm al interstellar extinction law toward the cluster.
